(57) **CLAIM**

The ornamental design for a pyramid pebble football with textured lacing, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side view of the pyramid pebble football with textured lacing;

FIG. 2 is the top plan view of the pyramid pebble football with textured lacing of FIG. 1;

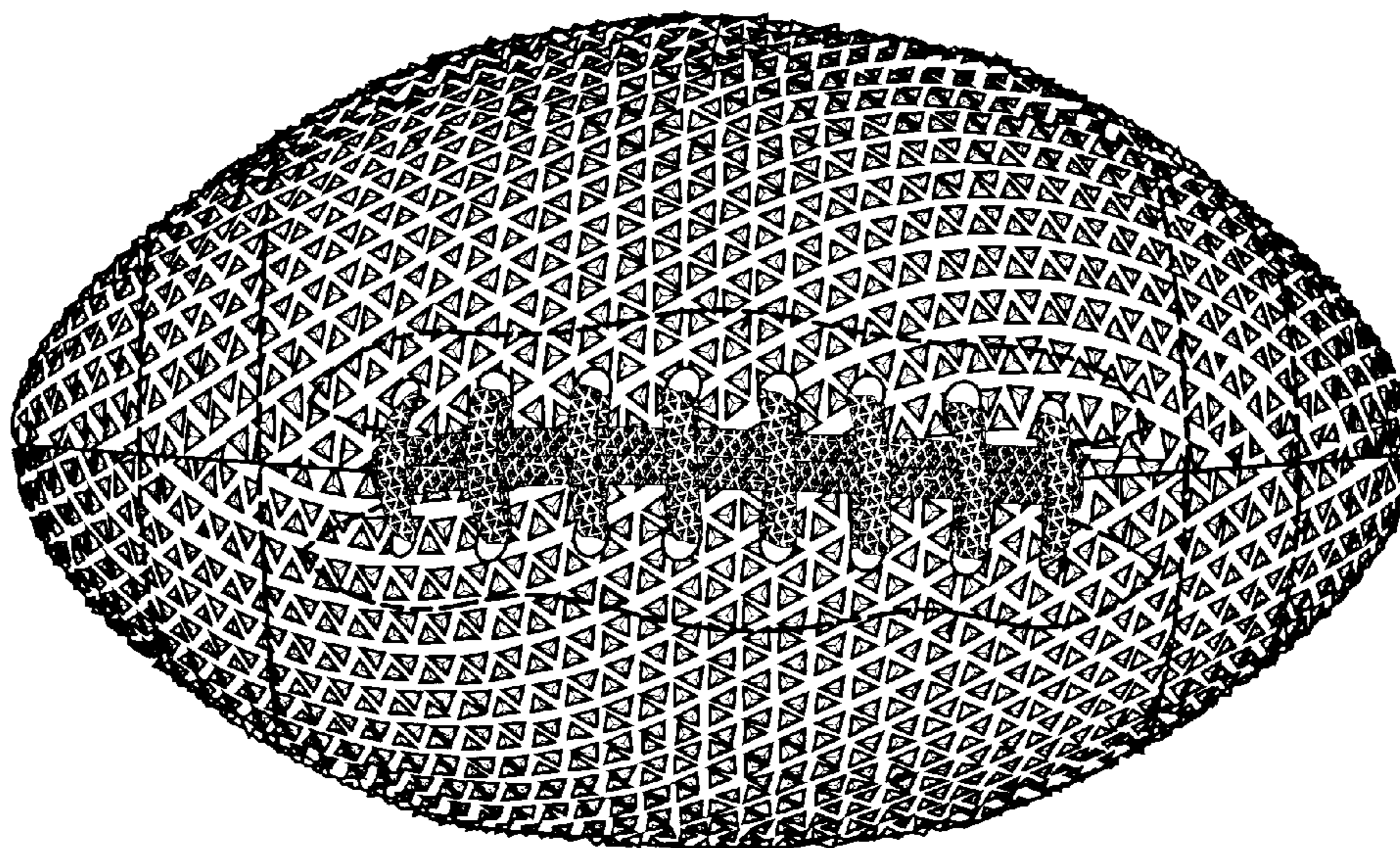
FIG. 3 is a left side view of the pyramid pebble football with textured lacing of FIG. 1;

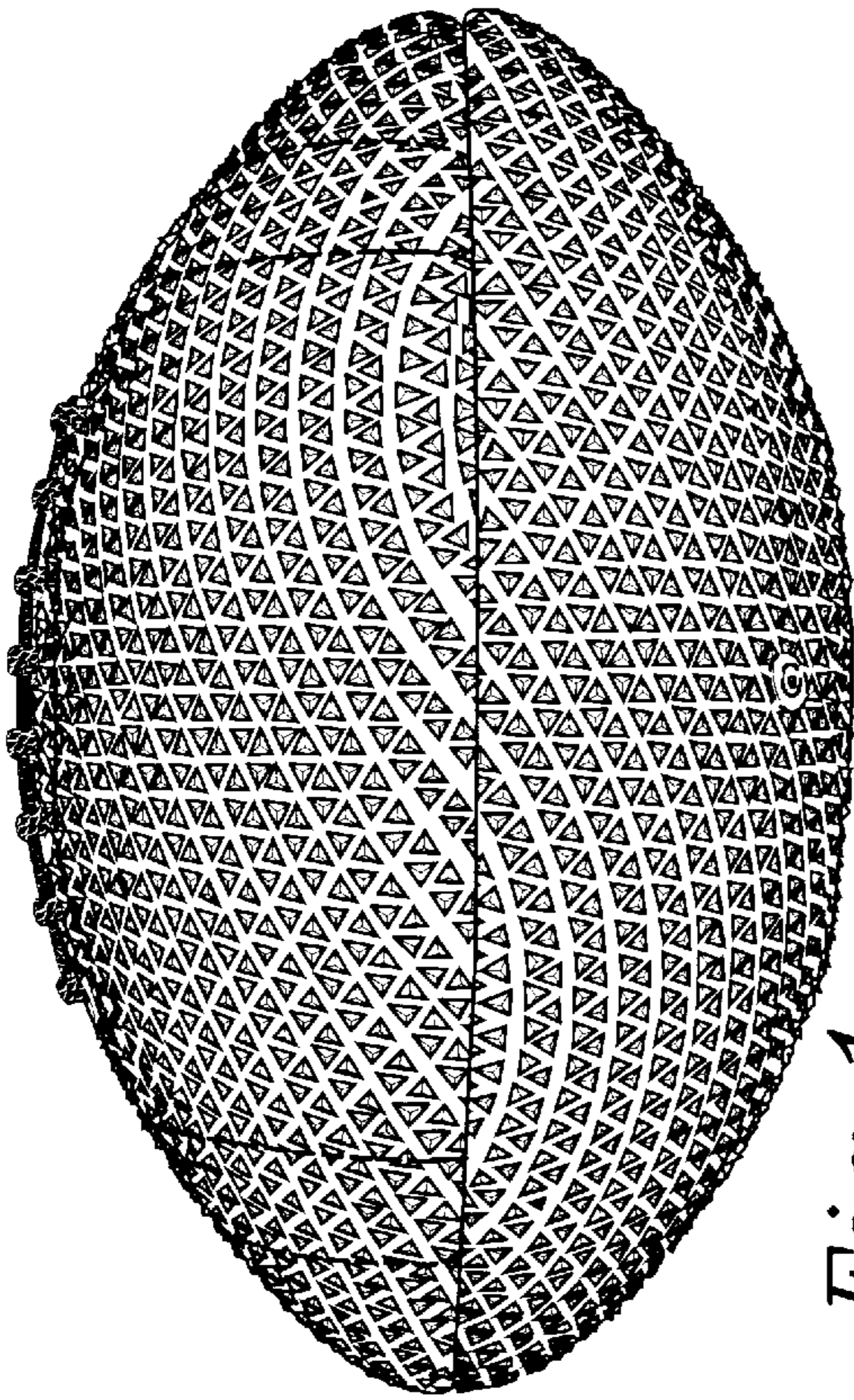
FIG. 4 is a bottom plan view of the pyramid pebble football with textured lacing of FIG. 1; and,

FIG. 5 is a front view of the pyramid pebble football with textured lacing of FIG. 1, the rear view of the pyramid pebble football with textured lacing is identical to the image of FIG. 5.

The broken lines showing the surface delineations on the top half of the football and the circular element on the lower right side thereof are for illustrative purposes only; and form no part of the design.

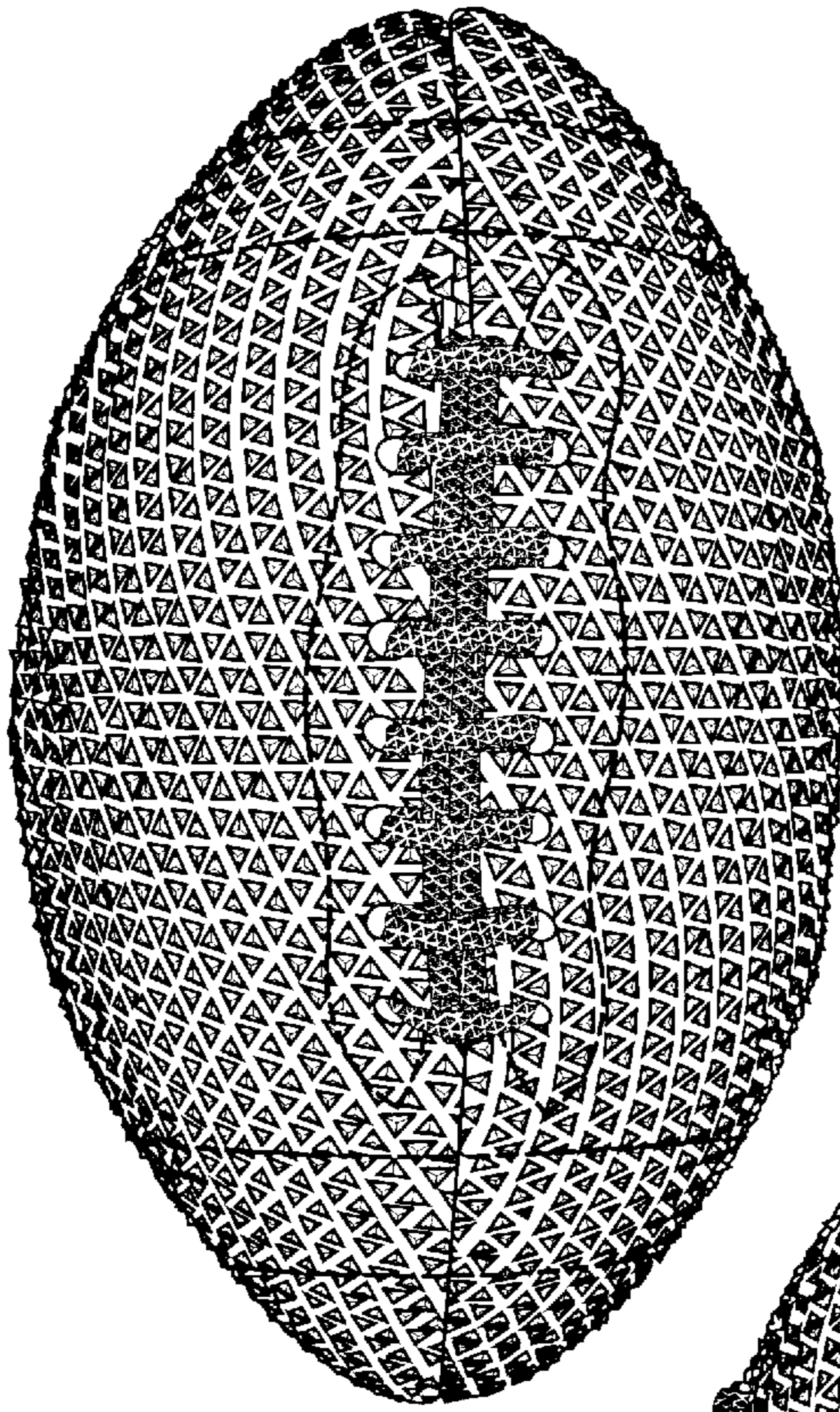

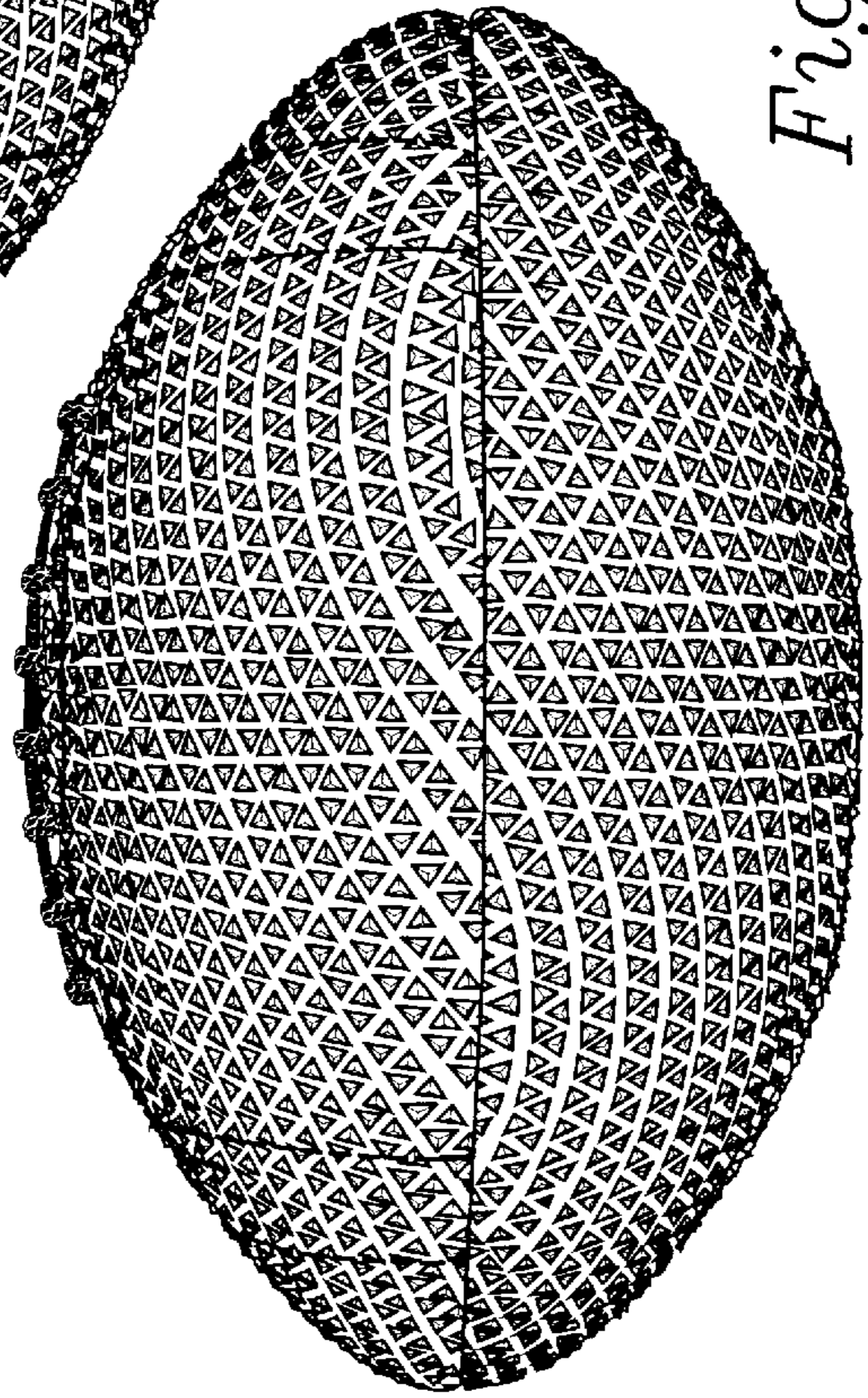

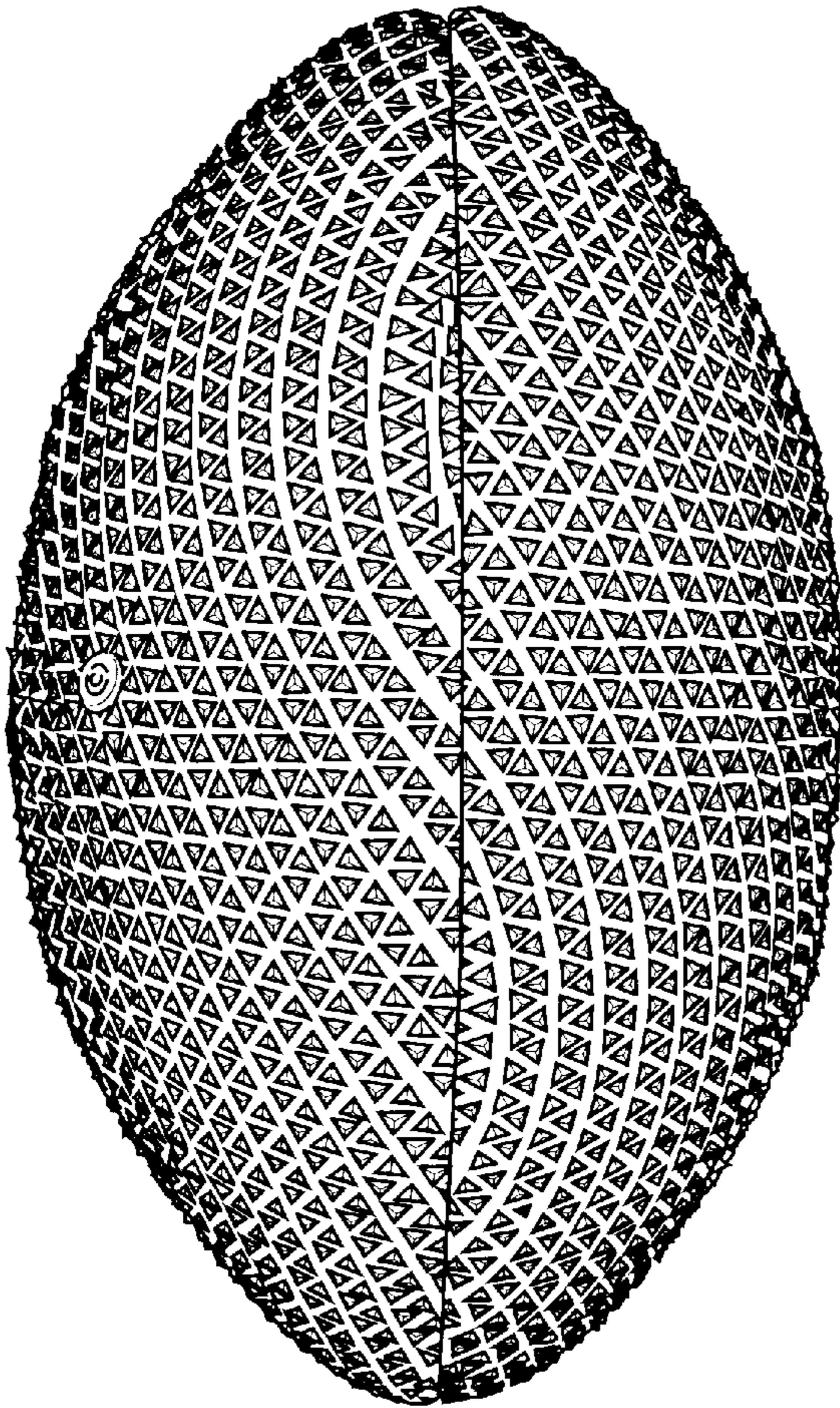
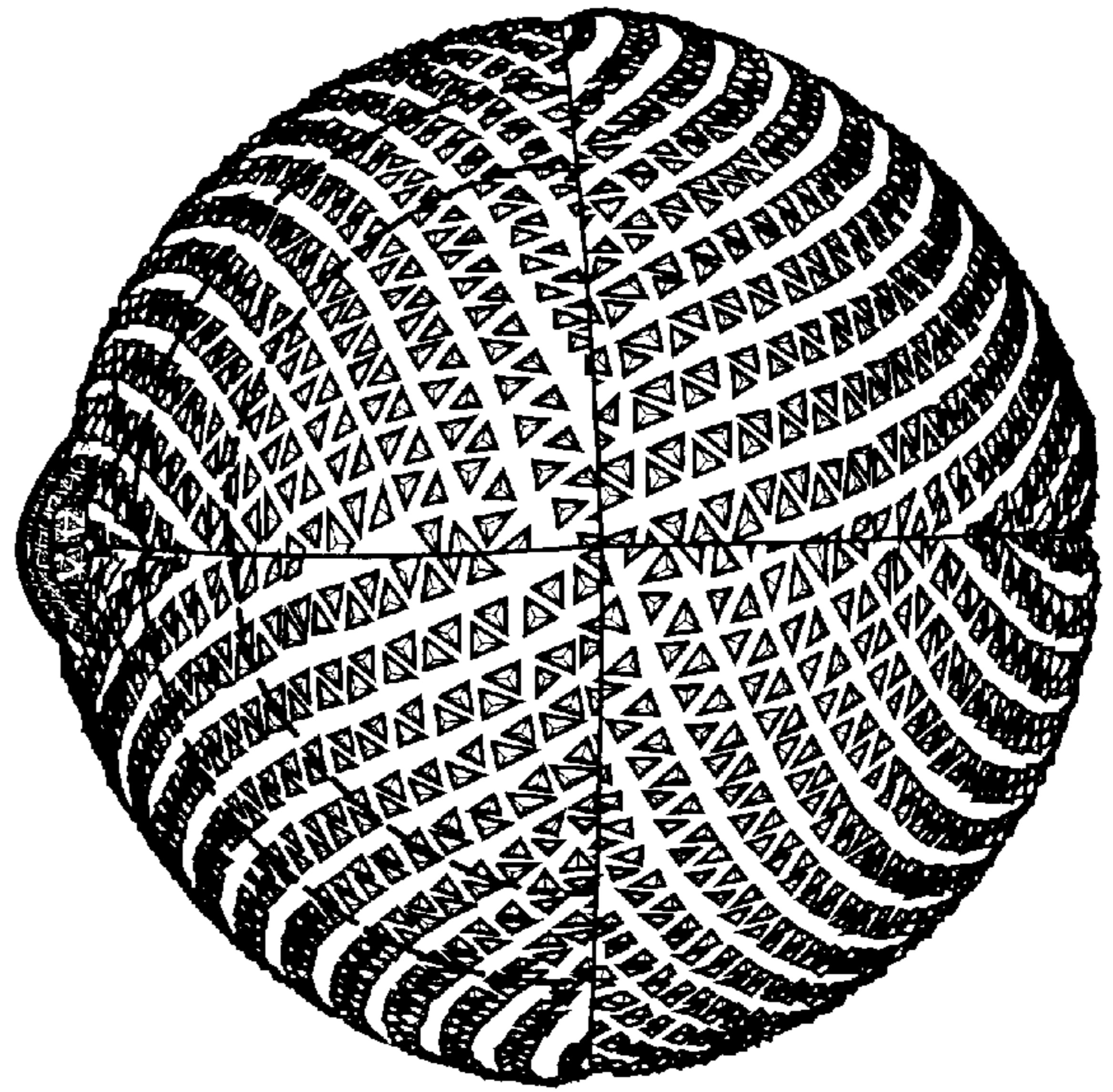
