The ornamental design for a seat for aircraft, as shown.

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of the seat for aircraft;

FIG. 2 is a rear elevational view of the first embodiment of the seat for aircraft;

FIG. 3 is a right side elevational view of the first embodiment of the seat for aircraft;

FIG. 6 is a front elevational view of the second embodiment of the seat for aircraft;

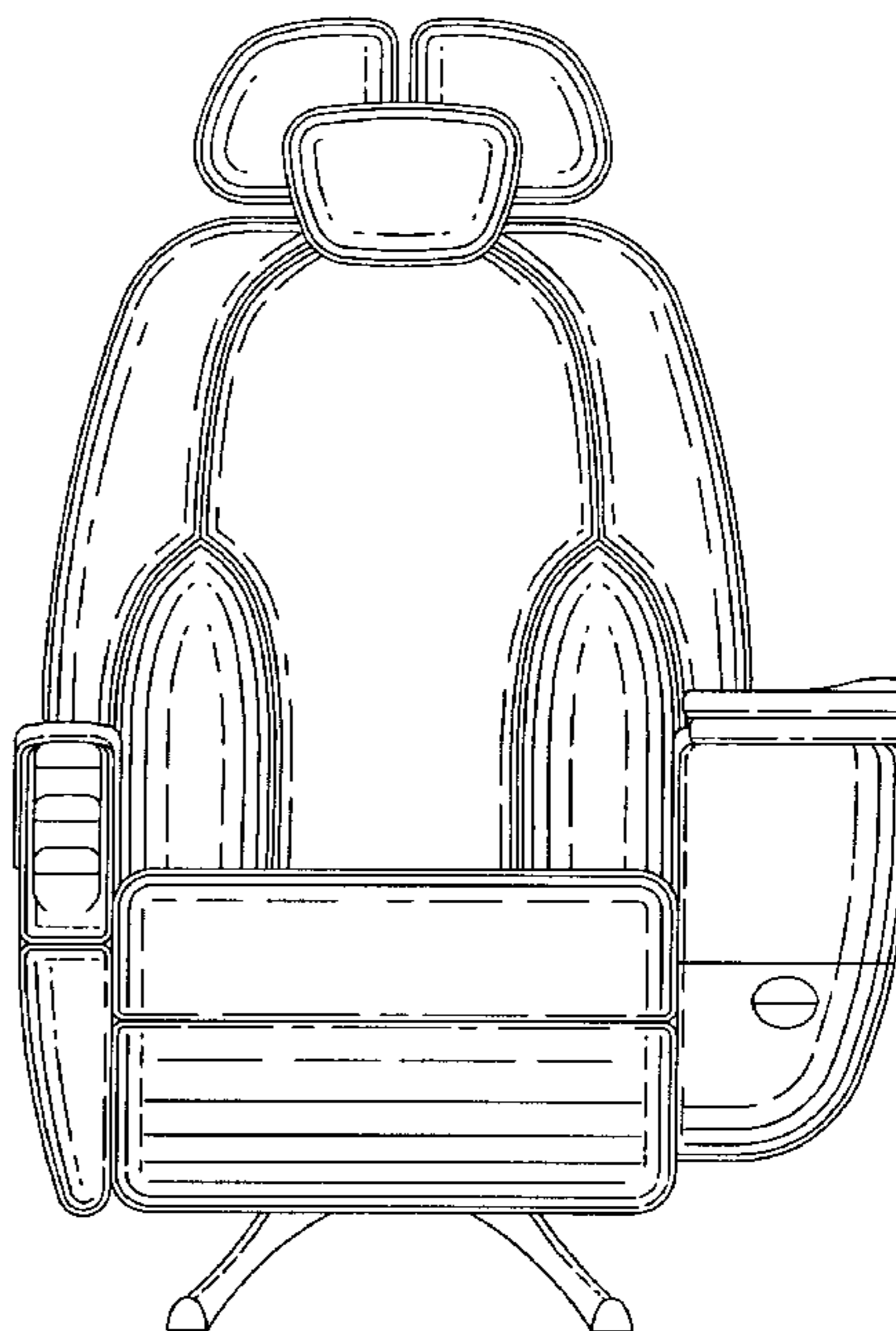
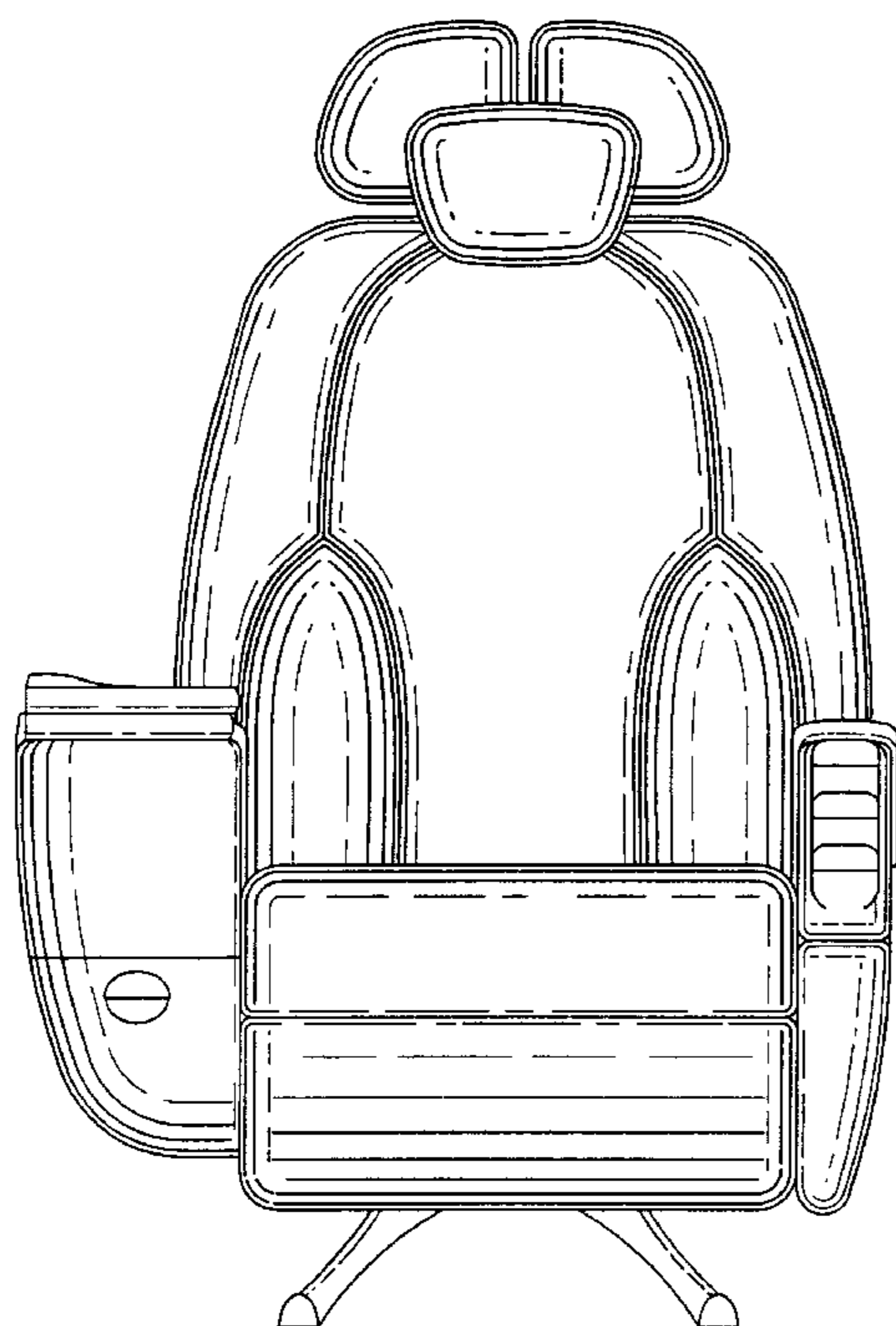
FIG. 7 is a rear elevational view of the second embodiment of the seat for aircraft;

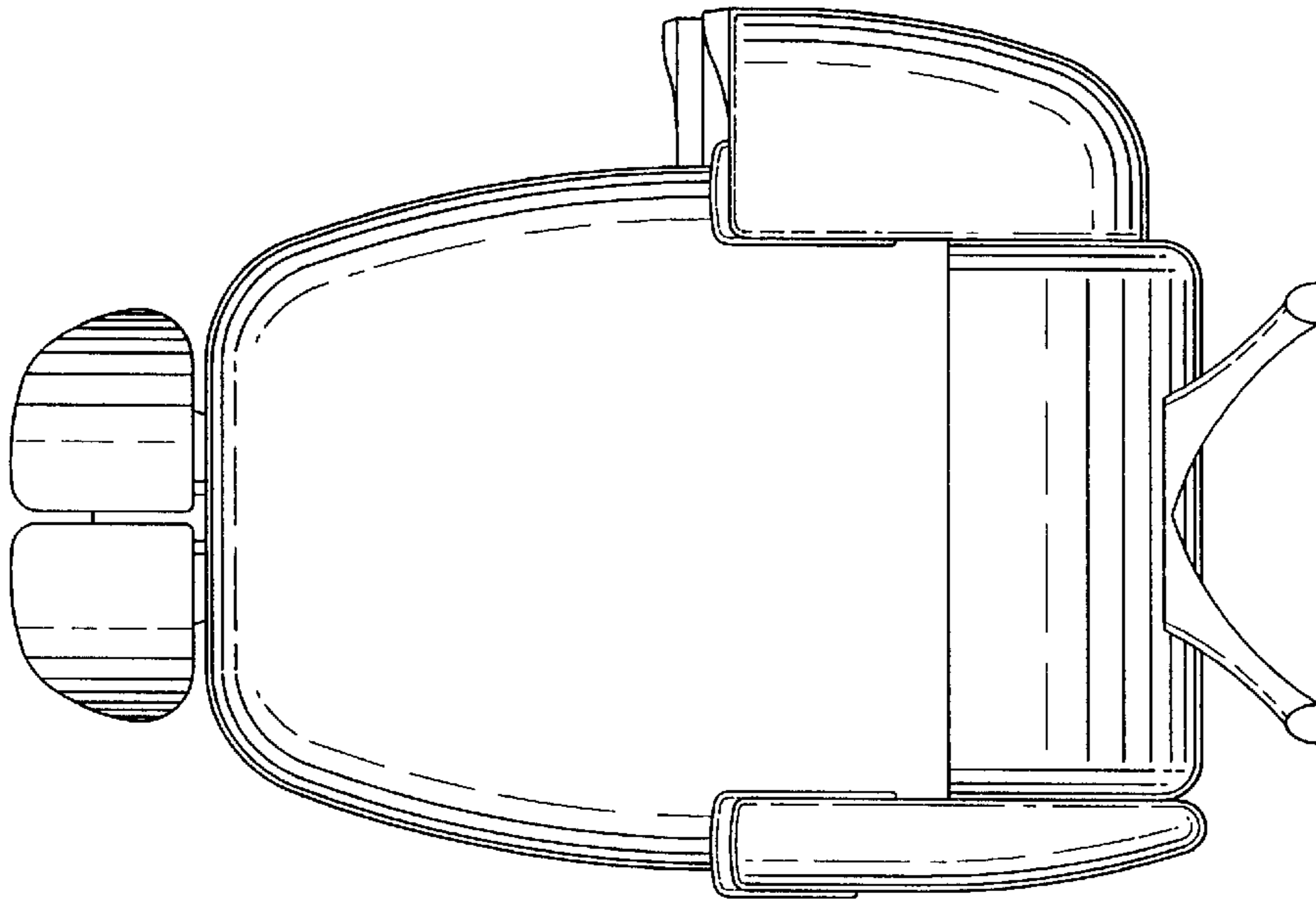

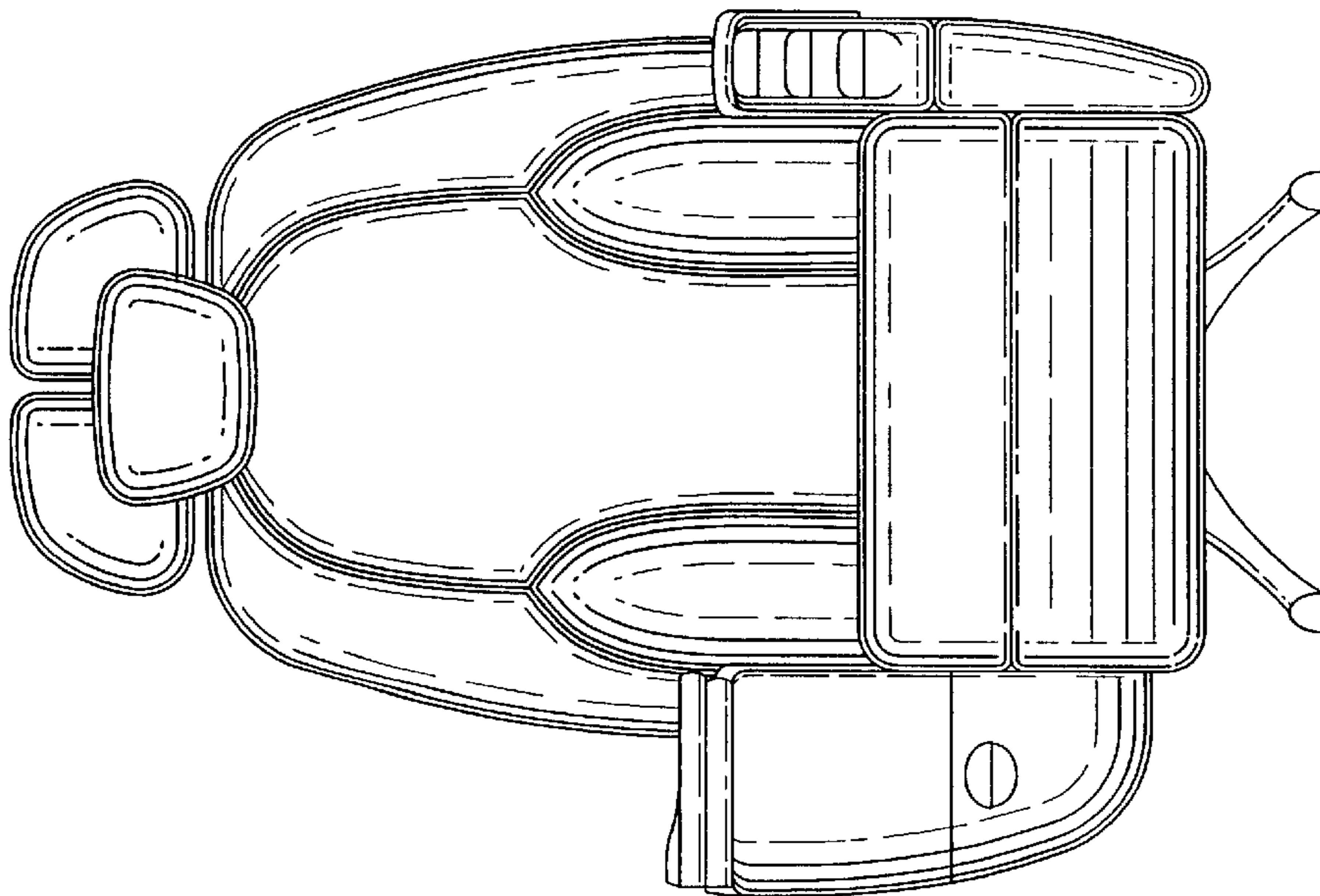

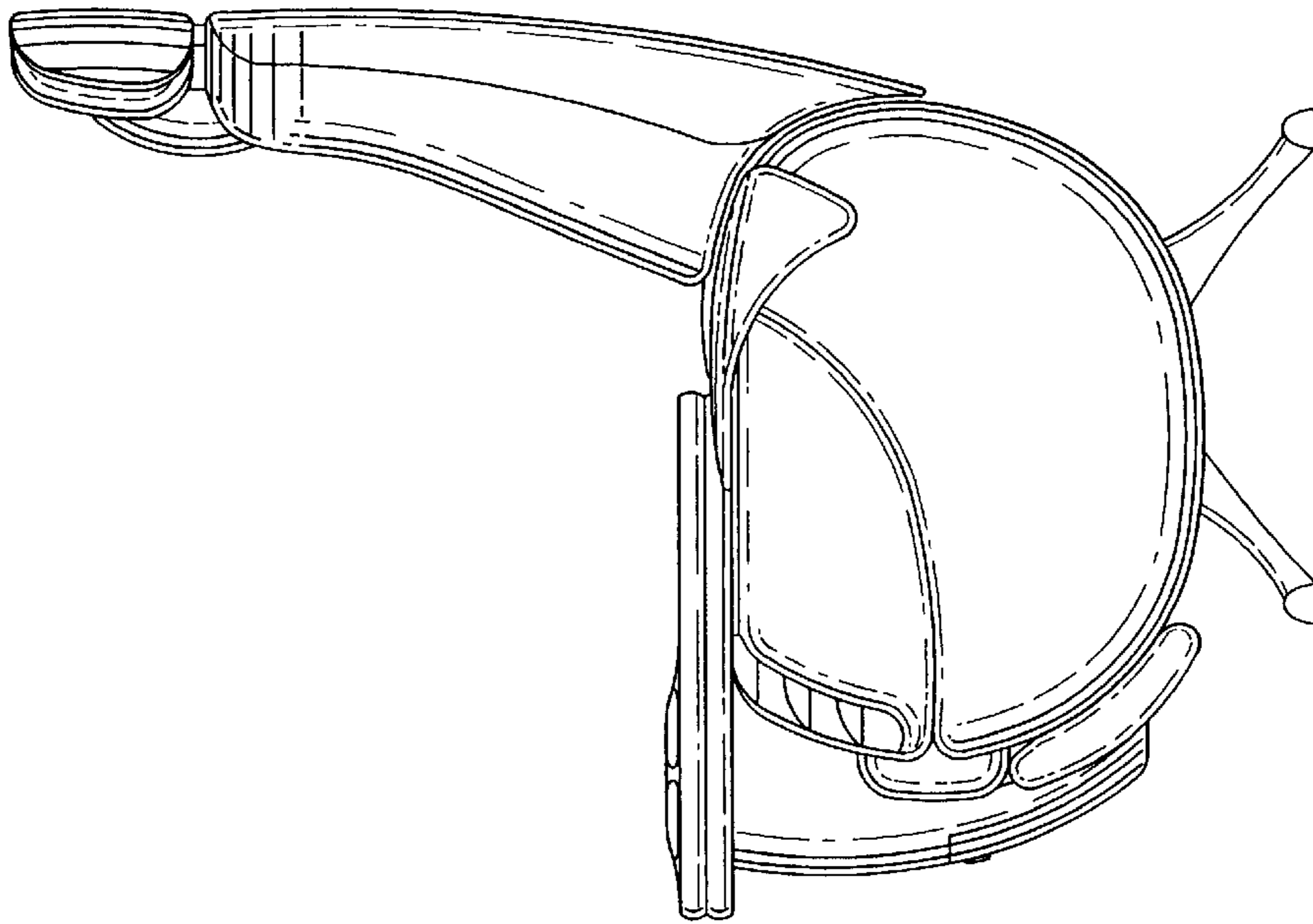

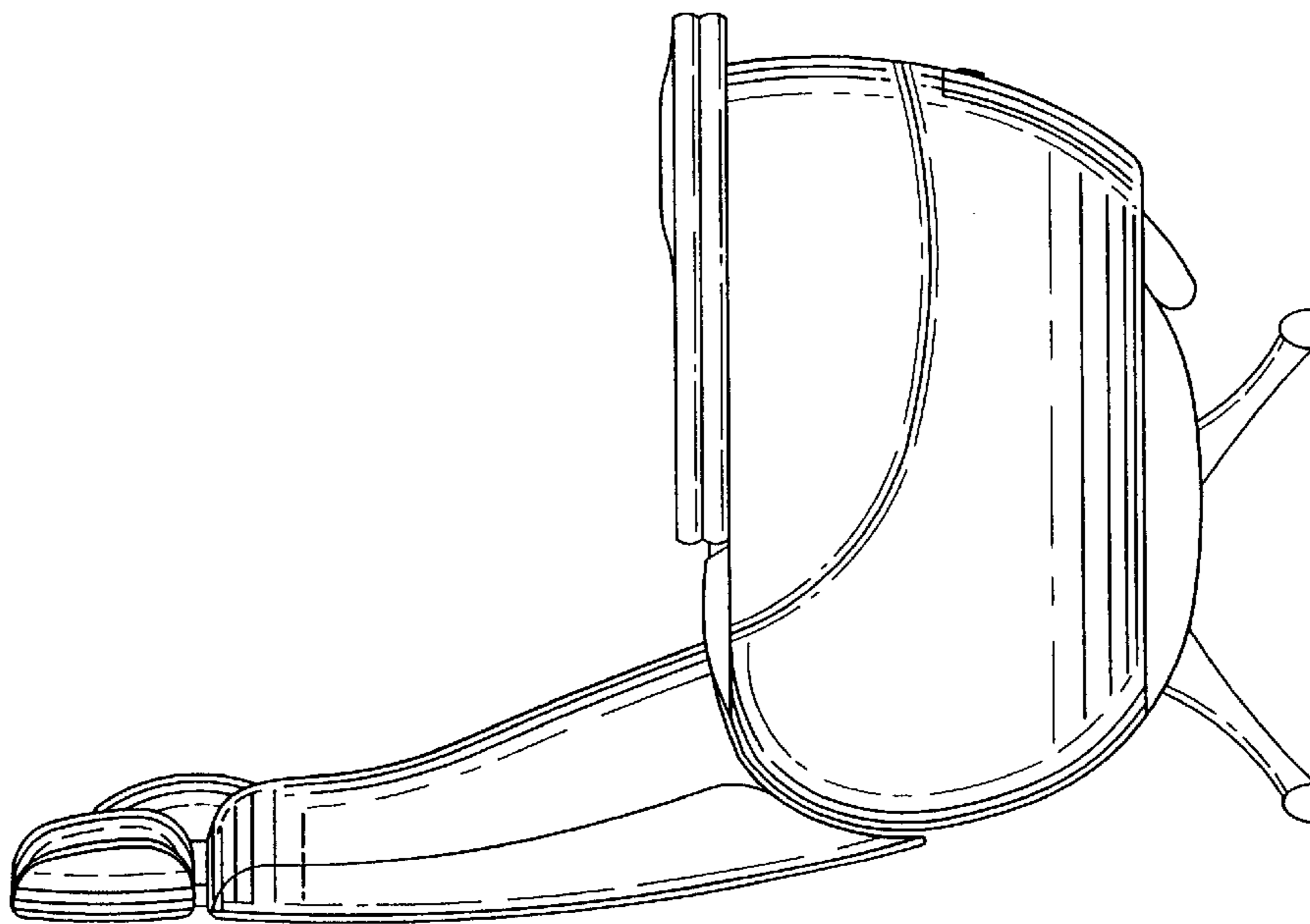

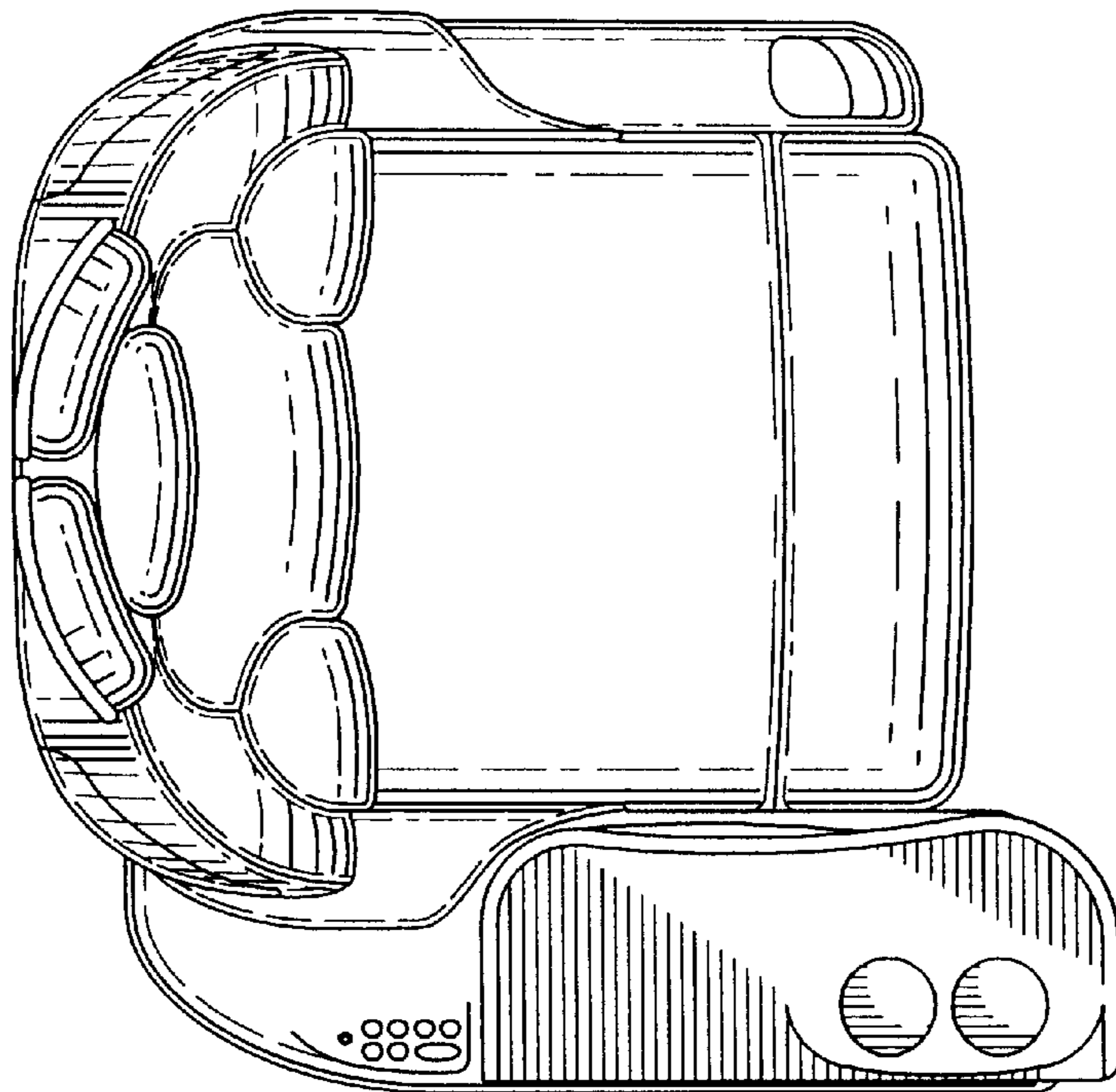

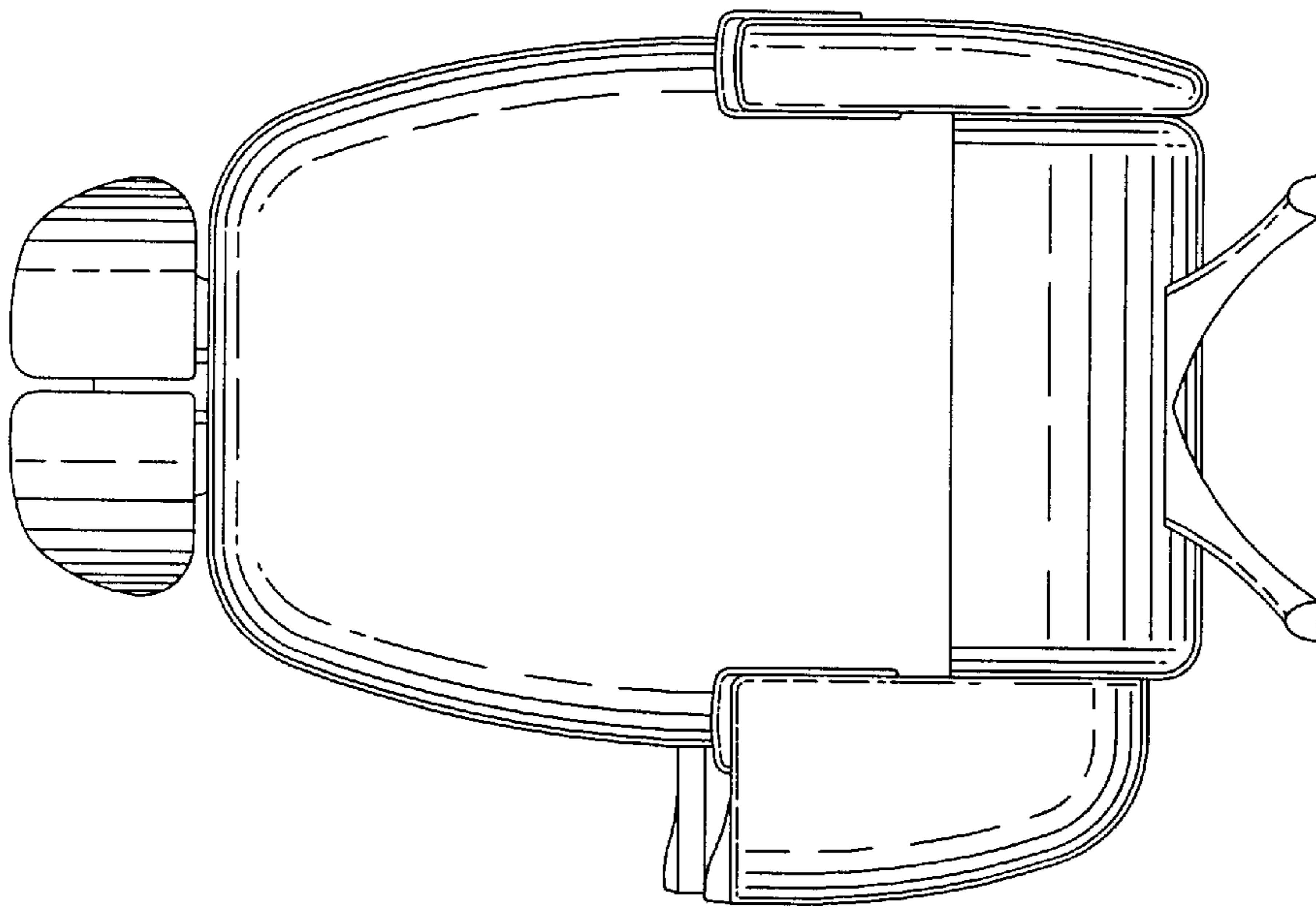

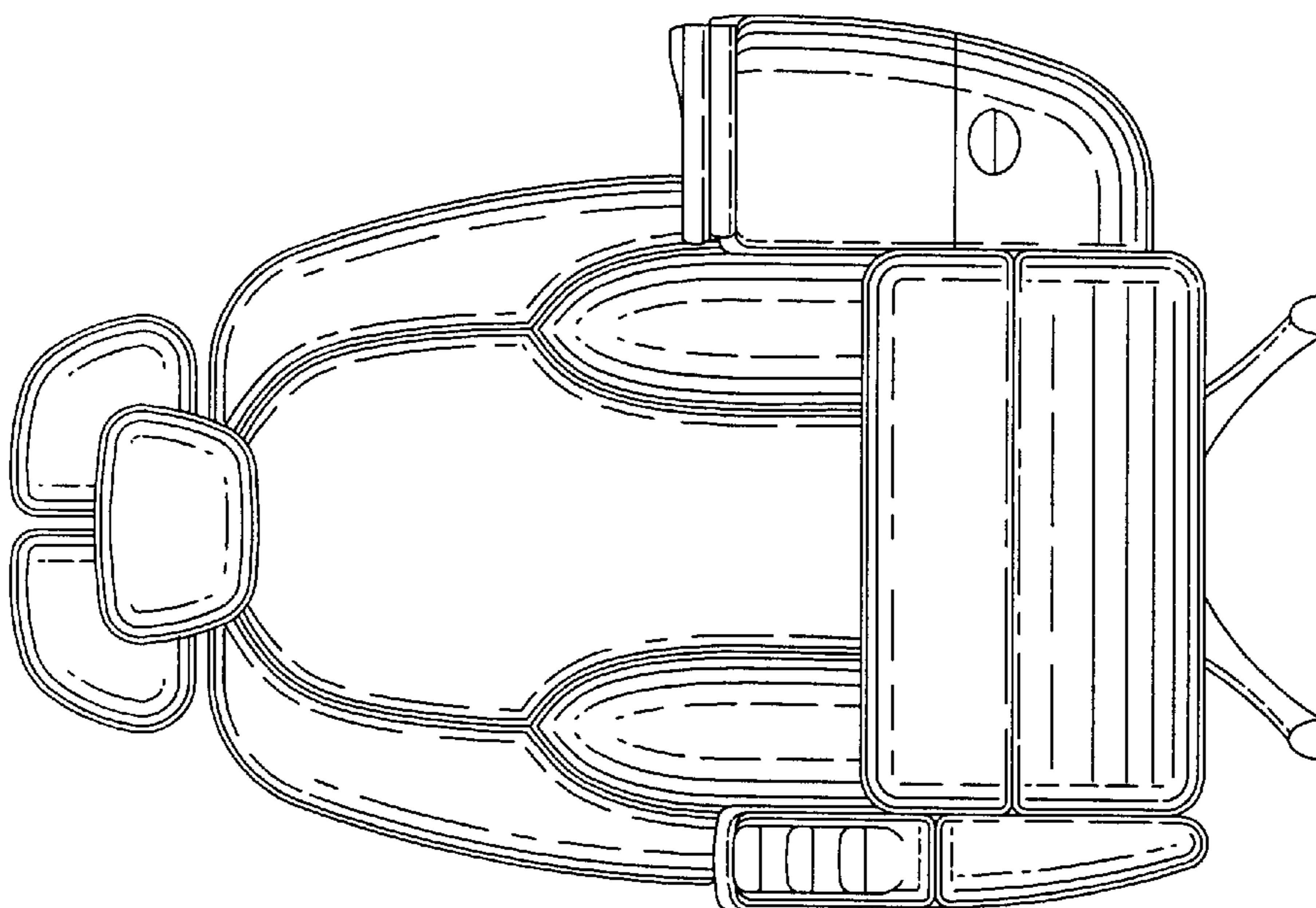

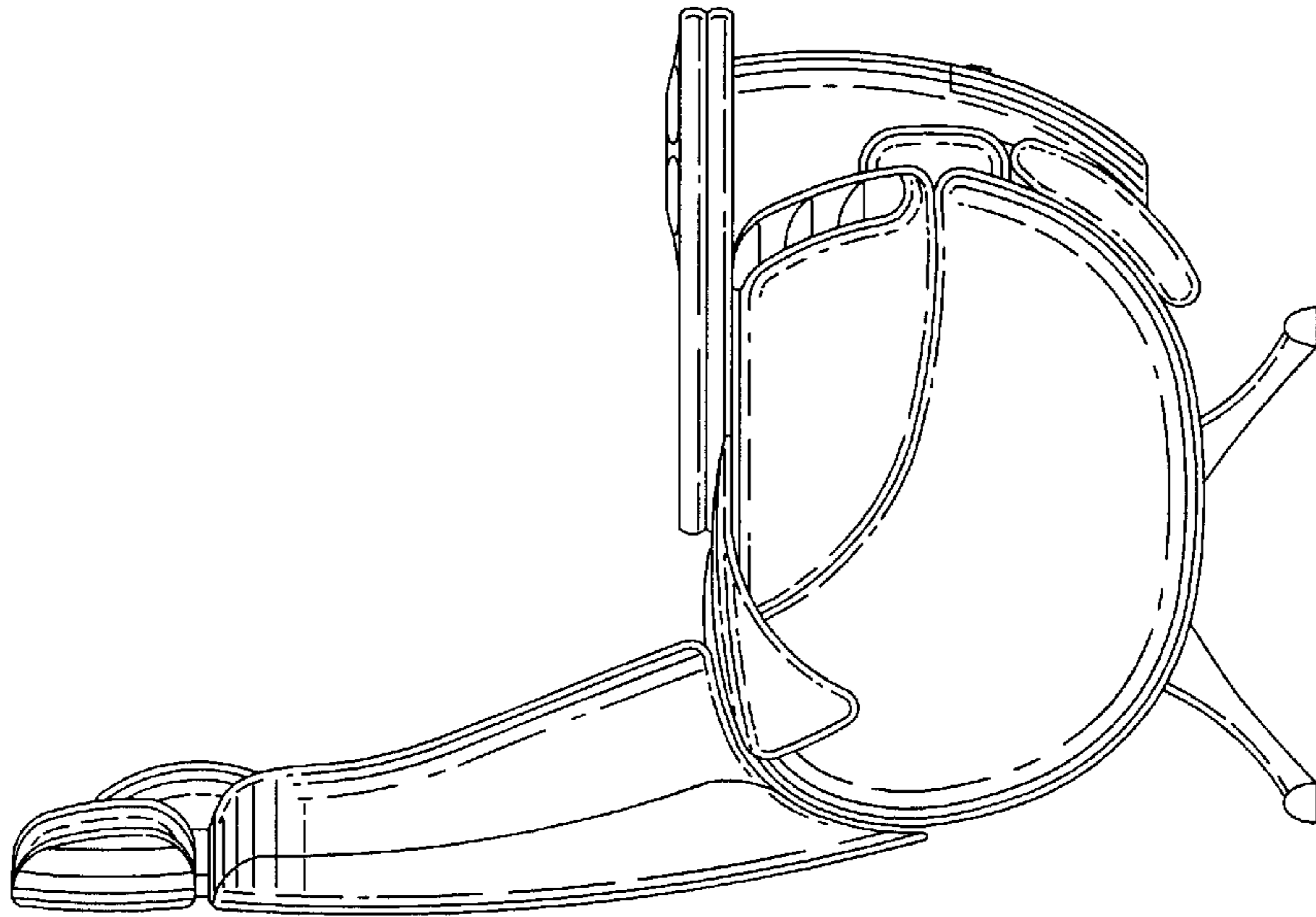

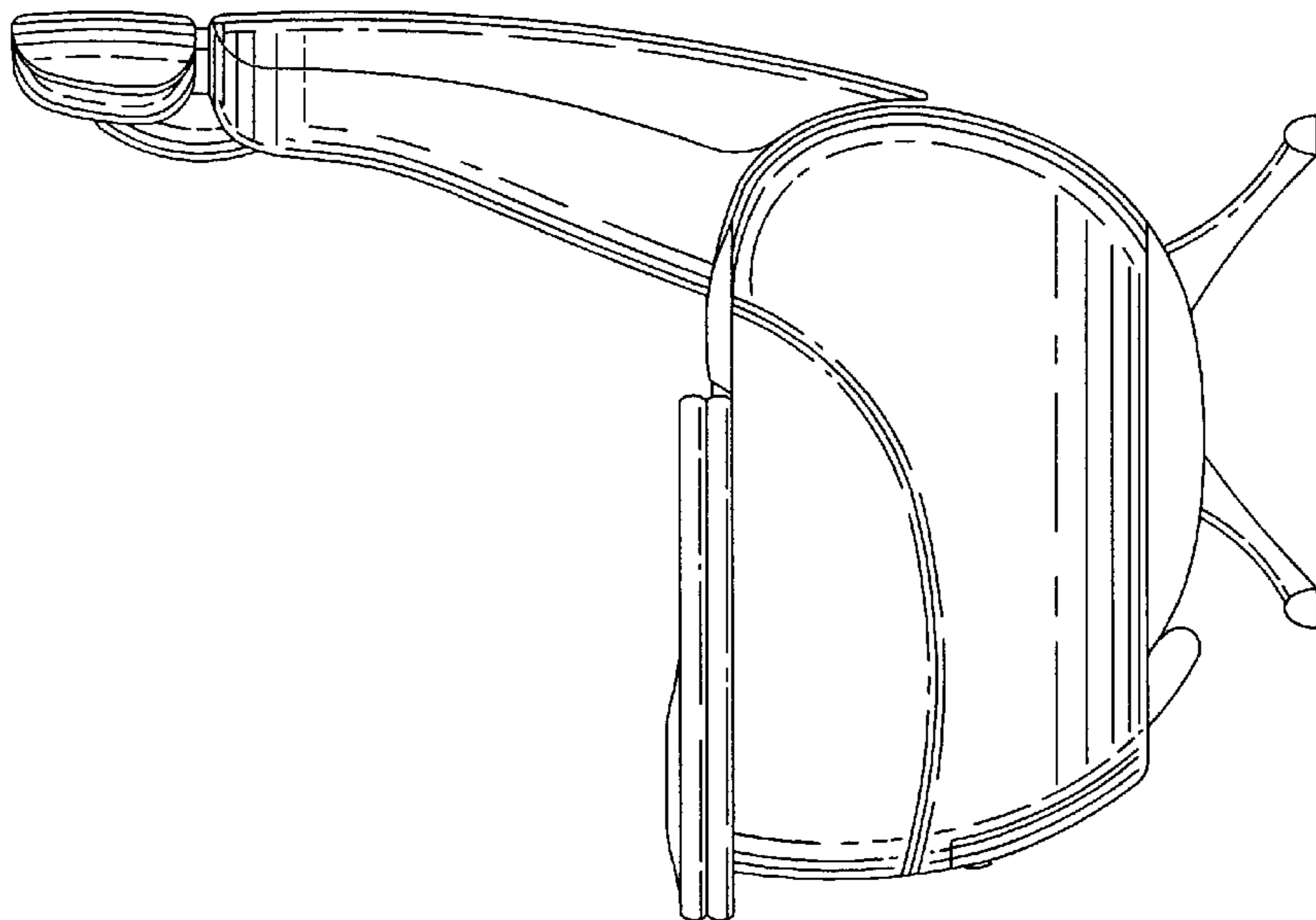

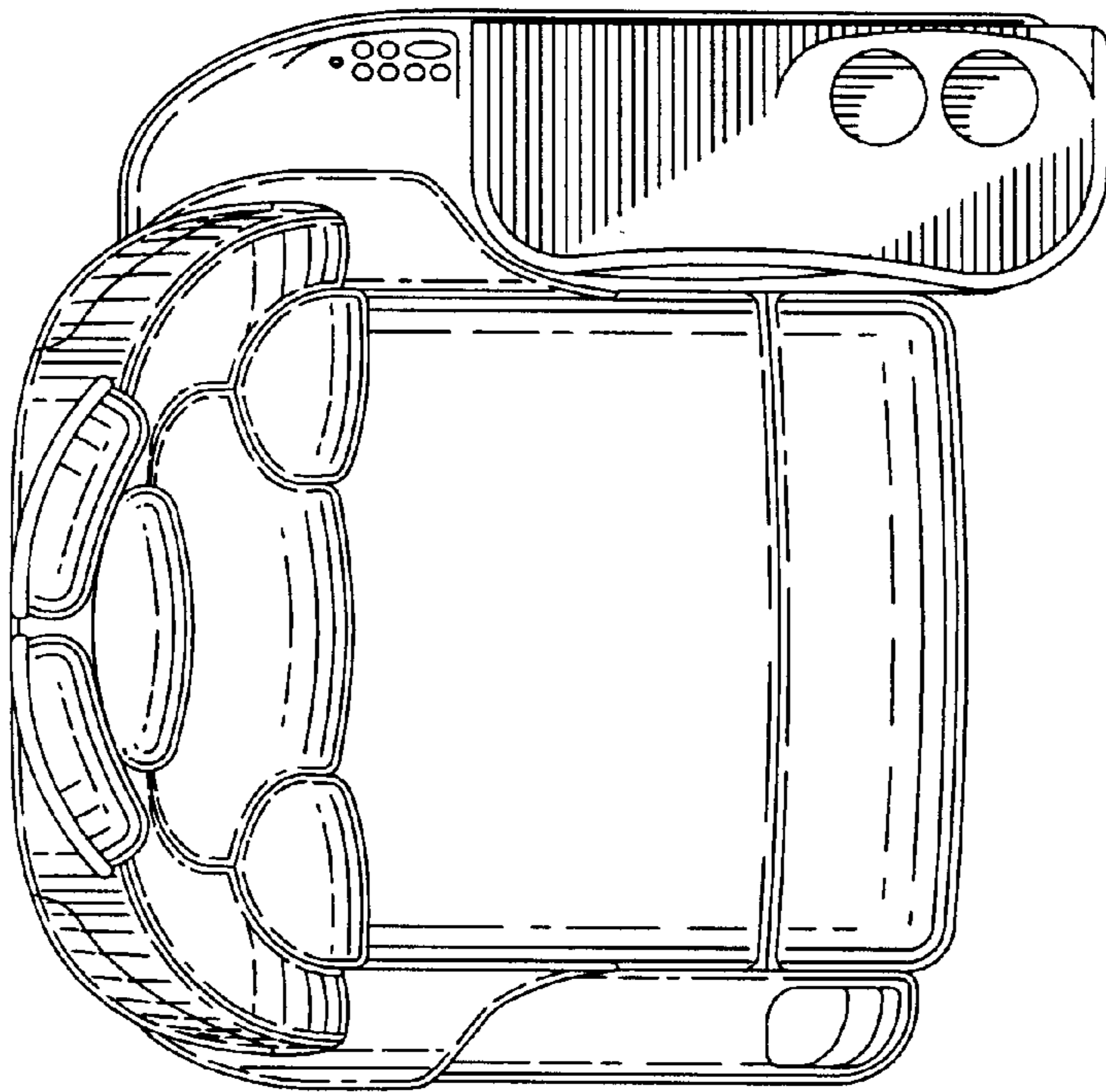
