(57) **CLAIM**

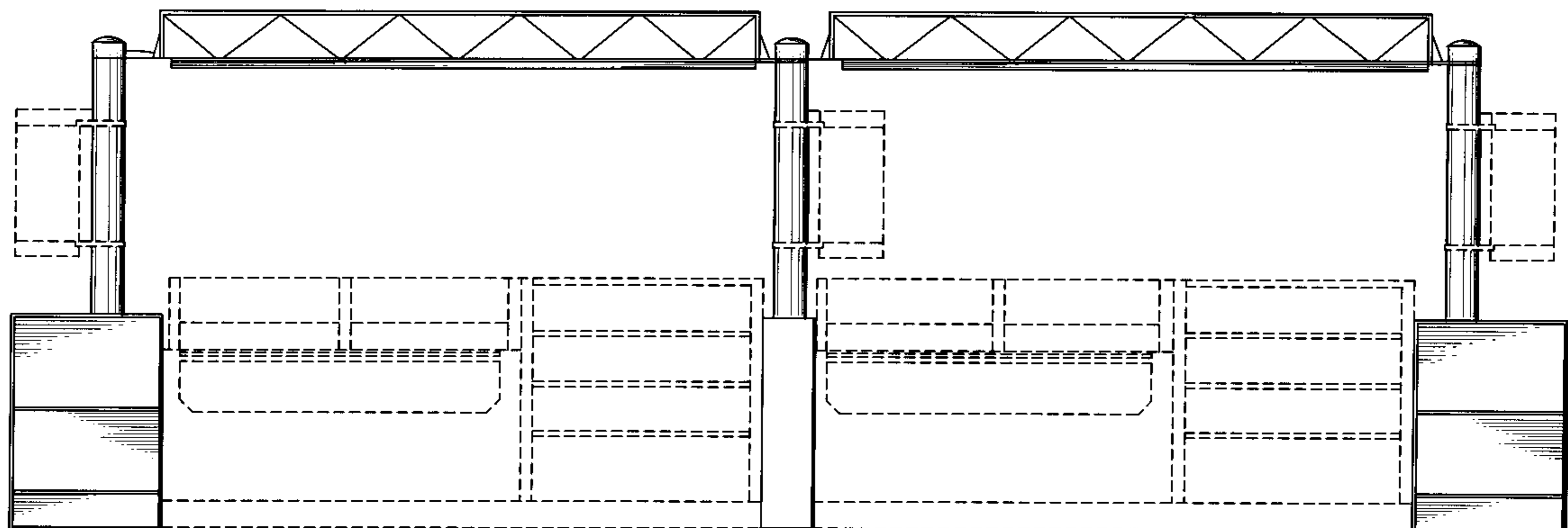
The ornamental design for a module, mounting post, and dual truss assembly for a temporary dining unit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a module, mounting post, and dual truss assembly for a temporary dining unit according to a preferred embodiment of the design; FIG. 2 is a top view of the design that is depicted in FIG. 1; FIG. 3 is a rear view of the design that is depicted in FIGS. 1 and 2; and, FIG. 4 is a side view of the design that is depicted in FIGS. 1-3.

The broken lines are shown in the views for illustrative purposes only and form no part of the claimed design.

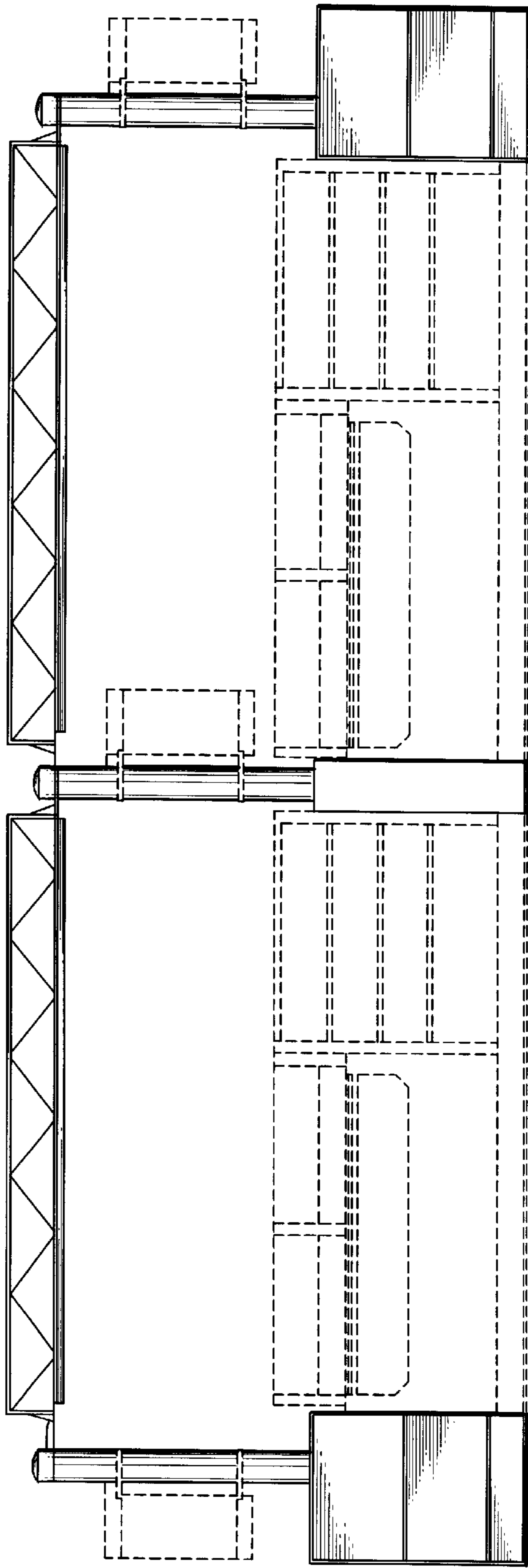

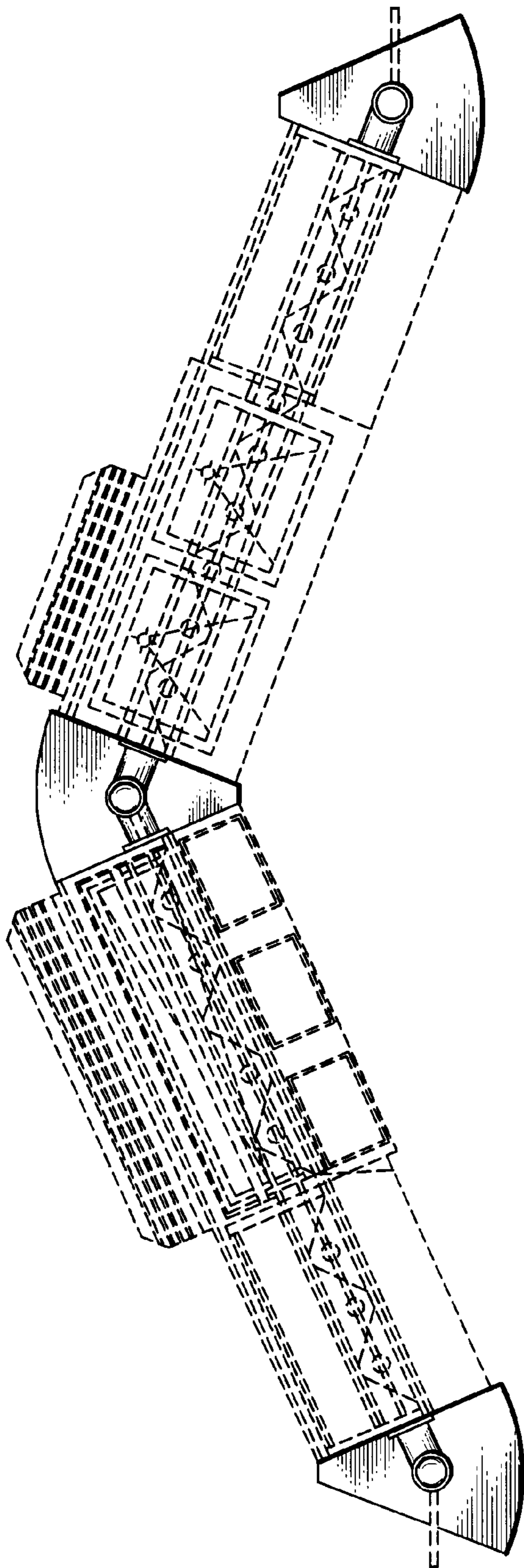

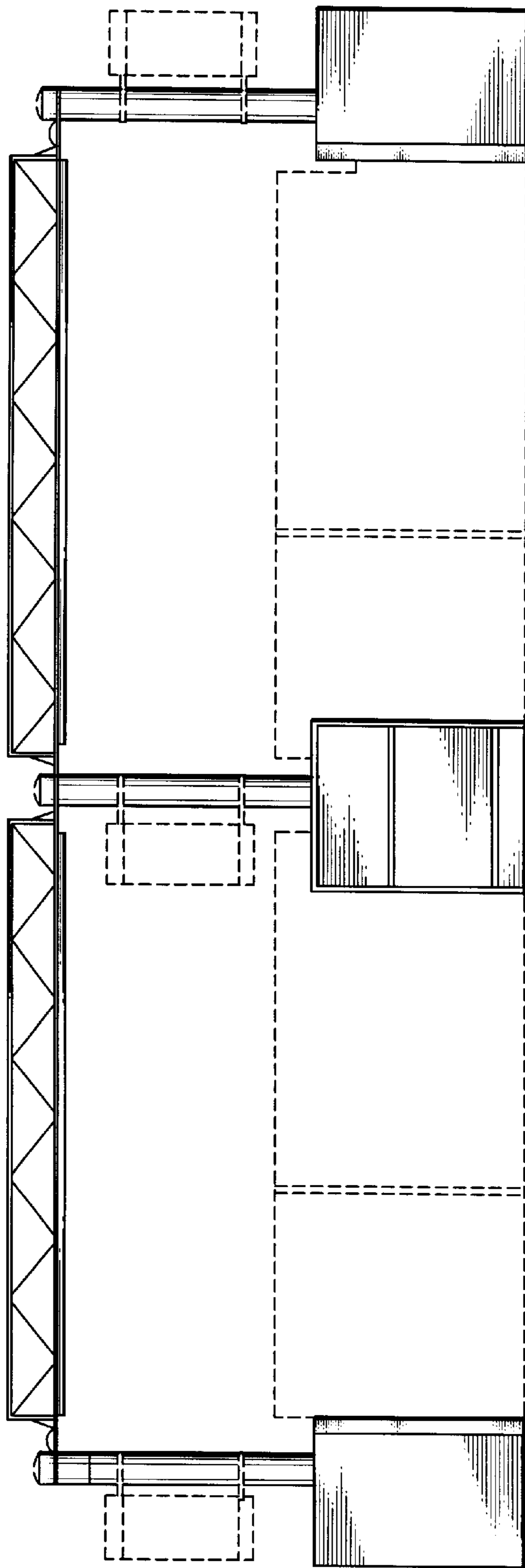

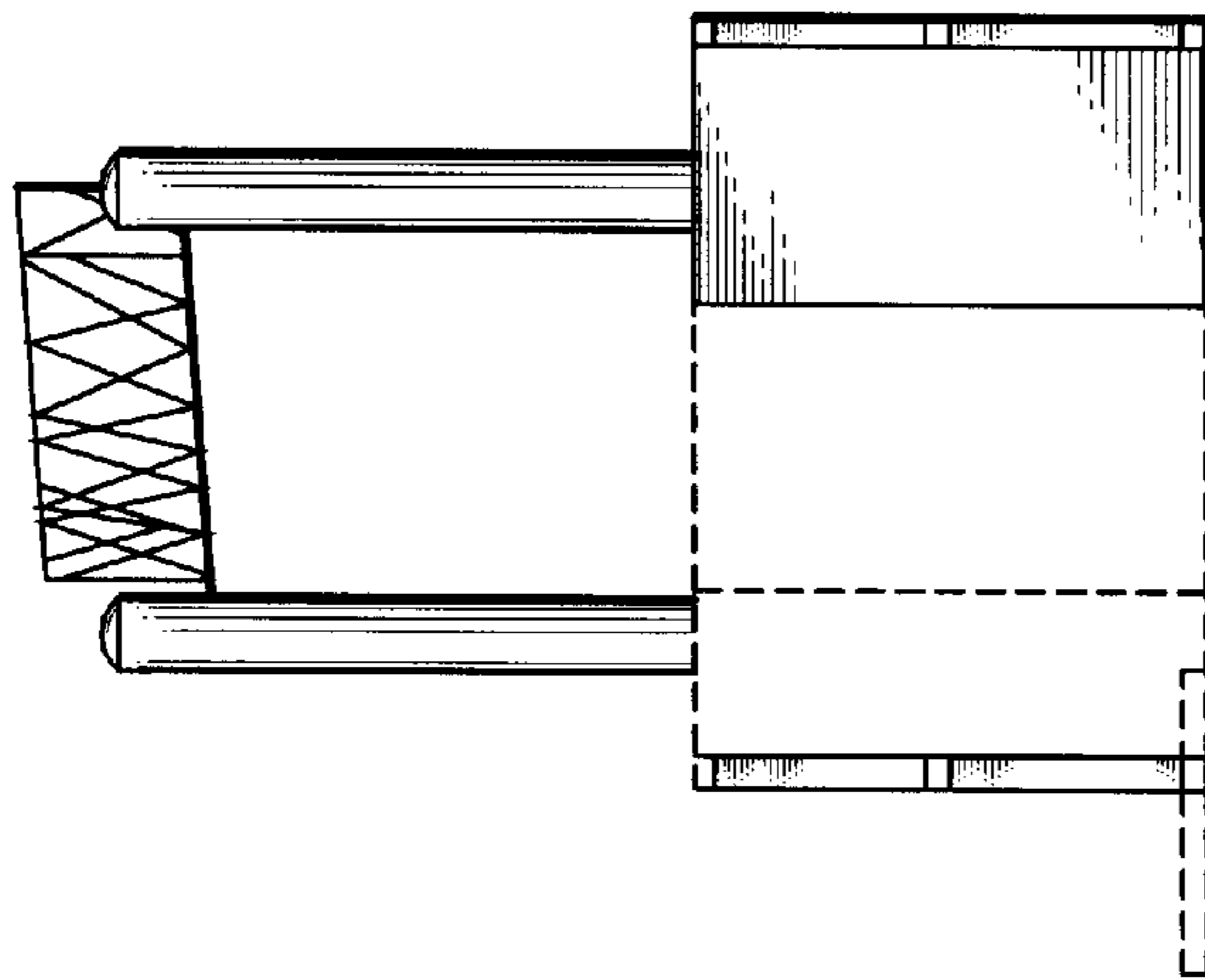
