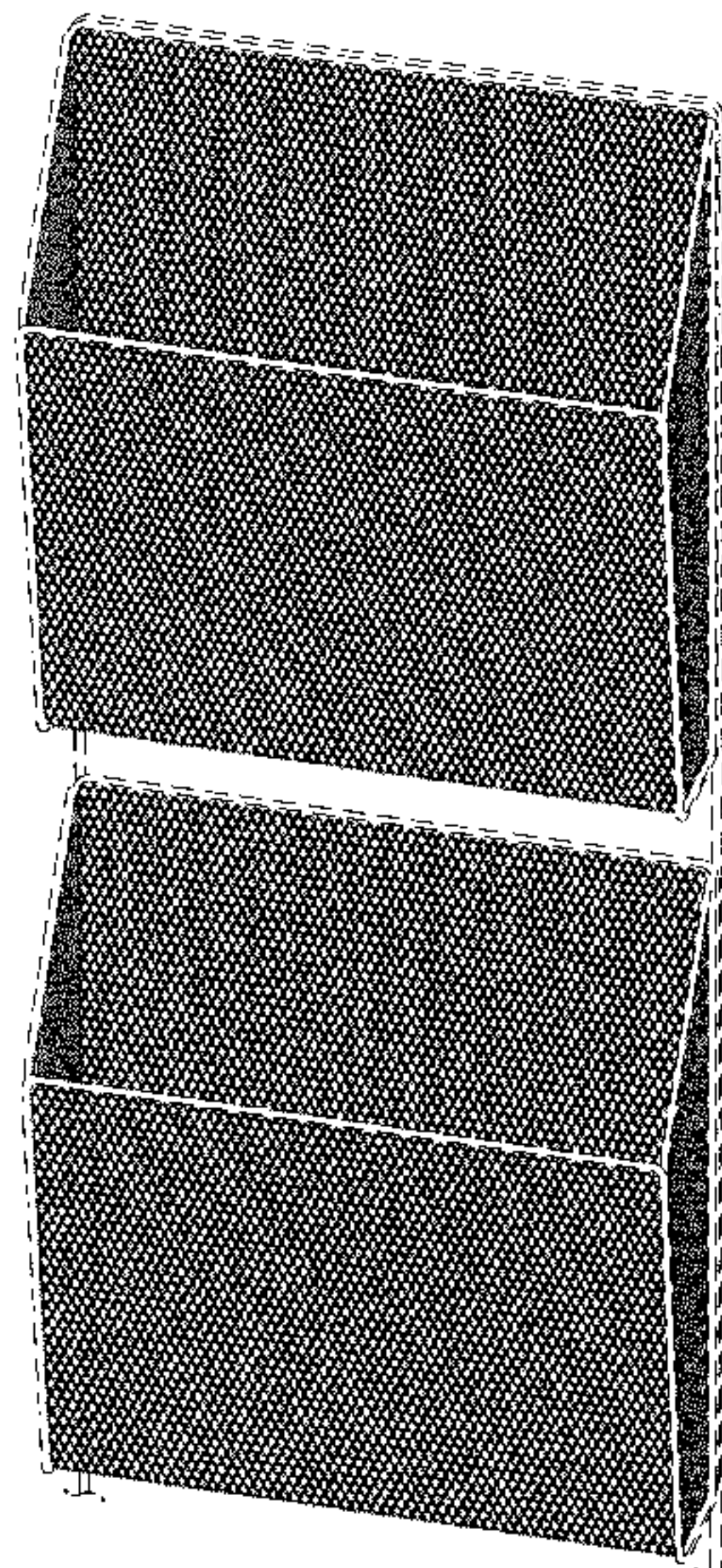
FIG. 1 is a perspective view of a first embodiment of a mesh wall rack showing our new design;

FIG. 6 is a bottom view thereof;
FIG. 7 is a front view of a second embodiment of a mesh wall rack showing our new design;
FIG. 8 is a right side view thereof, the left side view being a mirror image; and,
FIG. 9 is an enlarged, fragmentary view of an exemplary wire mesh used in the foregoing embodiments of FIGS. 1-8. The broken lines shown in the drawings form no part of the claimed design. The wavy broken lines at the terminal end of each embodiment also form no part of the claimed design. The mesh material that may be visible through the holes in the mesh has been removed for clarity.

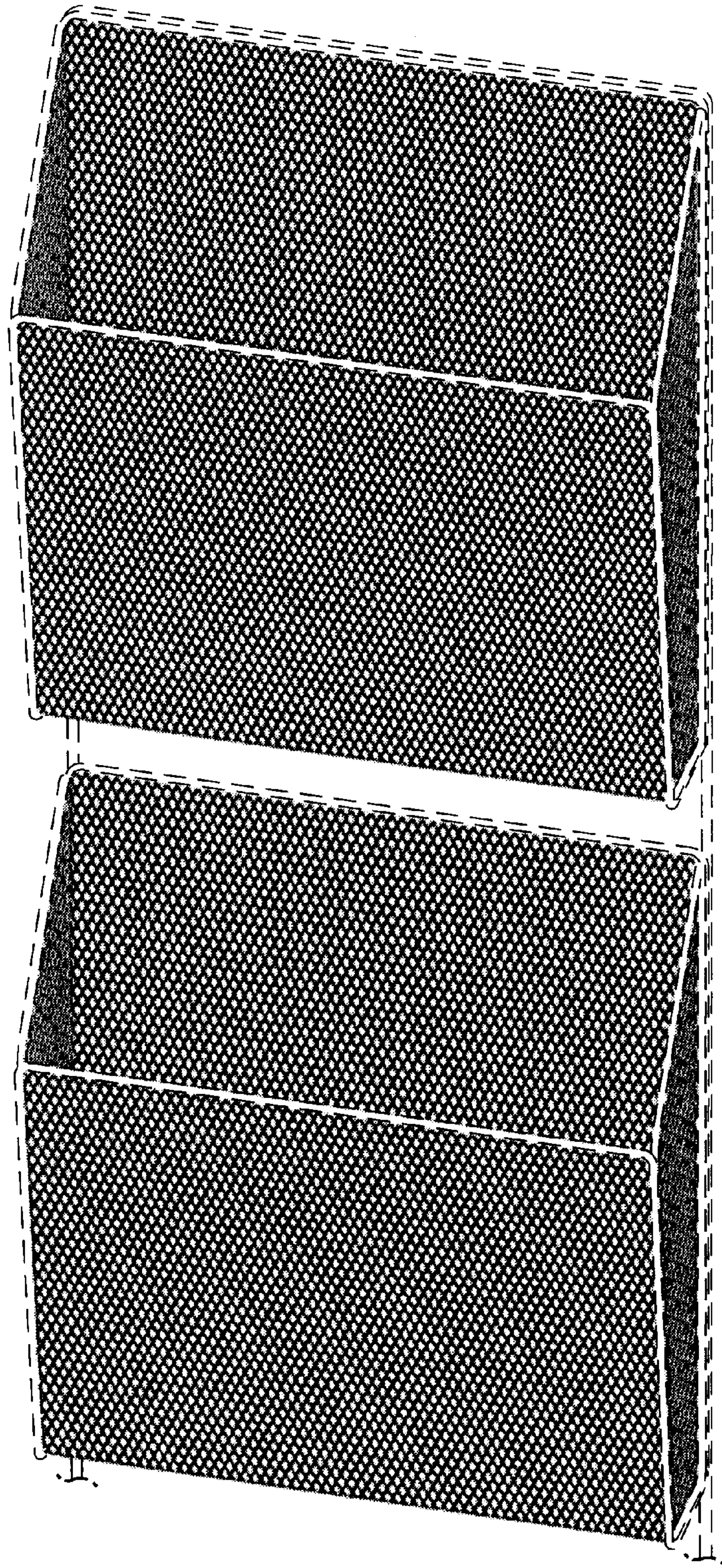

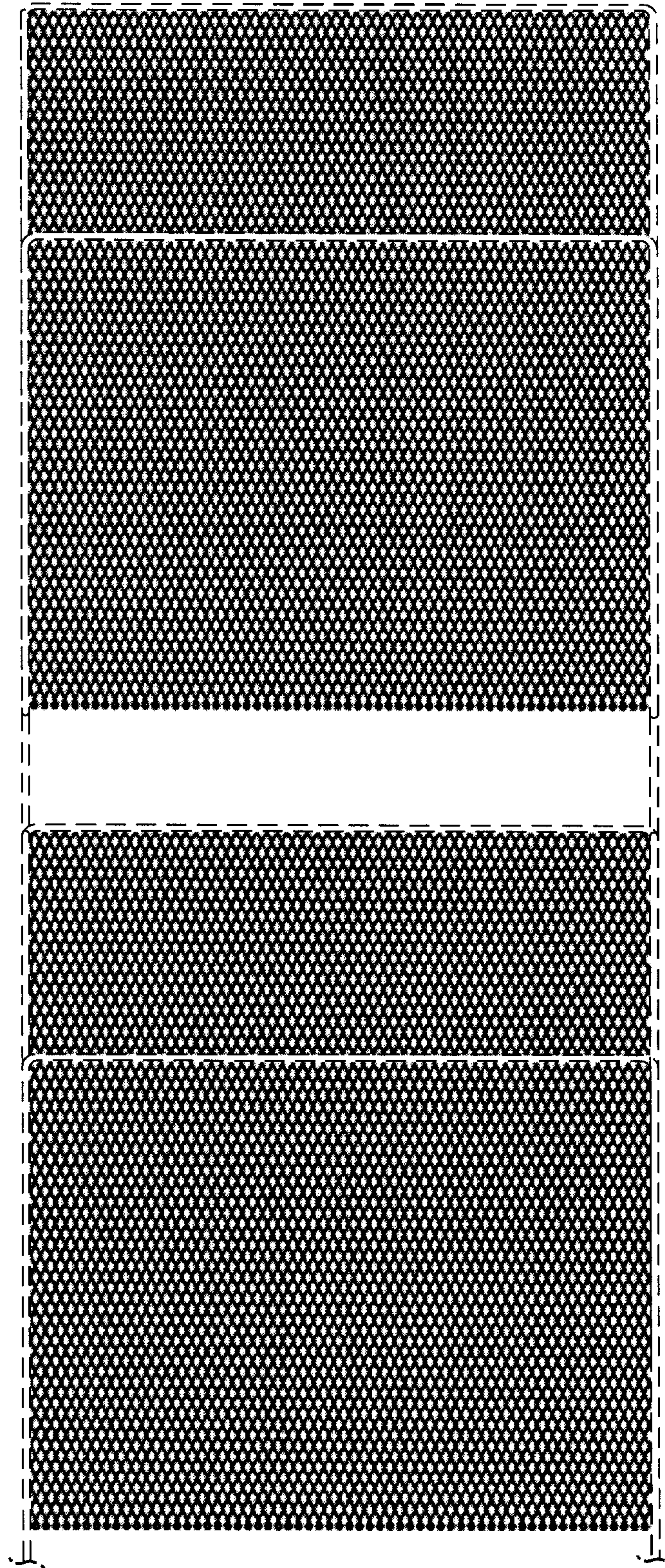

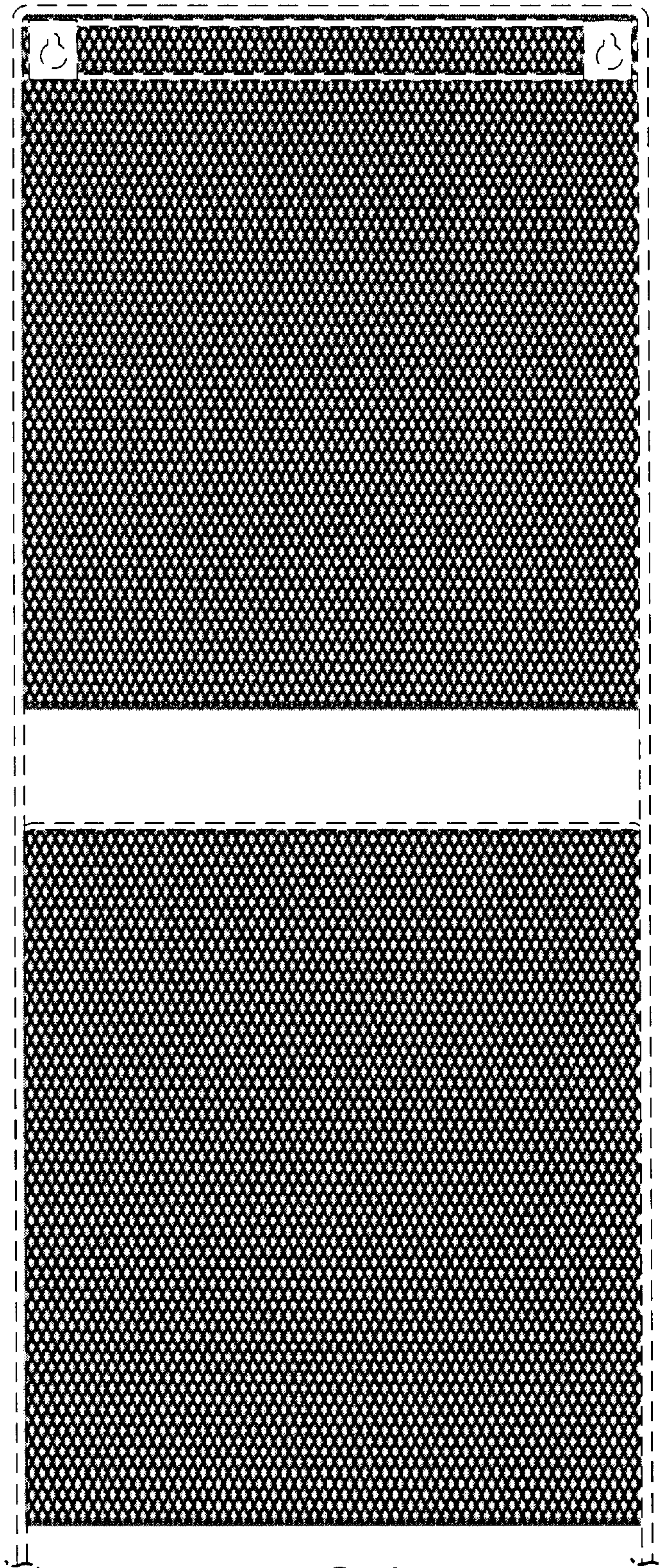

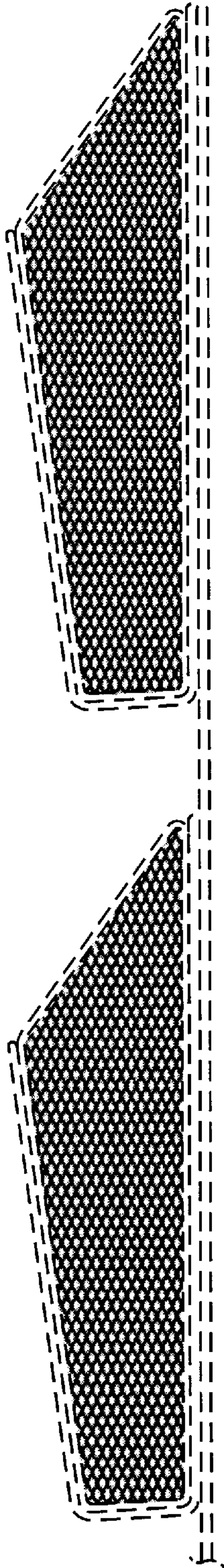

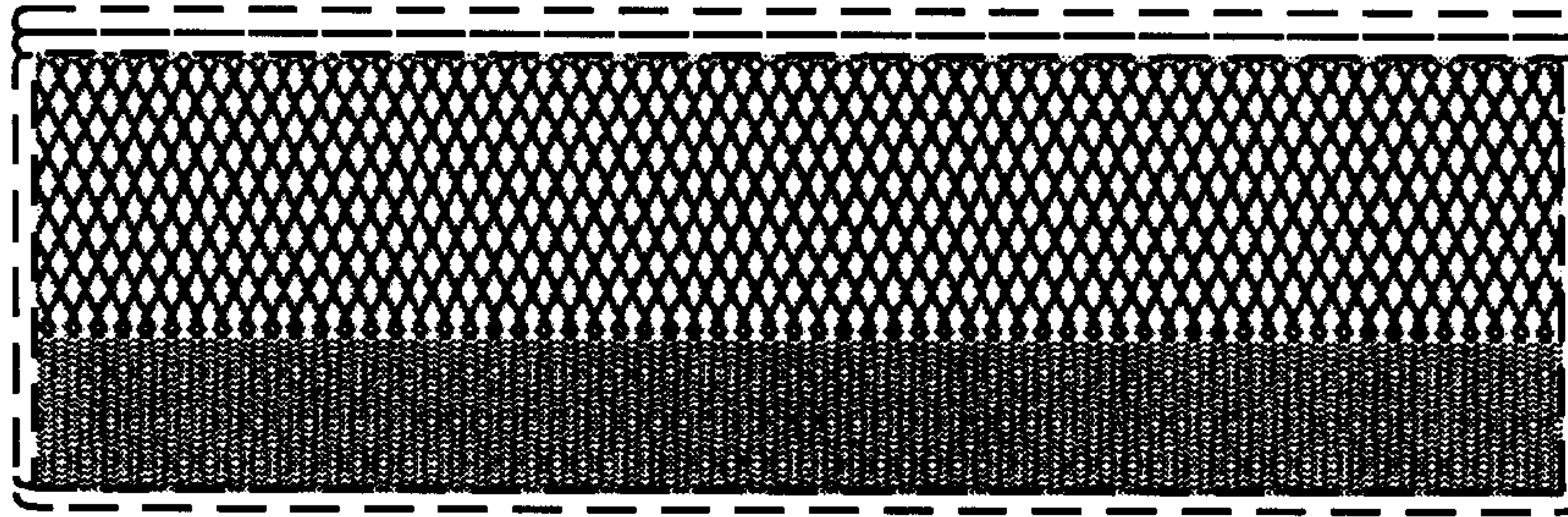

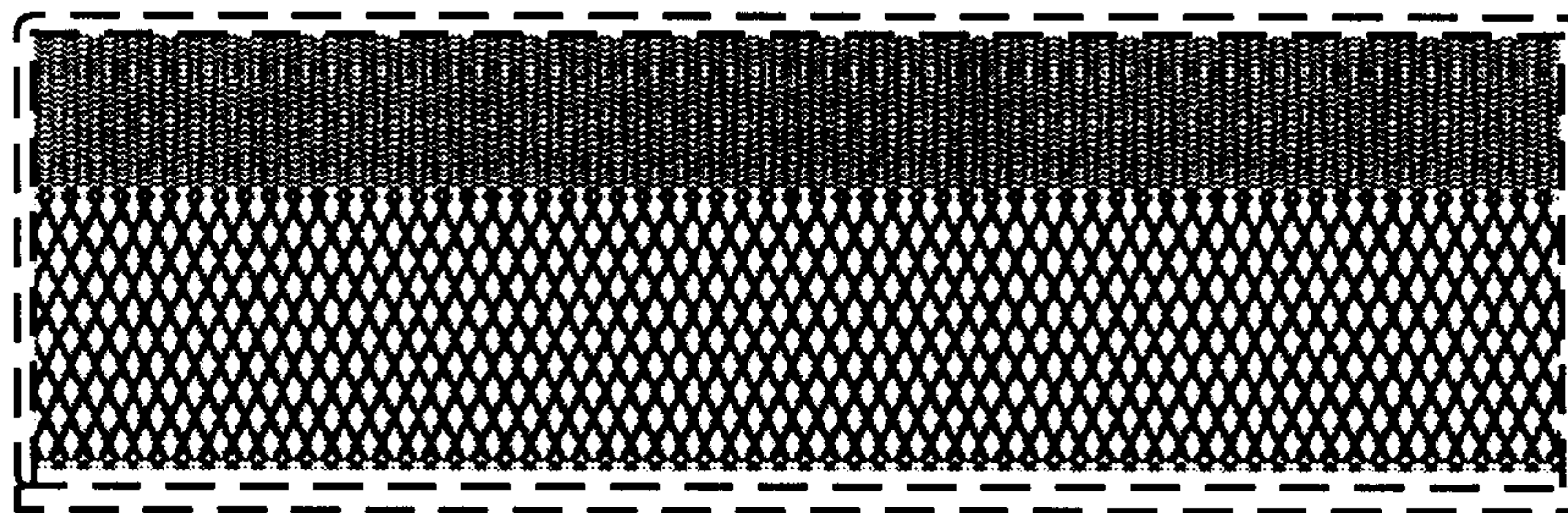

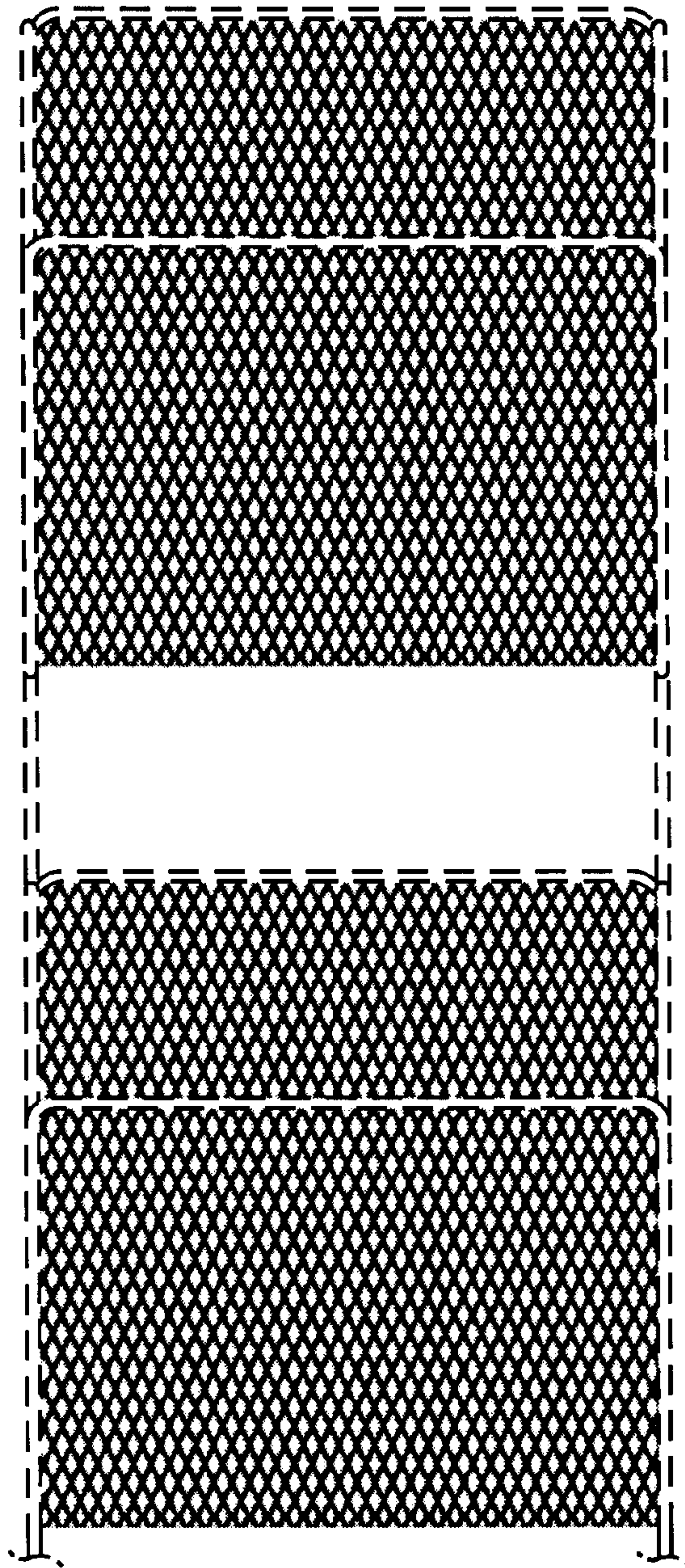

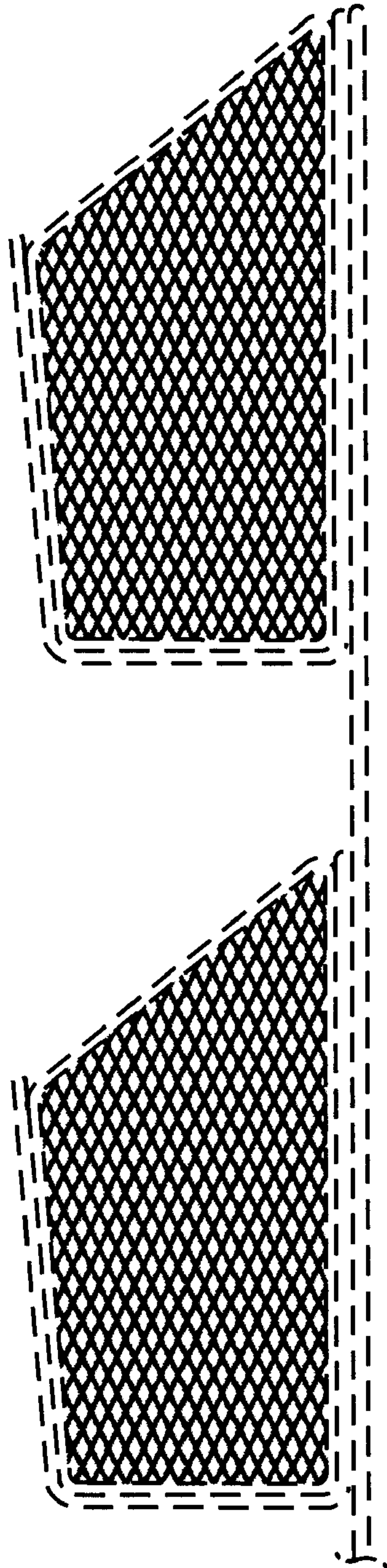

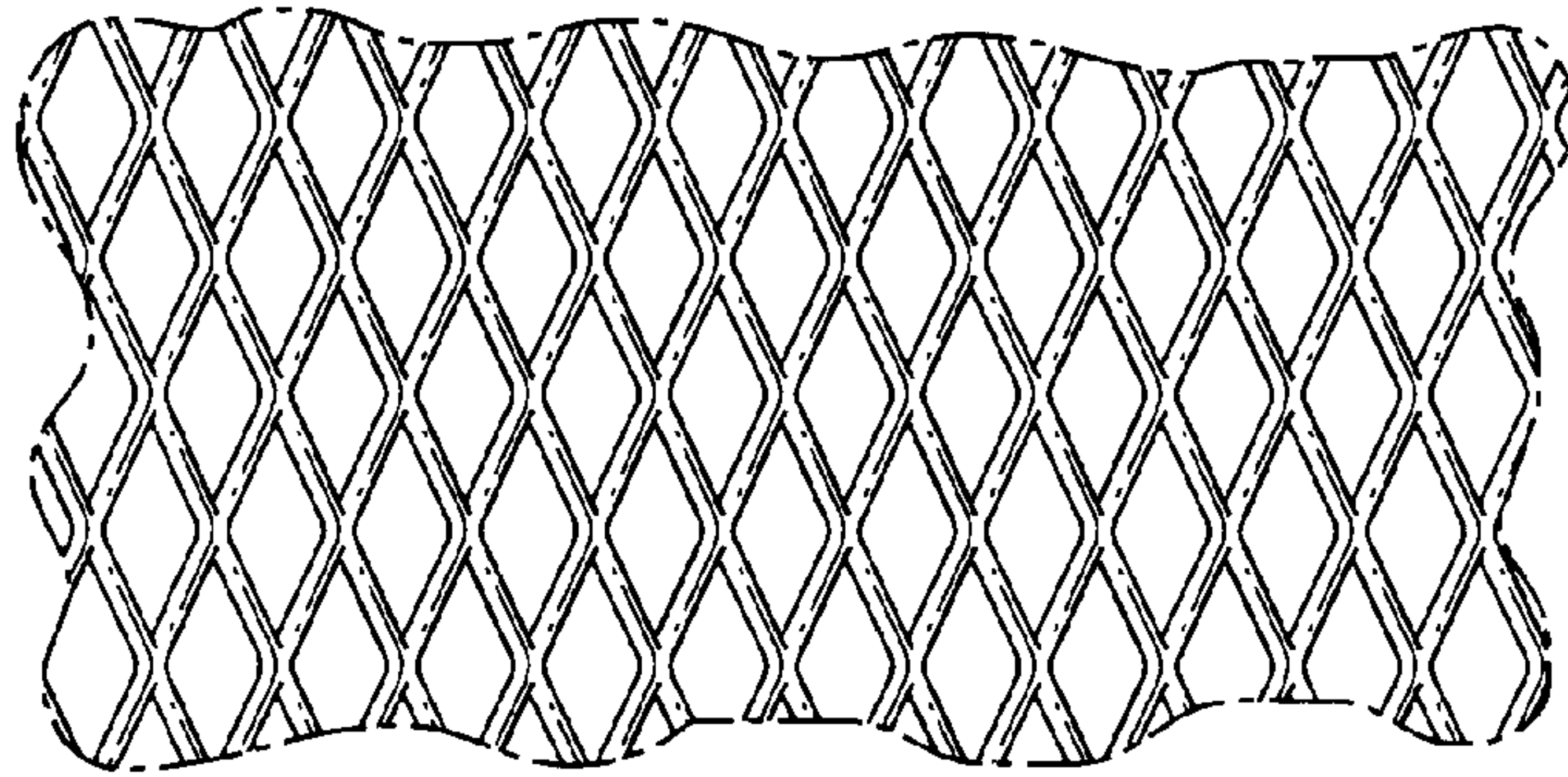
