The ornamental design for a self service kiosk, as shown and described.

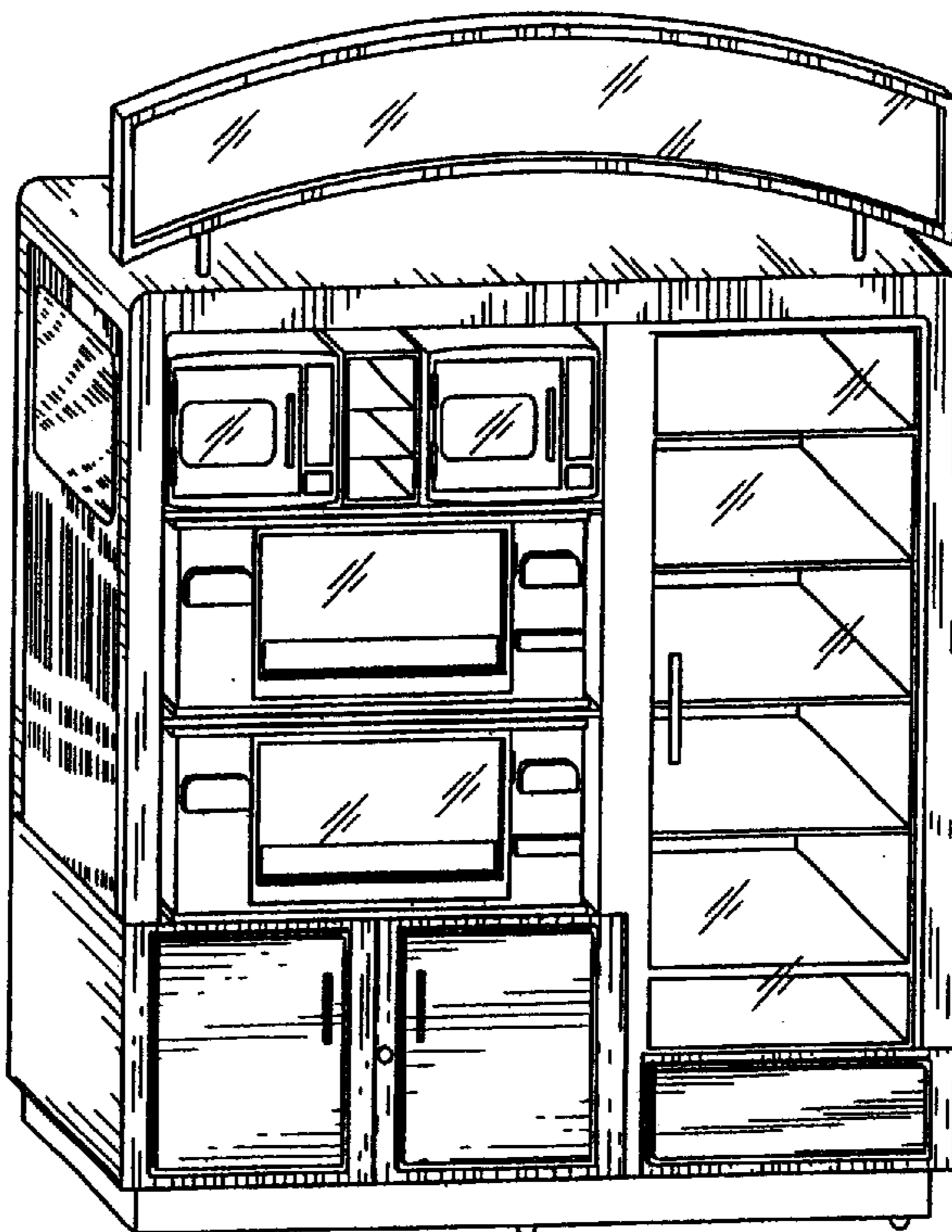
**DESCRIPTION**

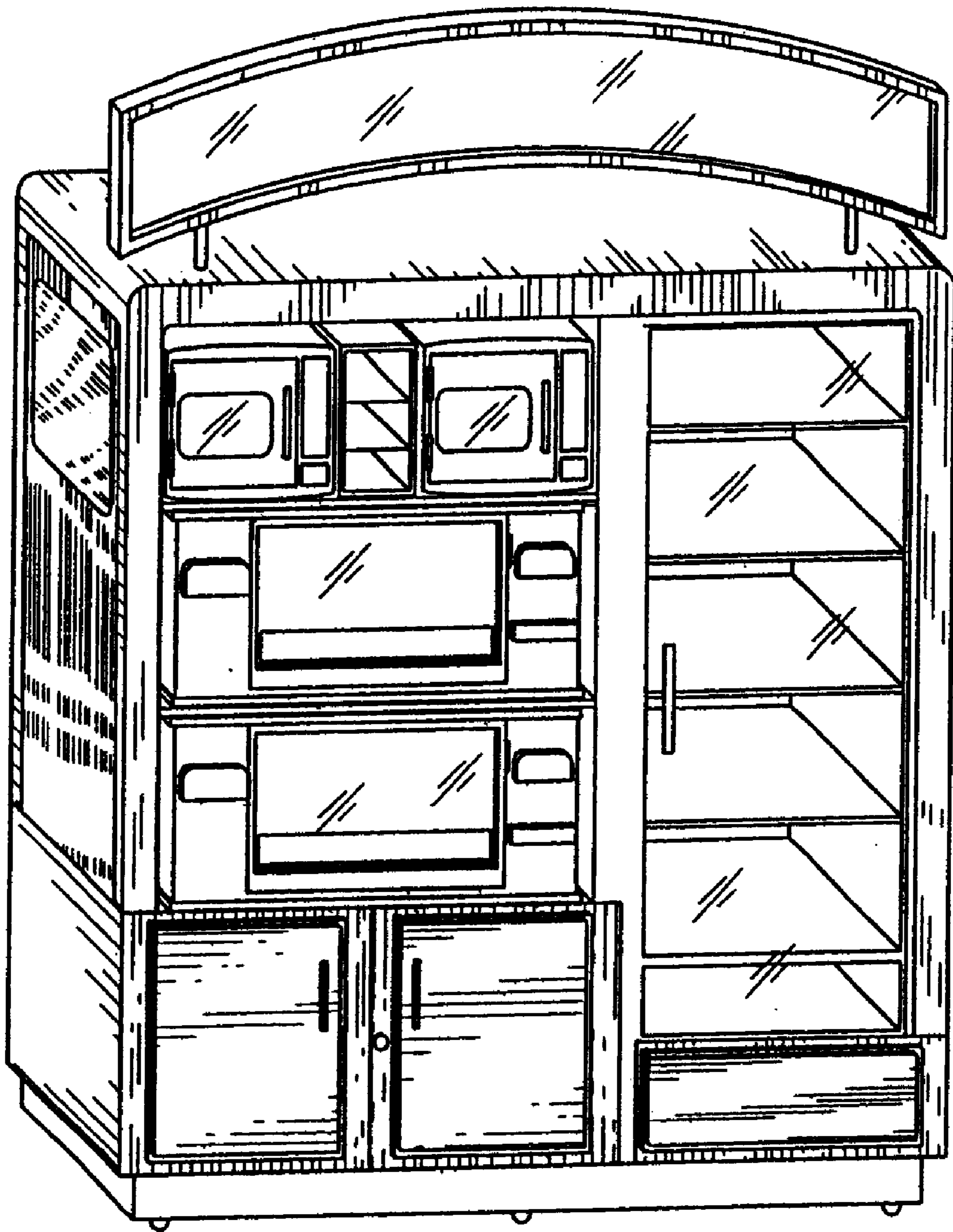
FIG. 1 is a front perspective view of the self service kiosk showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a side elevational view, with the opposite side being a mirror image thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof; and,  
FIG. 6 is a front perspective view of an alternate embodiment, with the side, top and bottom views being identical to those shown in FIGS. 3-5.

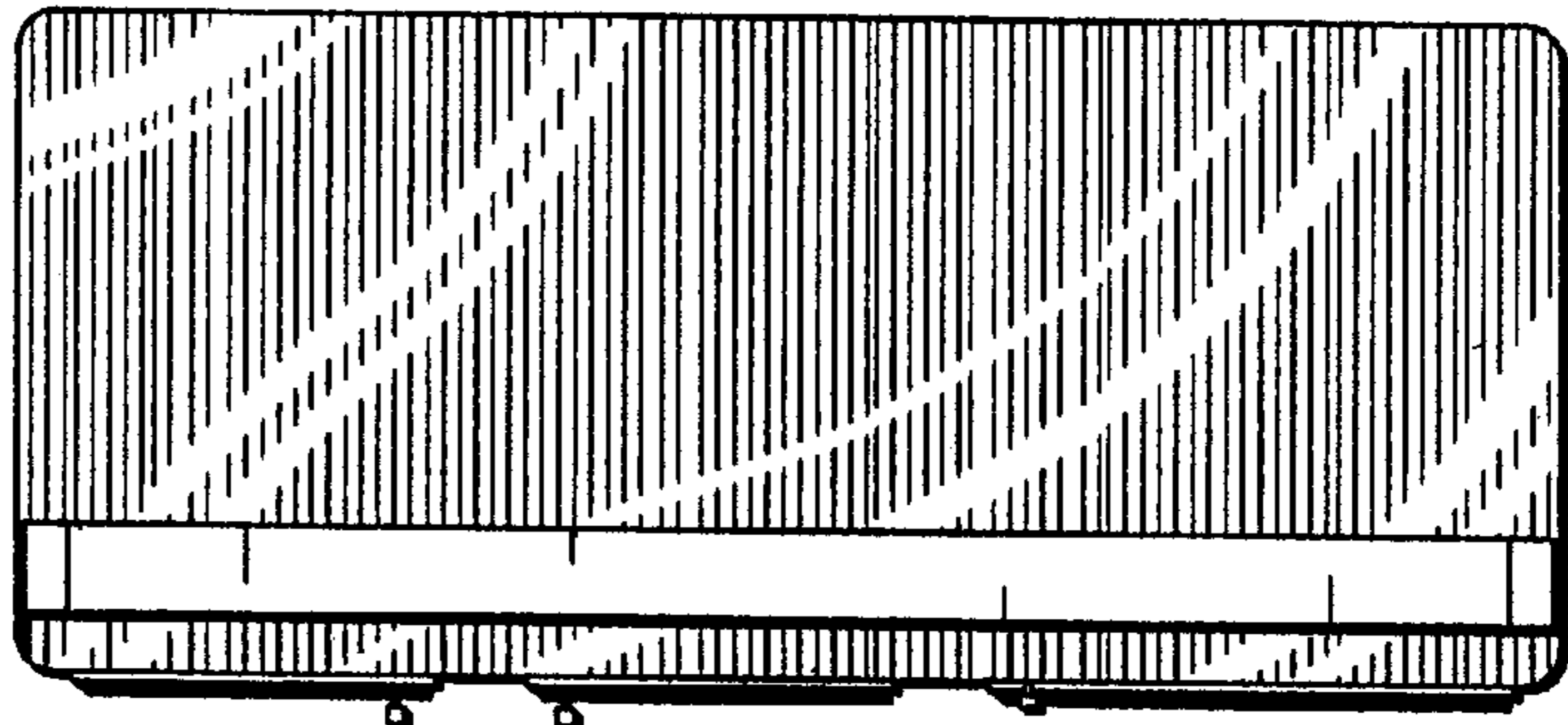

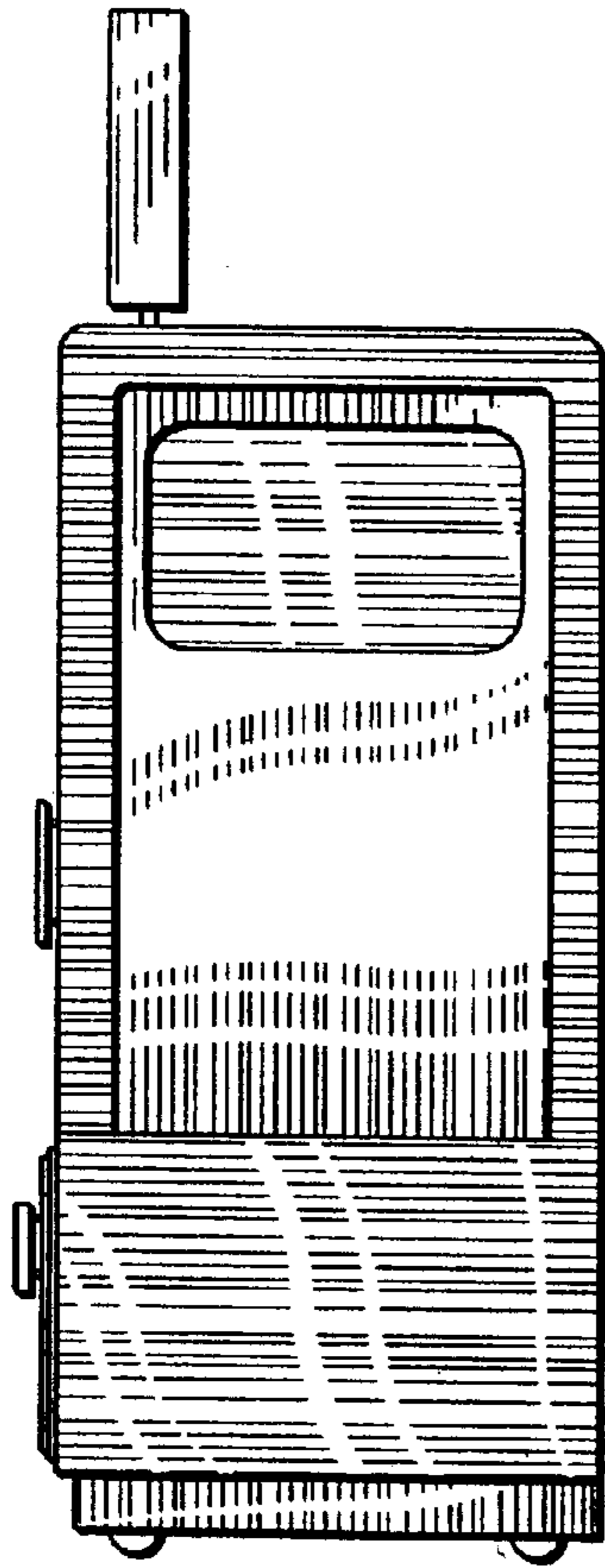

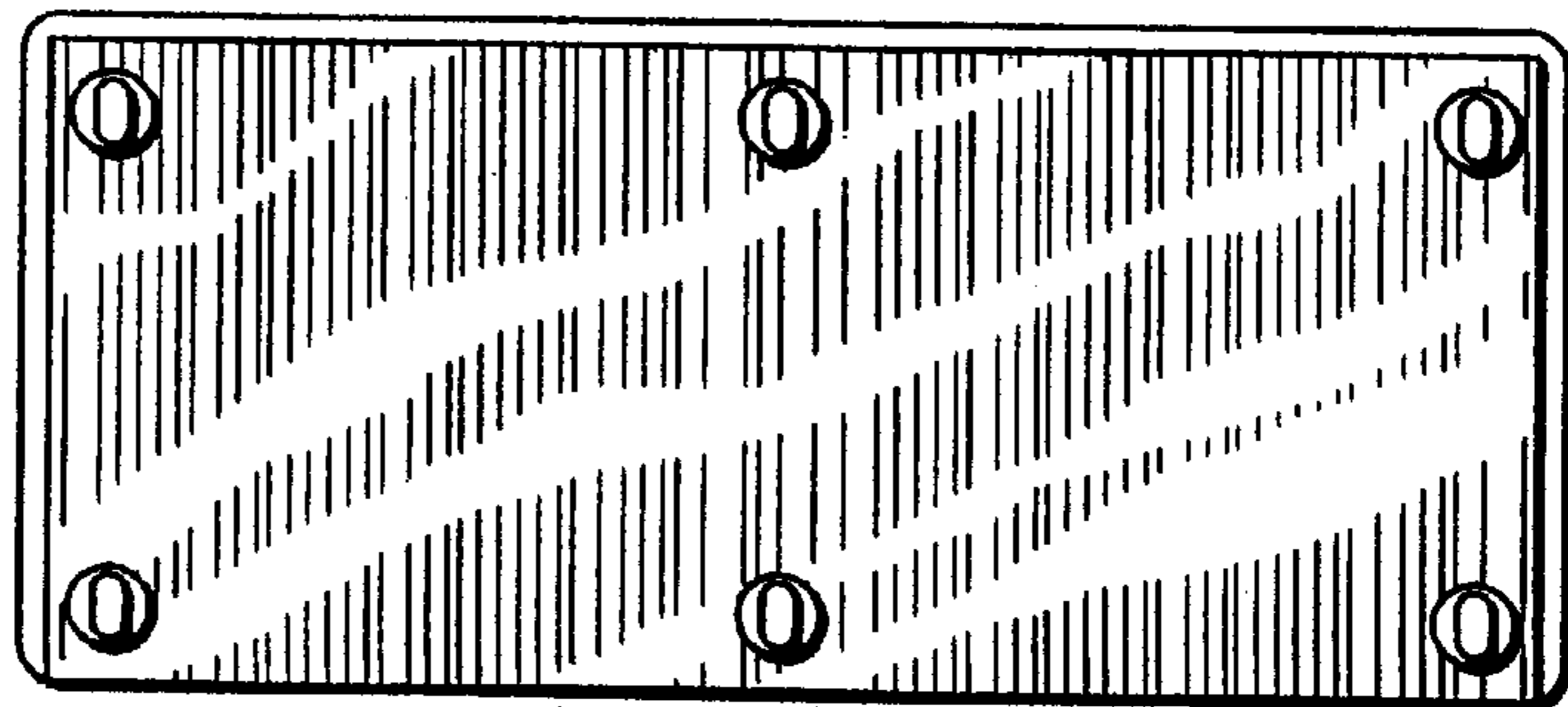

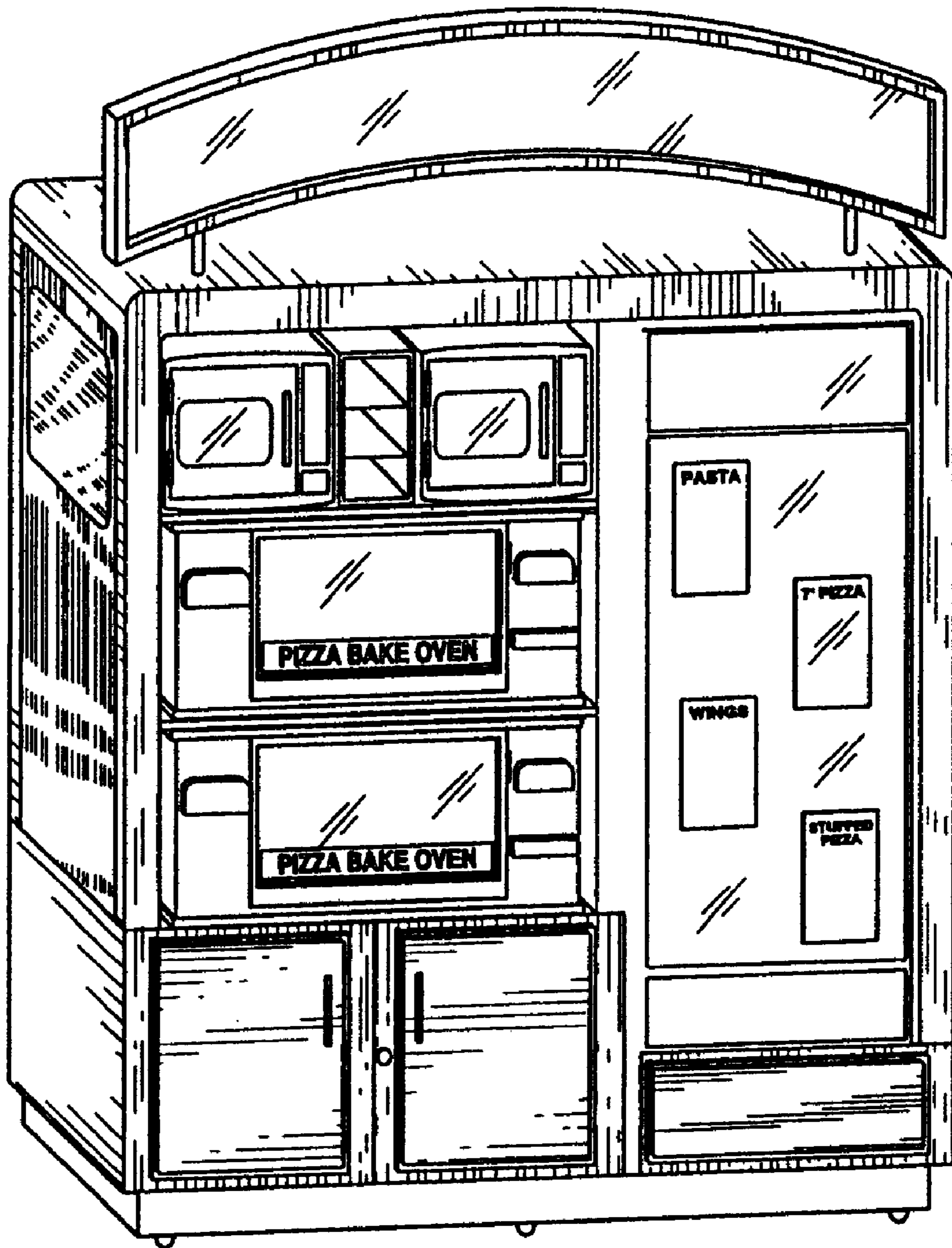
