(57) **CLAIM**

The ornamental design for a patio table planter and planter base, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded perspective view of the patio table planter and planter base.

FIG. 2 is a side view of the patio table planter and planter base.

FIG. 3 is a top view of the patio table planter and planter base, wherein only the top of the patio table planter may be seen.

FIG. 4 is a bottom view of the patio table planter and planter base, wherein only the bottom of the planter base may be seen.

FIG. 5 is a cross sectional view of the patio table planter and planter base taken along lines 5—5 of FIG. 3.

FIG. 6 is a side view of the patio table planter shown separately for ease of illustration.

FIG. 7 is a bottom view of FIG. 6.

FIG. 8 is a side view of the planter base shown separately for ease of illustration; and,

FIG. 9 is a top view of FIG. 8.
