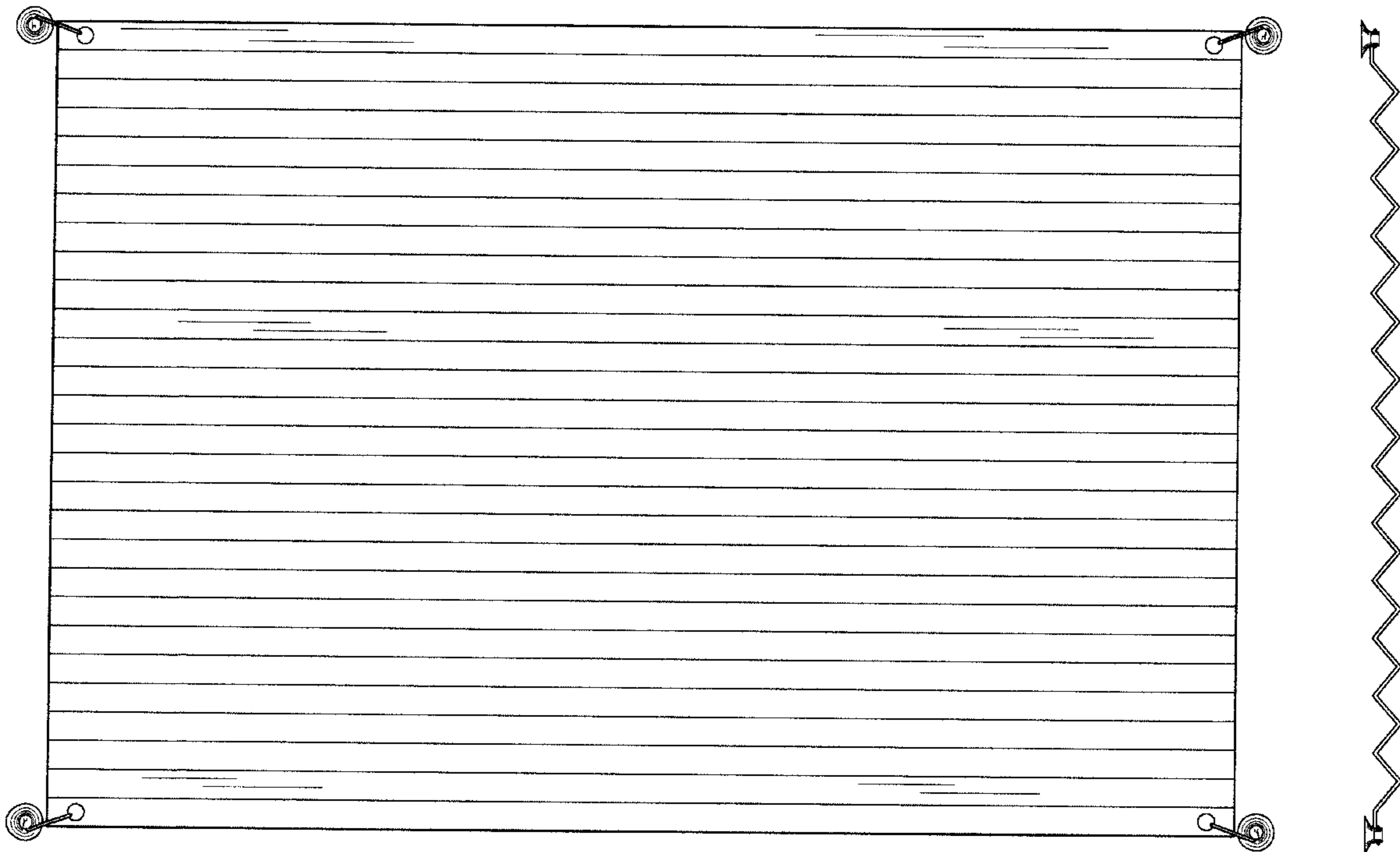
(57) **CLAIM**

The ornamental design for a front vehicle window shade, as shown and described.

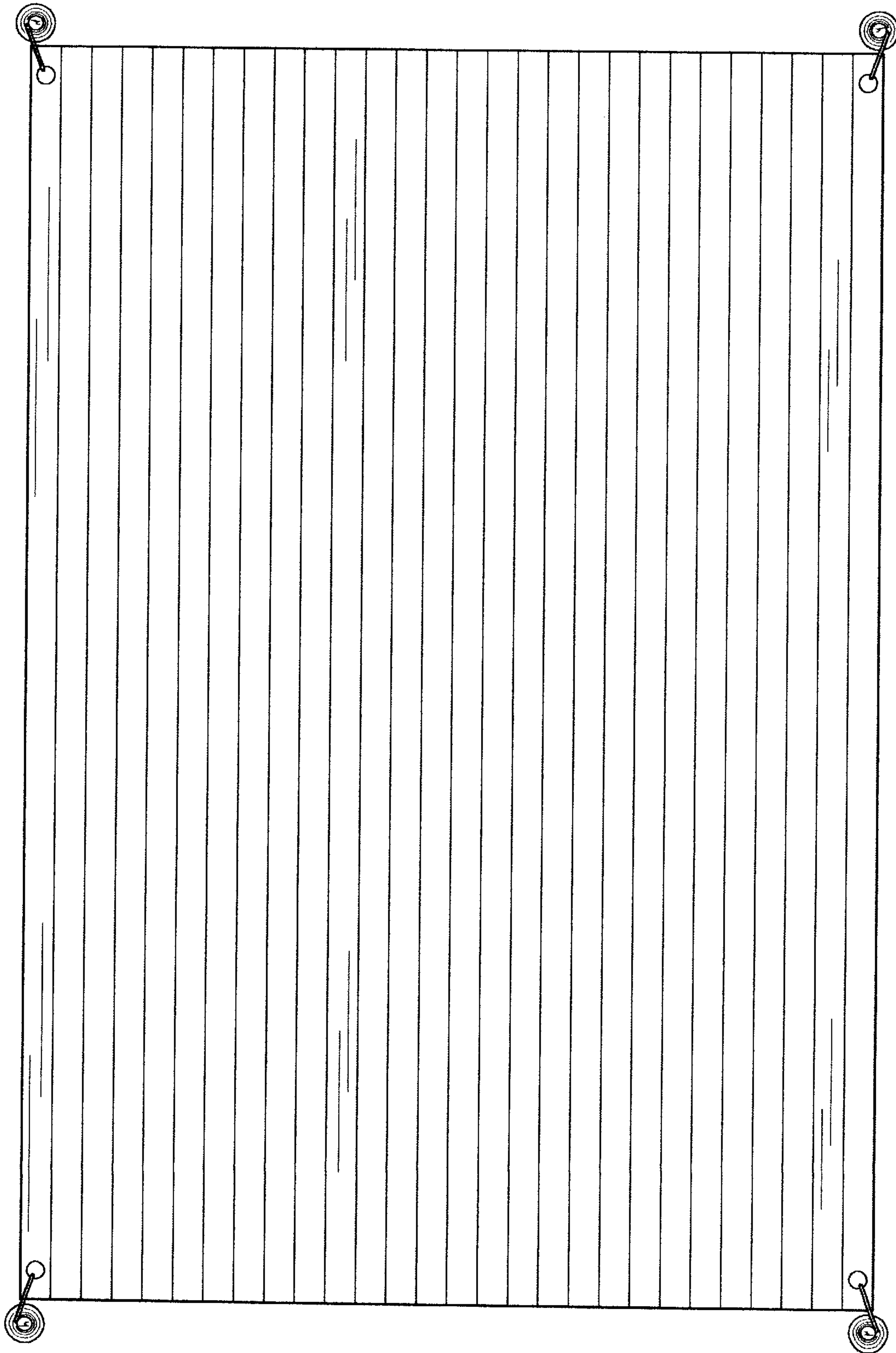

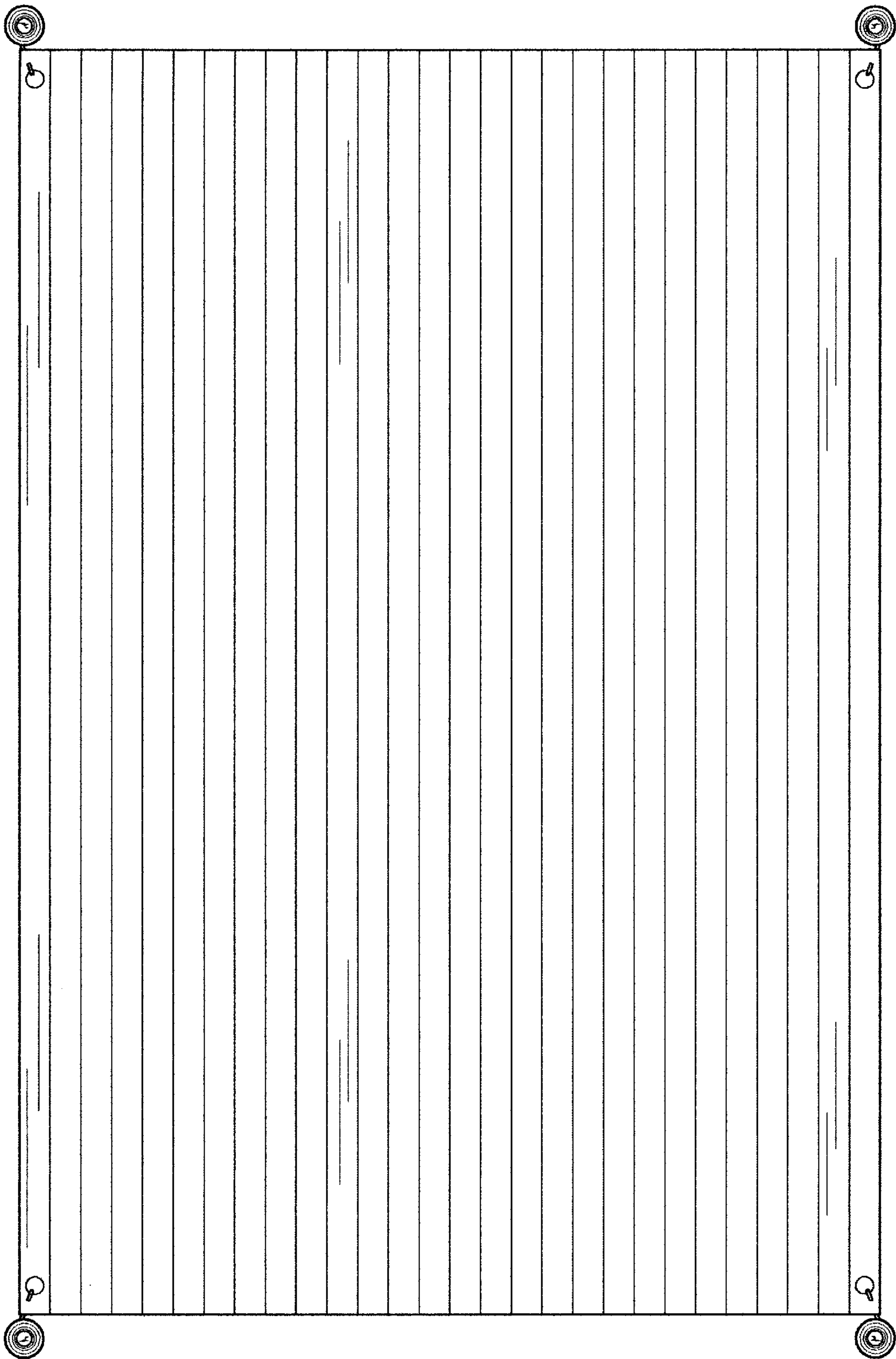
