FIG. 3 is a left side view of the surface configuration of an exhaust pipe for a vehicle according to my novel design;

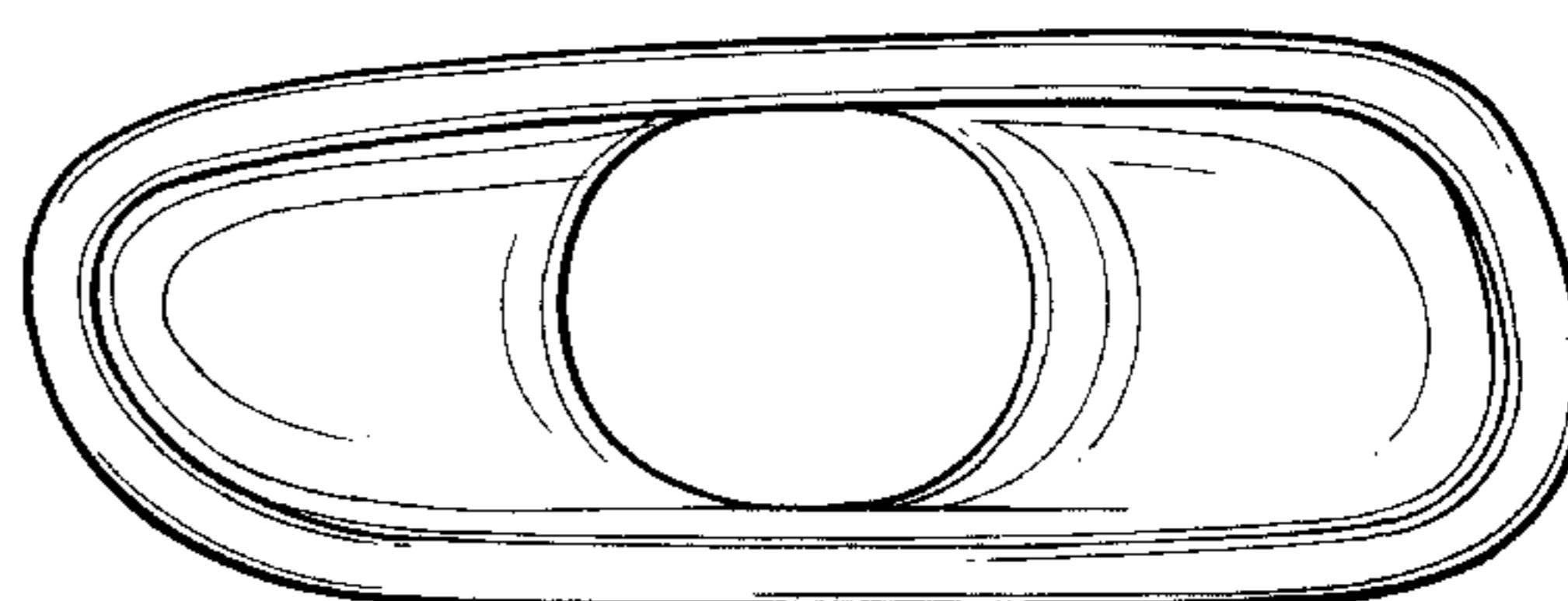
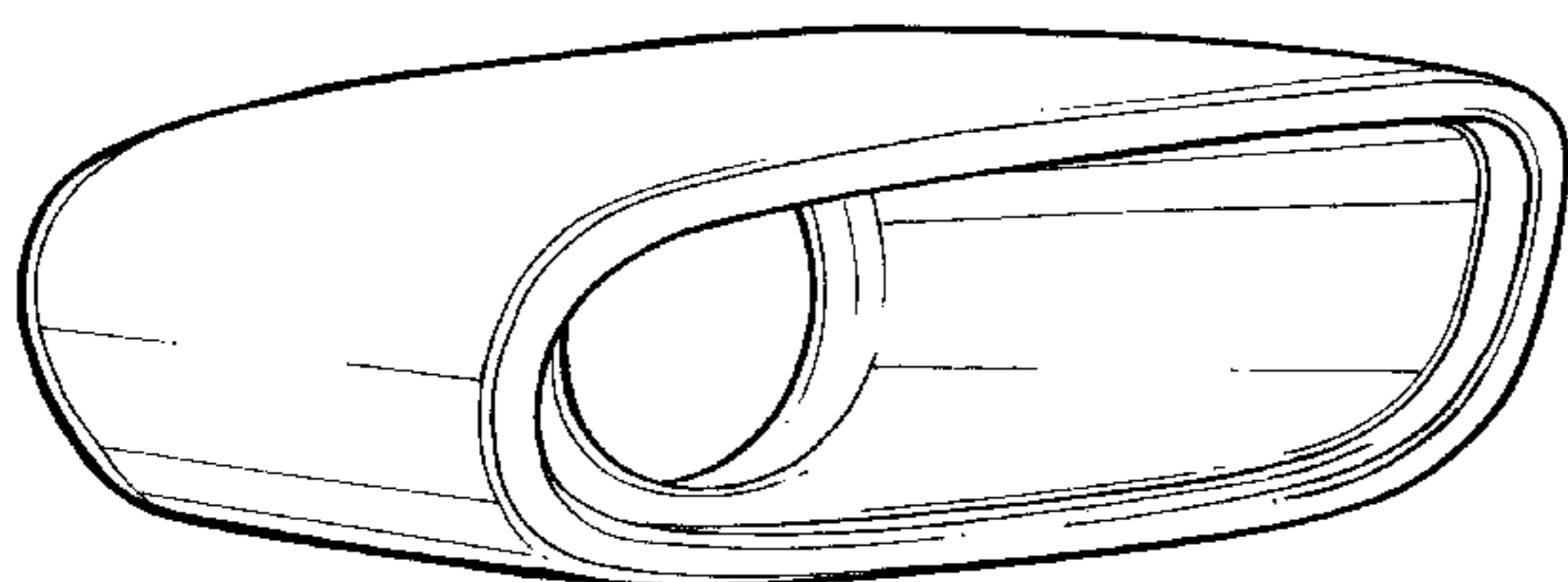
FIG. 4 is a right side view of the surface configuration of an exhaust pipe for a vehicle according to my novel design;

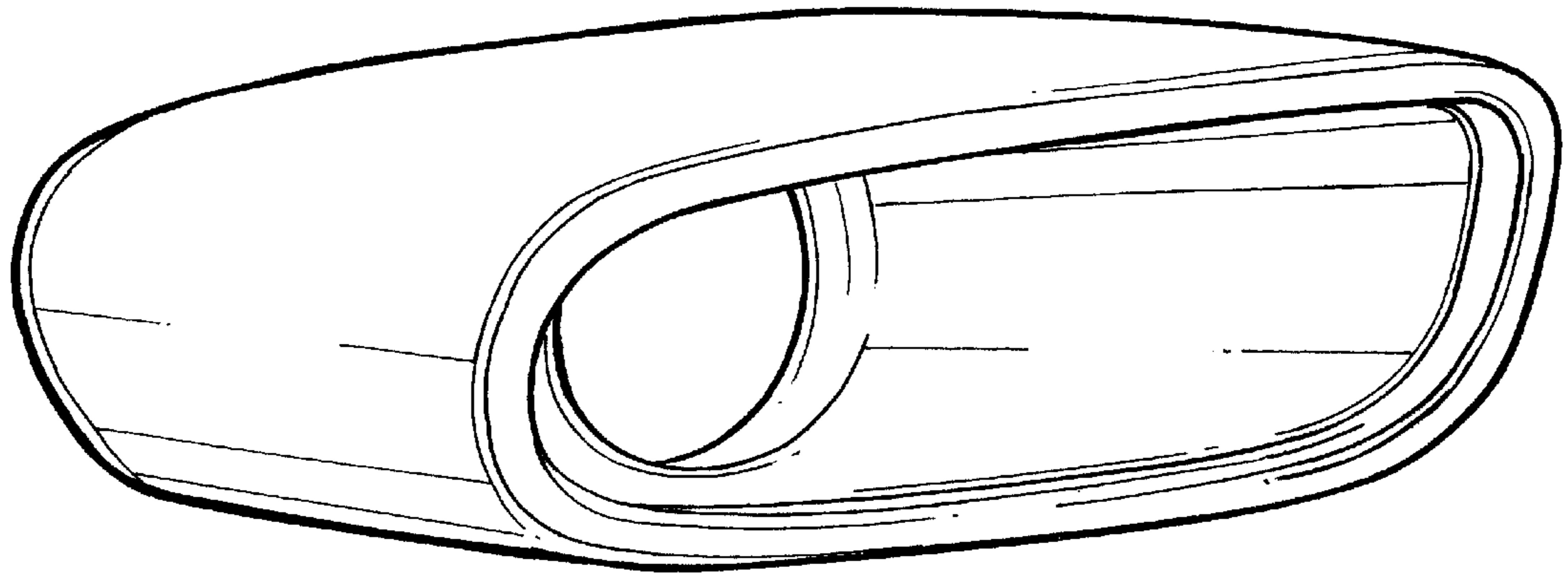

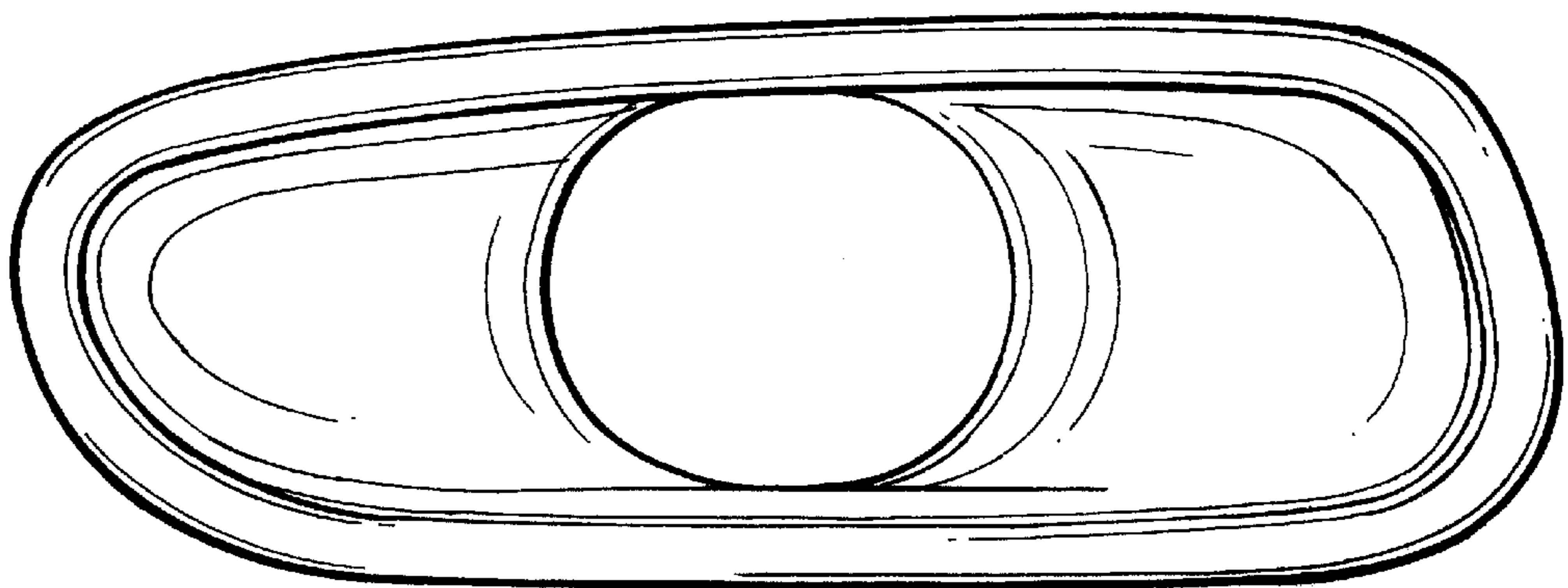

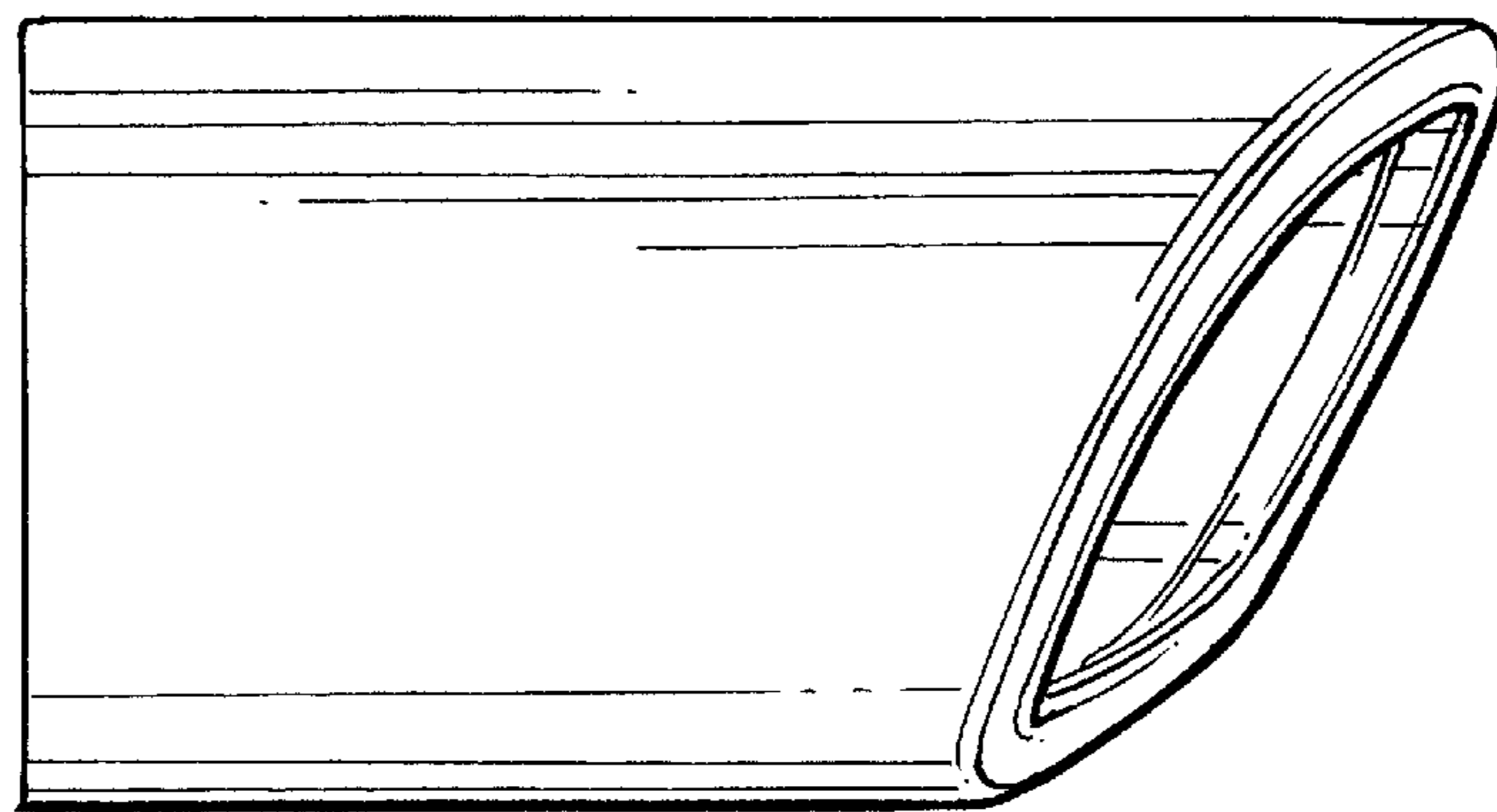

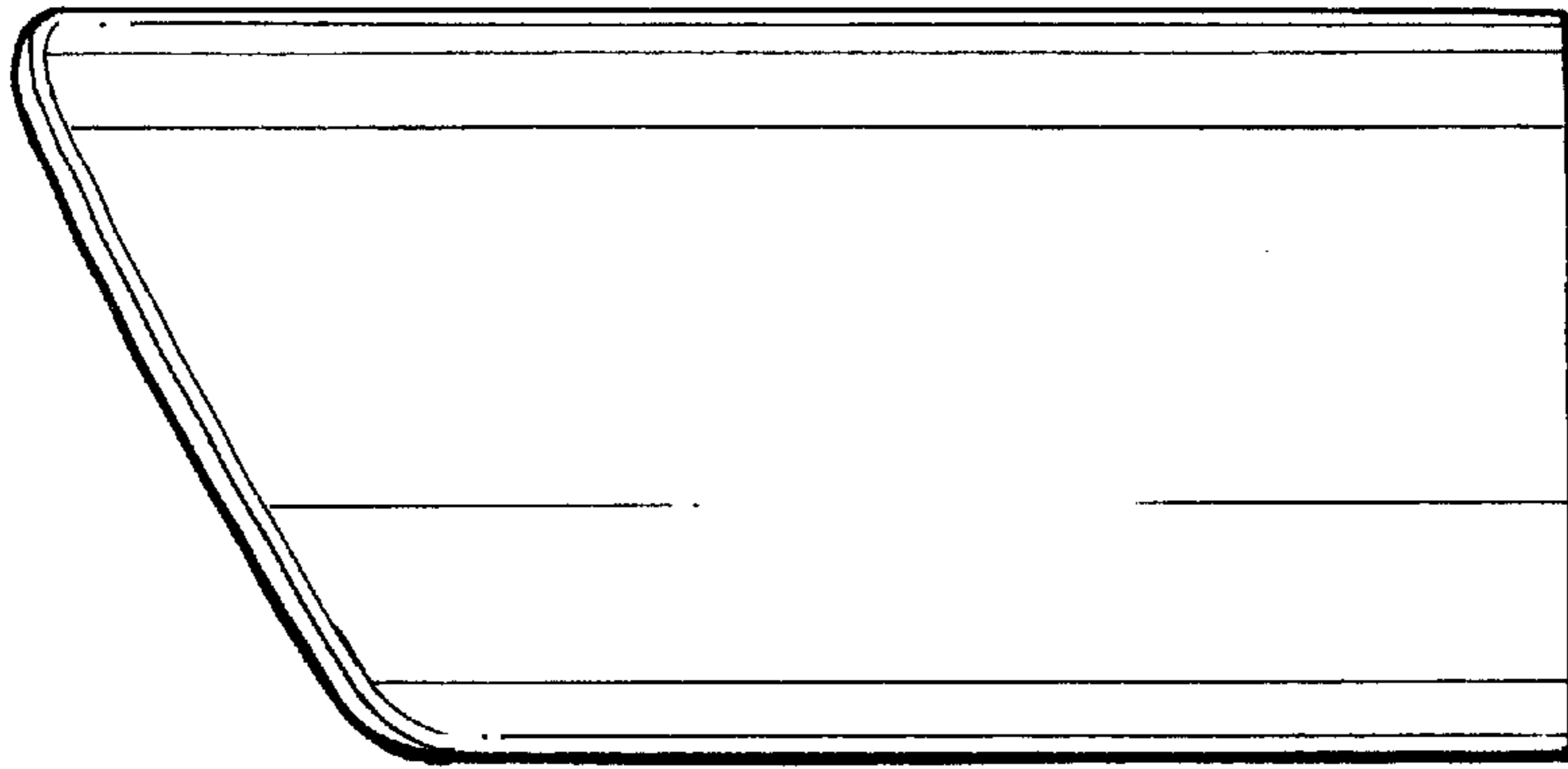

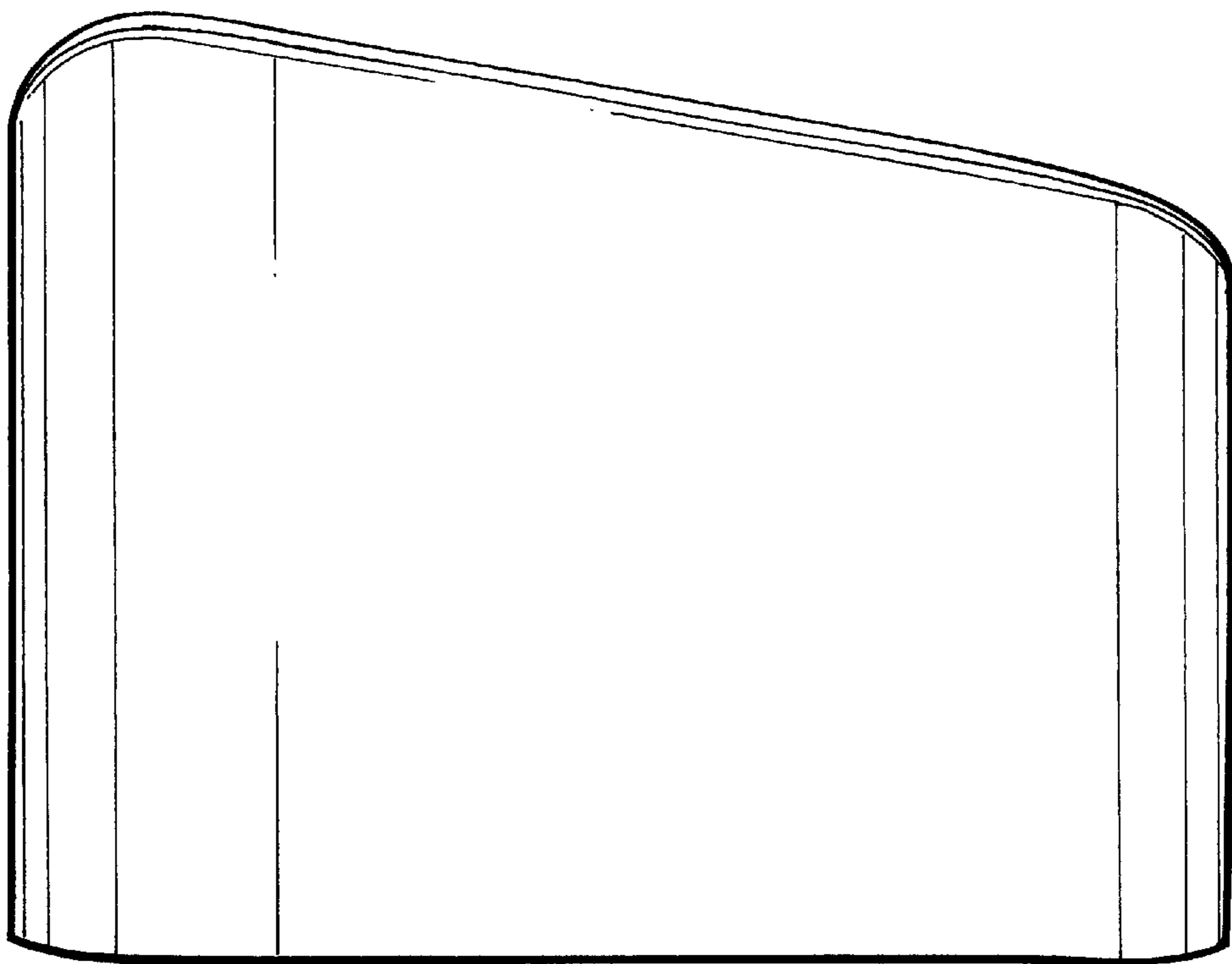

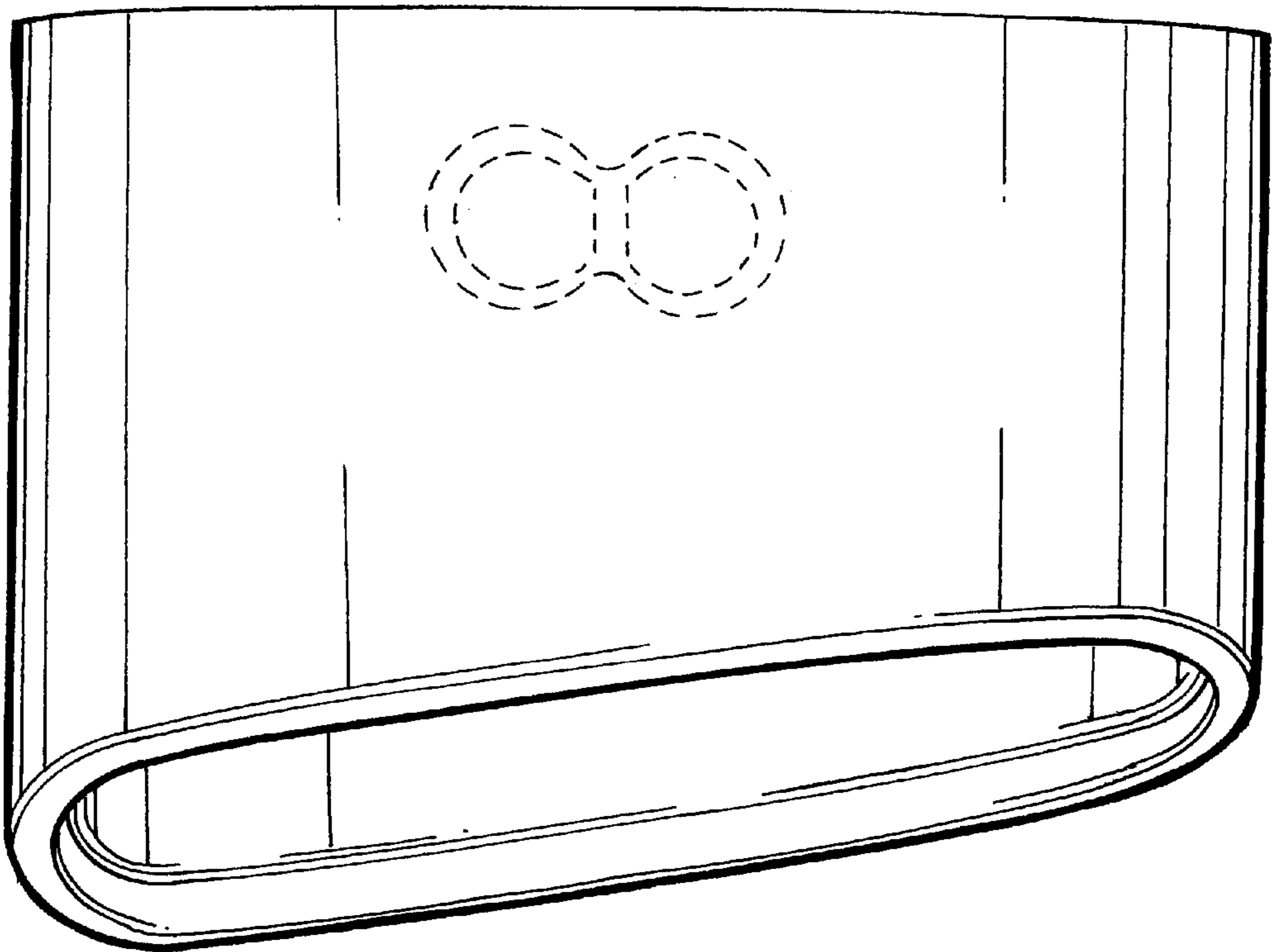
