**DESCRIPTION**

FIG. 2 is a front view of the telephone with the handset shown in phantom which forms no part of the design

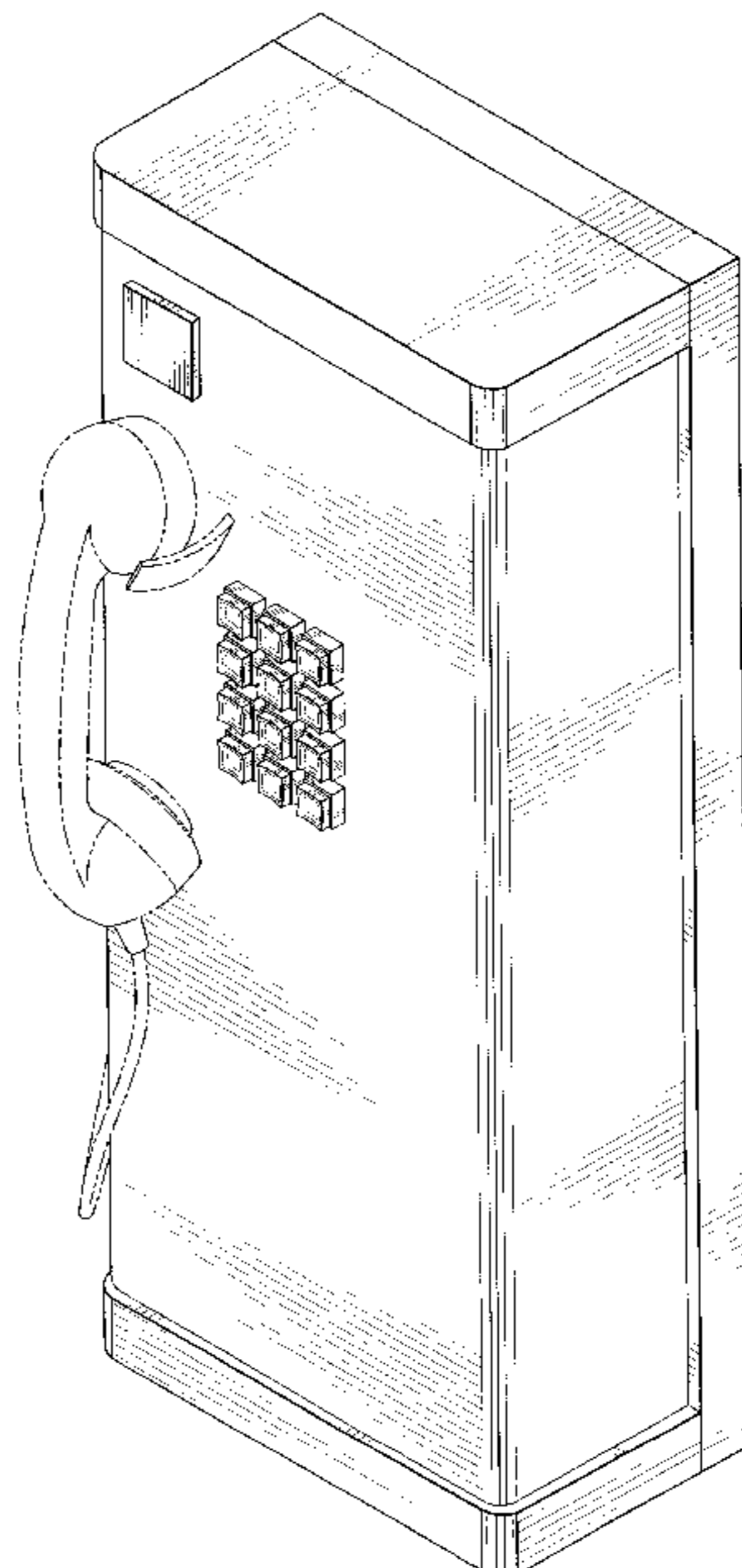
FIG. 3 is a left side view of the telephone with the handset shown in phantom which forms no part of the design;

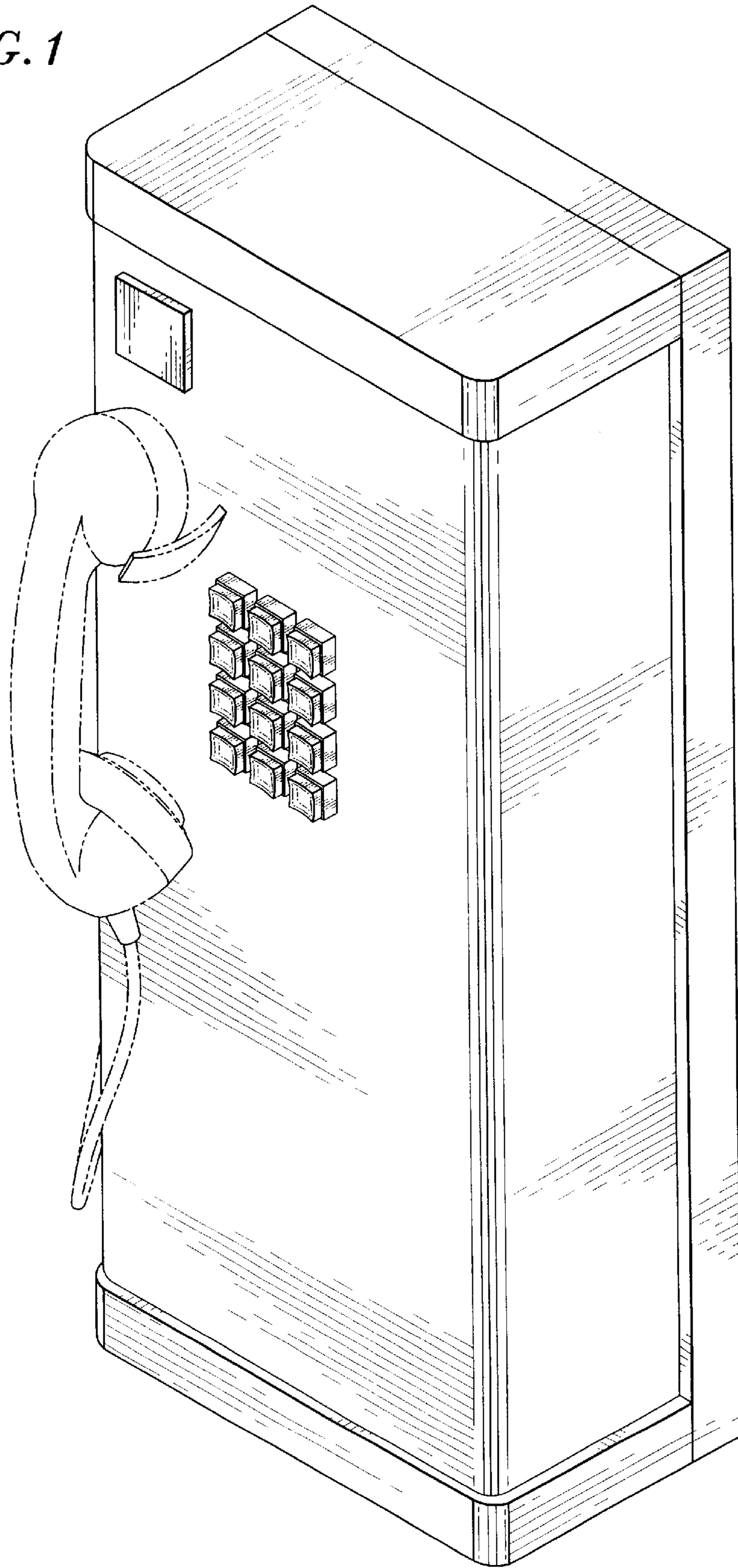

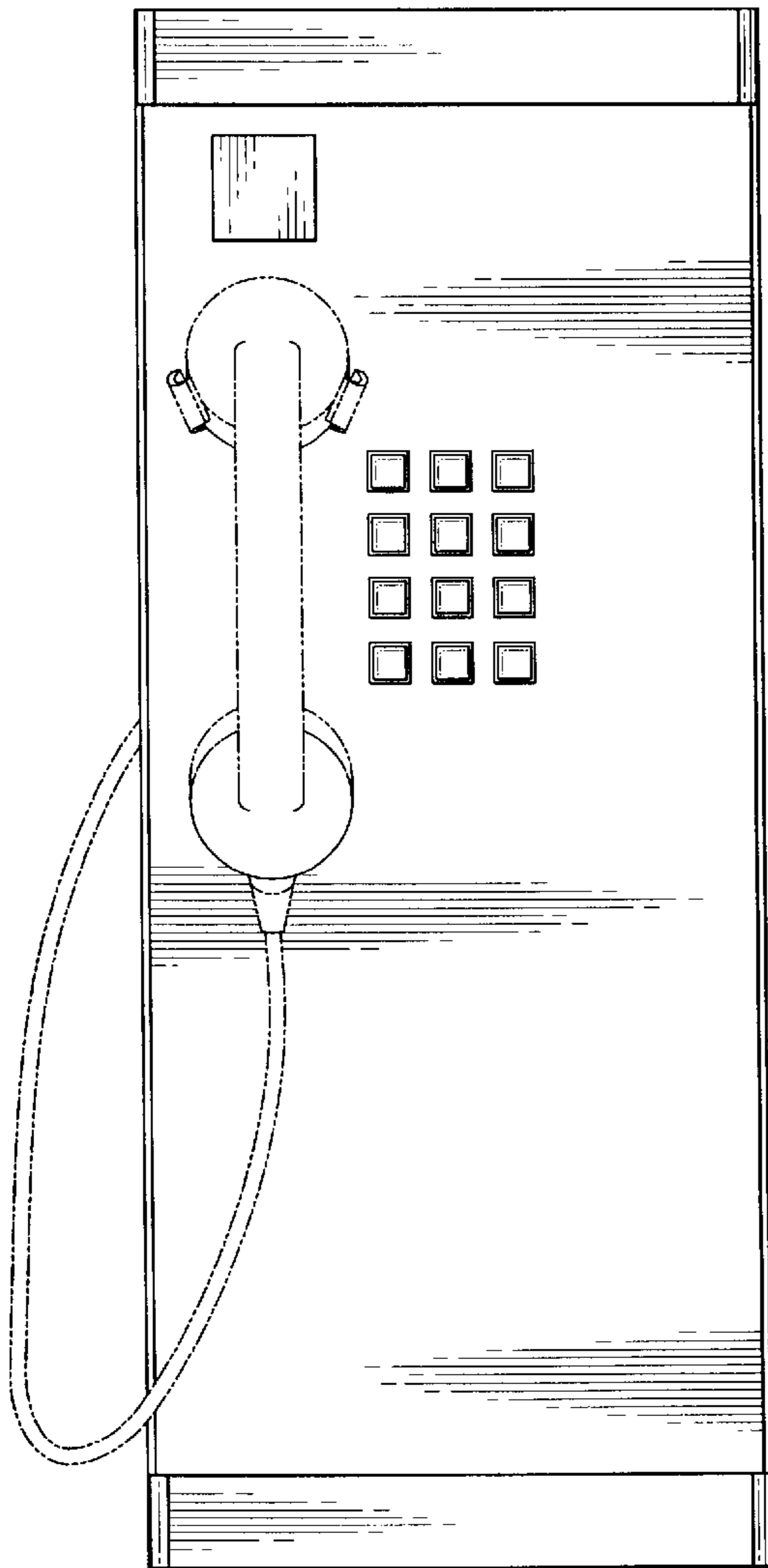
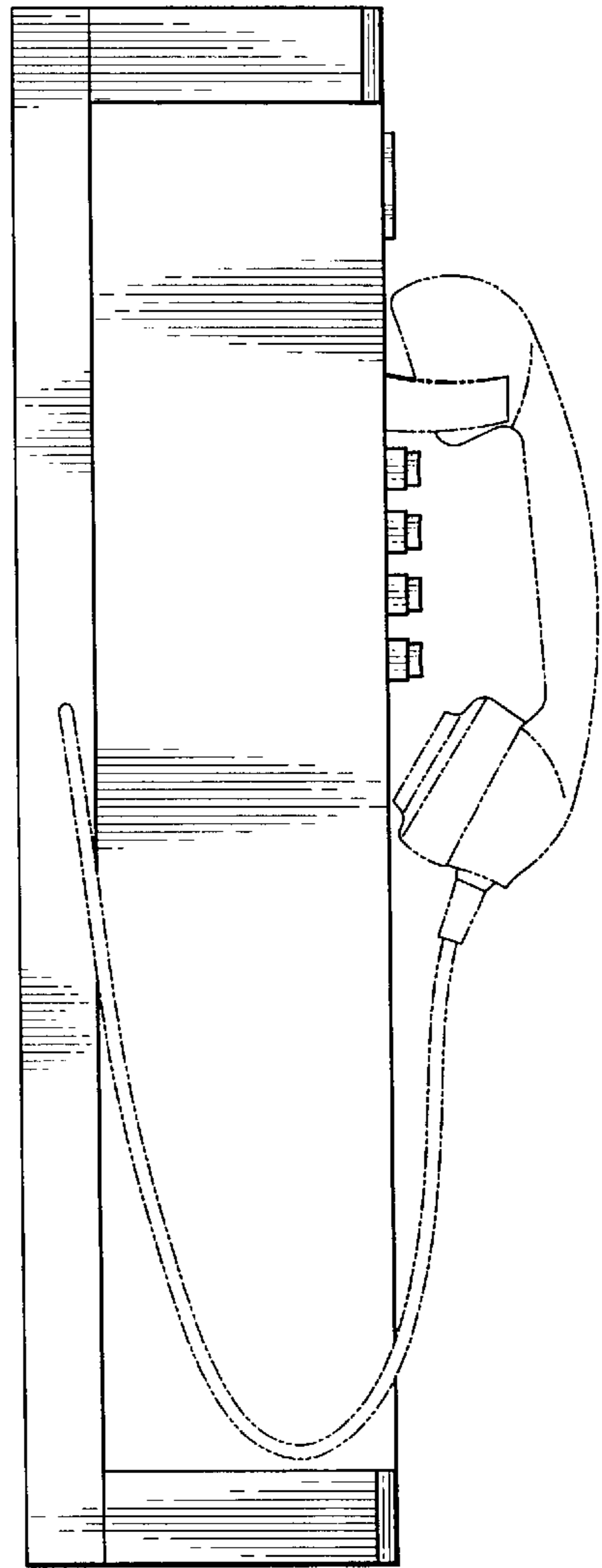
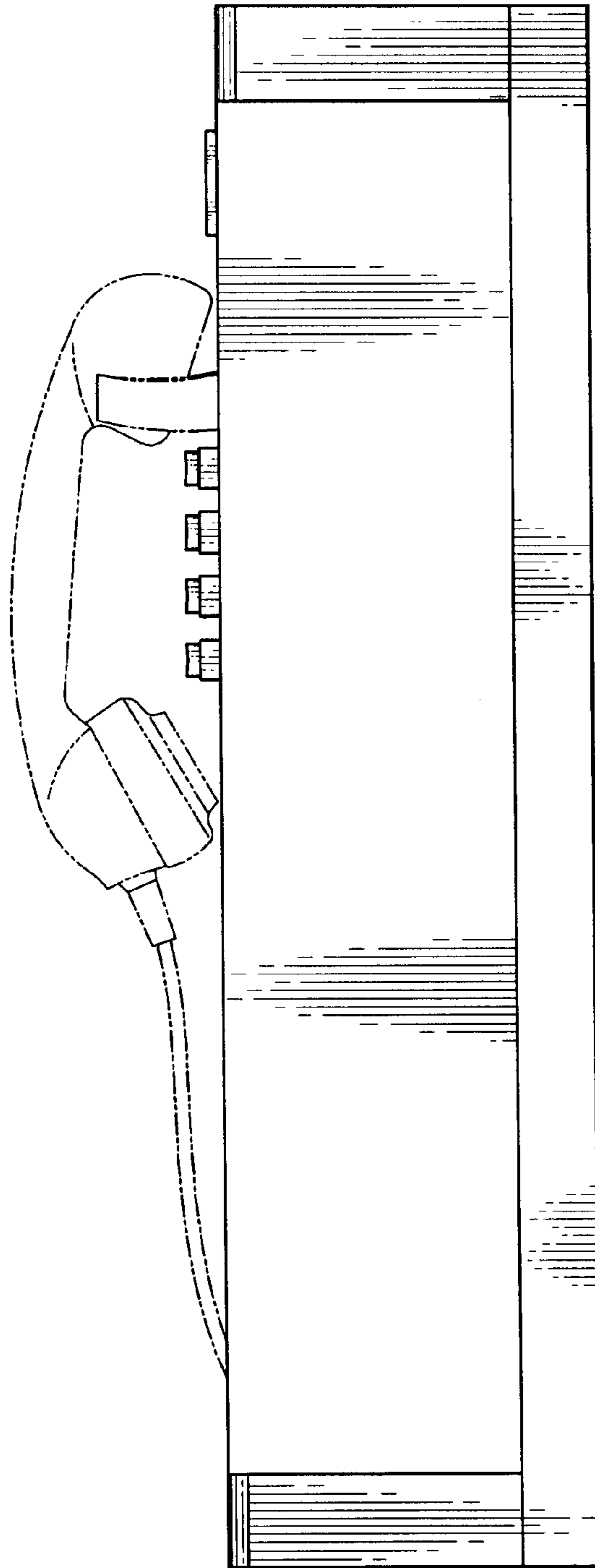


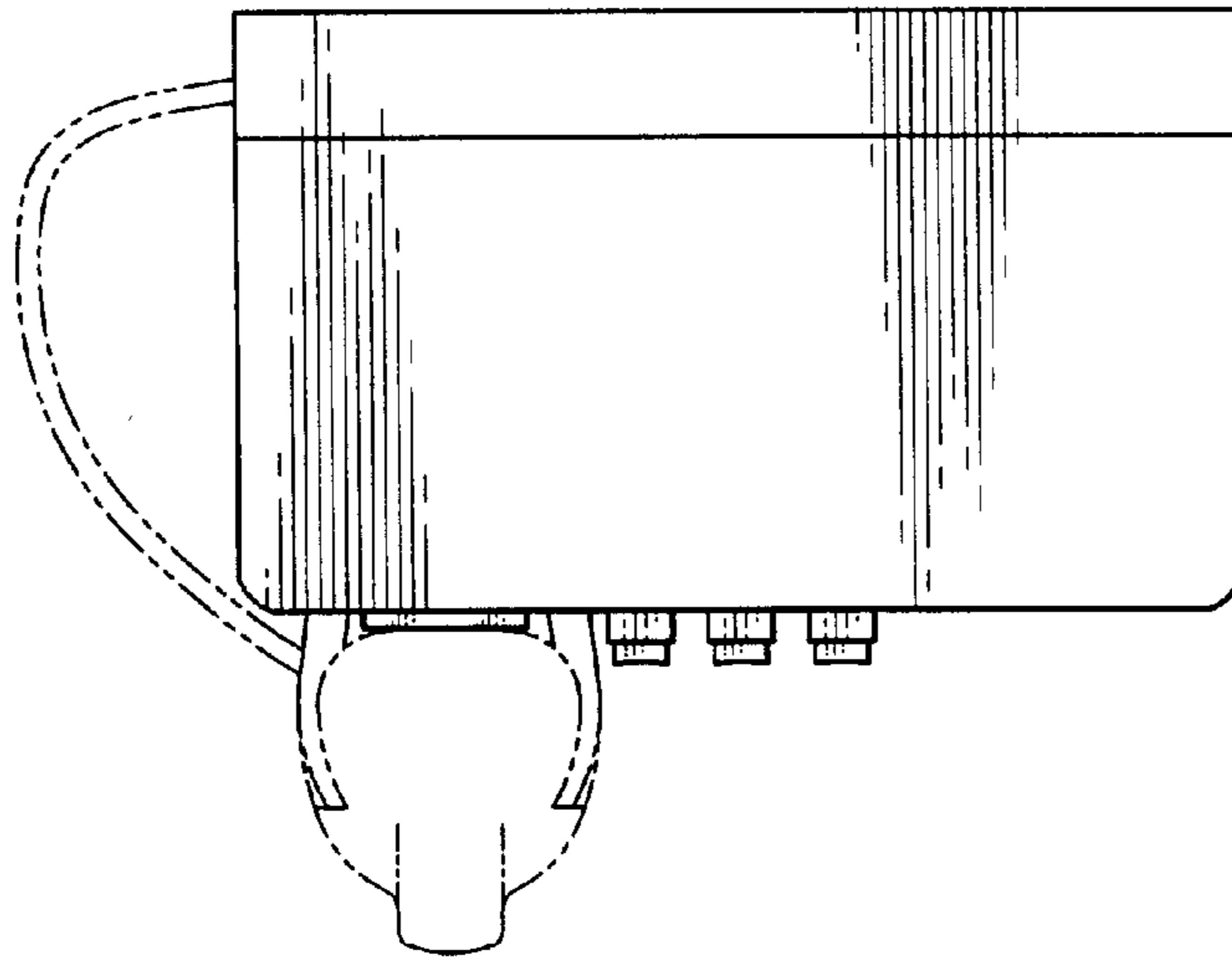
