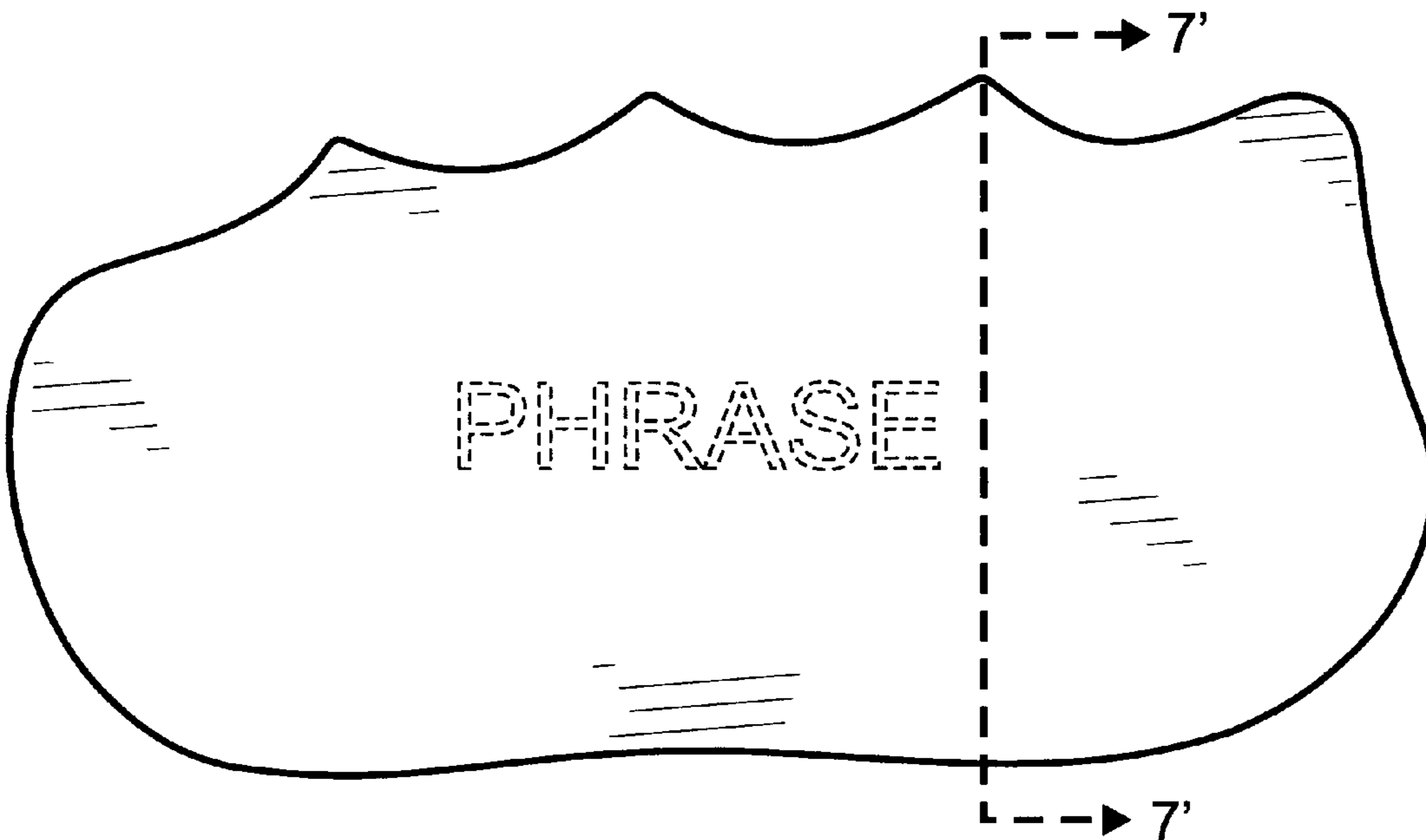
(57) **CLAIM**

I claim the ornamental design for an inspirational hand piece, as shown and described.

DESCRIPTION

FIG. 1 is a front view showing my new design;
 FIG. 2 is a top side view thereof;
 FIG. 3 is a bottom side view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a back side view thereof;
 FIG. 7 is a first alternative embodiment sectional view taken along line 7' of FIG. 1;
 FIG. 8 is a second alternative embodiment sectional view taken along line 7' of FIG. 1; and,
 FIG. 9 is a third alternative embodiment sectional view taken along line 7' of FIG. 1.

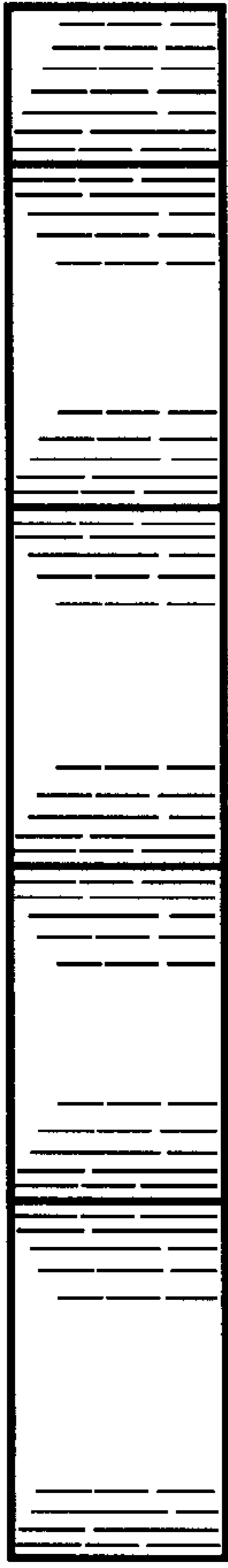

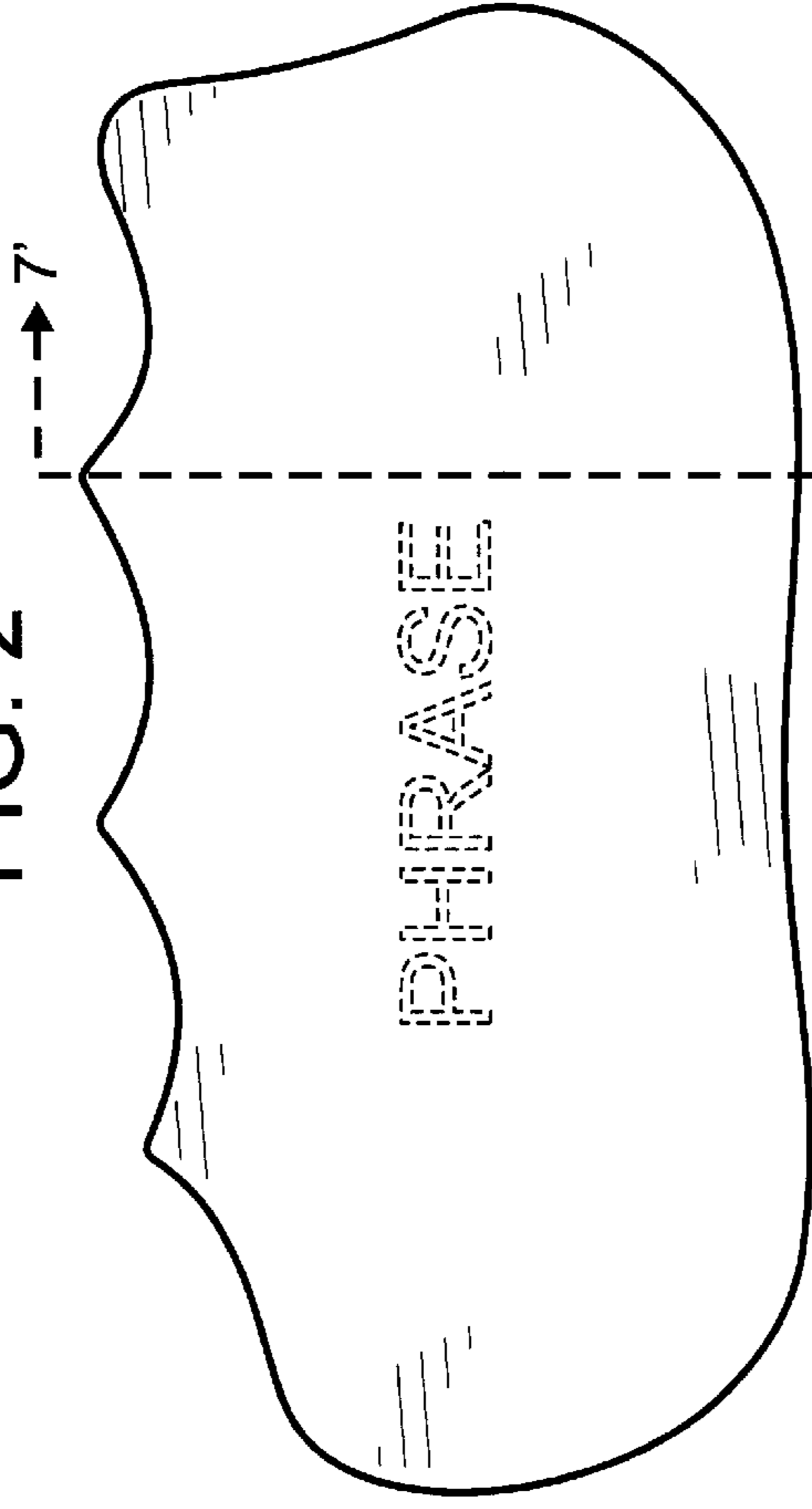

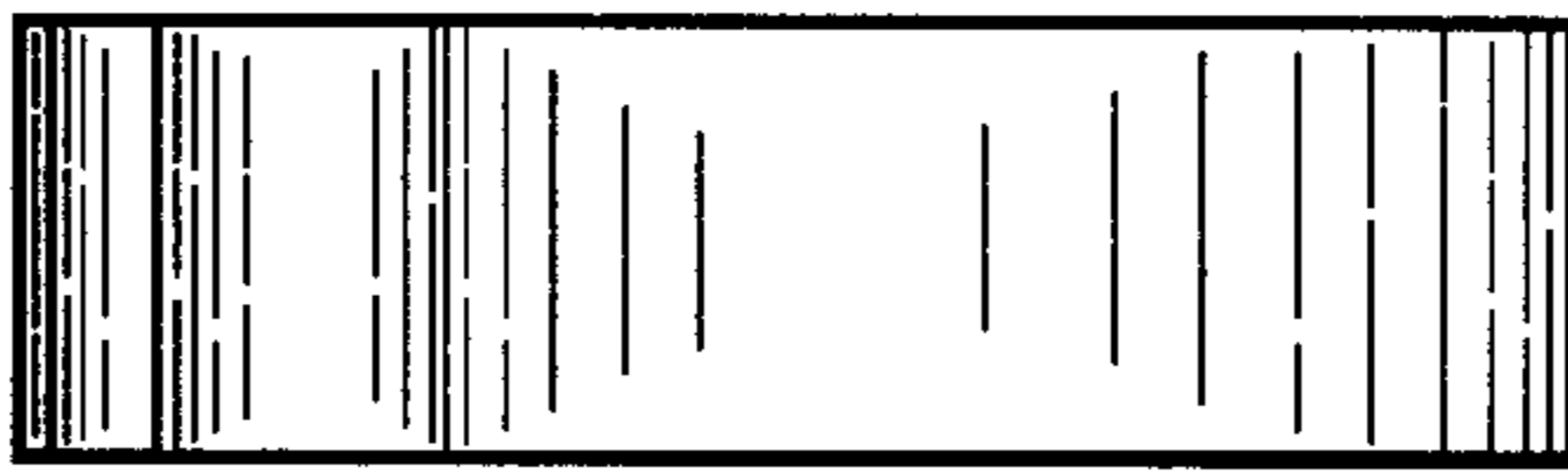

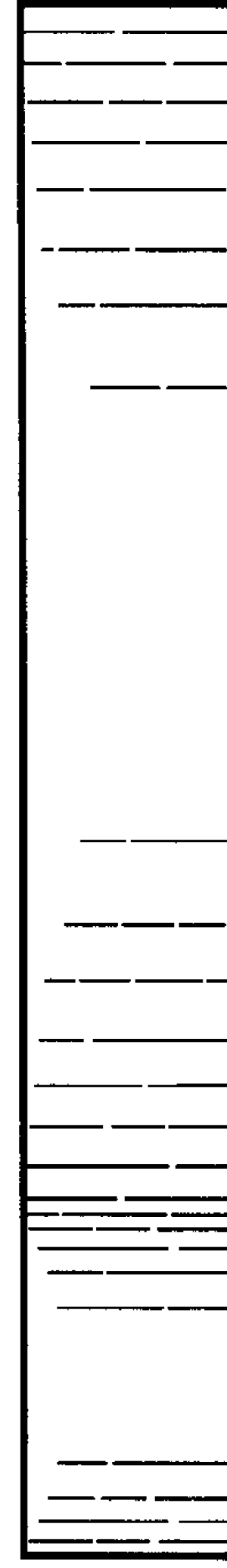

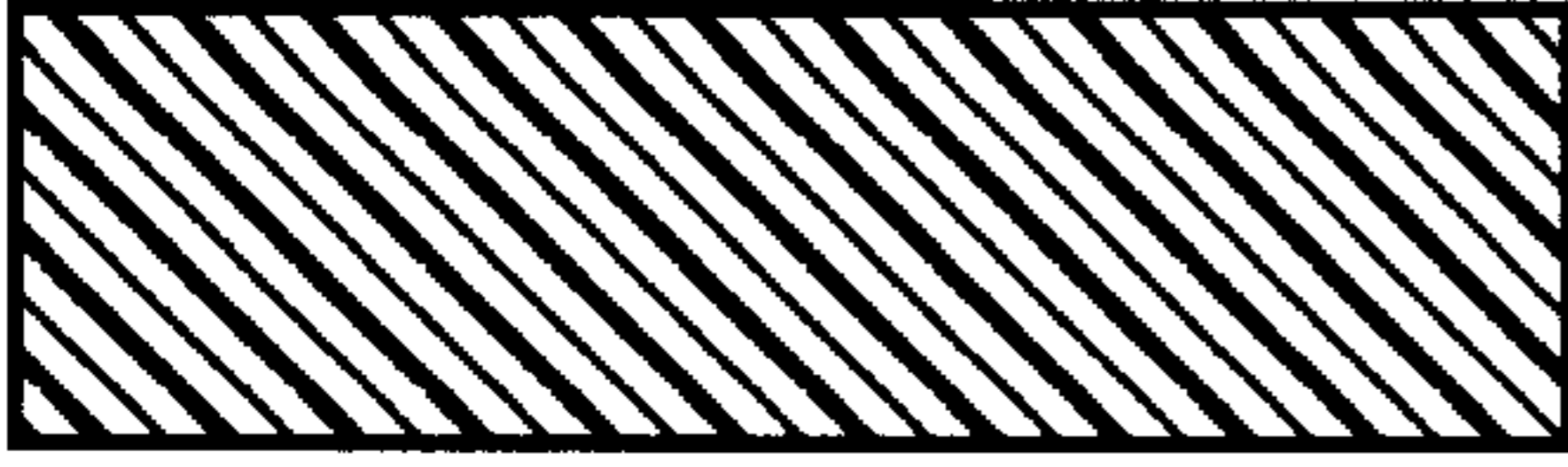

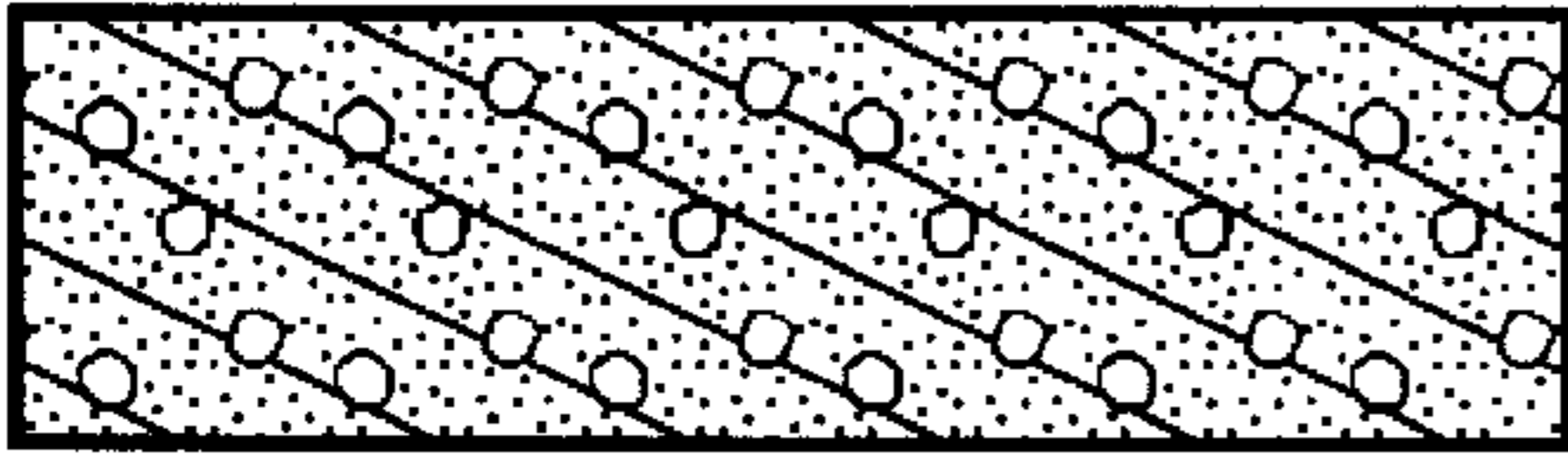

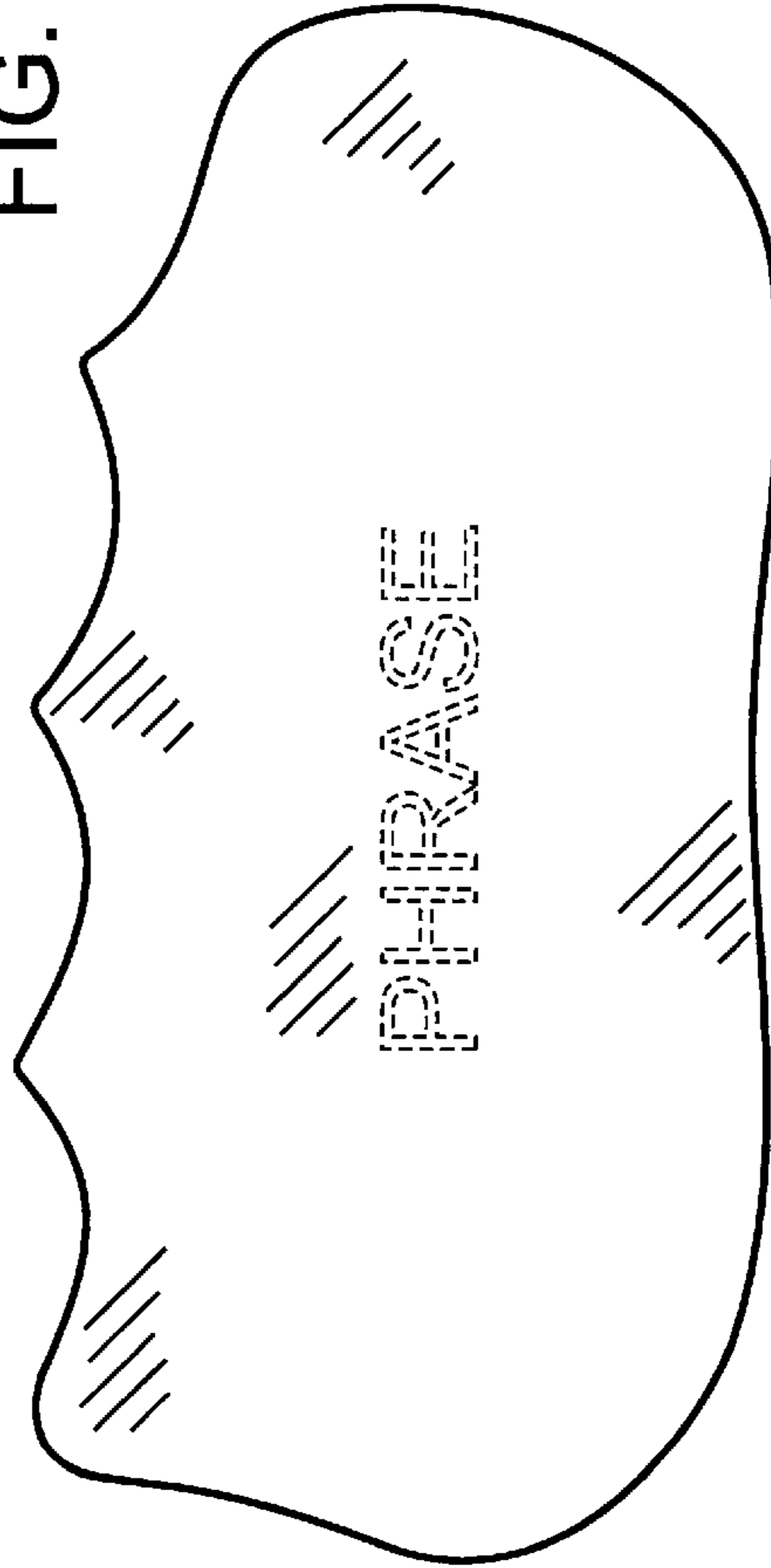
