a backpack.

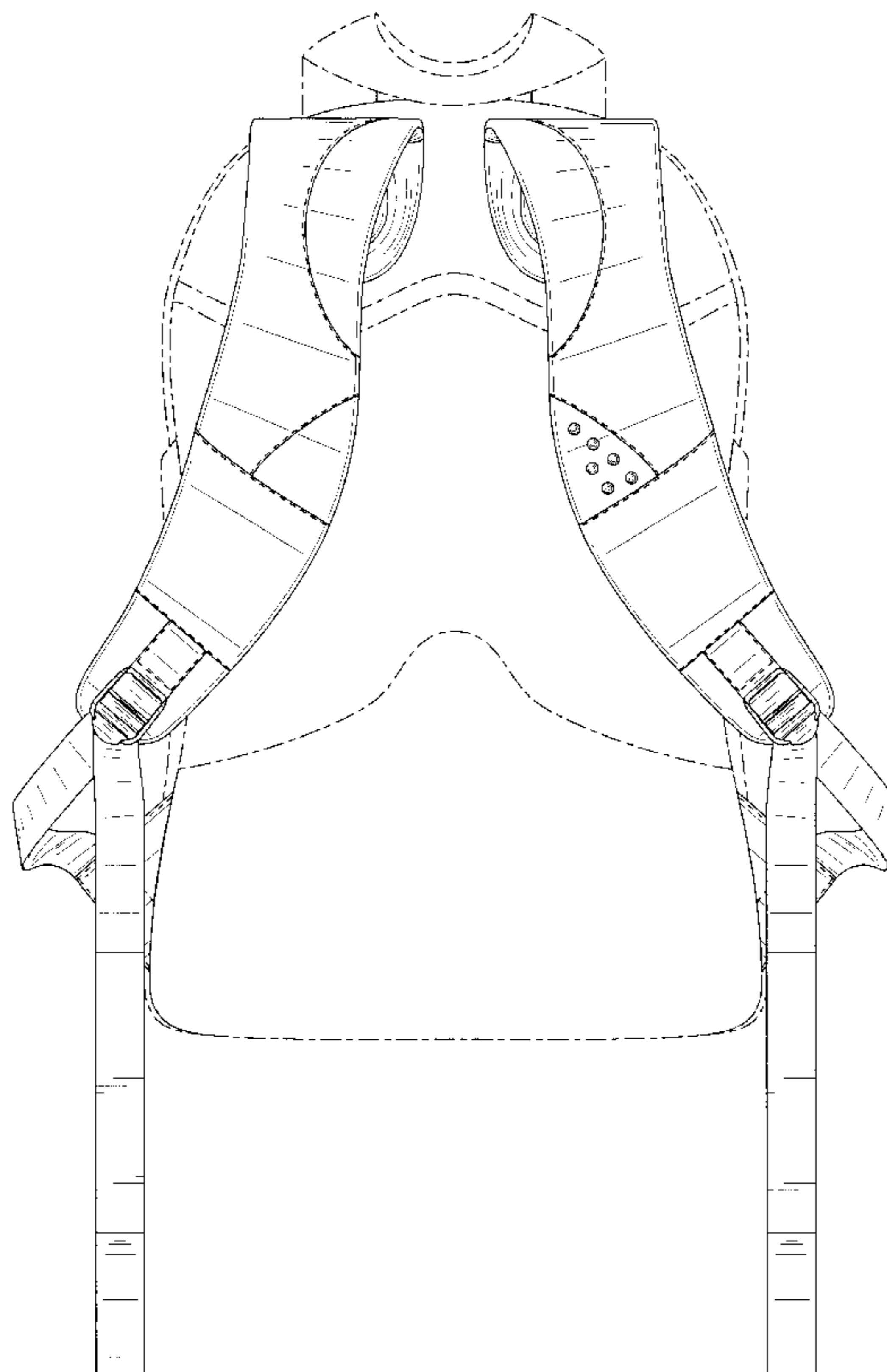
The broken line showing of a backpack, in the views, is for

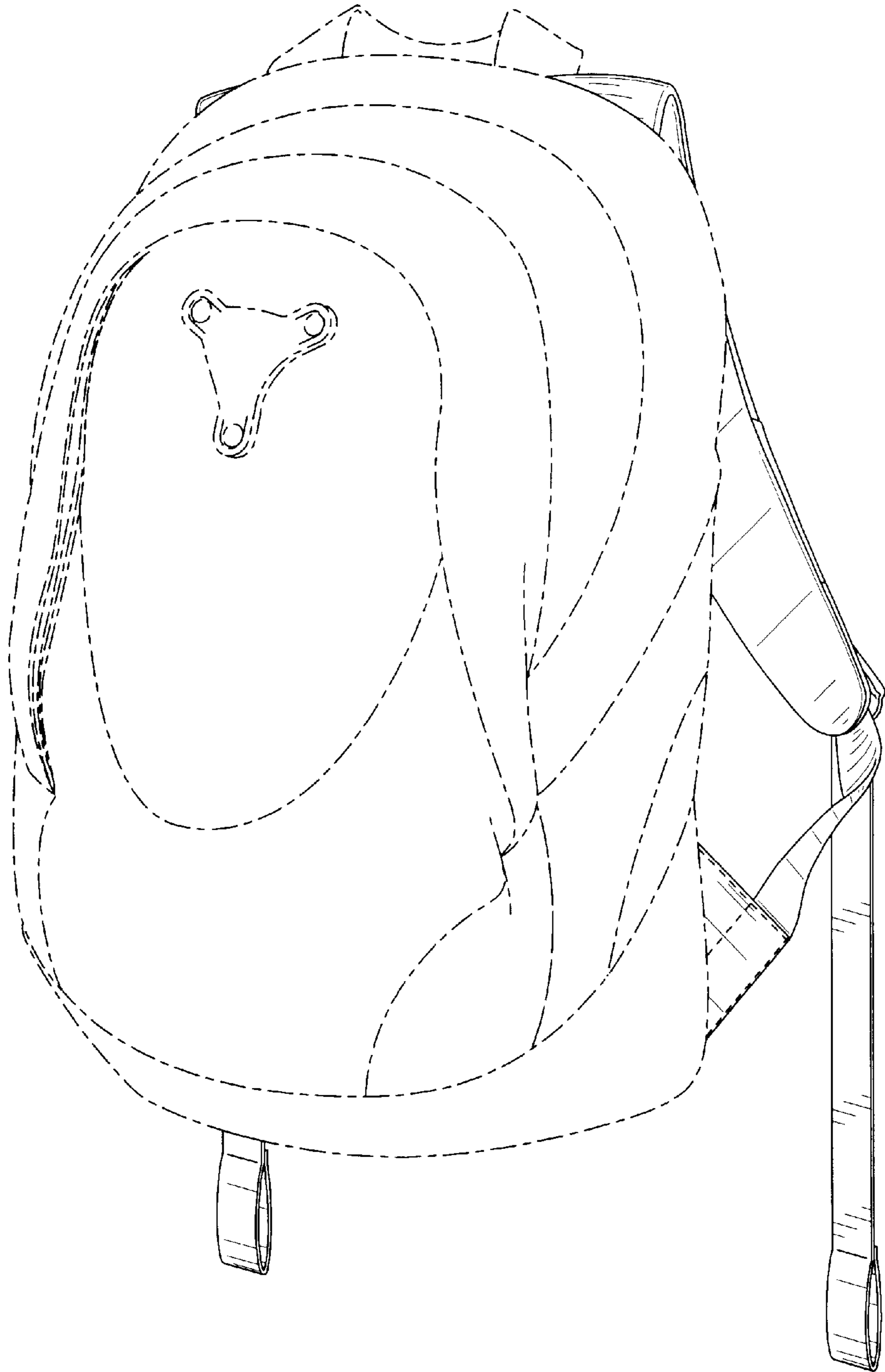

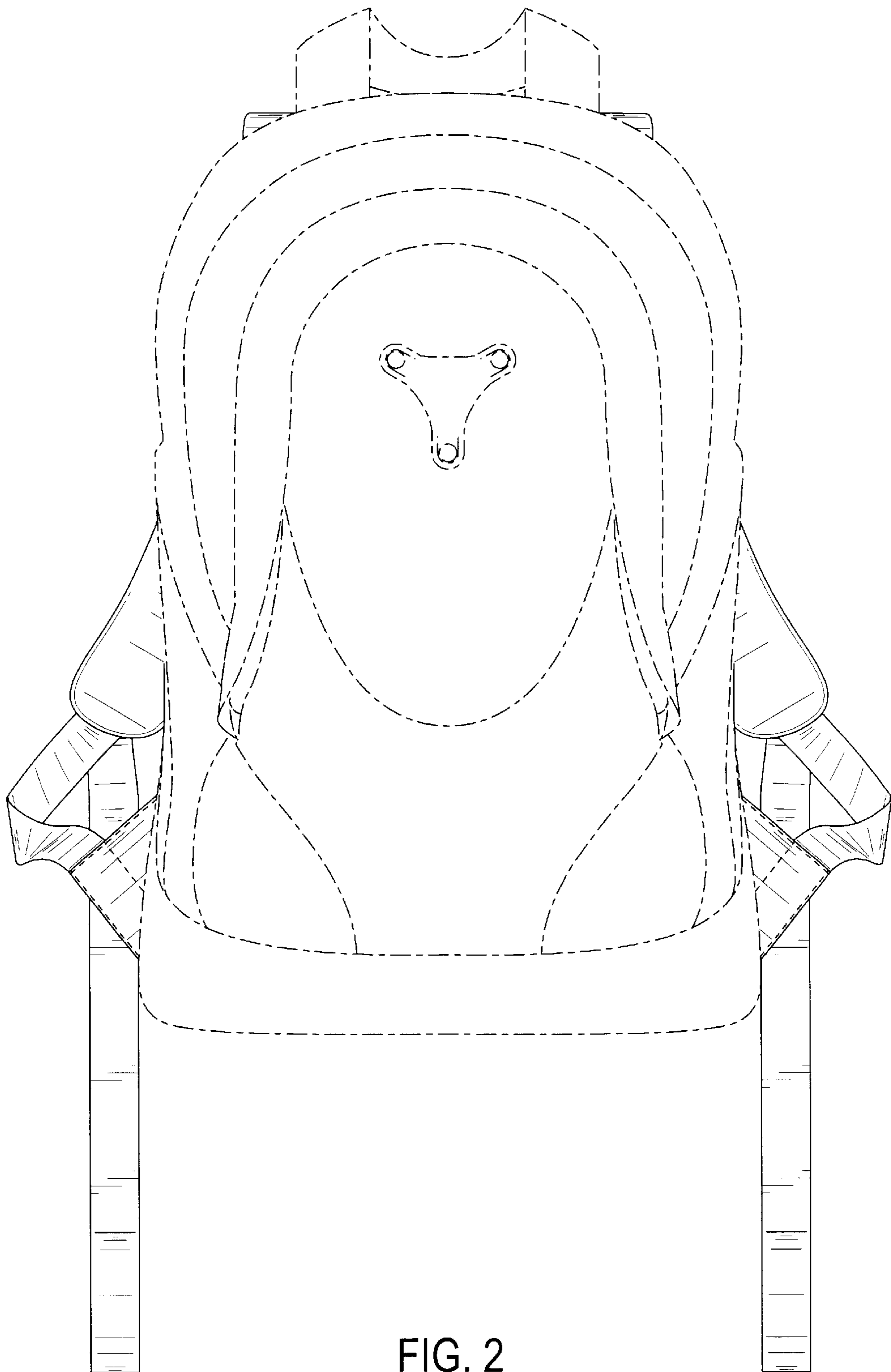

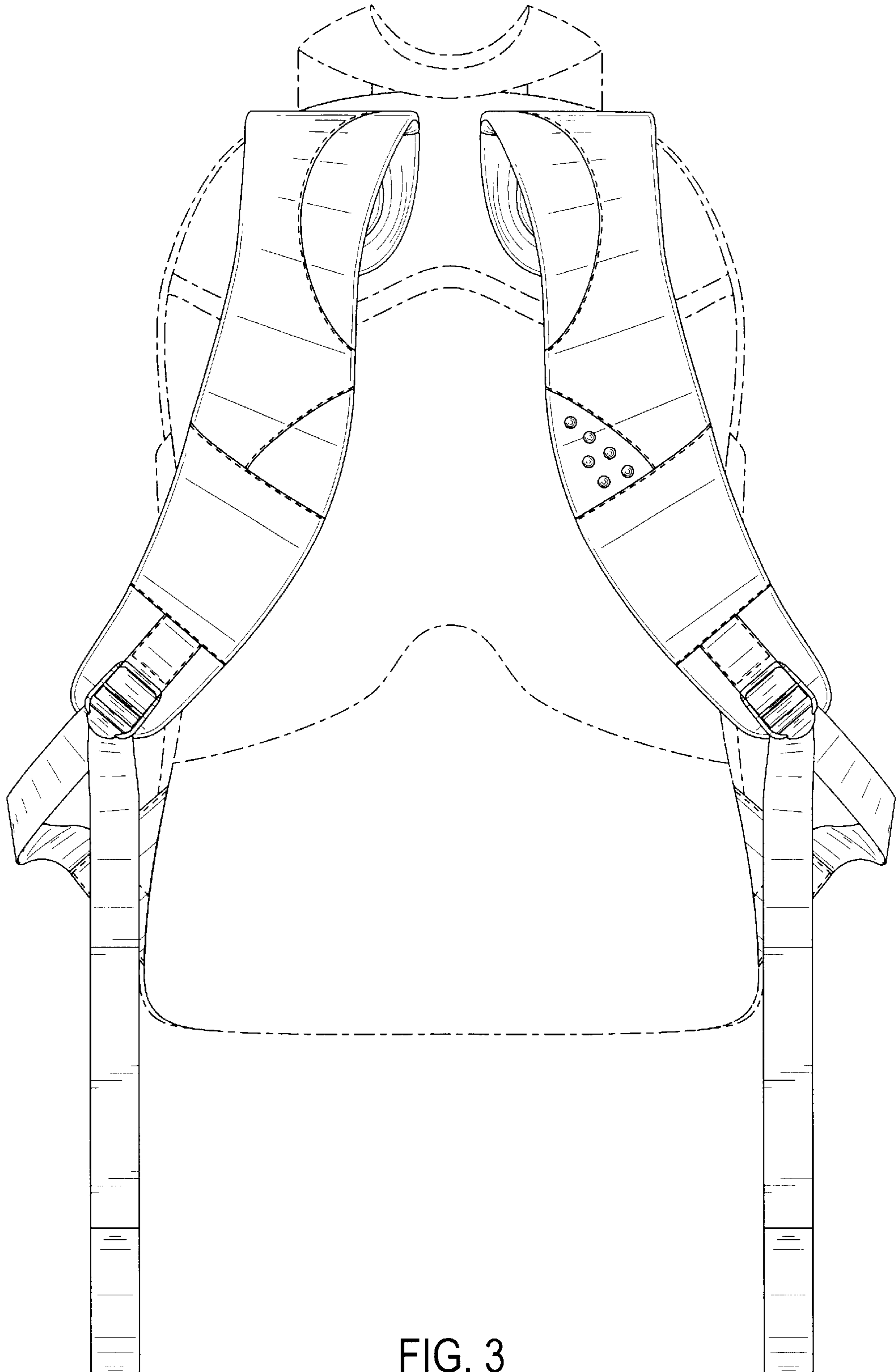

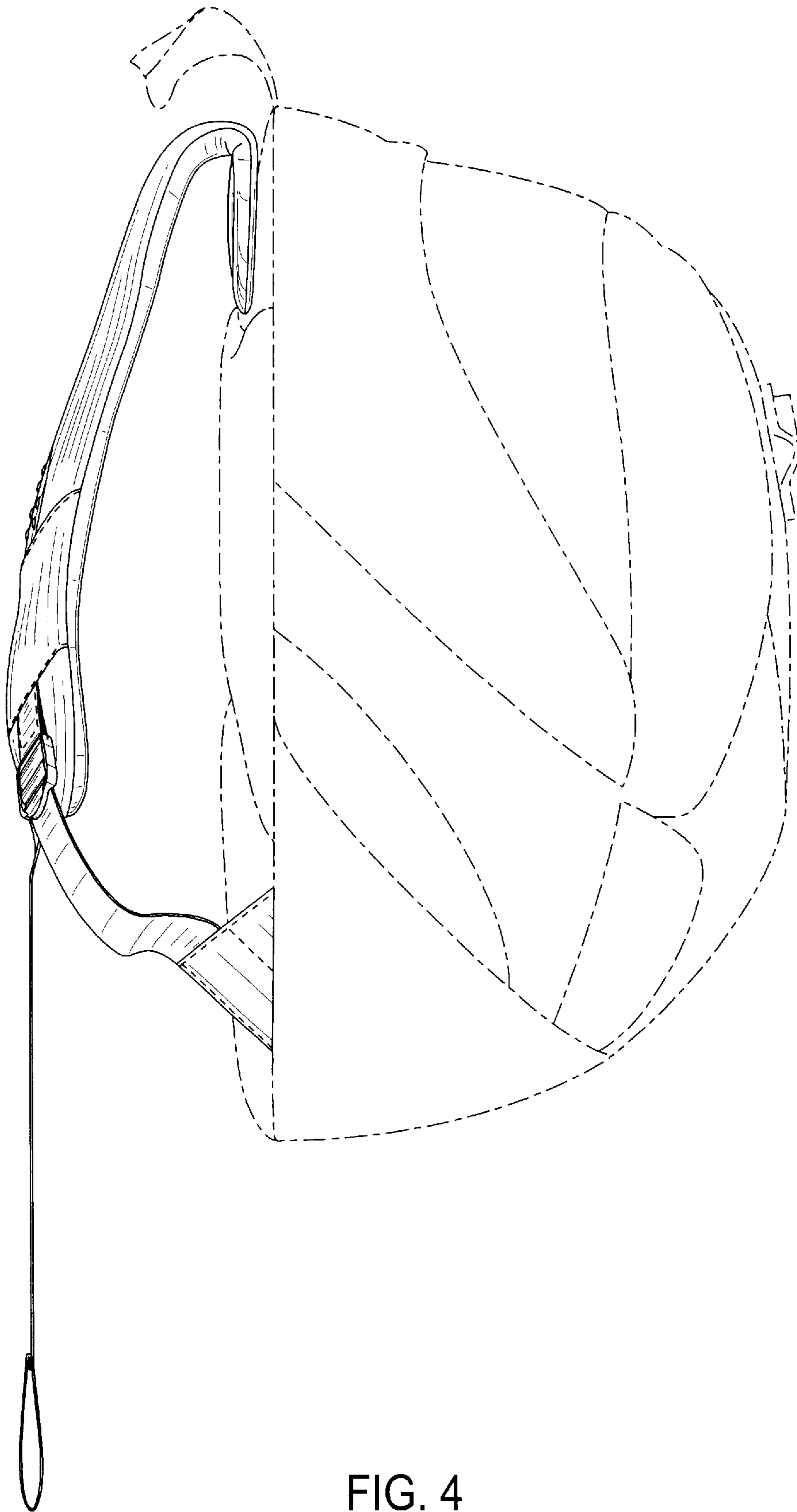

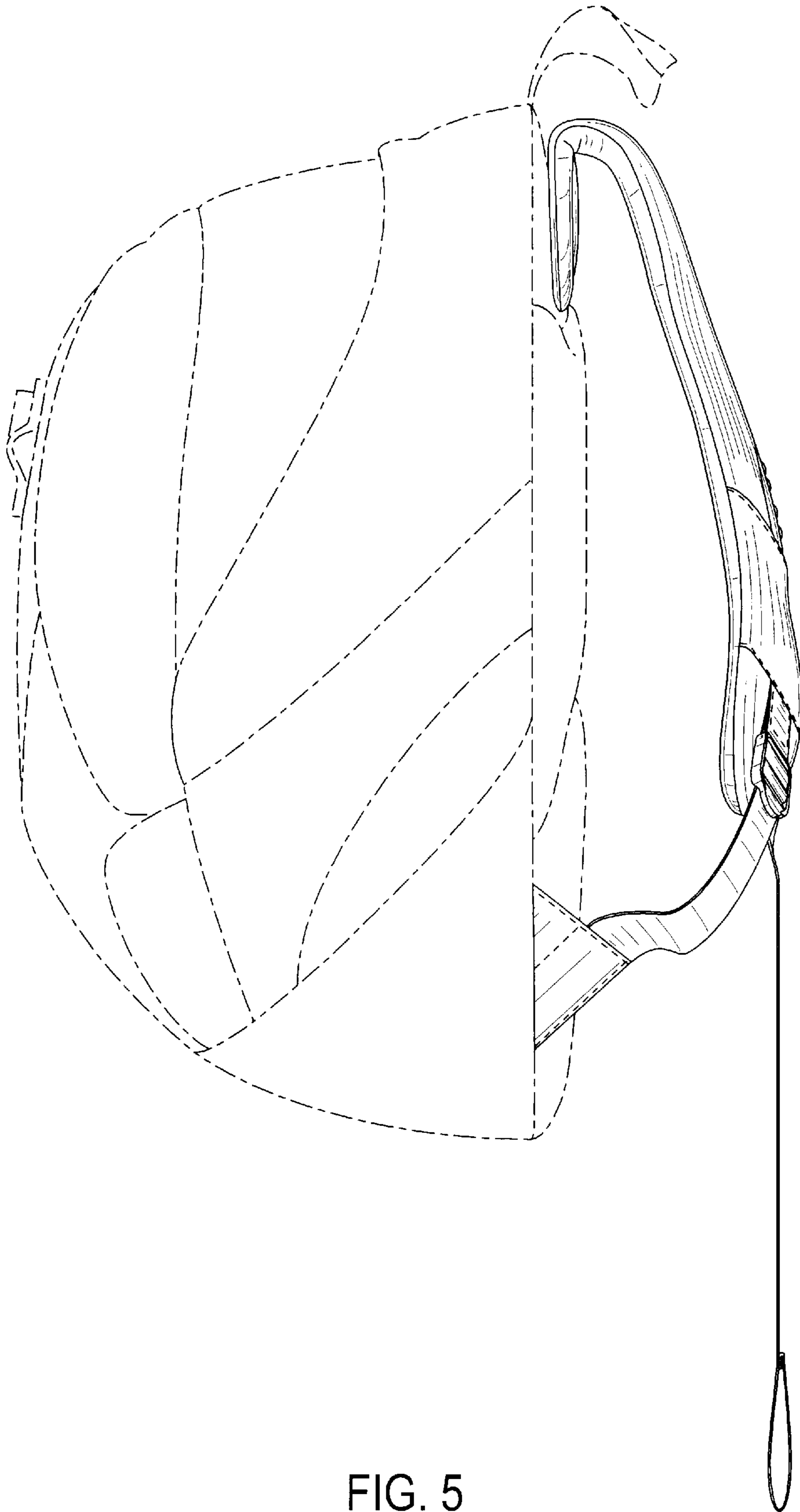

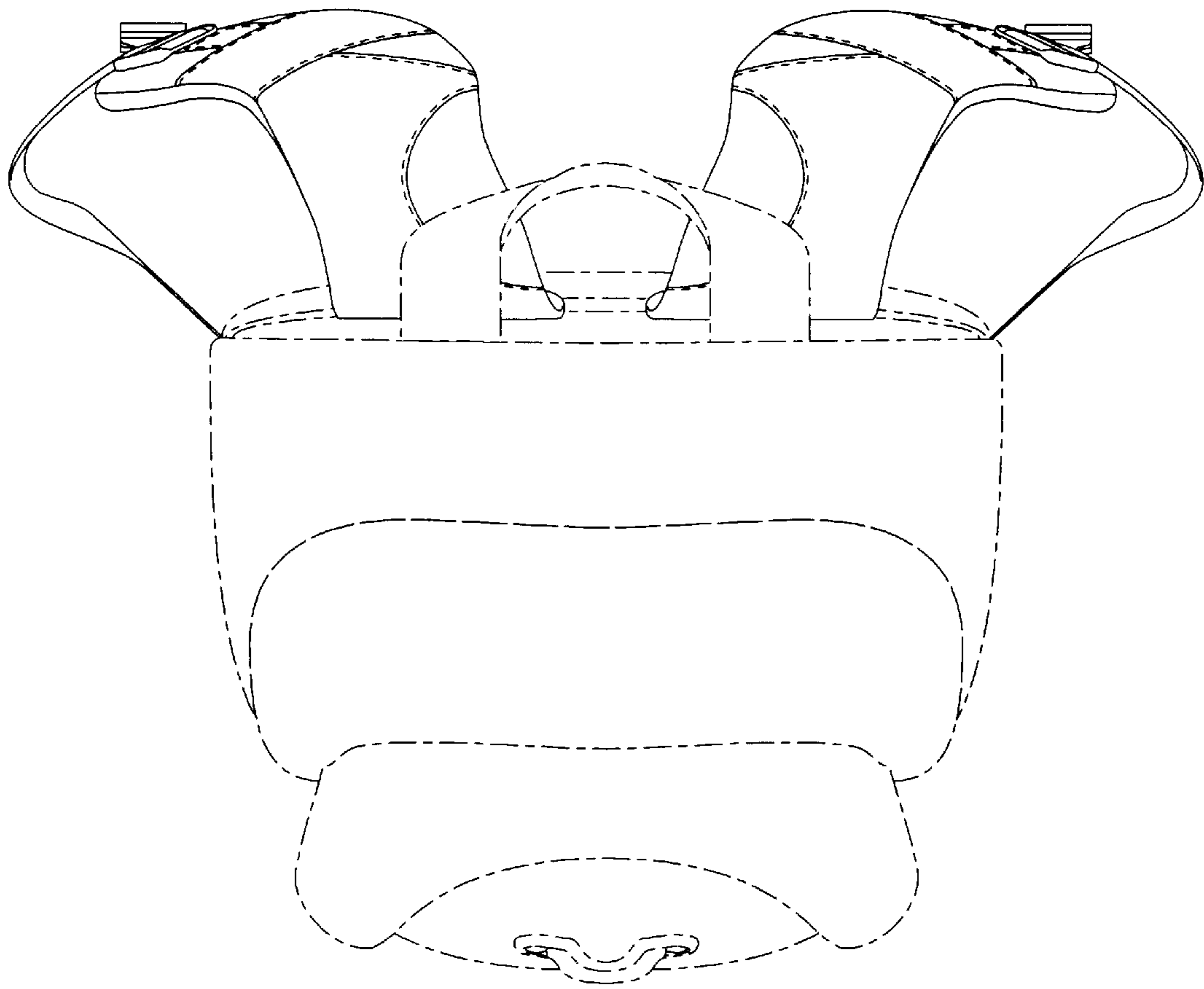

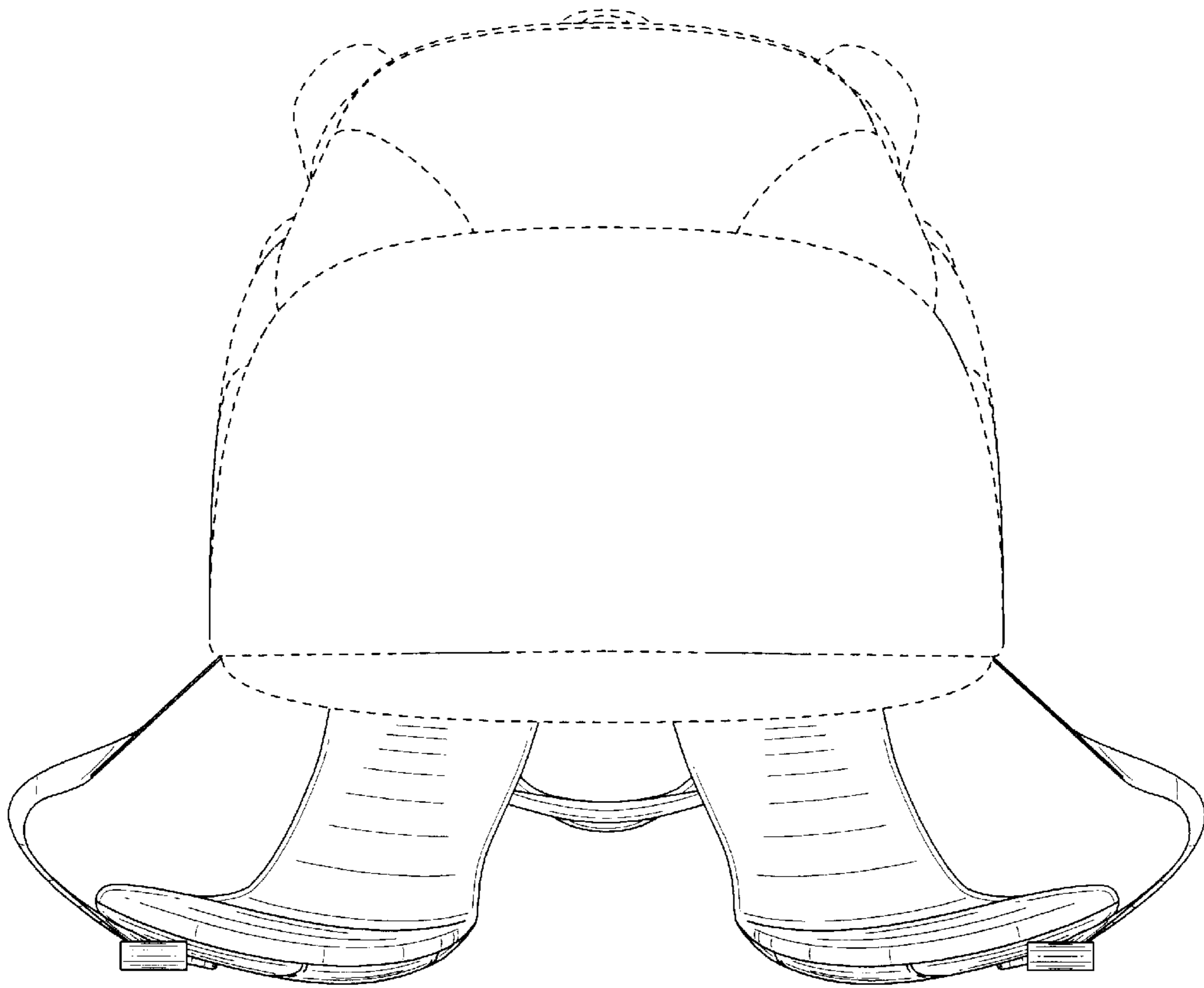
