(57) **CLAIM**

The ornamental design for the combined stuffed plush soccer ball and attached child sized security blanket, as shown and described.

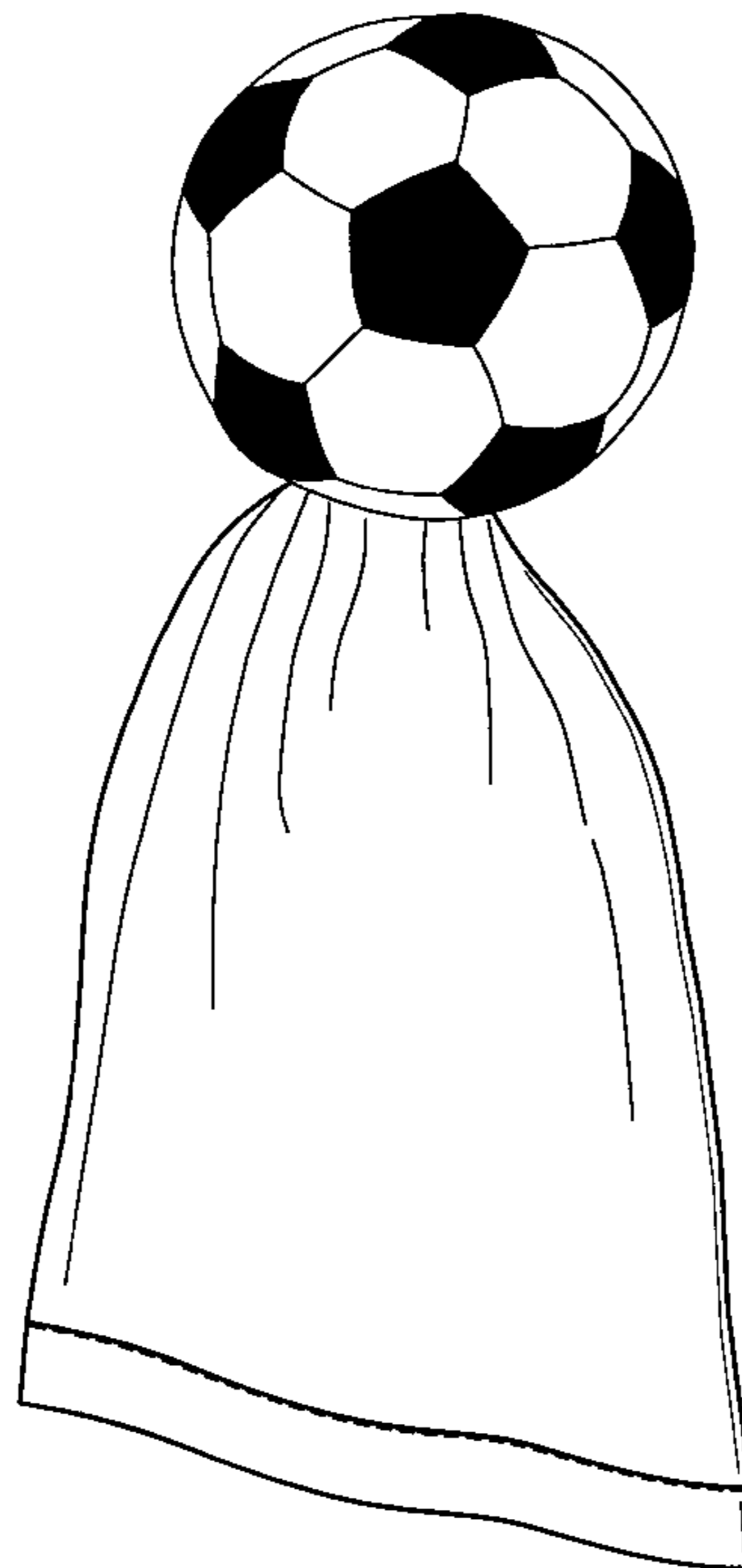

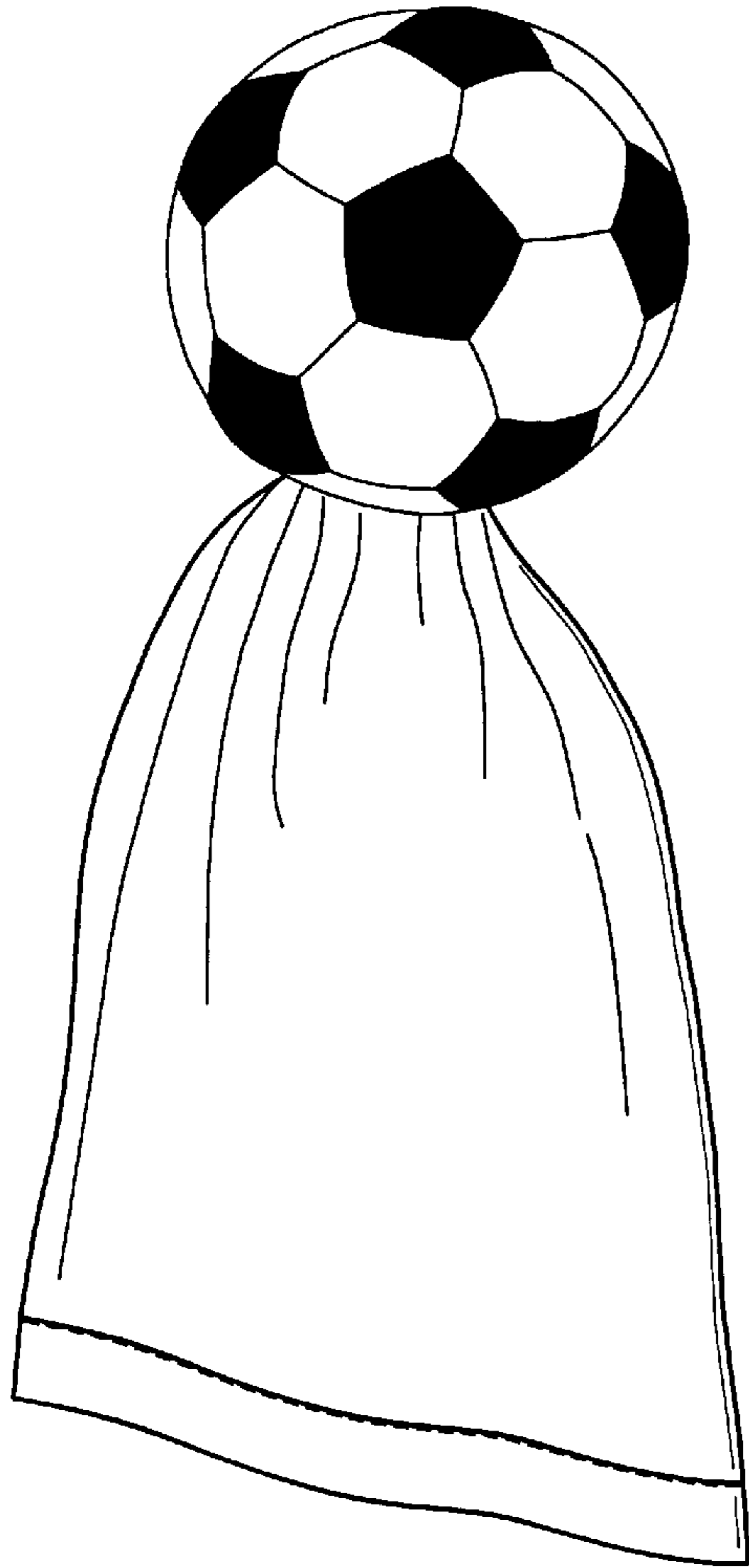

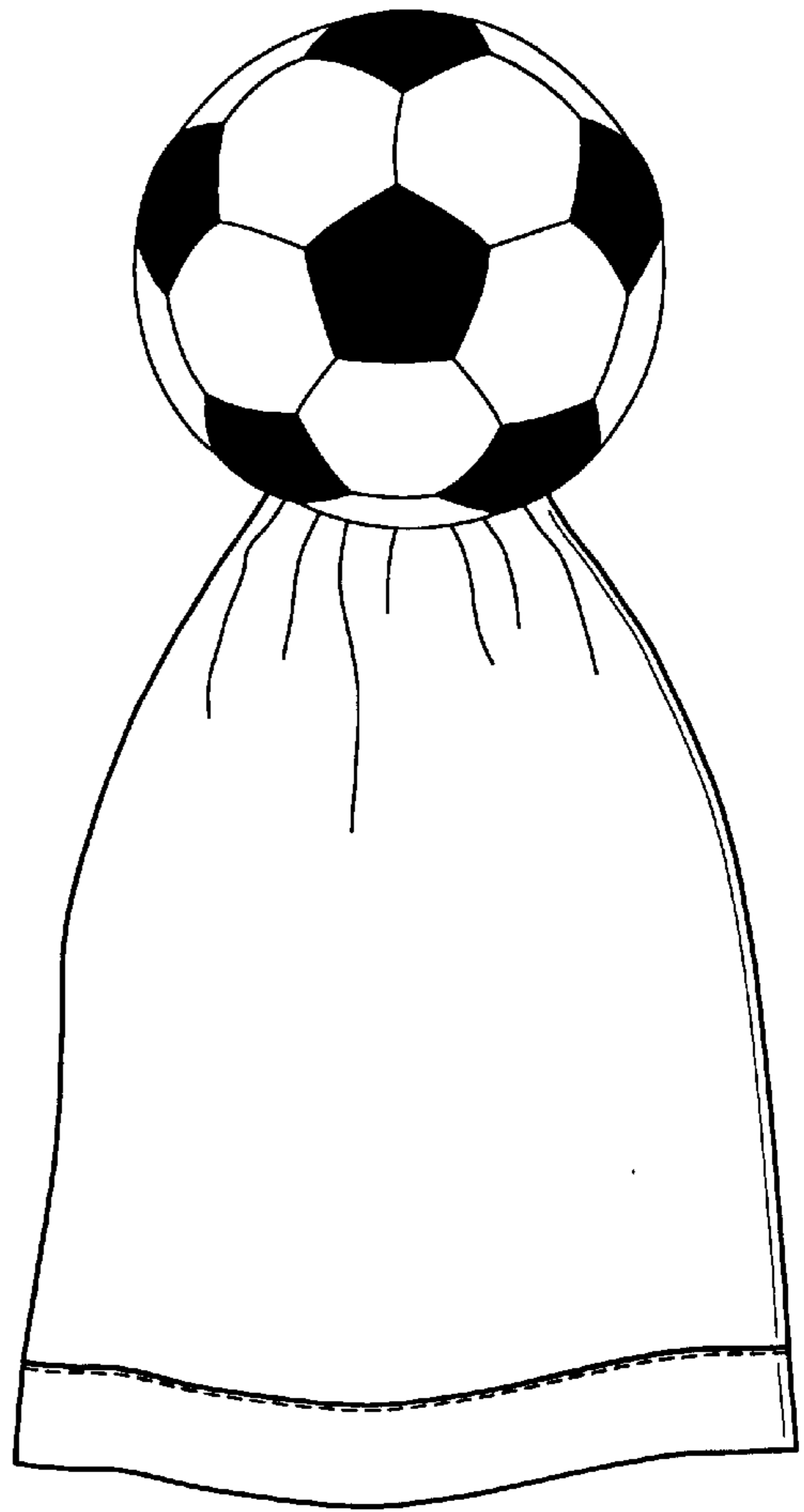
