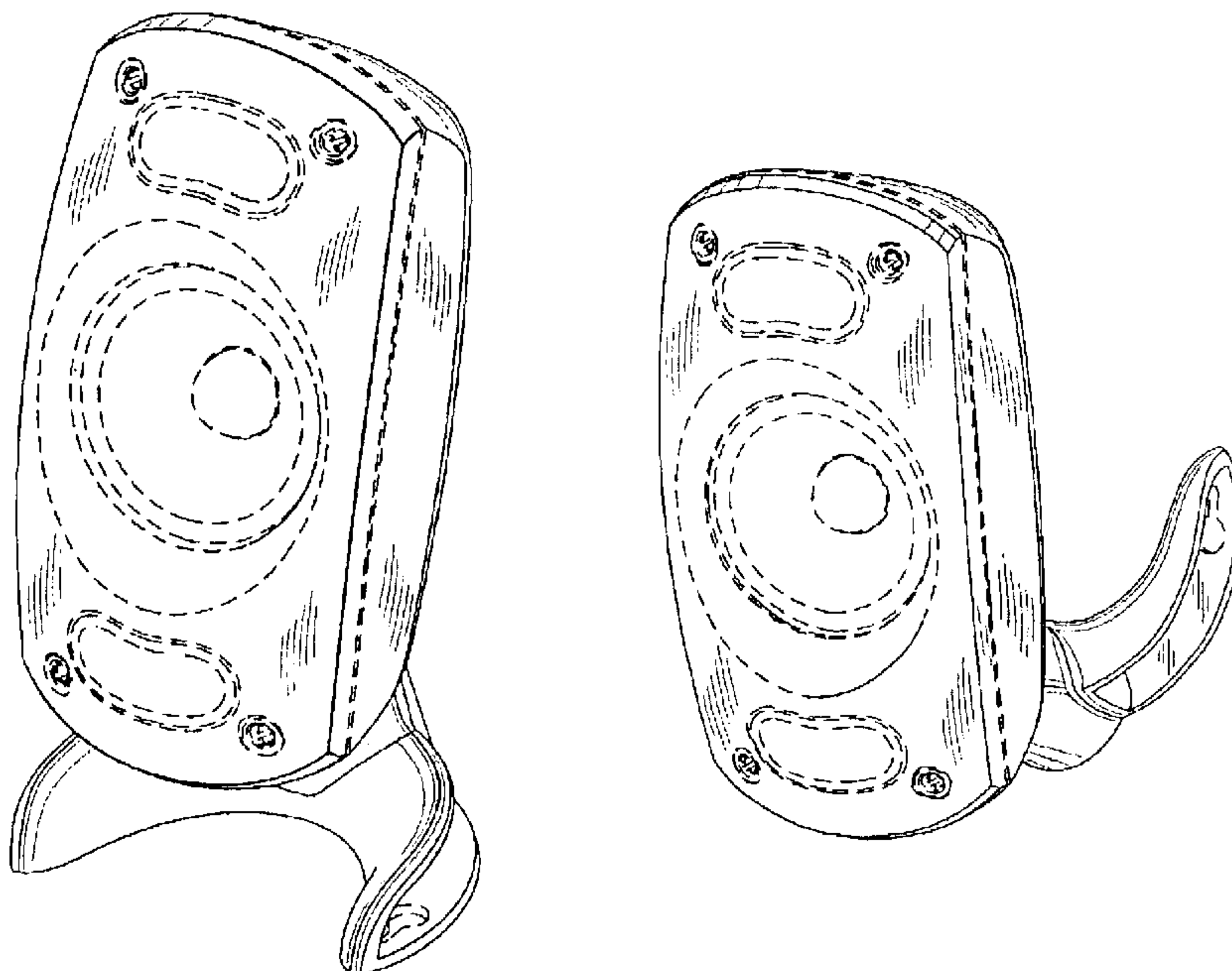
The ornamental design for a speaker with stand, as shown and described.

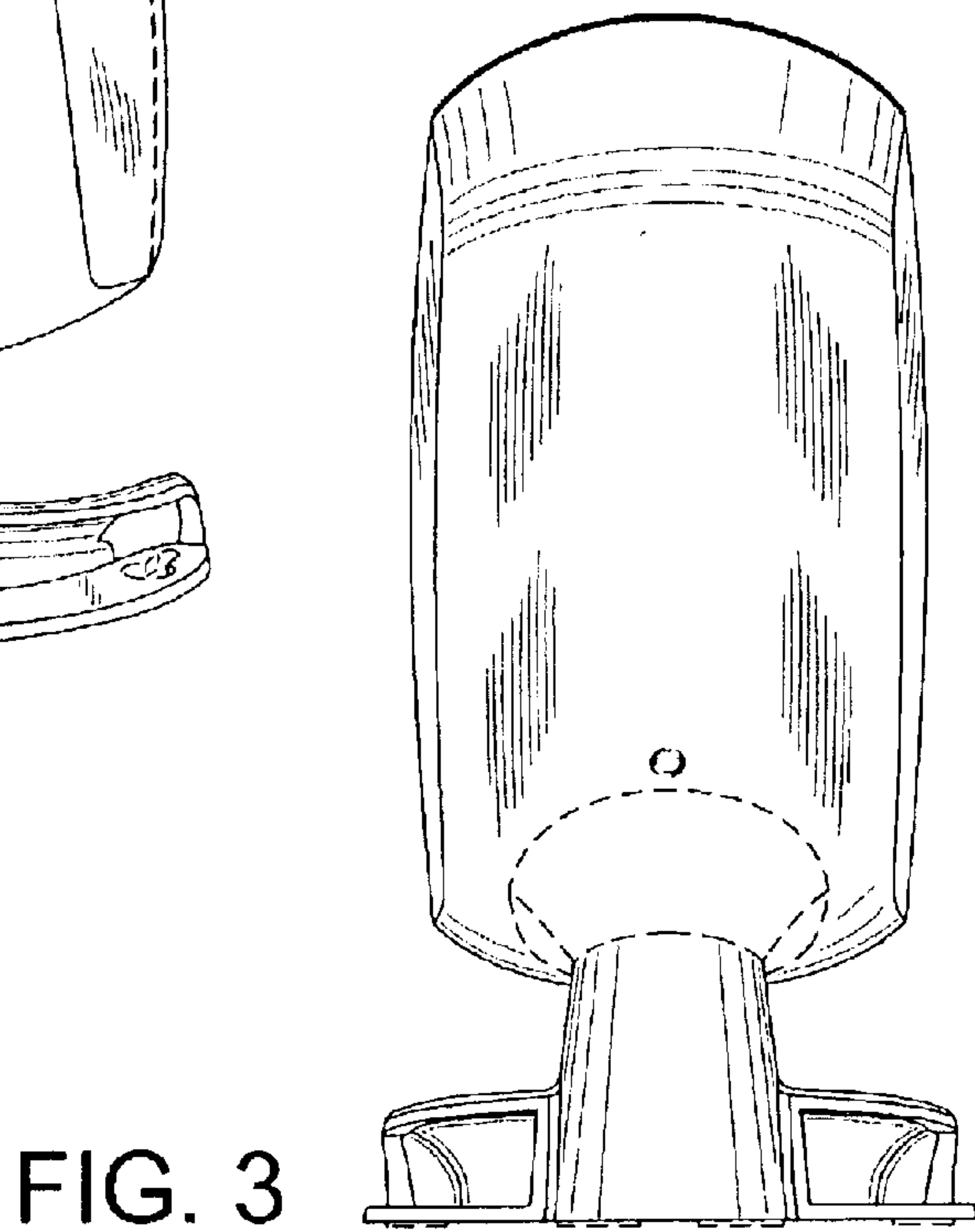
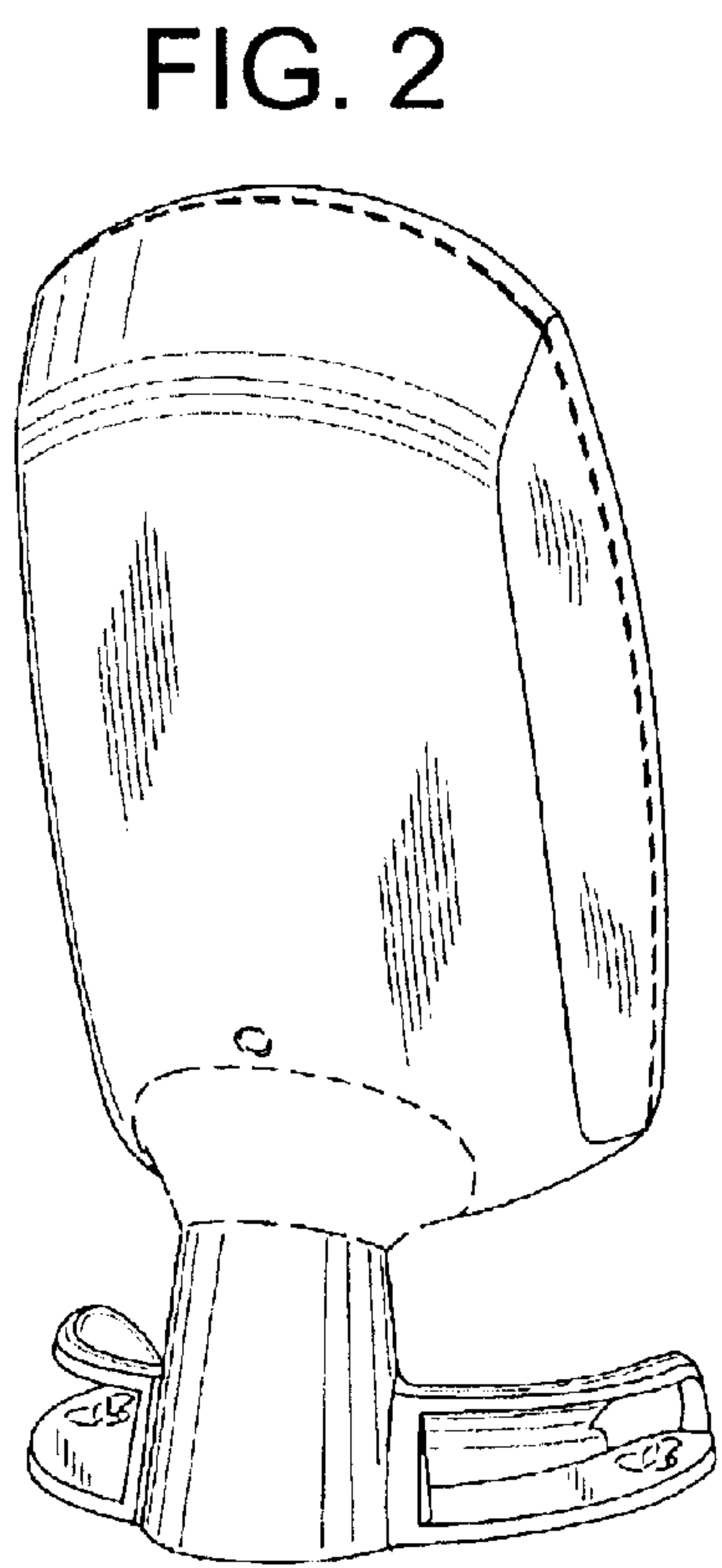
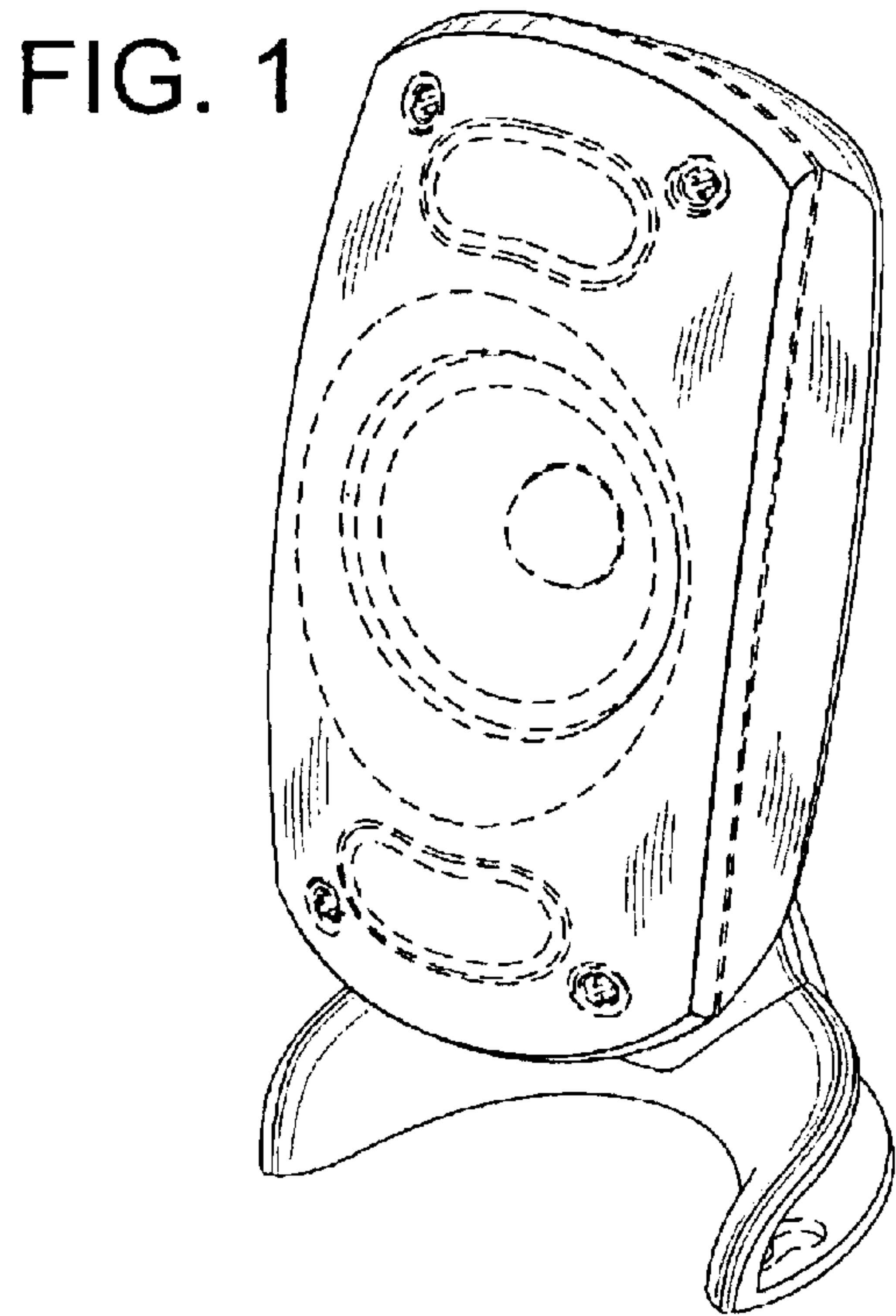
**DESCRIPTION**

FIG. 1 is a front, left perspective view of a speaker with stand showing our new design, with the stand positioned in a first possible position relative to the speaker; FIG. 2 is a rear, right perspective view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a left side elevational view thereof, the right side being a mirror image; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front, left perspective view of FIG. 1, with the stand positioned in a second possible position relative to the speaker; FIG. 9 is a rear elevational view thereof; FIG. 10 is a rear, right perspective view thereof; FIG. 11 is a top plan view thereof; FIG. 12 is a front elevational view thereof; FIG. 13 is a left side elevational view thereof, the right side being a mirror image; and, FIG. 14 is a bottom plan view thereof.

The broken lines showing the stand mounting portion, stand feet, seams, vents, speaker cone, speaker cone opening, and mounting holes and hardware are for illustrative purpose only and form no part of the claimed design.

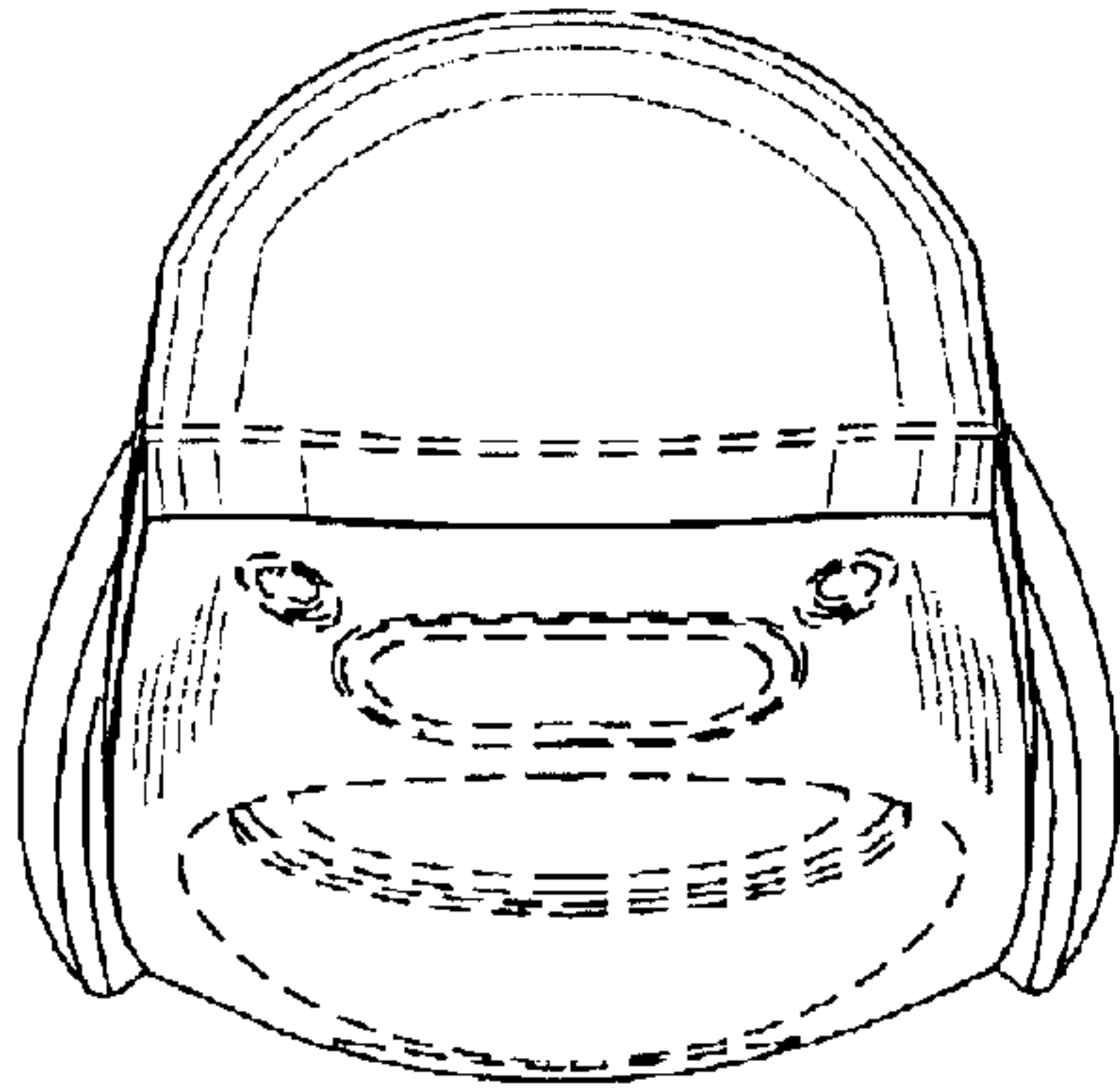

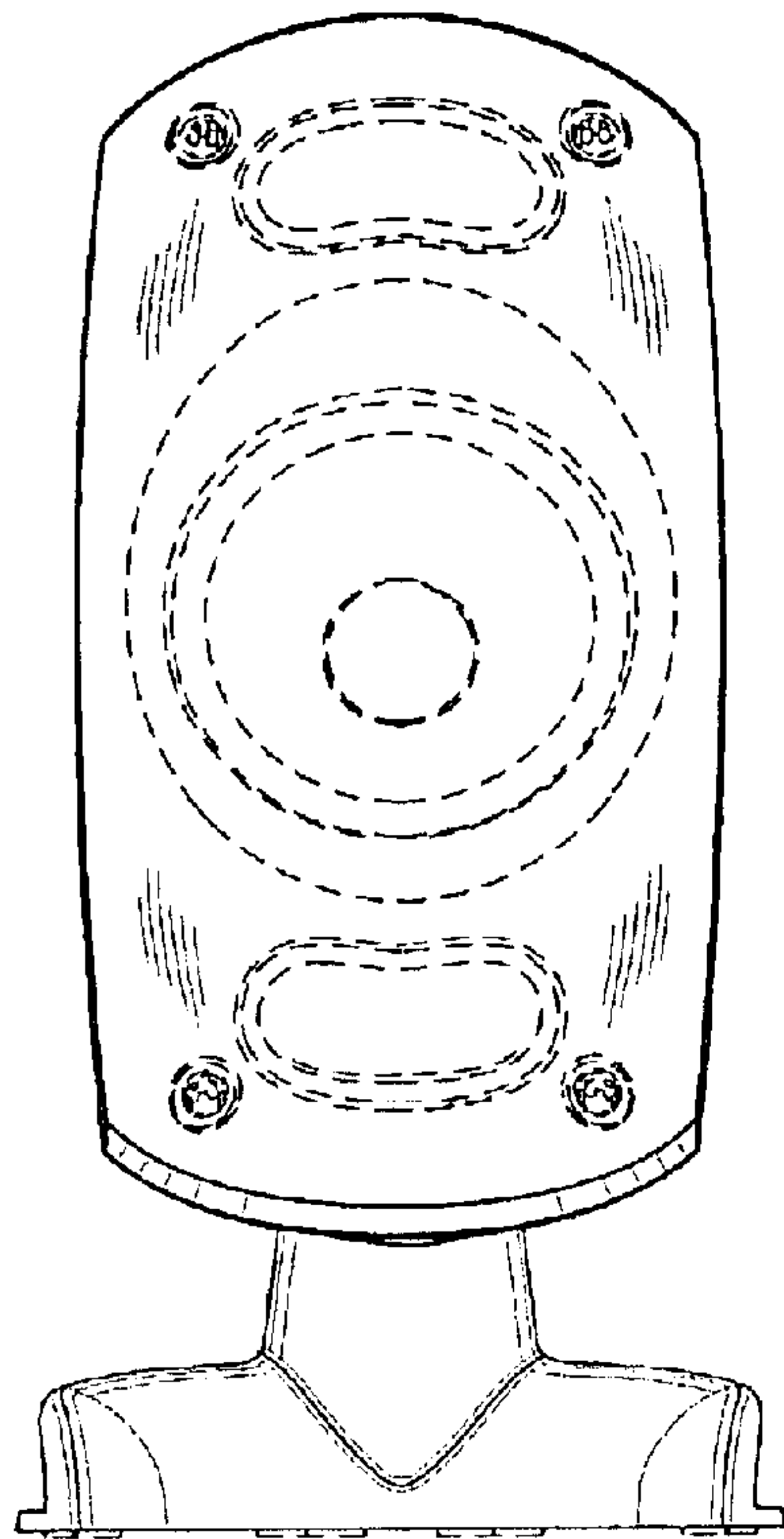

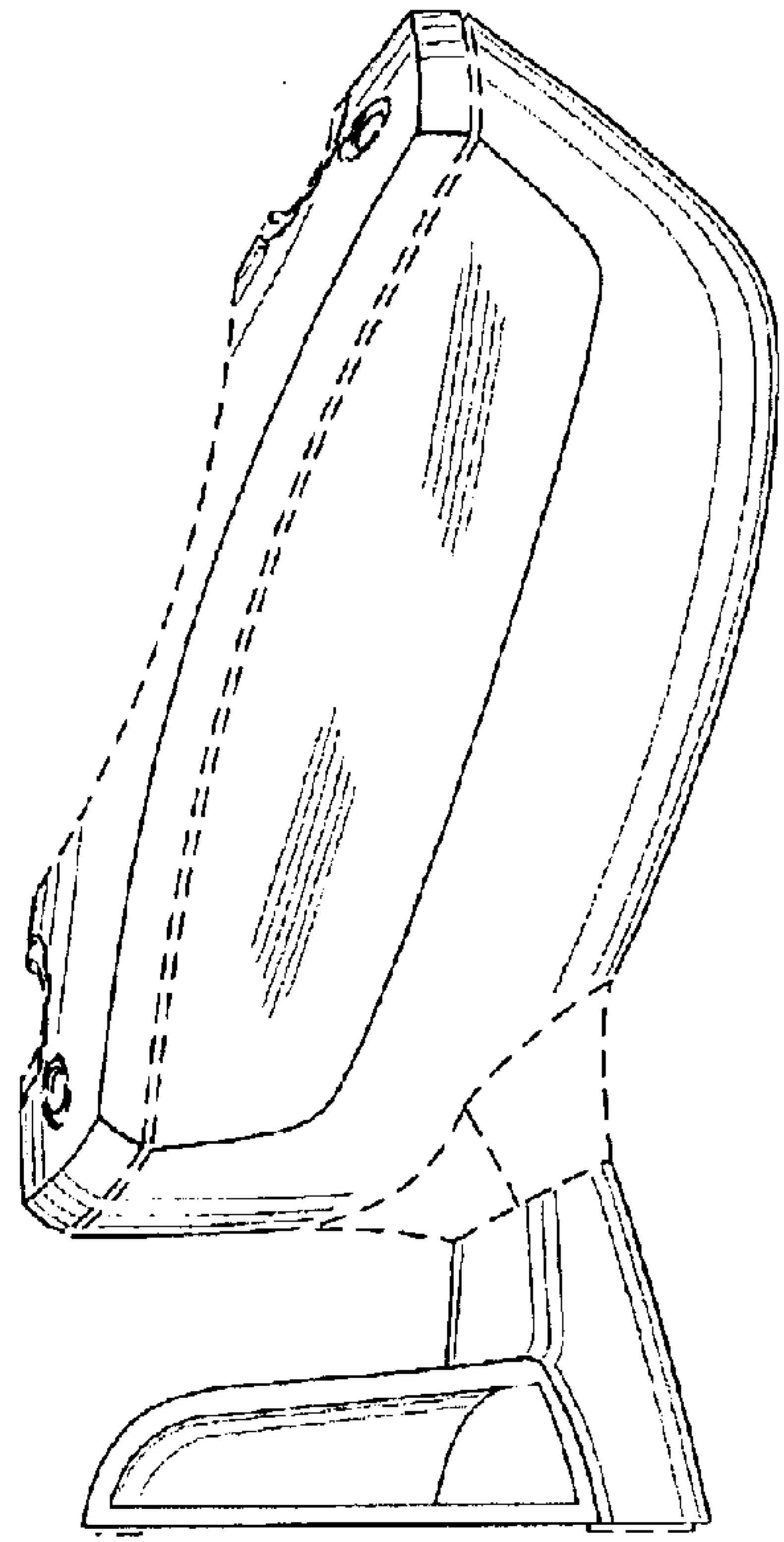

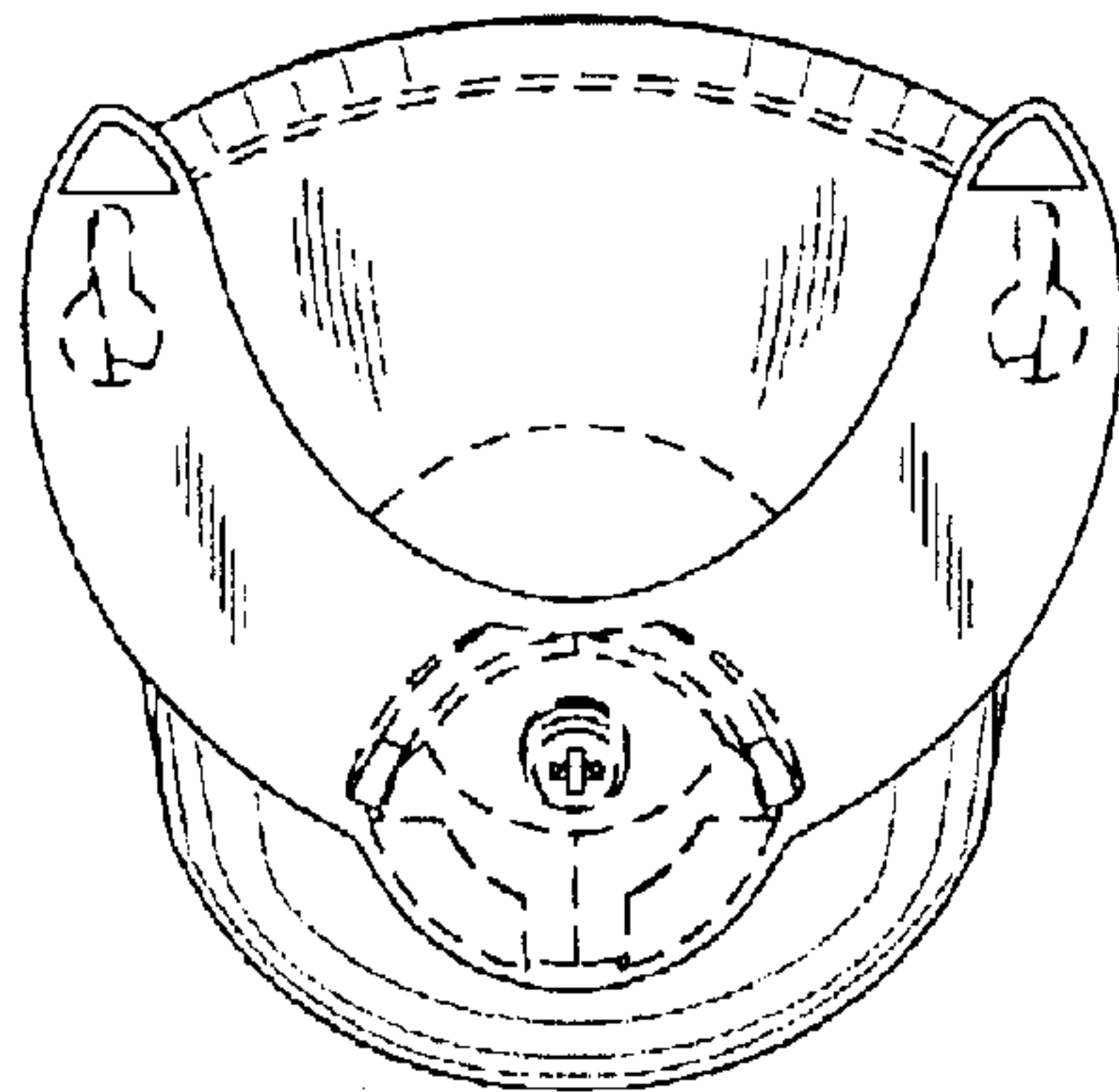

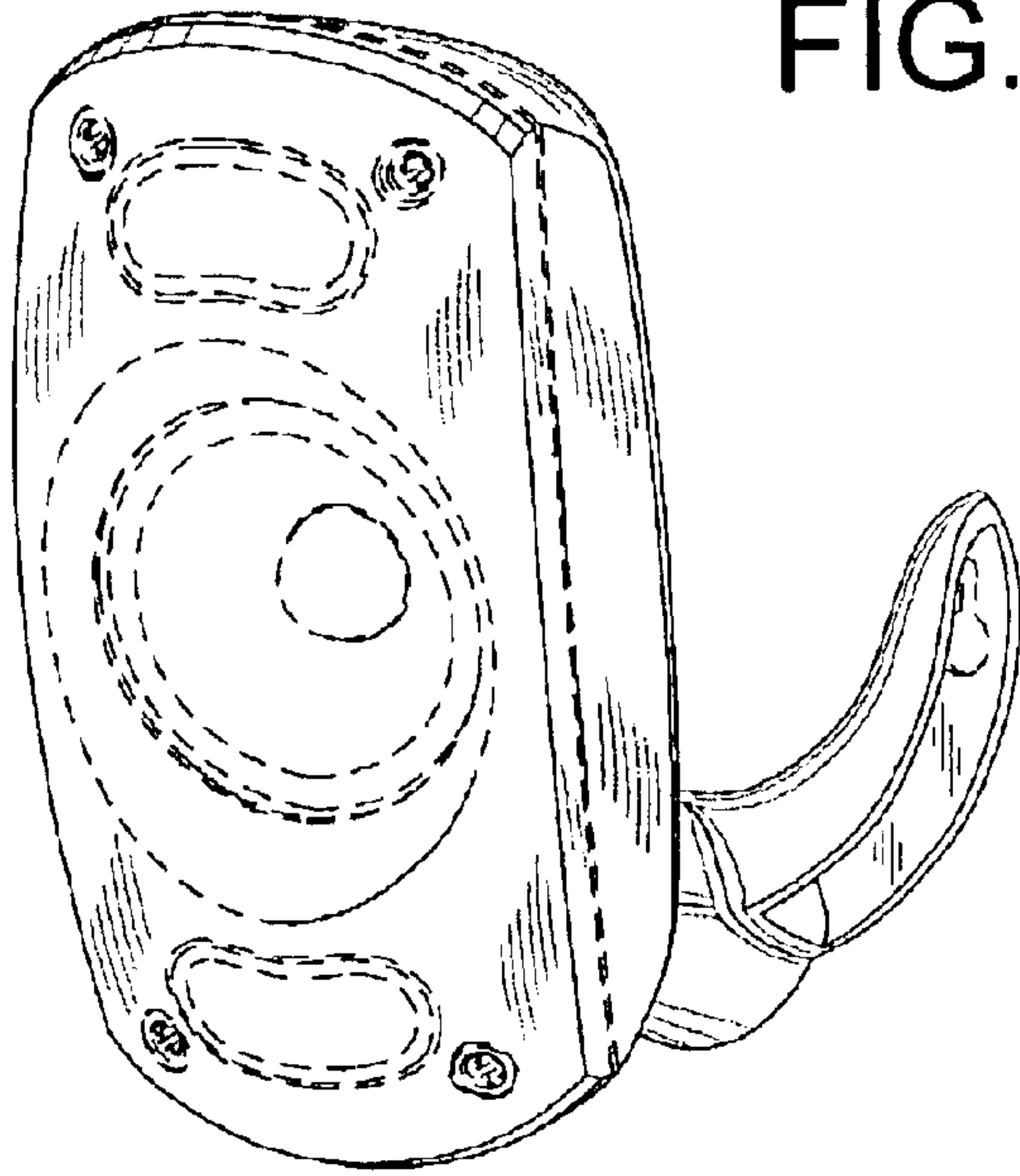

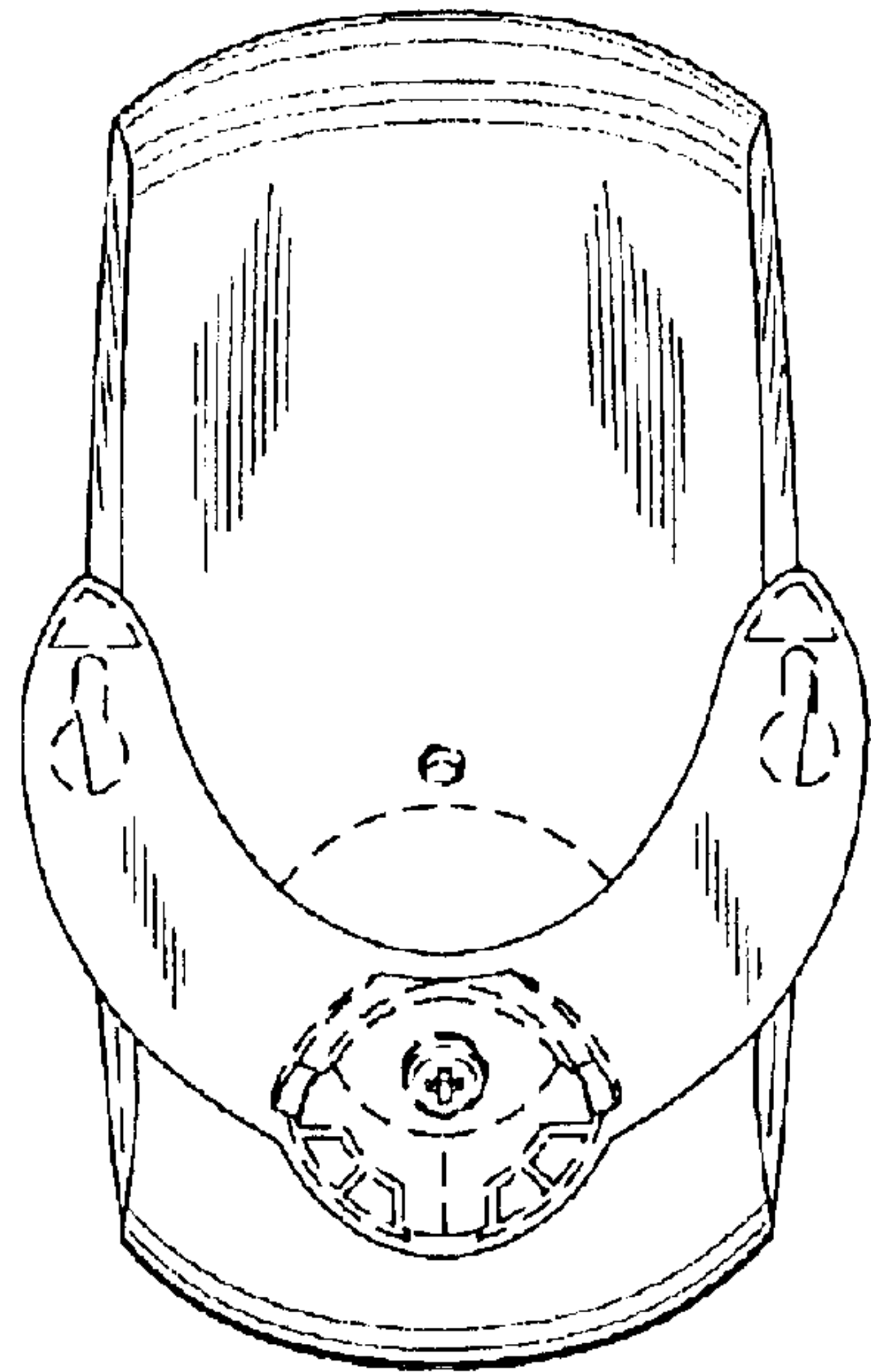
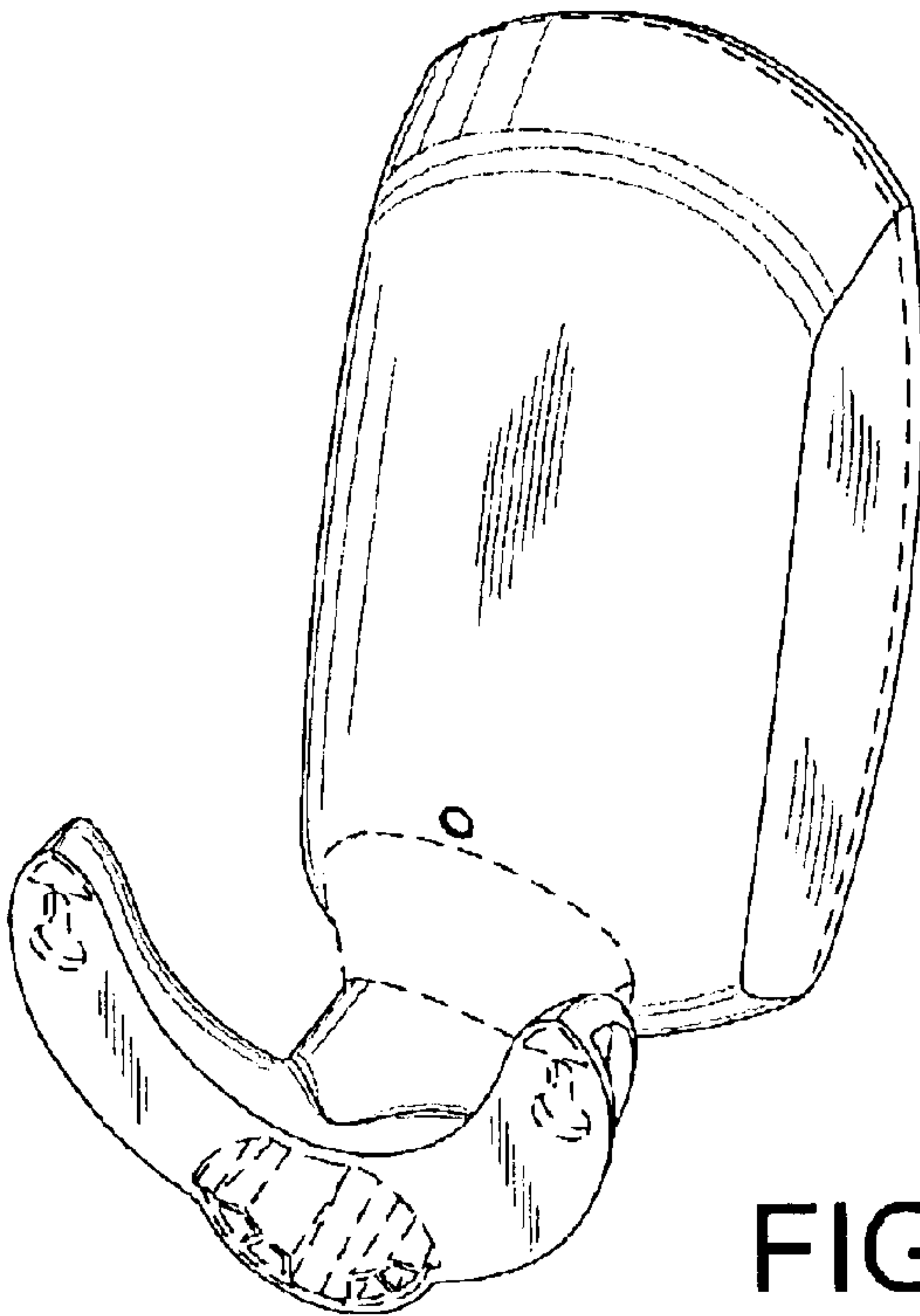

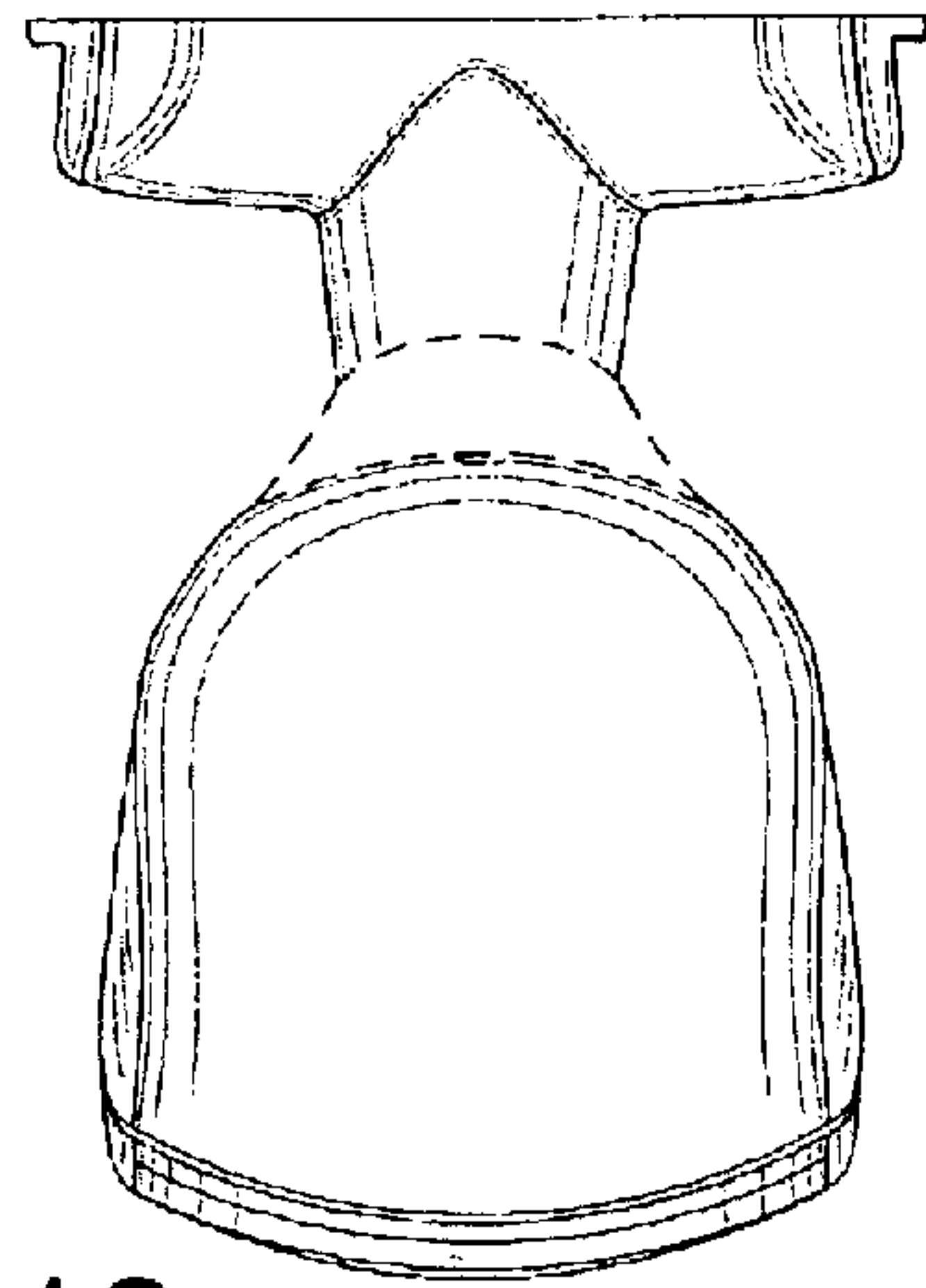

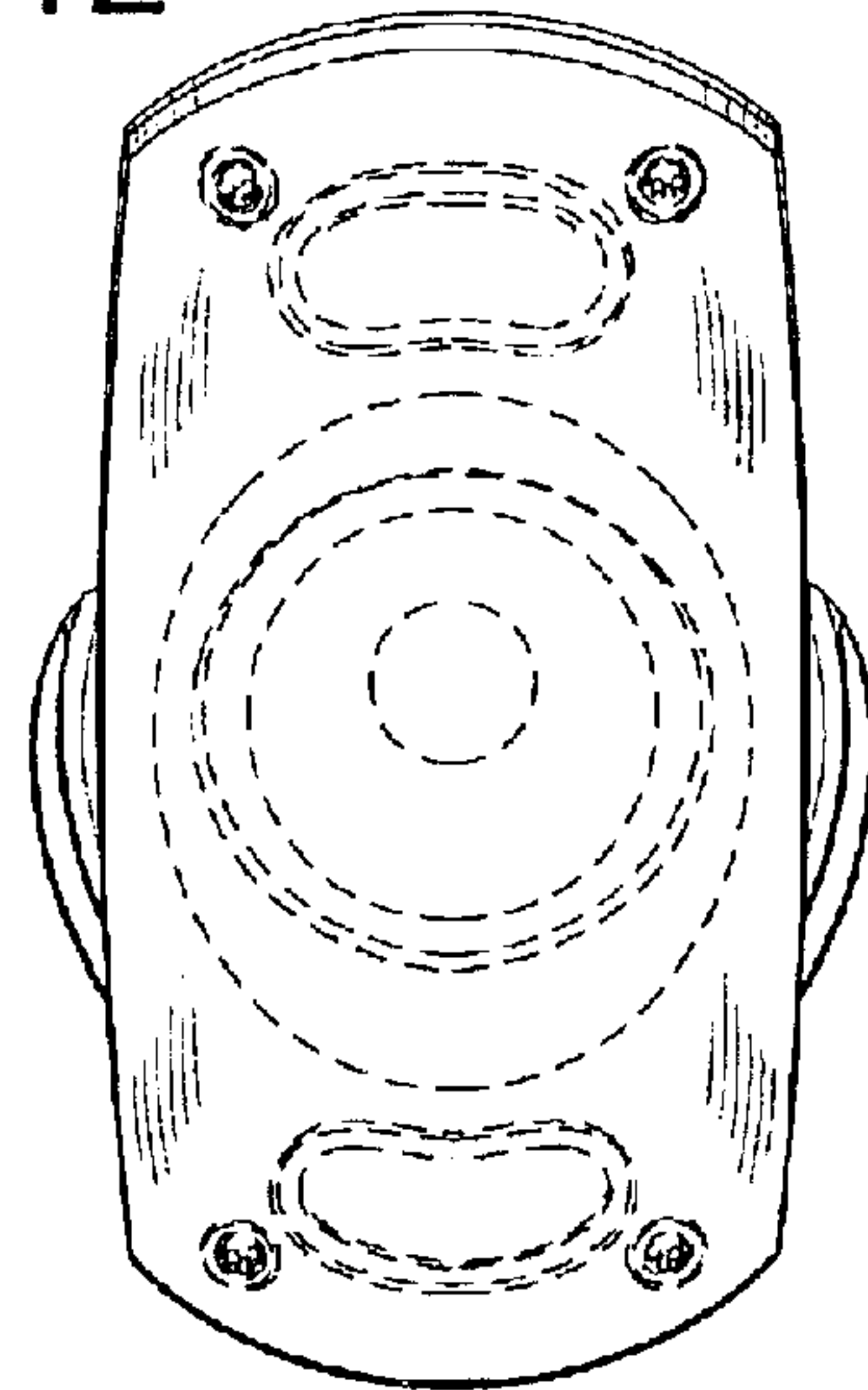

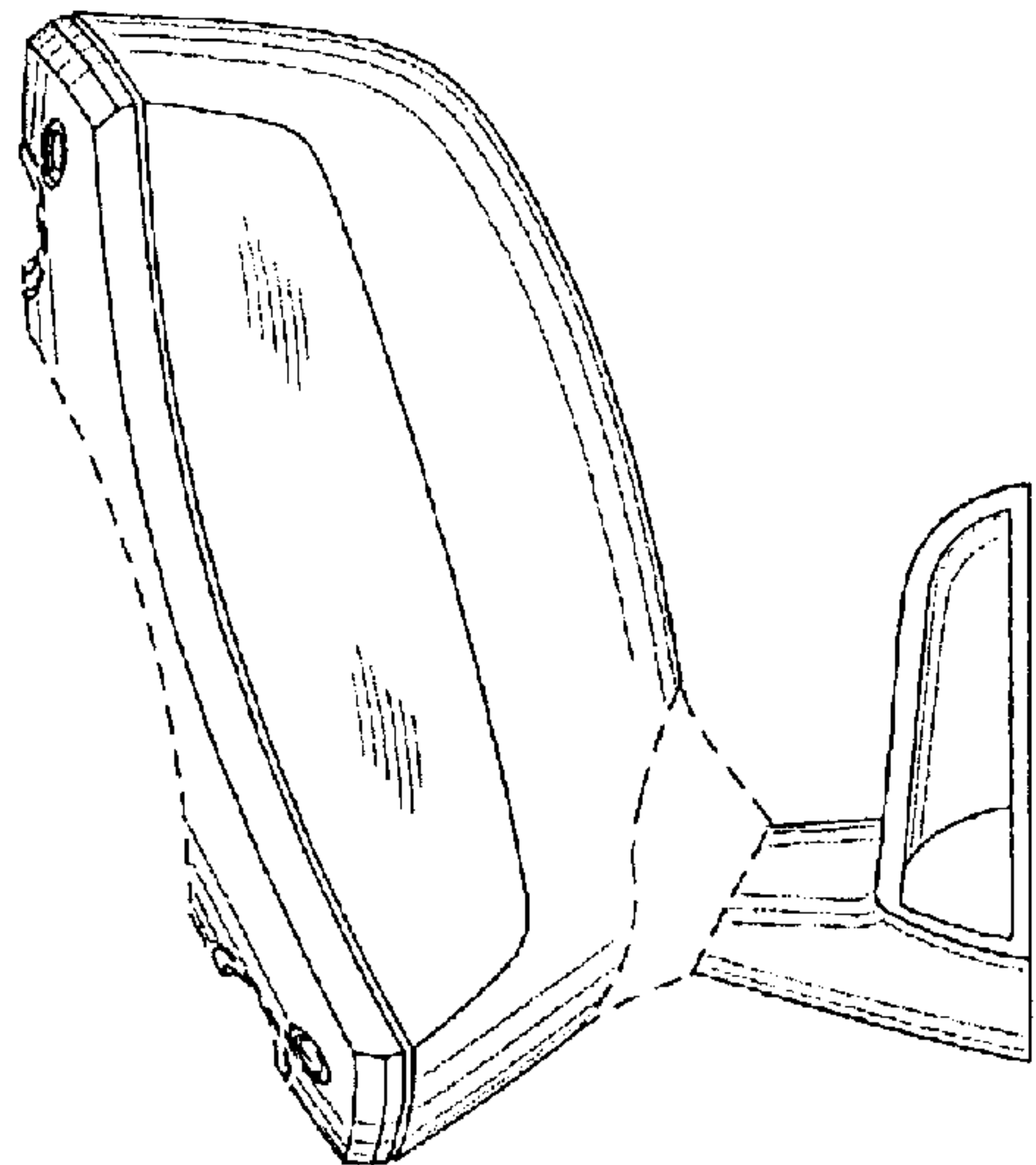
