(57) **CLAIM**

The ornamental design for a set of stackable baseball dolls, as shown and described.

**DESCRIPTION**

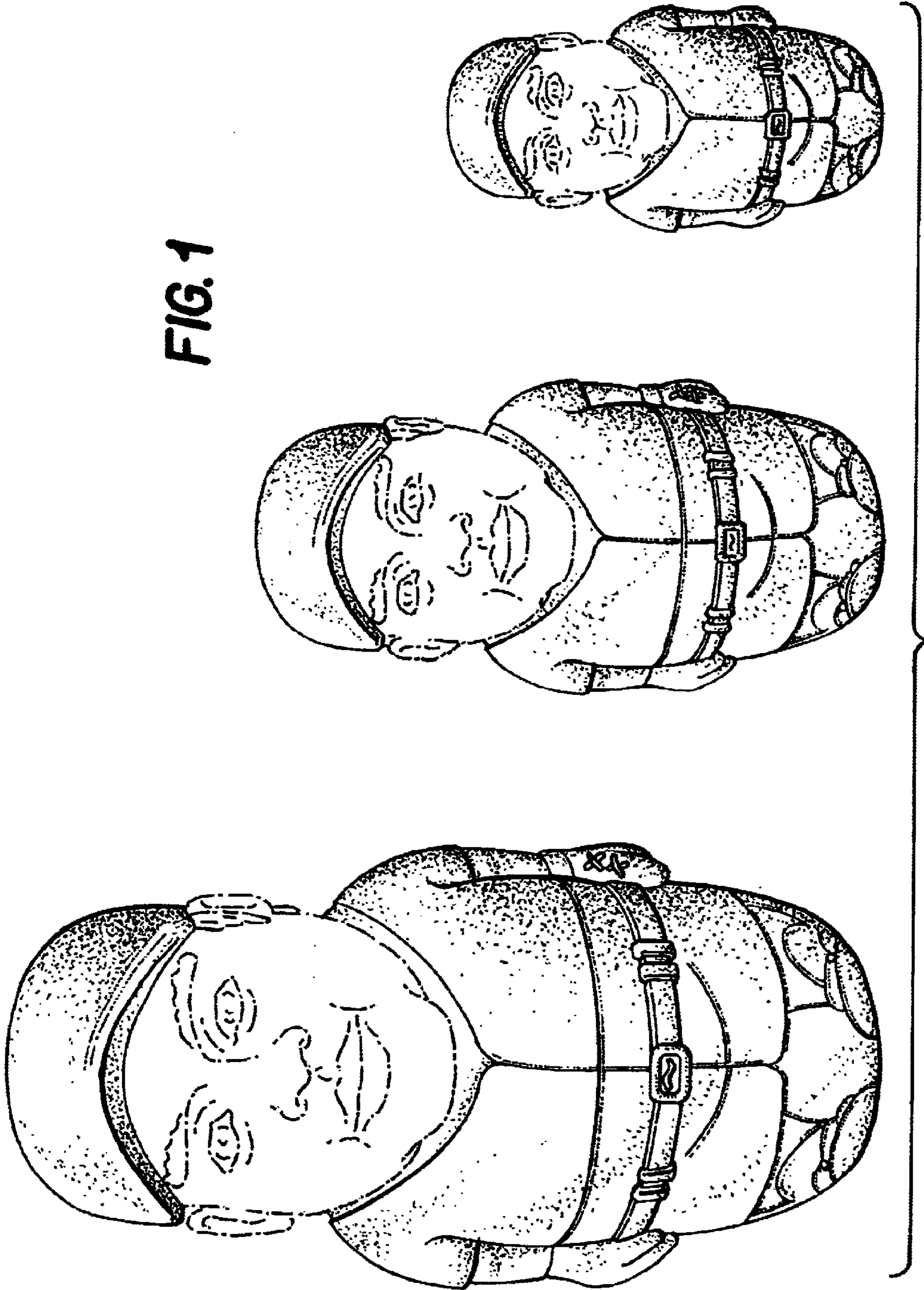

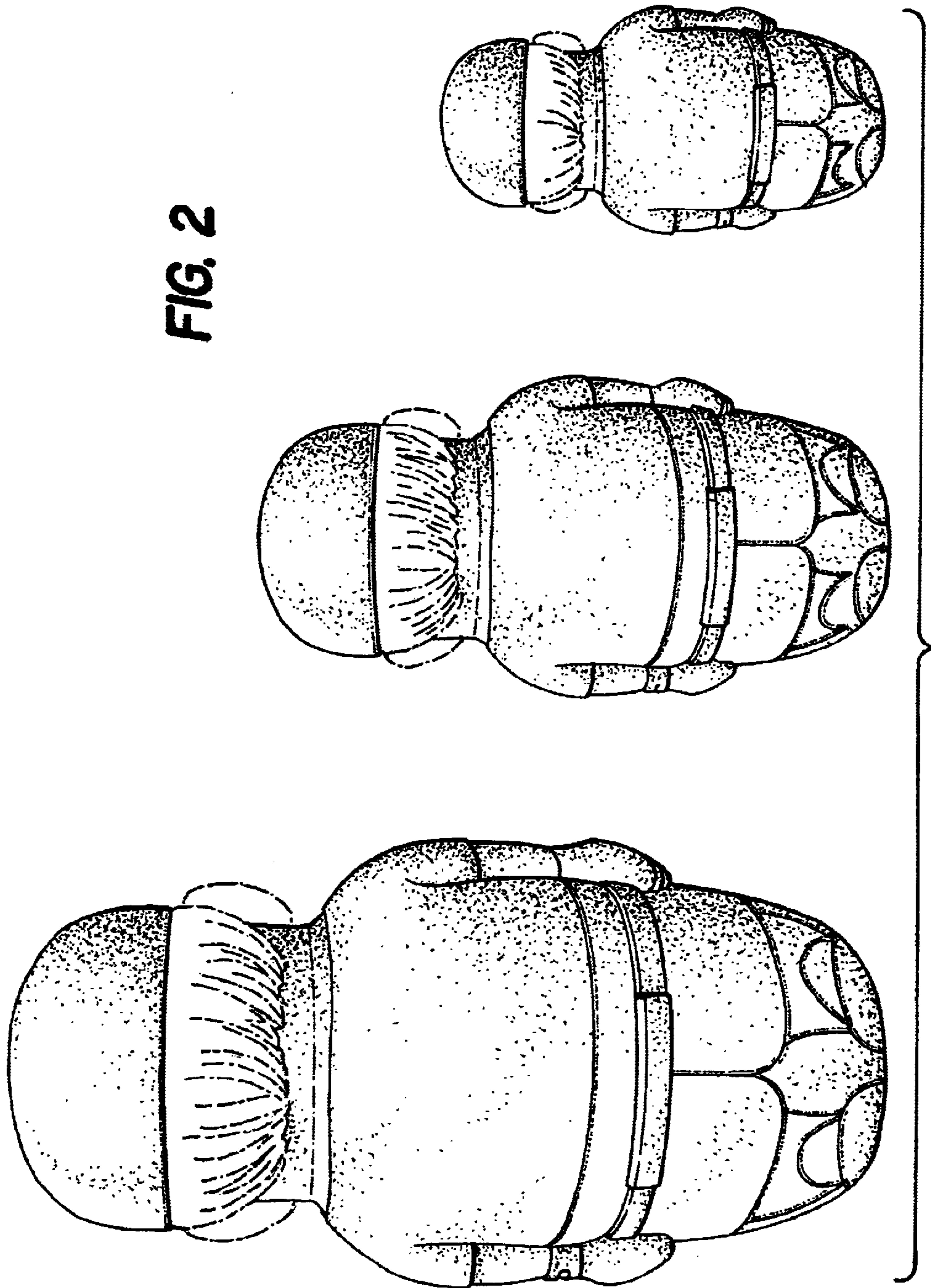

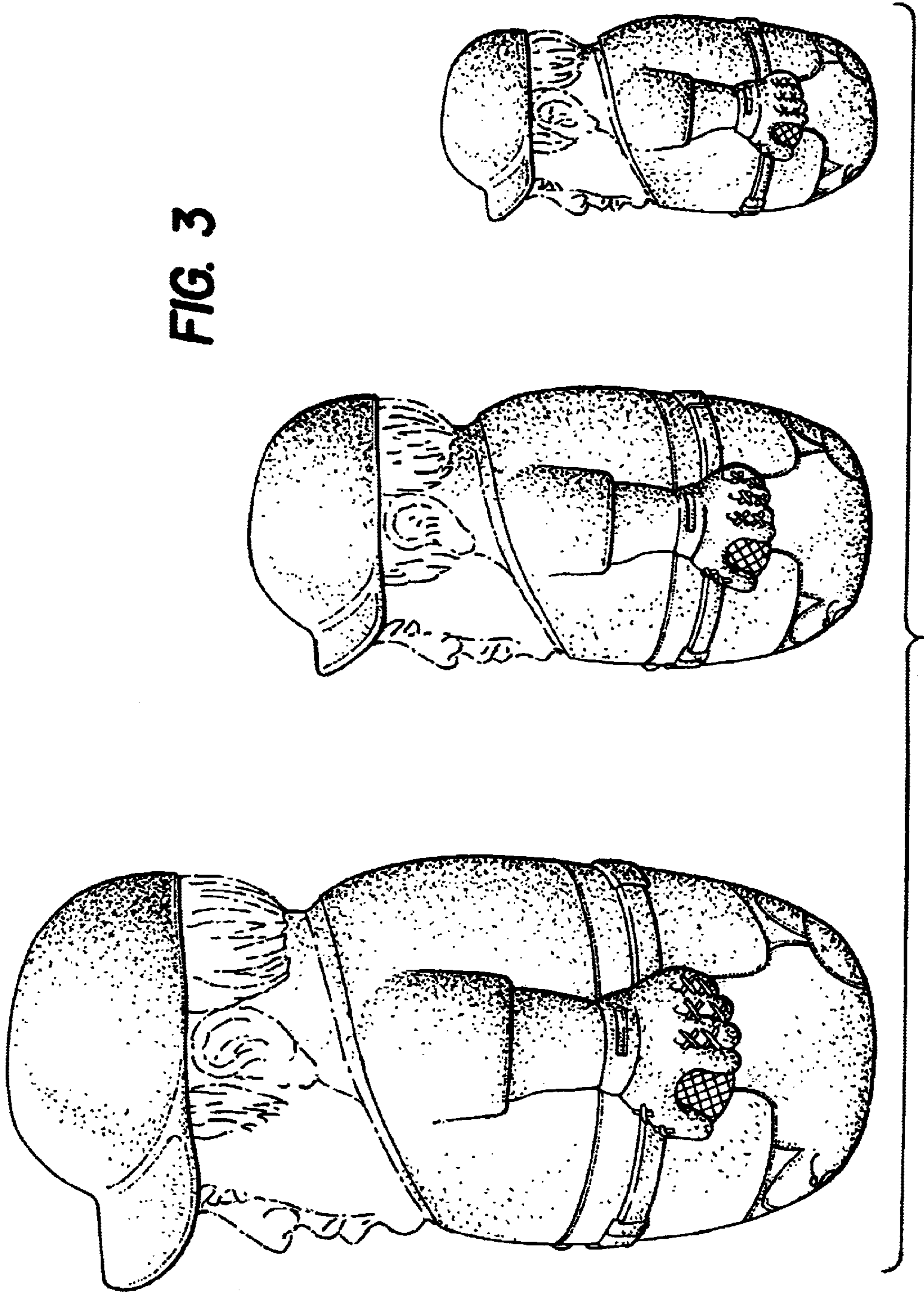
