The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the golf club head as claimed herein;

FIG. 2 is a rear elevational view of the golf club head thereof;

FIG. 3 is a toe elevational view thereof;

FIG. 4 is a heel elevational view thereof;

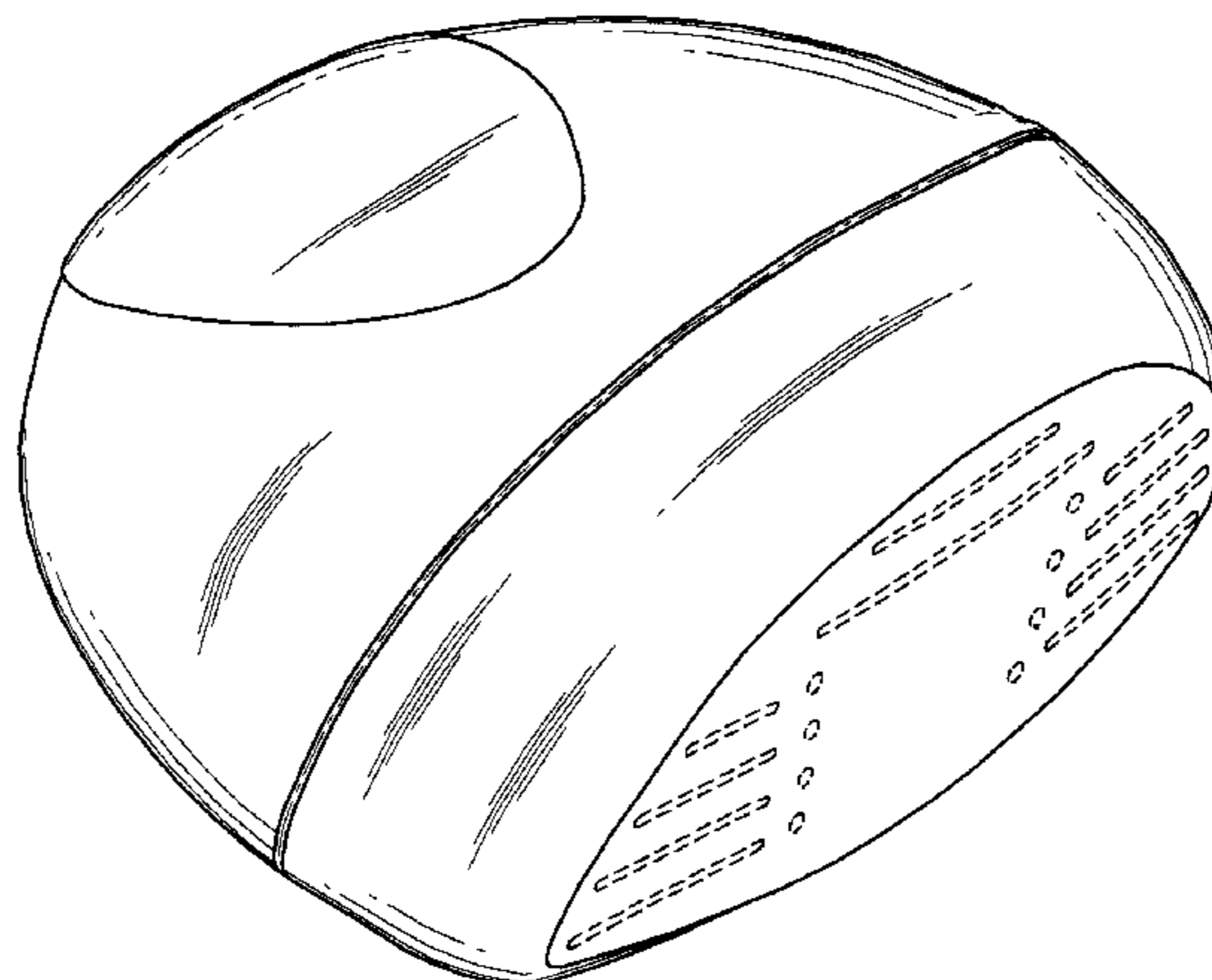
FIG. 5 is a top plan view thereof;

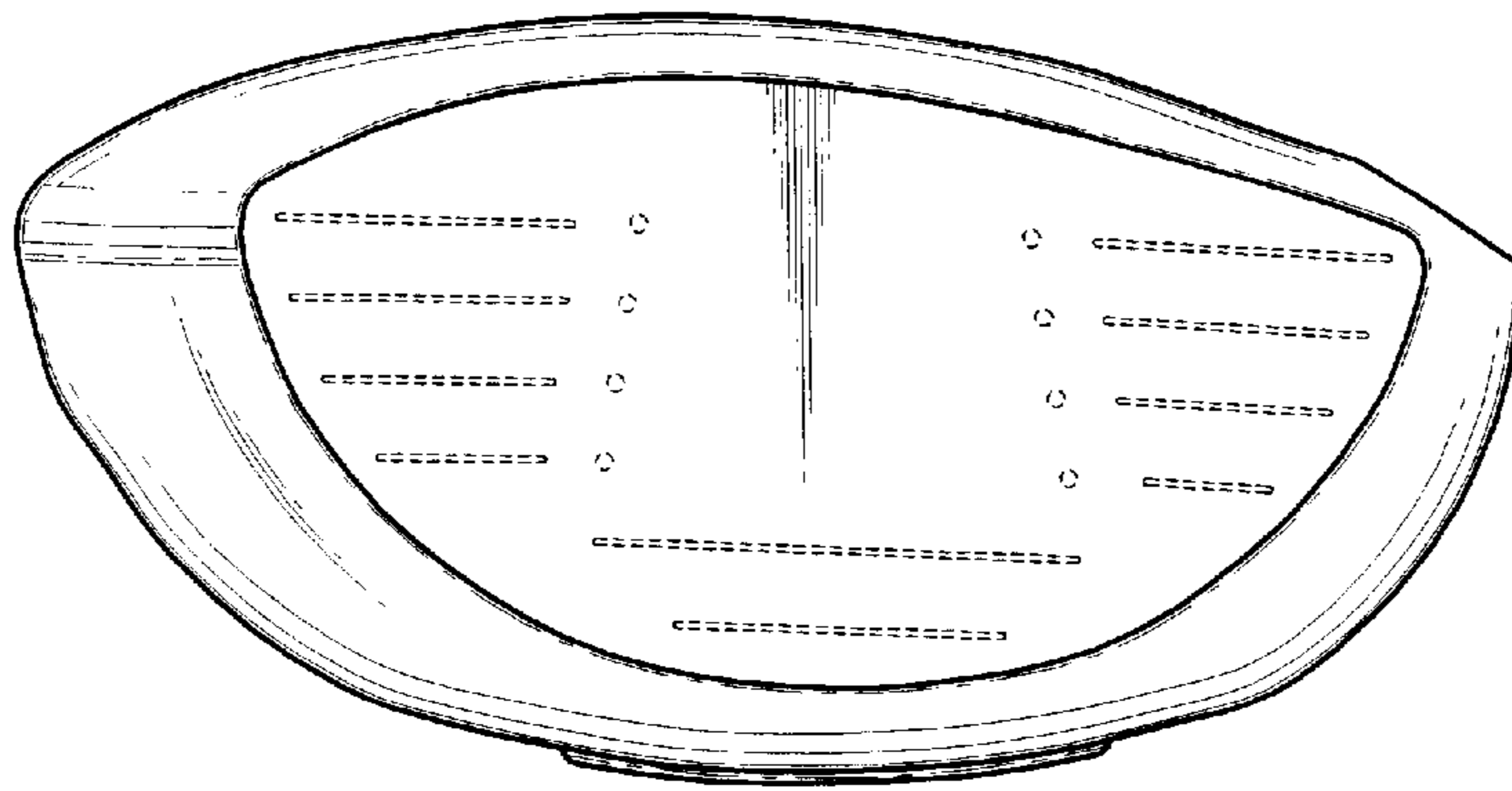

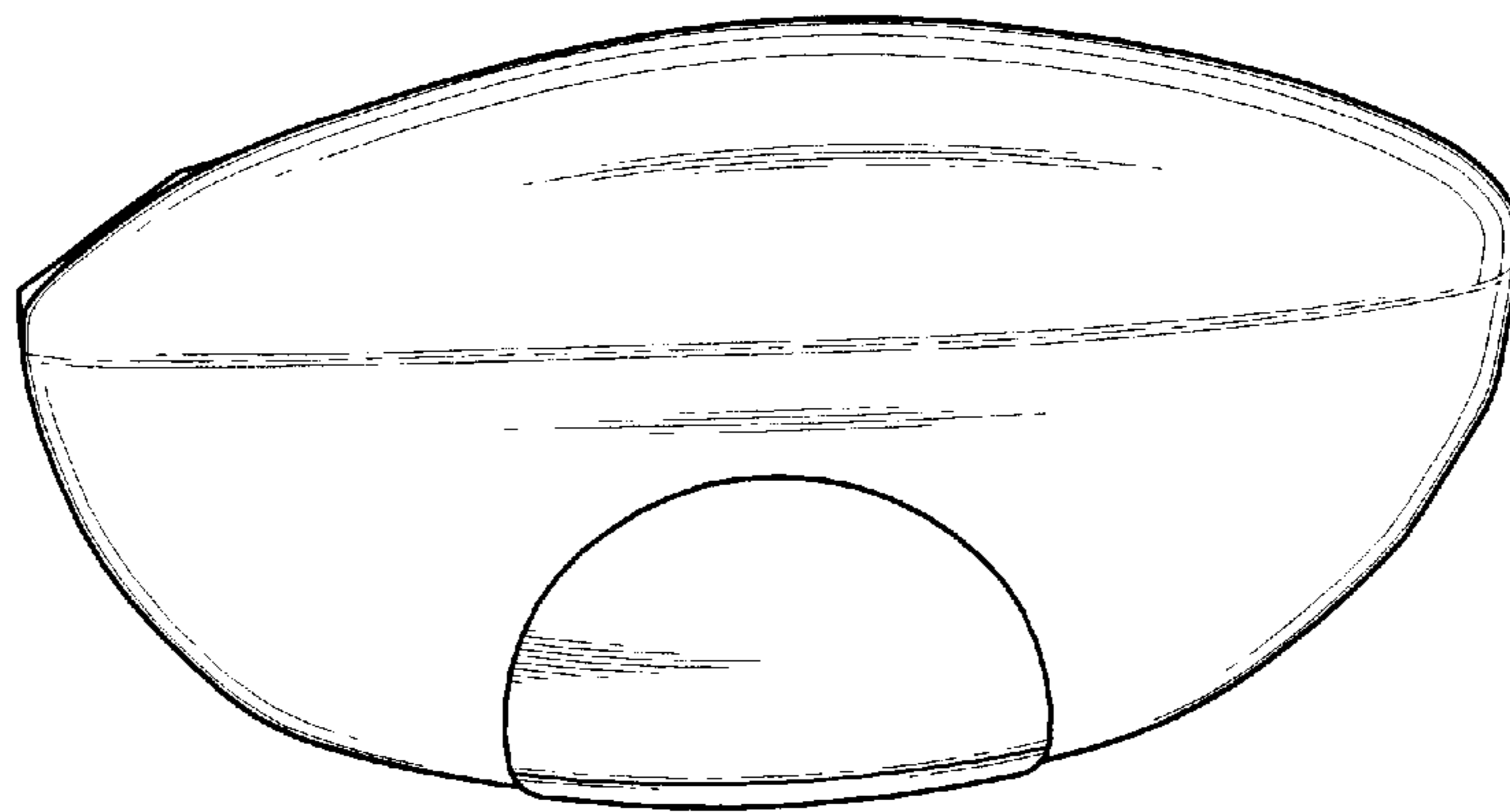

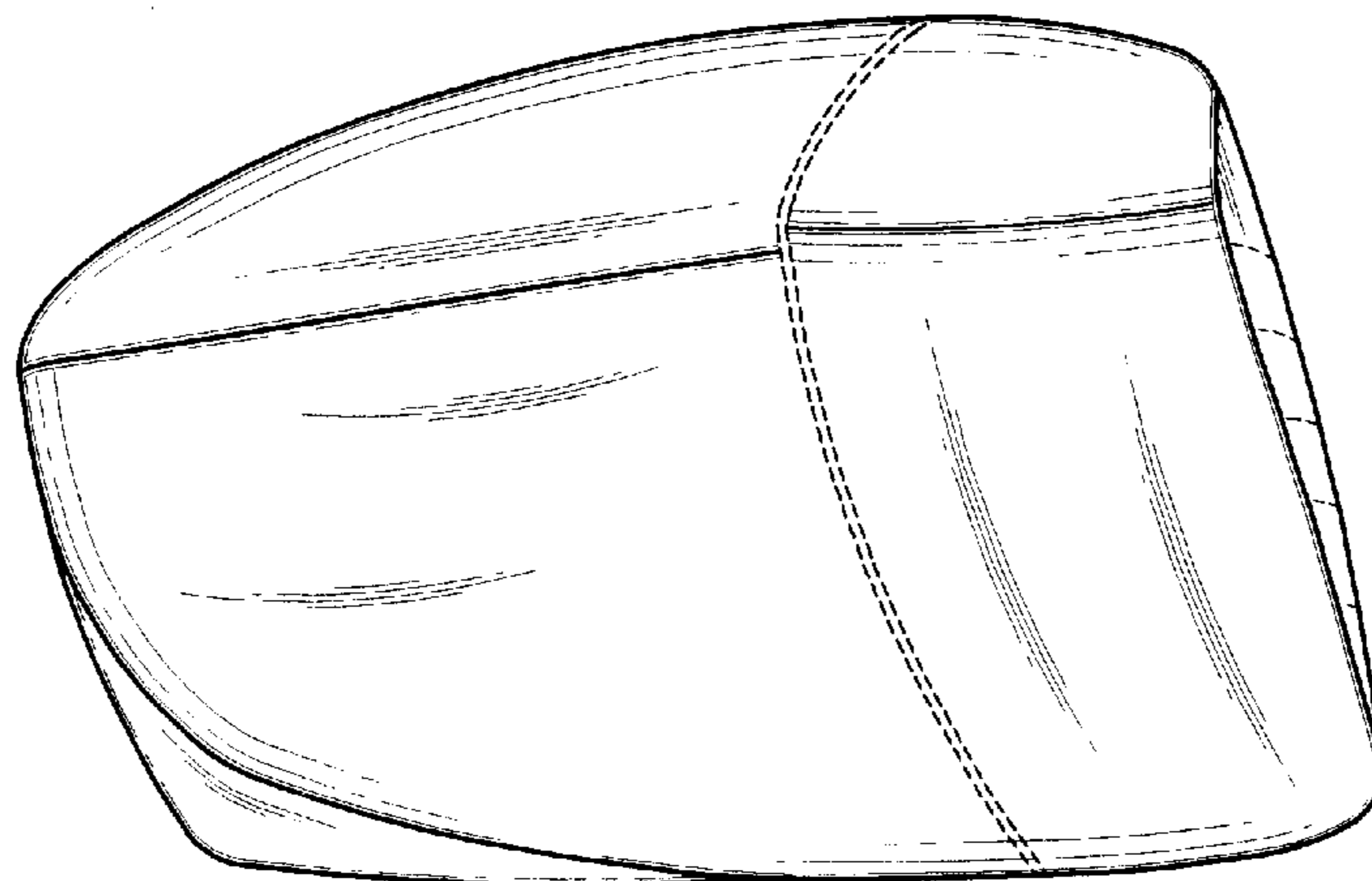

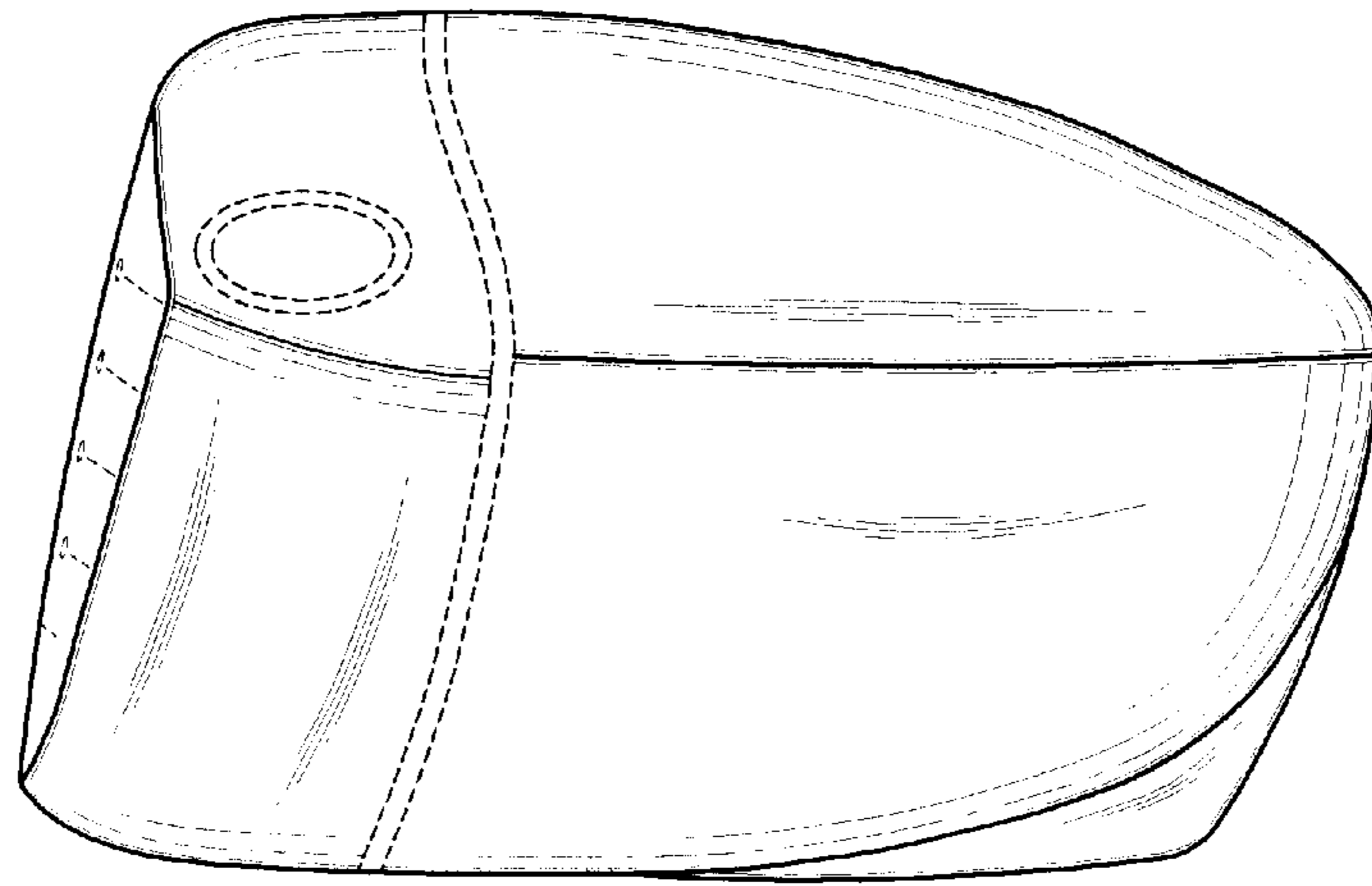

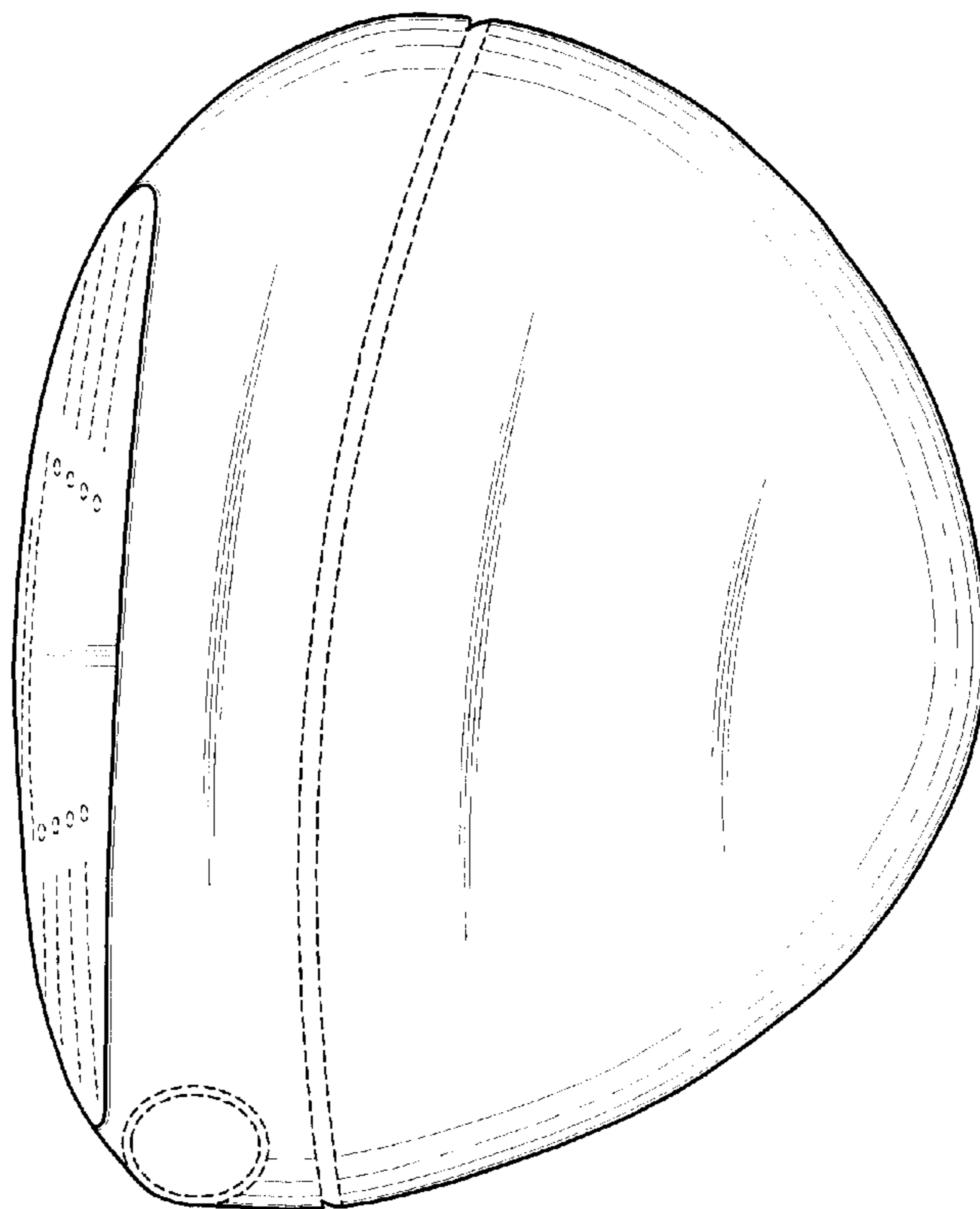

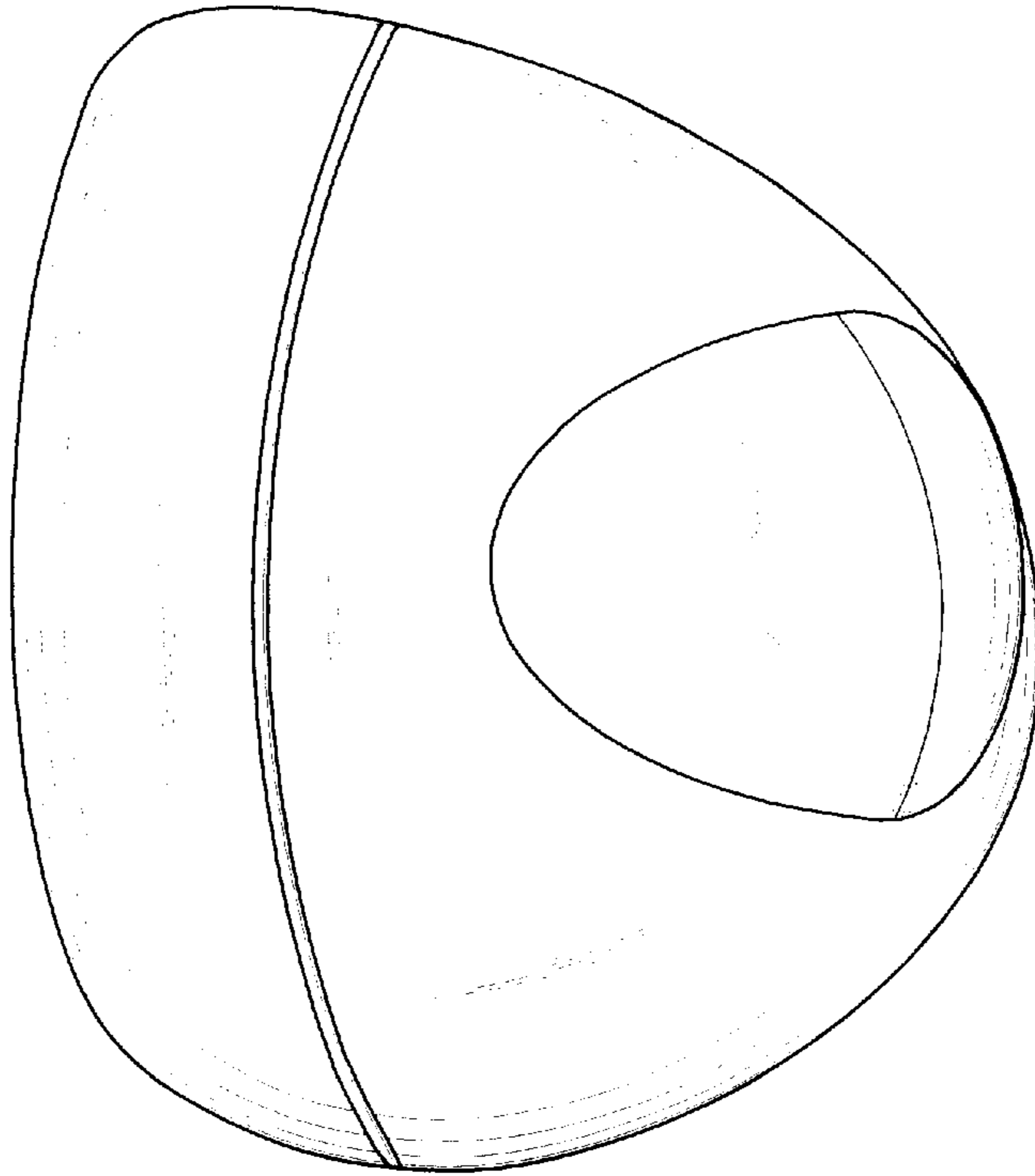

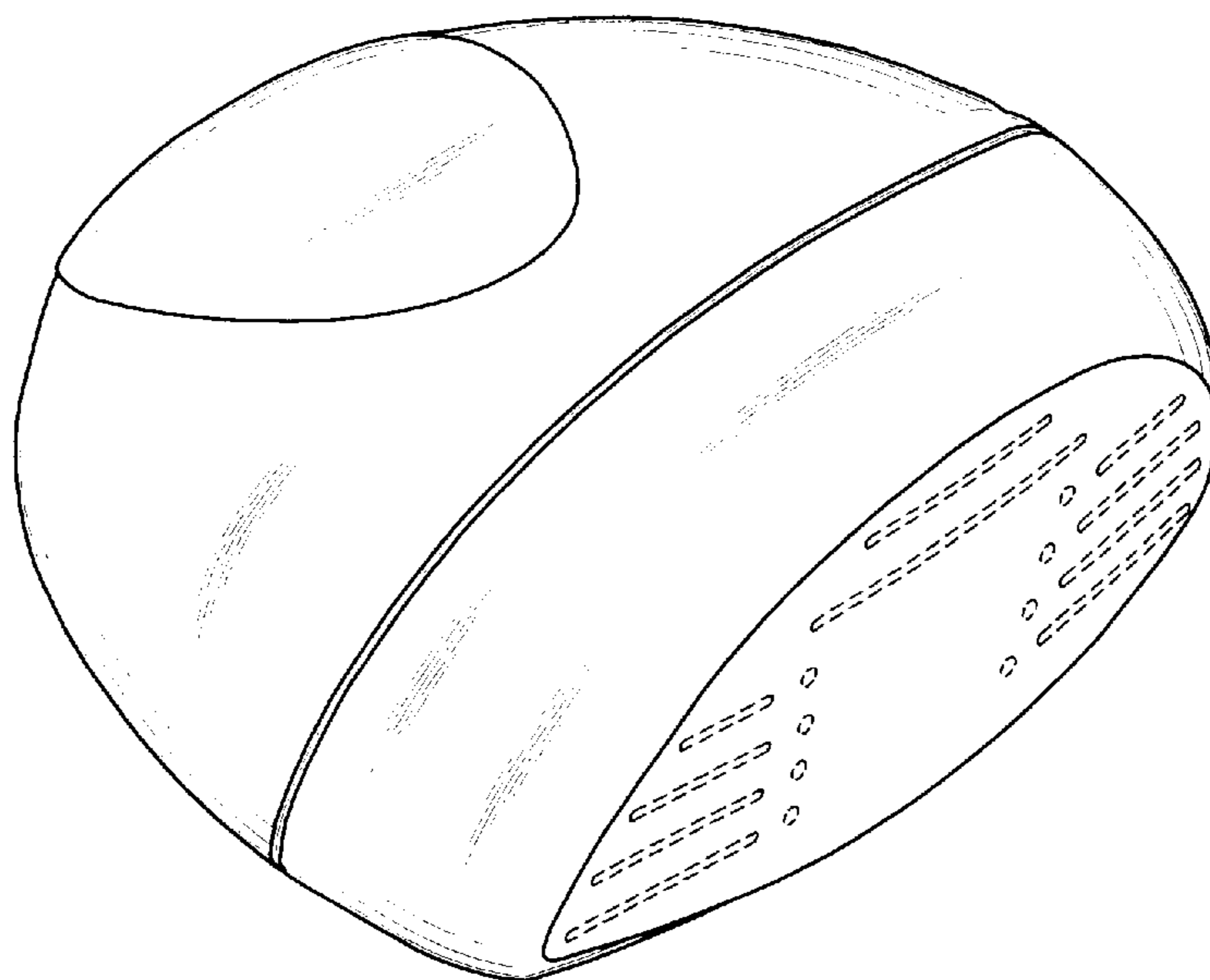
