DESCRIPTION

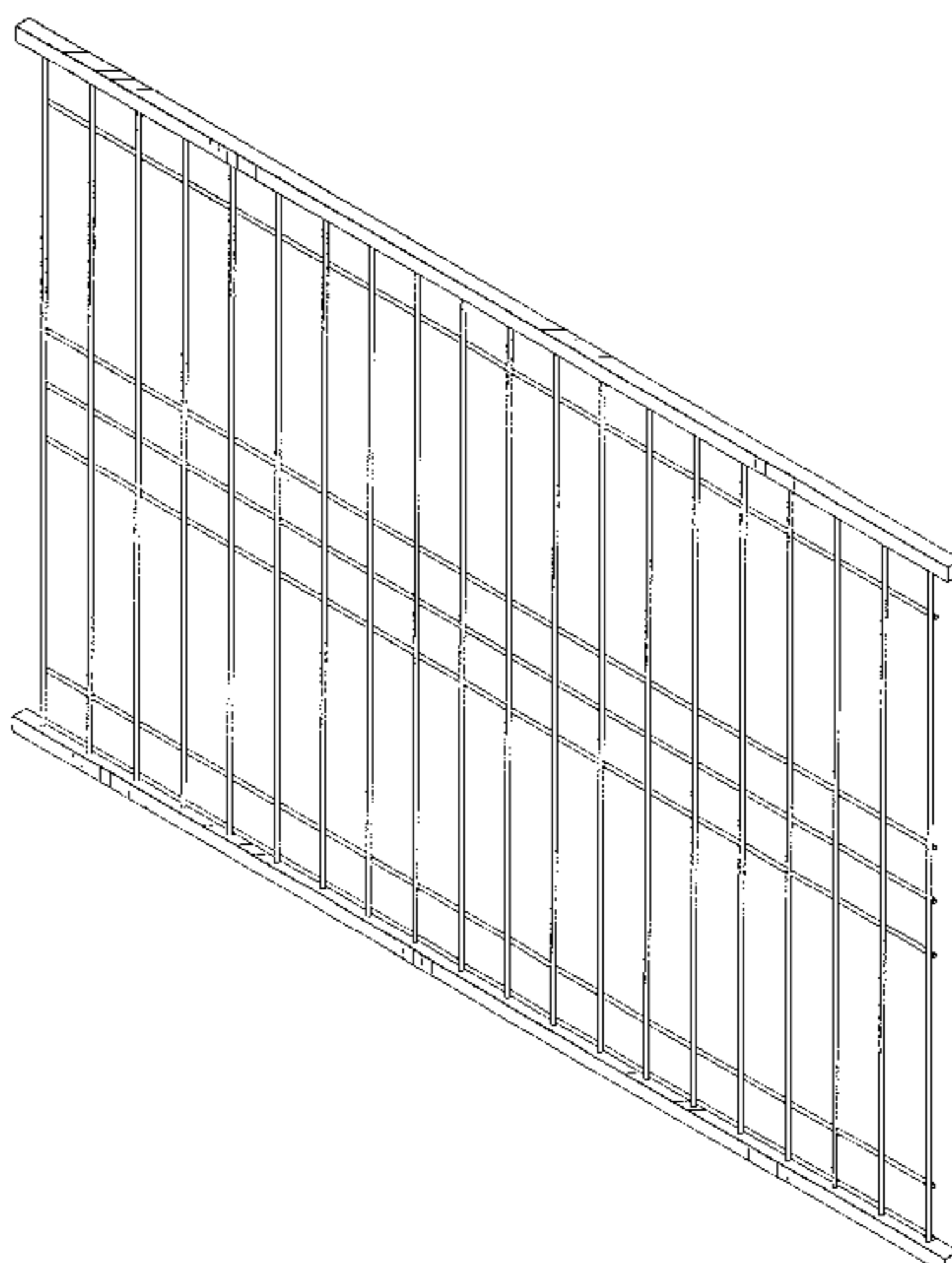

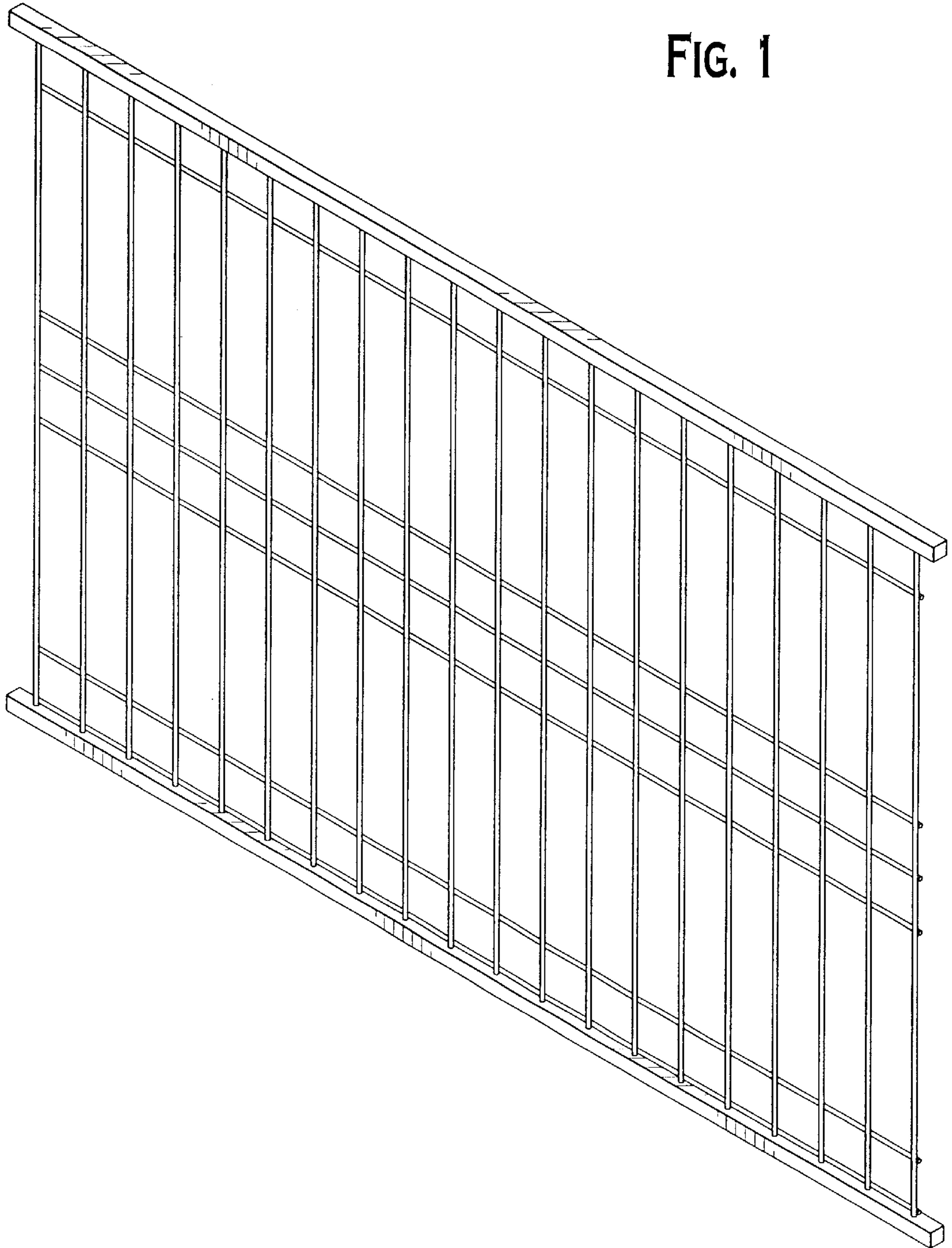

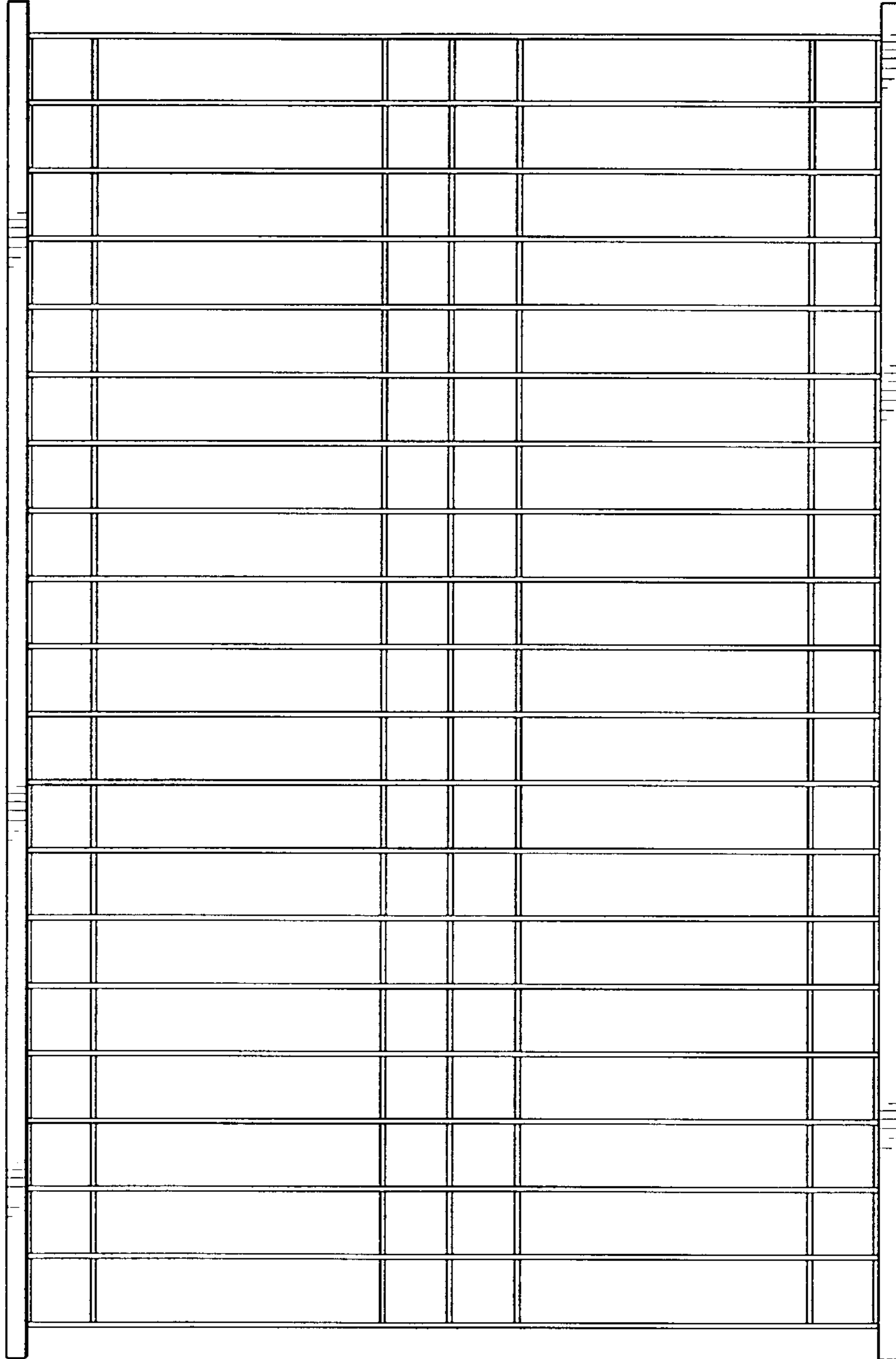

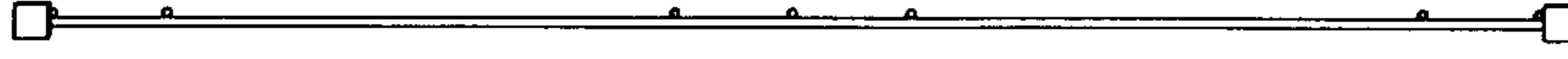

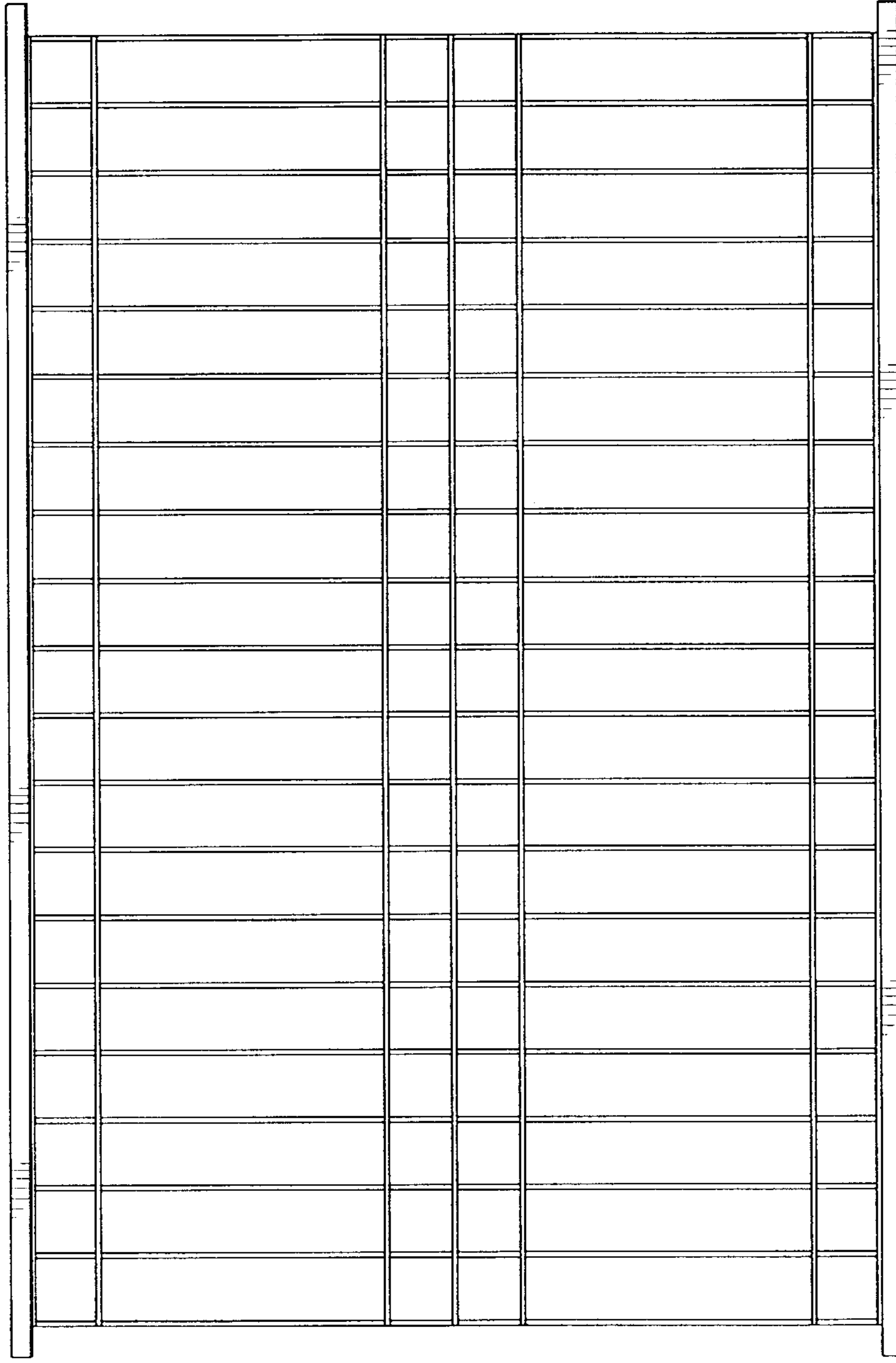

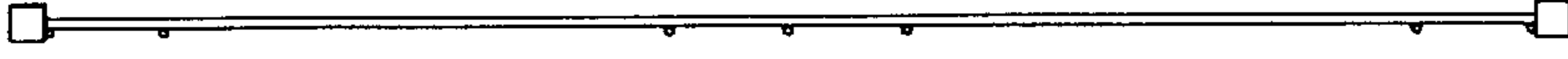

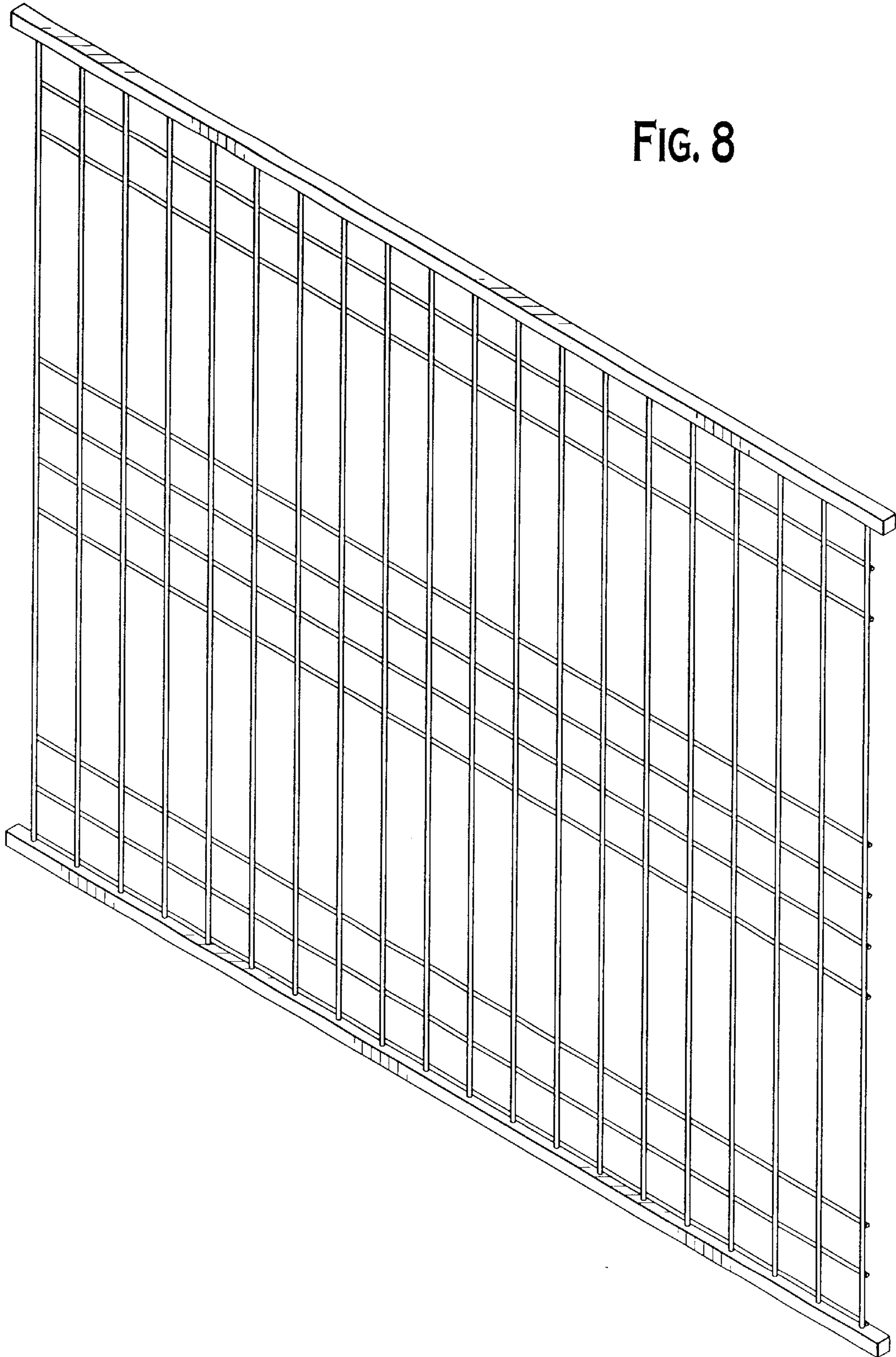

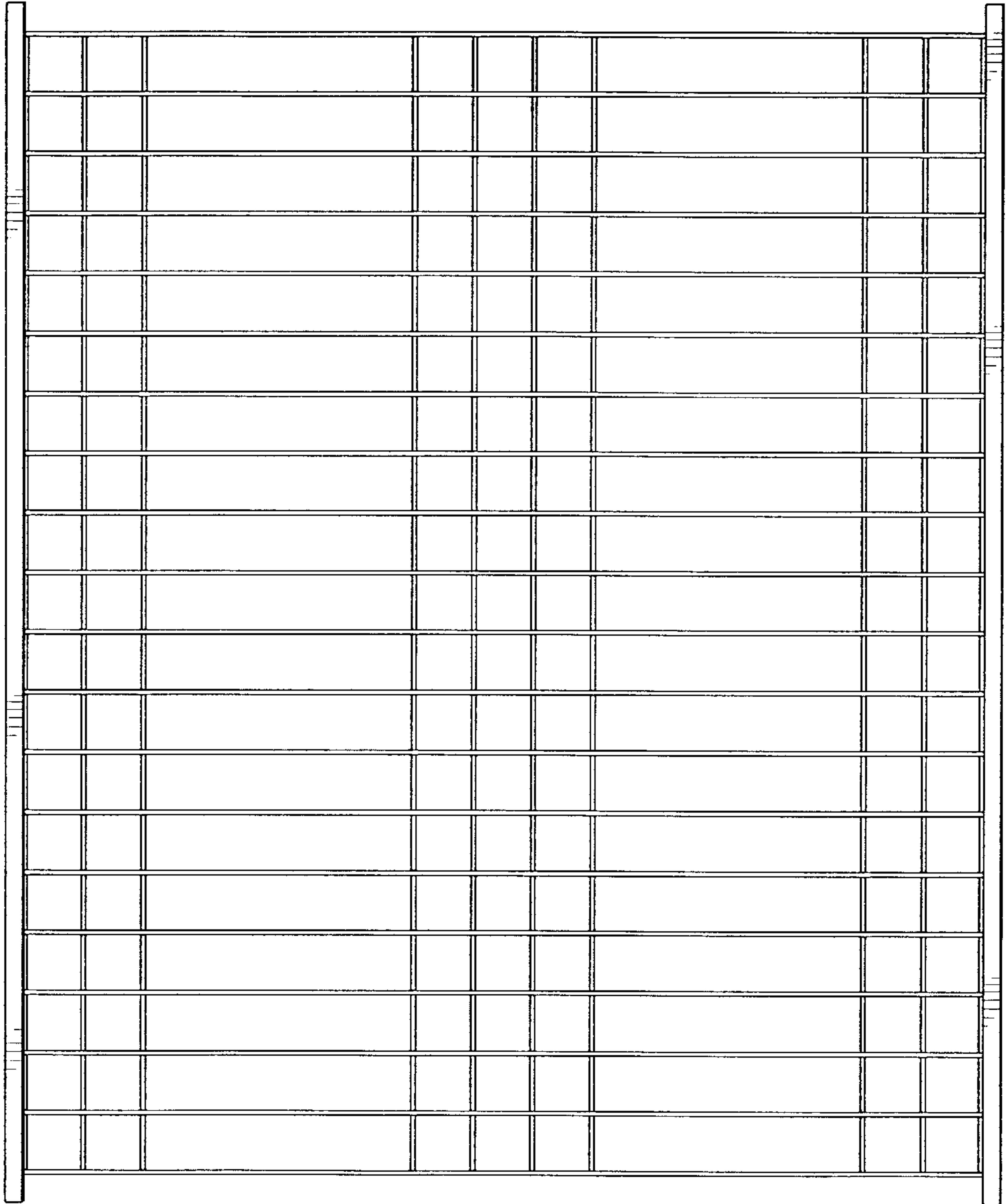

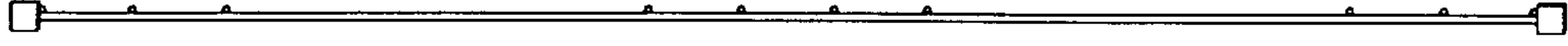

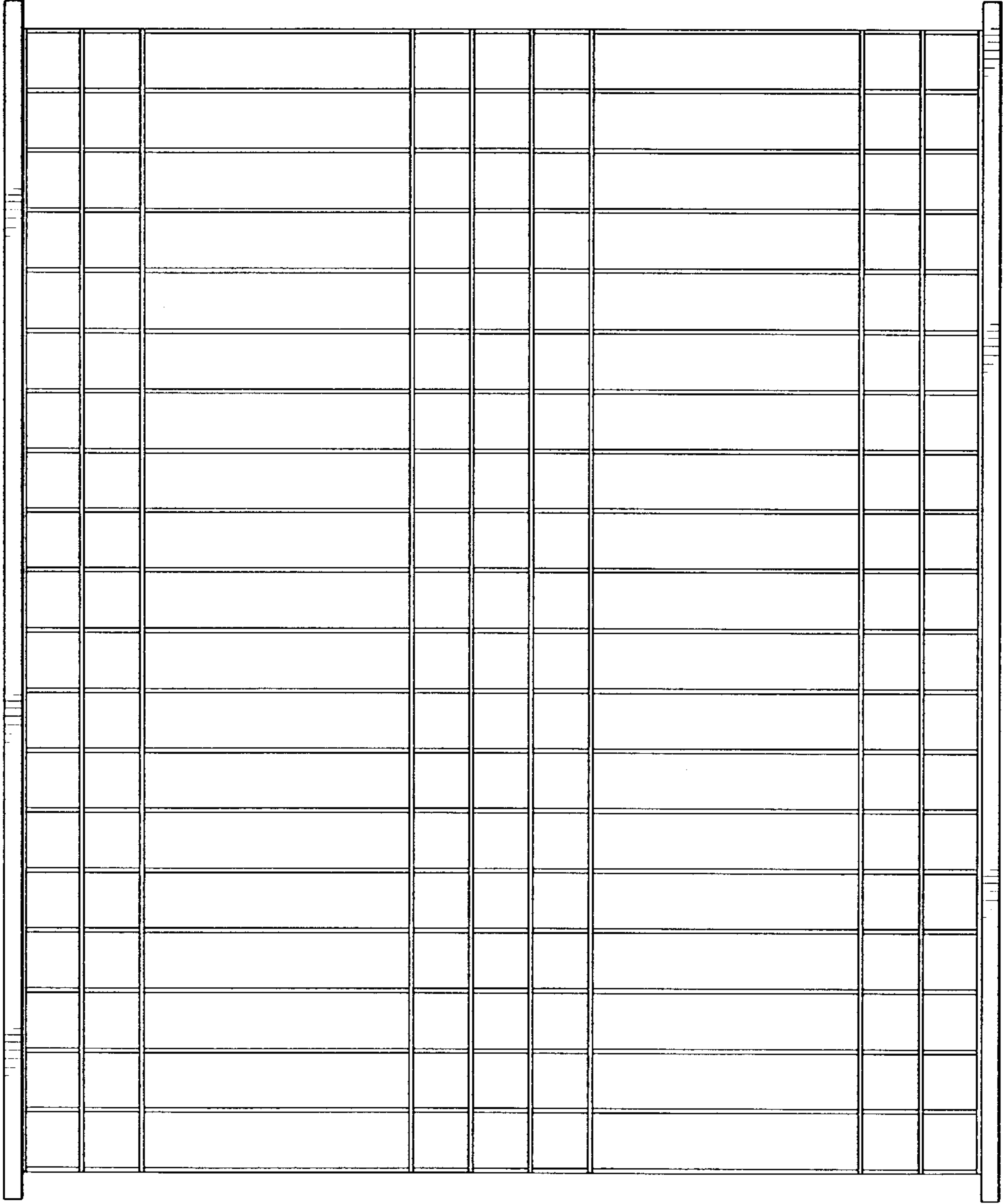
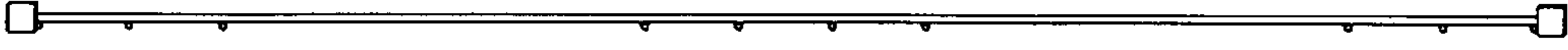

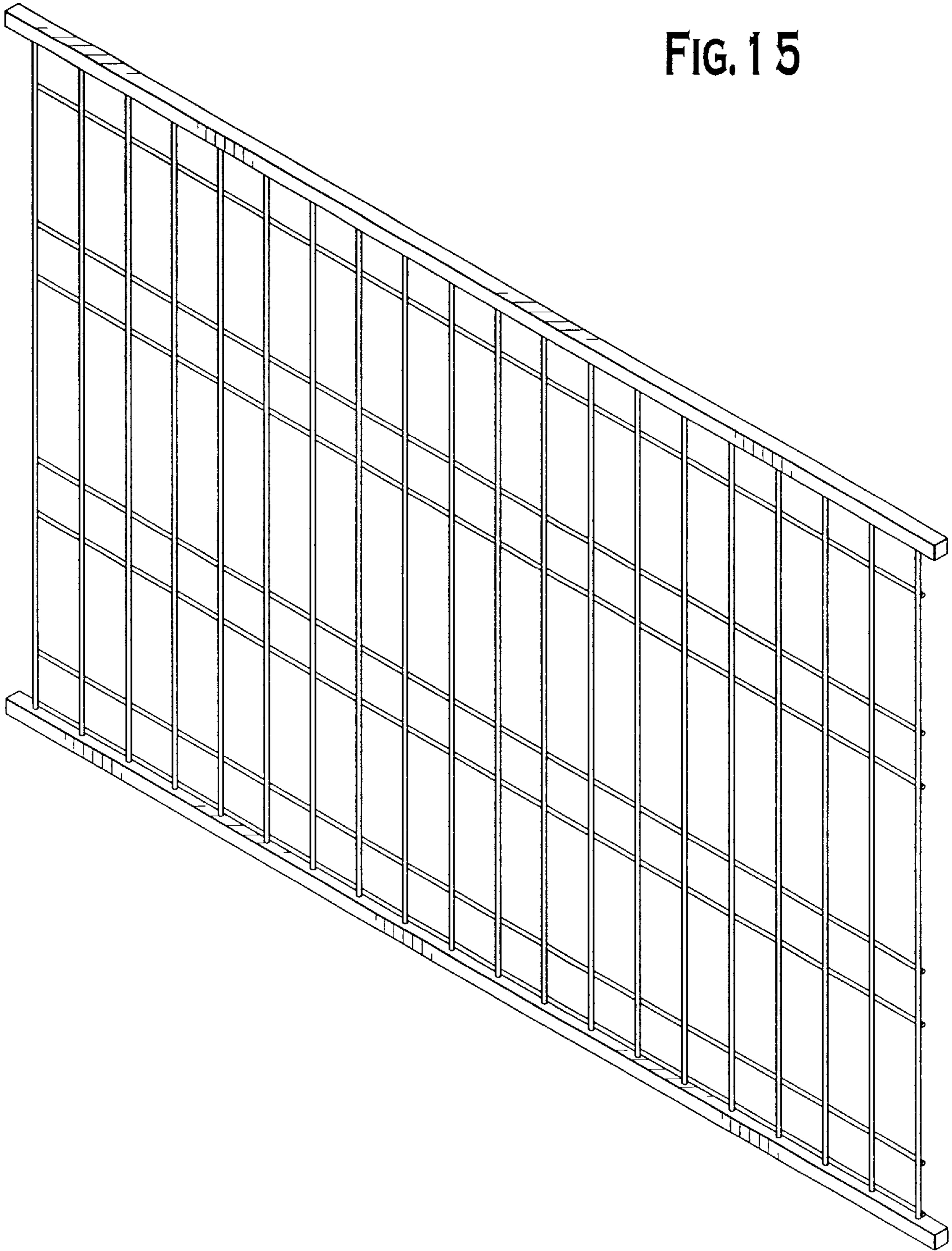

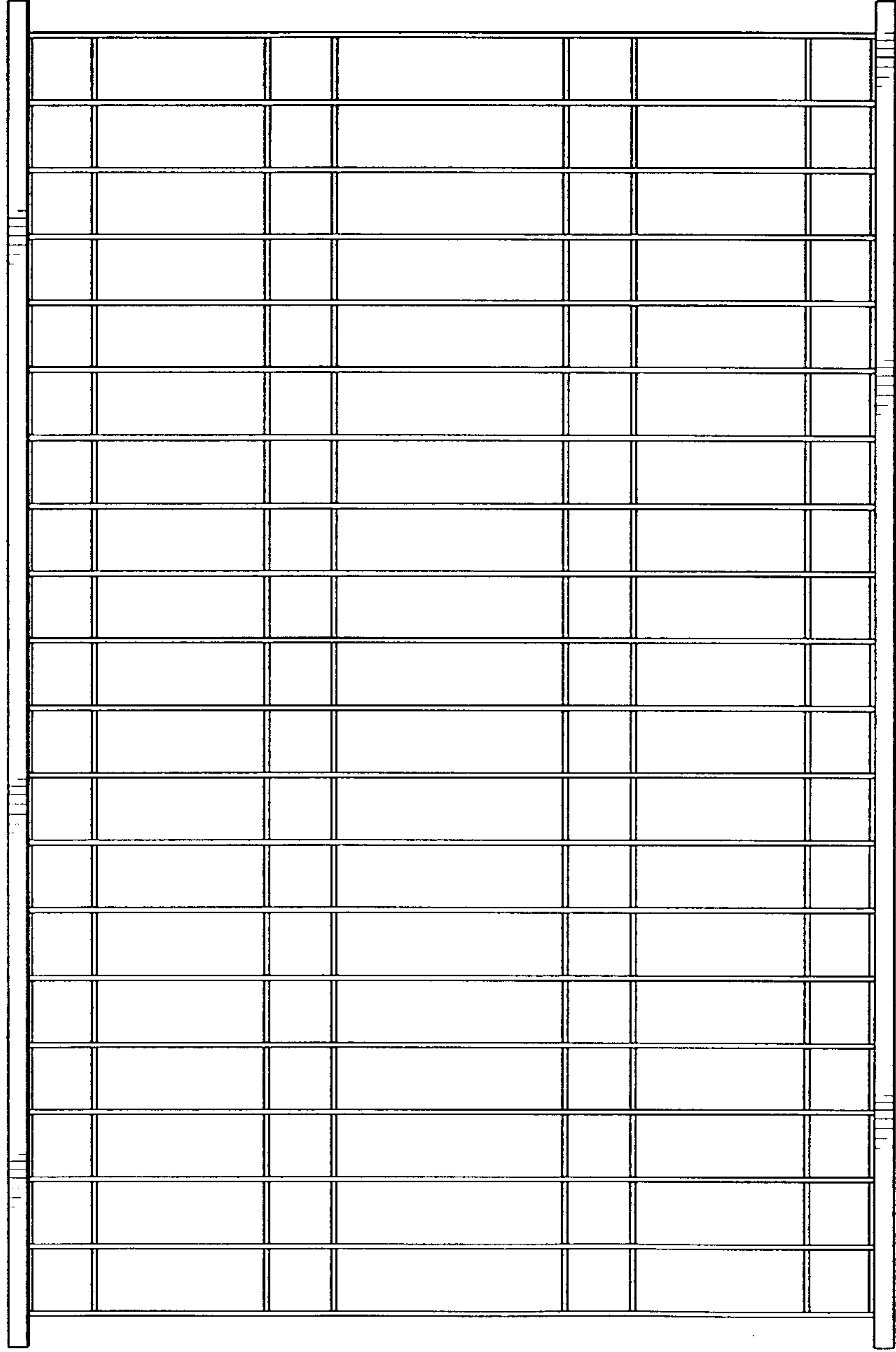

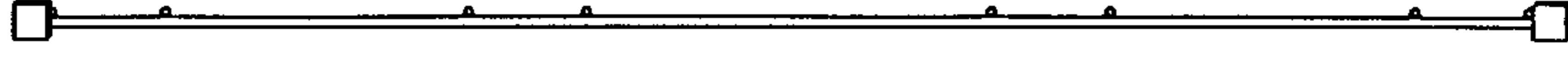

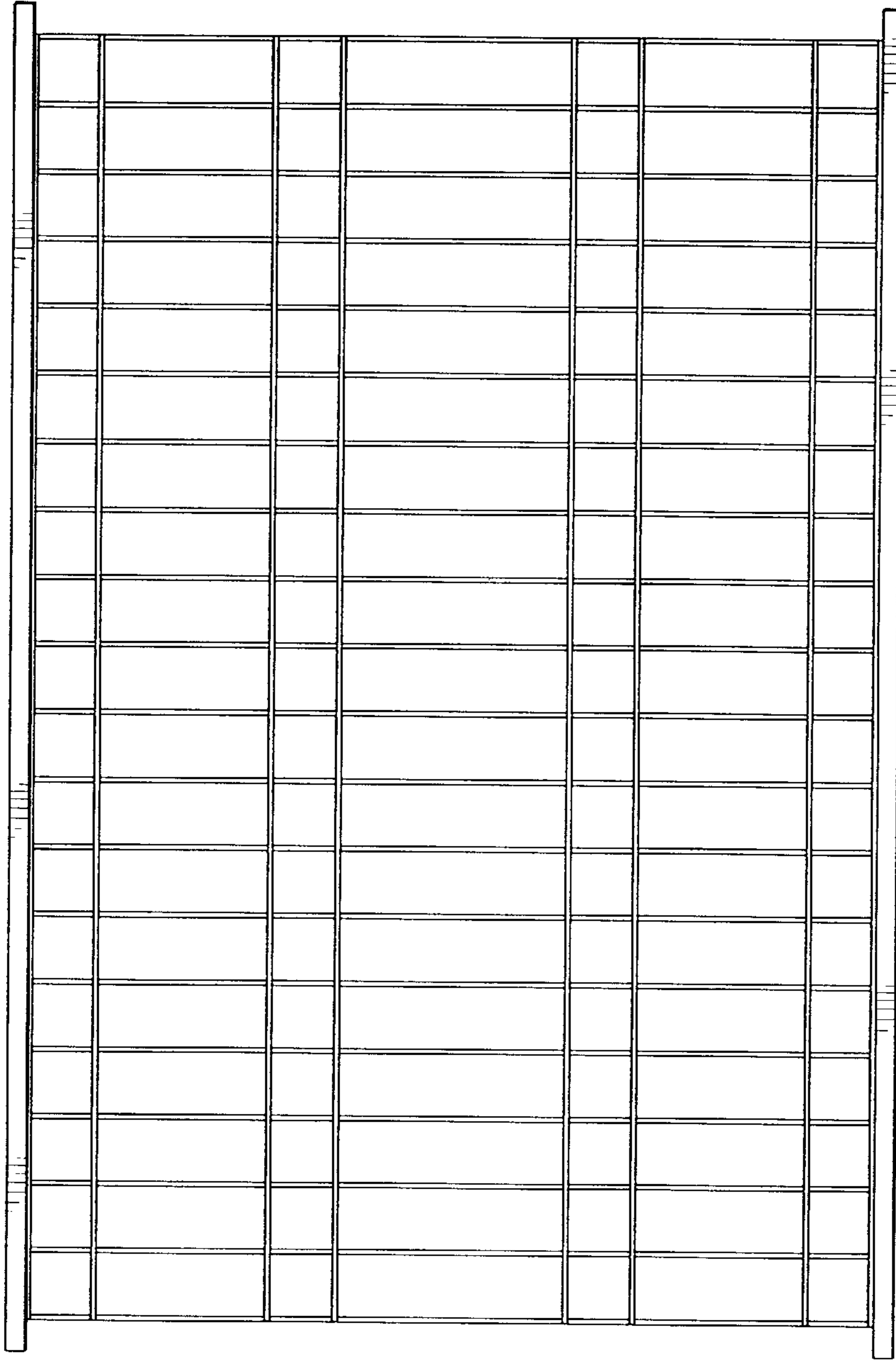

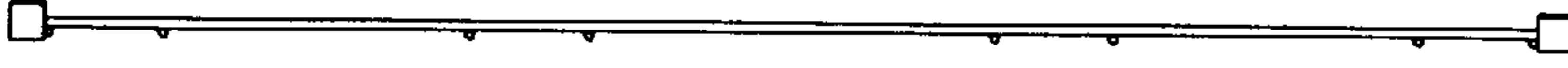
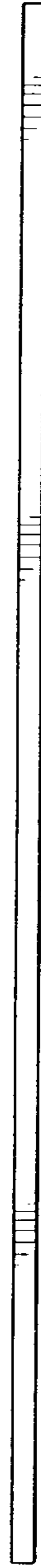

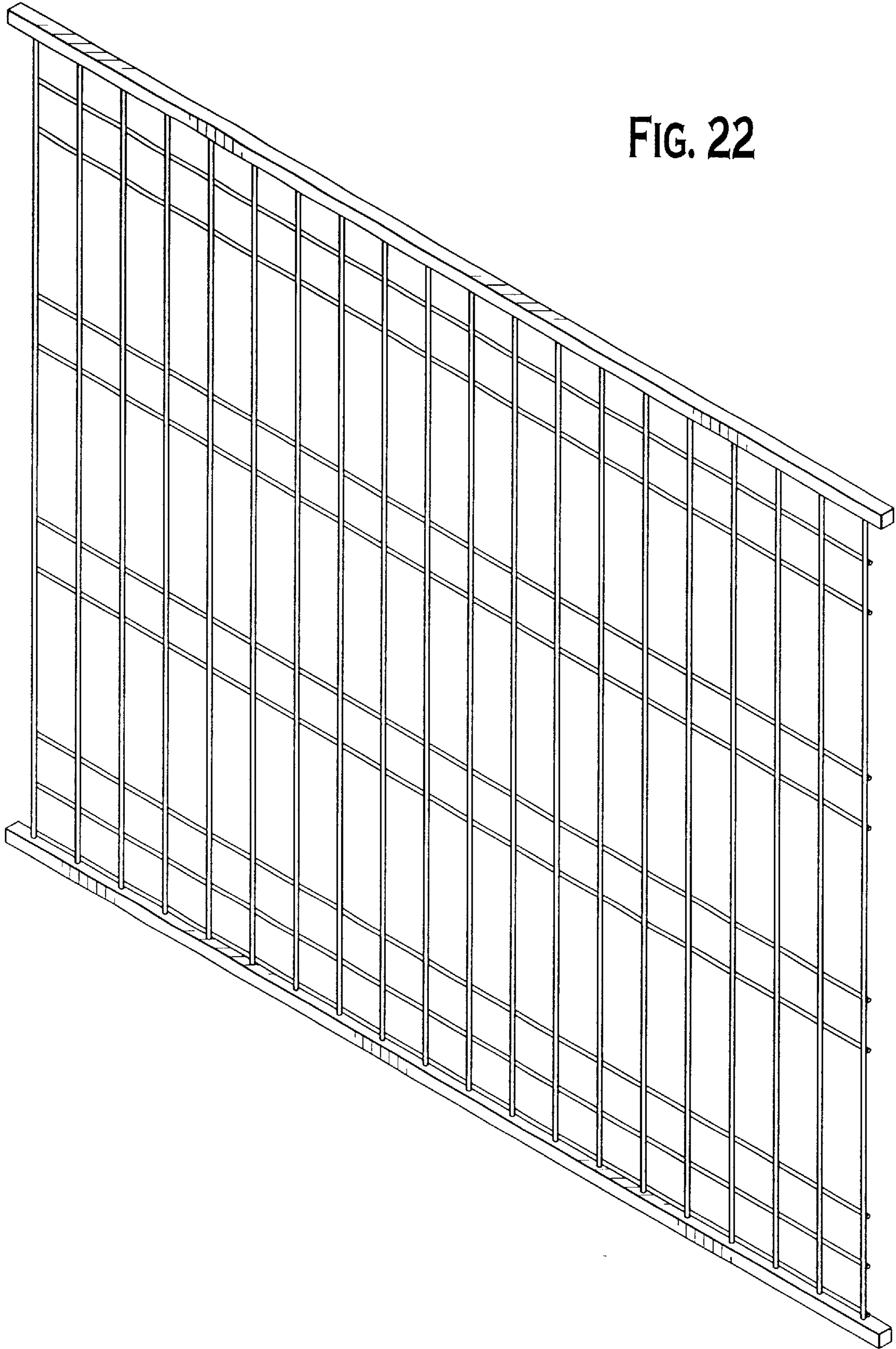

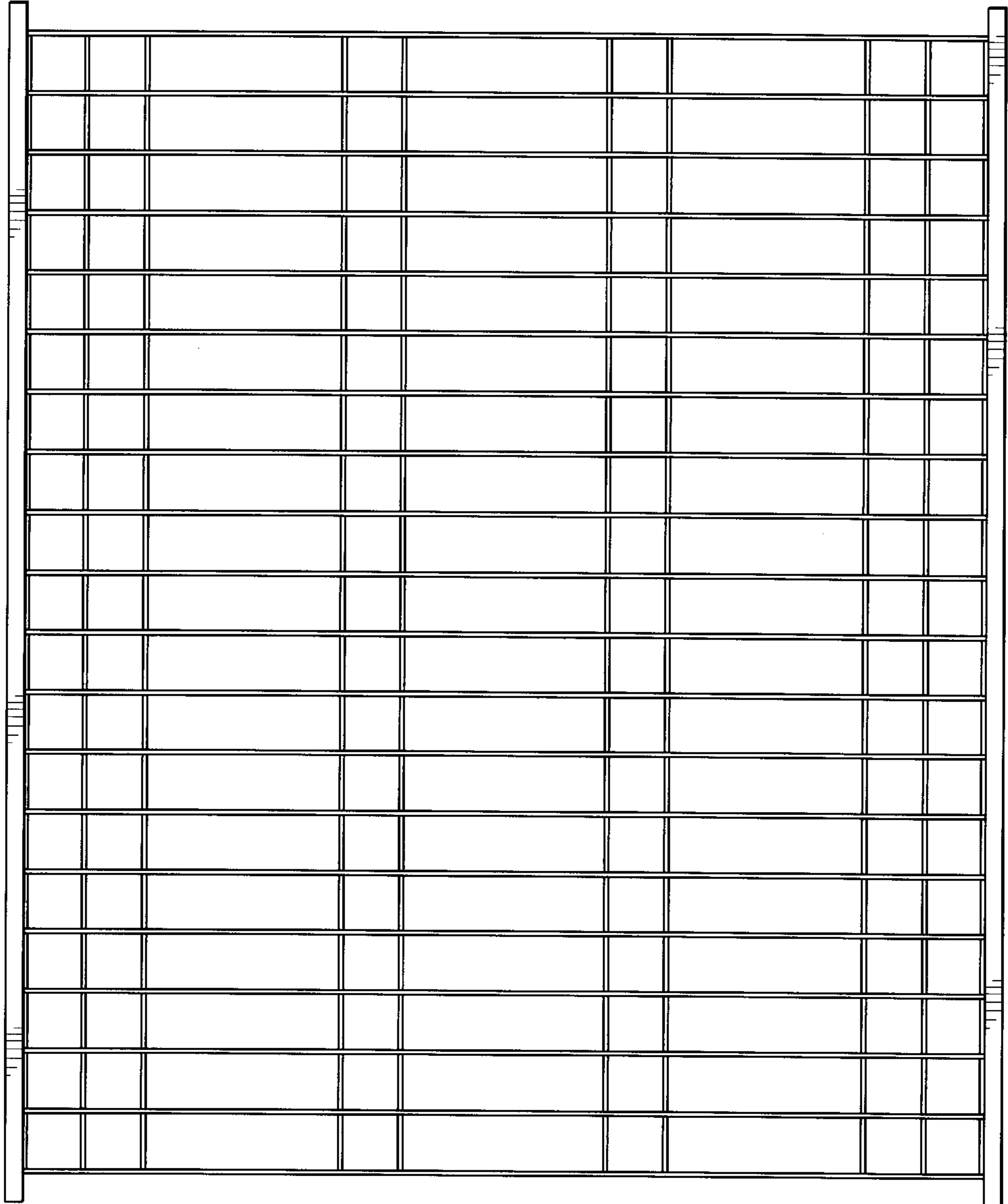
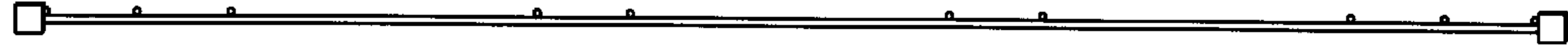

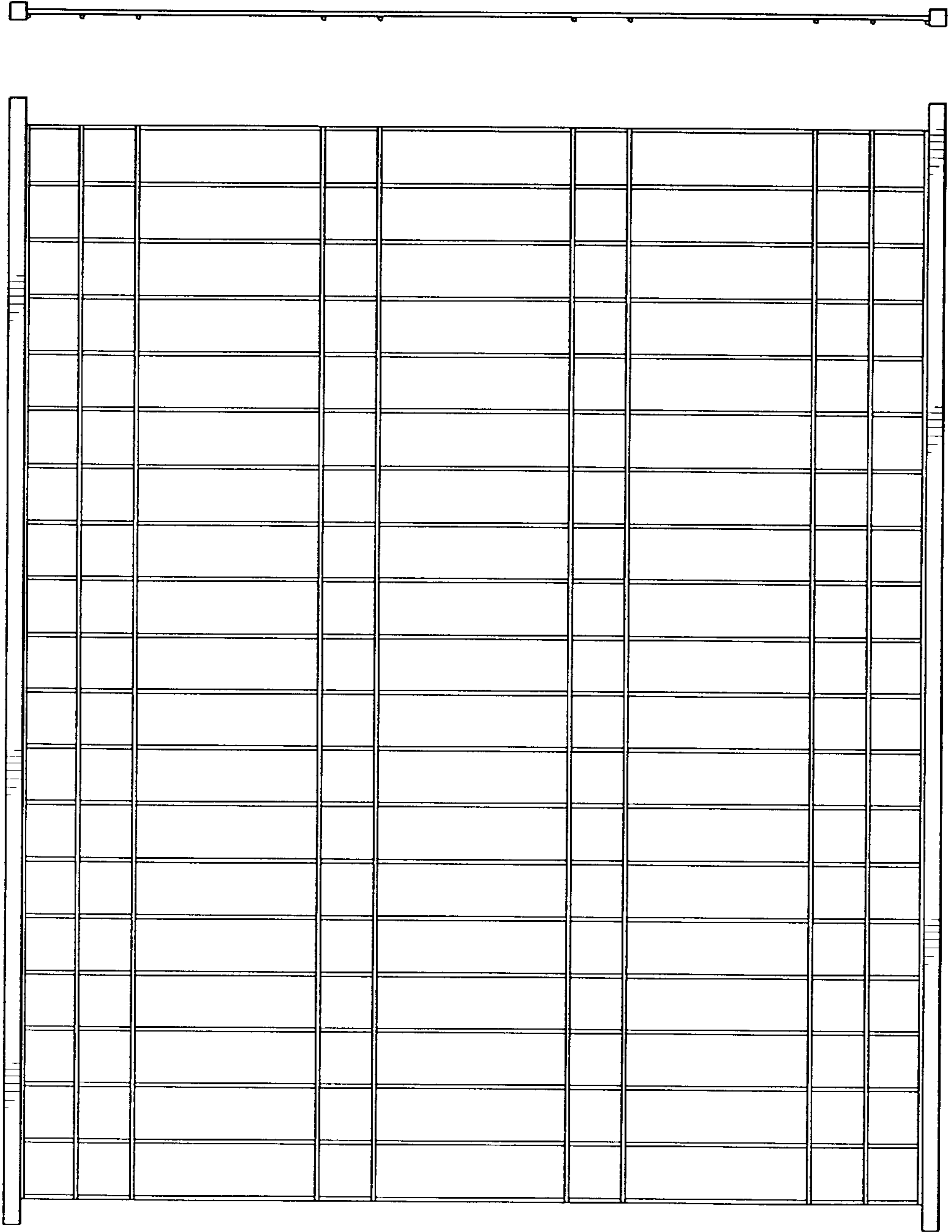

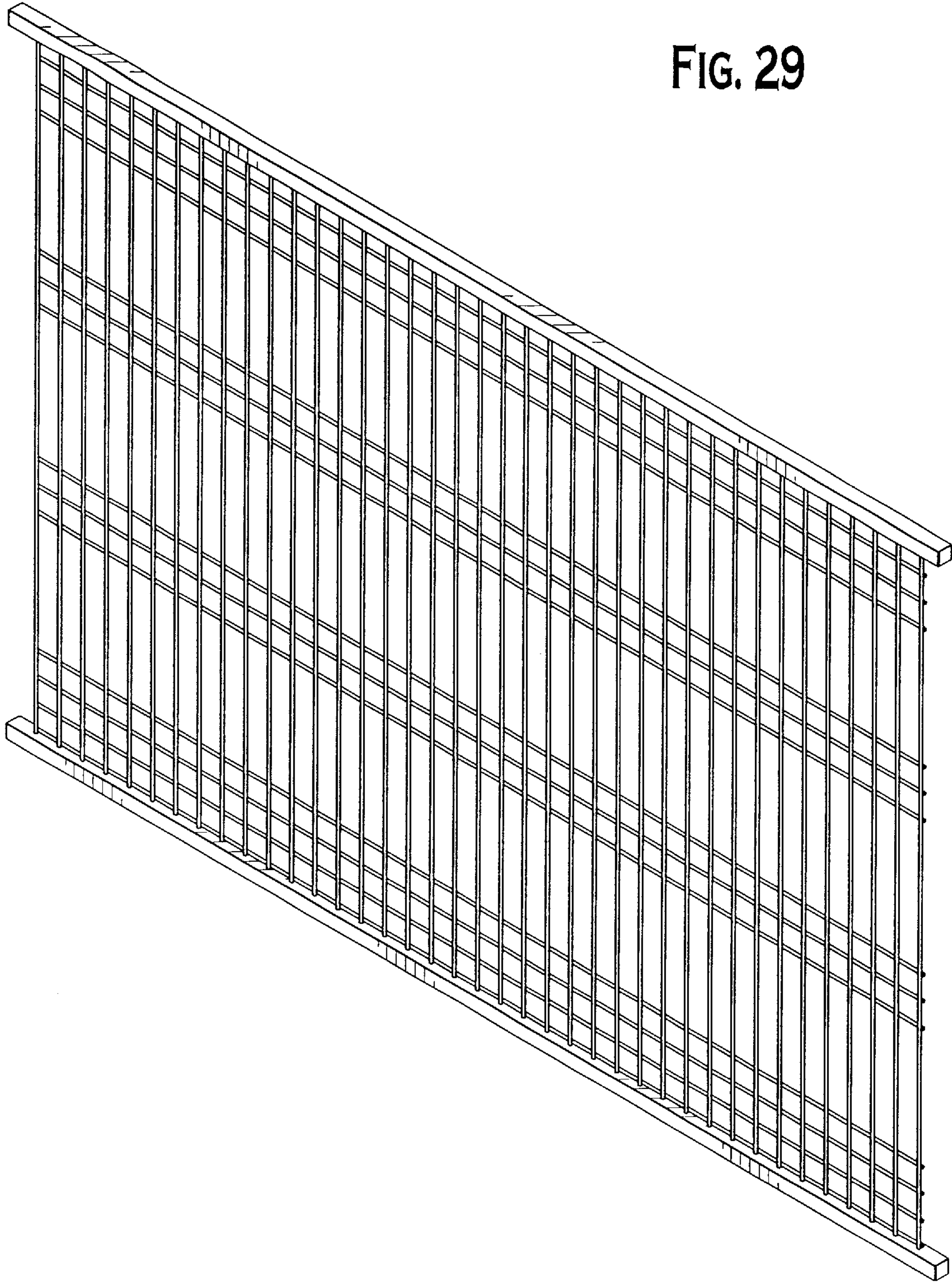

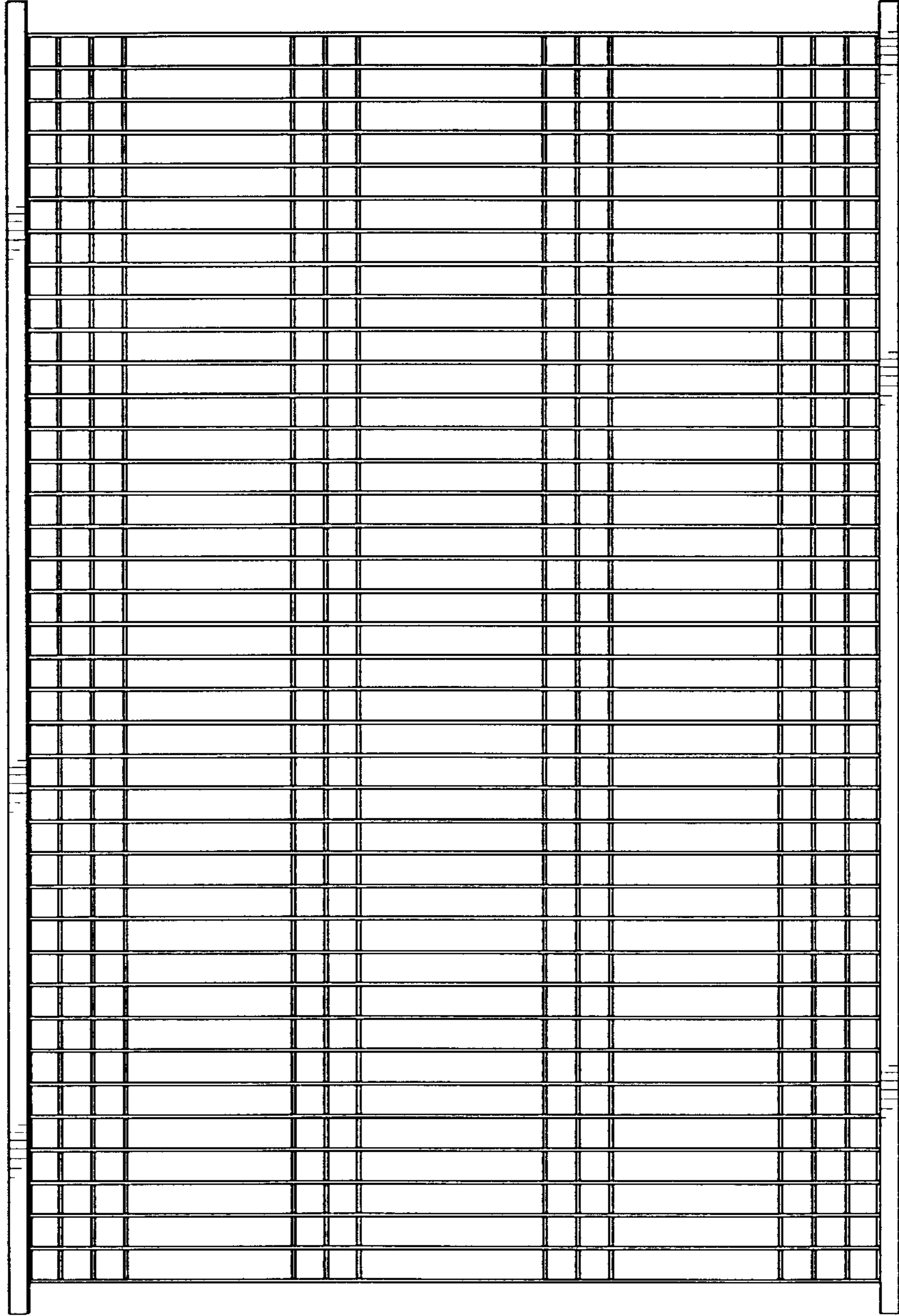

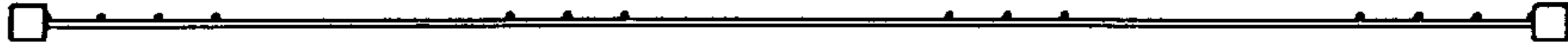

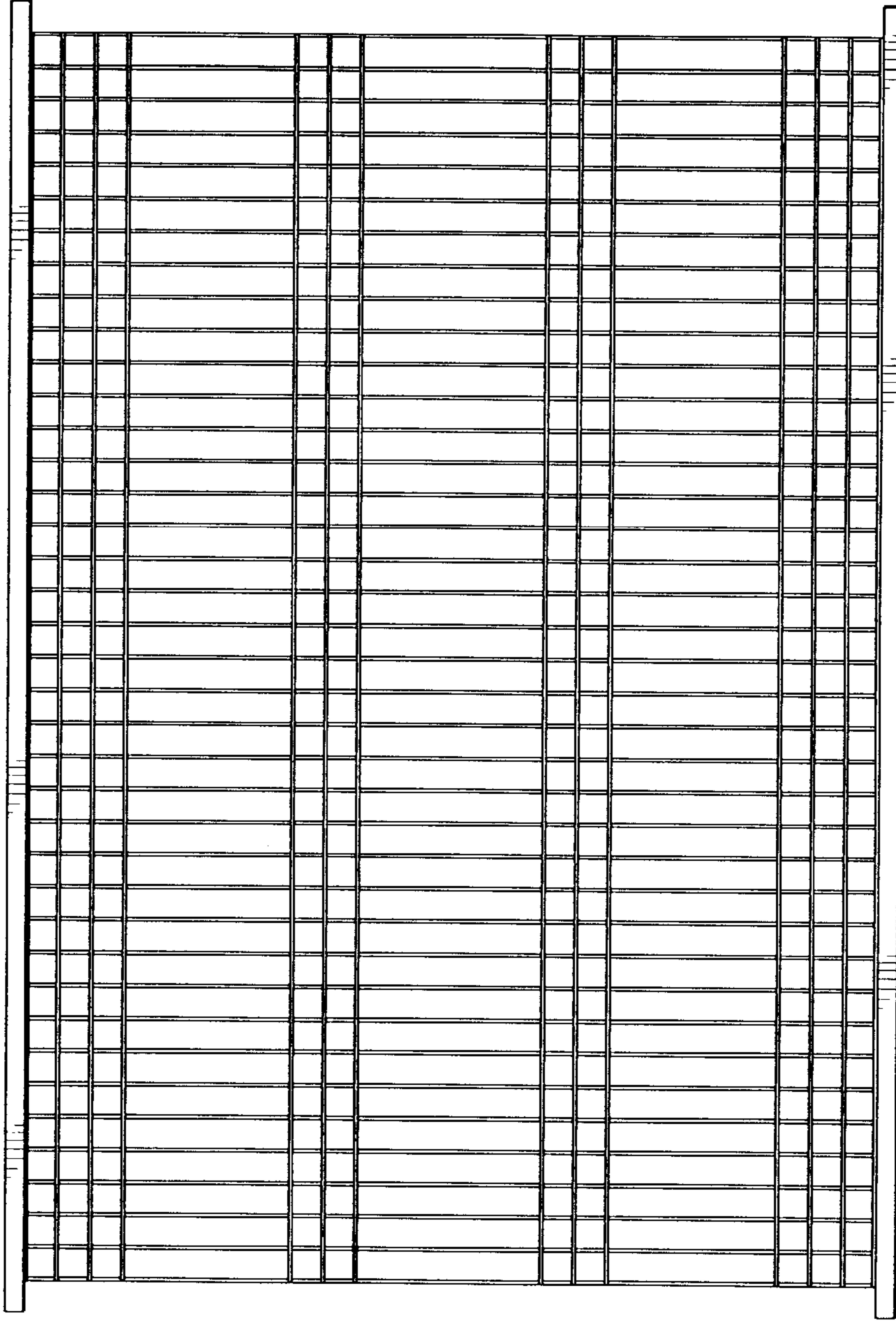
