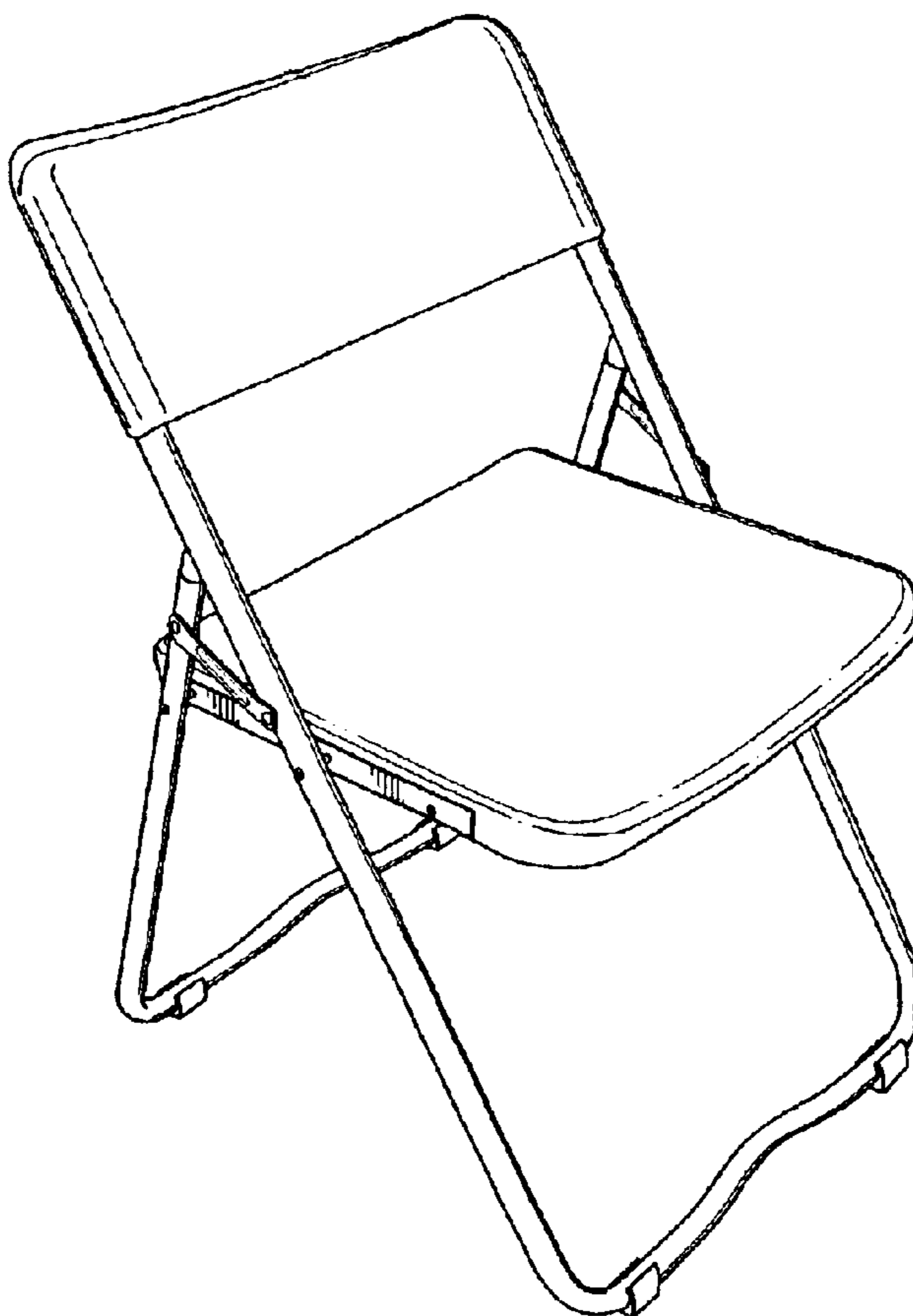
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a blow molded chair; FIG. 2 is an elevated left side view of the chair shown in FIG. 1, the right side view being the mirror image thereof; FIG. 3 is an elevated front view of the chair shown in FIG. 1; FIG. 4 is a top plan view of the chair shown in FIG. 1; FIG. 5 is an elevated back view of the chair shown in FIG. 1; and, FIG. 6 is a bottom plan view of the chair shown in FIG. 1.

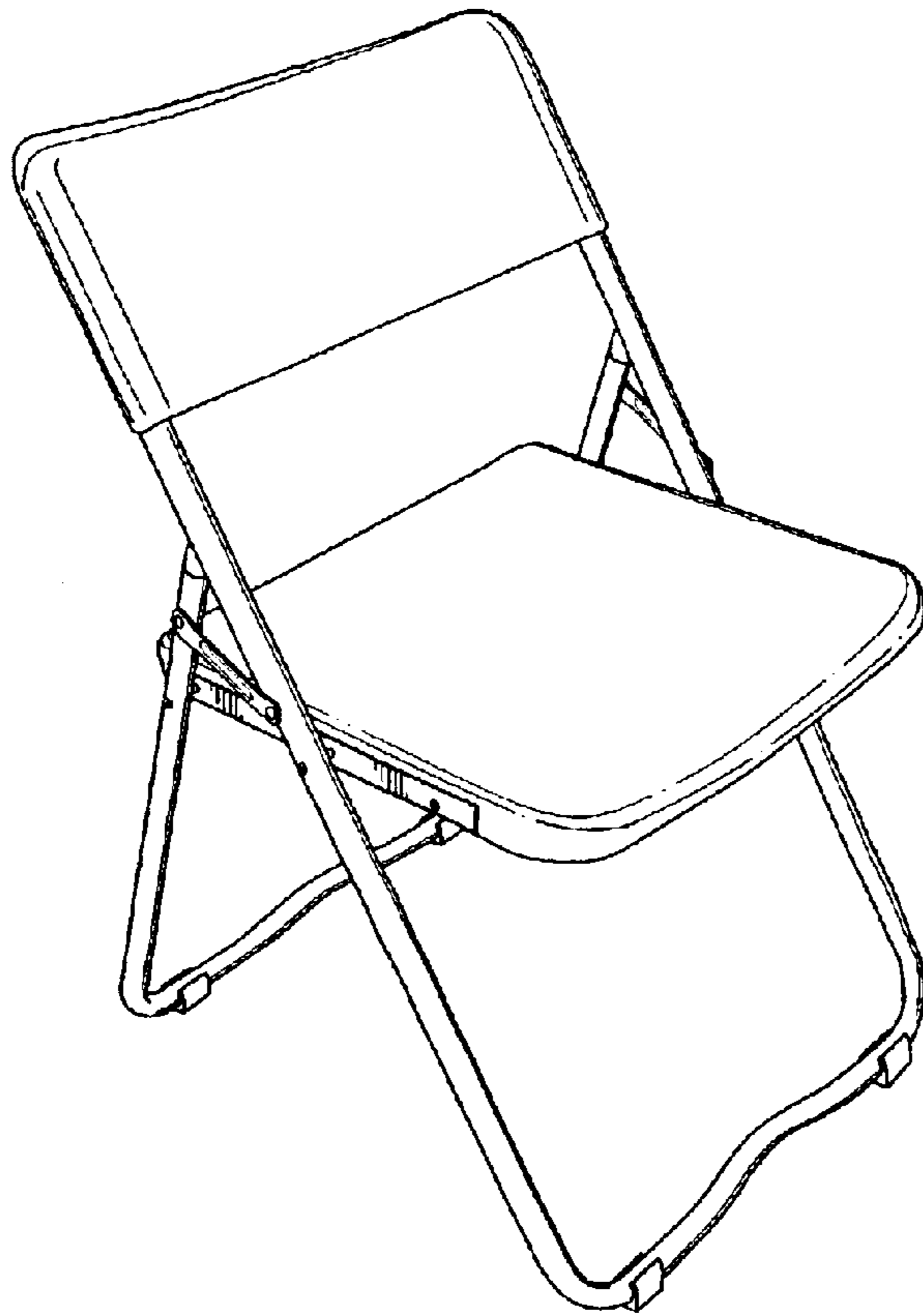

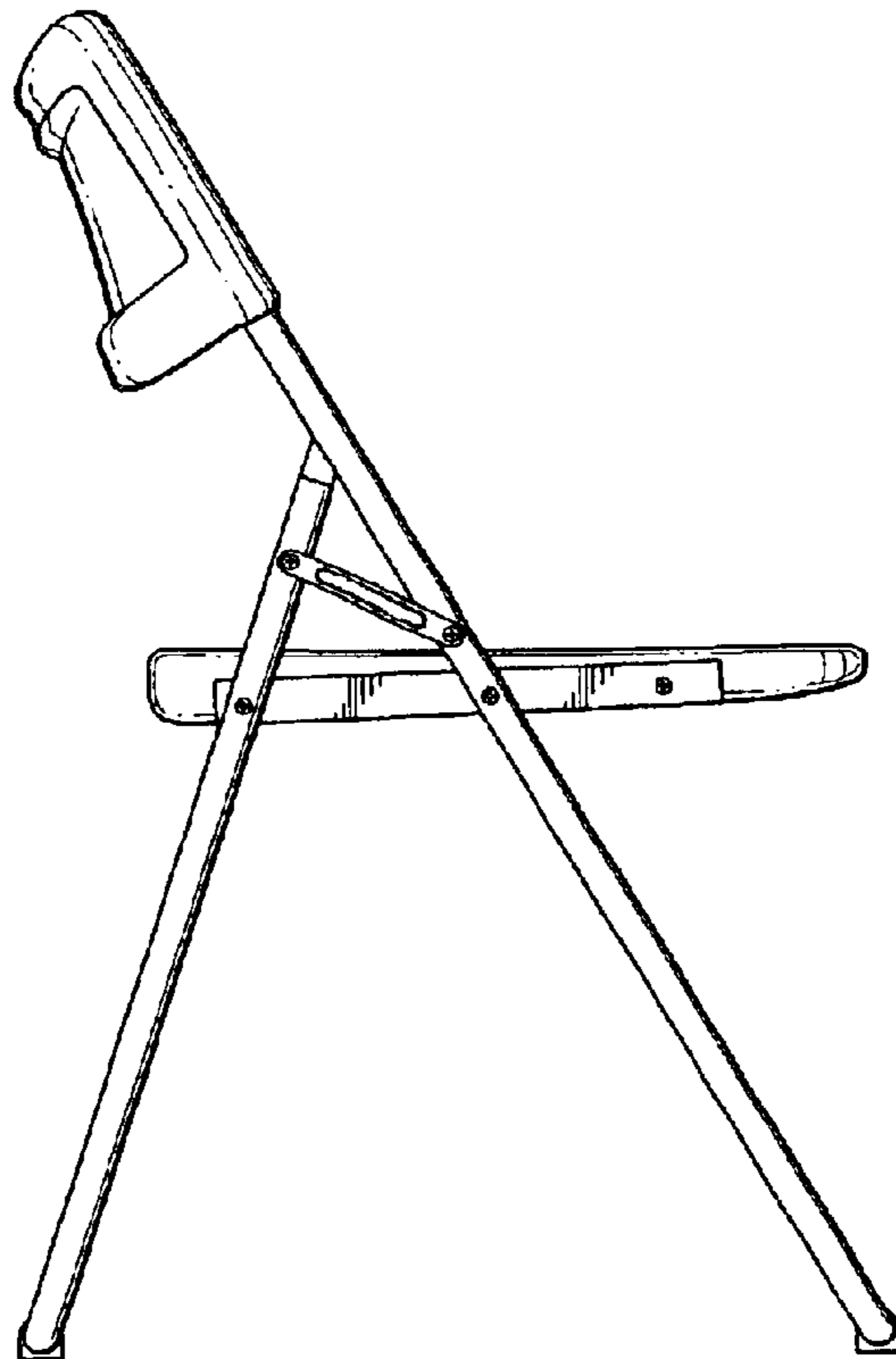

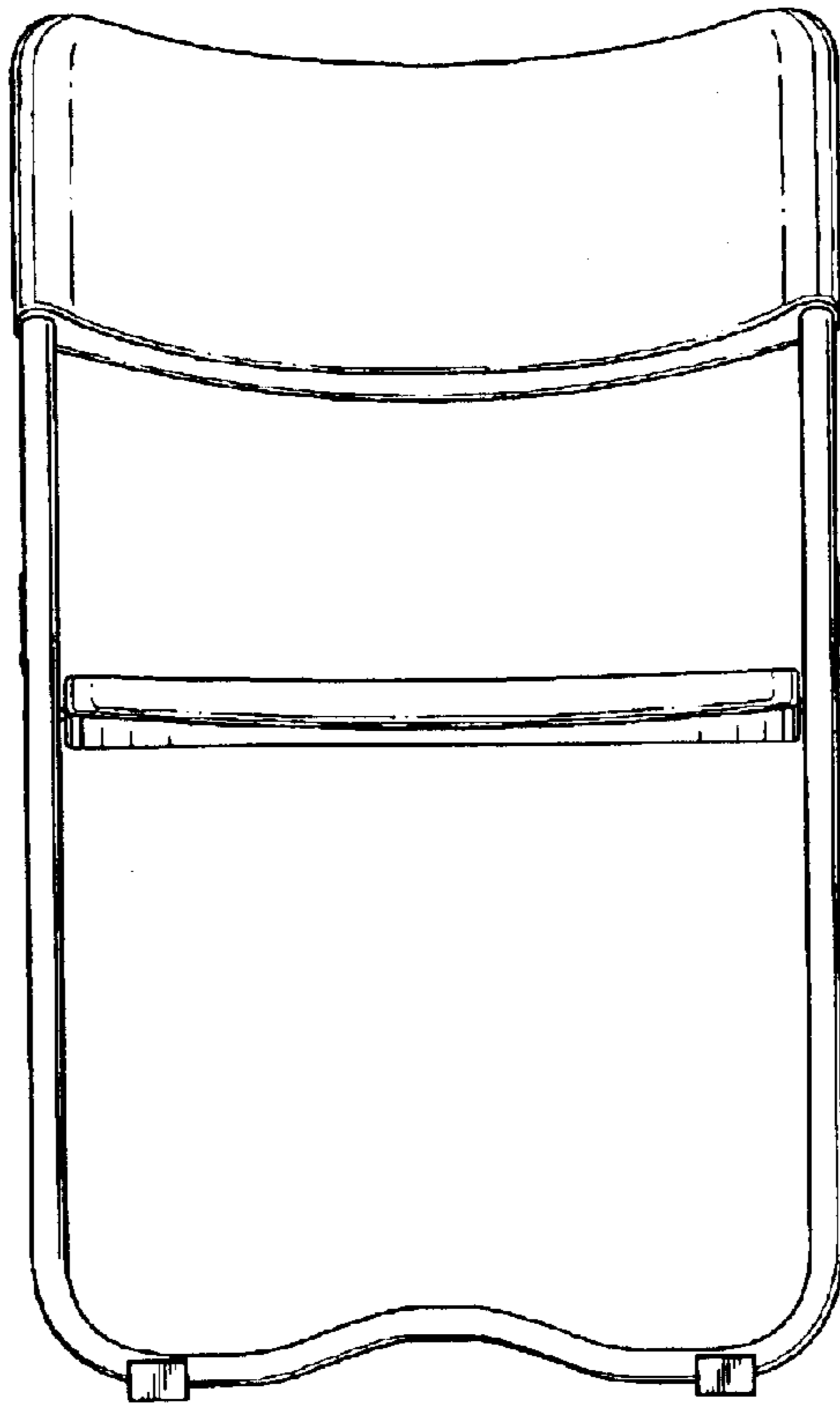

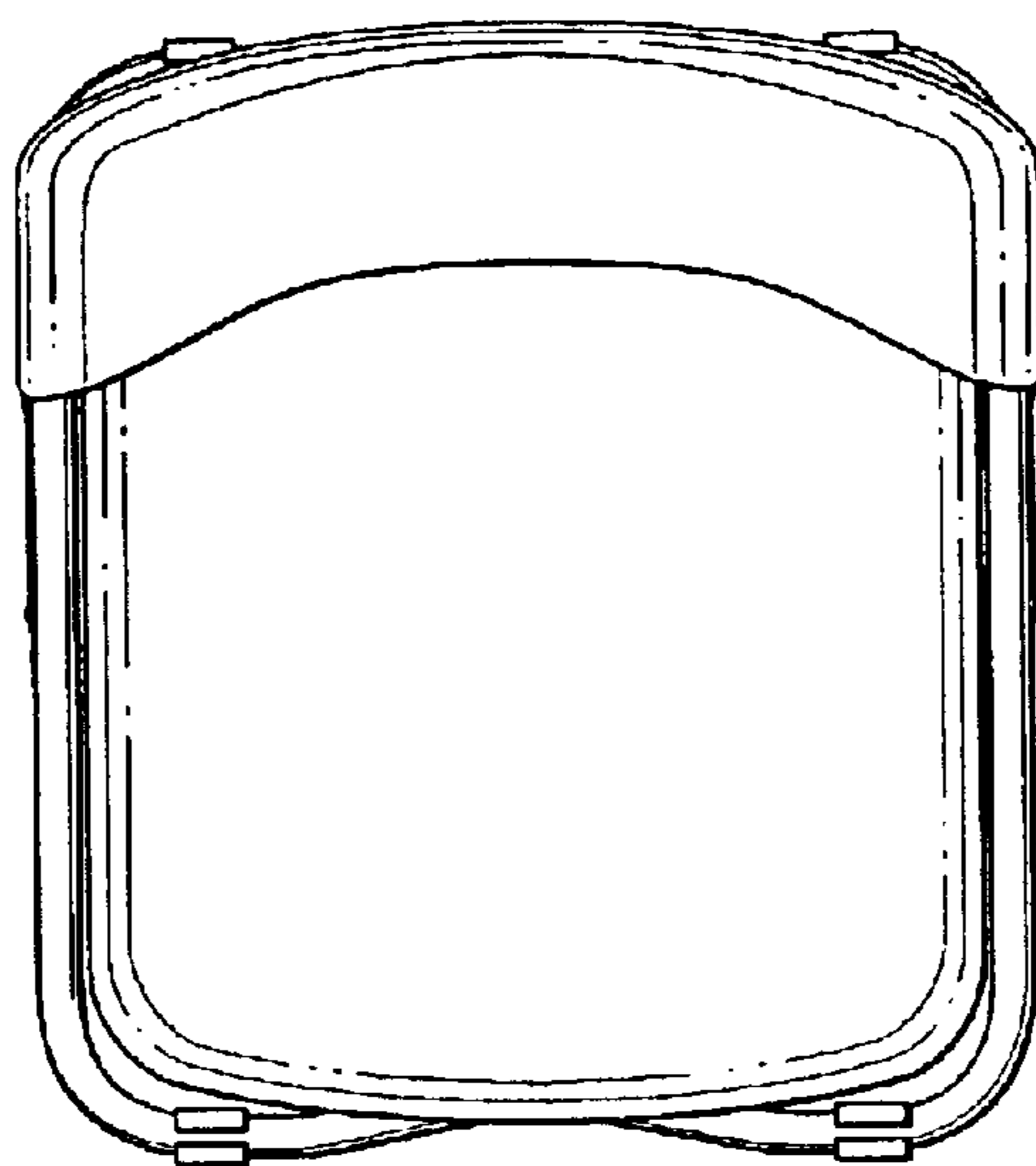

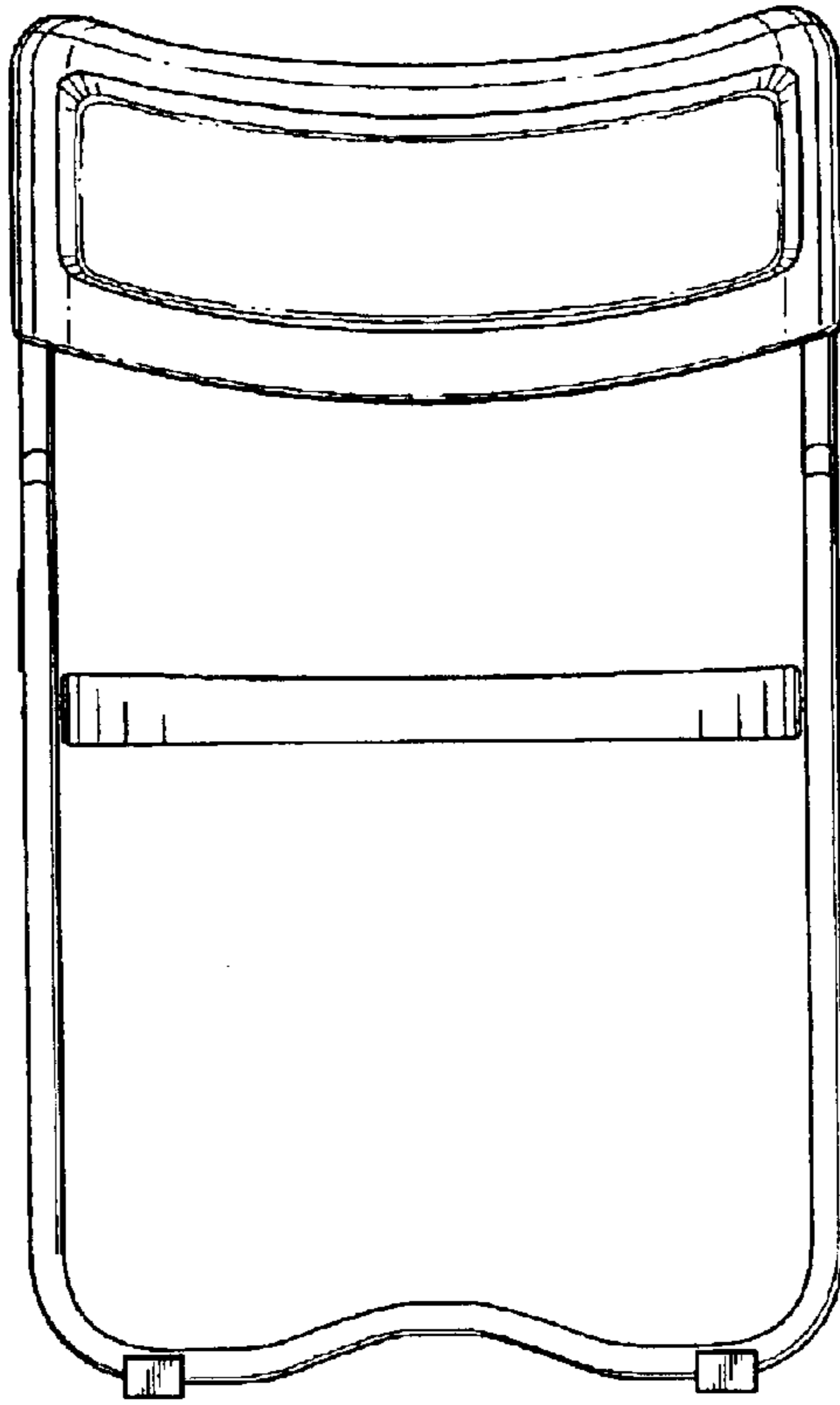

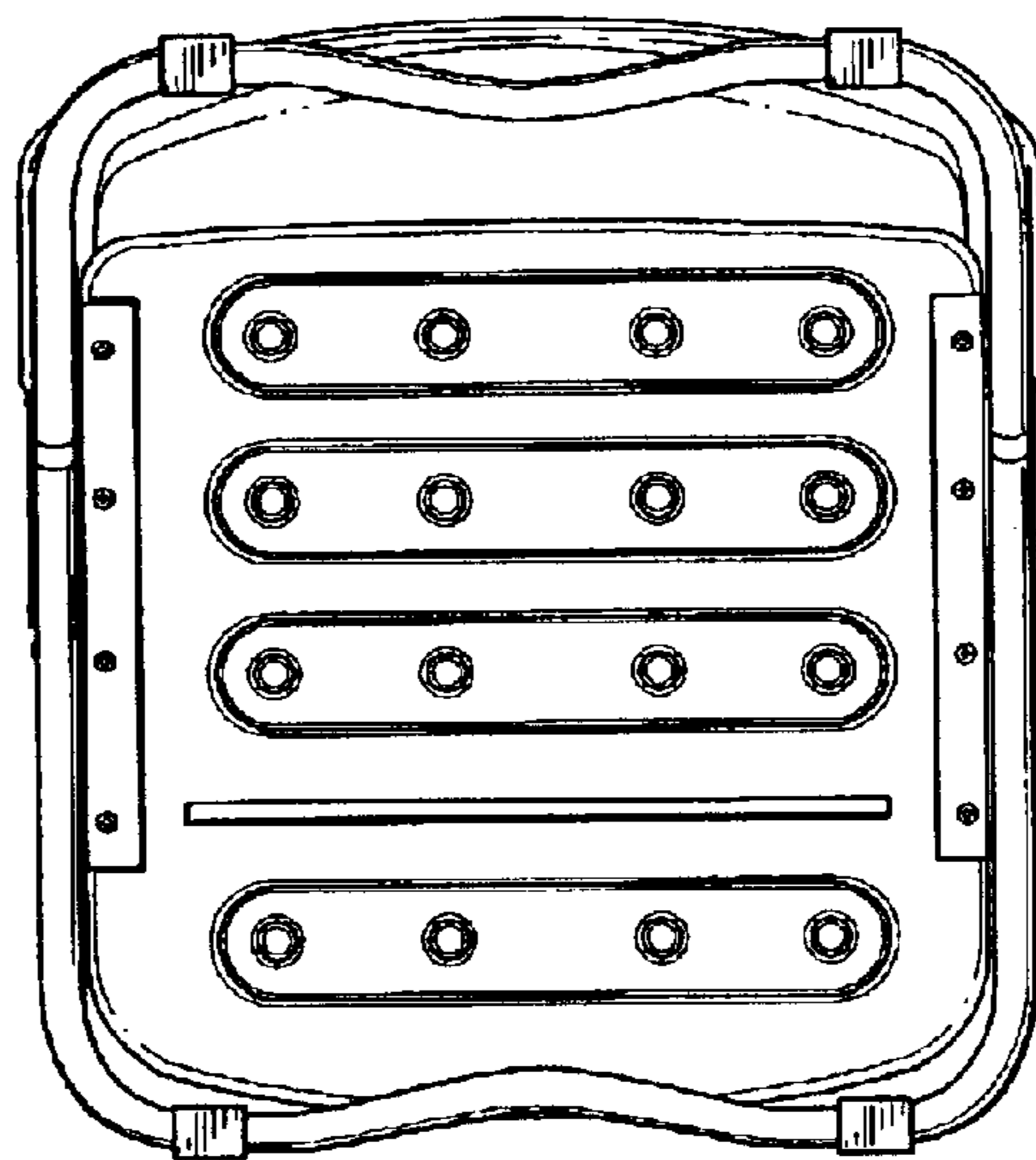
