DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a combined bottle and cap for cosmetic use according to a first embodiment of the invention;

FIG. 2 is a front elevation thereof;

FIG. 3 is a back view thereof;

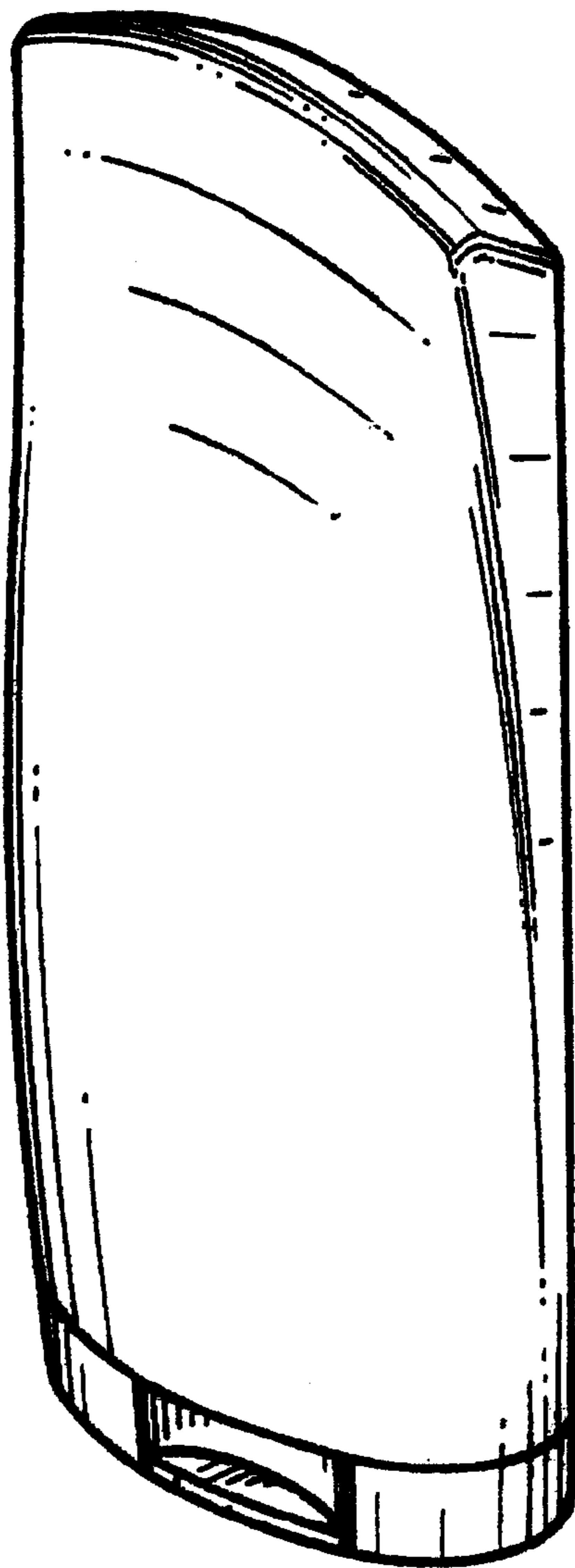

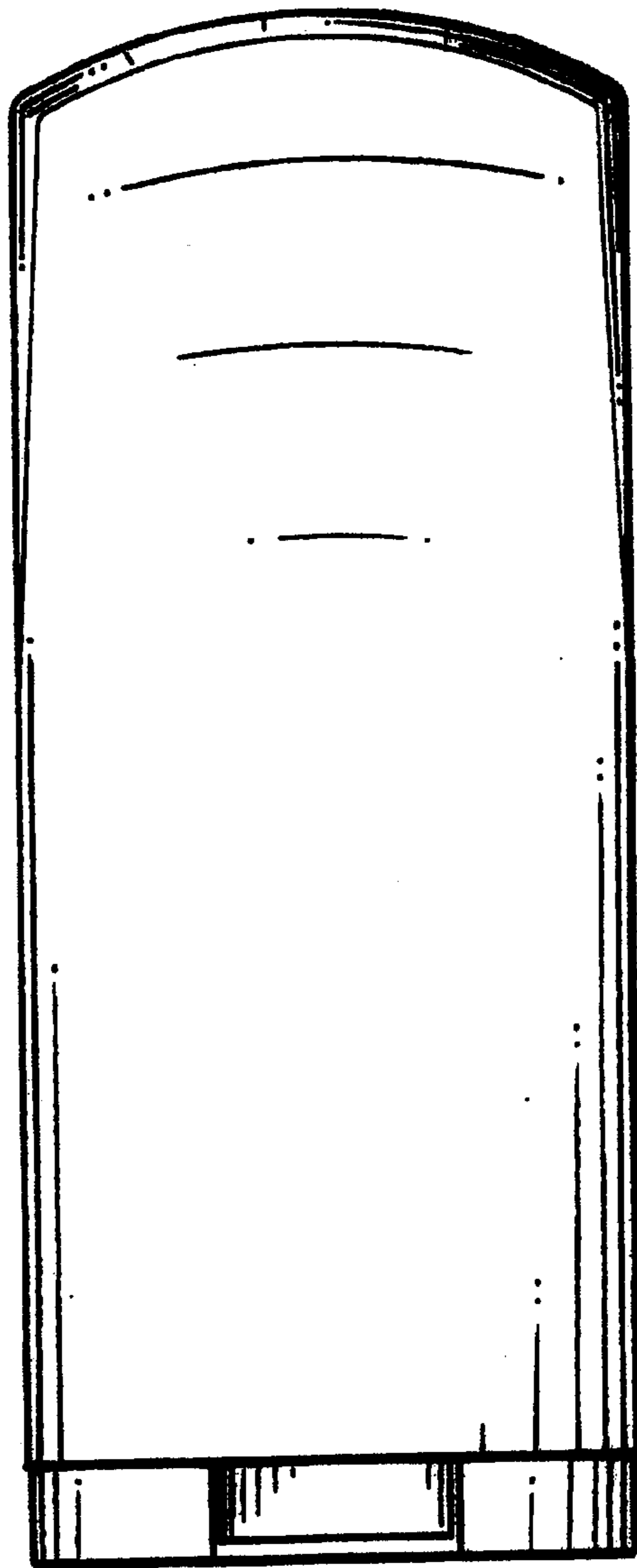

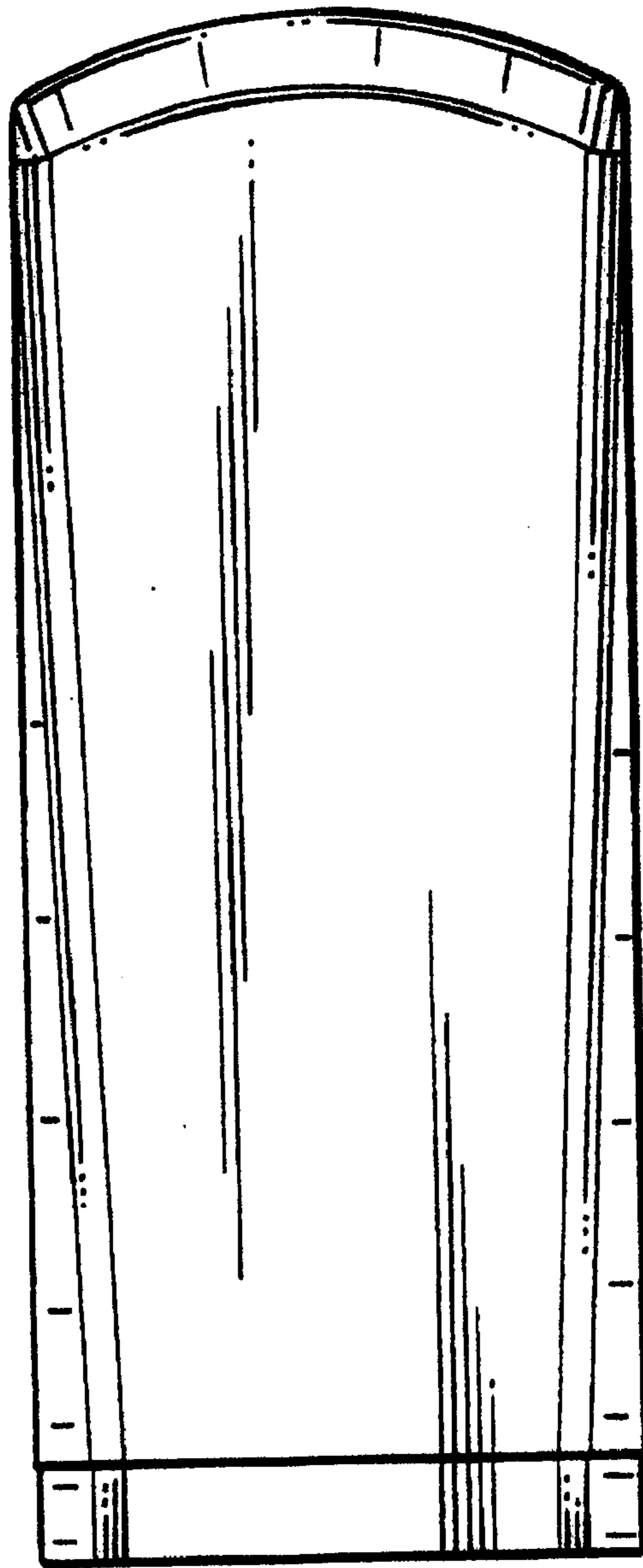

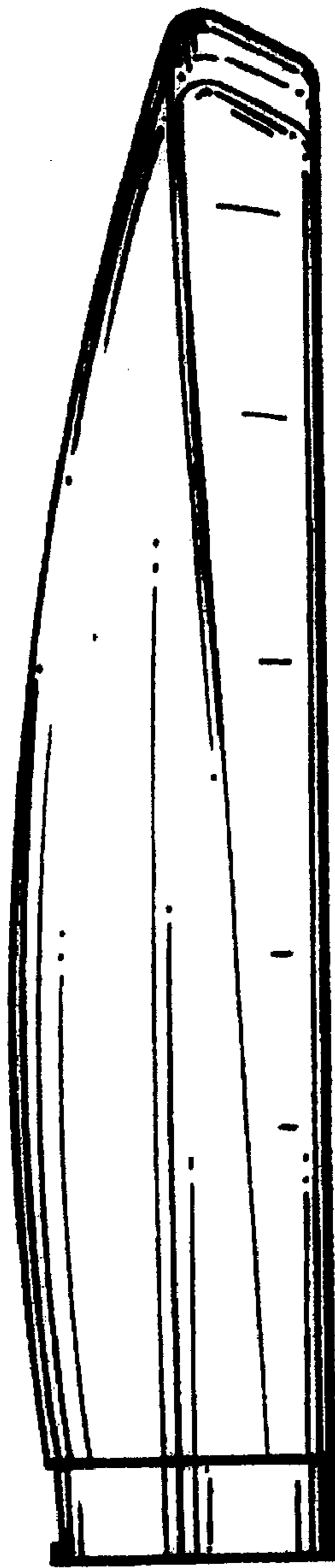

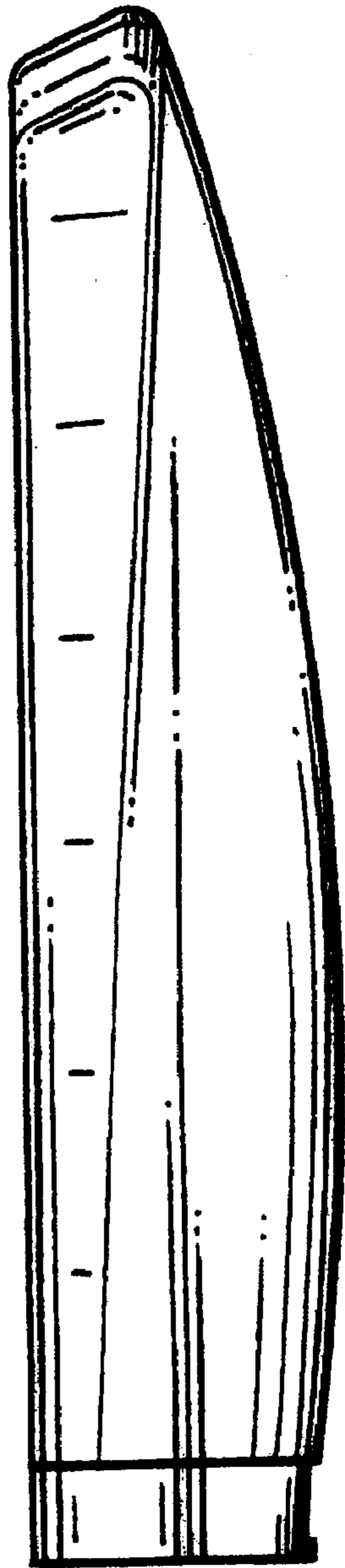

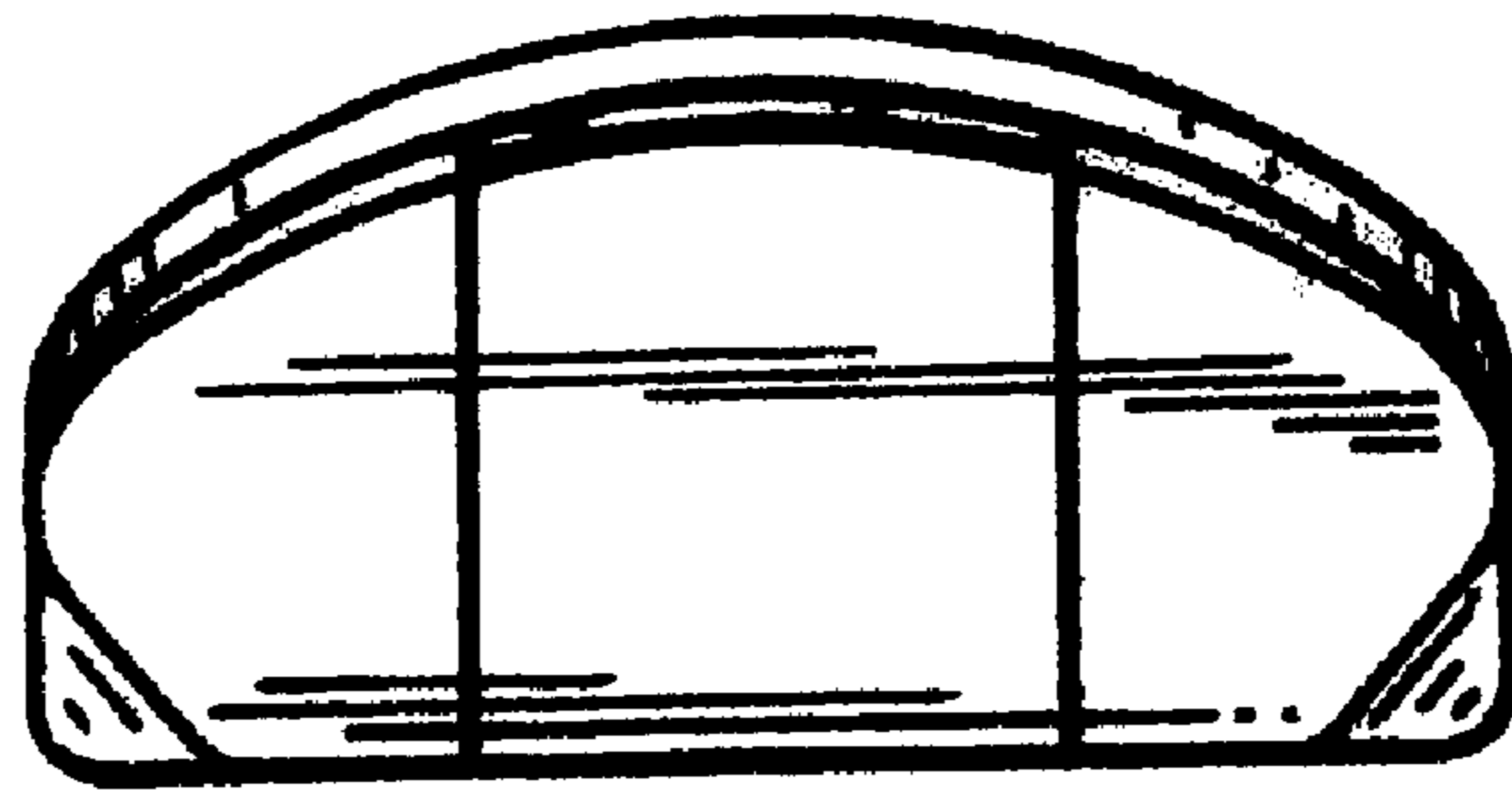
