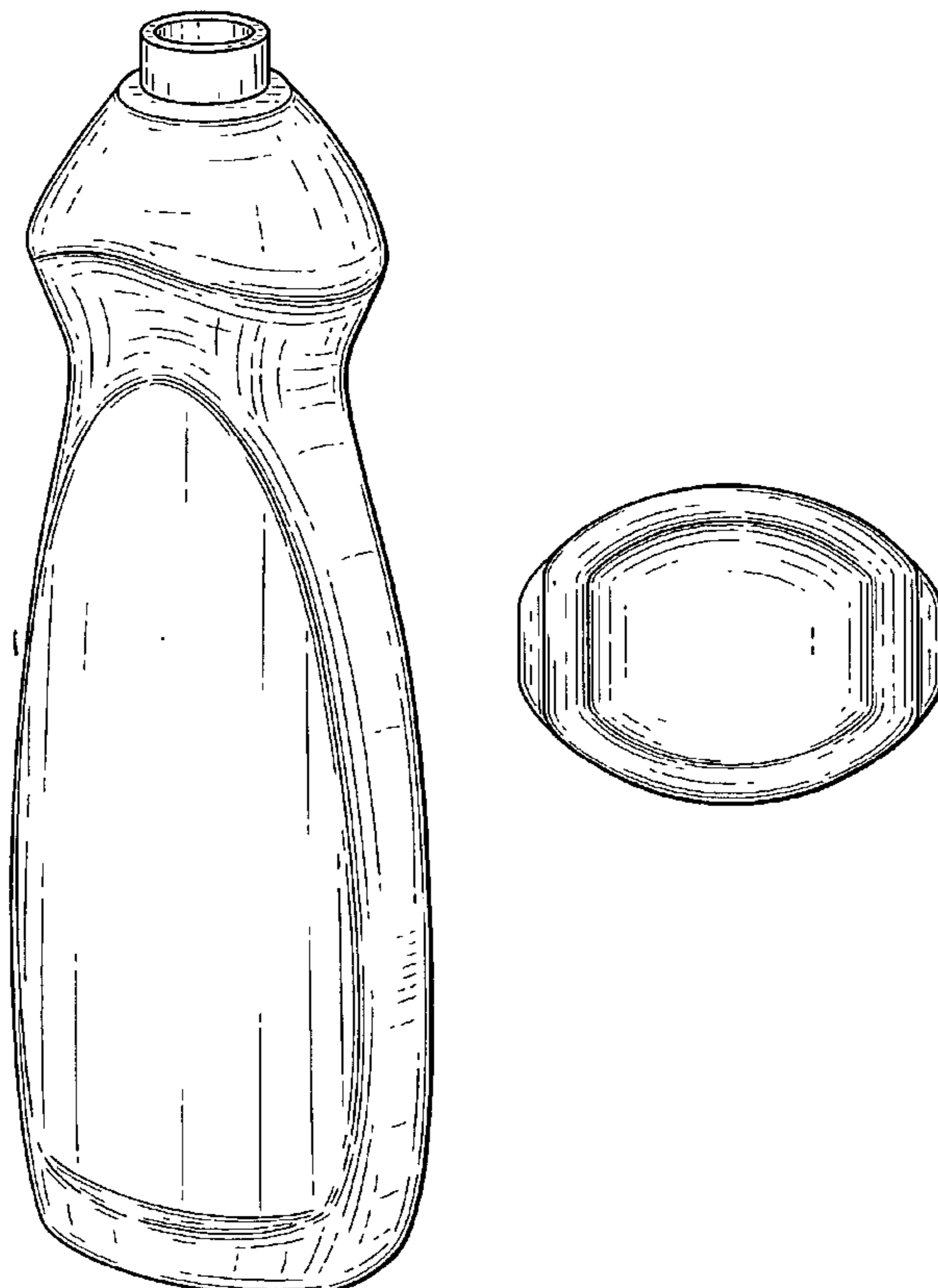
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the bottle of my design.
 FIG. 2 is a front elevation view thereof, the rear elevation view being a mirror image thereof.
 FIG. 3 of a right side elevation view thereof, the left side elevation view being a mirror image thereof.
 FIG. 4 is a top plan view thereof.

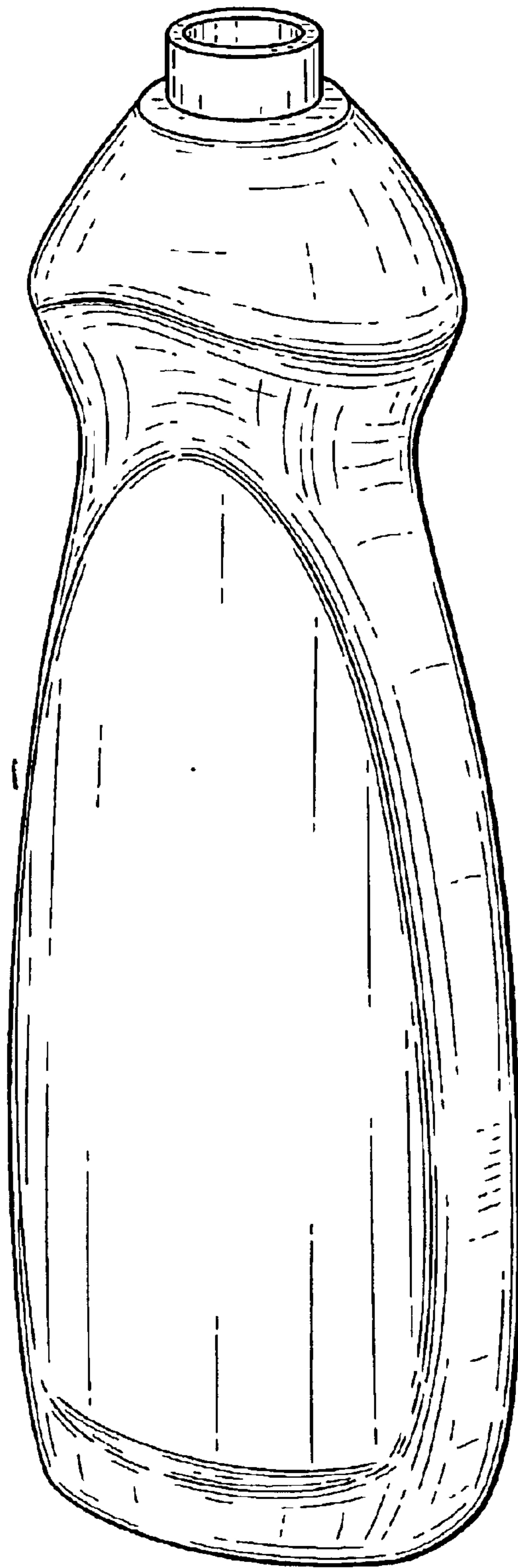

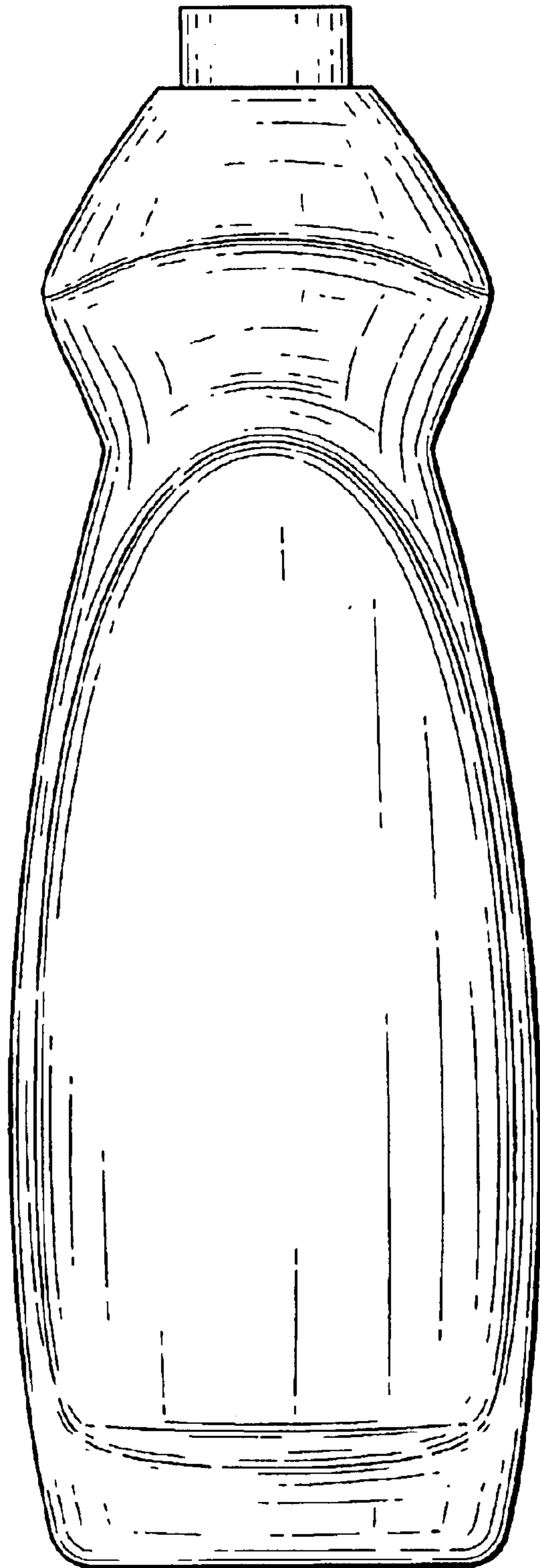

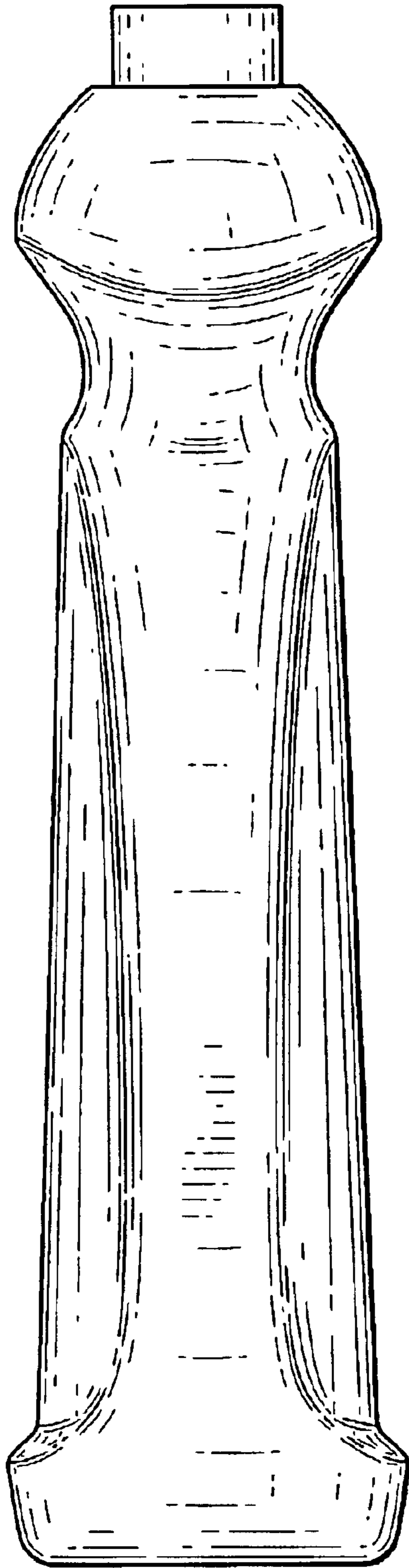

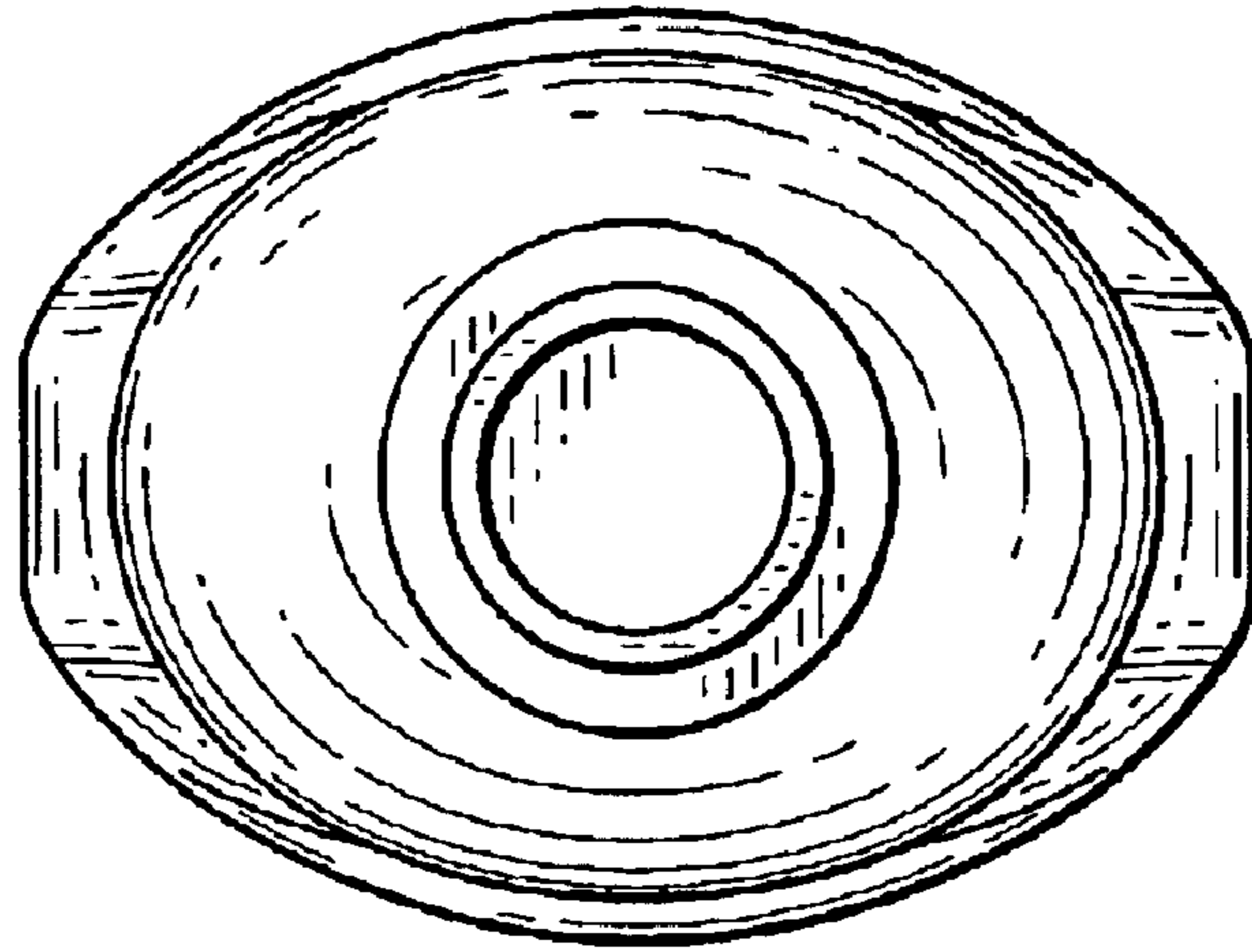

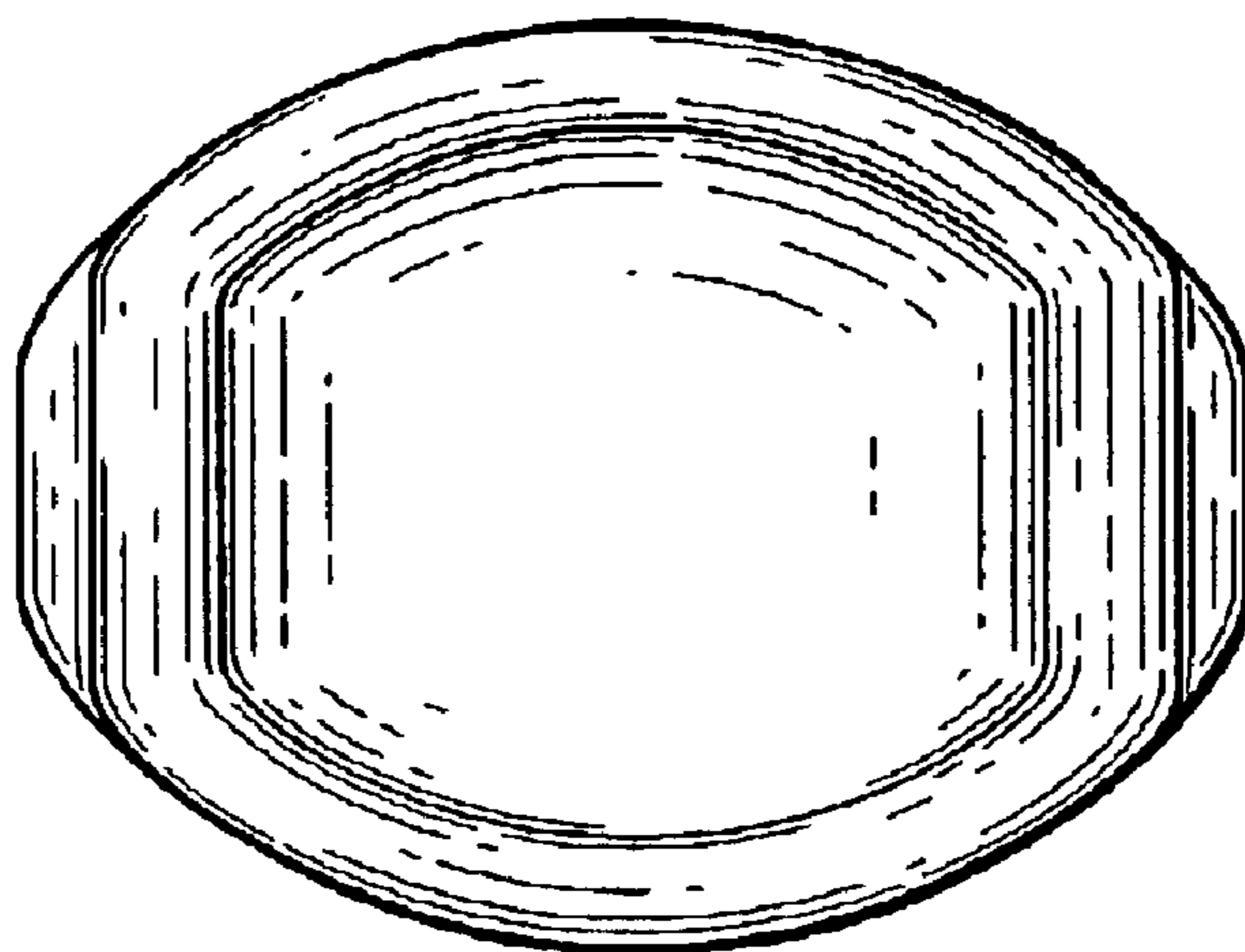

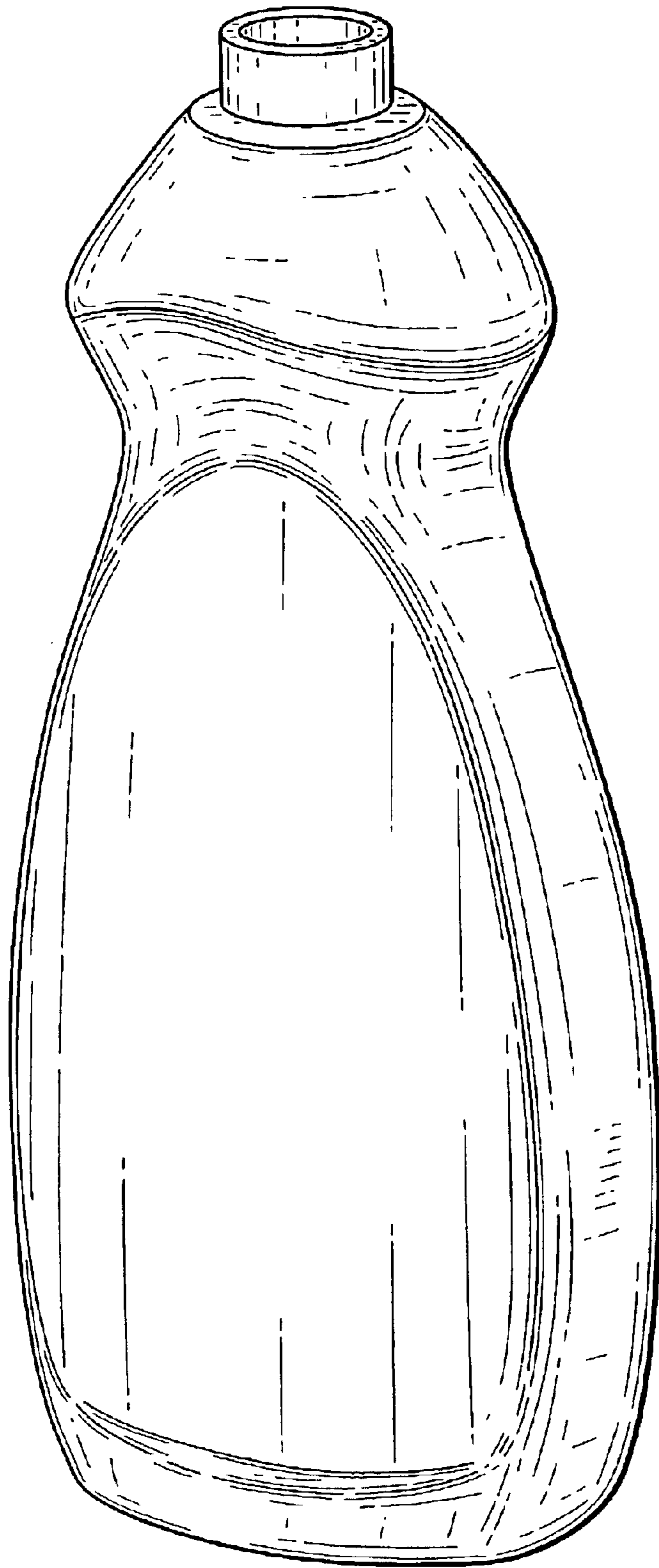

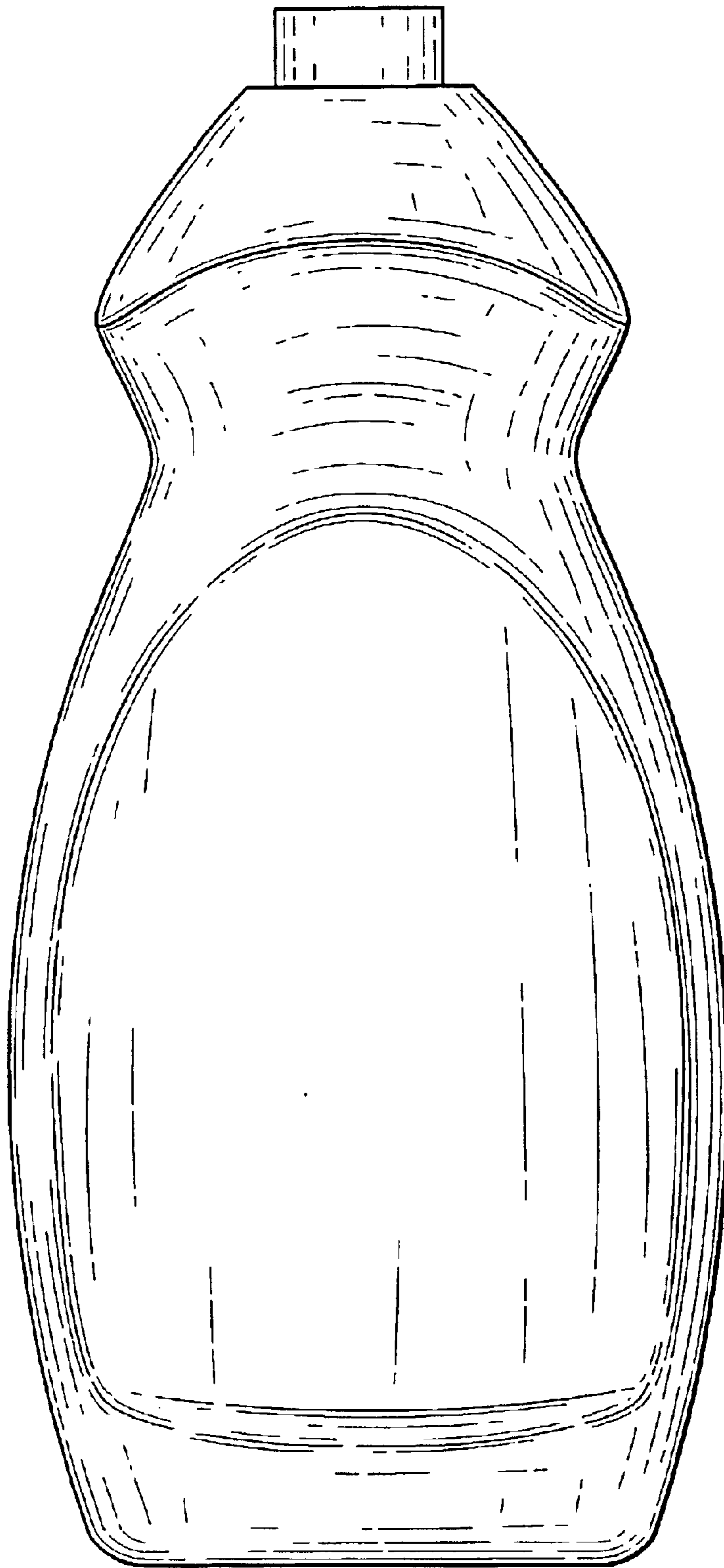

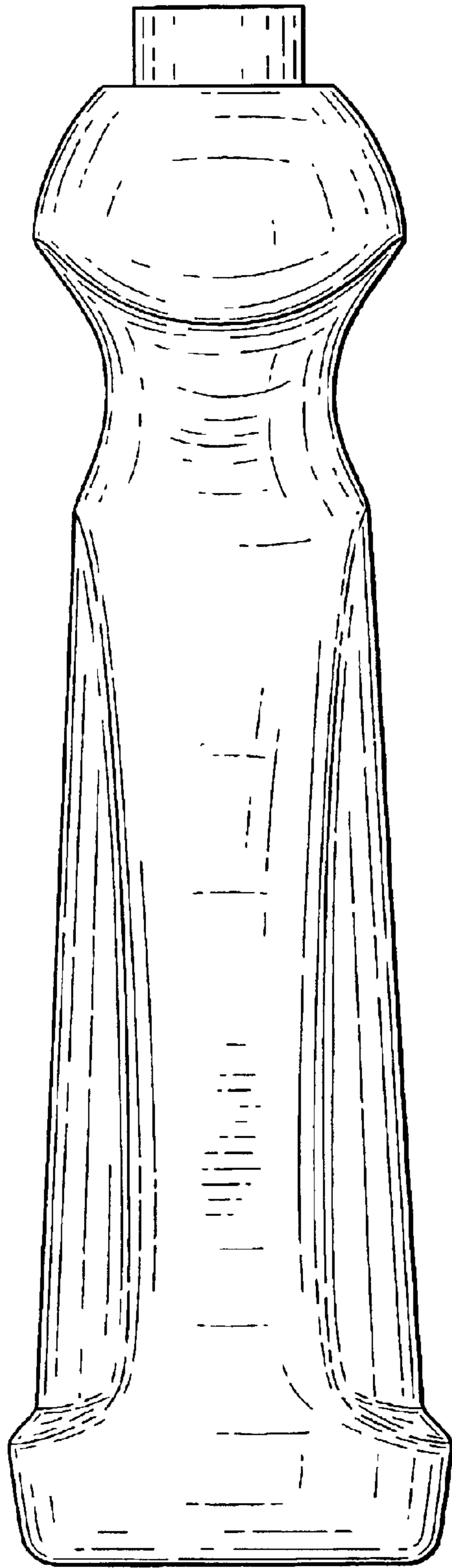

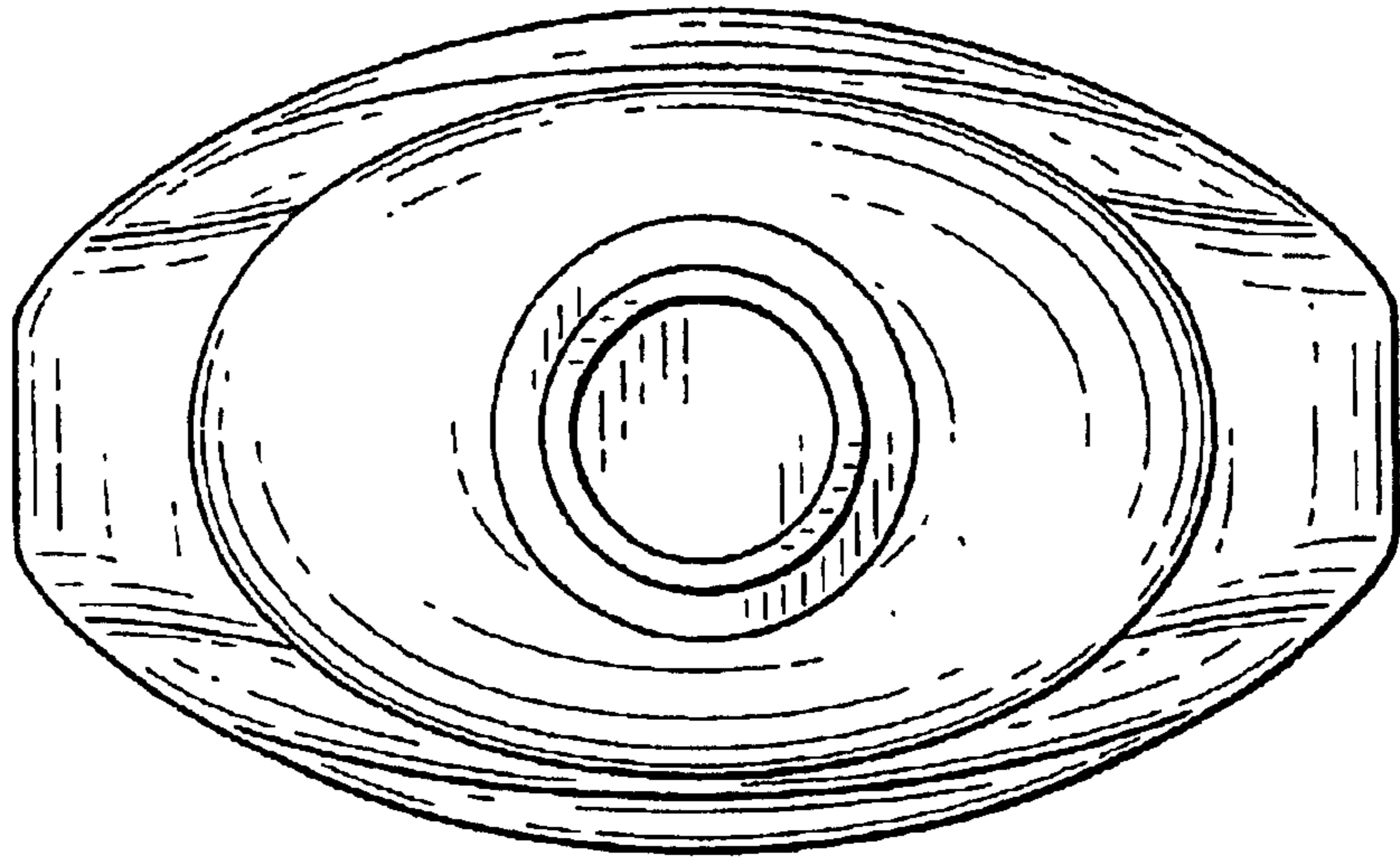

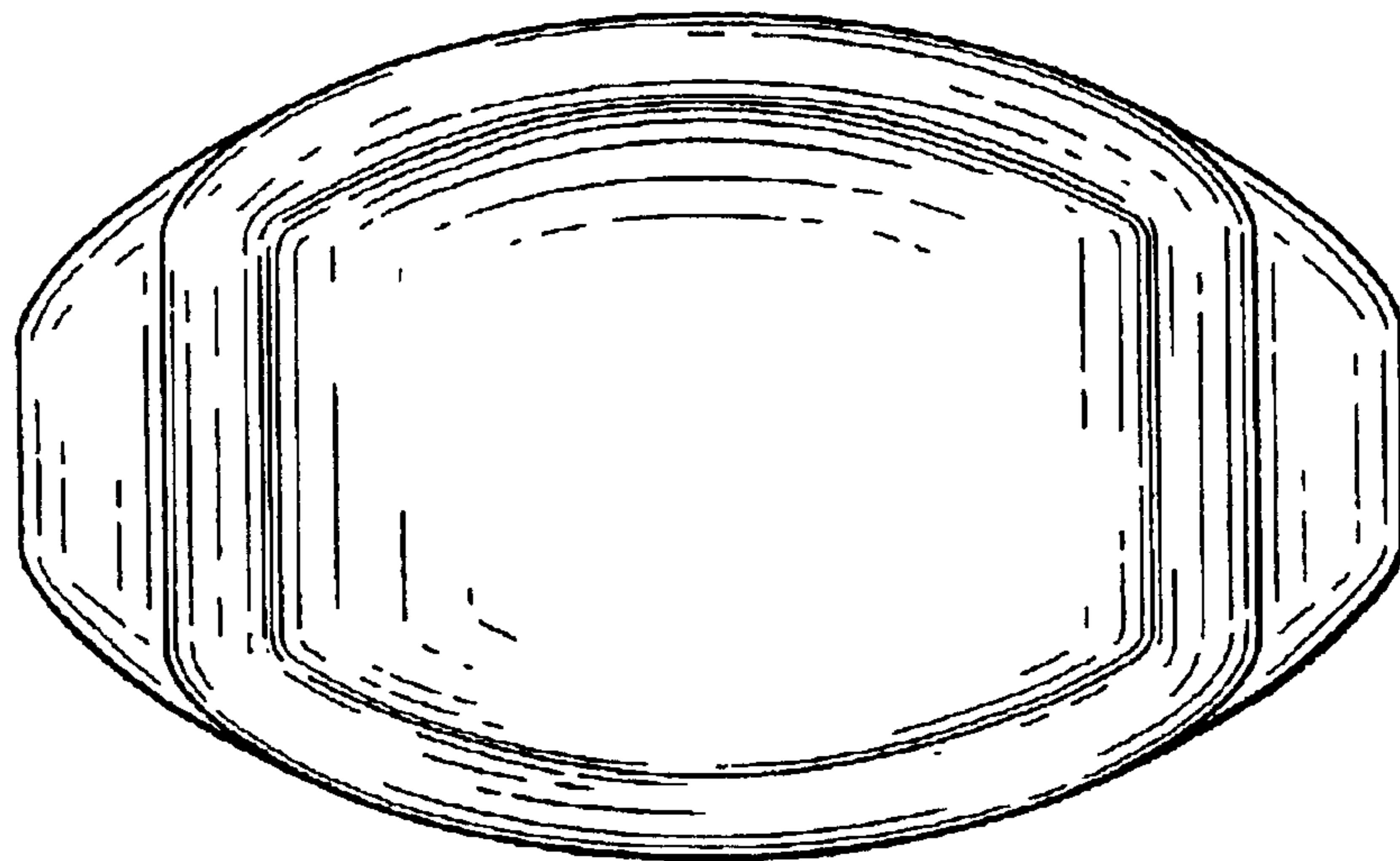
