(57) **CLAIM**

The ornamental design for a geometric ornament, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a geometric ornament in the form of a tetrahedron.

FIG. 2 is a top view of the geometric ornament of FIG. 1.

FIG. 3 is a side view of the geometric ornament of FIG. 1, the remaining two sides being identical.

FIG. 4 is a bottom view of the geometric ornament of FIG. 1.

FIG. 5 is a perspective view of a second embodiment of a geometric ornament in the form of a pyramid.

FIG. 6 is a top view of the geometric ornament of FIG. 5.

FIG. 7 is a side view of the geometric ornament of FIG. 5, the remaining three sides being identical.

FIG. 8 is a bottom view of the geometric ornament of FIG. 5.

FIG. 9 is a perspective view of a third embodiment of a geometric ornament in the form of a pyramid.

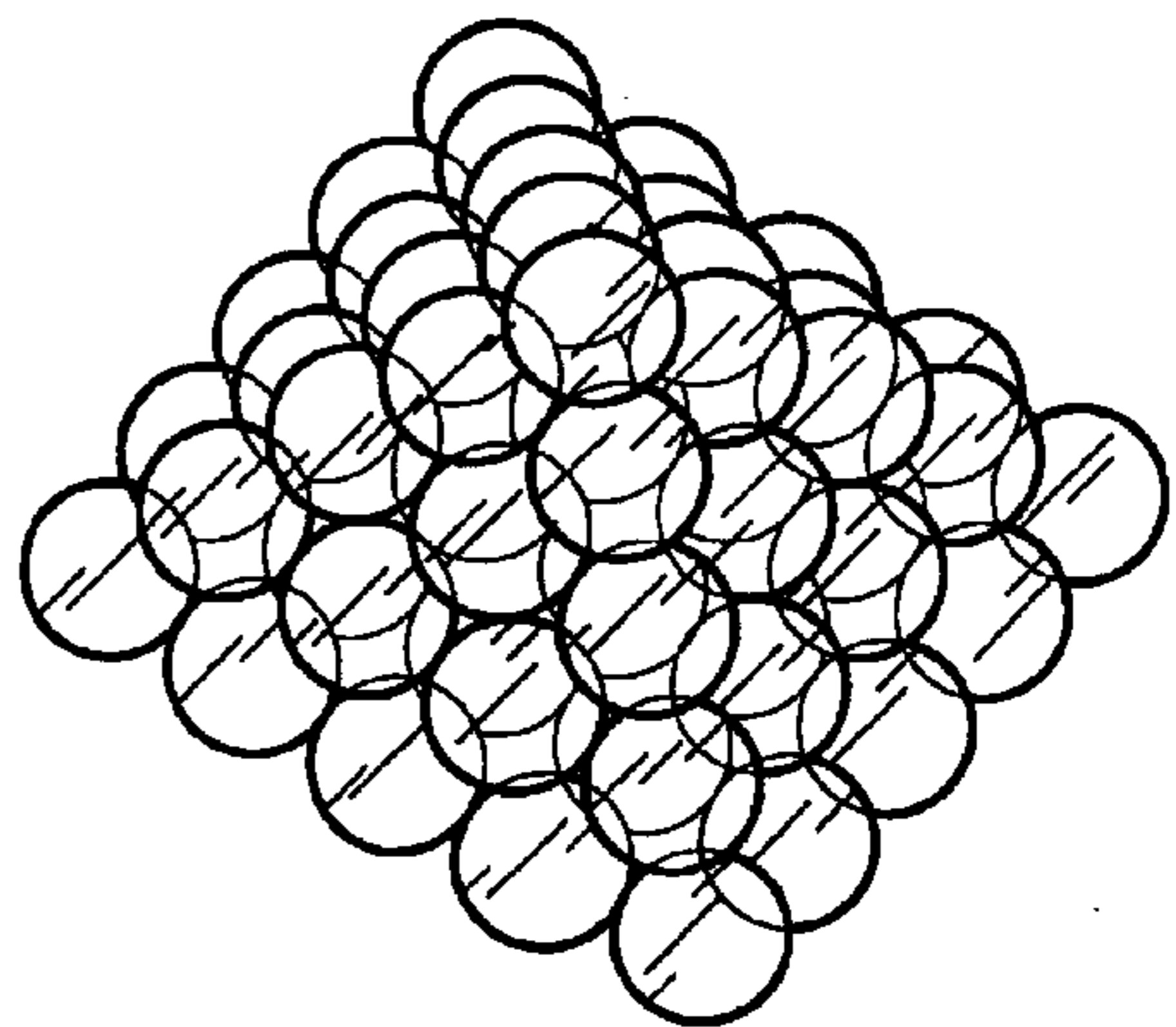
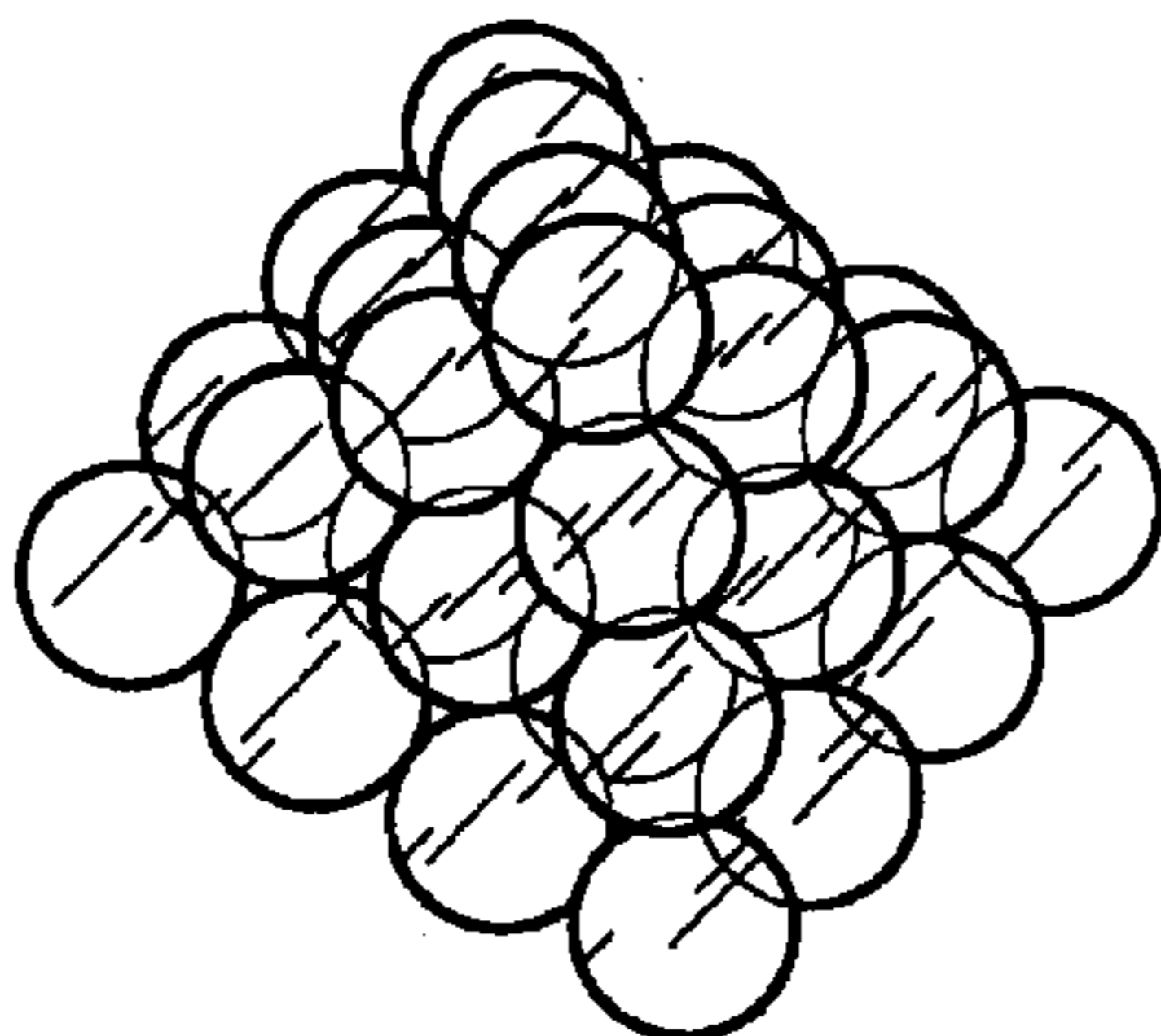
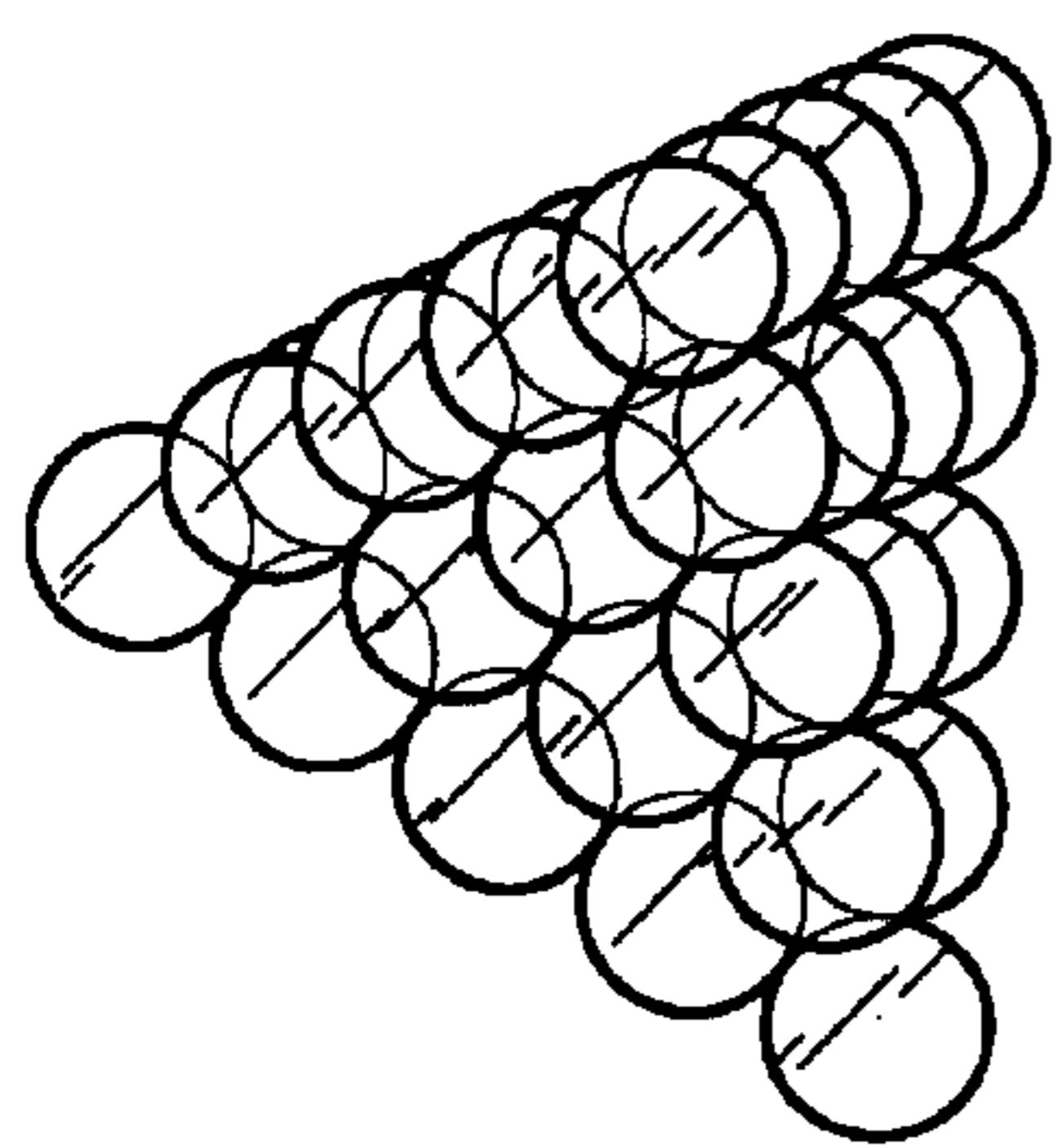
FIG. 10 is a top view of the geometric ornament of FIG. 9.

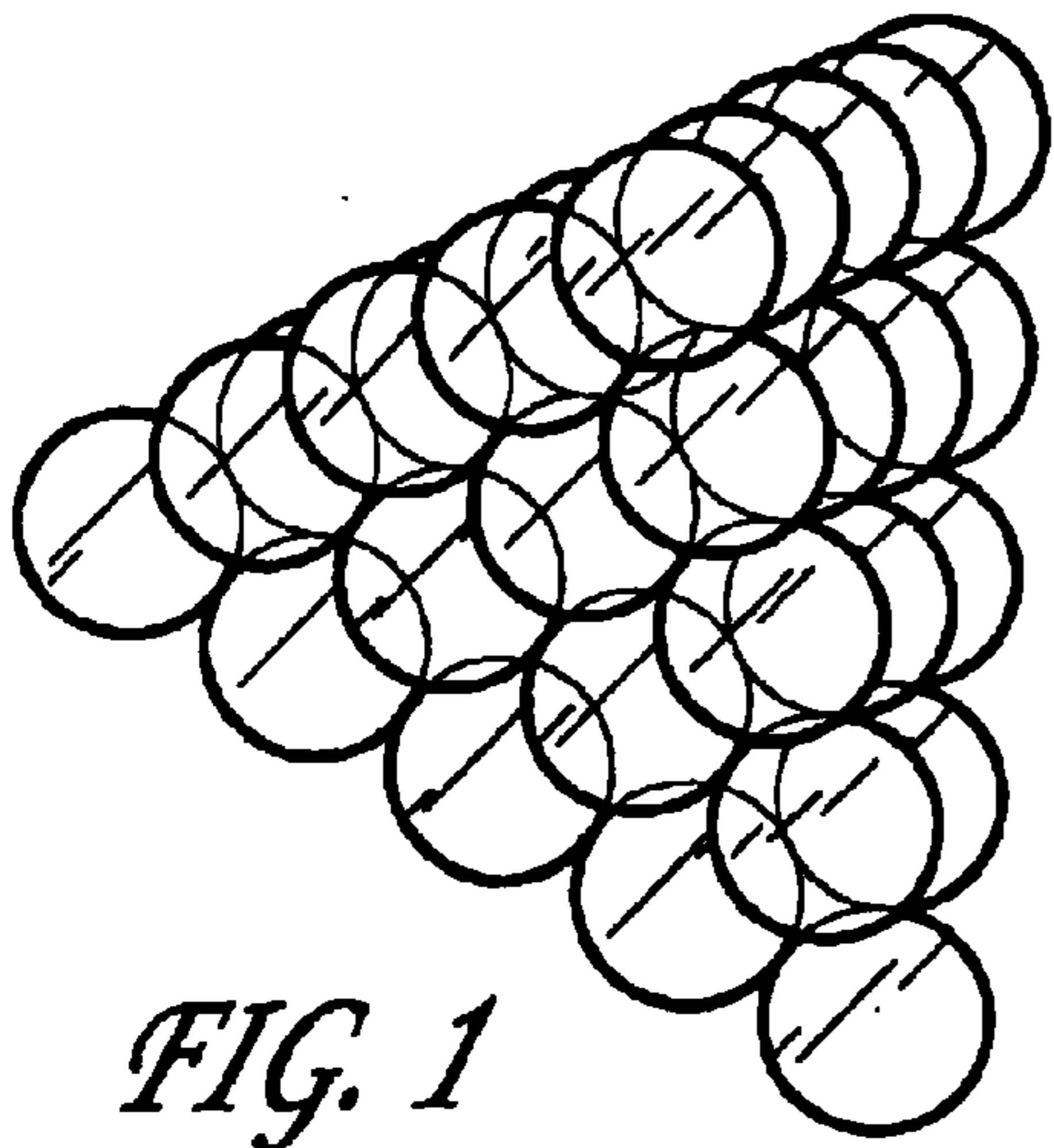

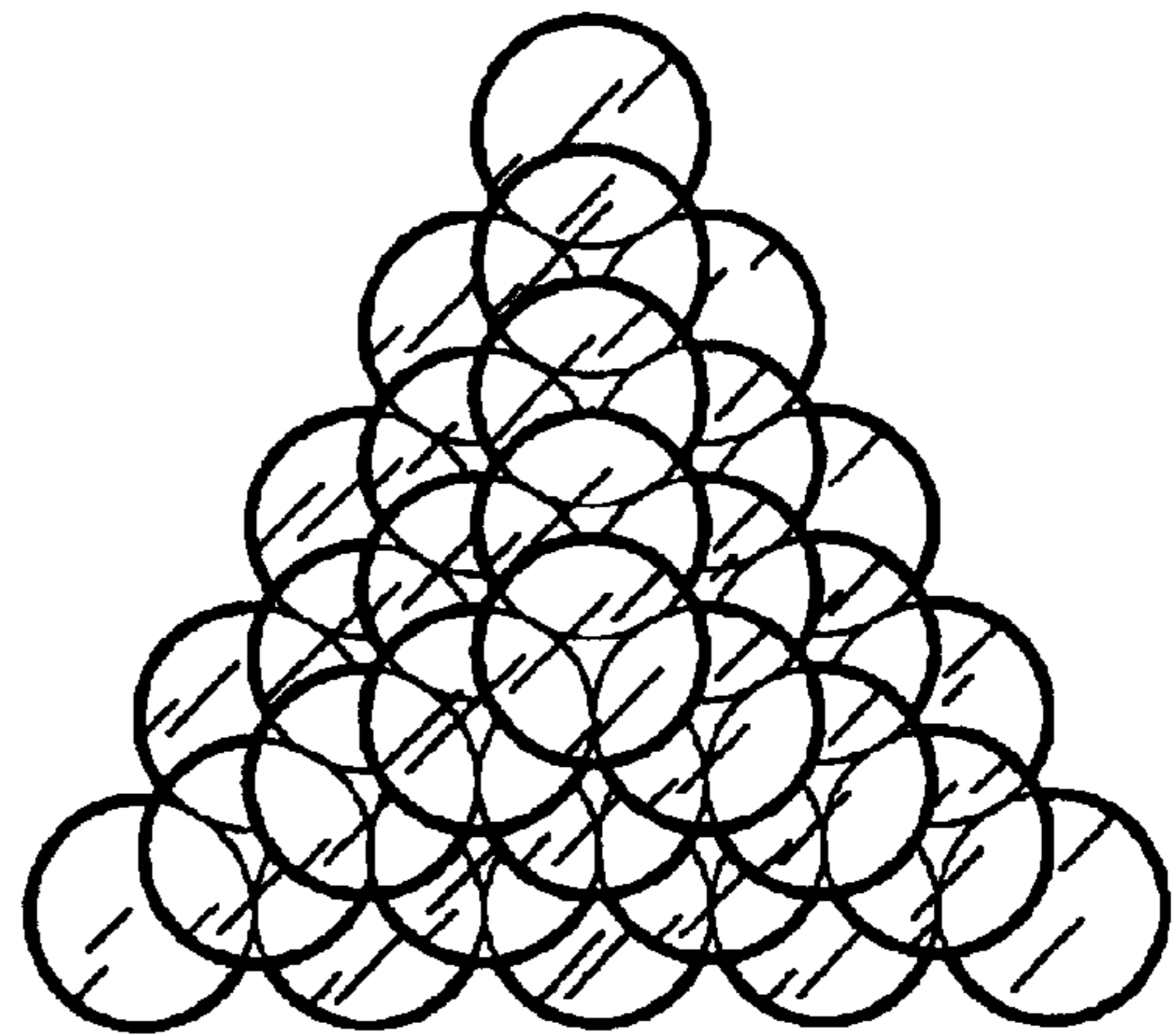

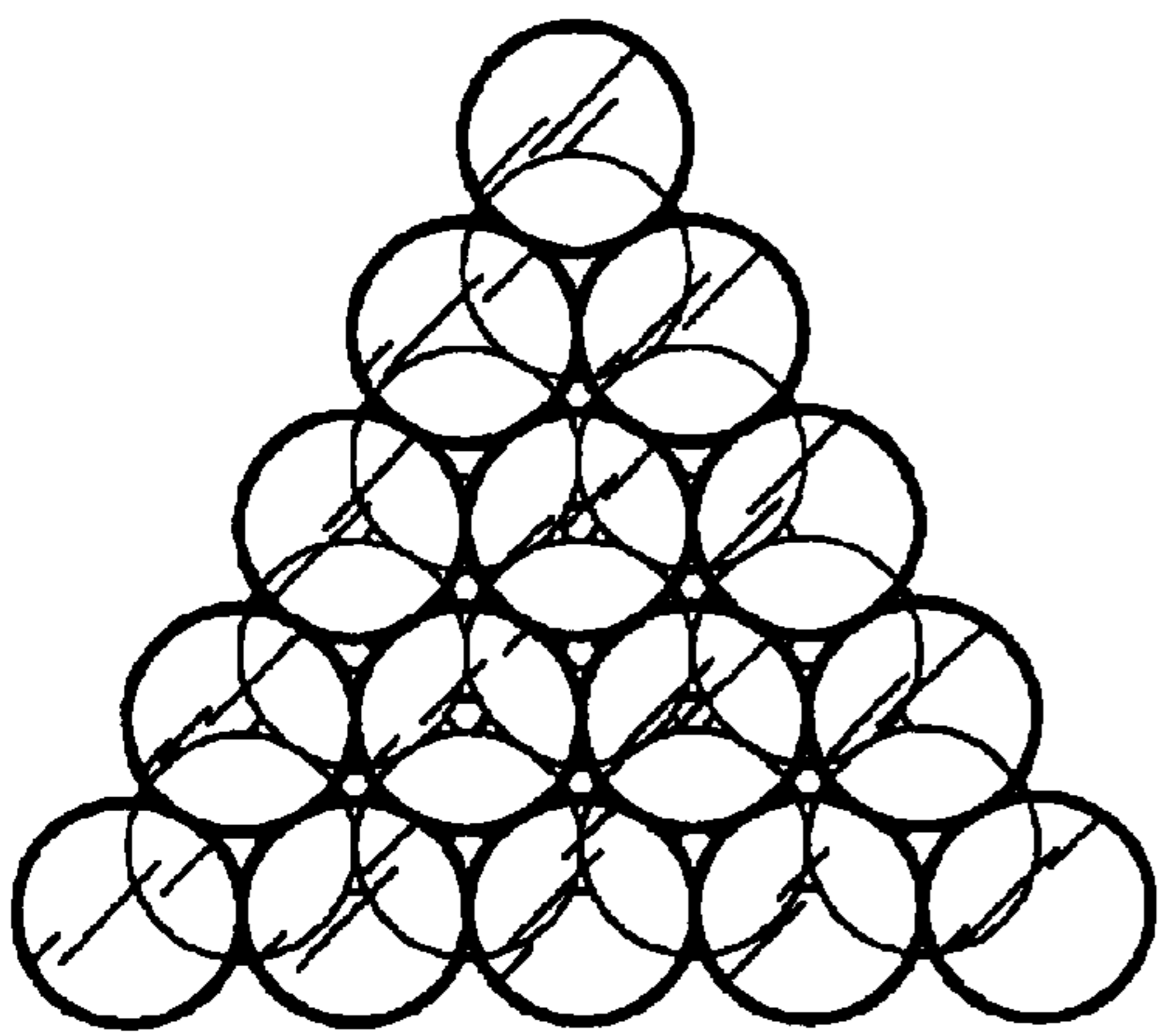

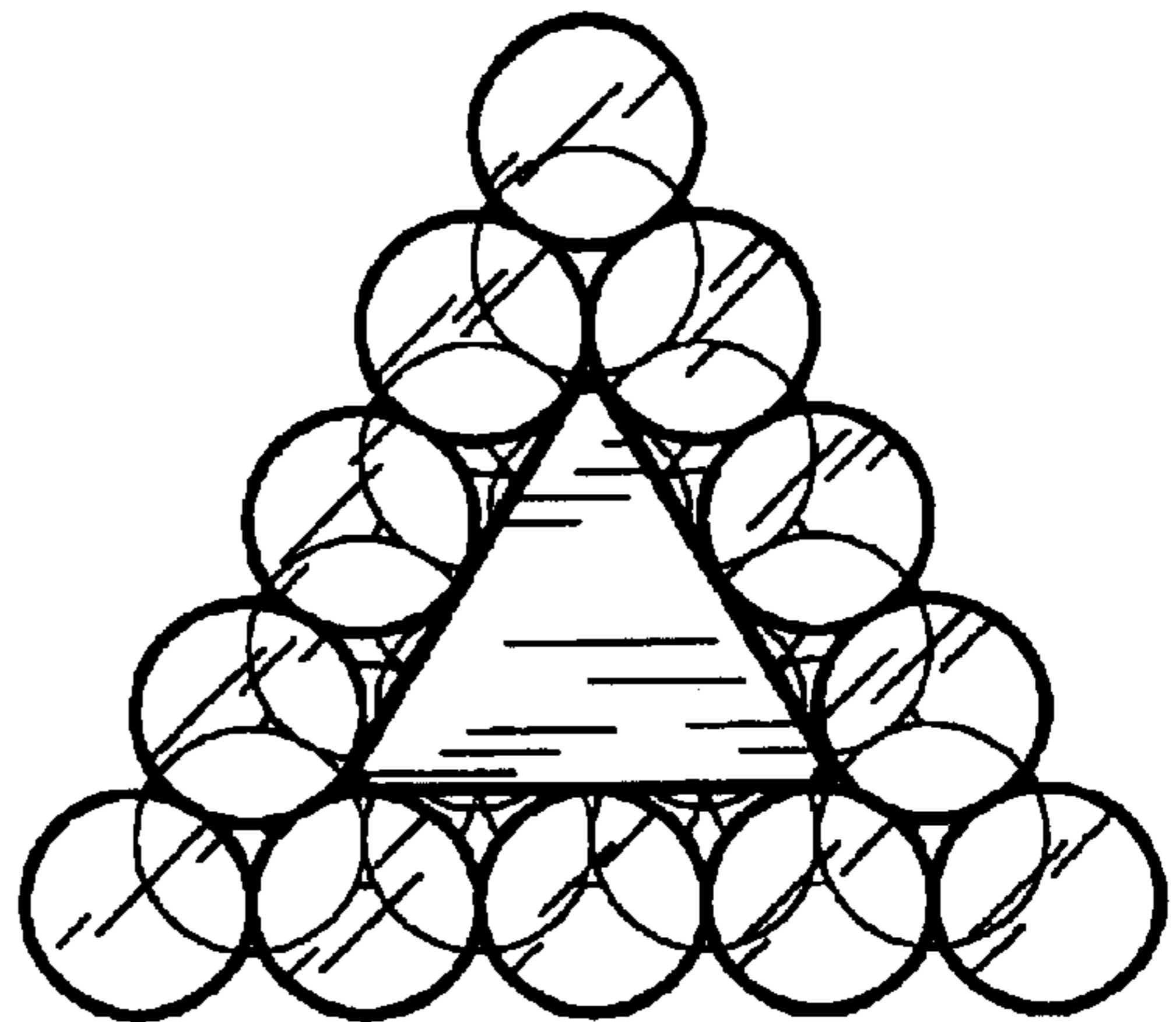

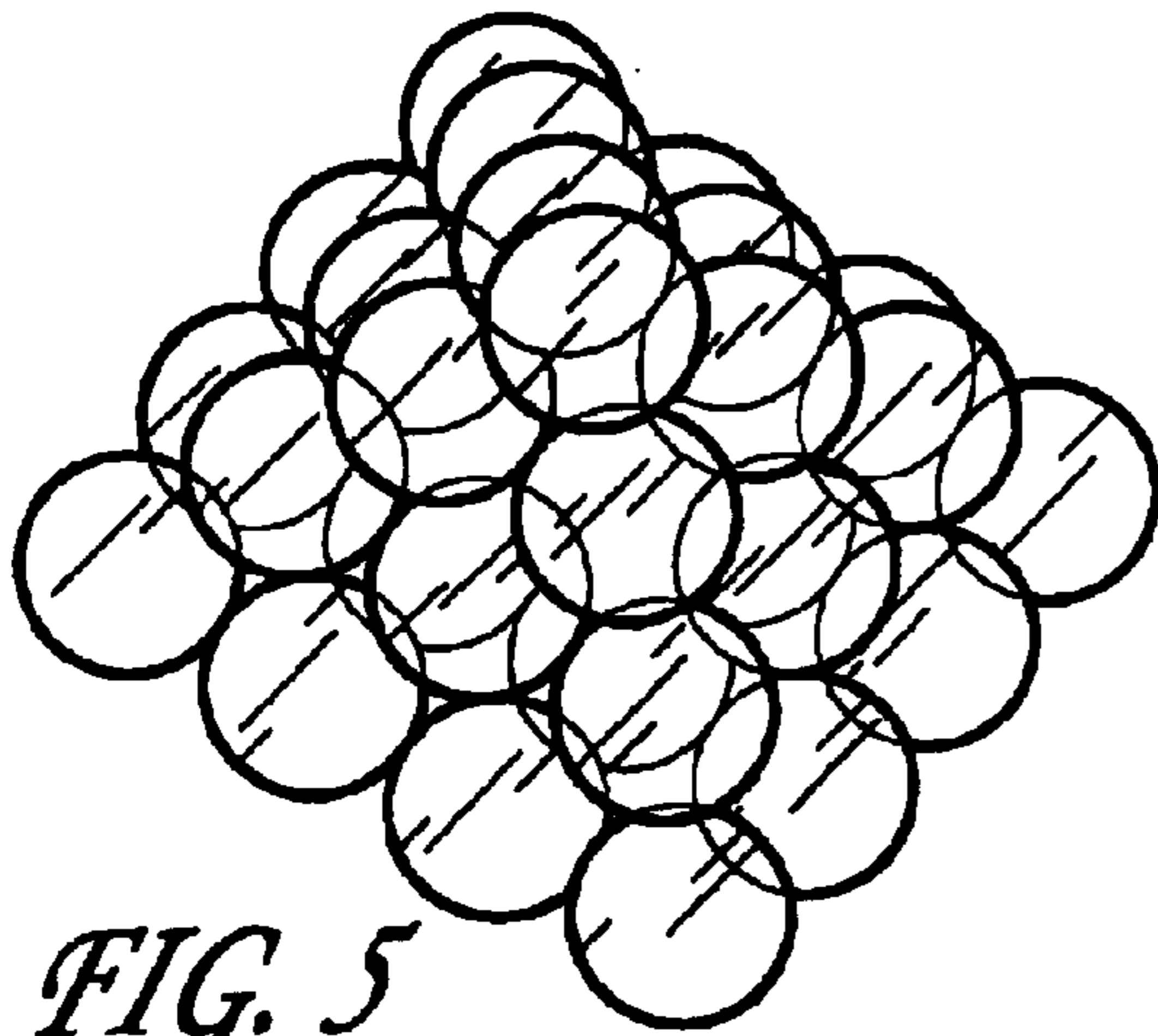

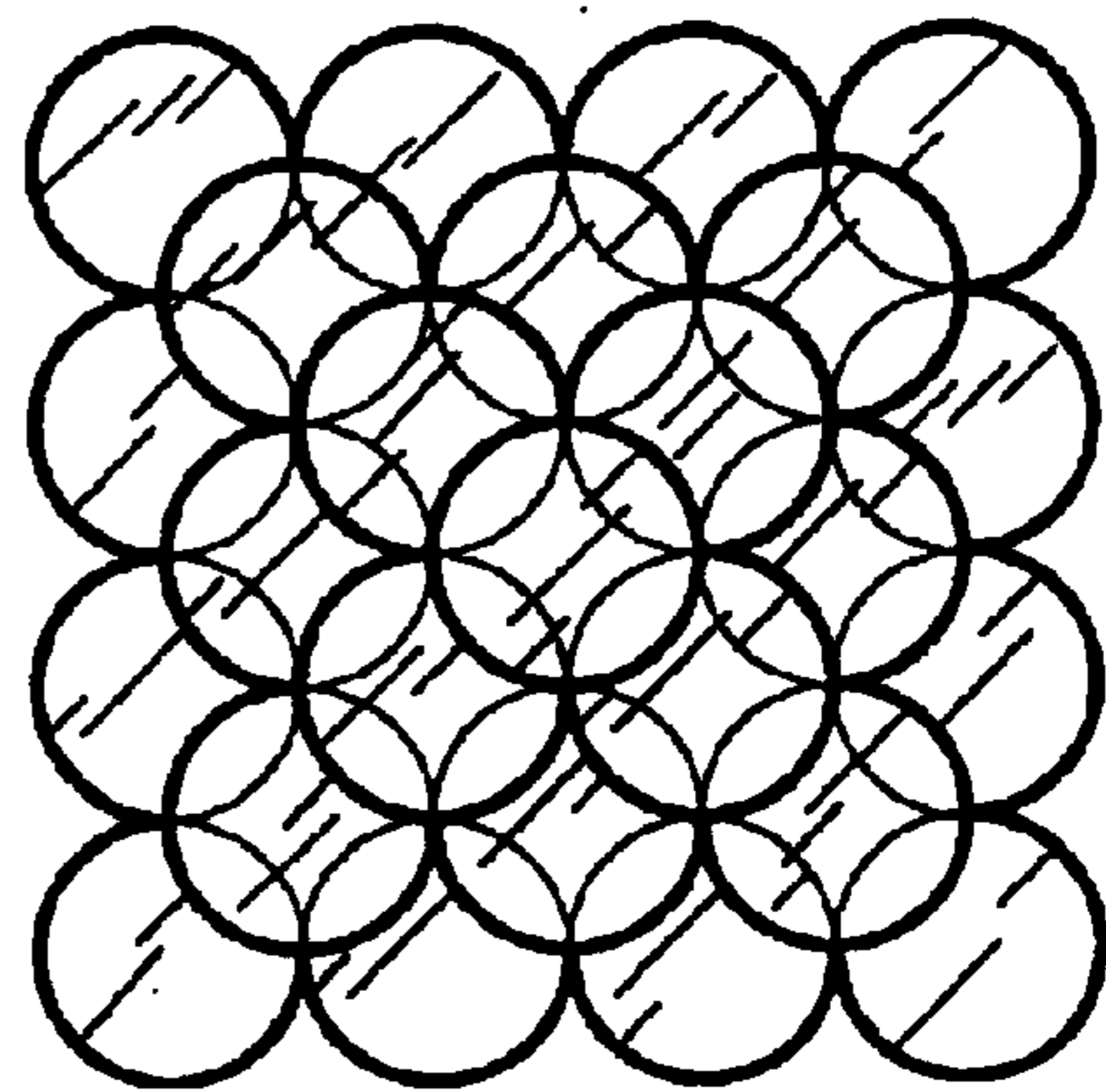

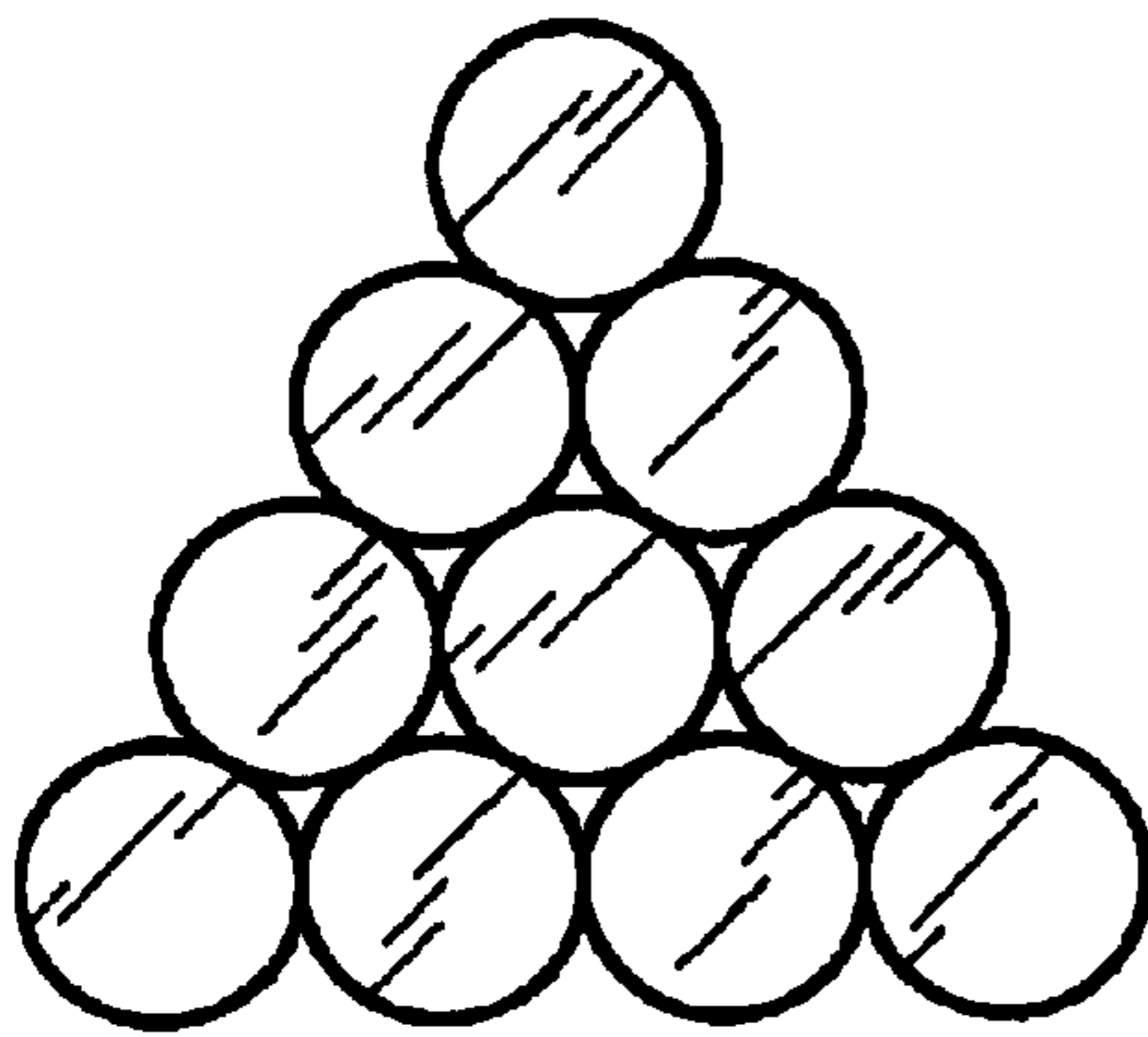

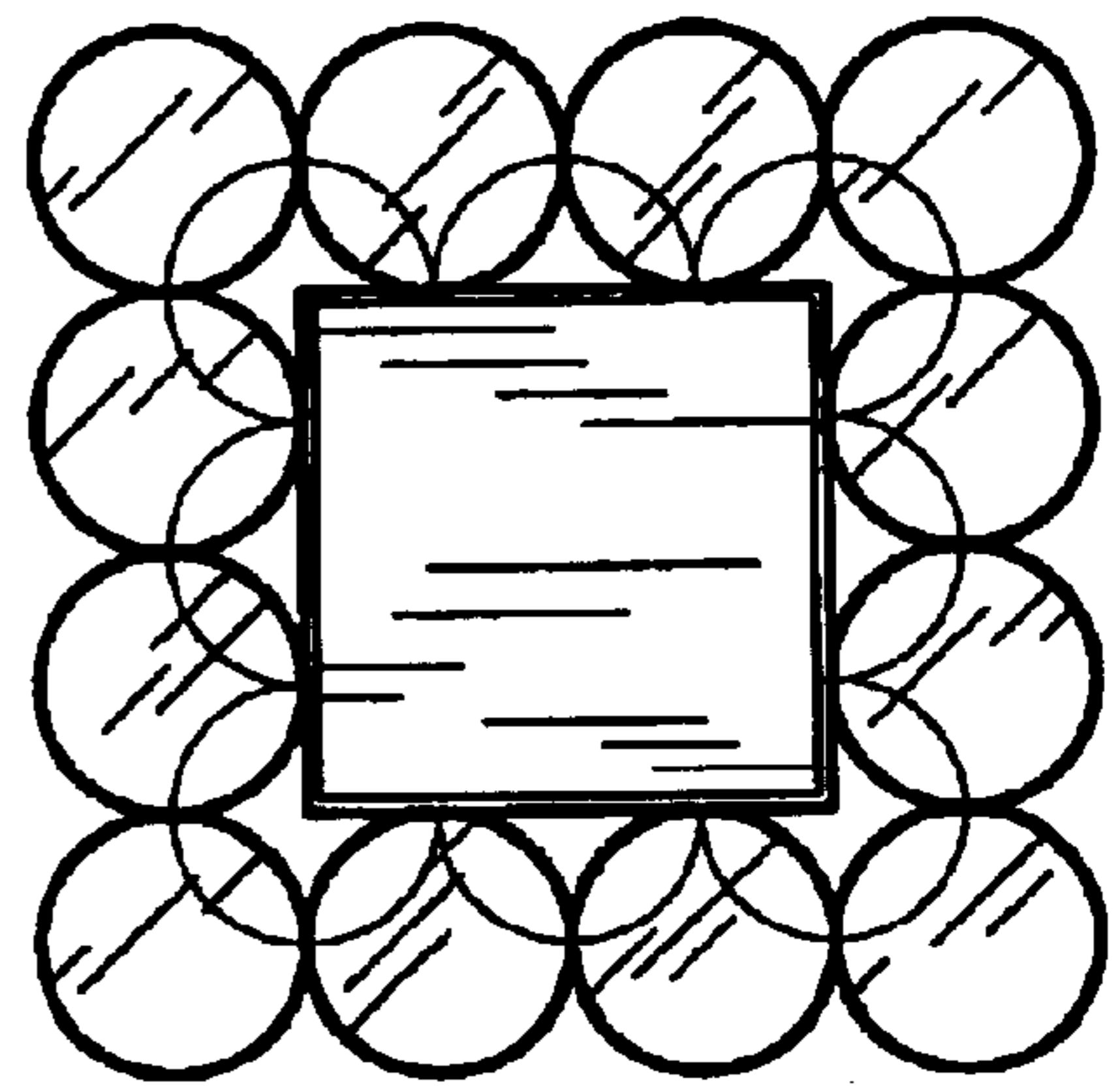

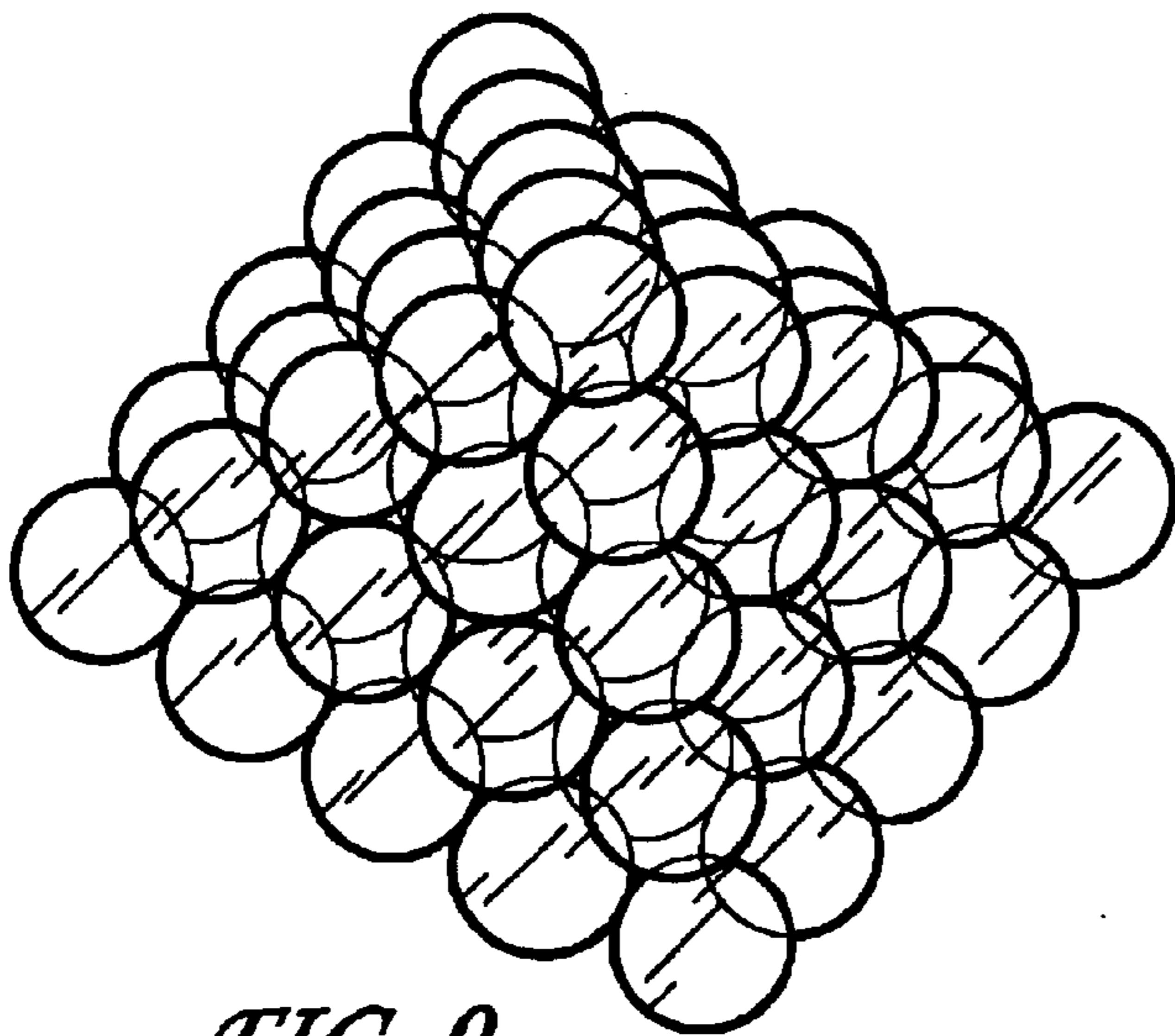

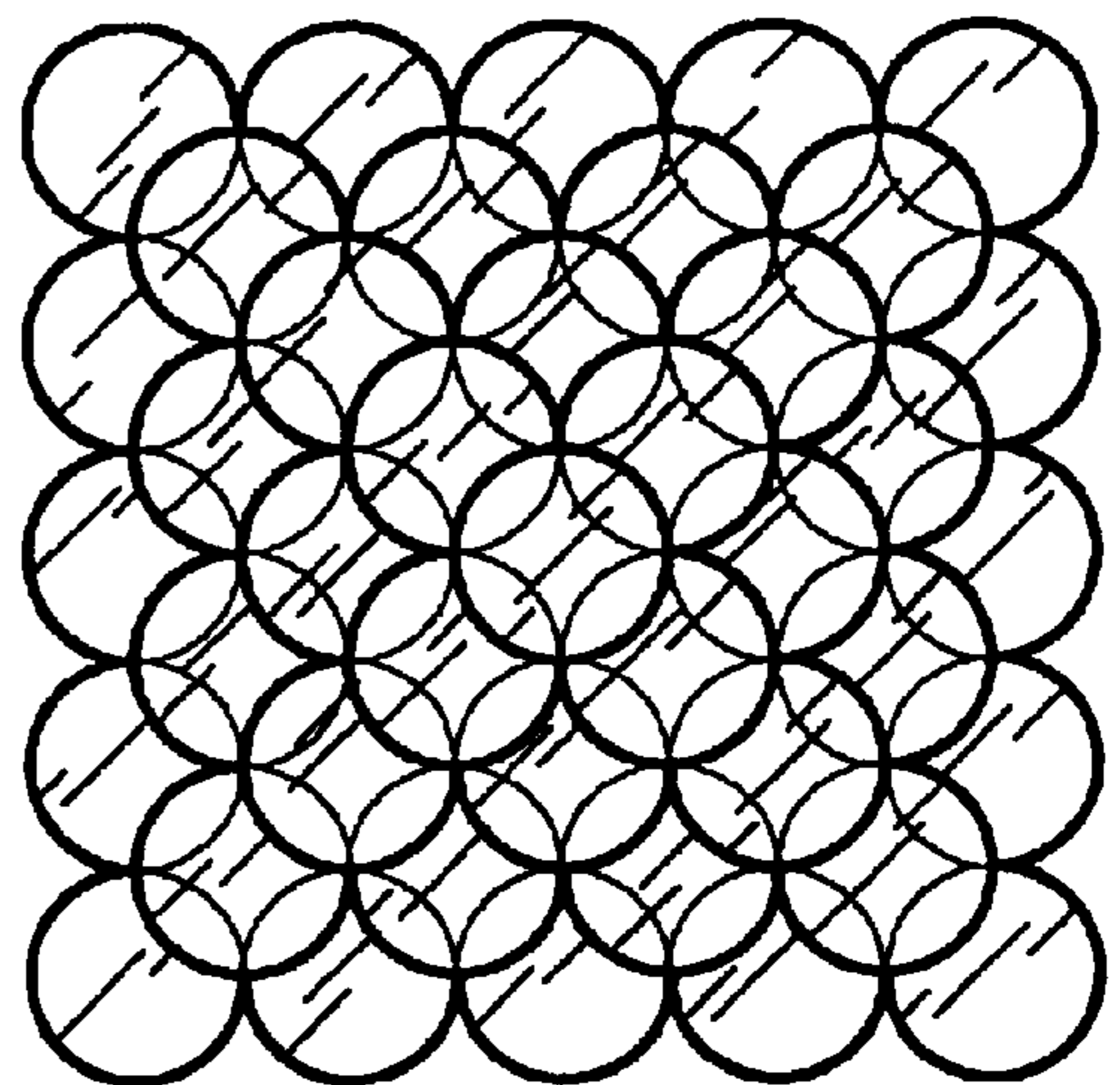

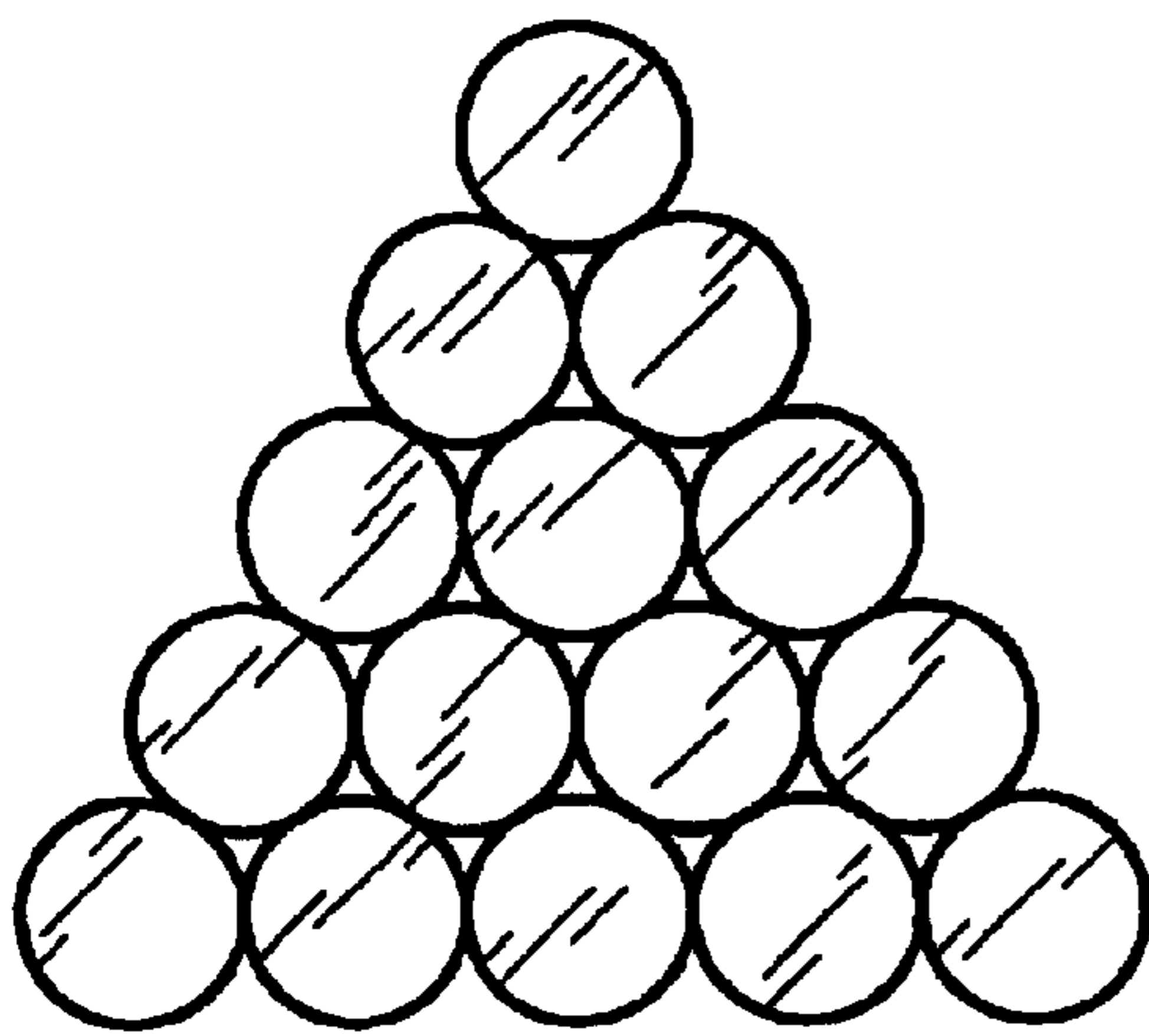

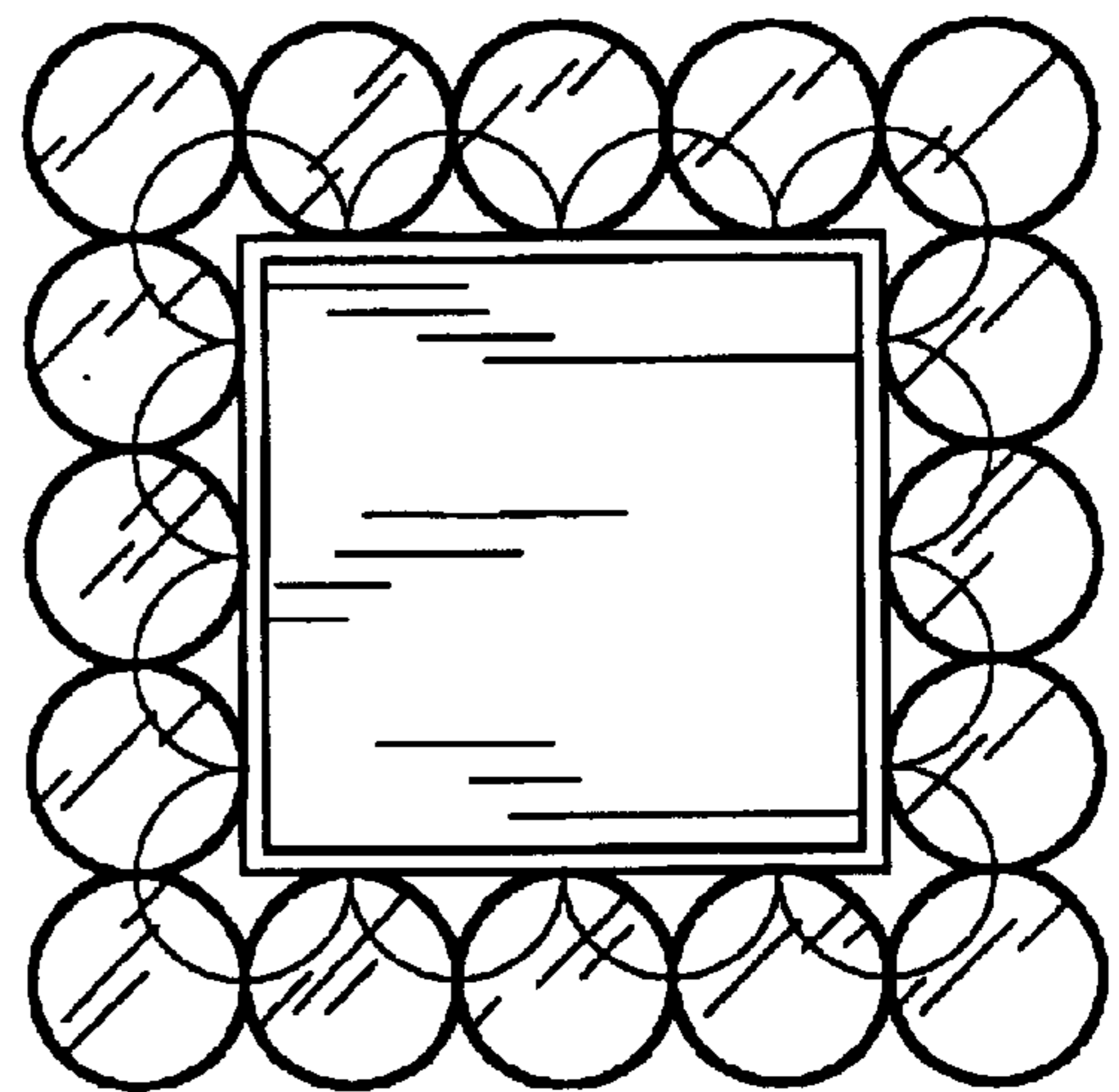
