(57) **CLAIM**

The ornamental design for the vehicle floor mat, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a vehicle floor mat incorporating my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right-side elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left-side elevational view thereof;

FIG. 6 is a reduced bottom plan view thereof;

FIG. 7 is a cross-sectional view along Line 7—7 of FIG. 1, depicting the contour of the upper rear surface section of the vehicle floor mat of FIG. 1;

FIG. 8 is a cross-sectional view along line 8—8 of FIG. 1, depicting the contour of the upper central surface section of the vehicle floor mat of FIG. 1; and

FIG. 9 is a cross-sectional view along Line 9—9 of FIG. 1, depicting the contour of the upper front surface section of the vehicle floor mat of FIG. 1.

FIG. 10 is a top plan view of a second embodiment of a vehicle floor mat incorporating my new design;

FIG. 11 is a front elevational view thereof;

FIG. 12 is a right-side elevational view thereof;

FIG. 13 is a rear elevational view thereof;

FIG. 14 is a left-side elevational view thereof;

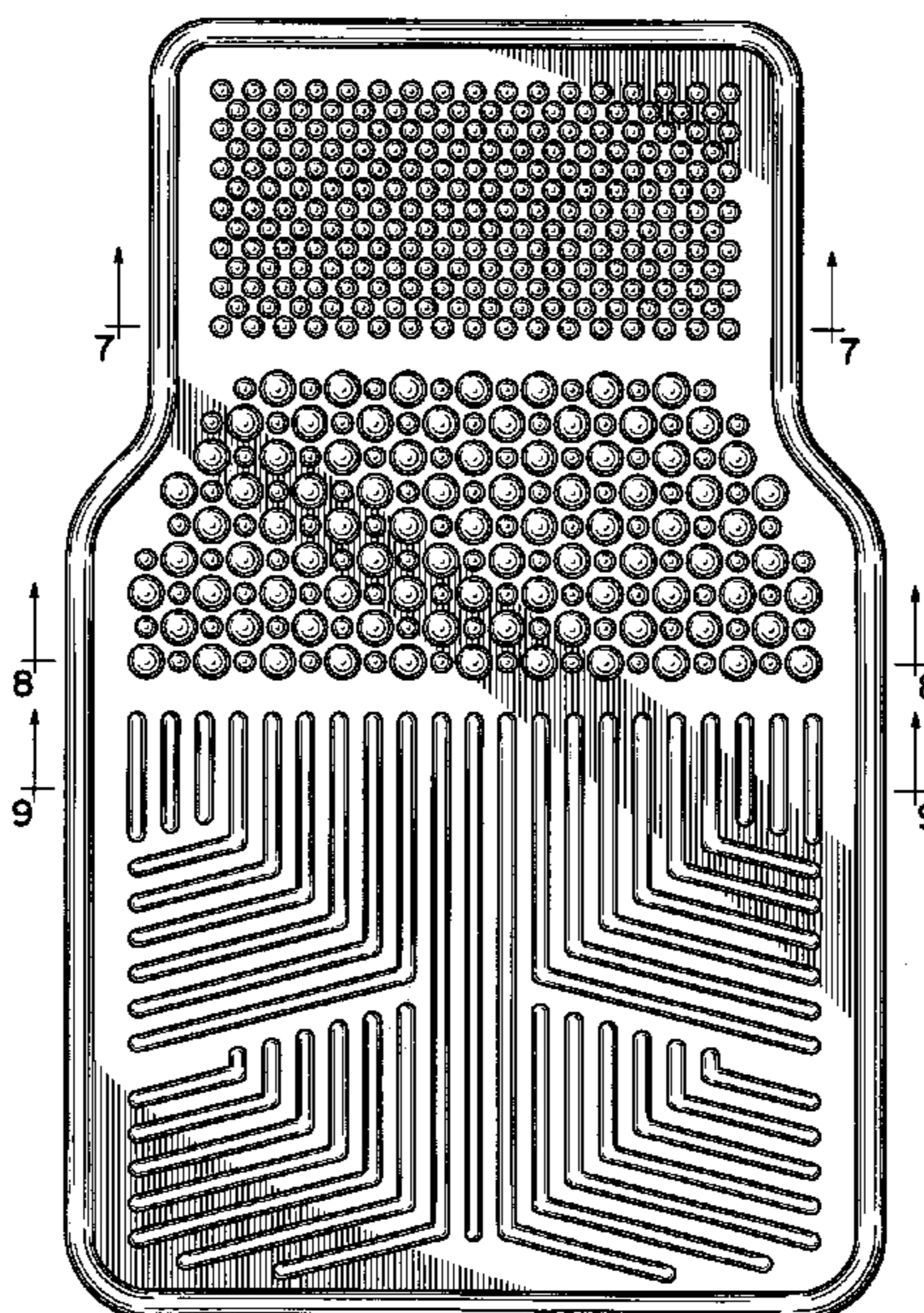

FIG. 17 is a cross sectional view taken along line 17—17 of FIG. 10 depicting the contour of the upper front surface section of the vehicle floor mat of FIG. 10; and,

FIG. 18 is a reduced bottom plan view thereof.

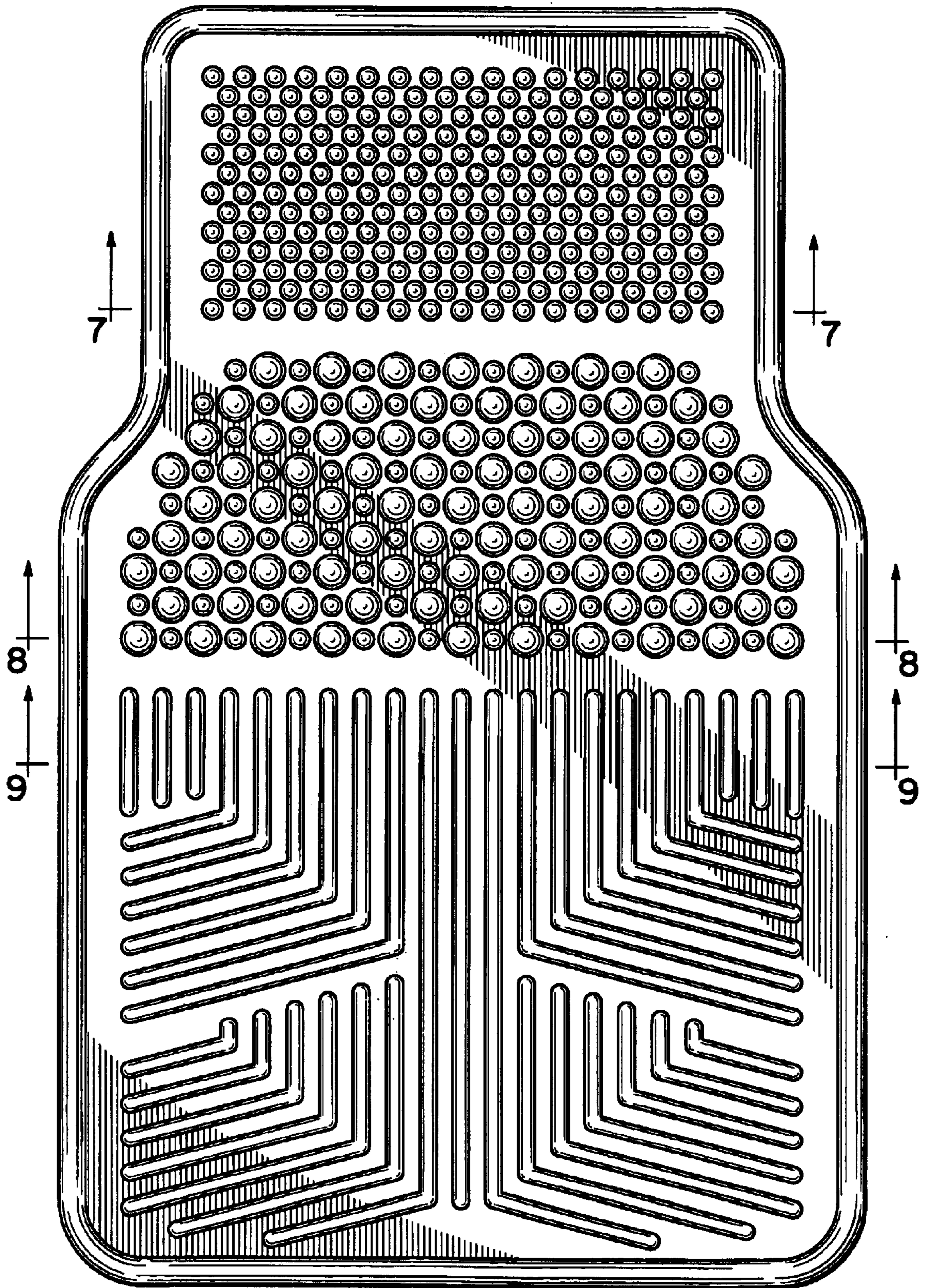

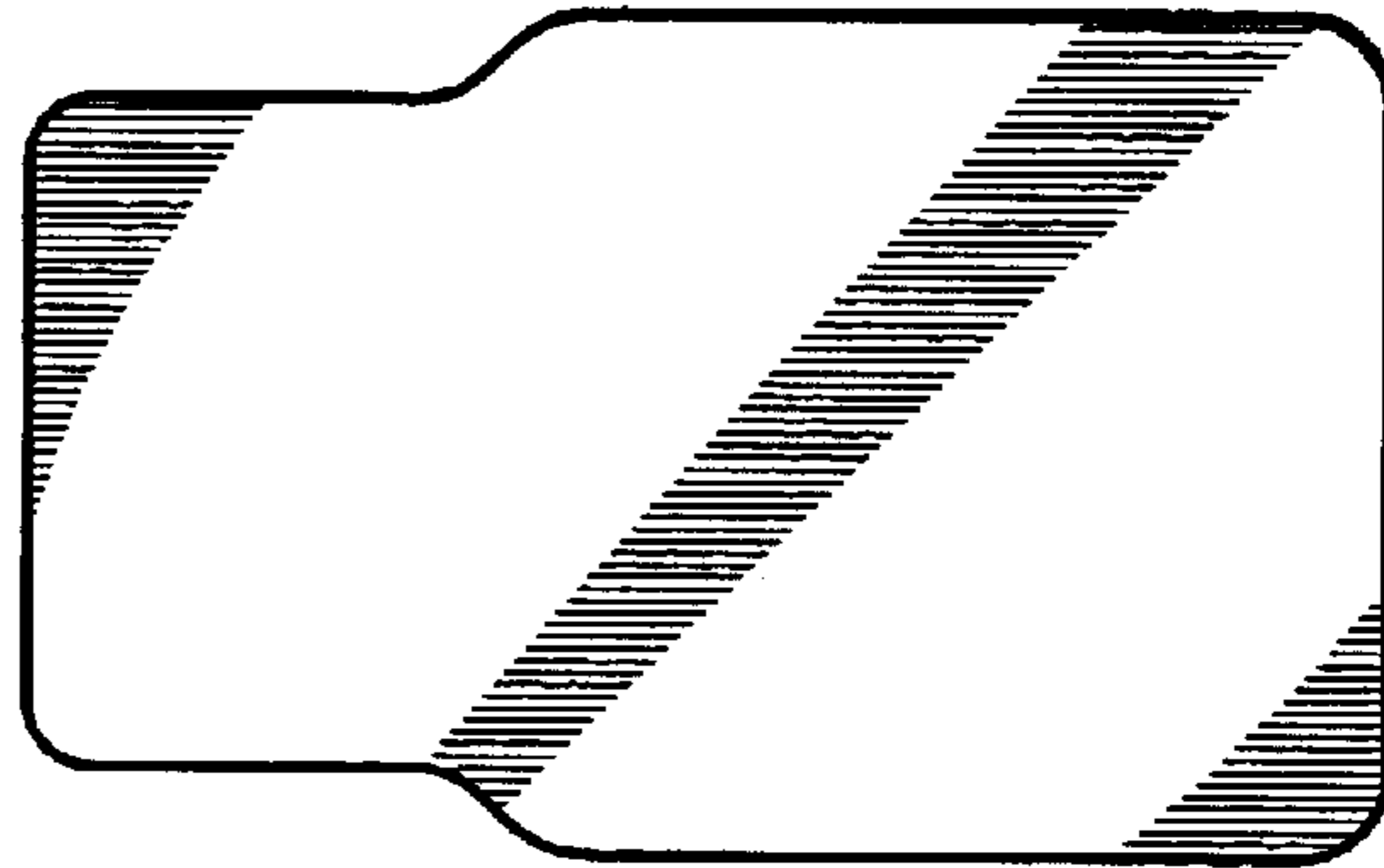

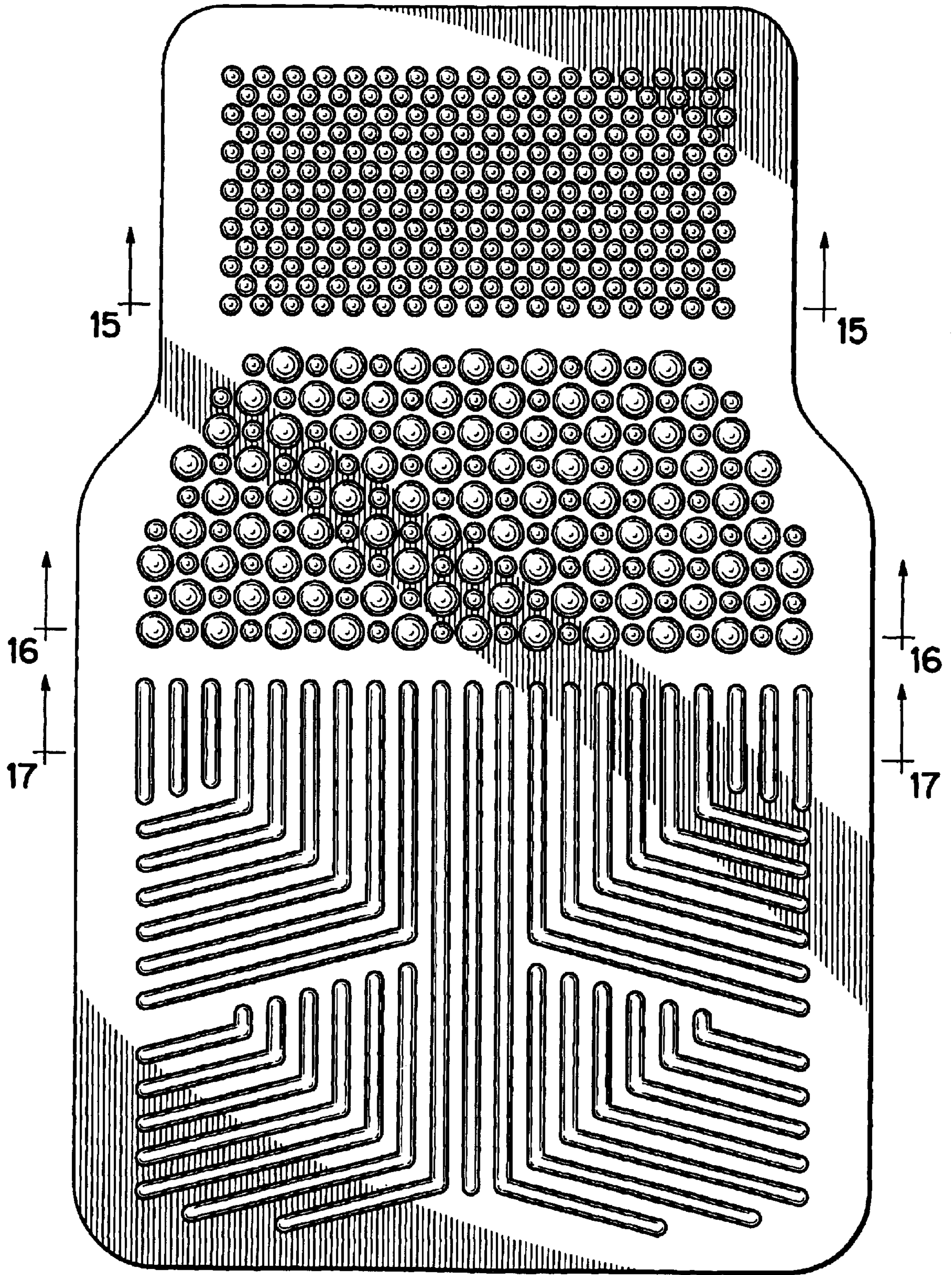

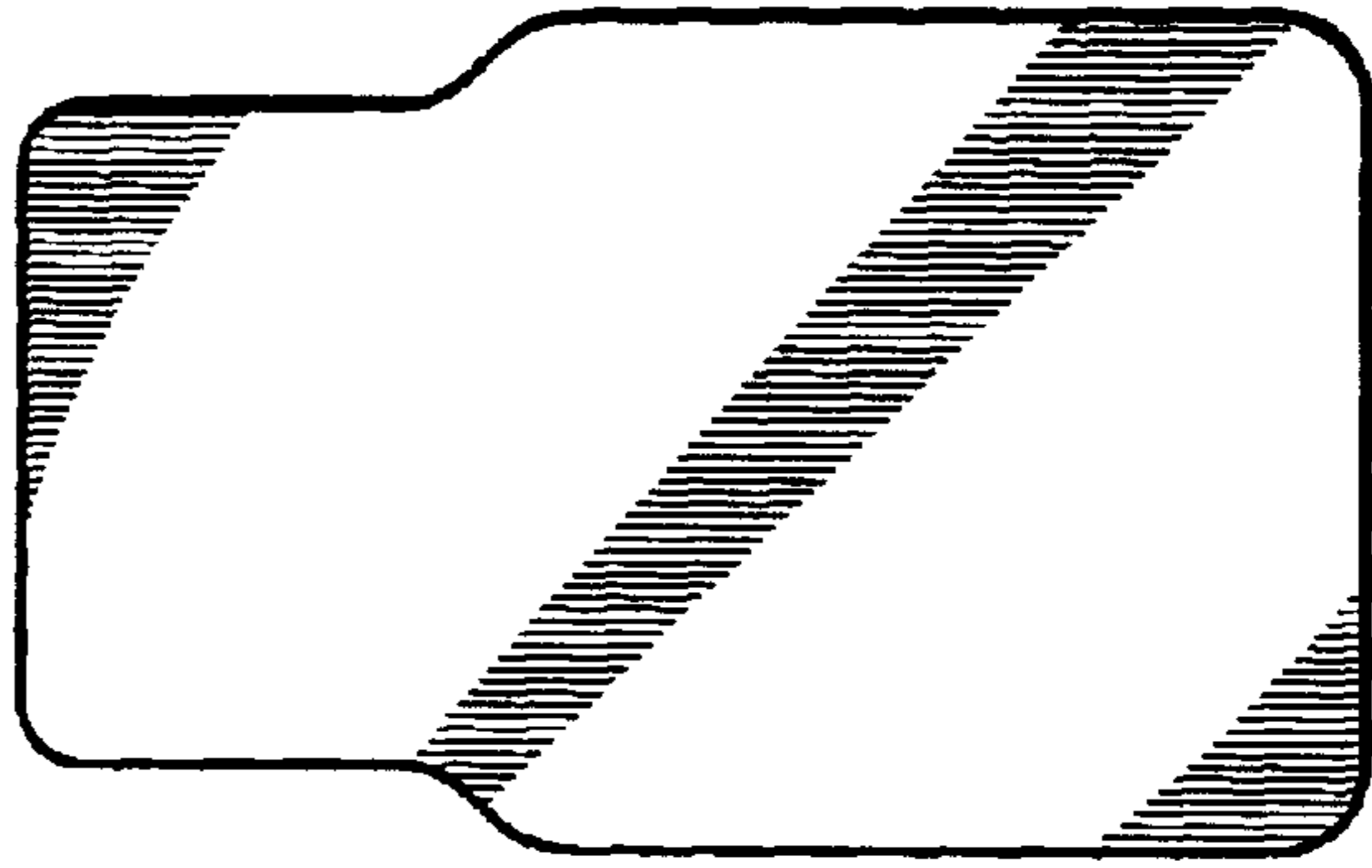
