I claim the ornamental design for the spoiler for load carrier strut, as shown and described.

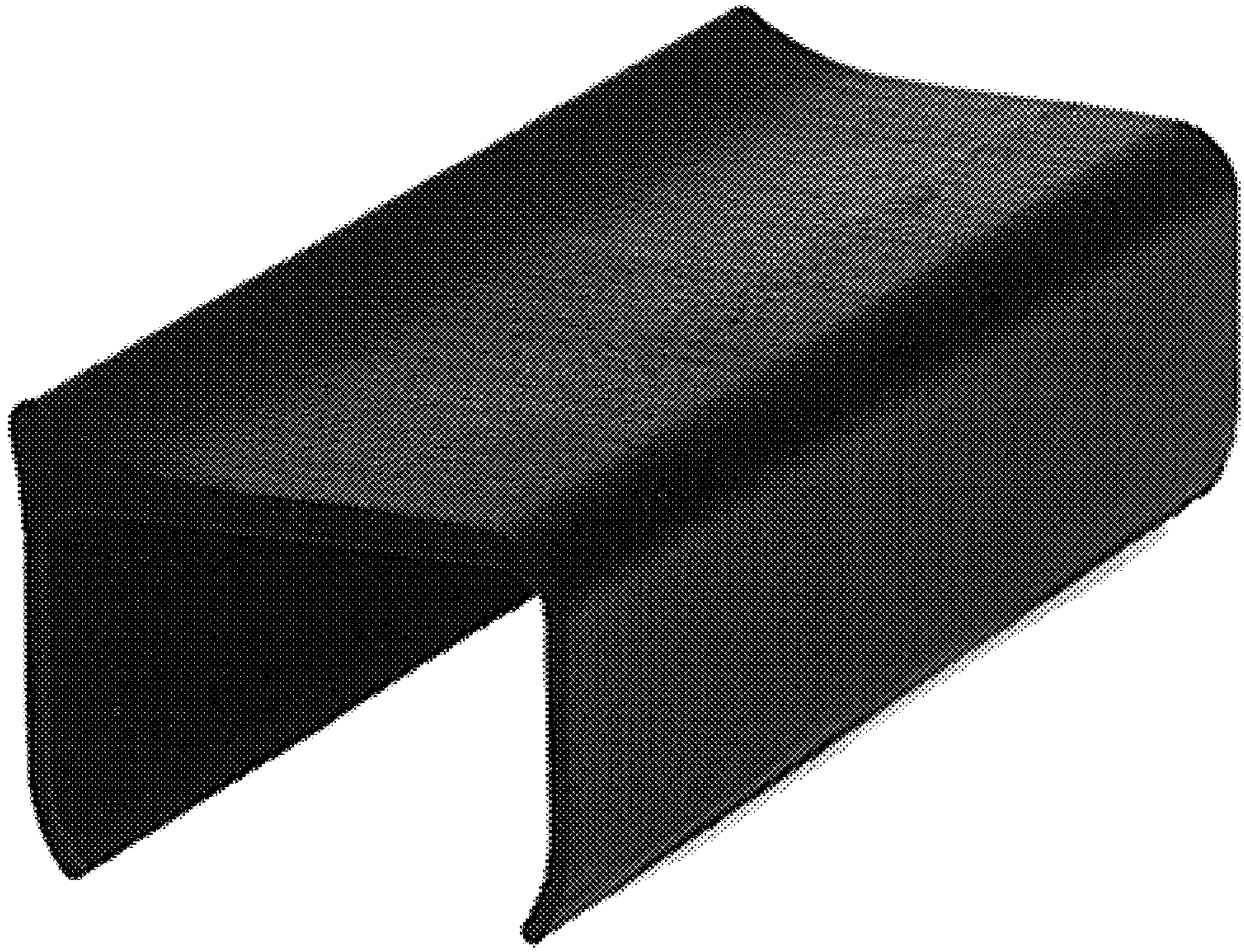
**DESCRIPTION**

FIG. 5 is a perspective view of one end of the present invention.

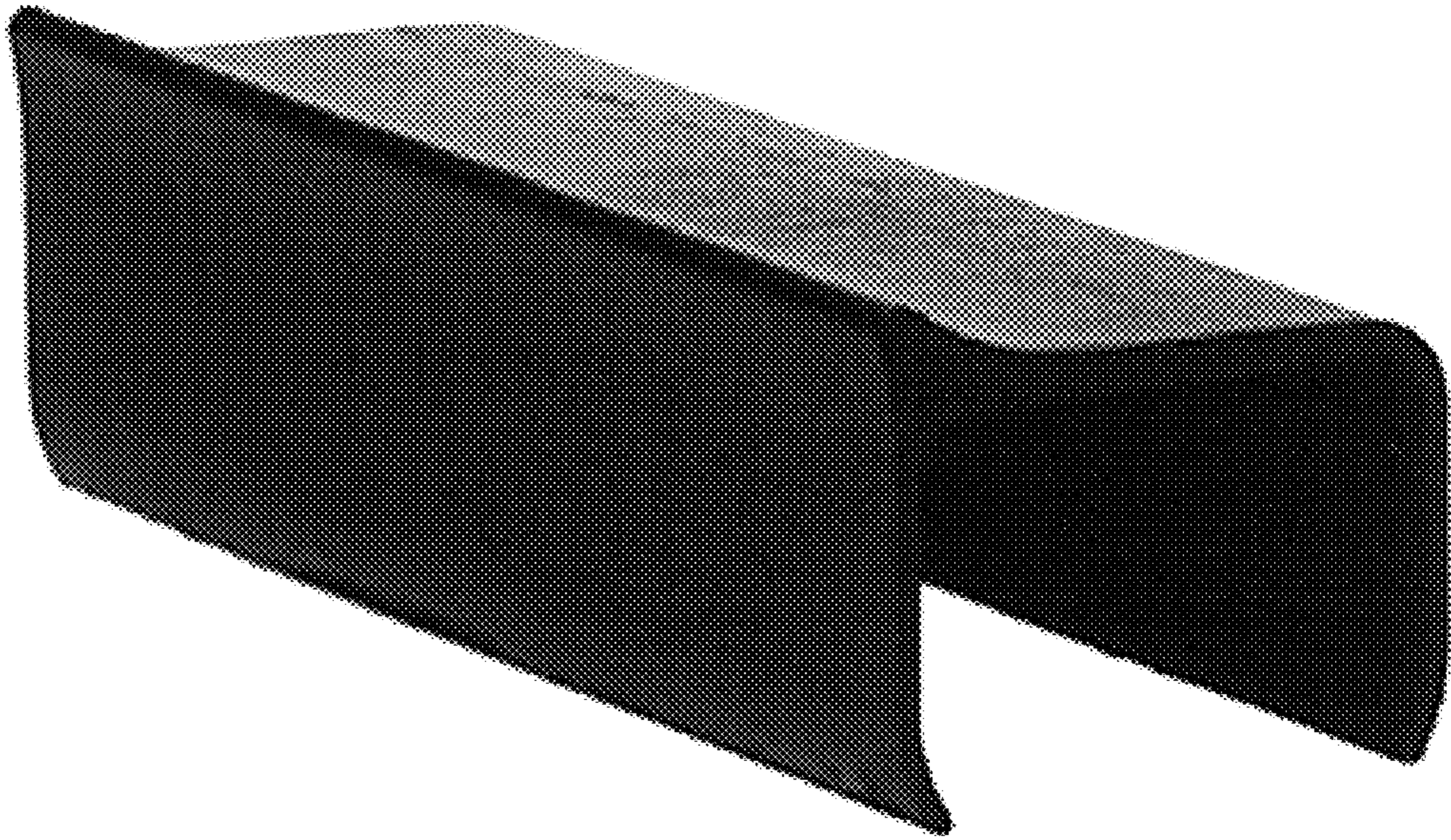

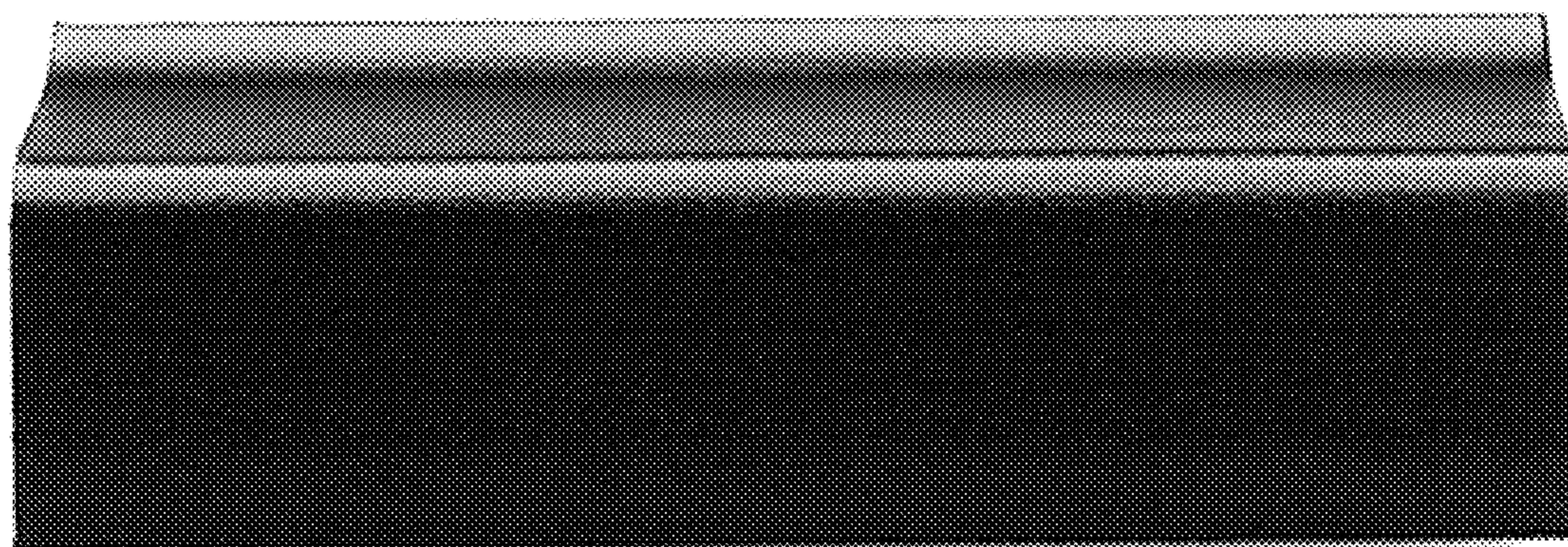

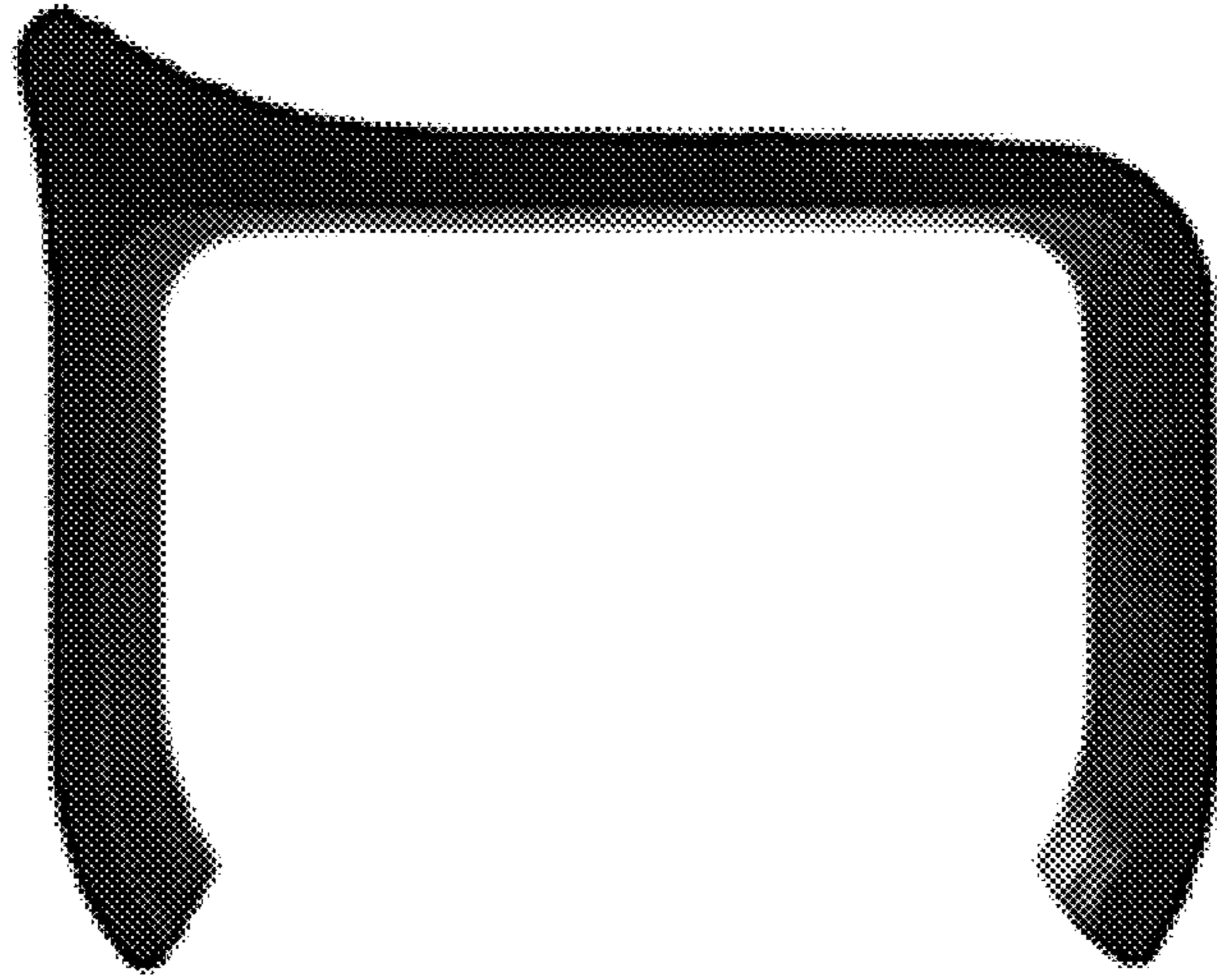

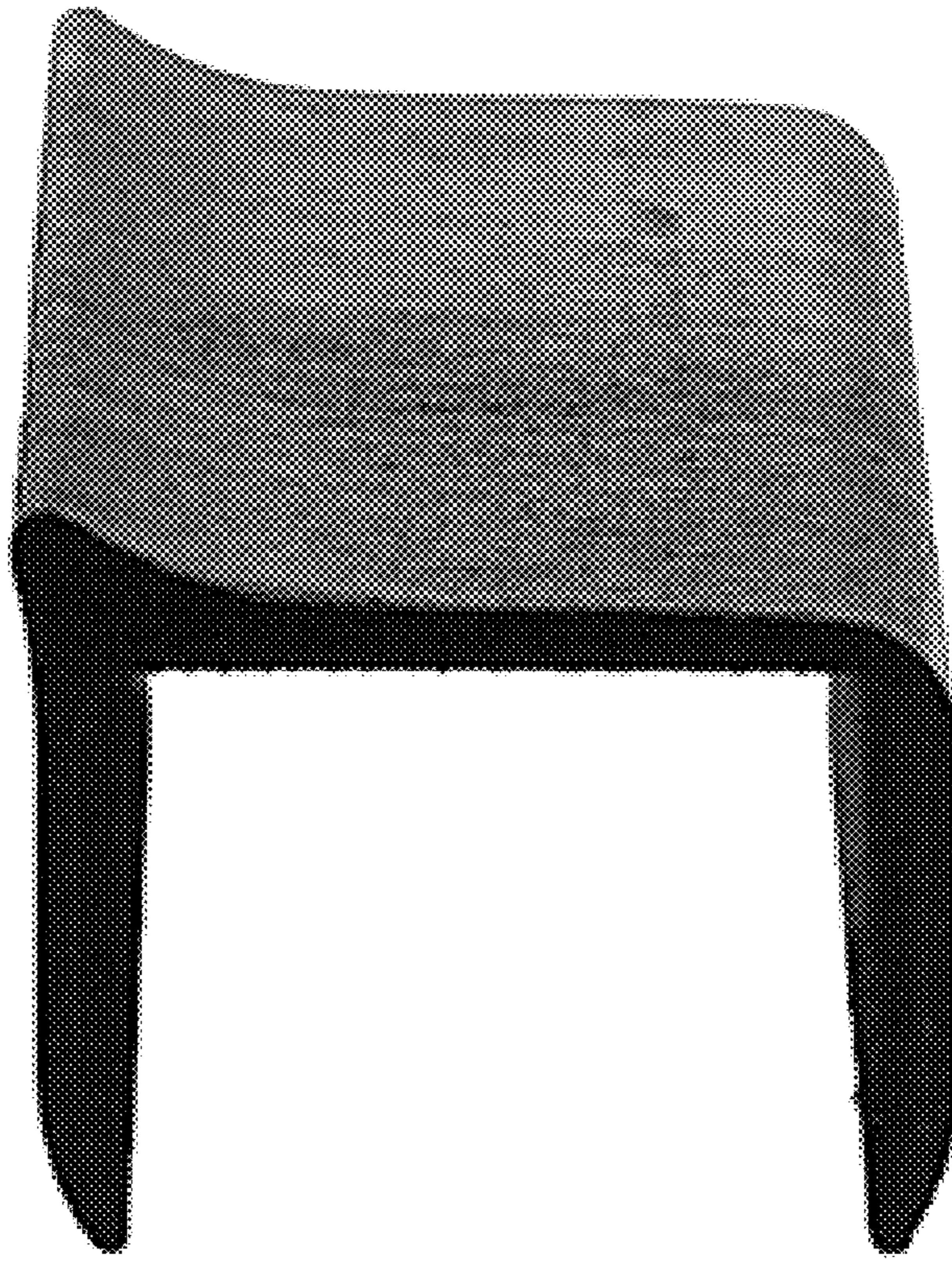
