(57) **CLAIM**

The ornamental design for automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an automobile tire, showing the new design, a top plan view and a bottom plan view appearing the same as the front view;

FIG. 2 is a rear view of the automobile tire;

FIG. 3 is a right side view of the automobile tire;

FIG. 4 is a left side view of the automobile tire;

FIG. 5 is a fragmentary front view, showing in enlargement the portion of lines 5—5 in FIG. 1;

FIG. 6 is a sectional view, taken along line 6—6 and in the direction of arrows in FIG. 5; and,

FIG. 7 is a perspective view of the automobile tire.

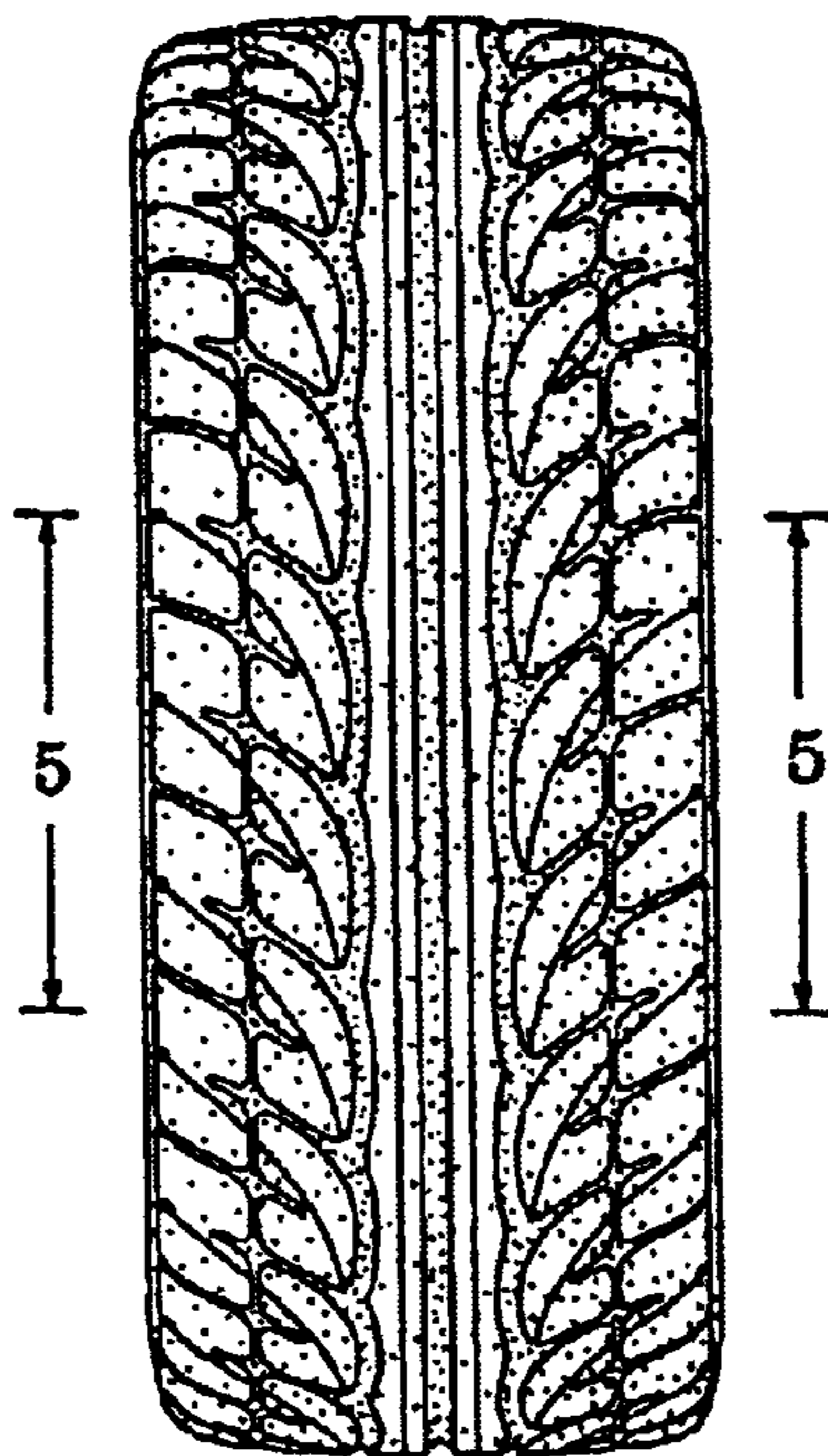

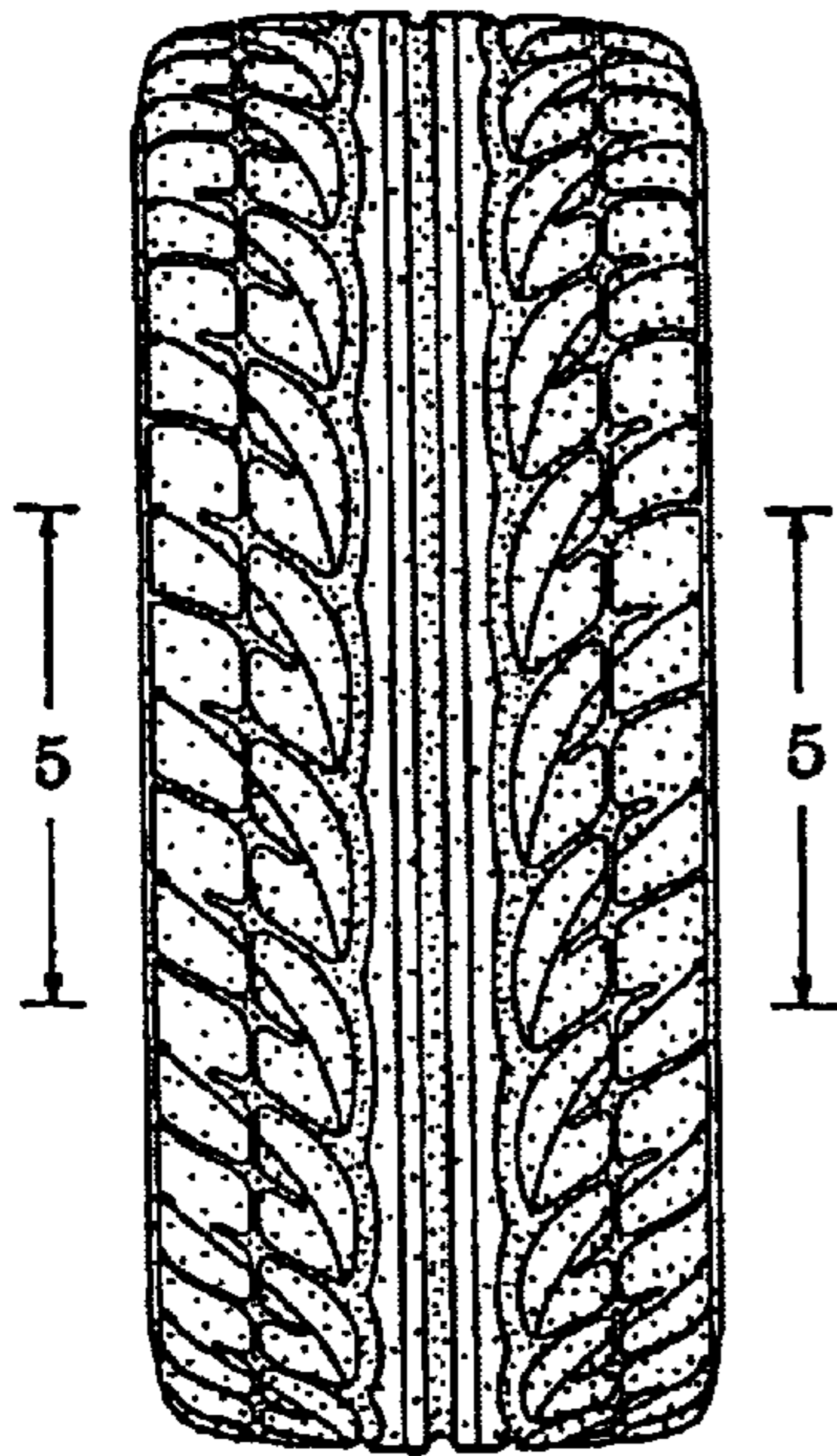

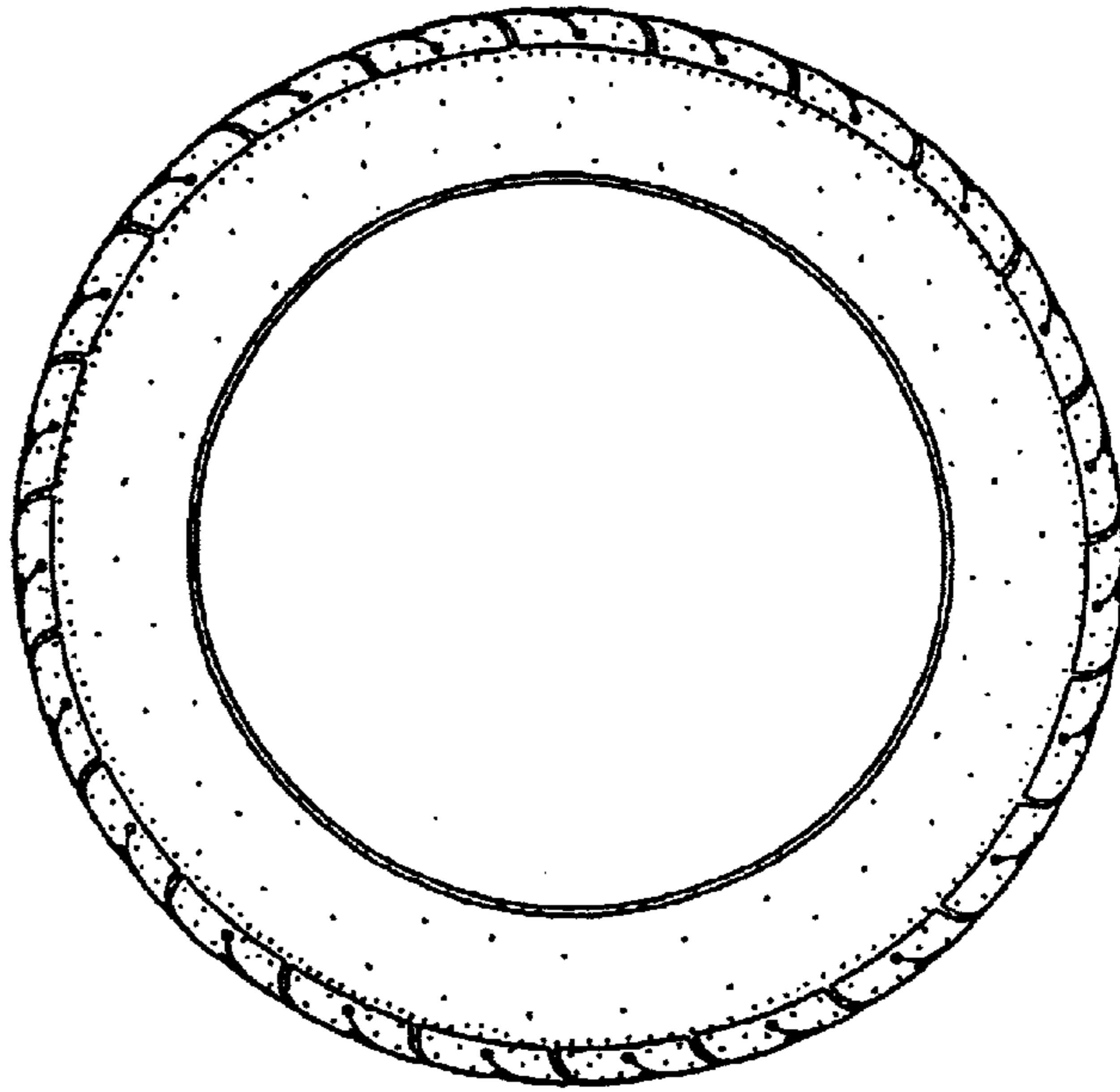

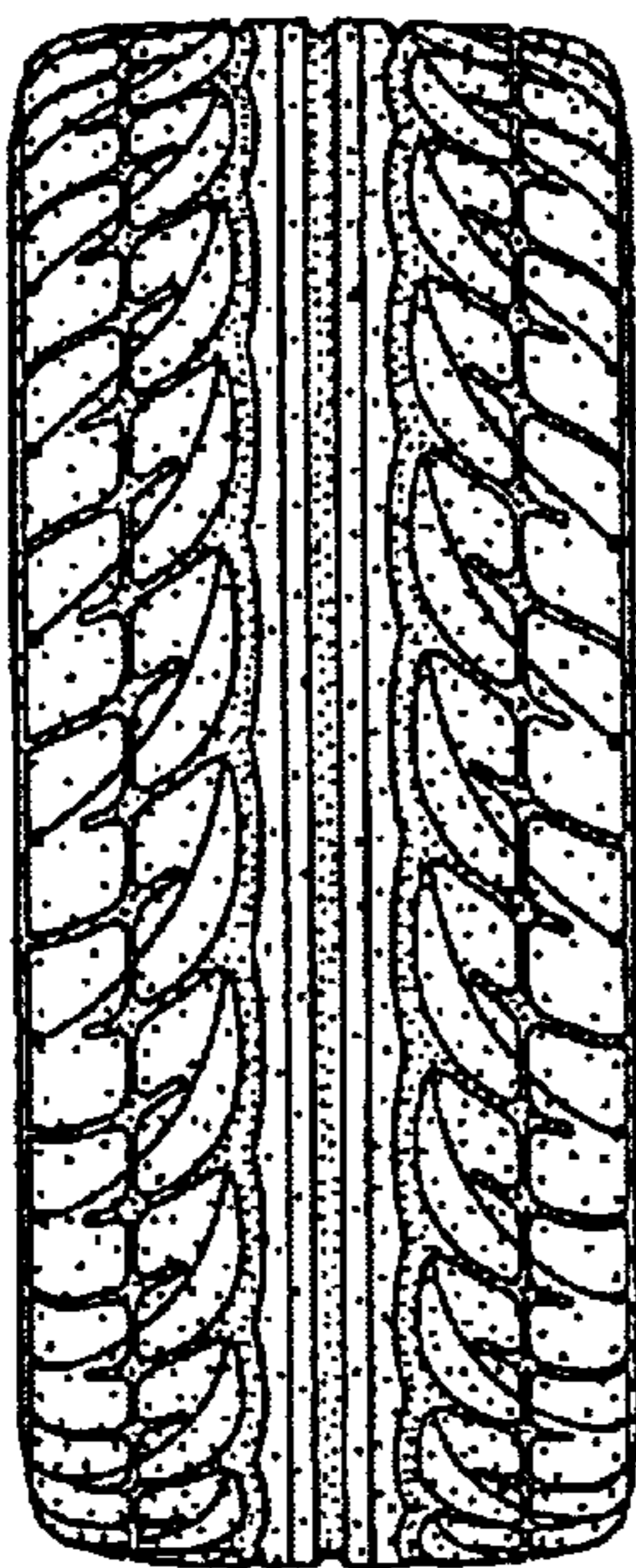

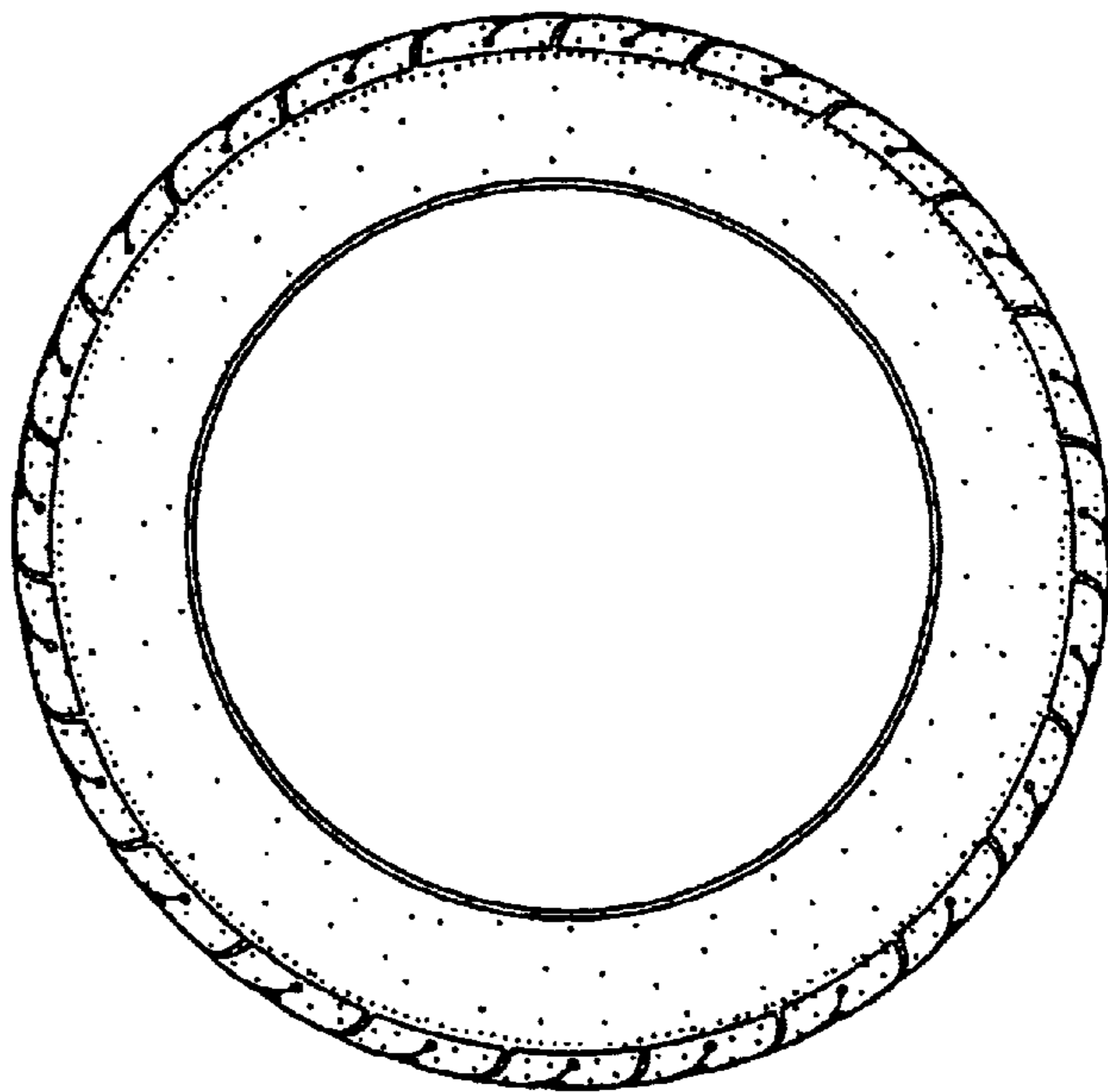

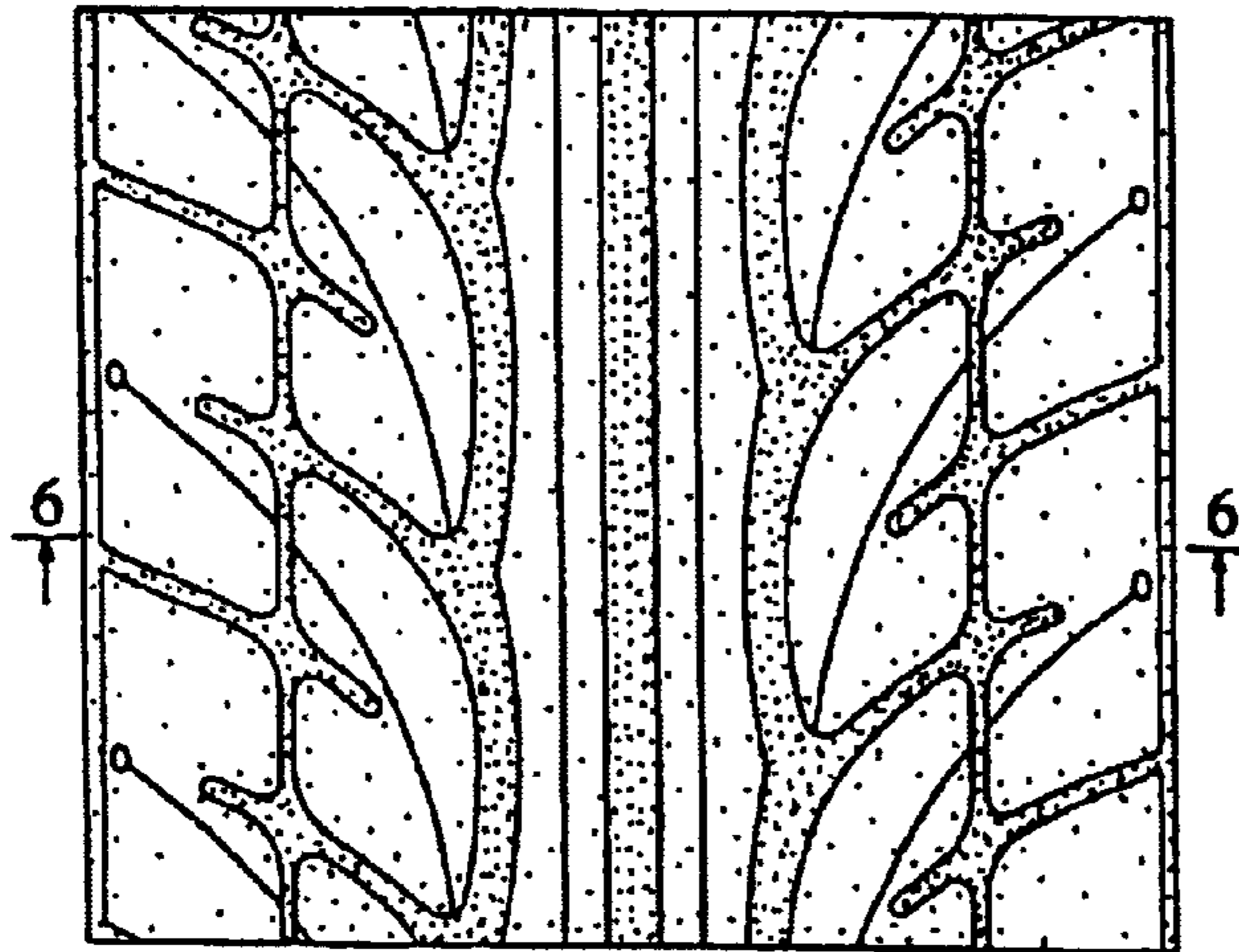

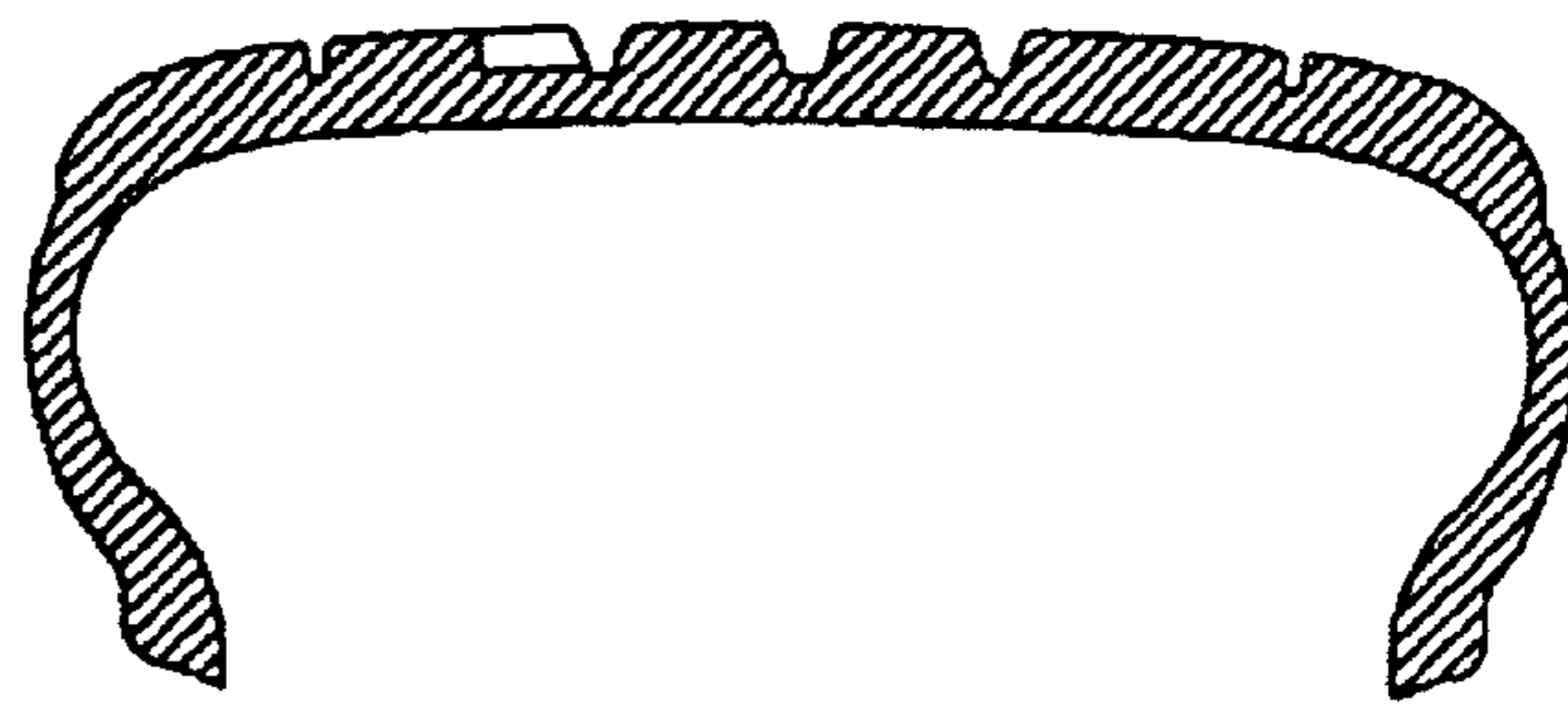
