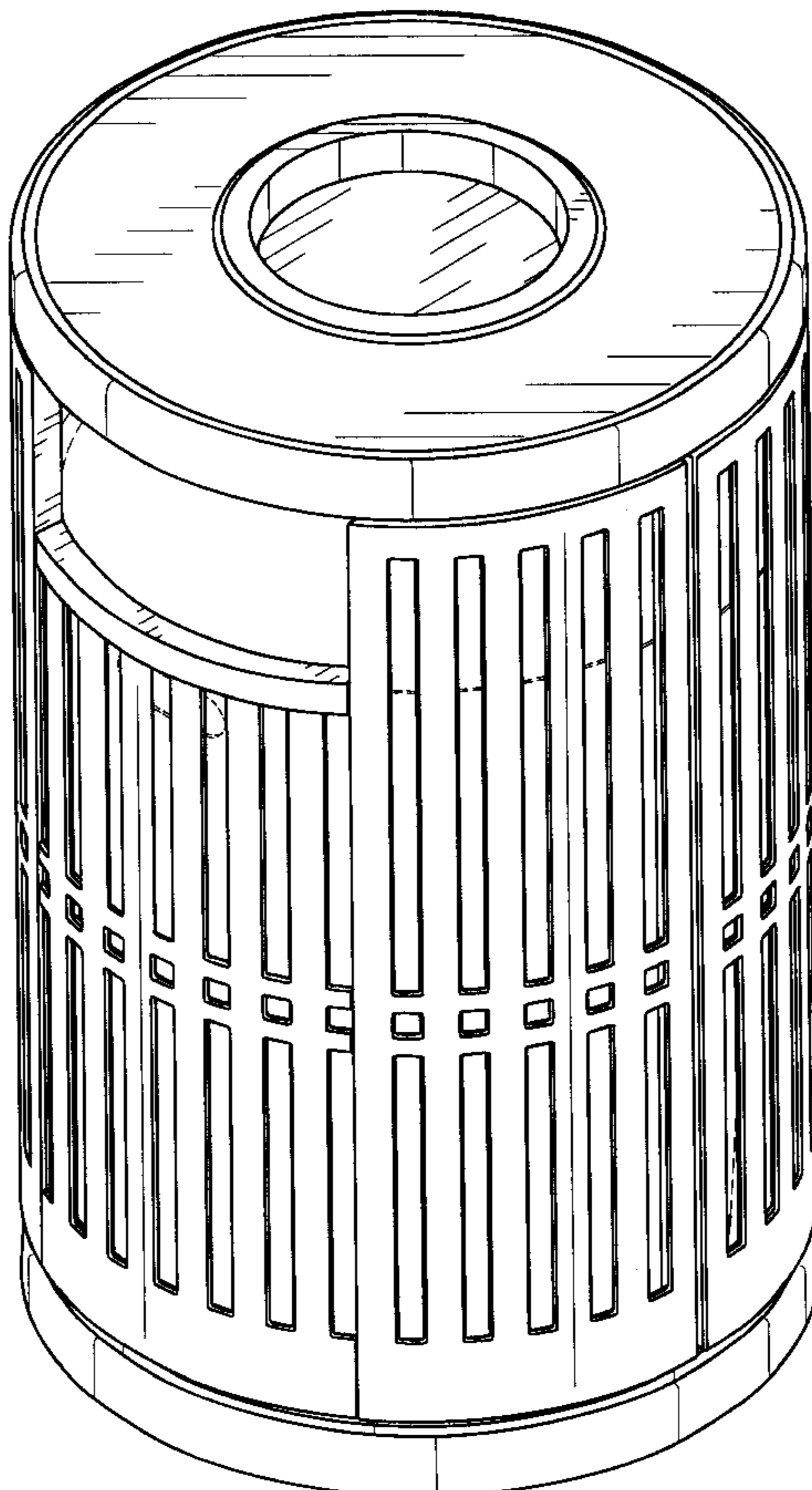

The ornamental design for a trash receptacle, as shown and described.

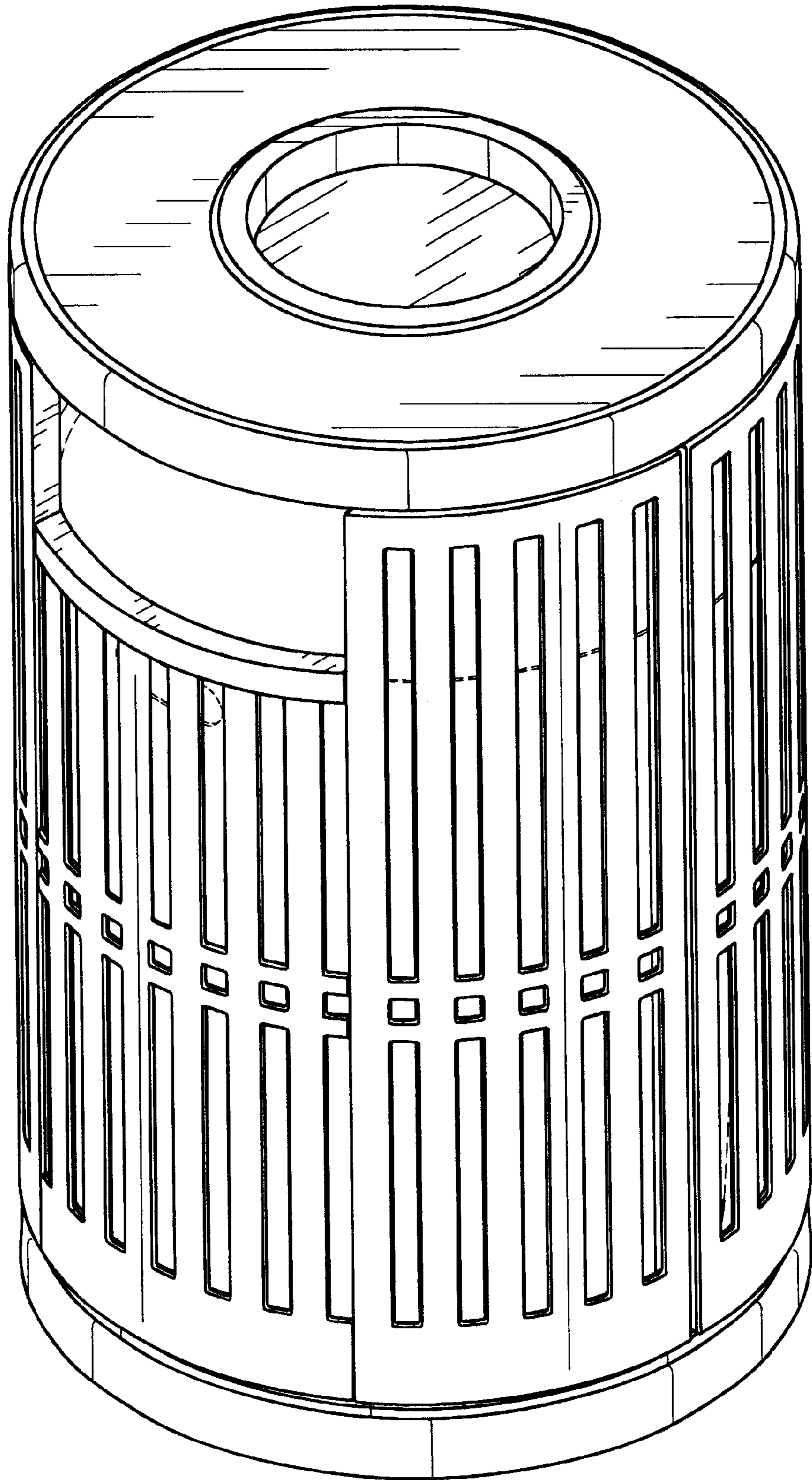
**DESCRIPTION**

FIG. 1 is an isometric view of the trash receptacle; FIG. 2 is a front elevational view thereof, the back elevational view being identical thereto; FIG. 3 is a right-side elevational view thereof; FIG. 4 is a left-side elevational view thereof; and, FIG. 5 is a top plan view thereof. The broken line showing in the drawing figures is for illustrative purposes only and forms no part of the claimed design.

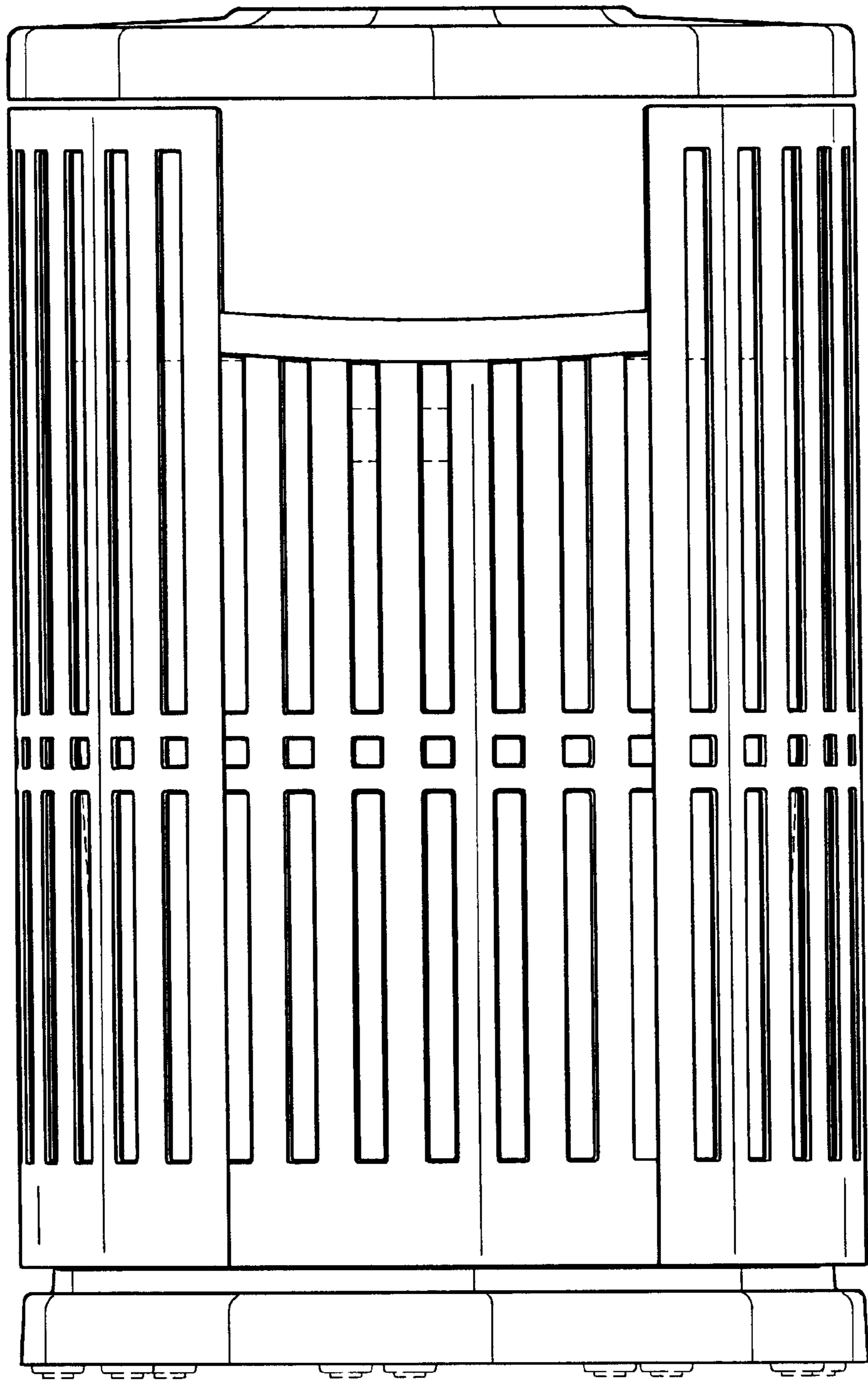

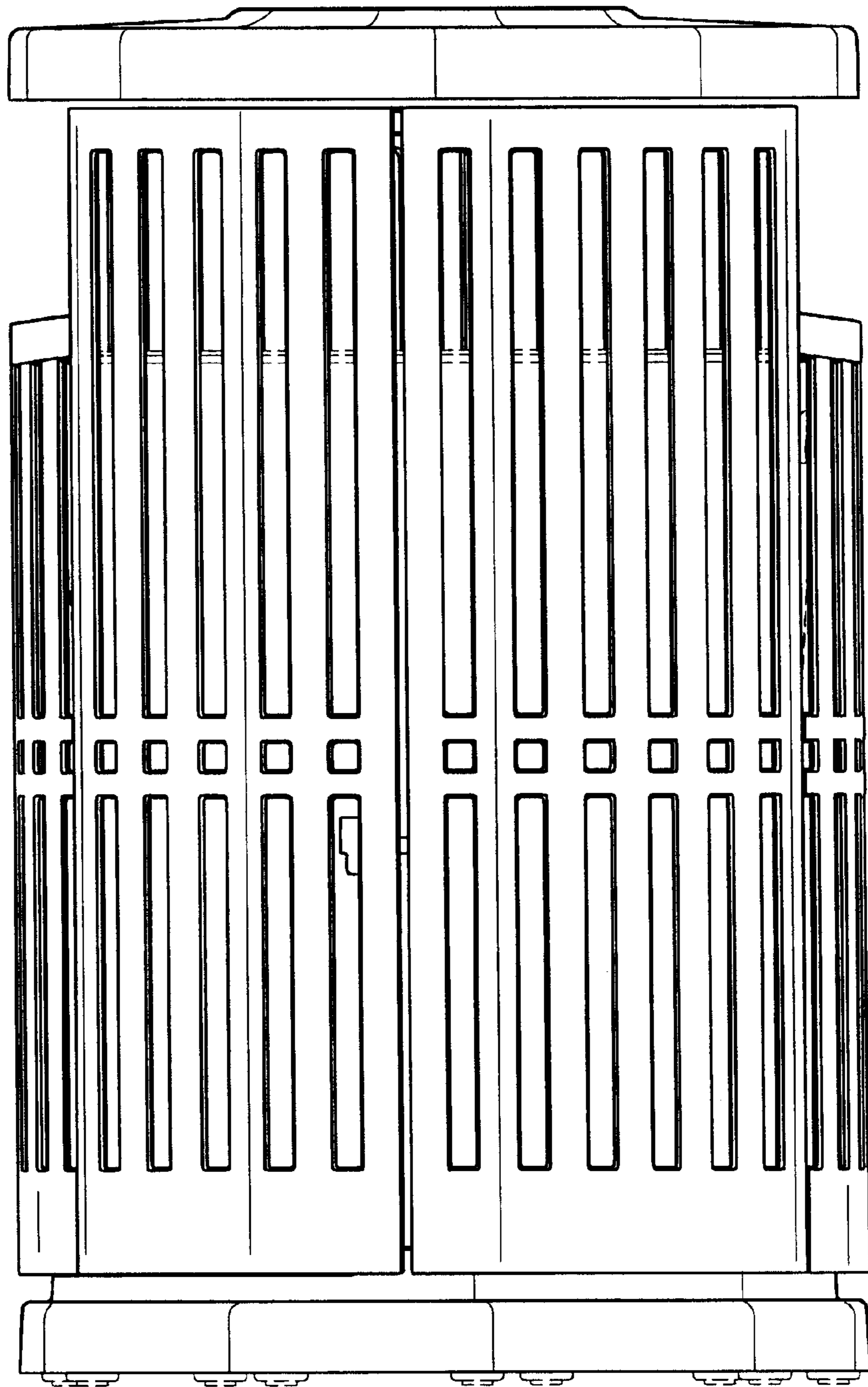

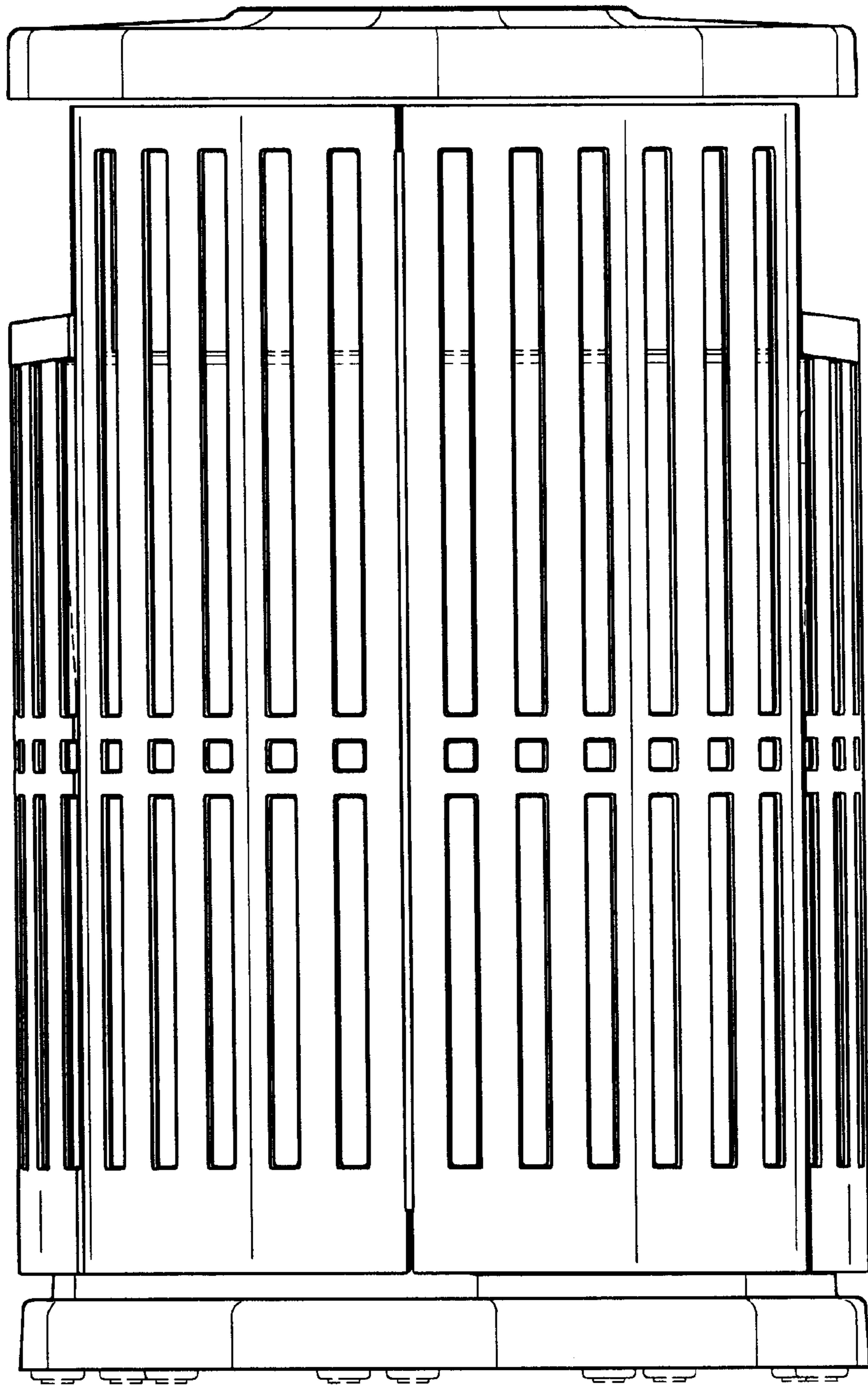
