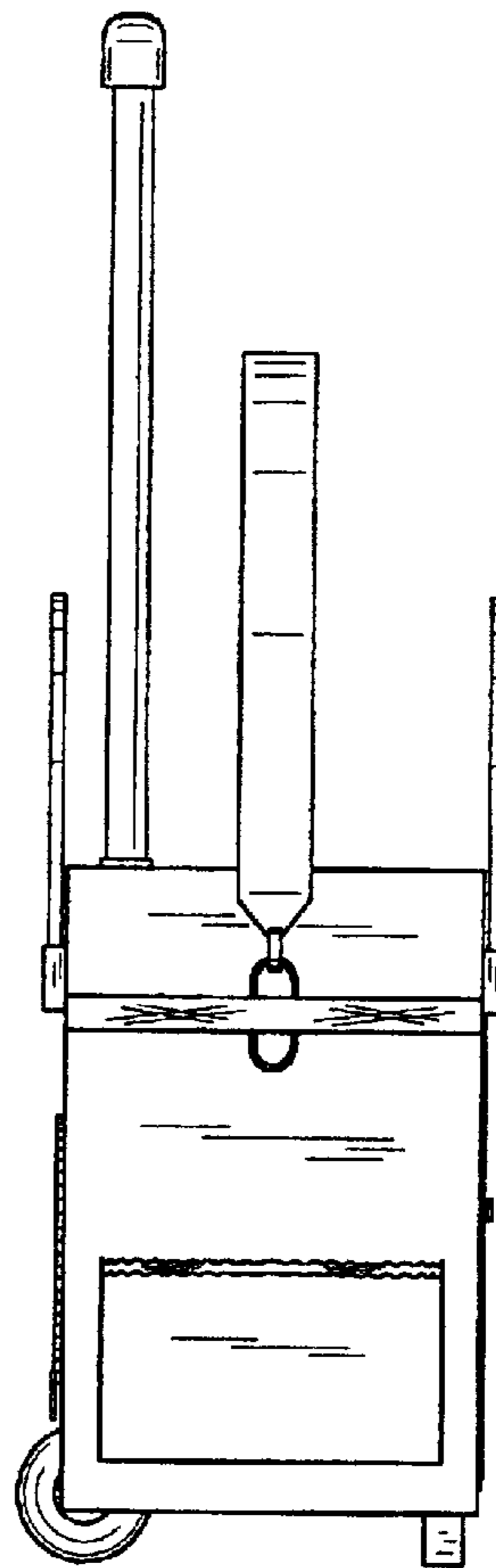
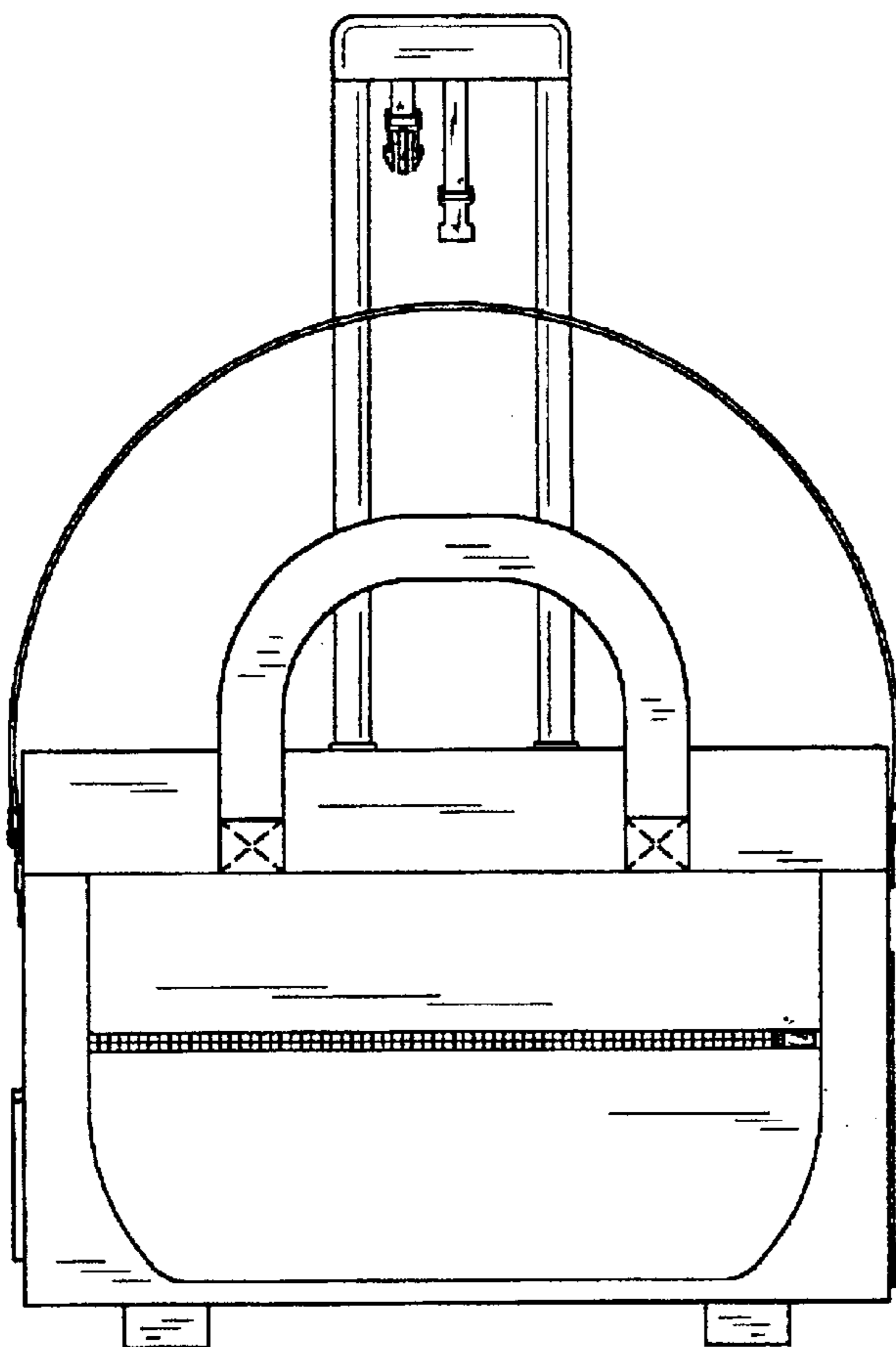
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of a diaper bag showing our new design;  
FIG. 2 is a rear elevational view thereof;

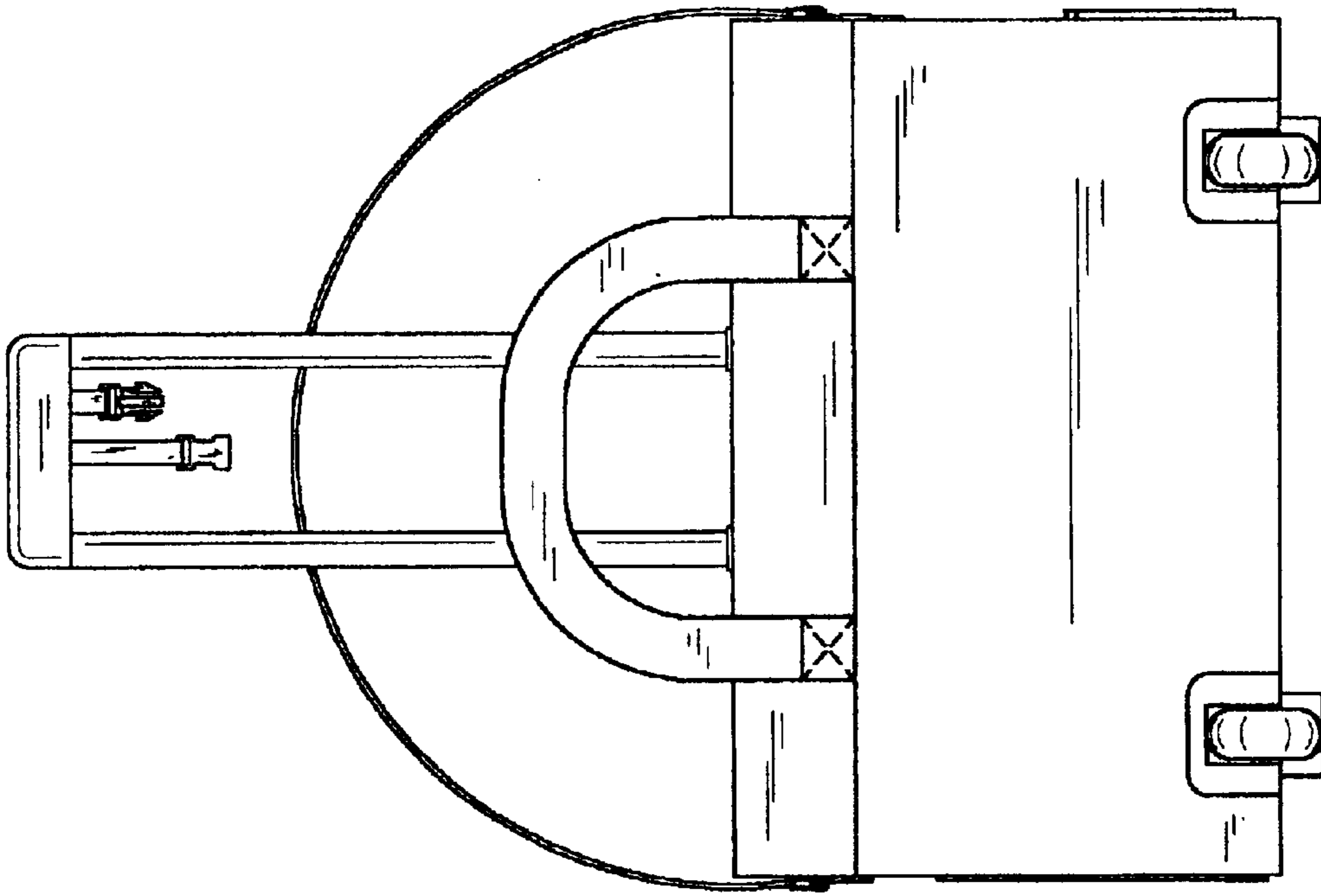

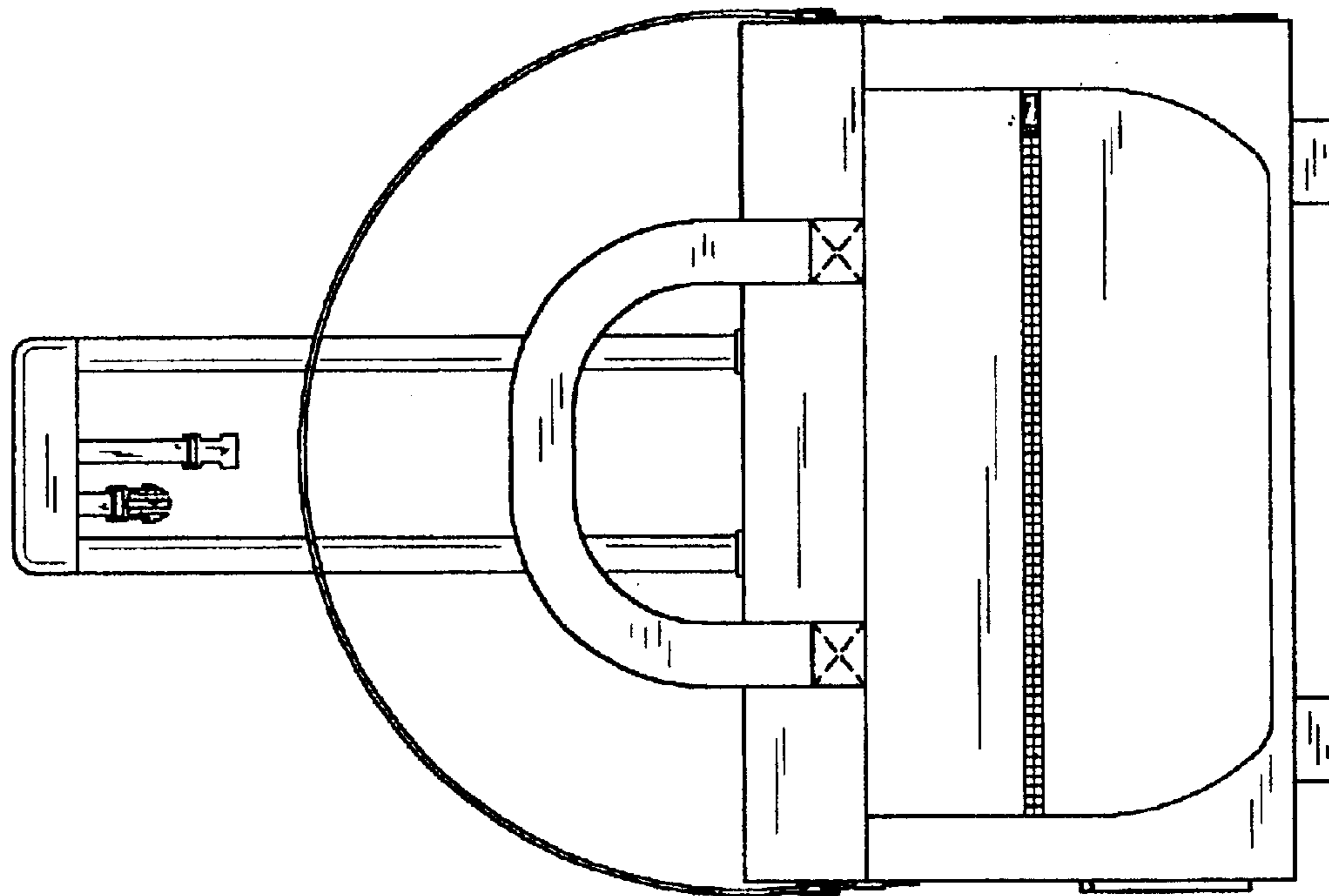

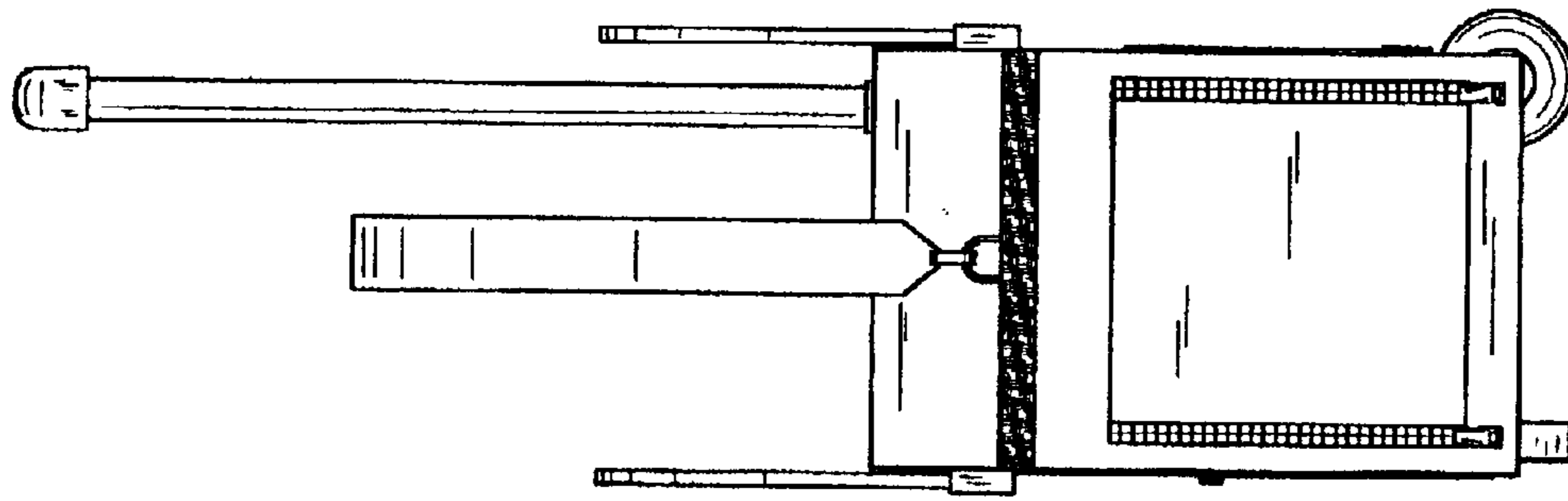

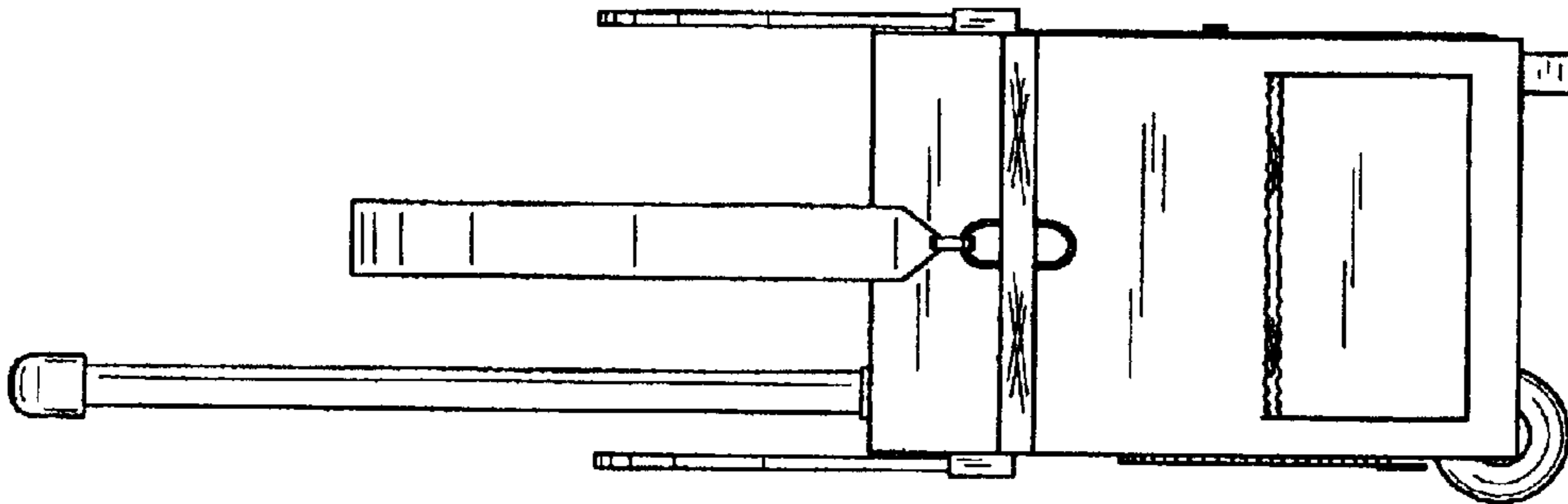

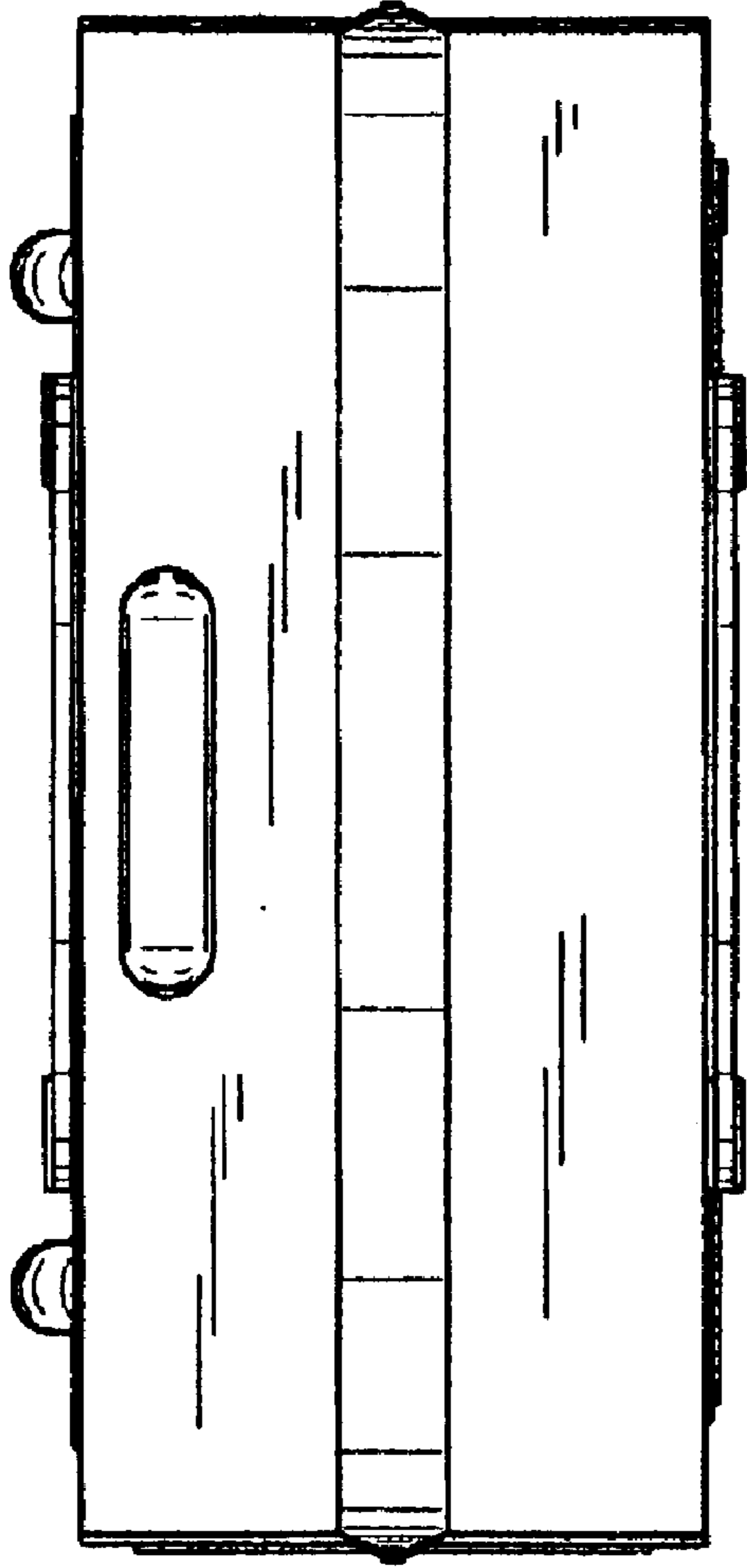

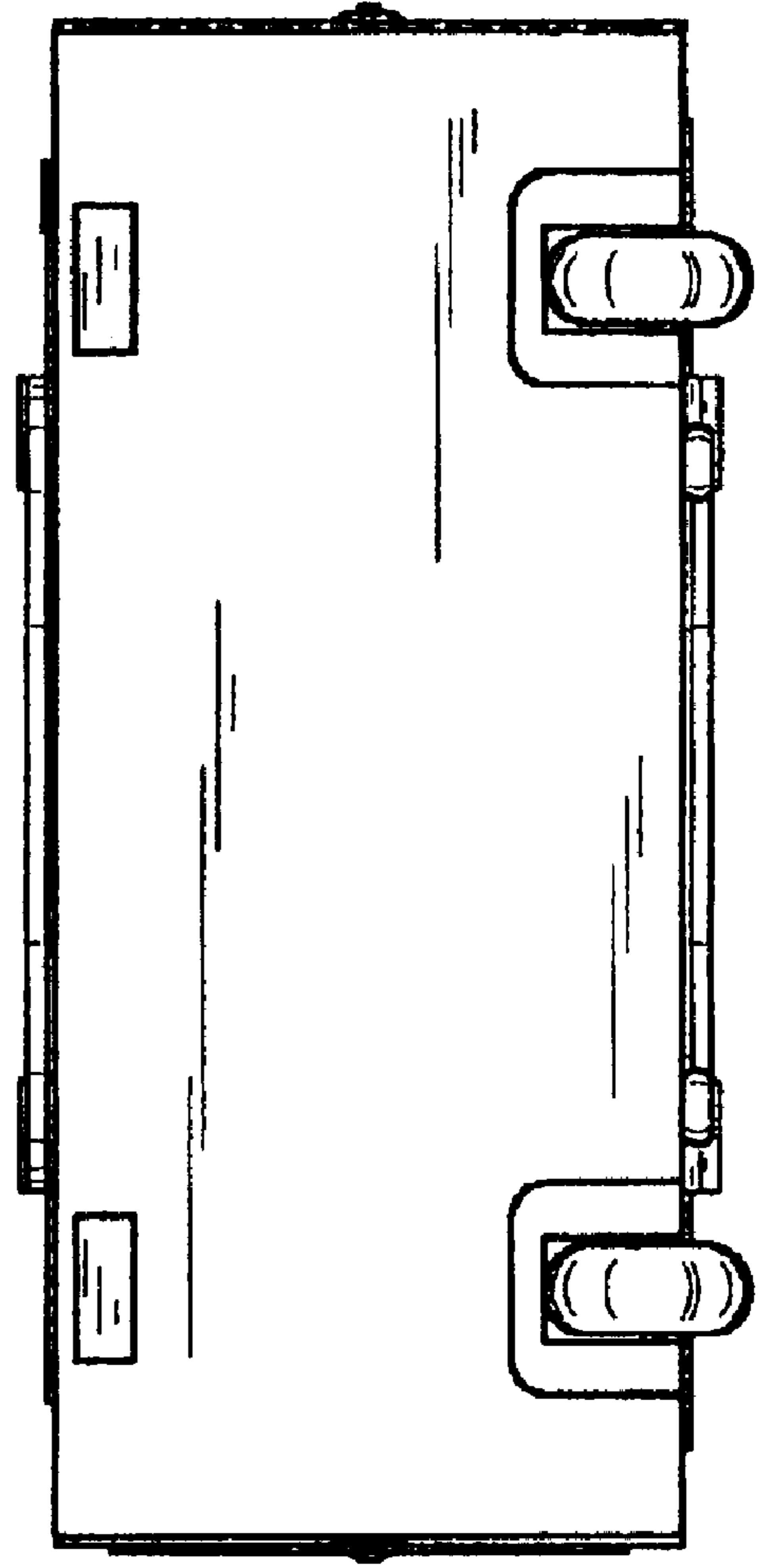
