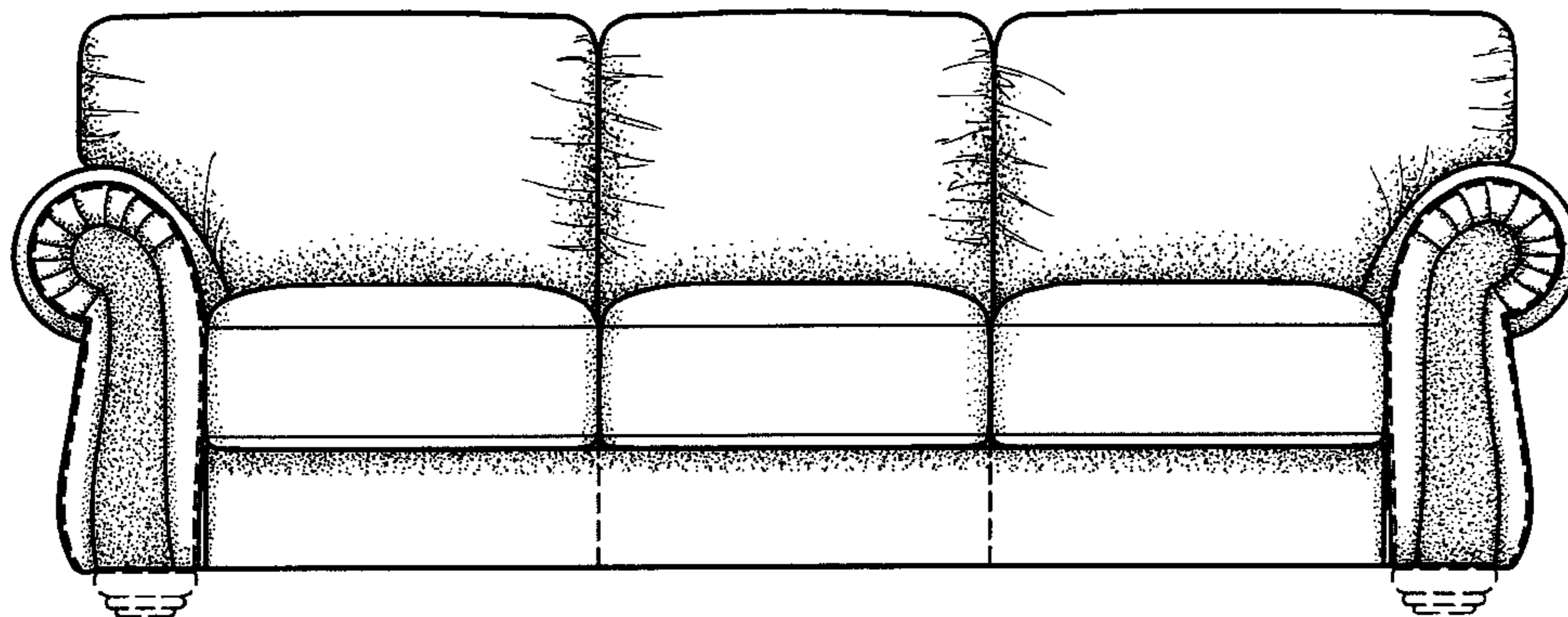
(57) **CLAIM**

The ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of one embodiment of my new seat design in the form of a sofa;
 FIG. 2 is an enlarged view of the front corner portion of the right arm of FIG. 1;
 FIG. 3 is a front elevation view of the embodiment of FIG. 1;
 FIG. 4 is a left, side elevation view of the embodiment of FIG. 1, with the right side elevational view being a mirror image thereof;
 FIG. 5 is a rear elevation view of the embodiment of FIG. 1;
 FIG. 6 is a front perspective view of a second embodiment of my new seat design in the form of a chair;
 FIG. 7 is a front elevation view of the embodiment of FIG. 5; and,
 FIG. 8 is a back elevation view of the embodiment of FIG. 5.
 The end view of FIGS. 6, 7 and 8 are like that shown in FIG. 4.
 The broken line disclosure is for illustrative purposes only and forms no part of the claimed design.

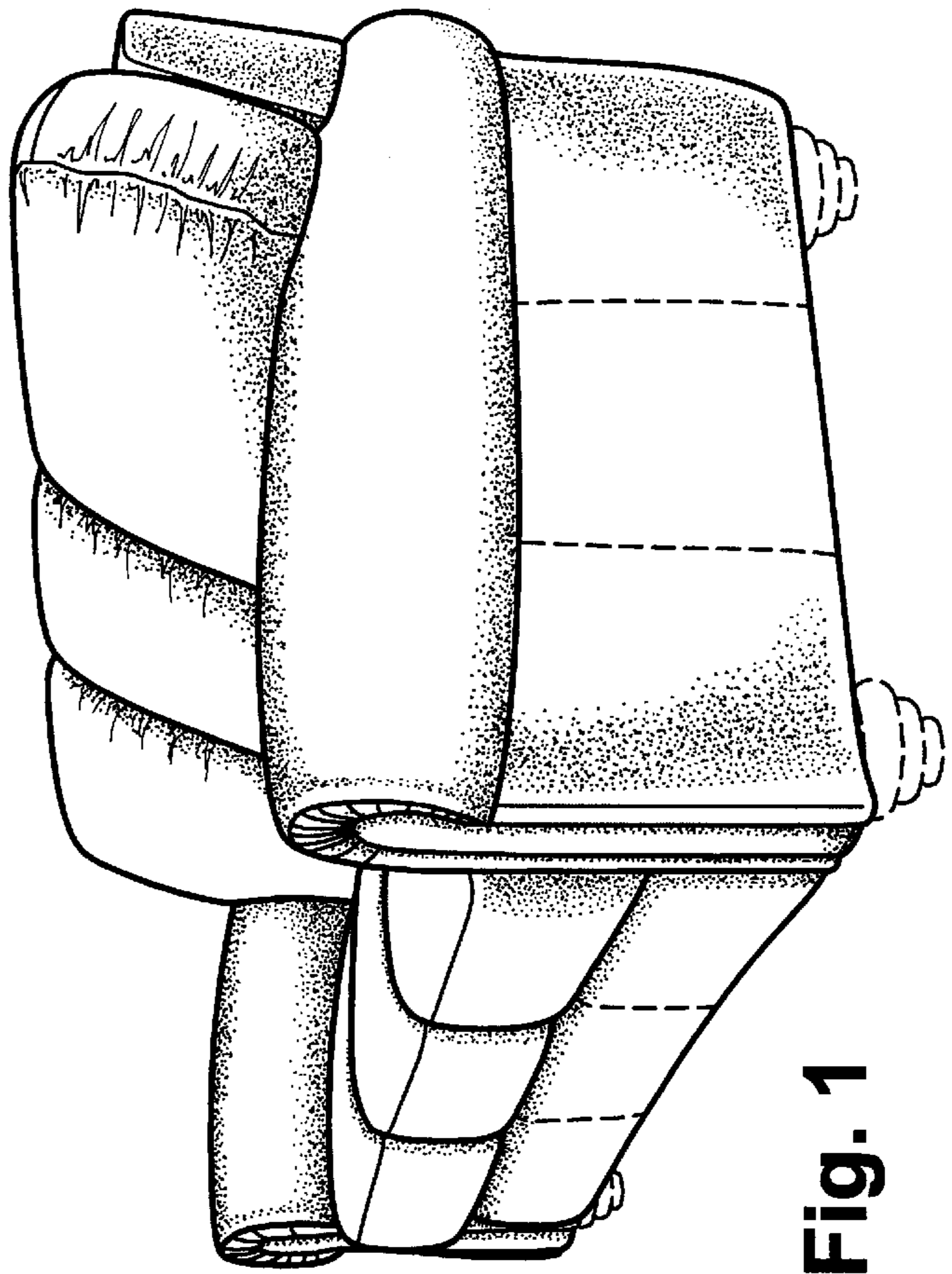

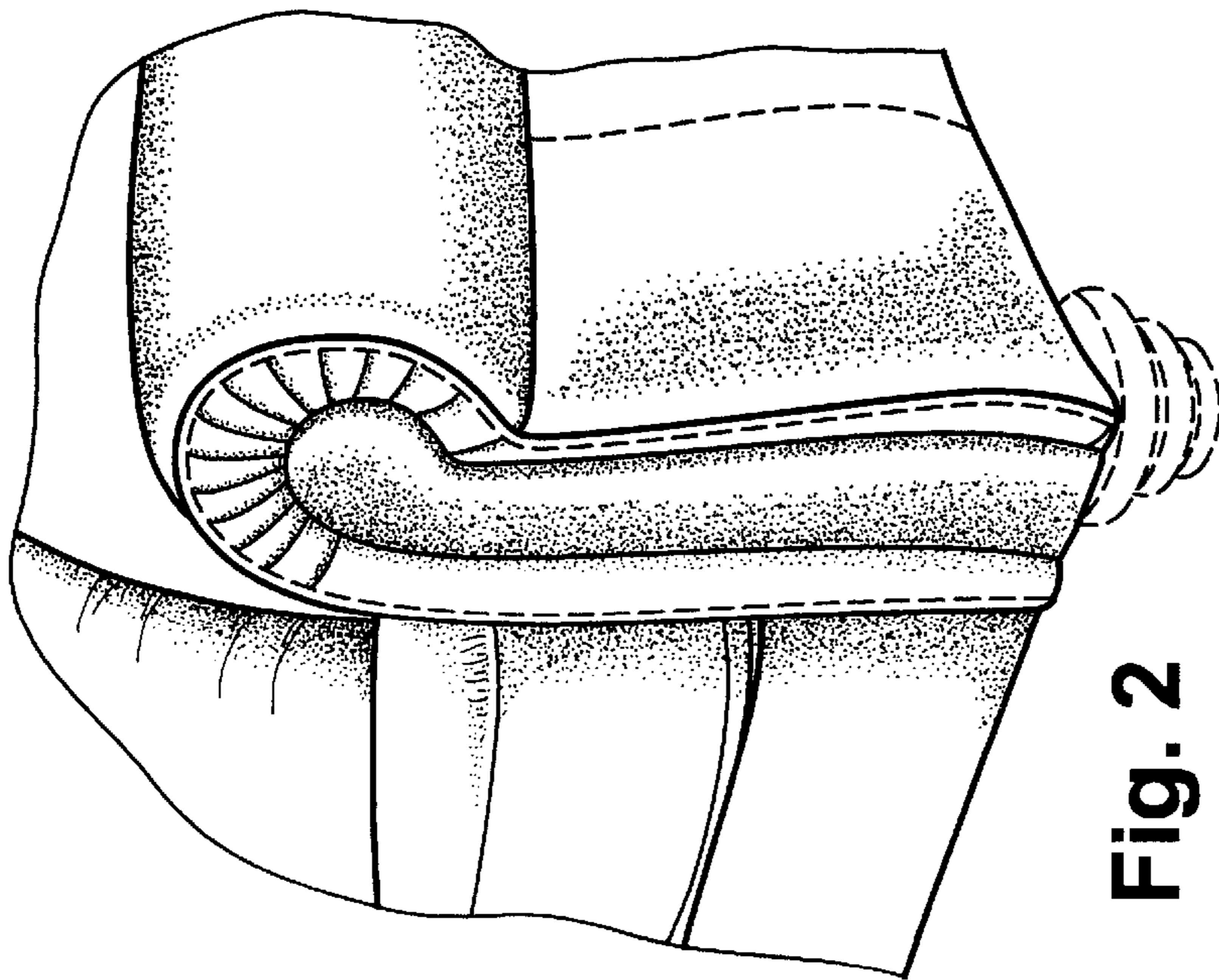

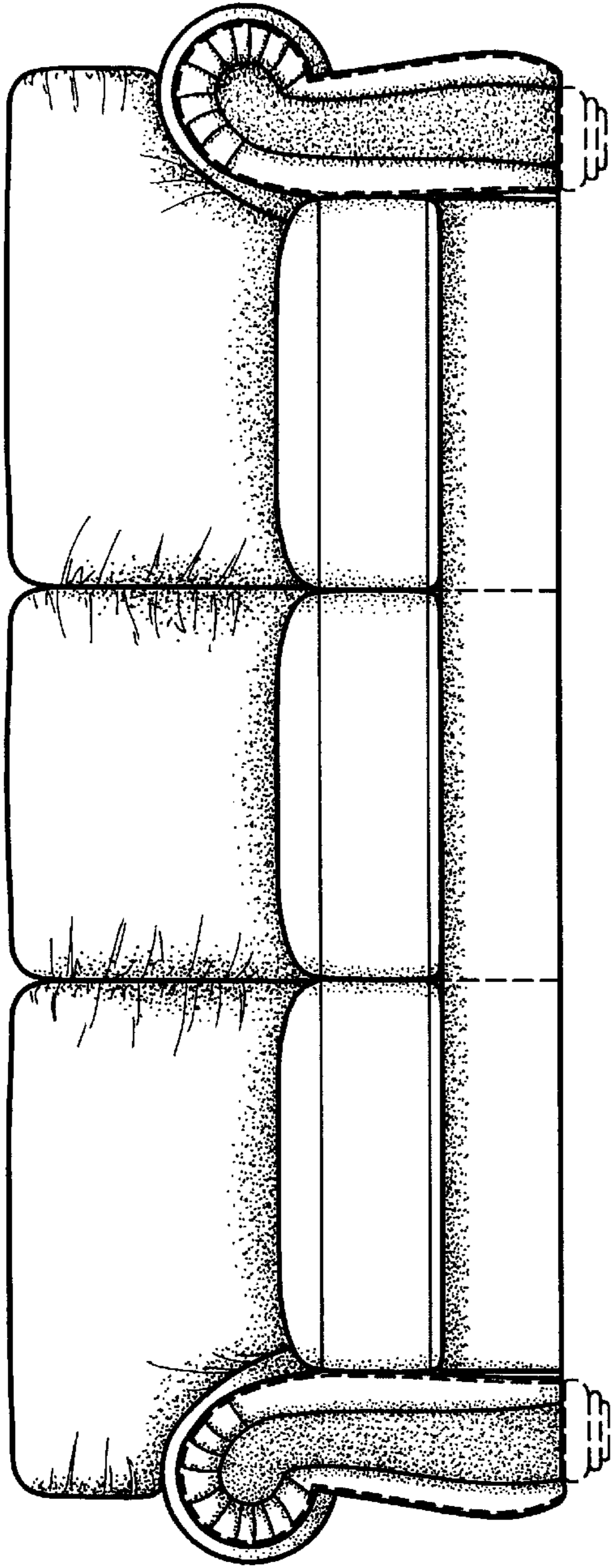

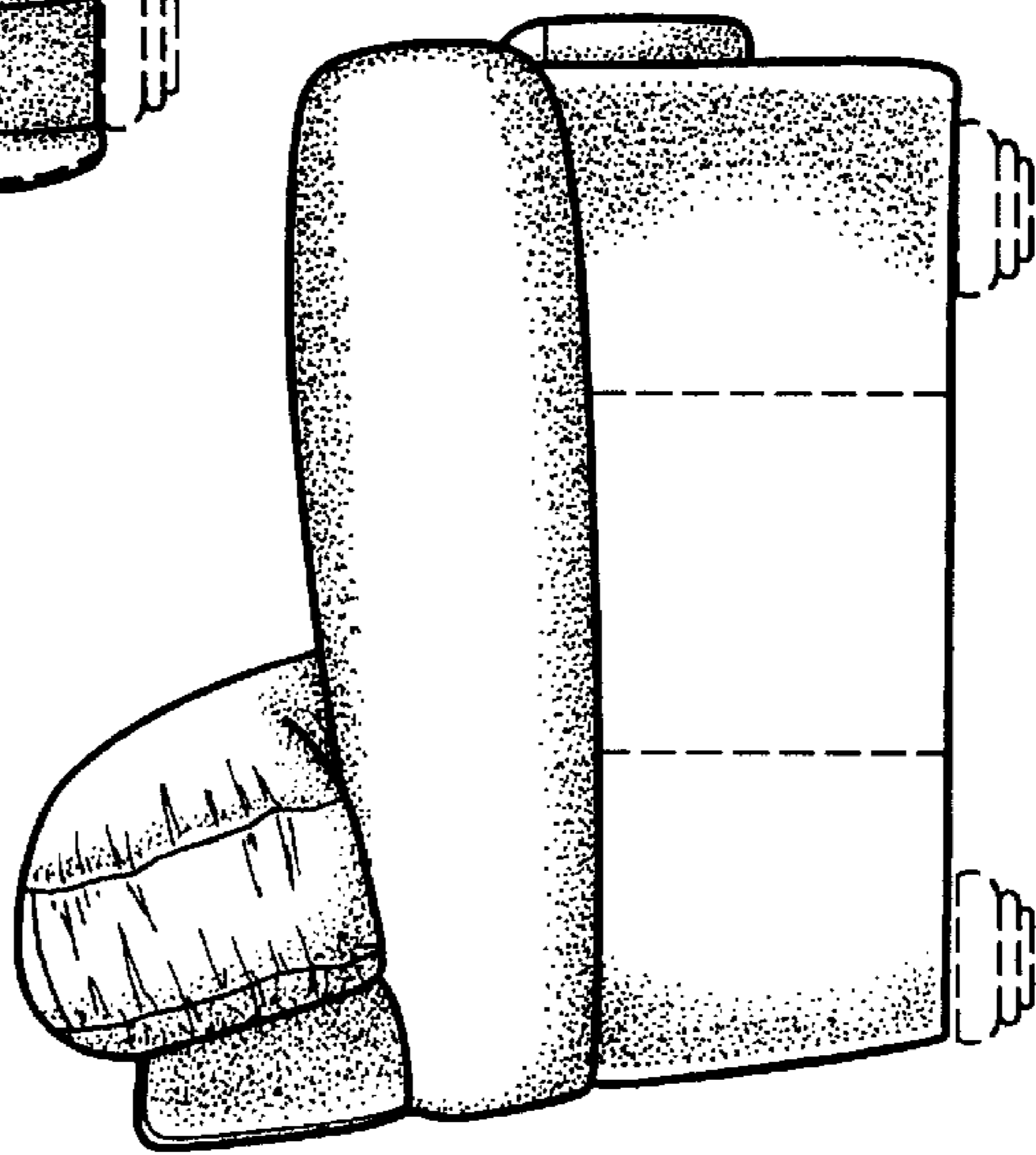

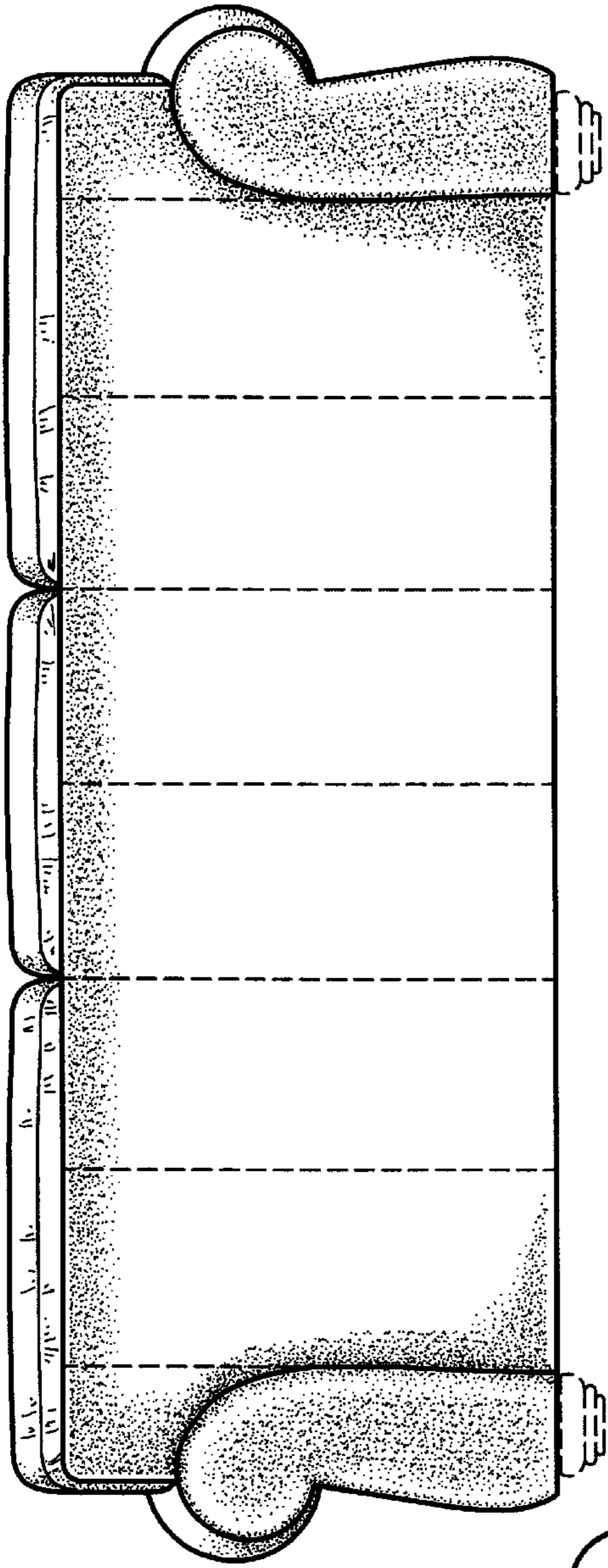

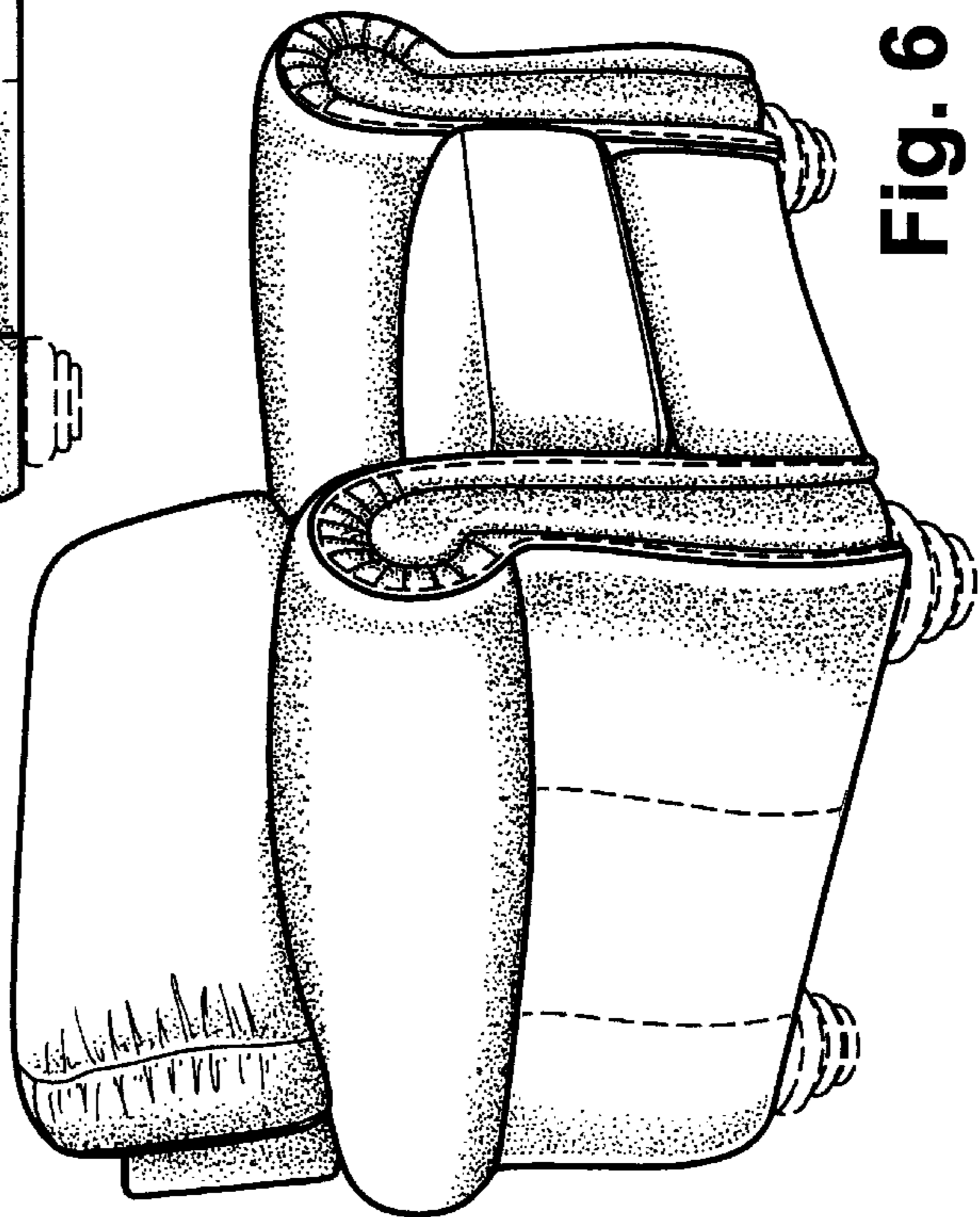

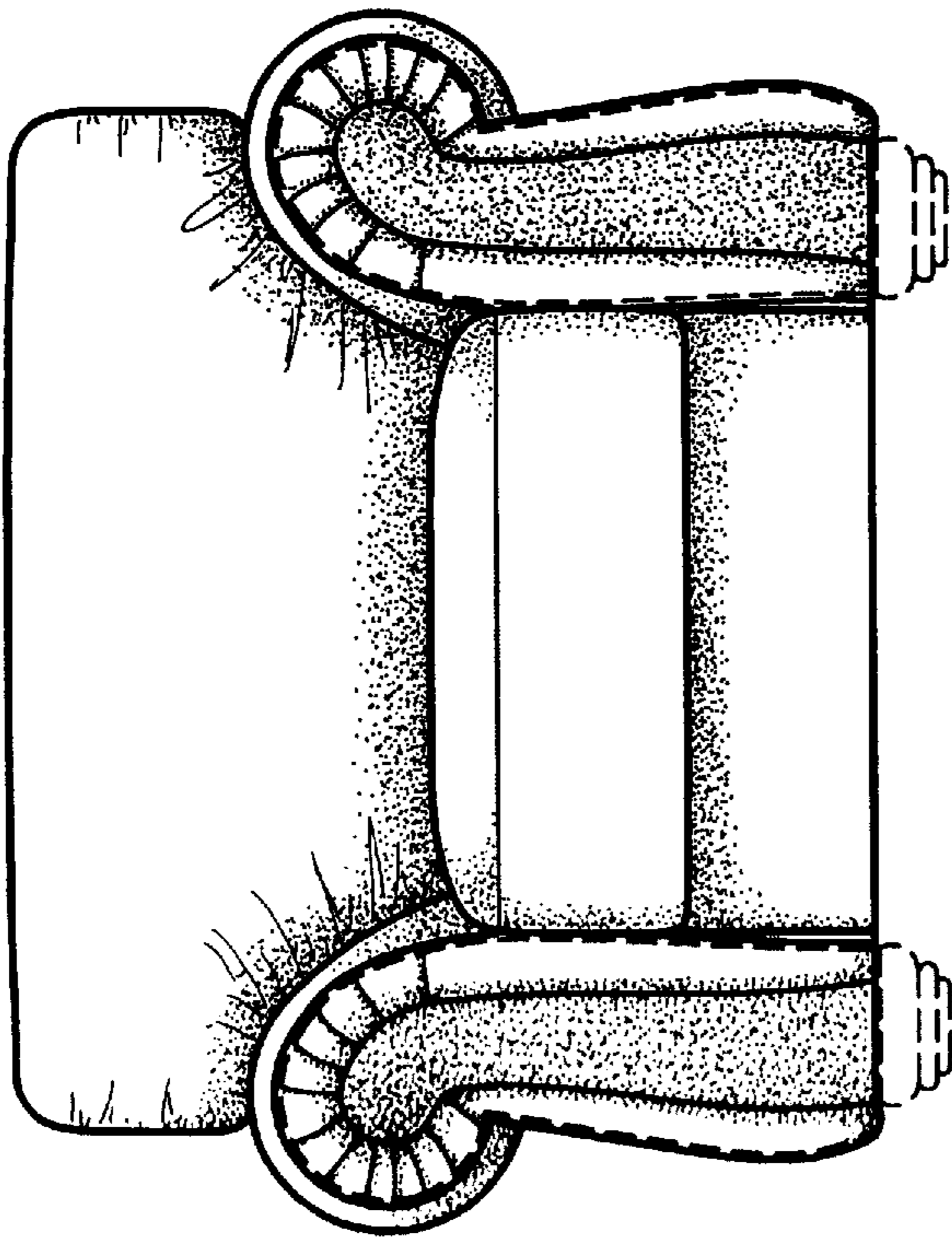

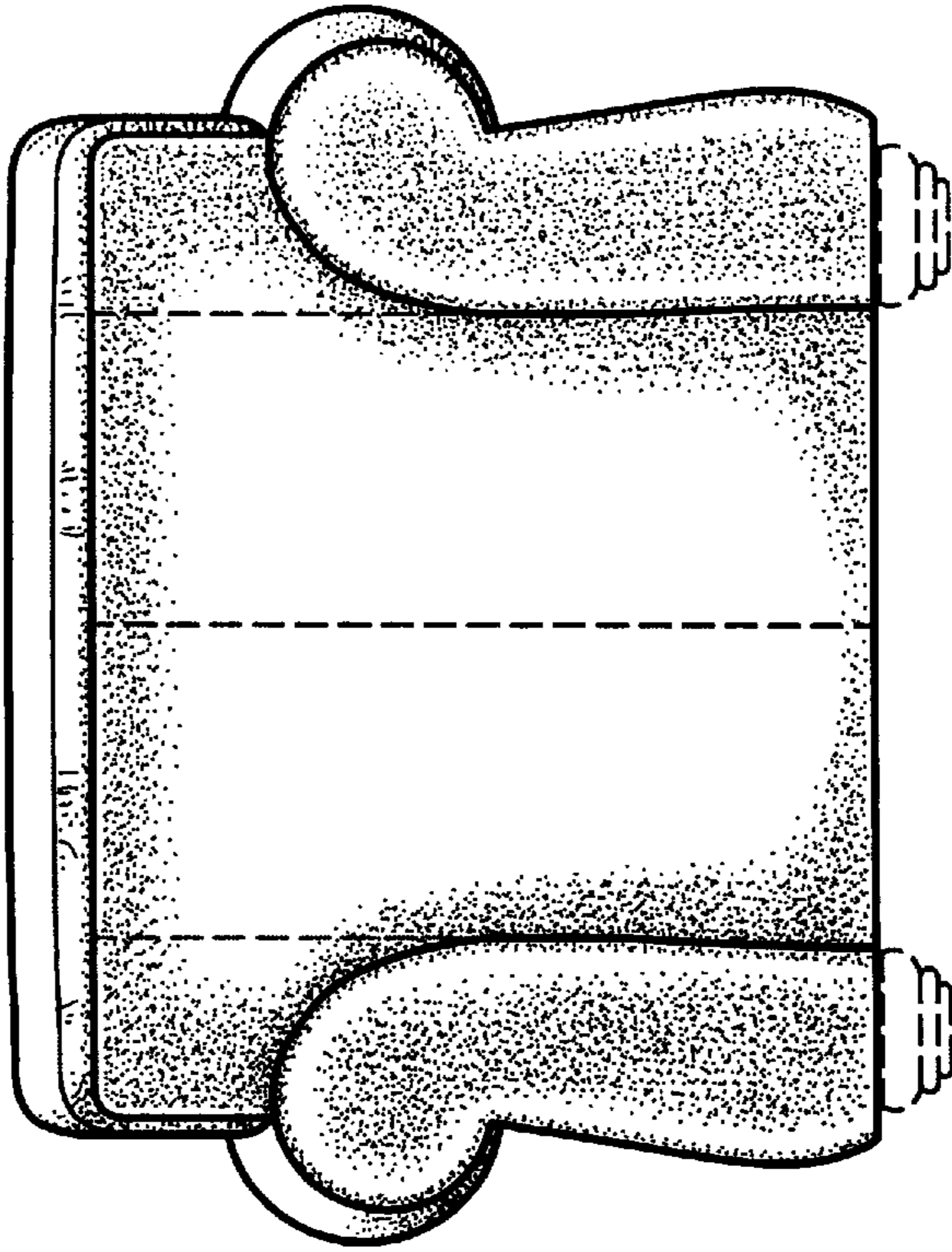
