FIG. 1 is a front perspective view of the remote control of our new design;

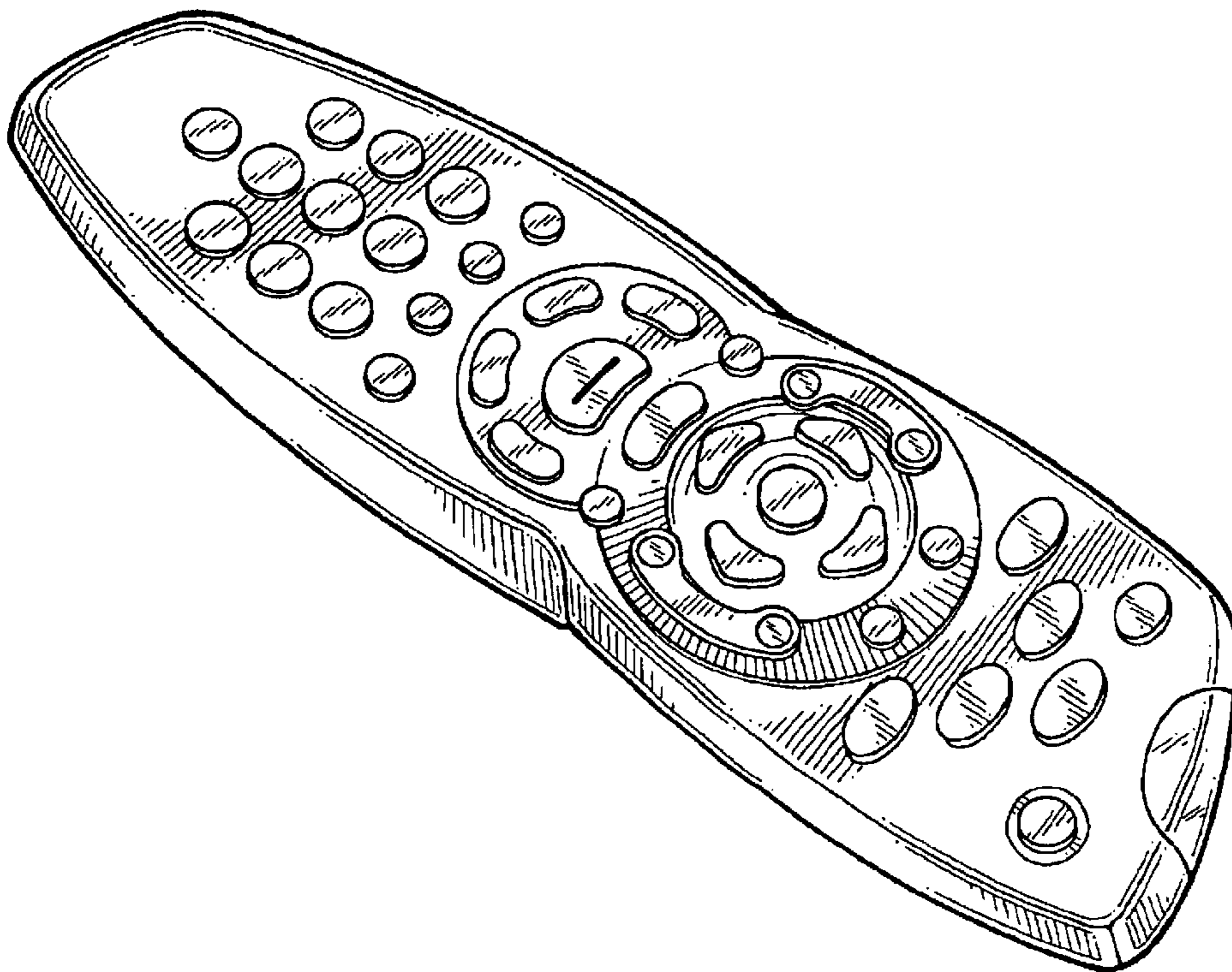
FIG. 2 is a front plan view thereof;

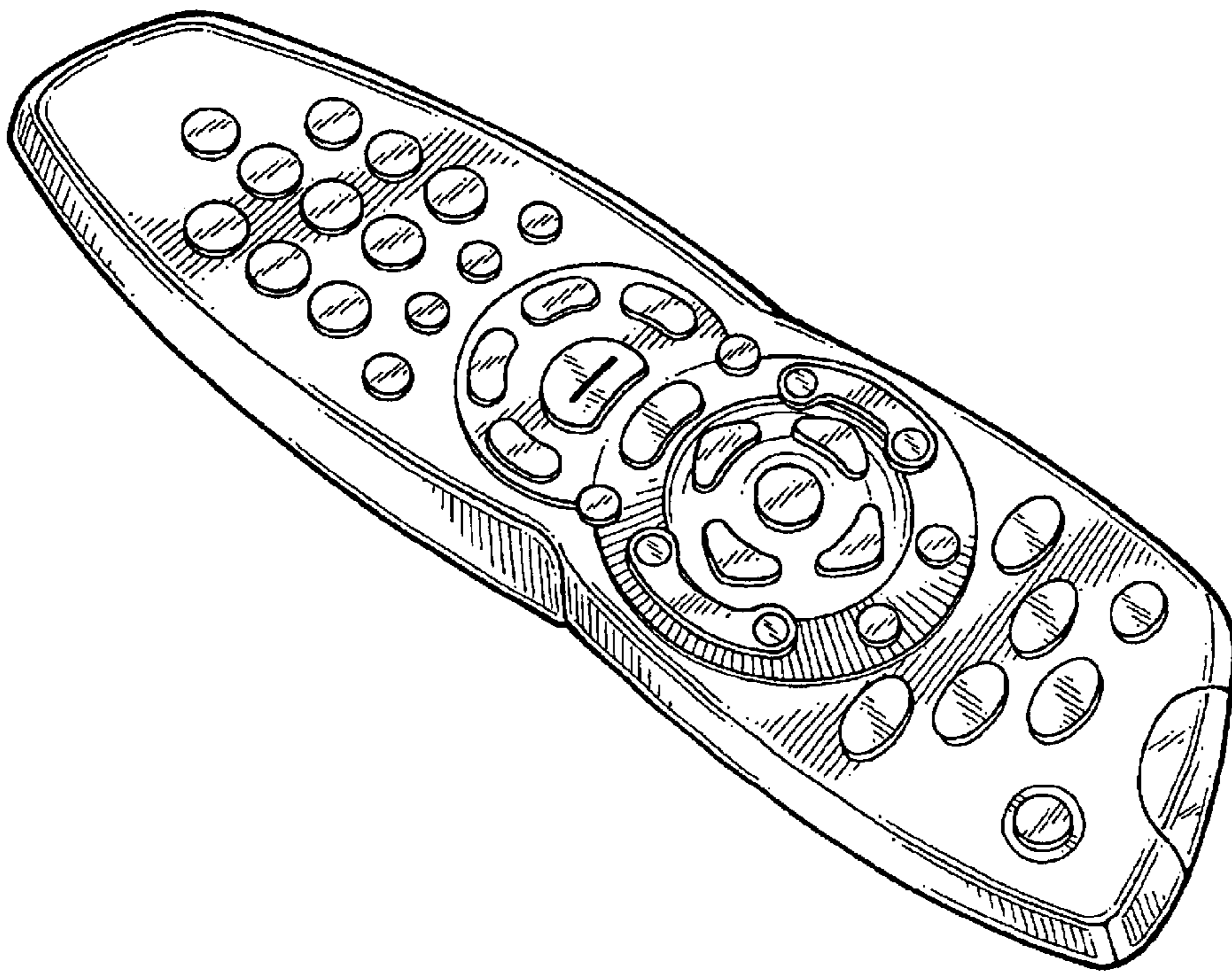

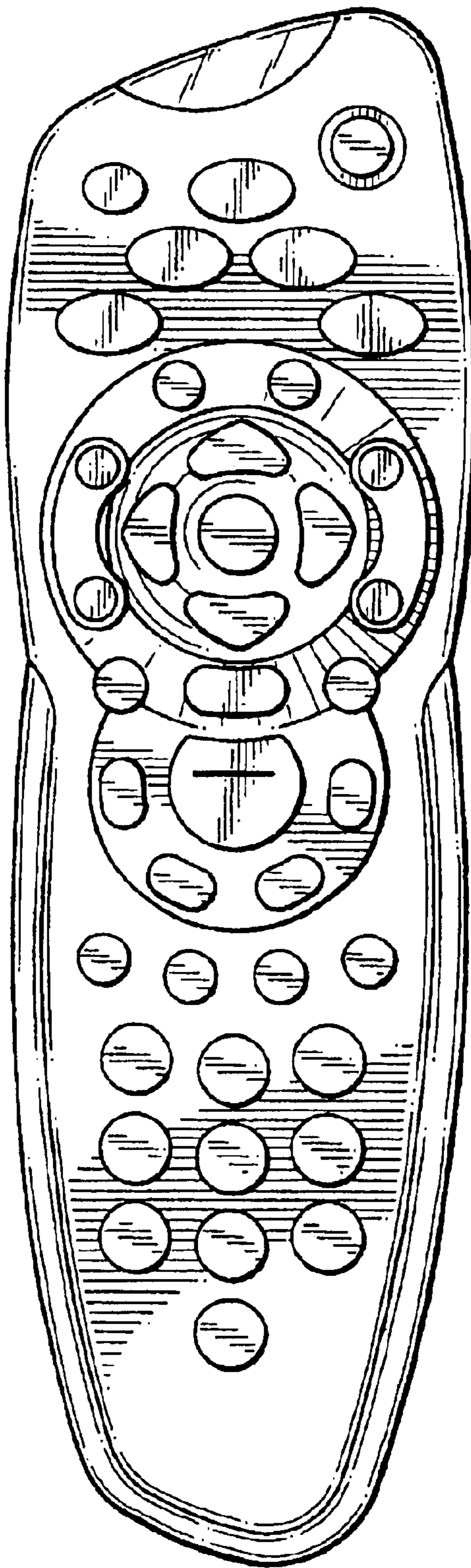

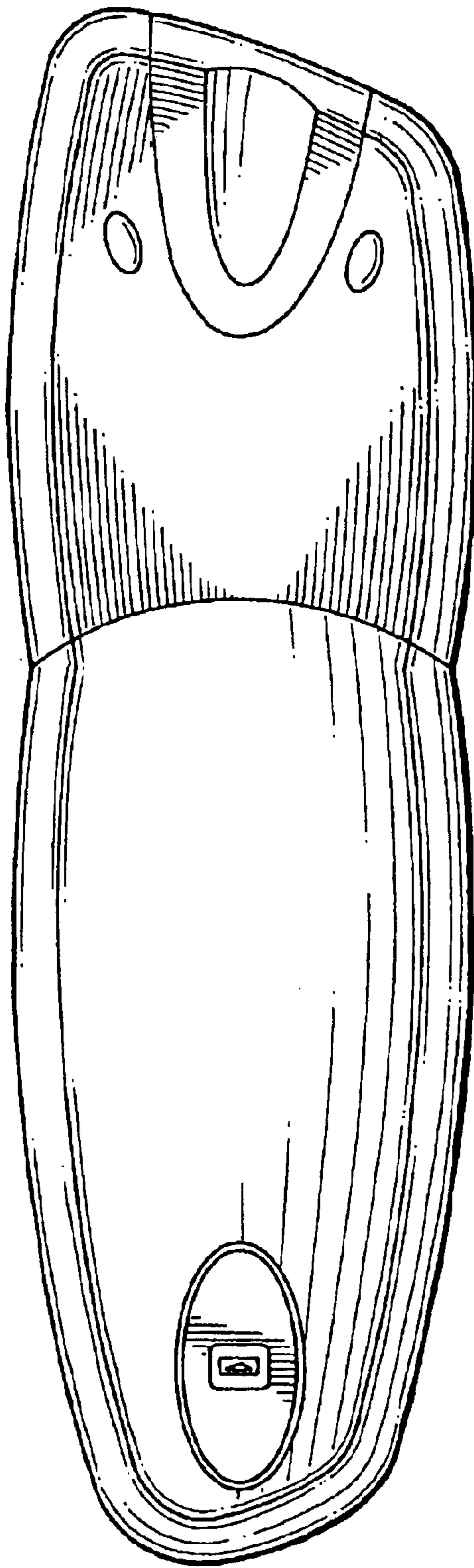

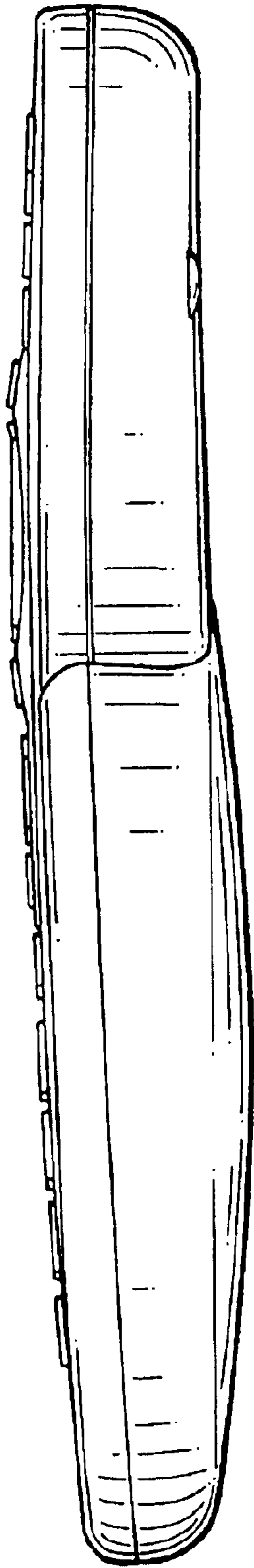

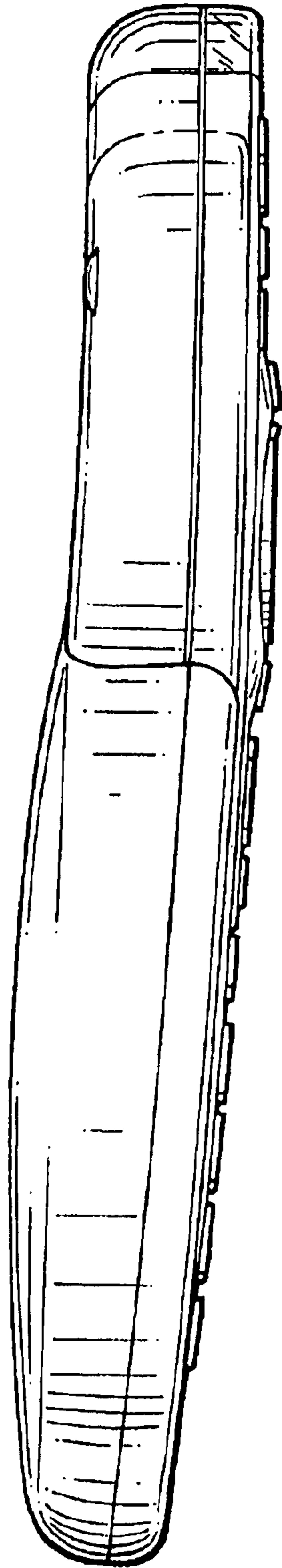
