DESCRIPTION

FIG. 1 is a bottom plan view of a front cover for a handset showing our new design;

FIG. 3 is a front view thereof;

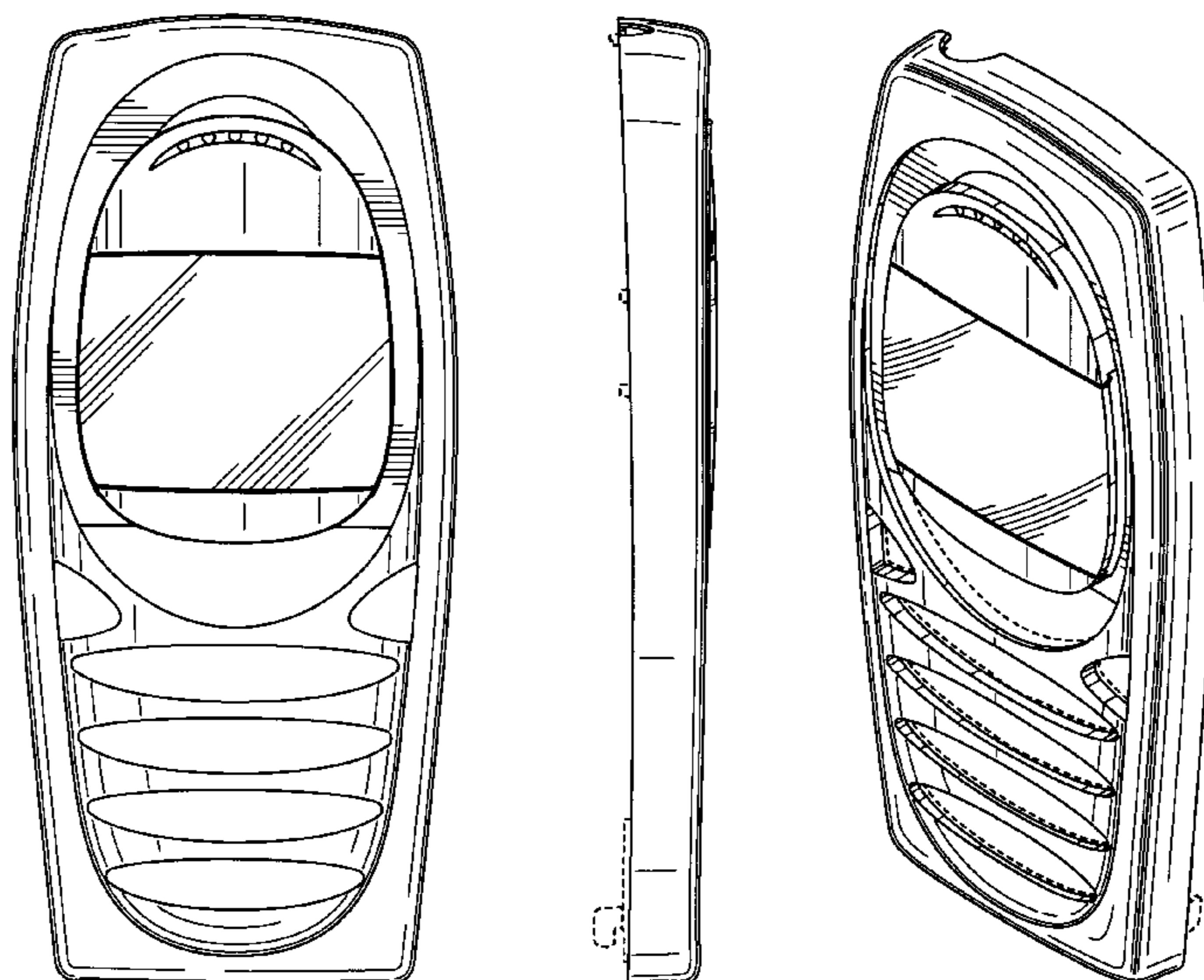
FIG. 4 is a left side view thereof;

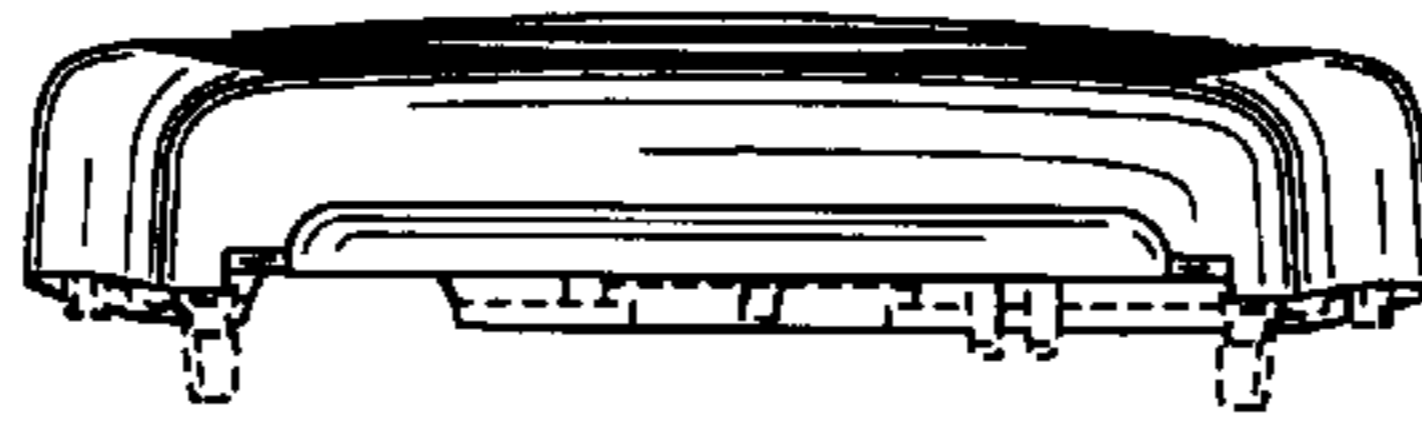

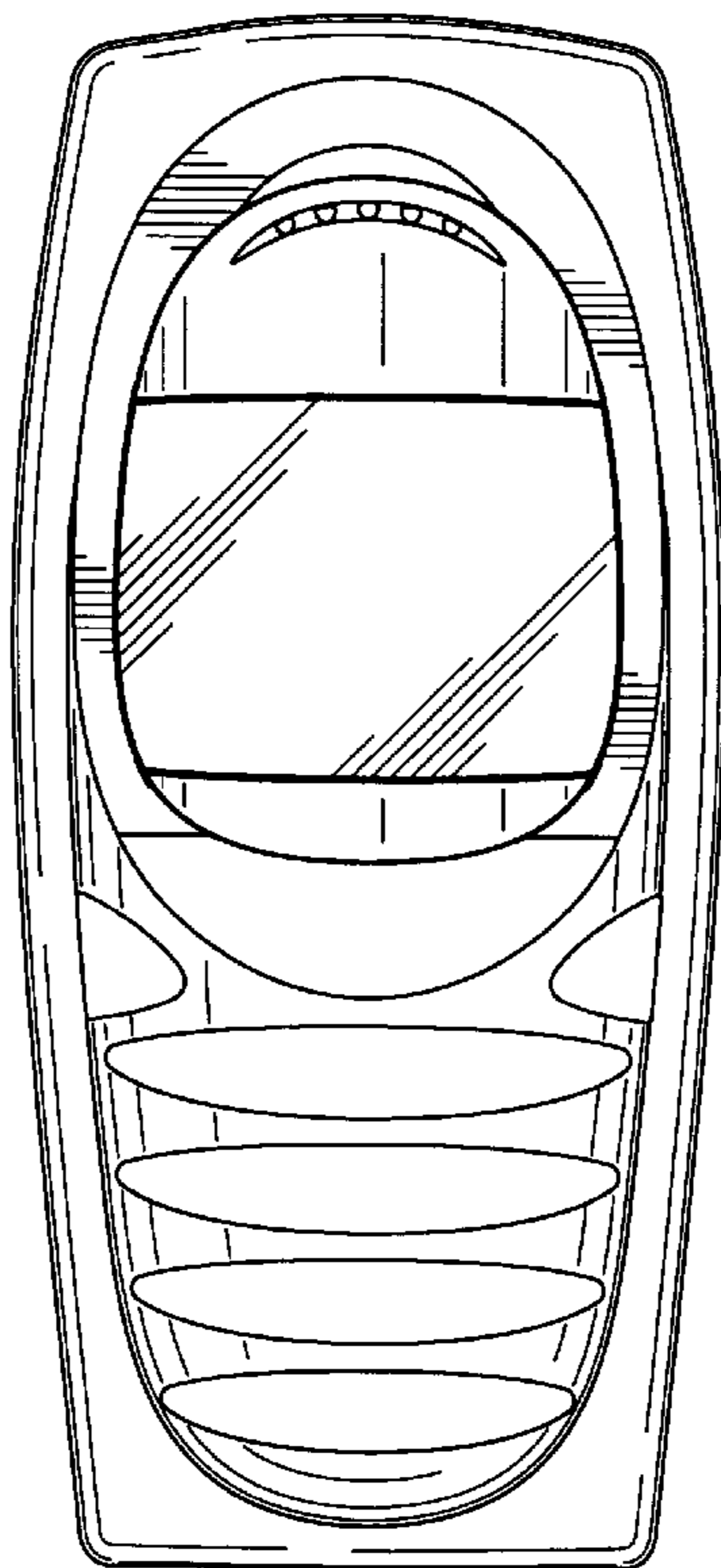

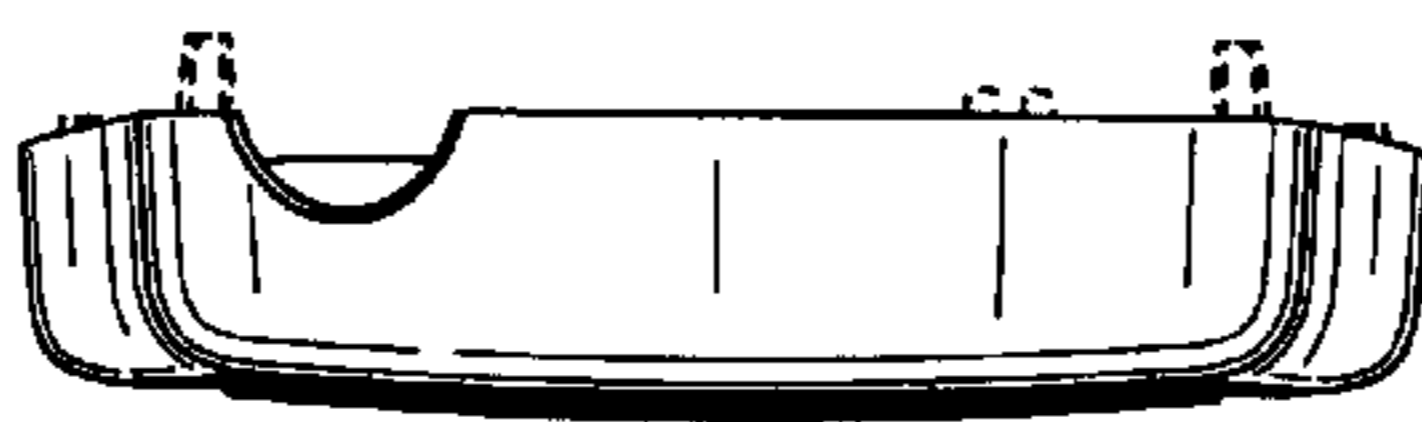

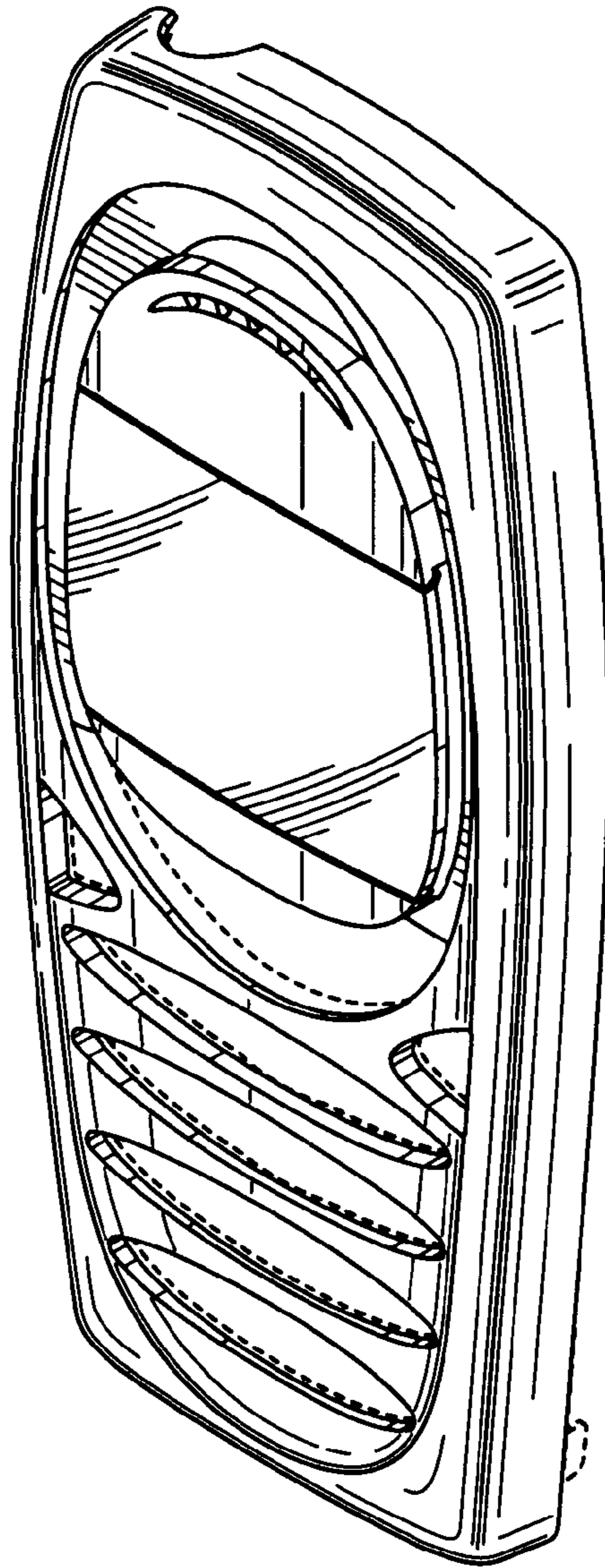
