The ornamental design for a toy kitchen, as shown.

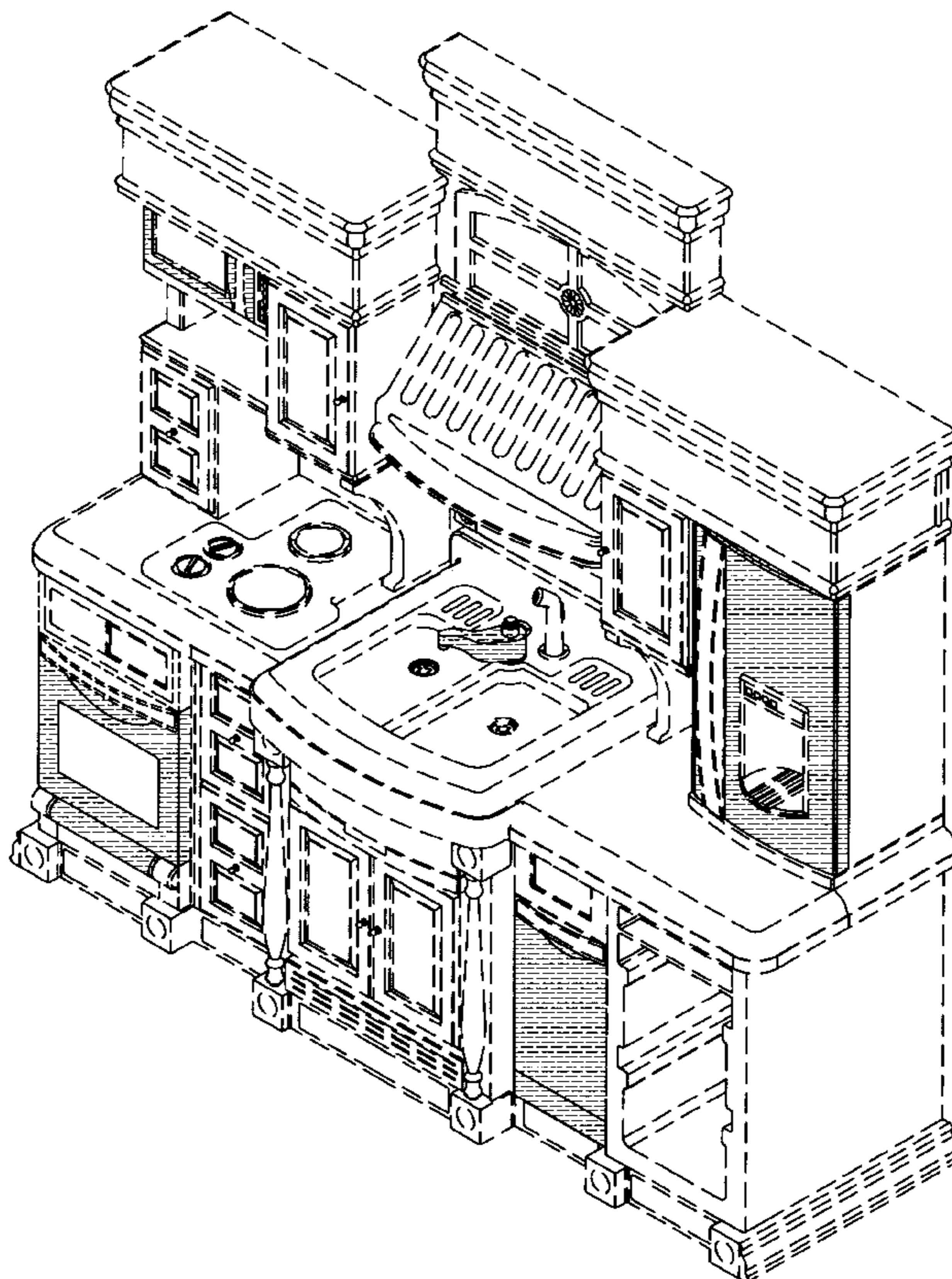
DESCRIPTION

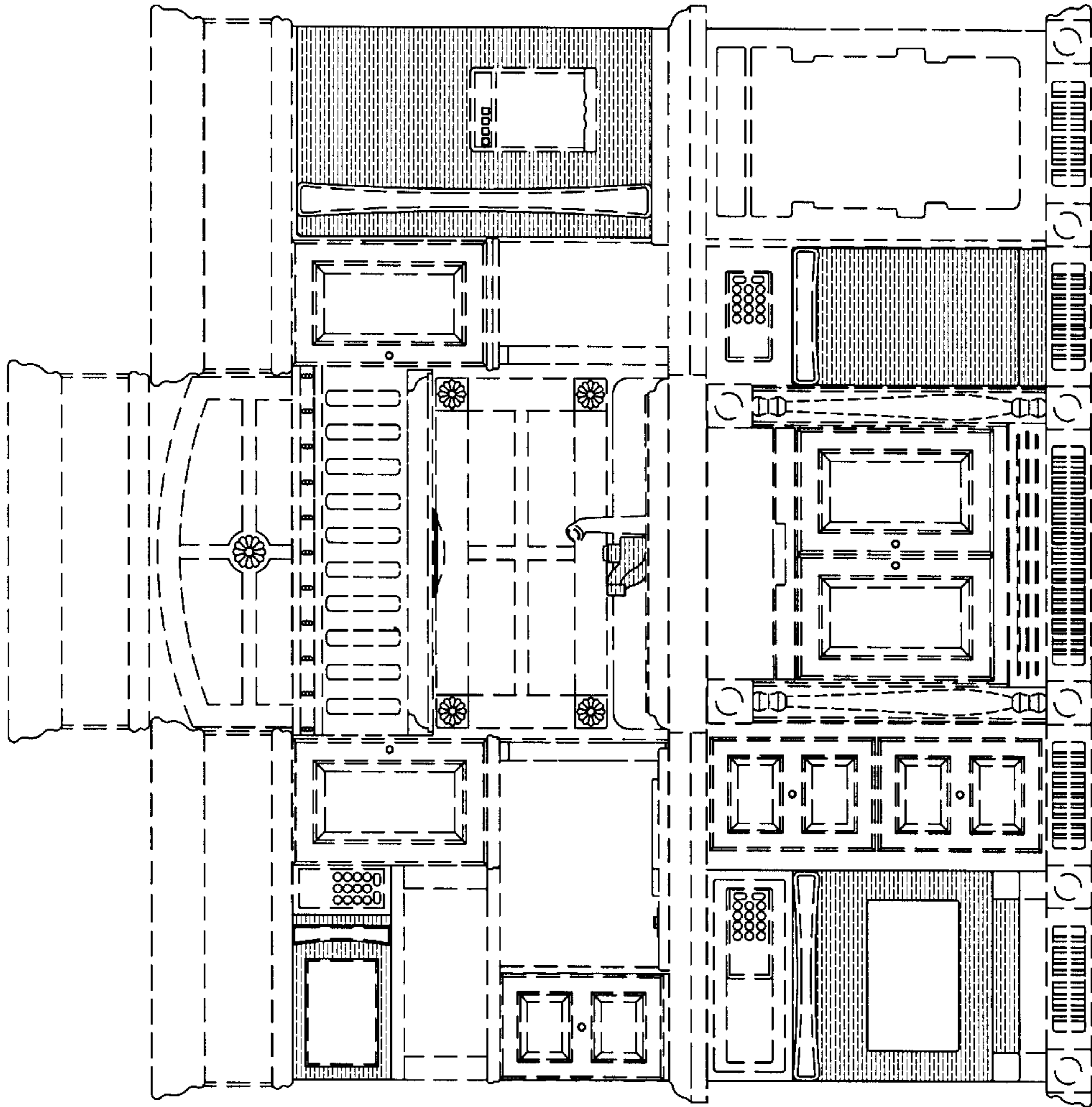

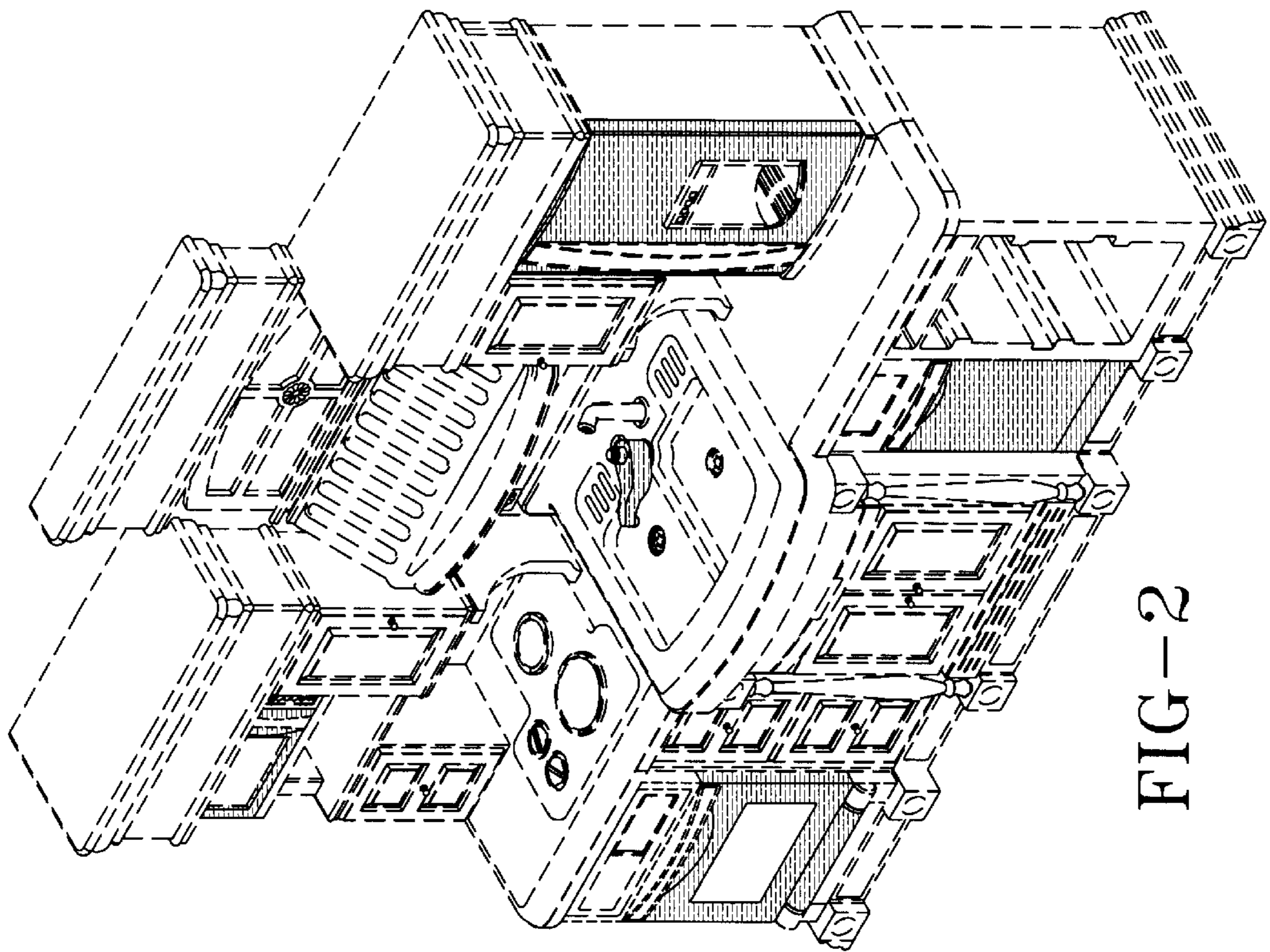

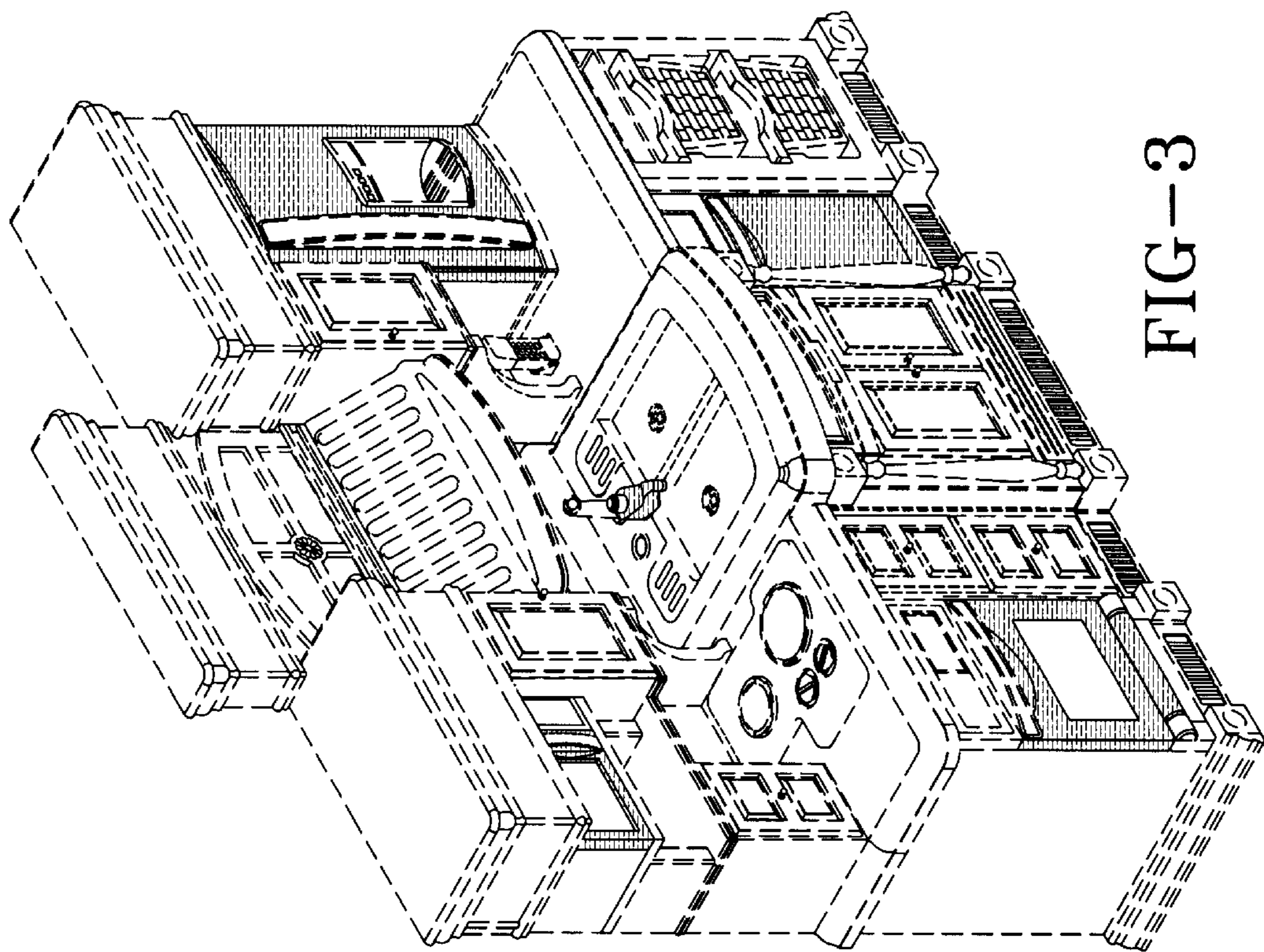
