FIG. 11 is a sectional view taken on the line 11—11 of FIG. 10.

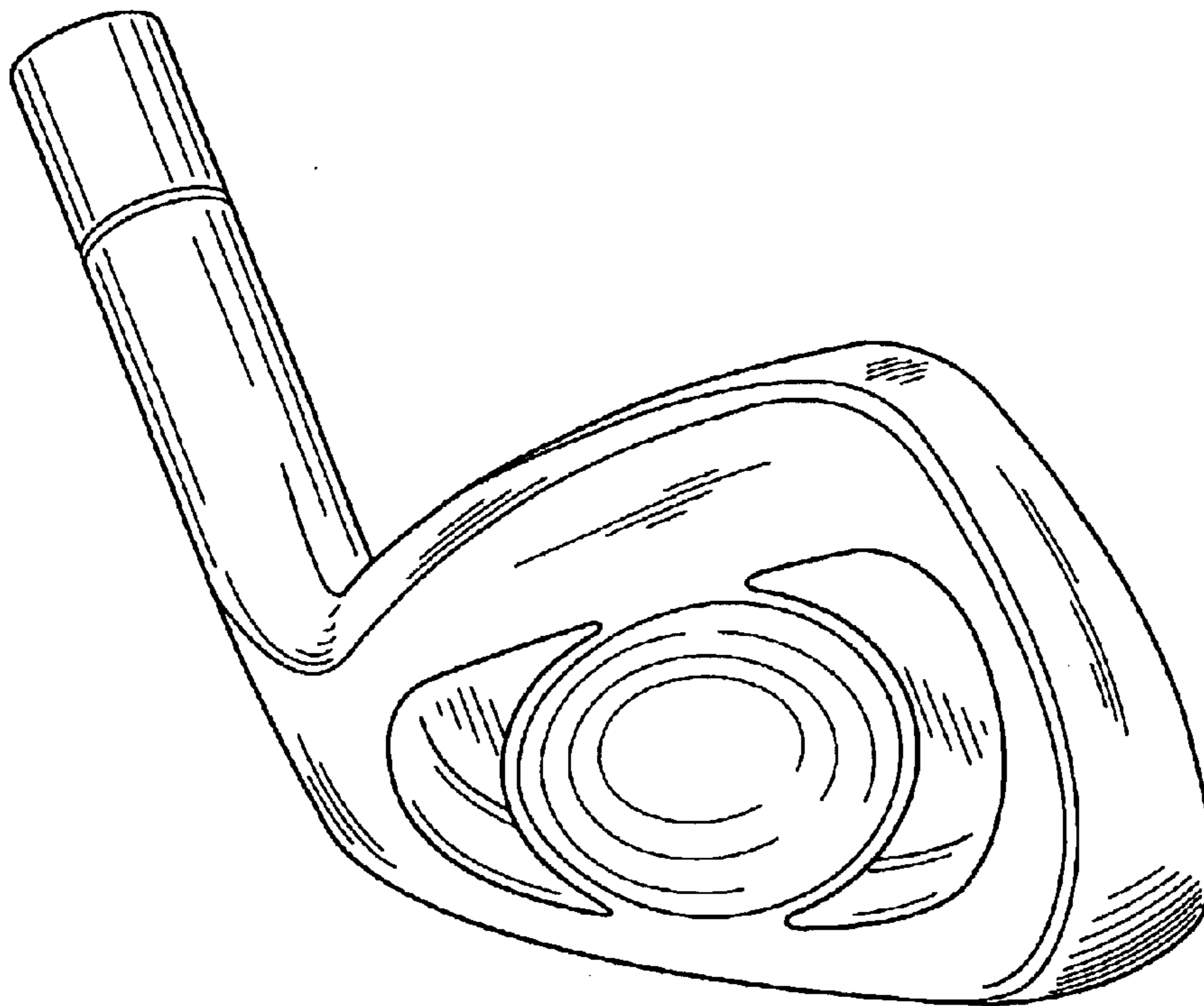

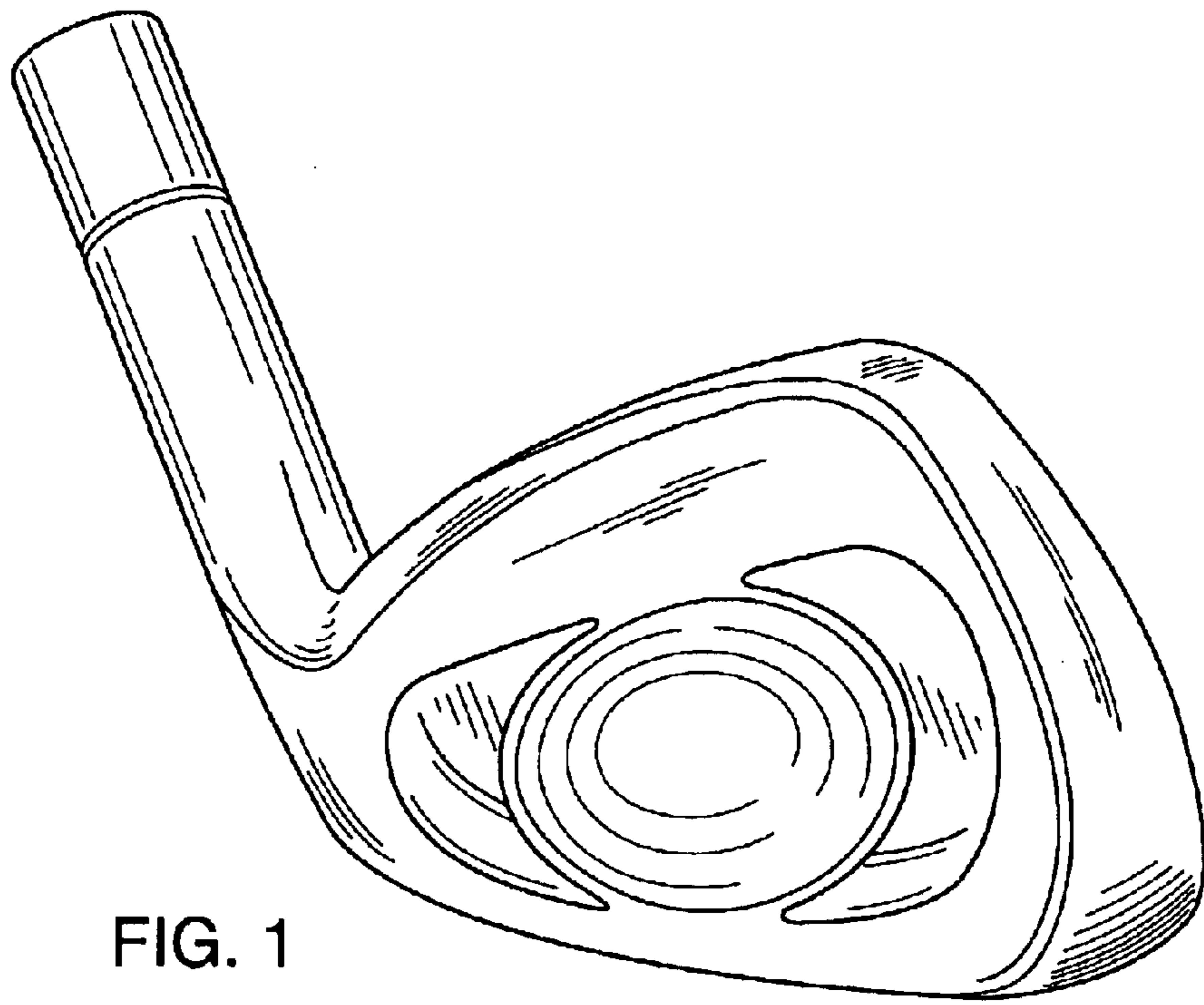

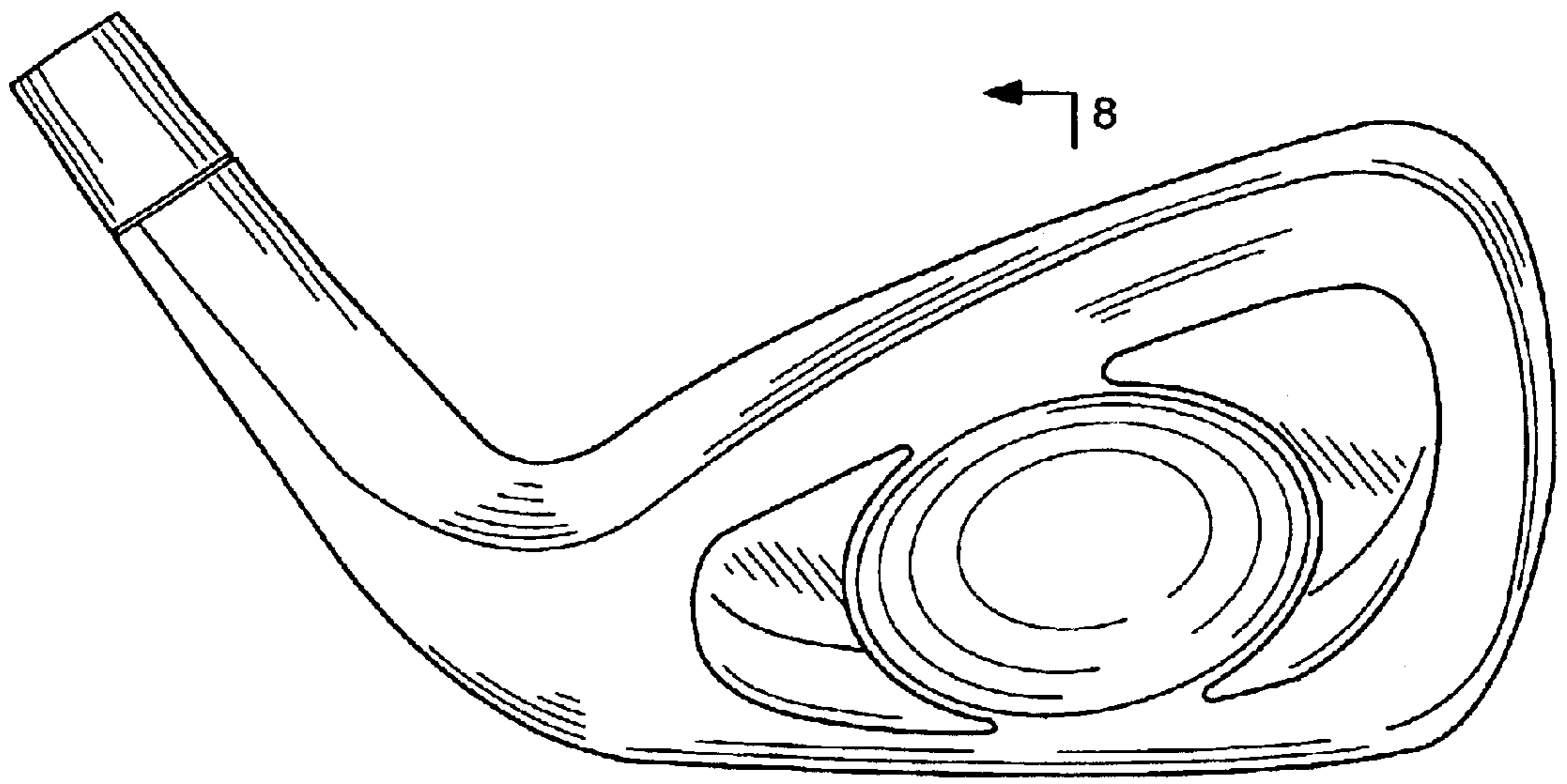

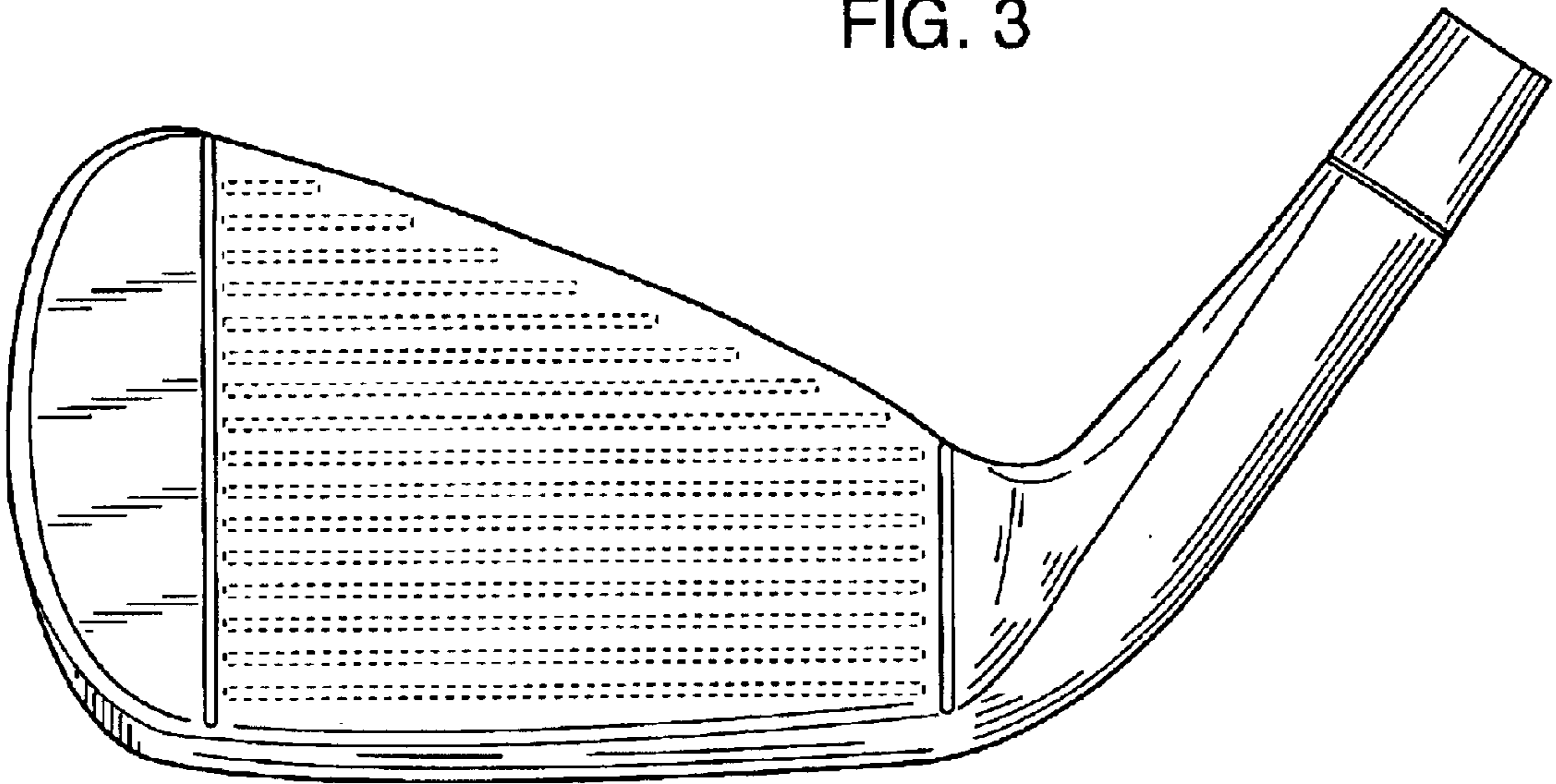

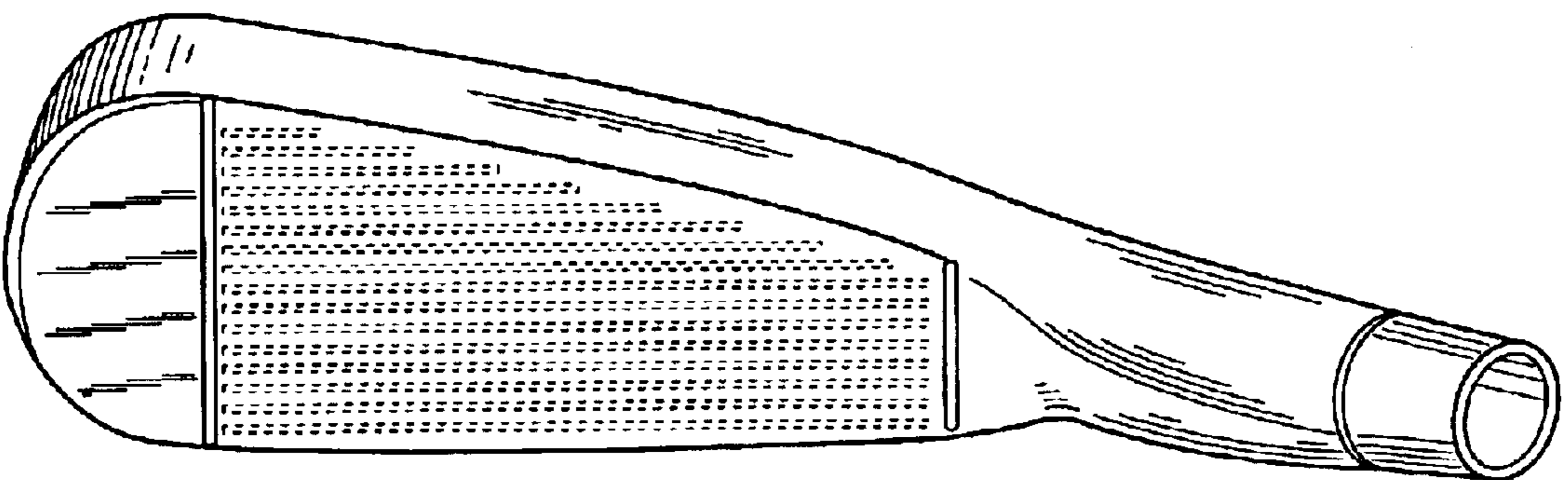

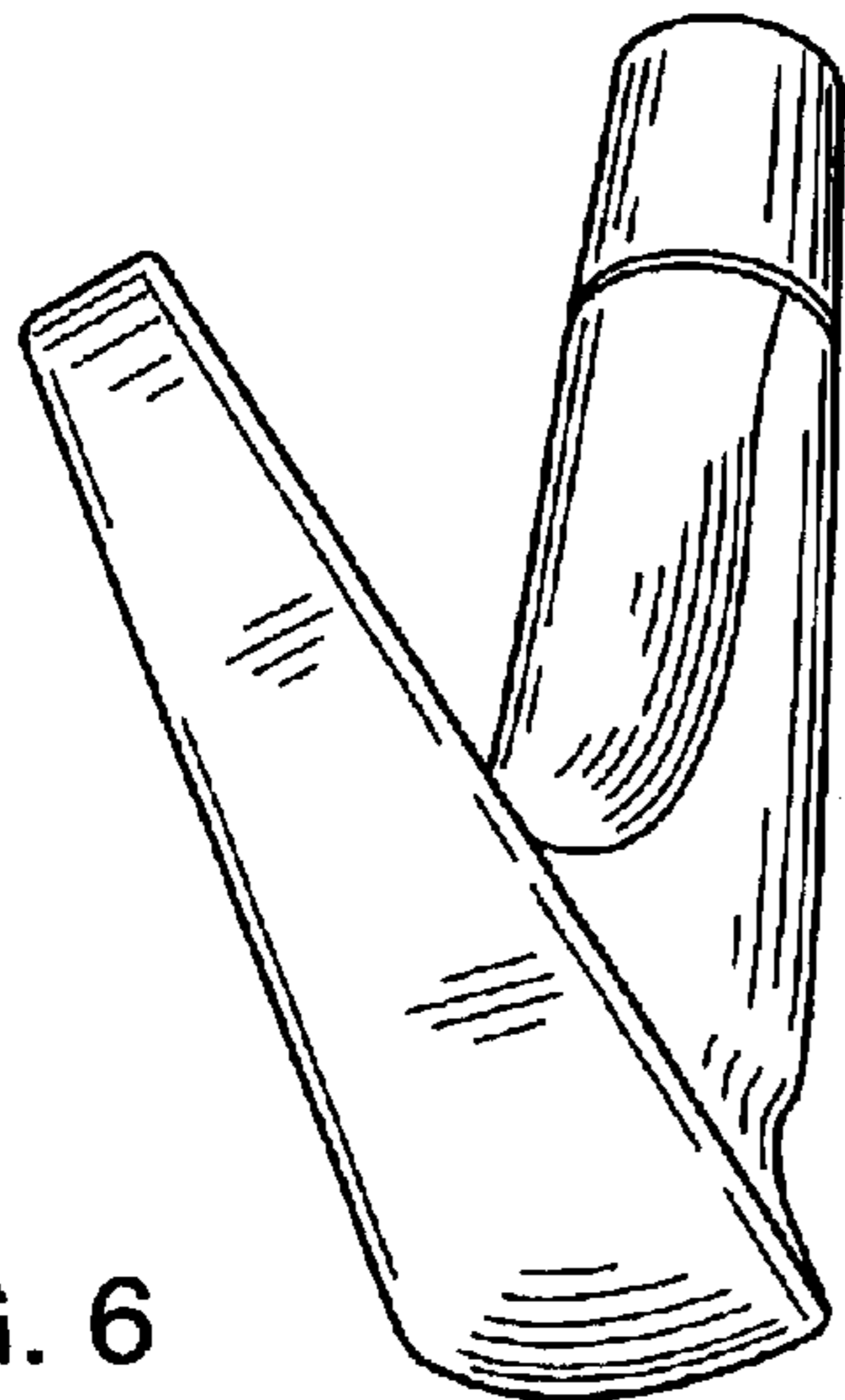
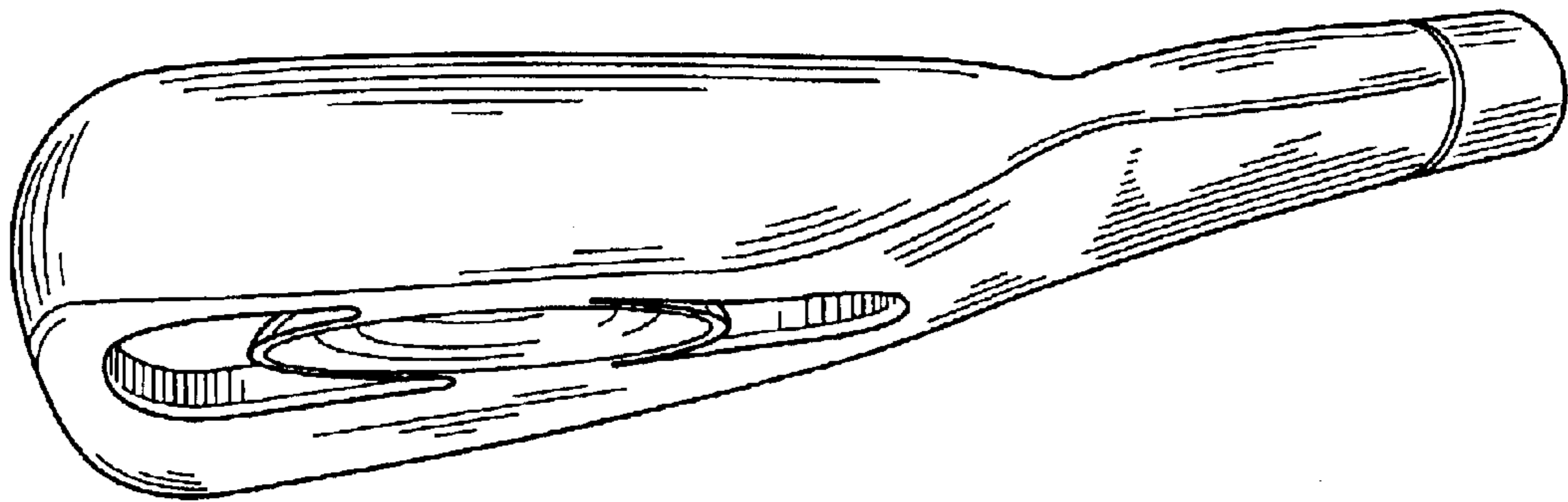

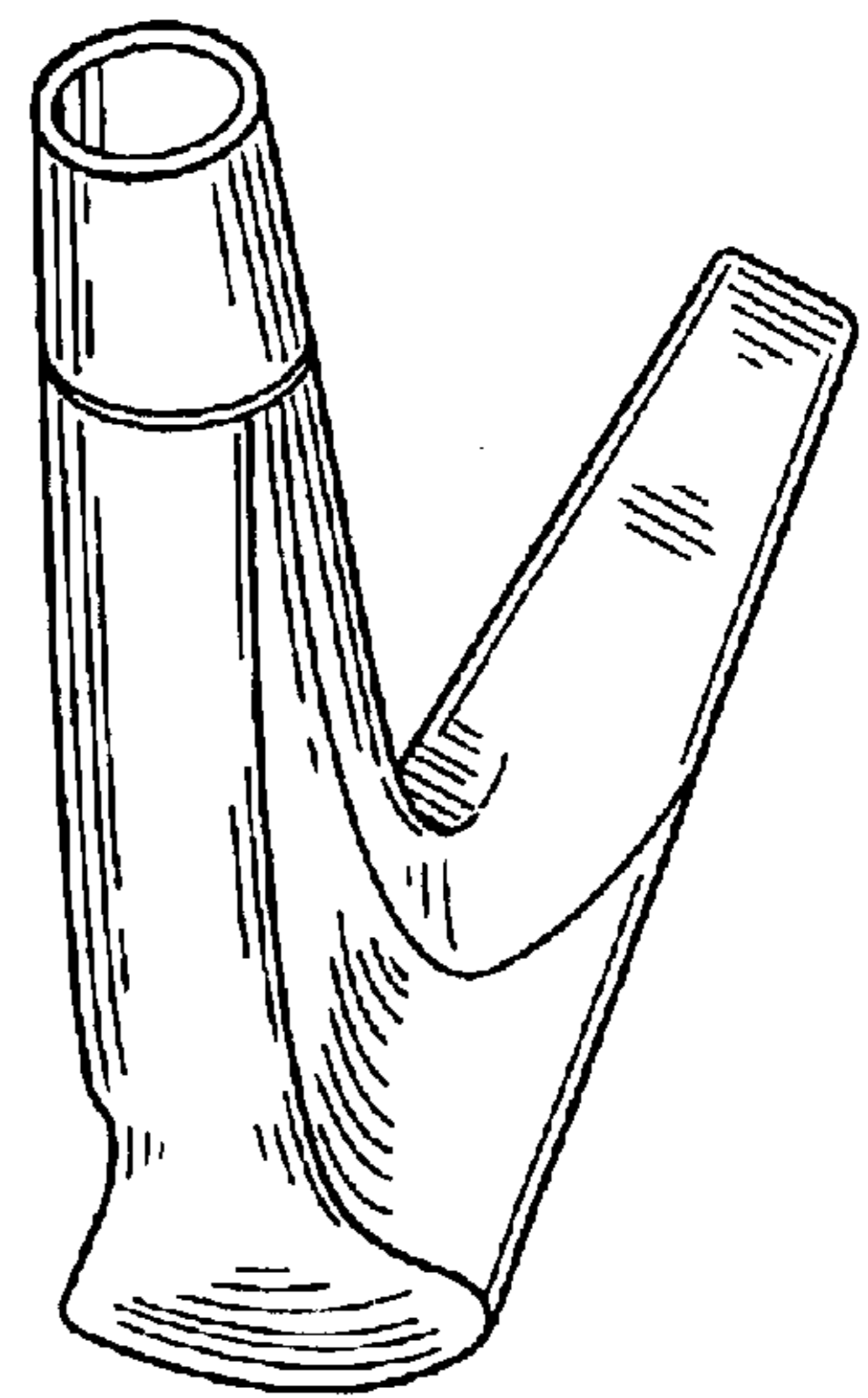

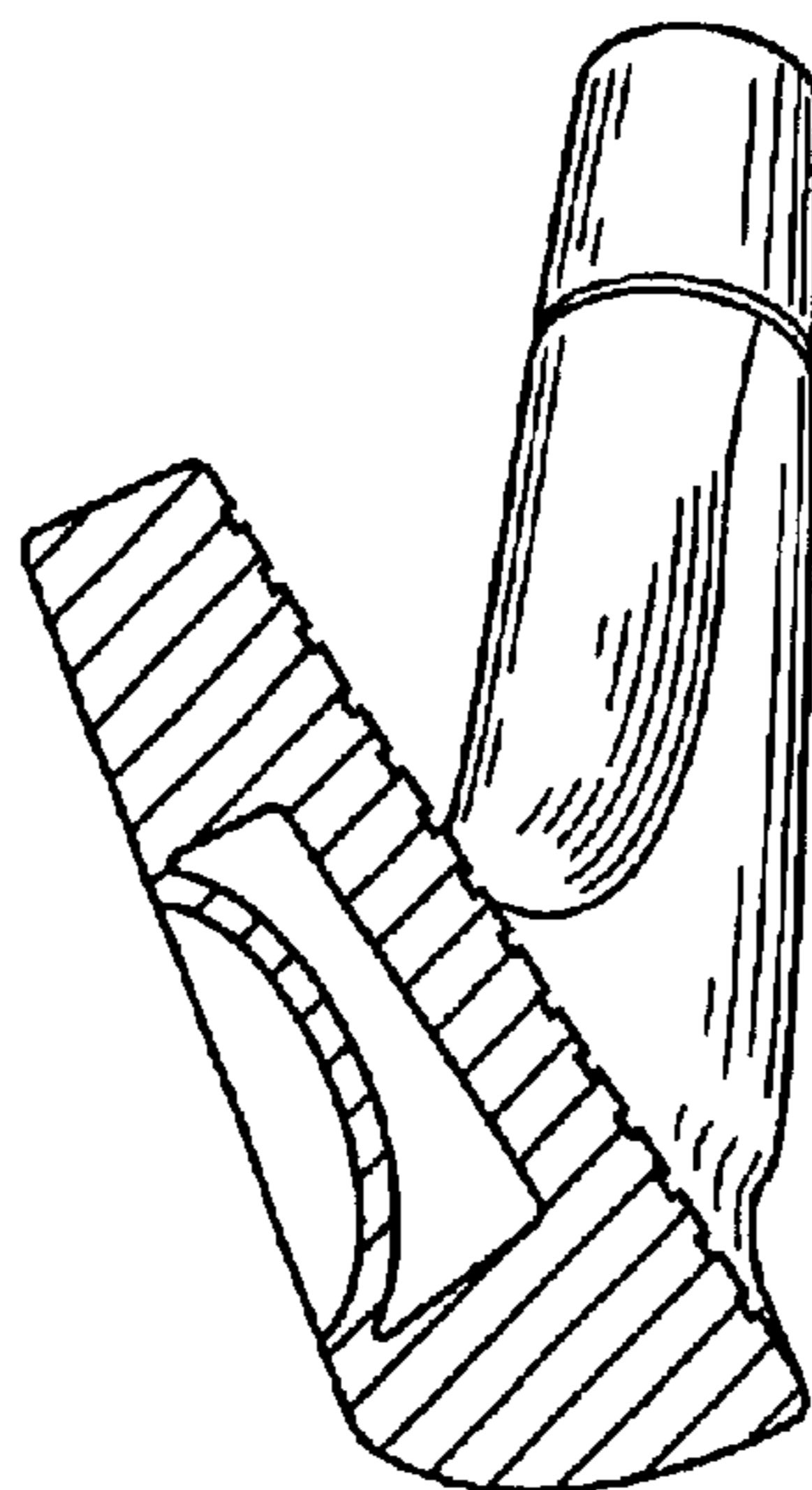

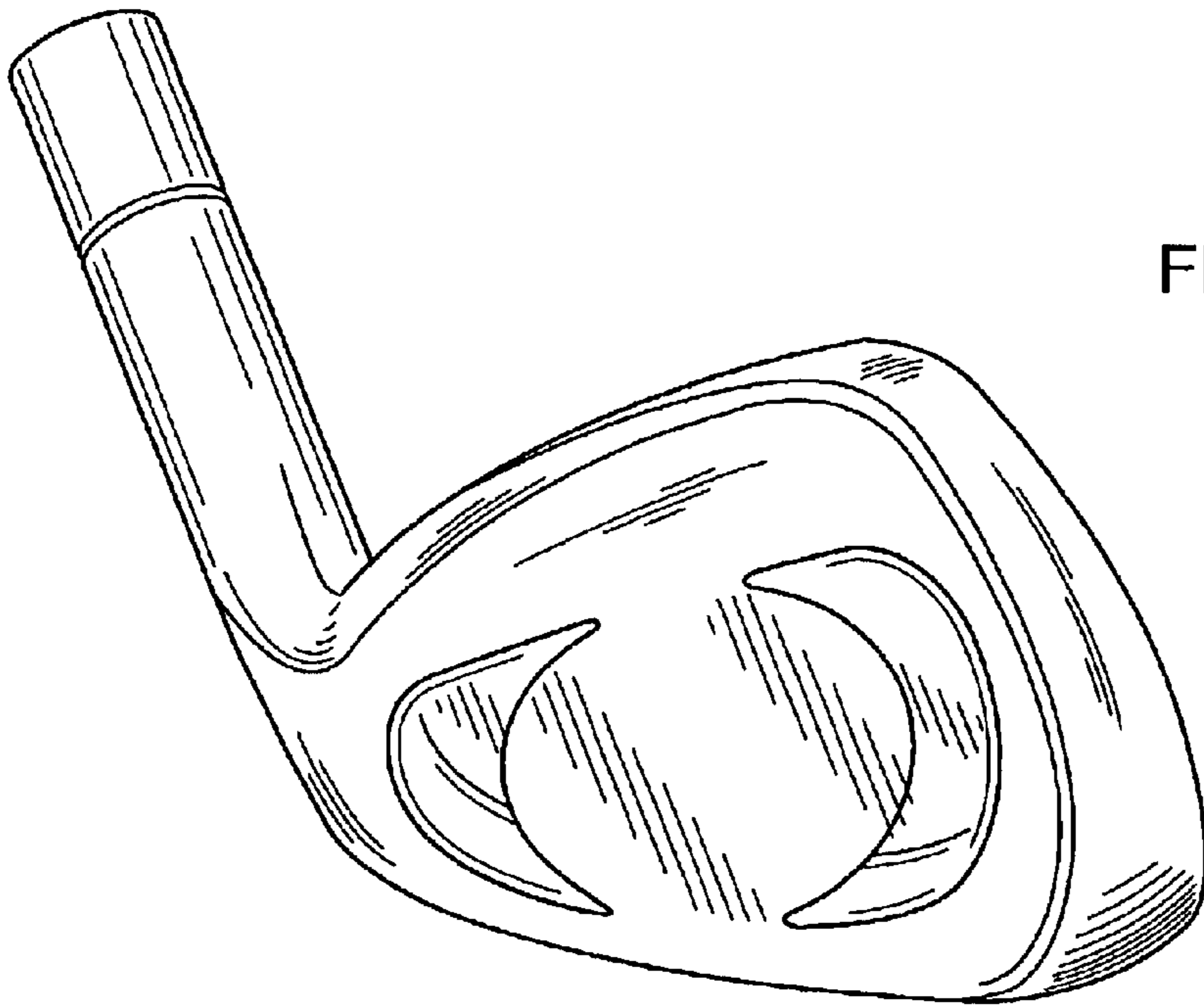

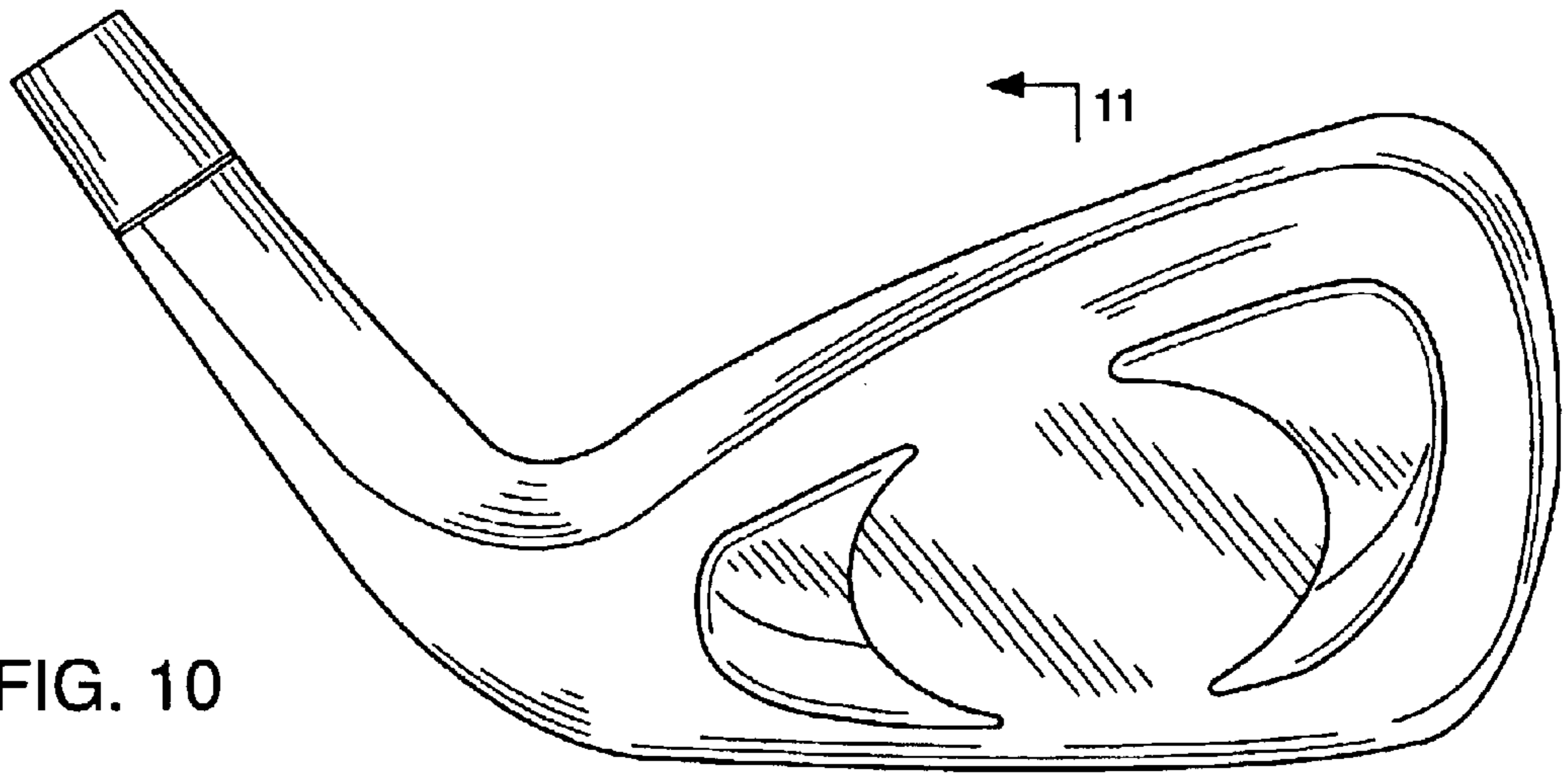

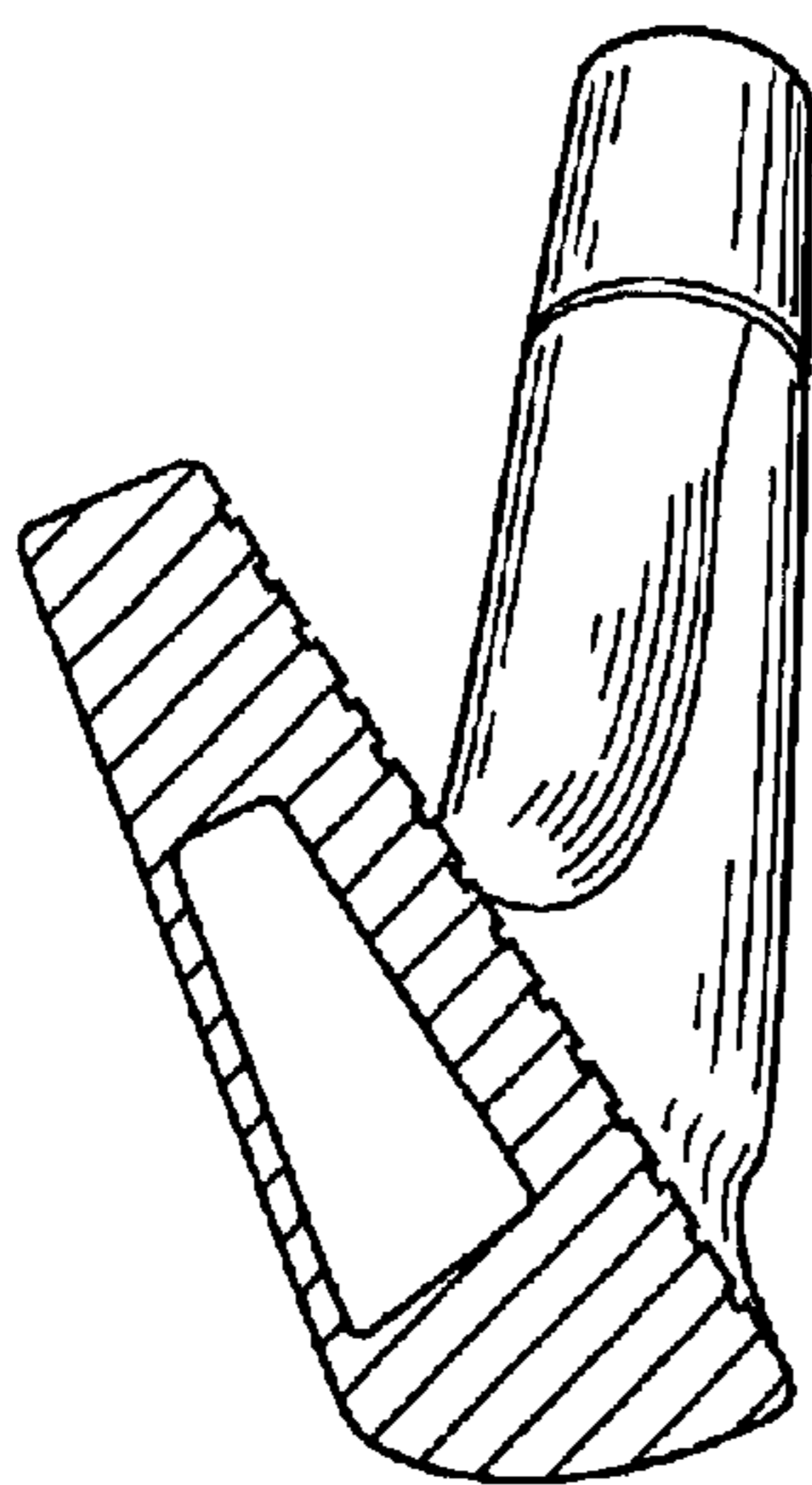
