FIG. 6 is a left side view thereof; and,

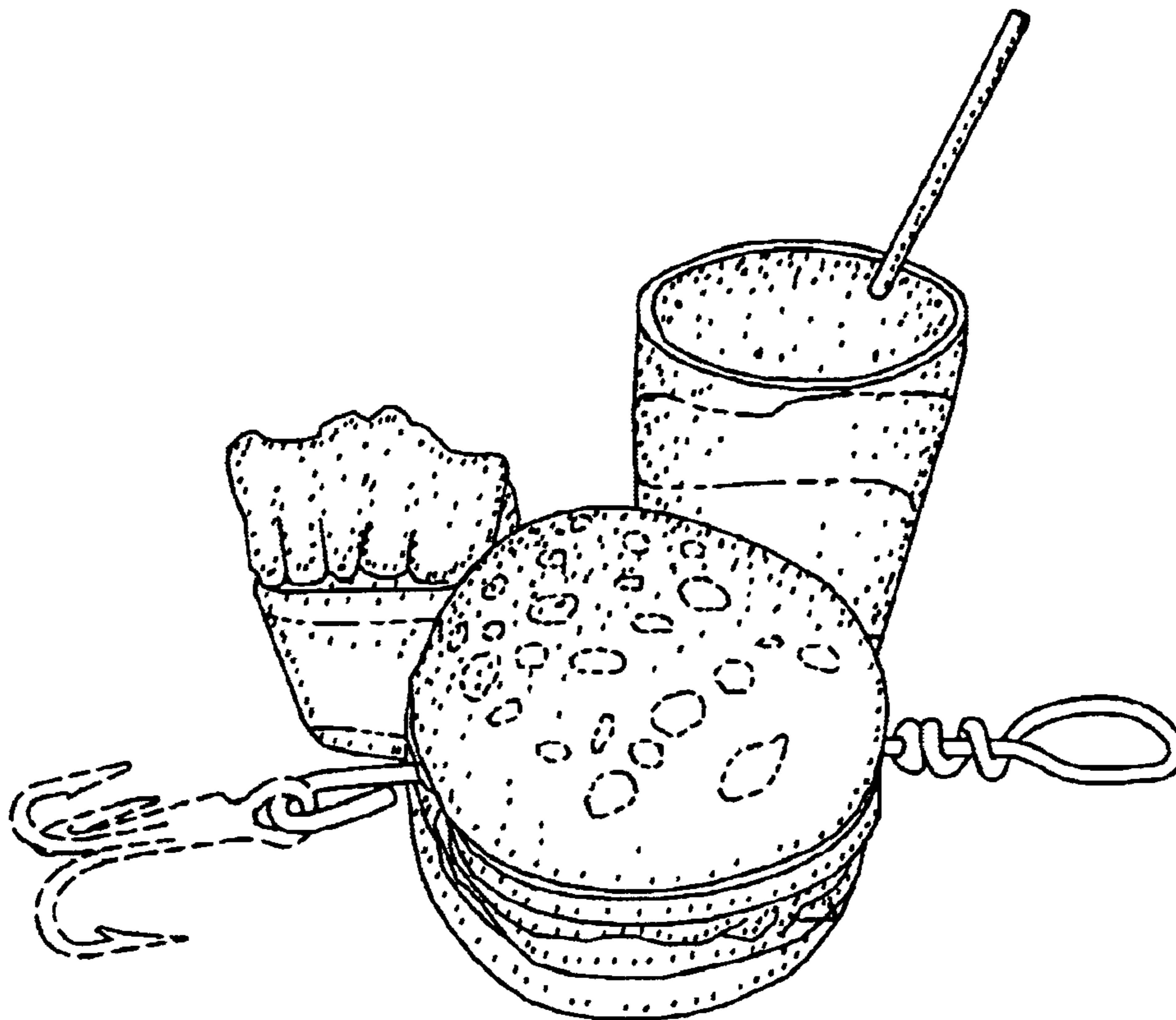
FIG. 7 is a bottom view thereof.

The broken line showing of environment in FIGS. 1 and 3 is for illustrative purposes only and forms no part of the claimed design.

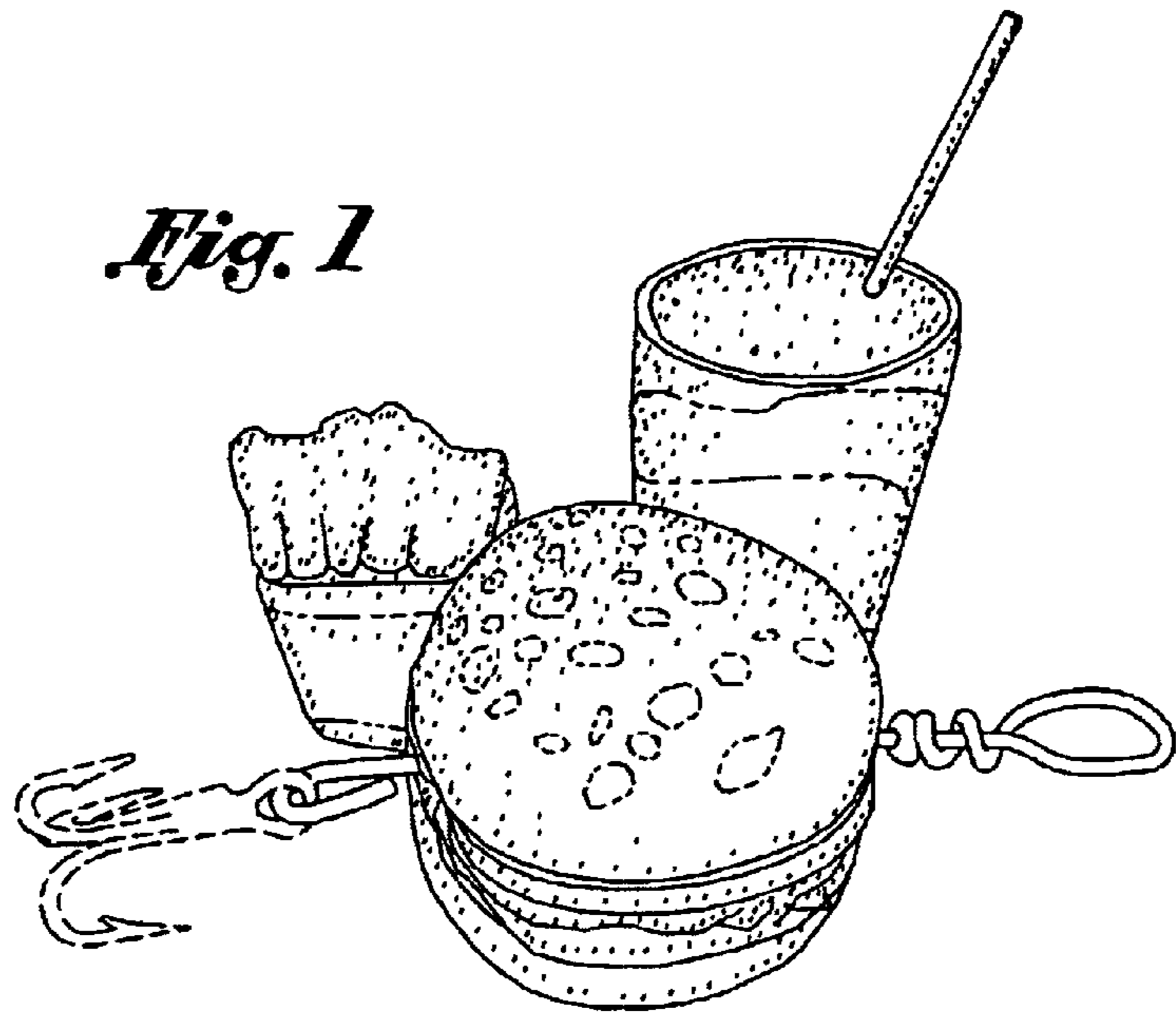

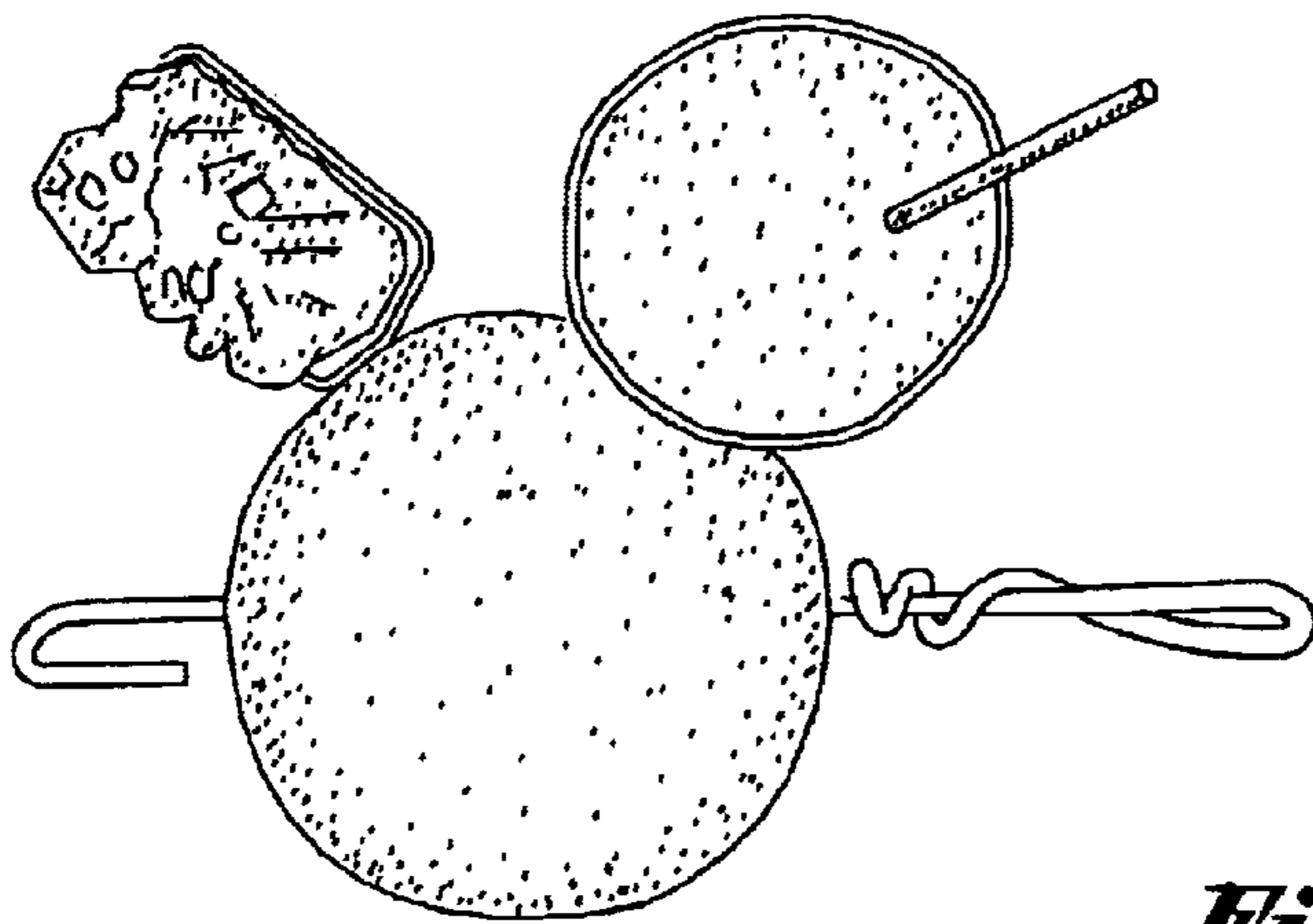

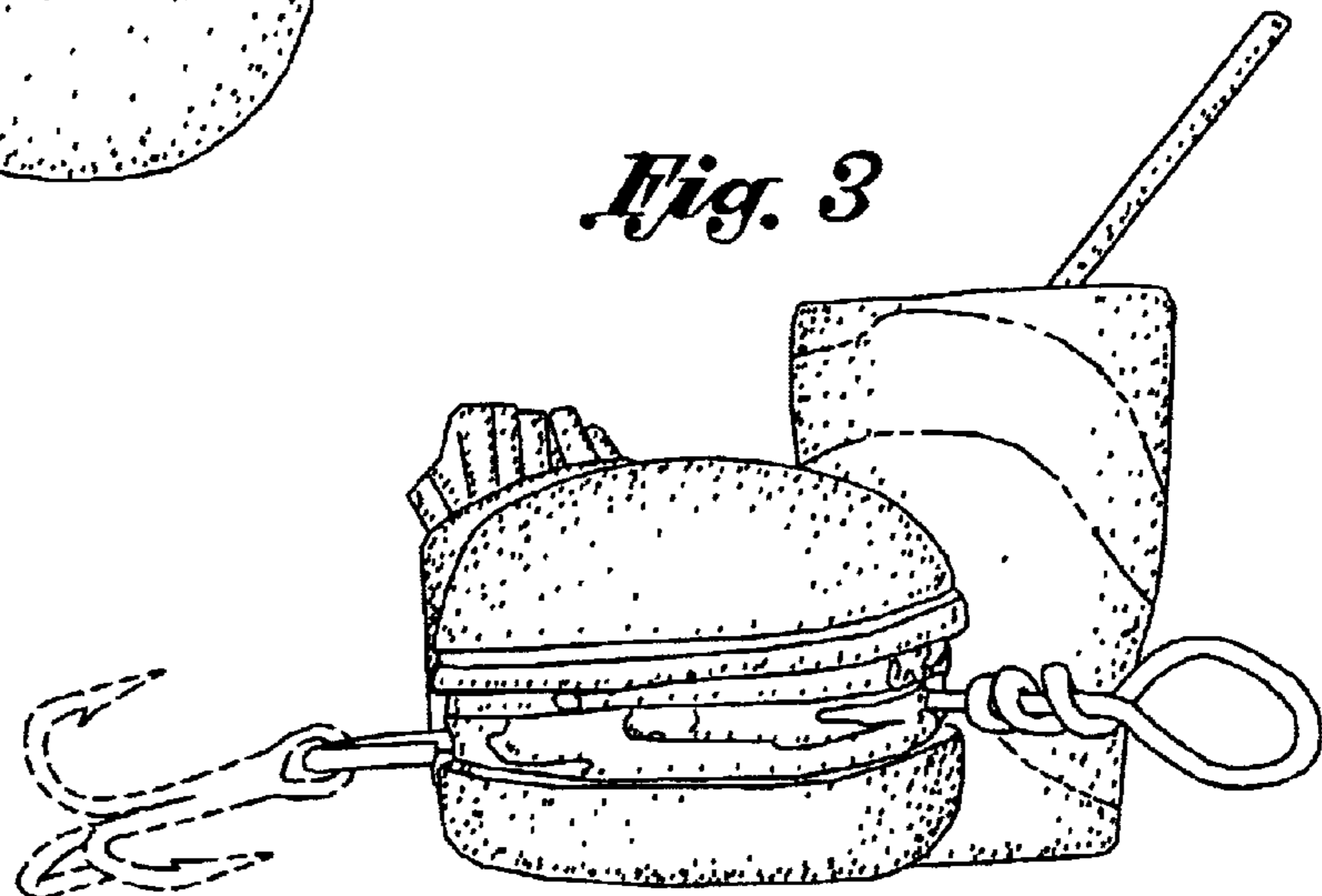

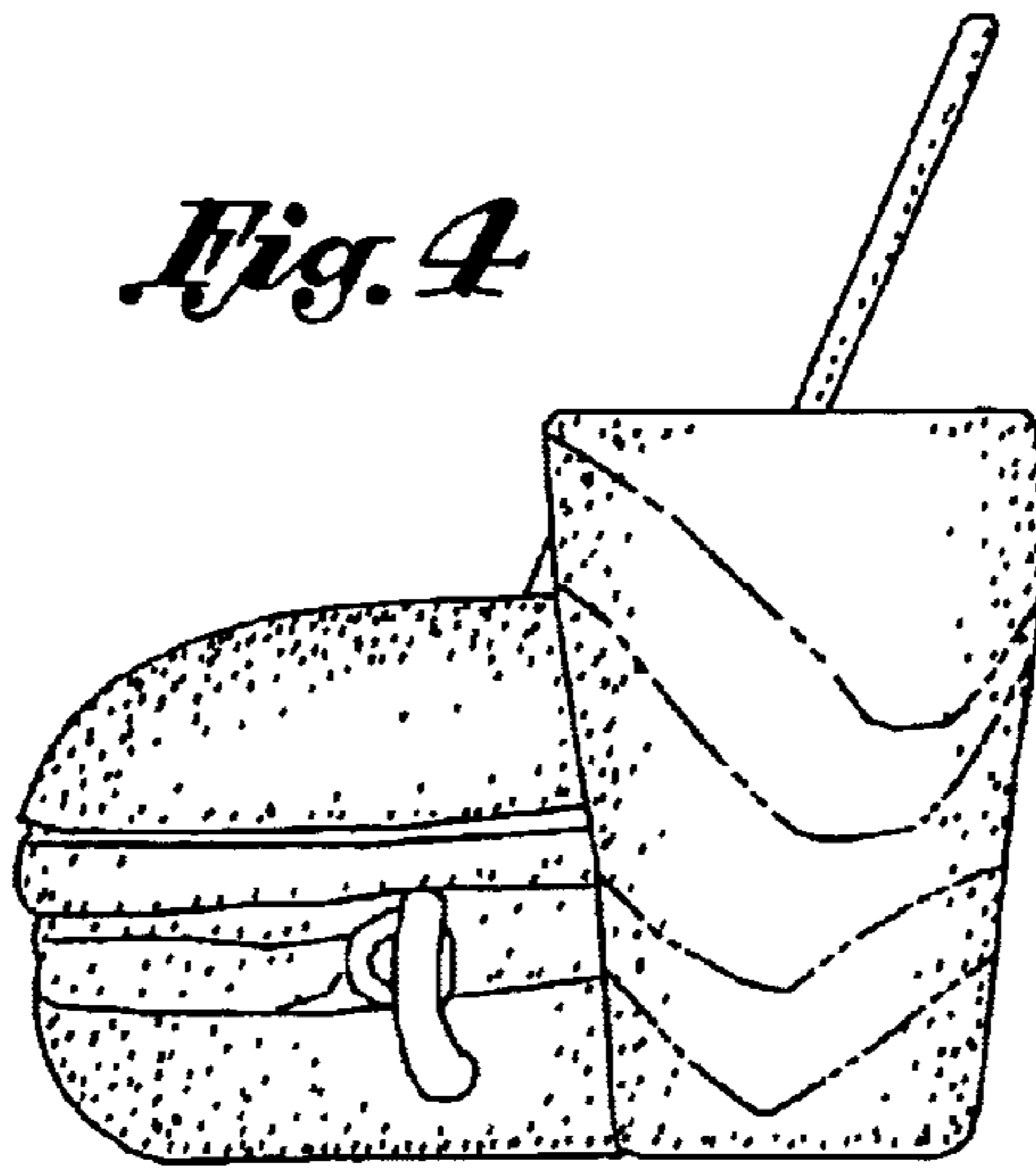

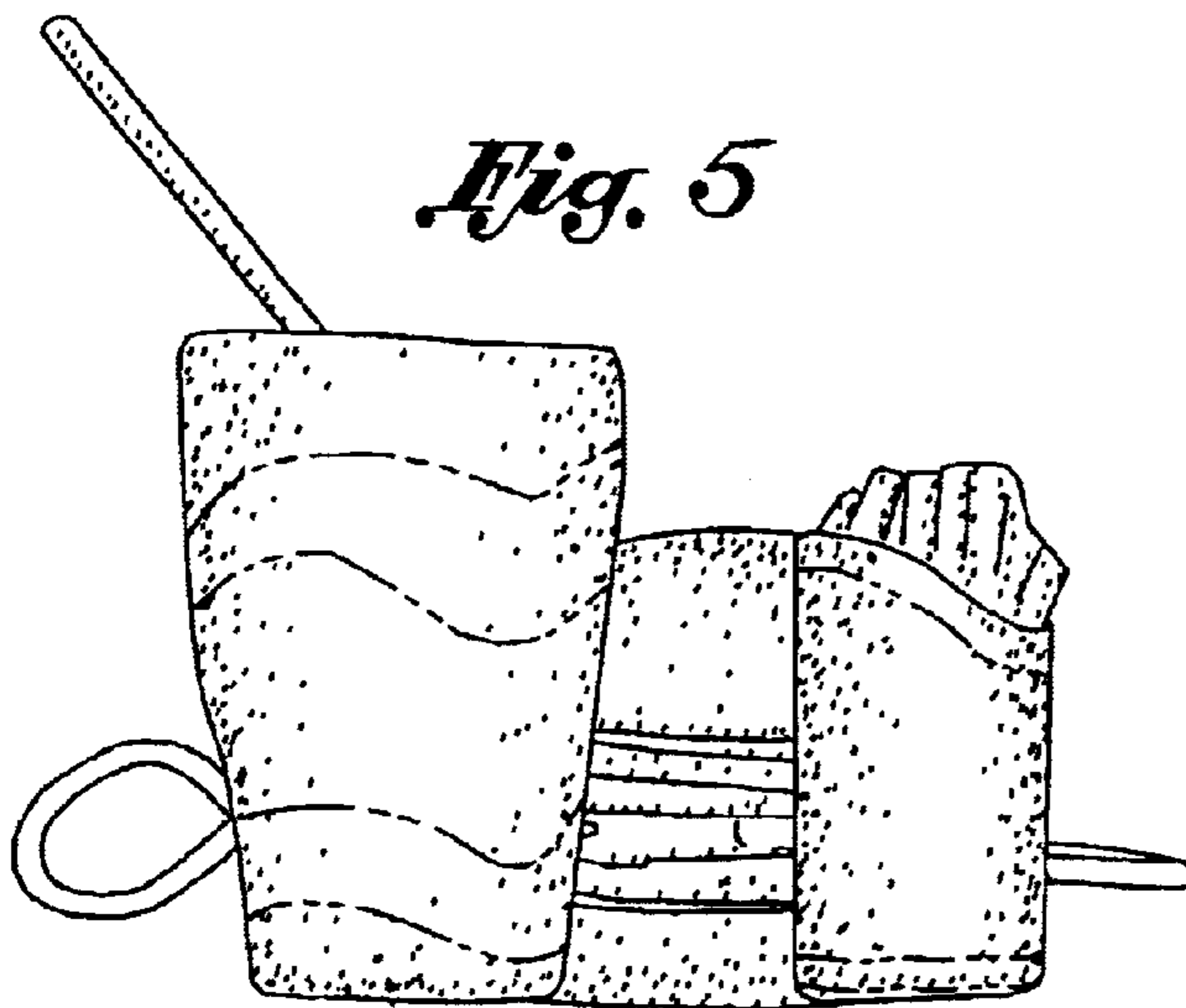

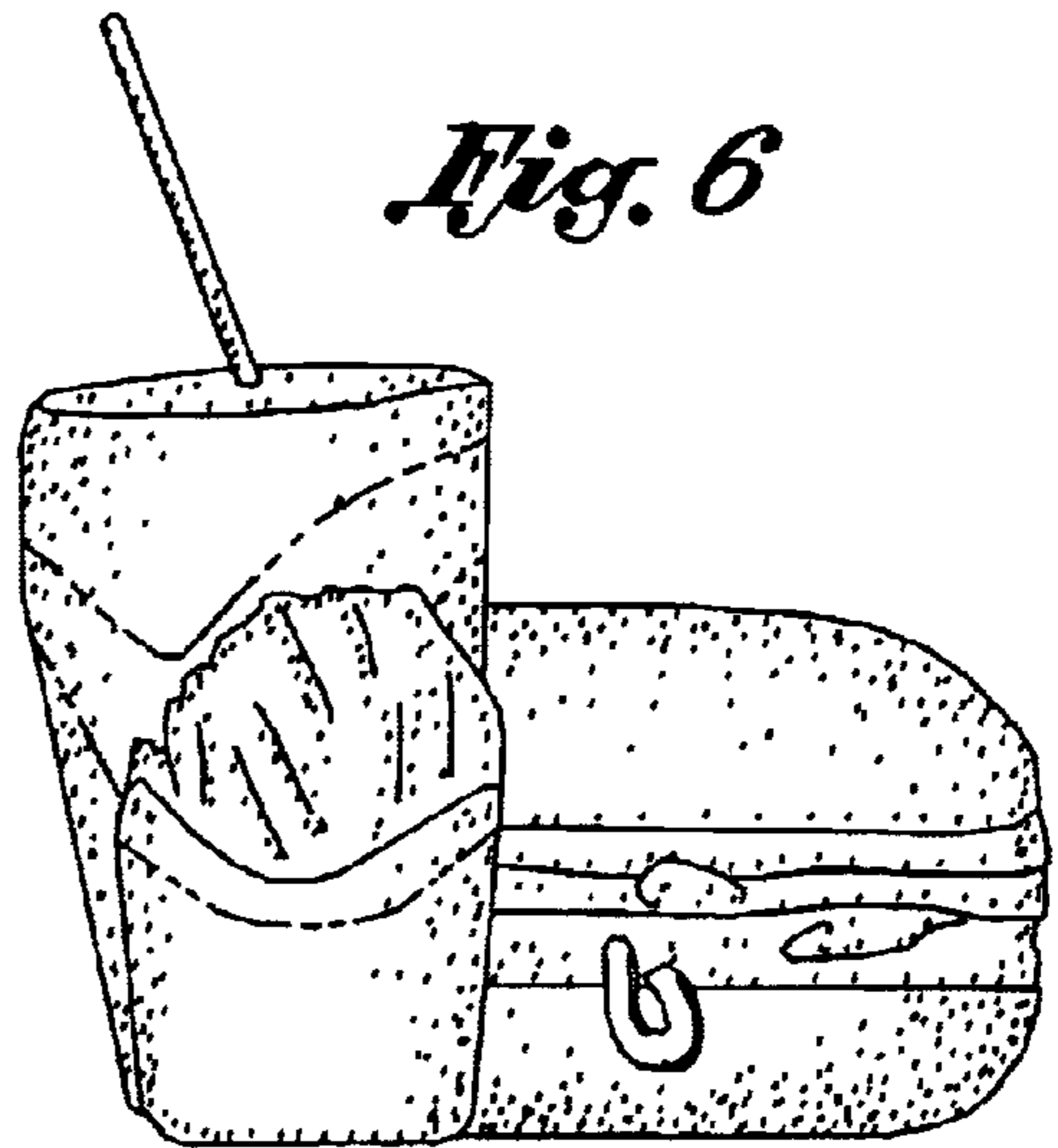
