FIG. 1 is a front perspective view of one embodiment of my new chair design;

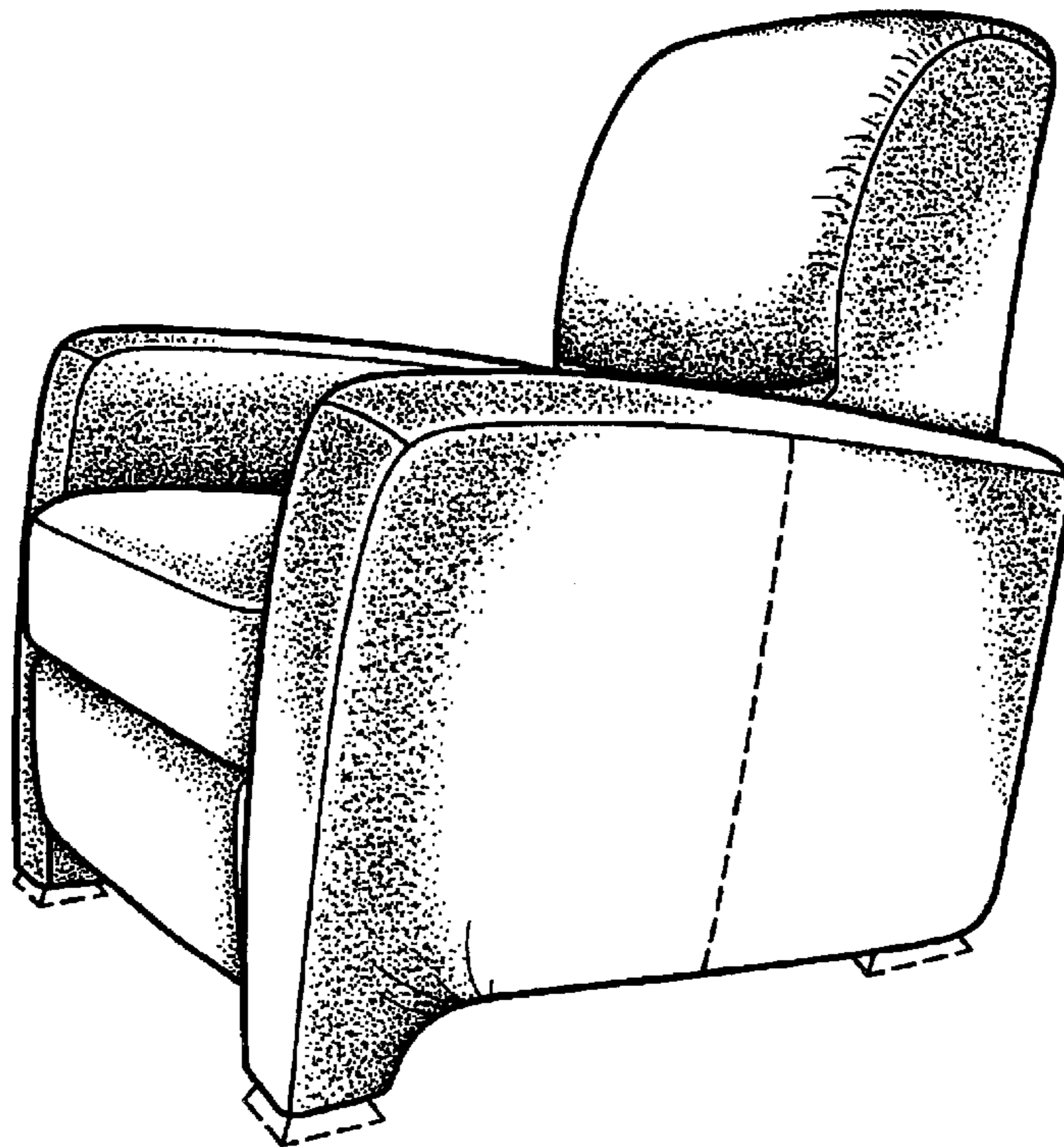
FIG. 2 is a front elevation view of the embodiment of FIG. 1;

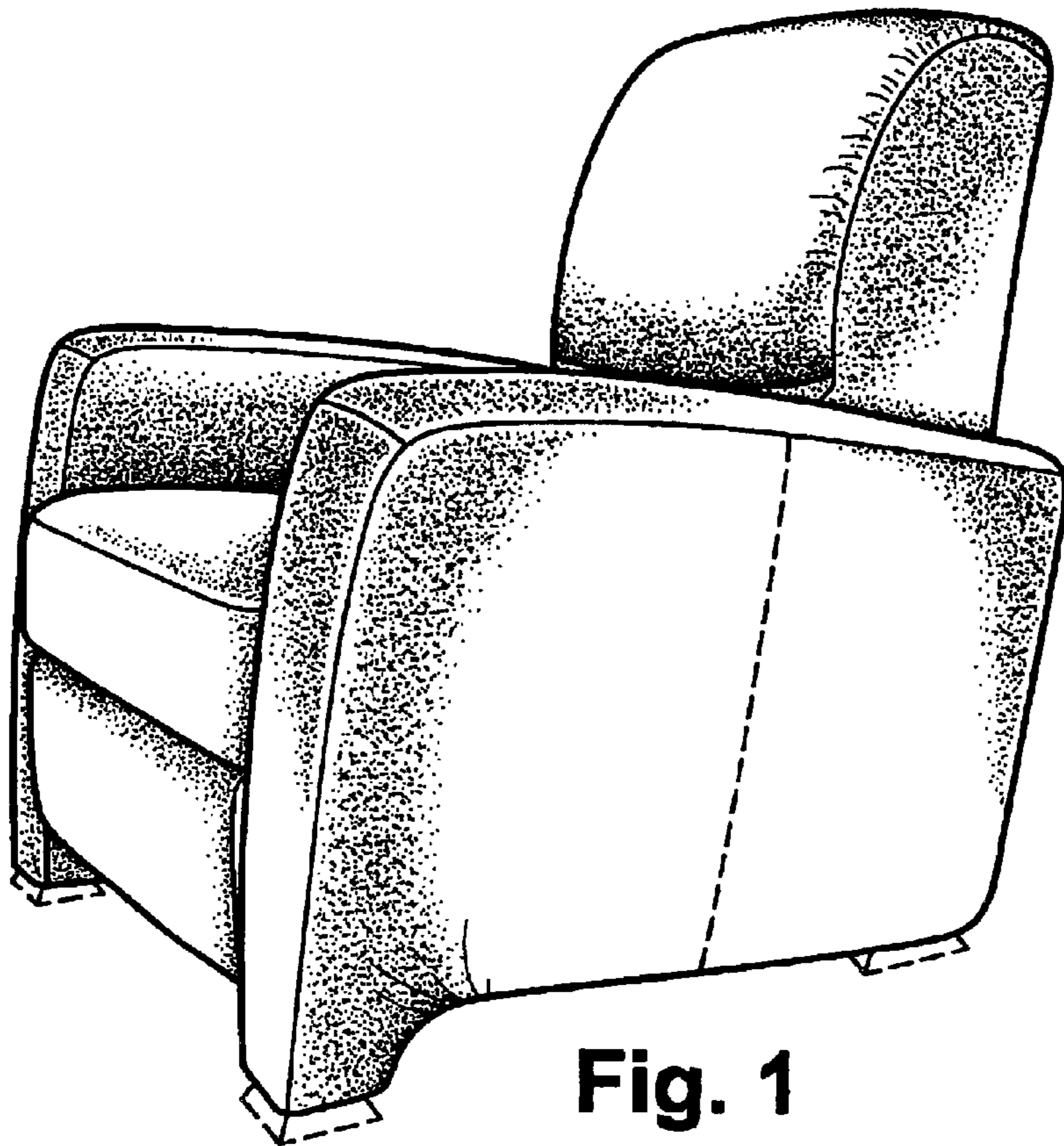

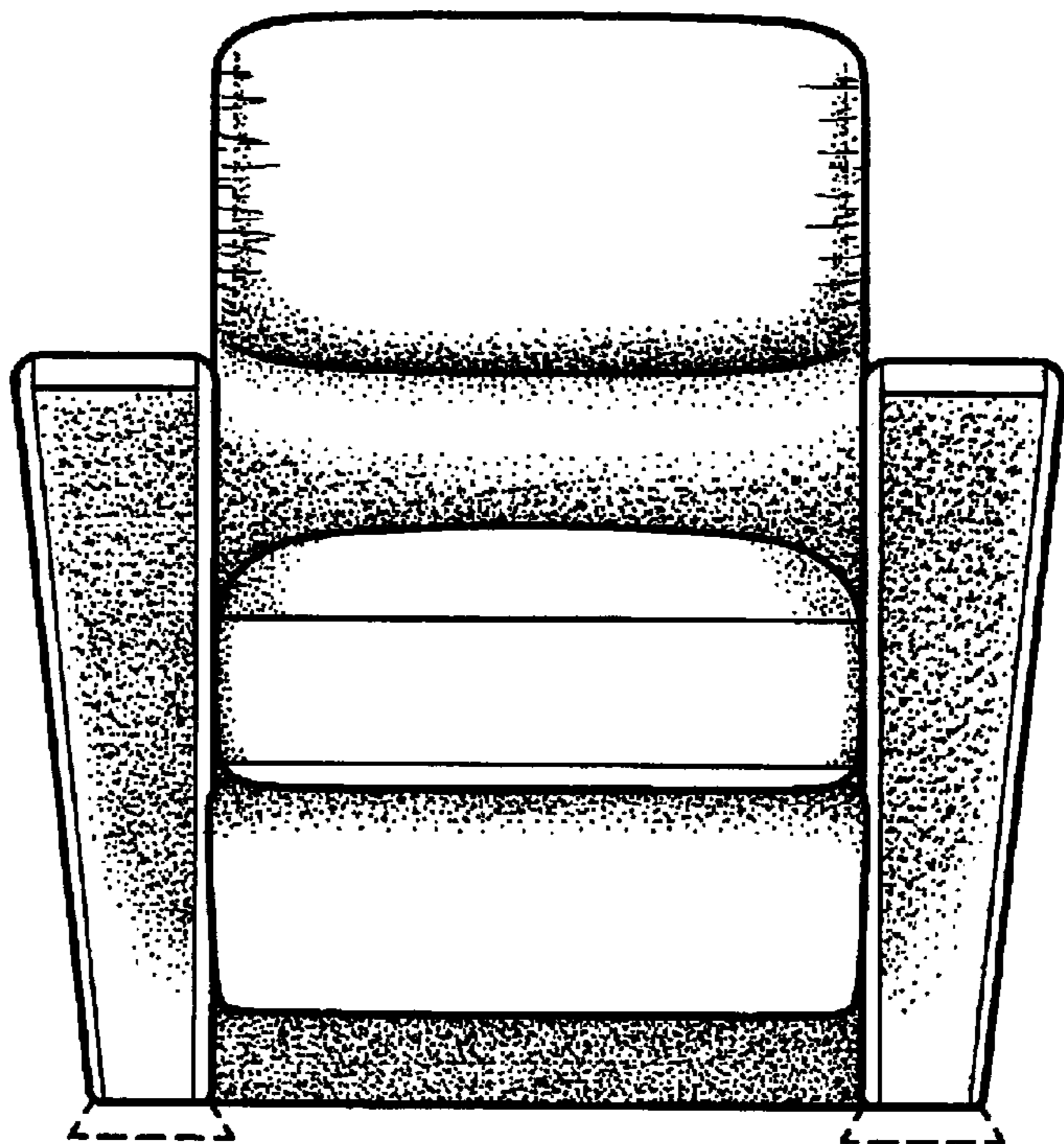

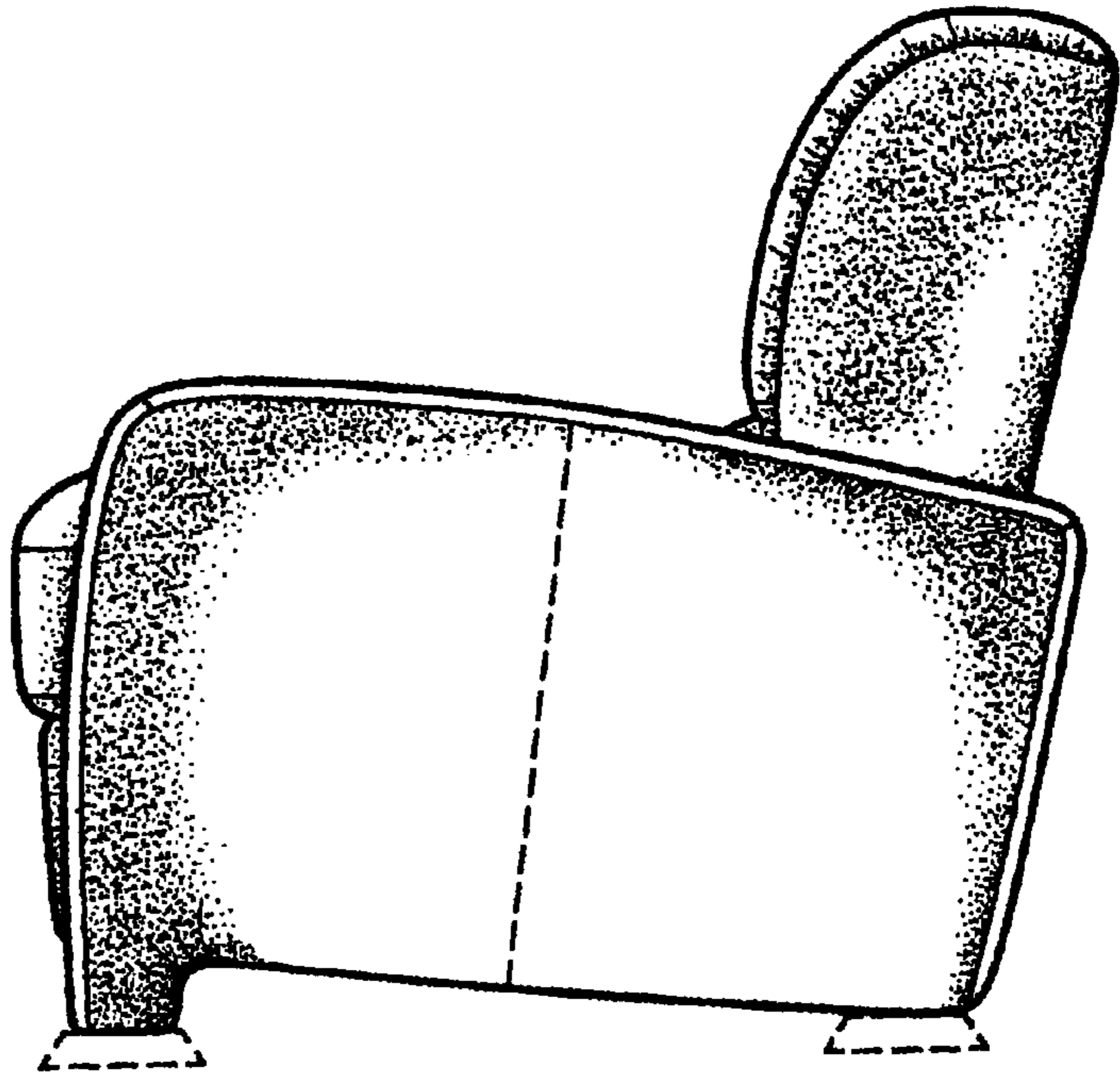

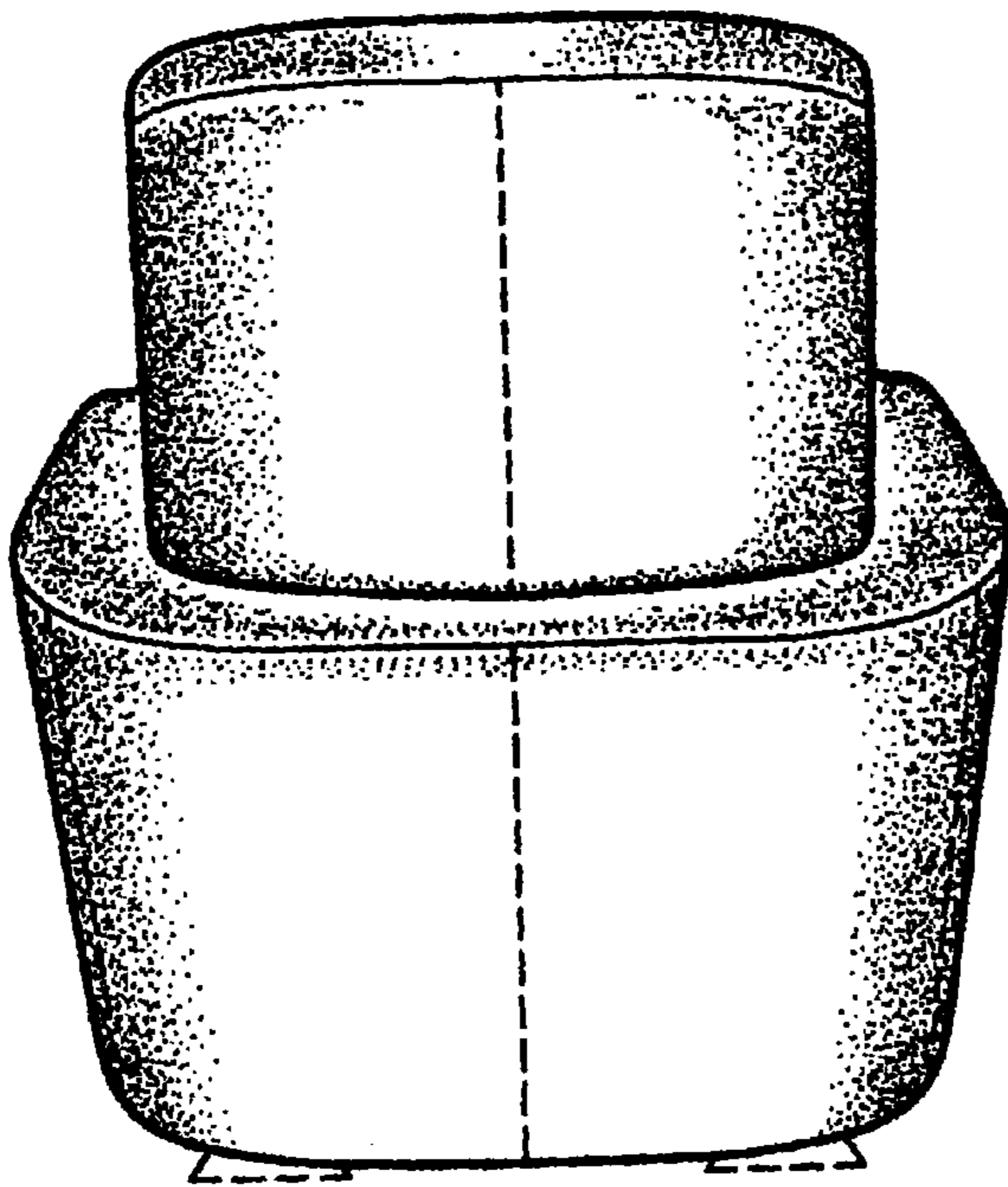
