(57) **CLAIM**

I claim the ornamental design for a plant support, as shown
and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a plant support of
the present invention;

FIG. 2 is a top, front perspective view of an alternative
configuration of the plant support of FIG. 1;

FIG. 3 is a front view of the plant support of FIG. 1;

FIG. 4 is a rear view of the plant support of FIG. 1;

FIG. 5 is a right side view of the plant support of FIG. 1, the
left side view being a mirror image of the right side view;

FIG. 6 is a top view of the plant support of FIG. 1;

FIG. 7 is a bottom view of the plant support of FIG. 1;

FIG. 8 is a top, front perspective view of an alternative
embodiment of a plant support of the present invention;

FIG. 9 is a top, front perspective view of an alternative
configuration of the plant support of FIG. 8;

FIG. 10 is a front view of the plant support of FIG. 8;

FIG. 11 is a rear view of the plant support of FIG. 8;

FIG. 12 is a right side view of the plant support of FIG. 8, the
left side view being a mirror image of the right side view;

FIG. 13 is a top view of the plant support of FIG. 8;

FIG. 14 is a bottom view of the plant support of FIG. 8;

FIG. 15 is a top, front perspective view of another alternative
embodiment of a plant support of the present invention;

FIG. 16 is a top, front perspective view of an alternative
configuration of the plant support of FIG. 15;

FIG. 17 is a front view of the plant support of FIG. 15;

FIG. 18 is a rear view of the plant support of FIG. 15;

FIG. 19 is a right side view of the plant support of FIG. 15, the
left side view being a mirror image of the right side view;

FIG. 20 is a top view of the plant support of FIG. 15; and,

FIG. 21 is a bottom view of the plant support of FIG. 15.

The various embodiments of the plant supports of the
present invention are shown broken away in FIGS. 3–5,
10–12, and 17–19 to indicate indeterminate length.

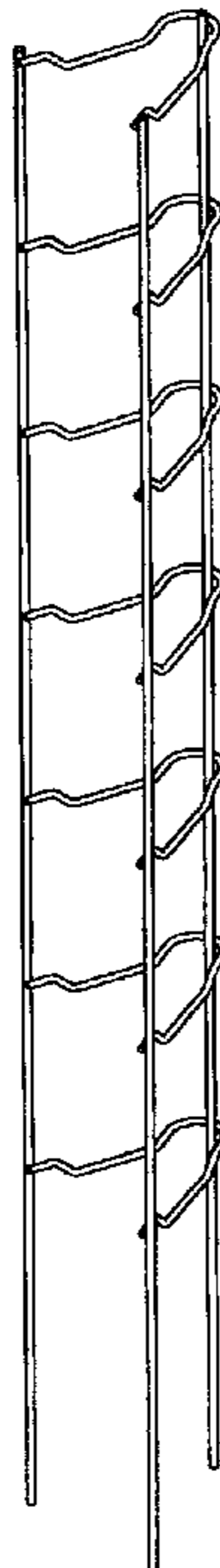

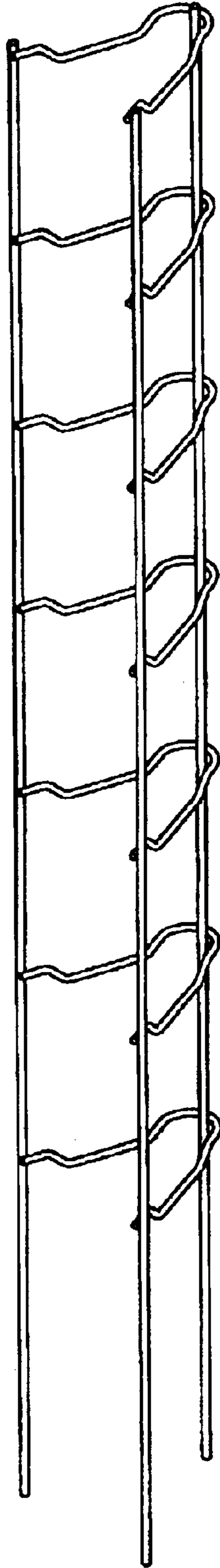

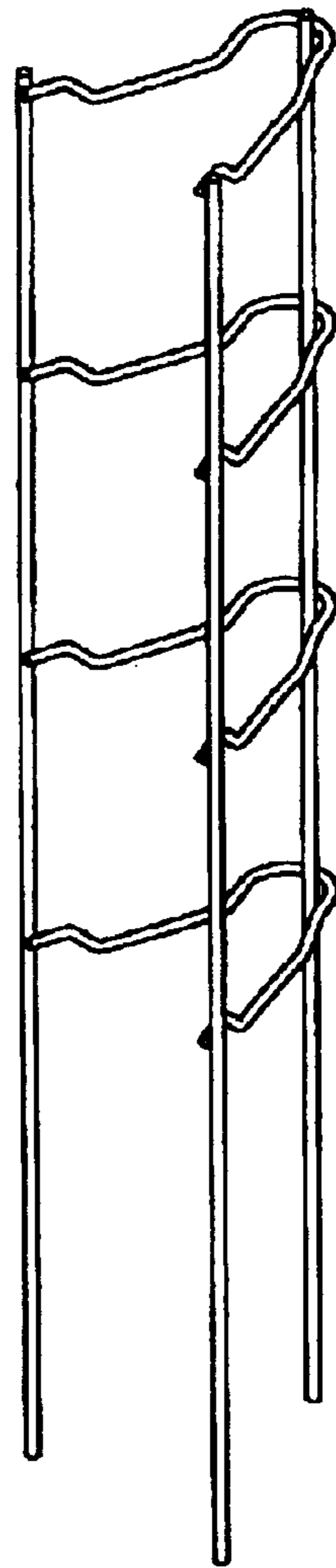

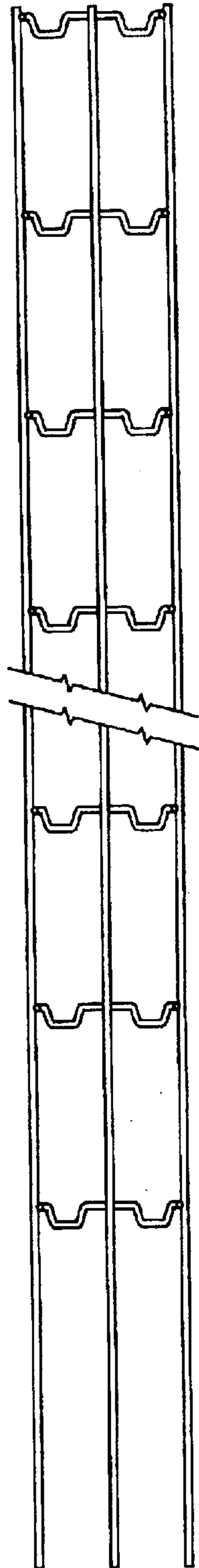

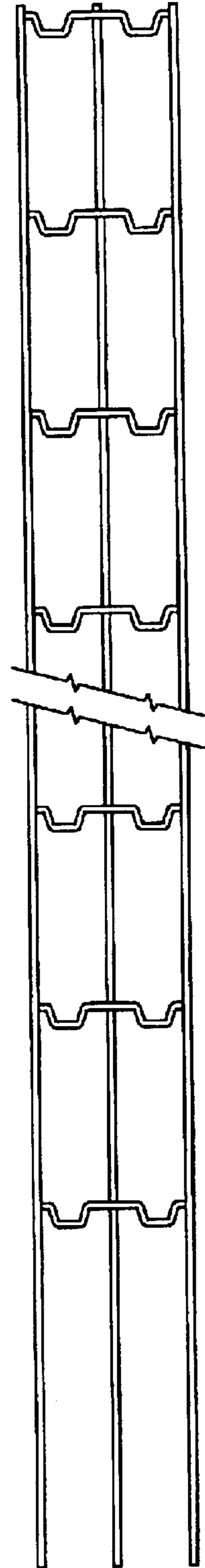

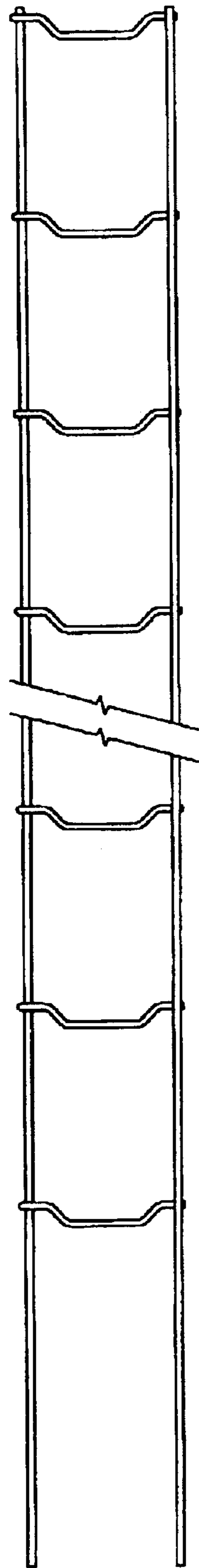

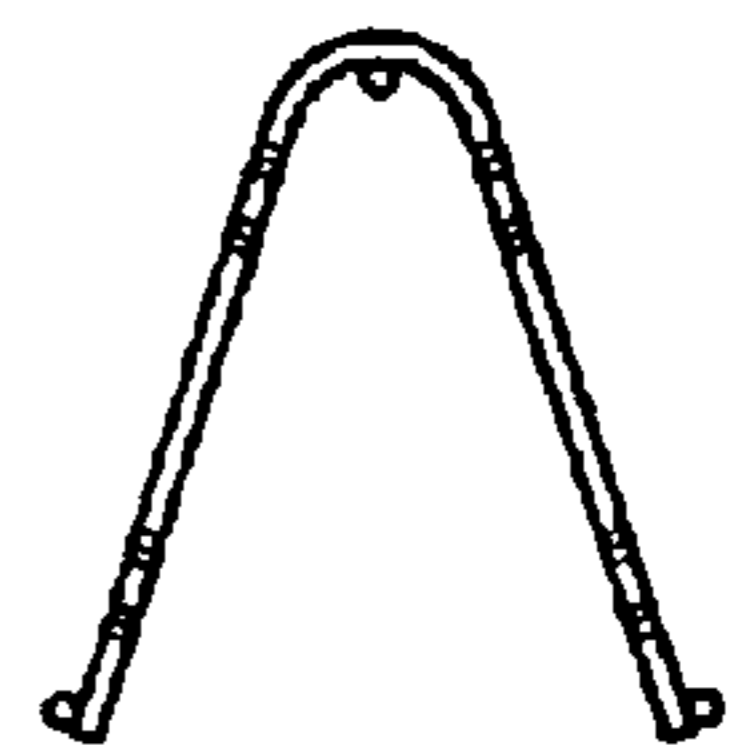

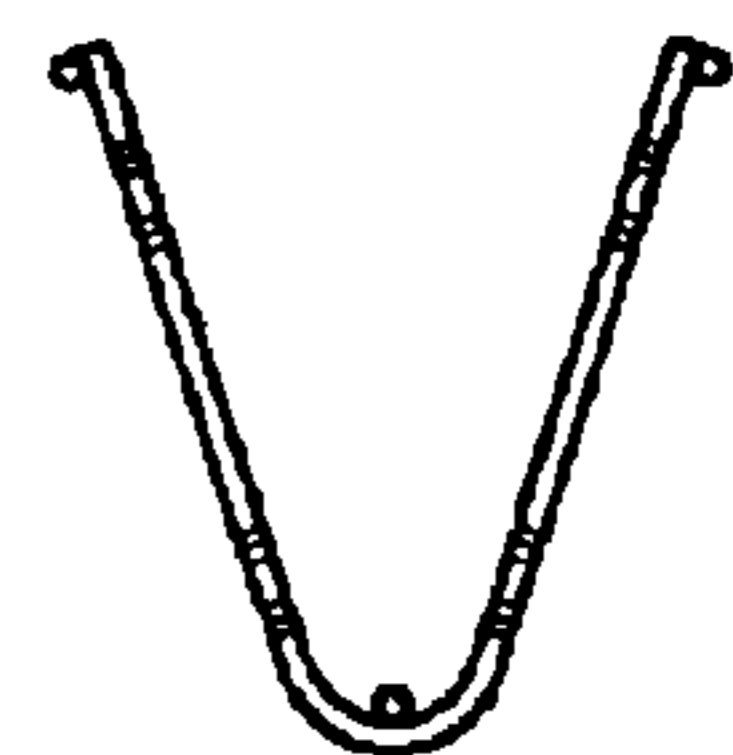

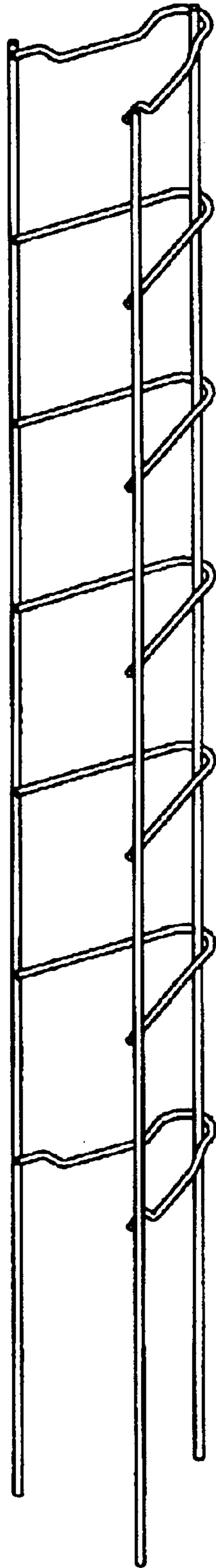

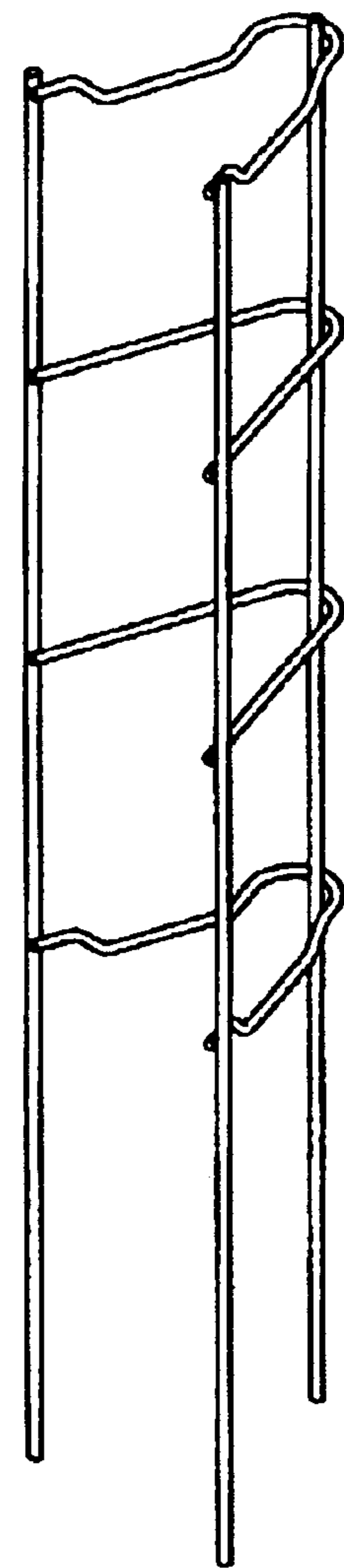

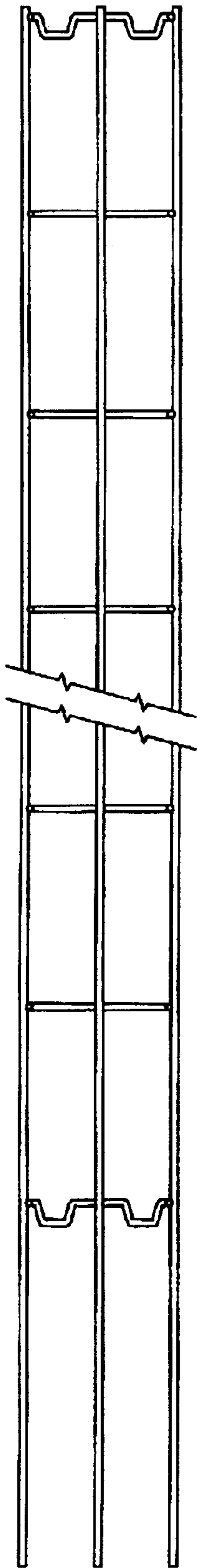

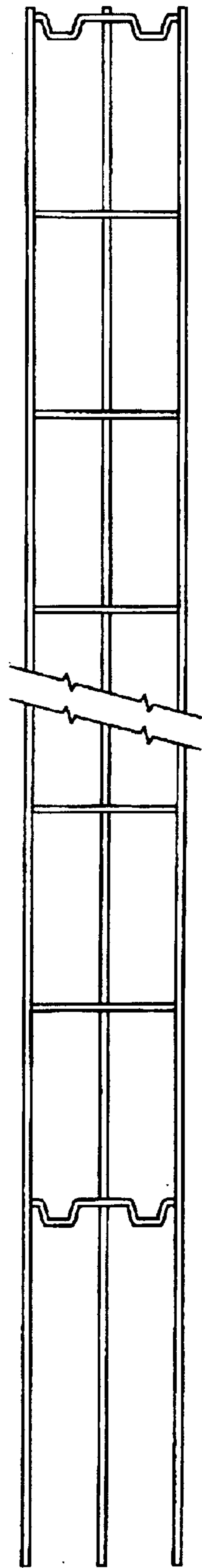

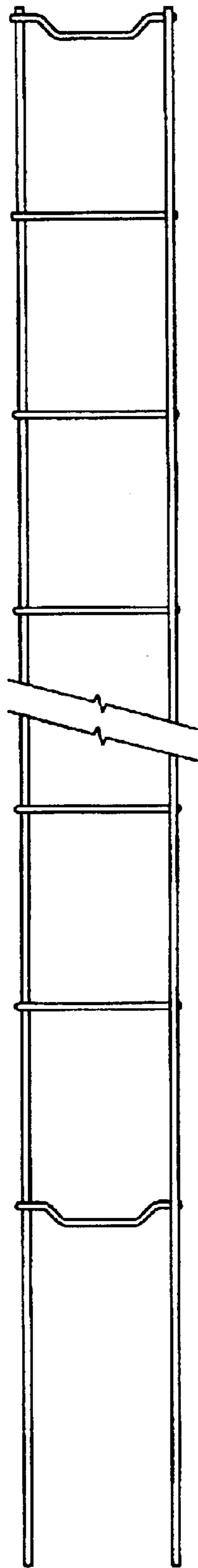

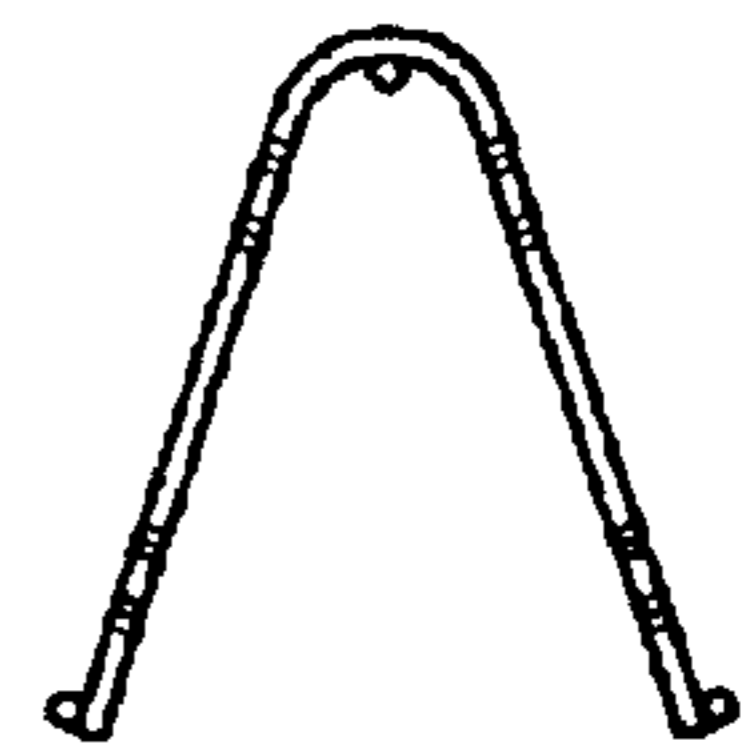

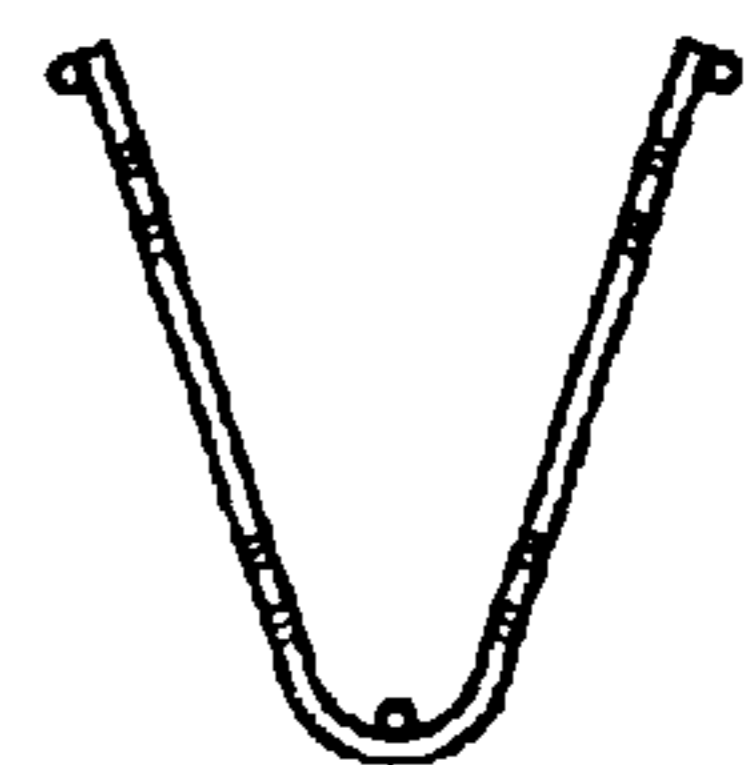

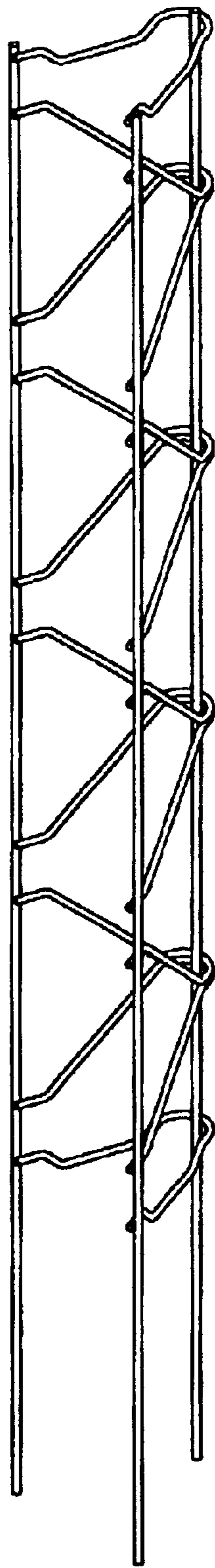

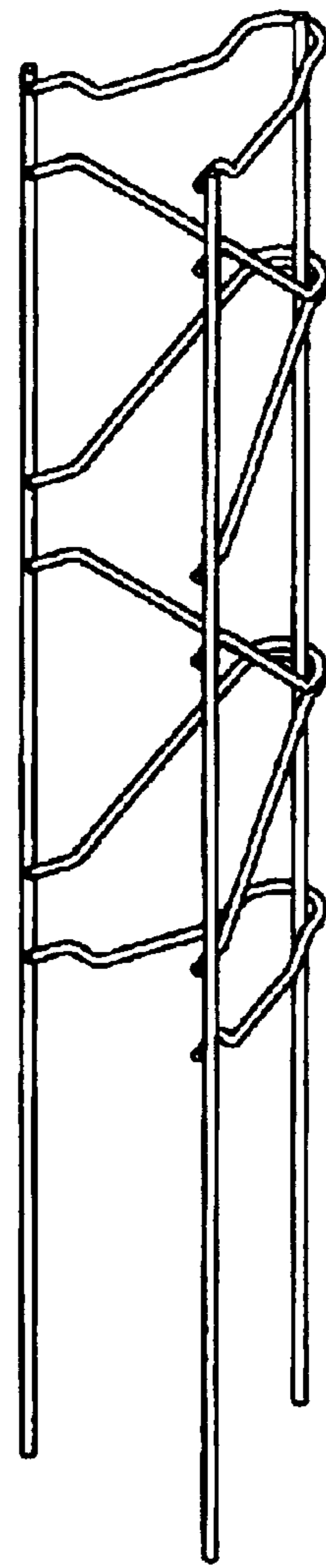

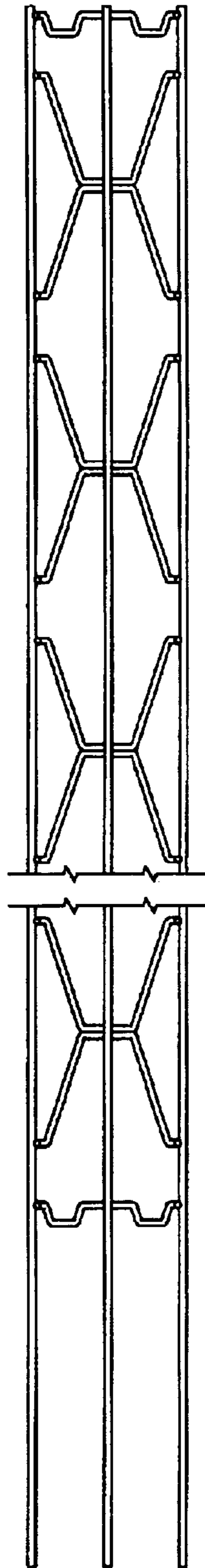

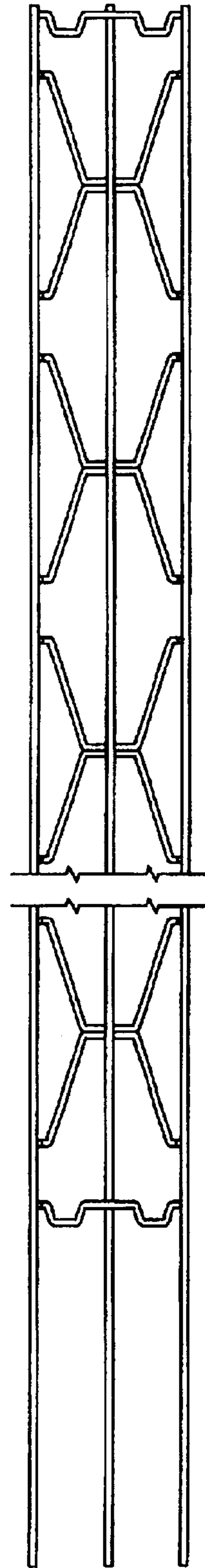

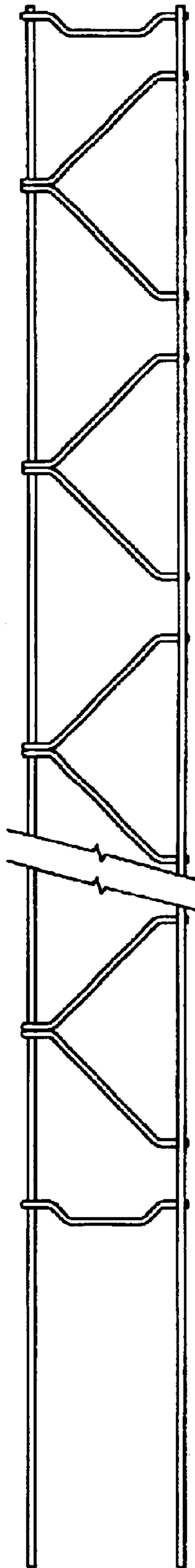

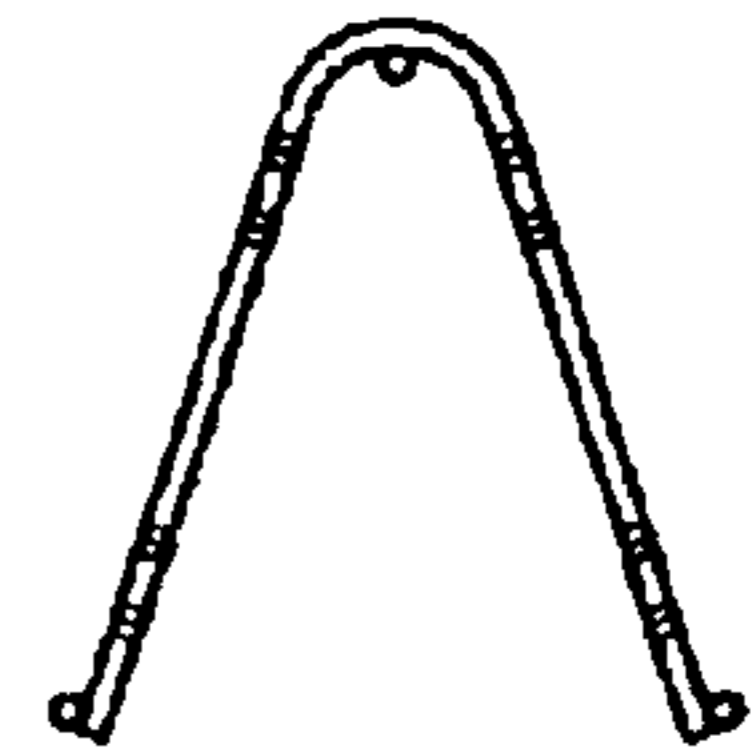
