FIG. 6 is a rear elevational view of a medical device package according to an embodiment of the invention; and,

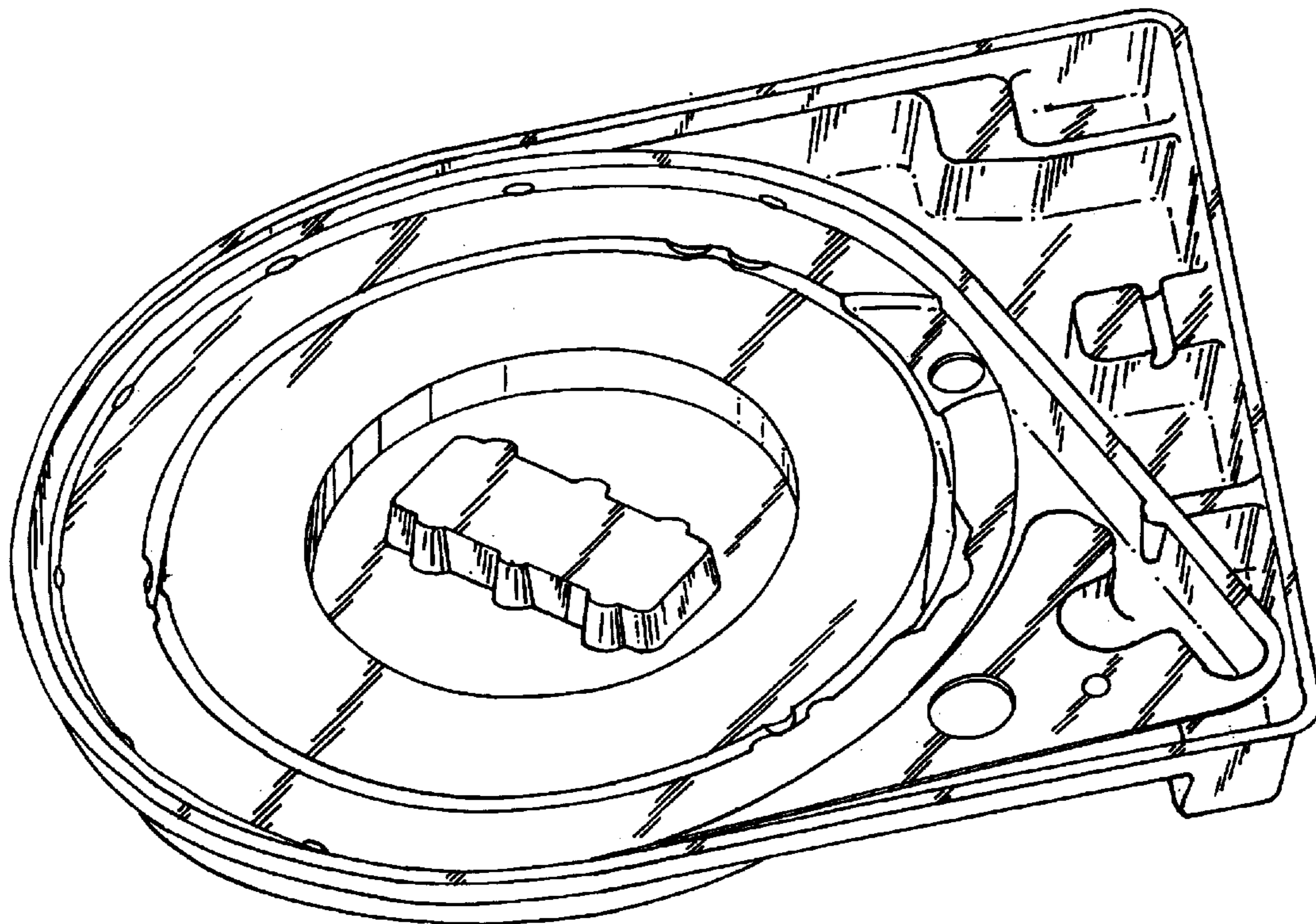
FIG. 7 is a front elevational view of a medical device package according to an embodiment of the invention.

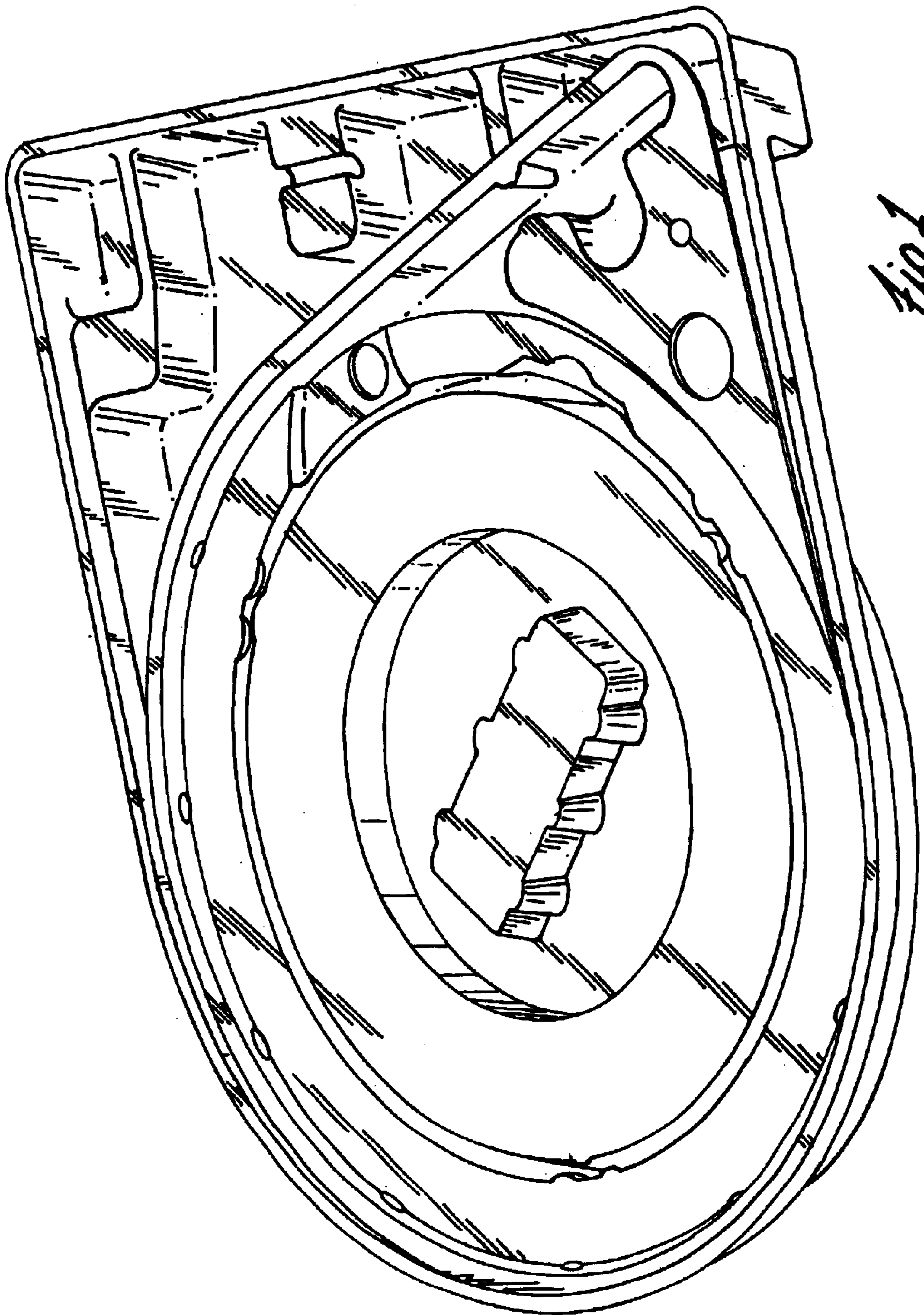

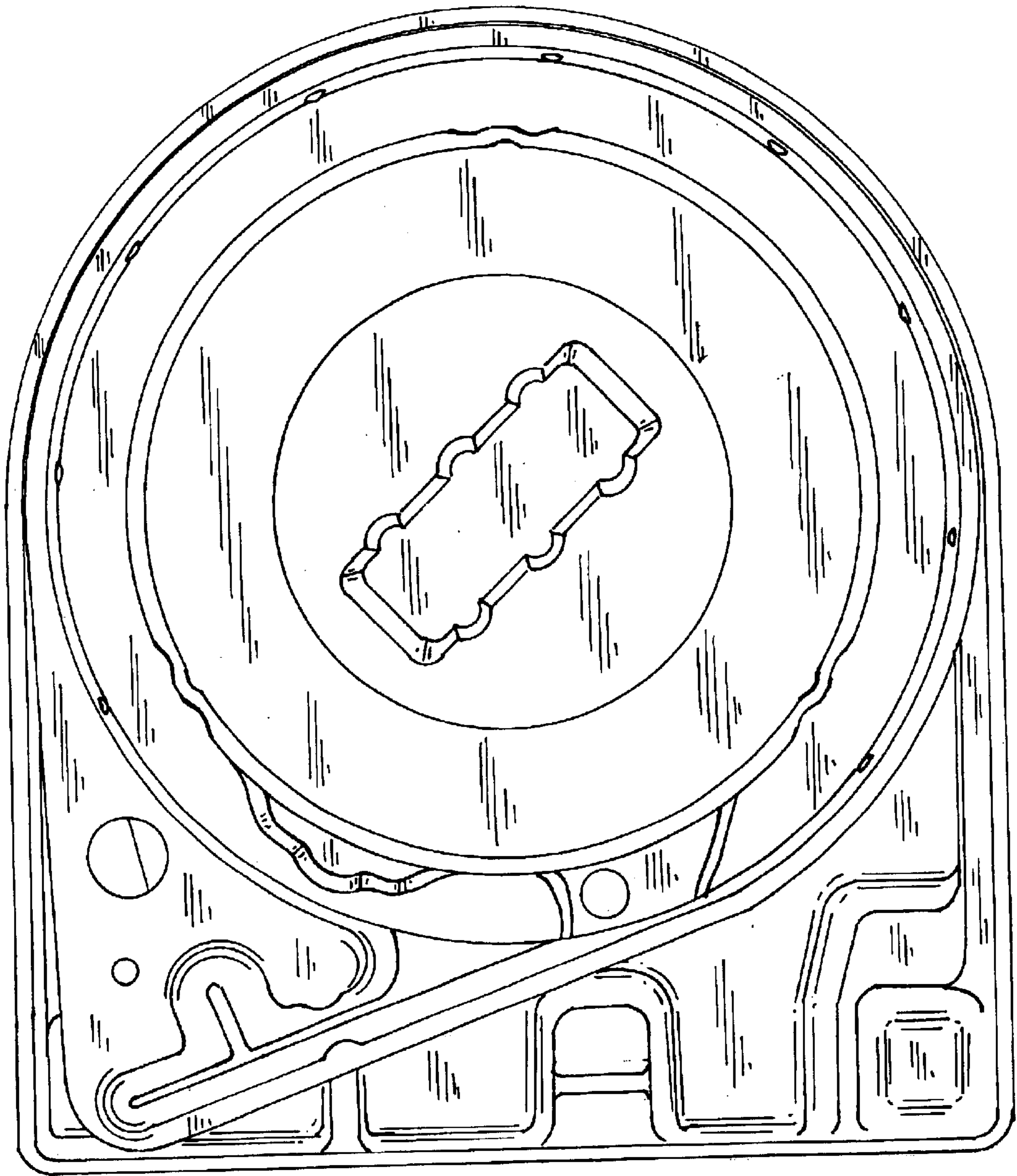

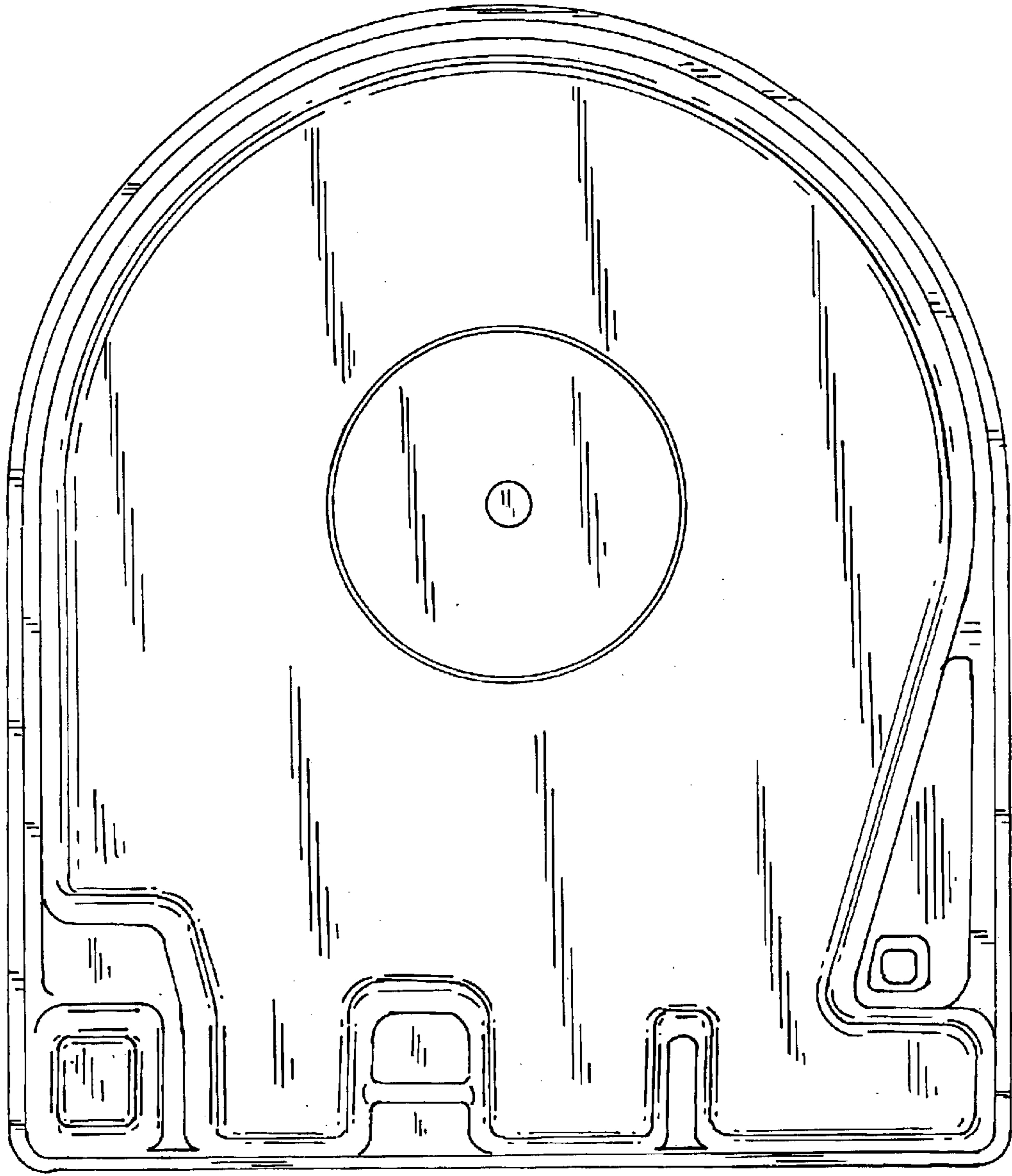

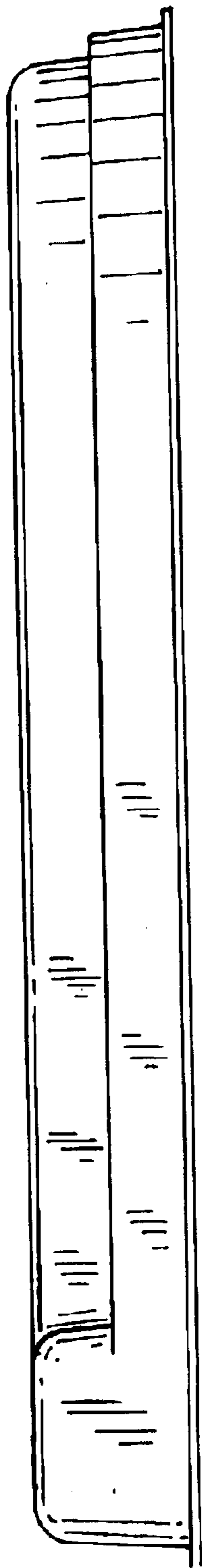

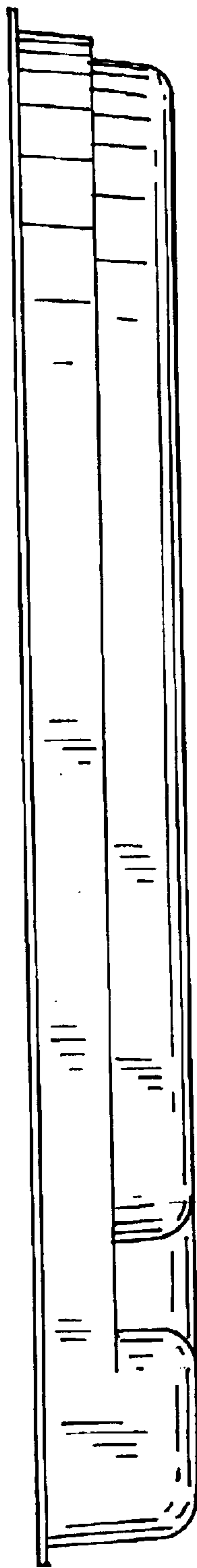

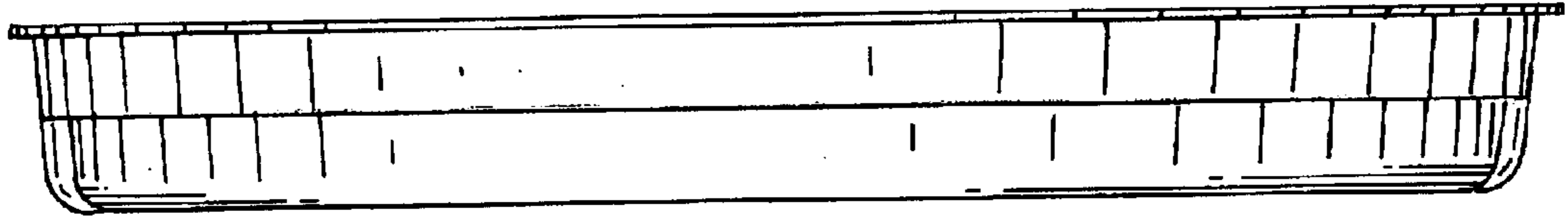

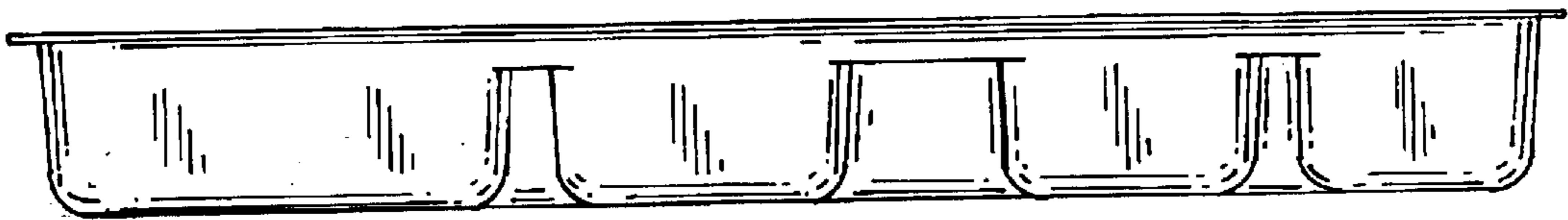
