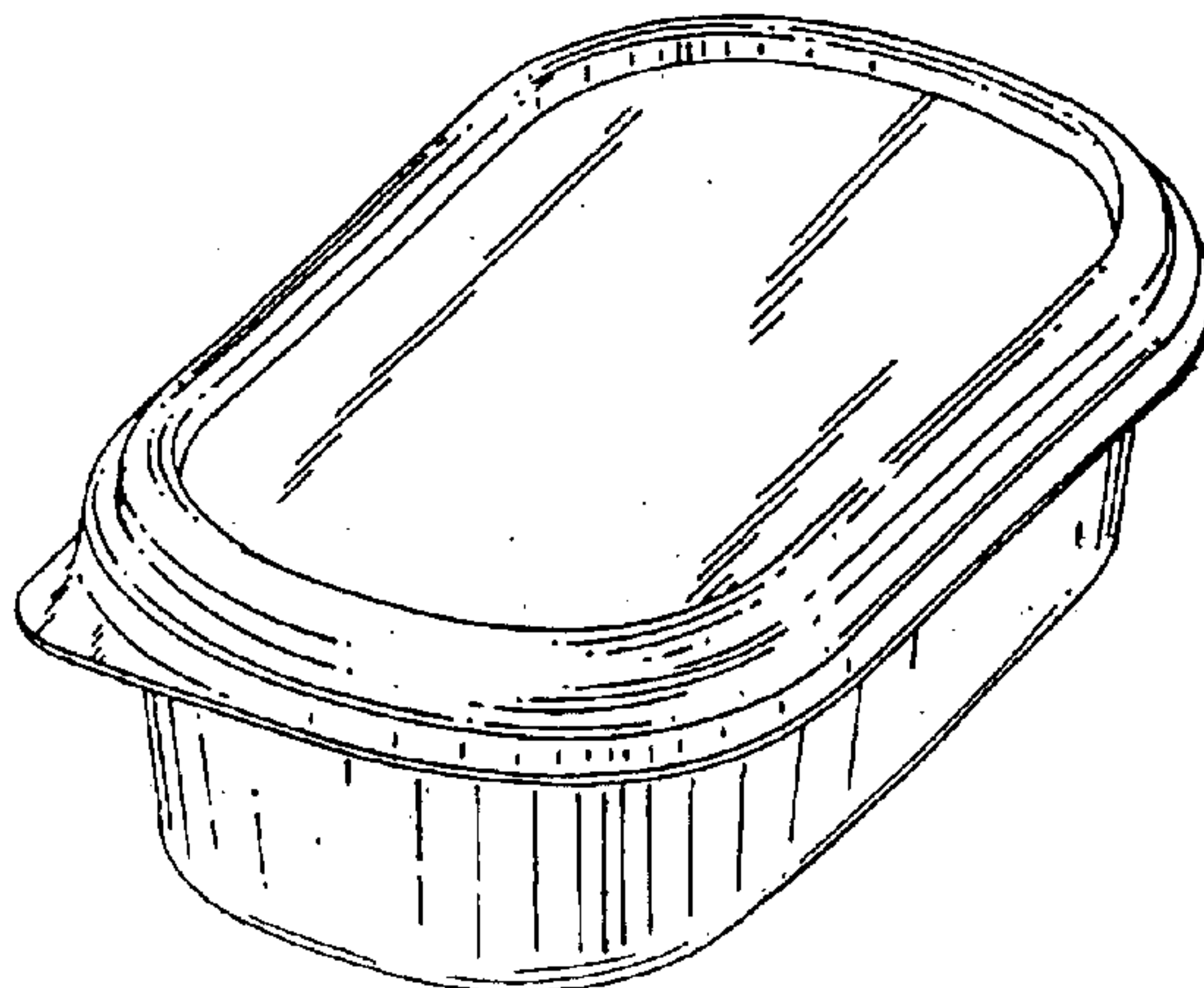
(57) **CLAIM**

The ornamental design for a food package, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of the food package of the present invention;  
FIG. 2 is a top plan view of the embodiment;

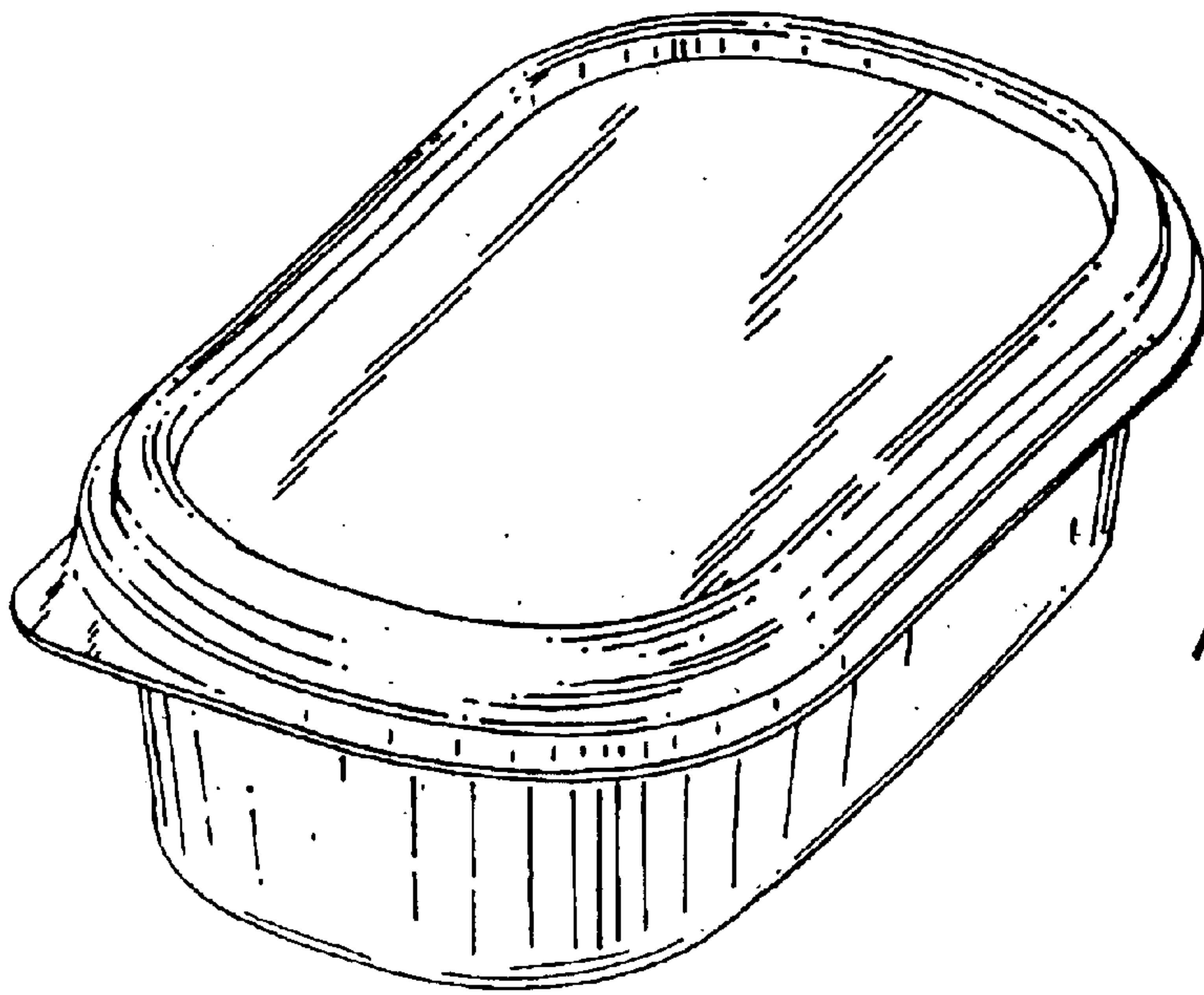

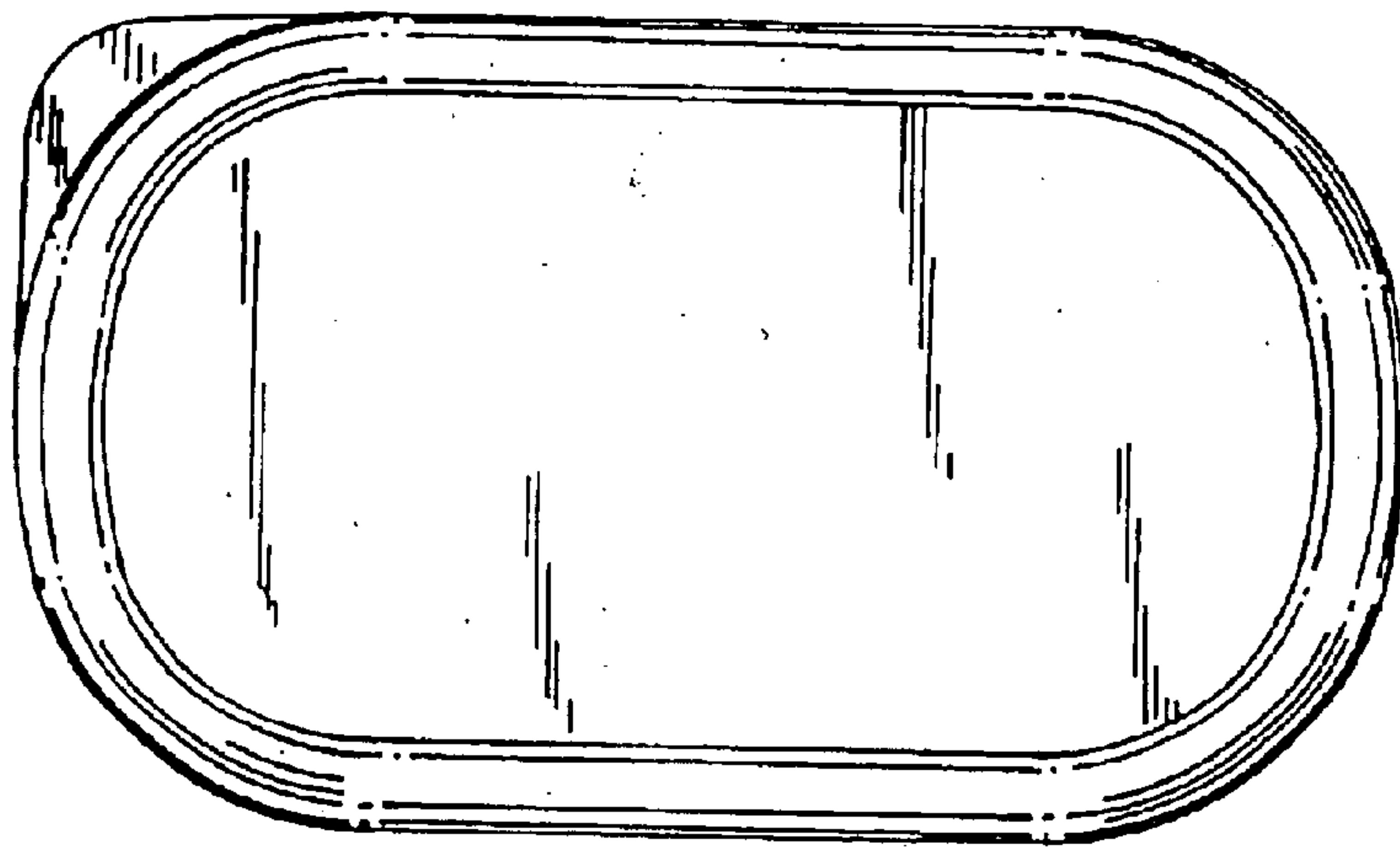

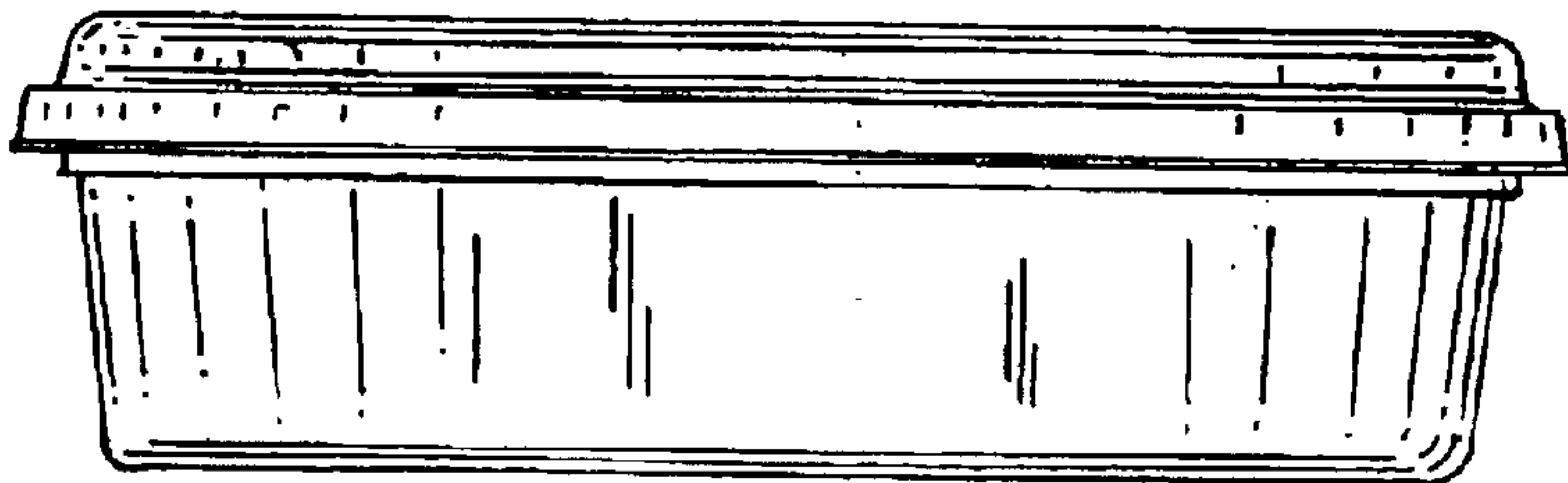




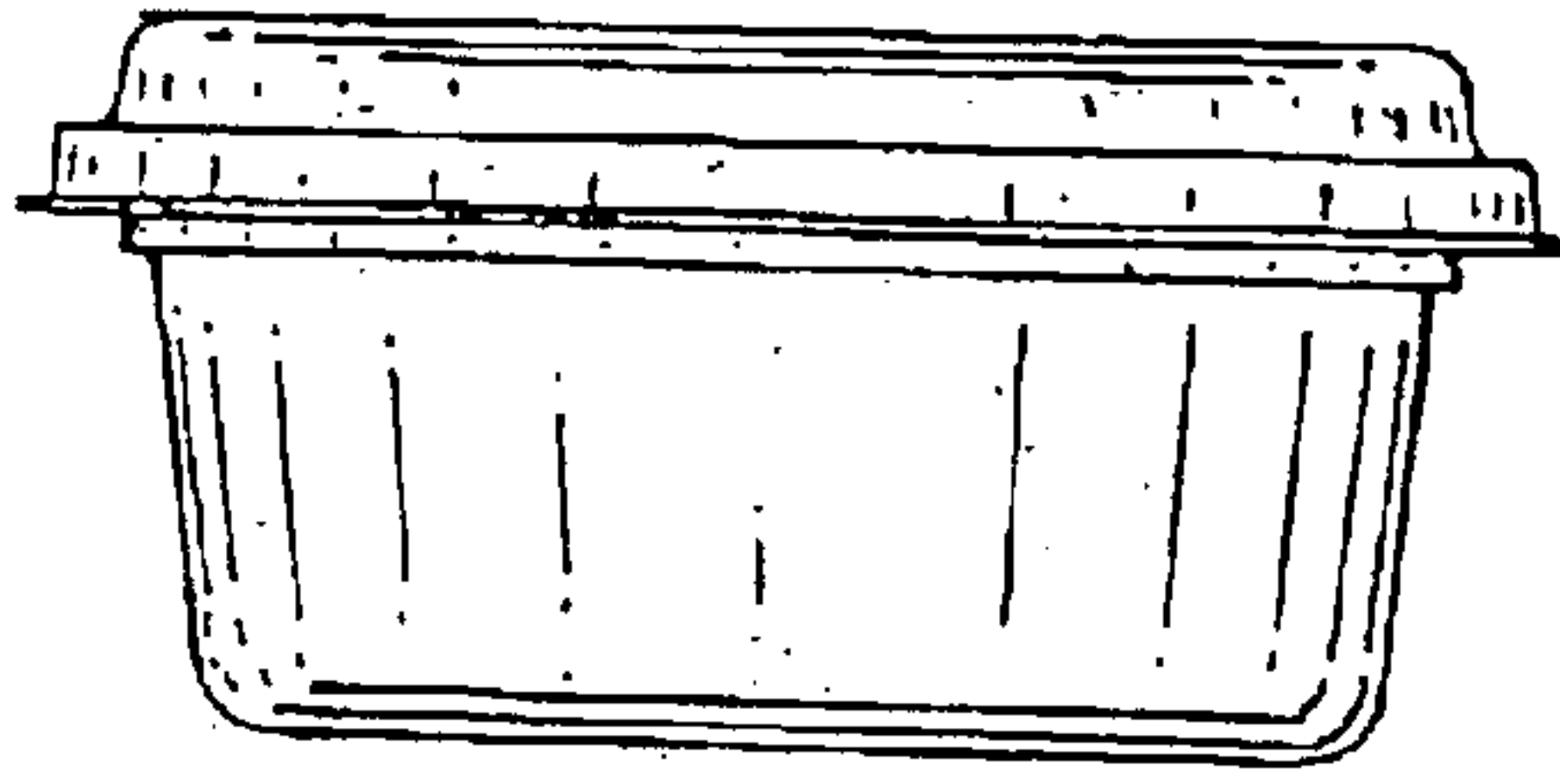

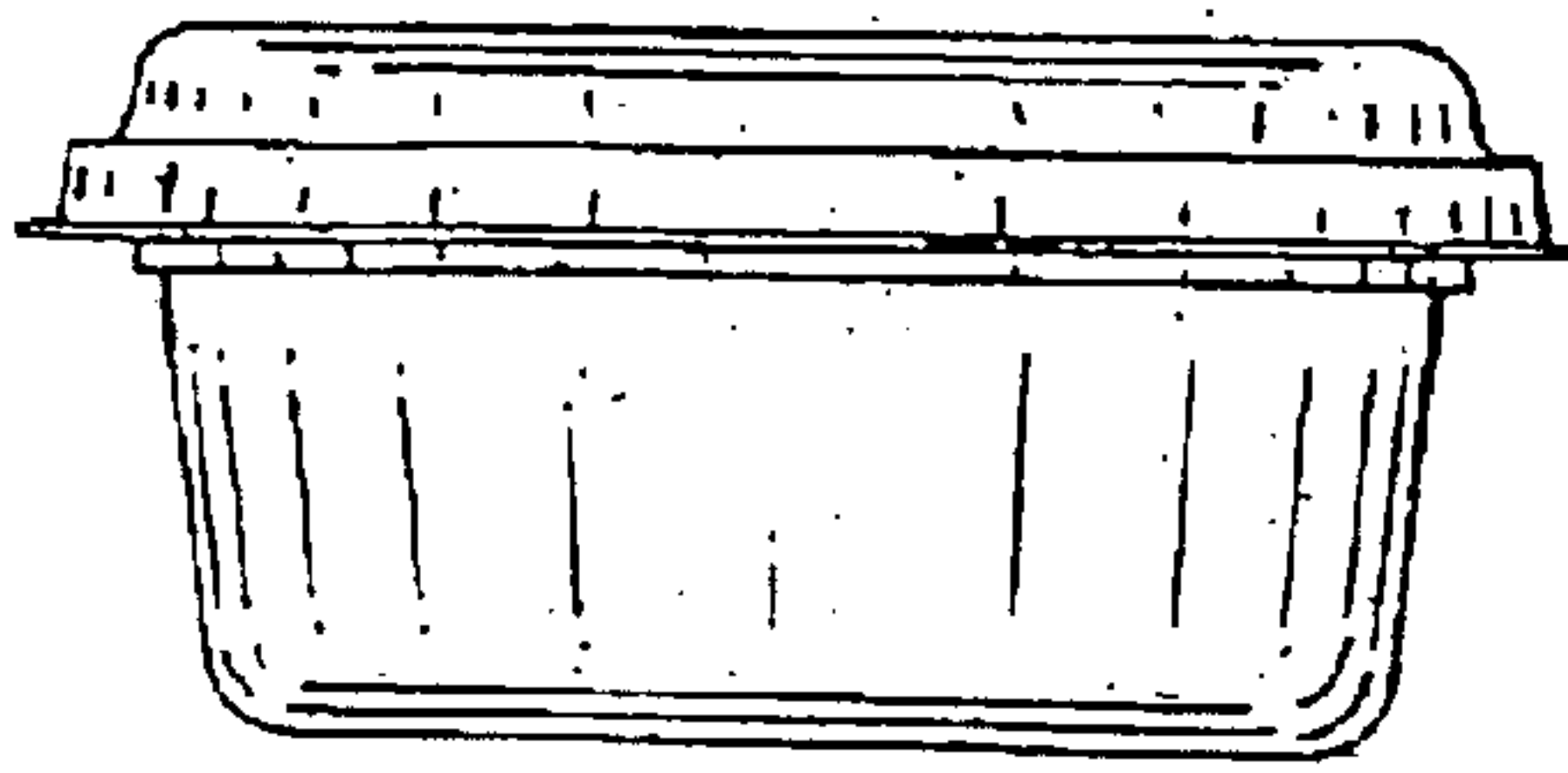

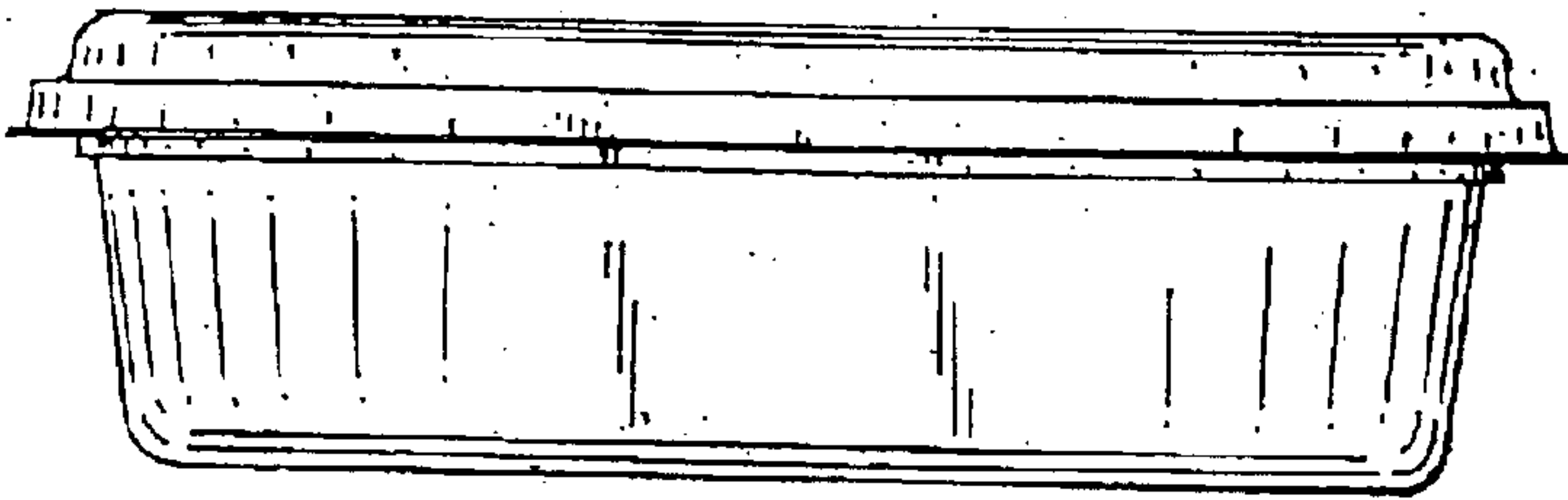

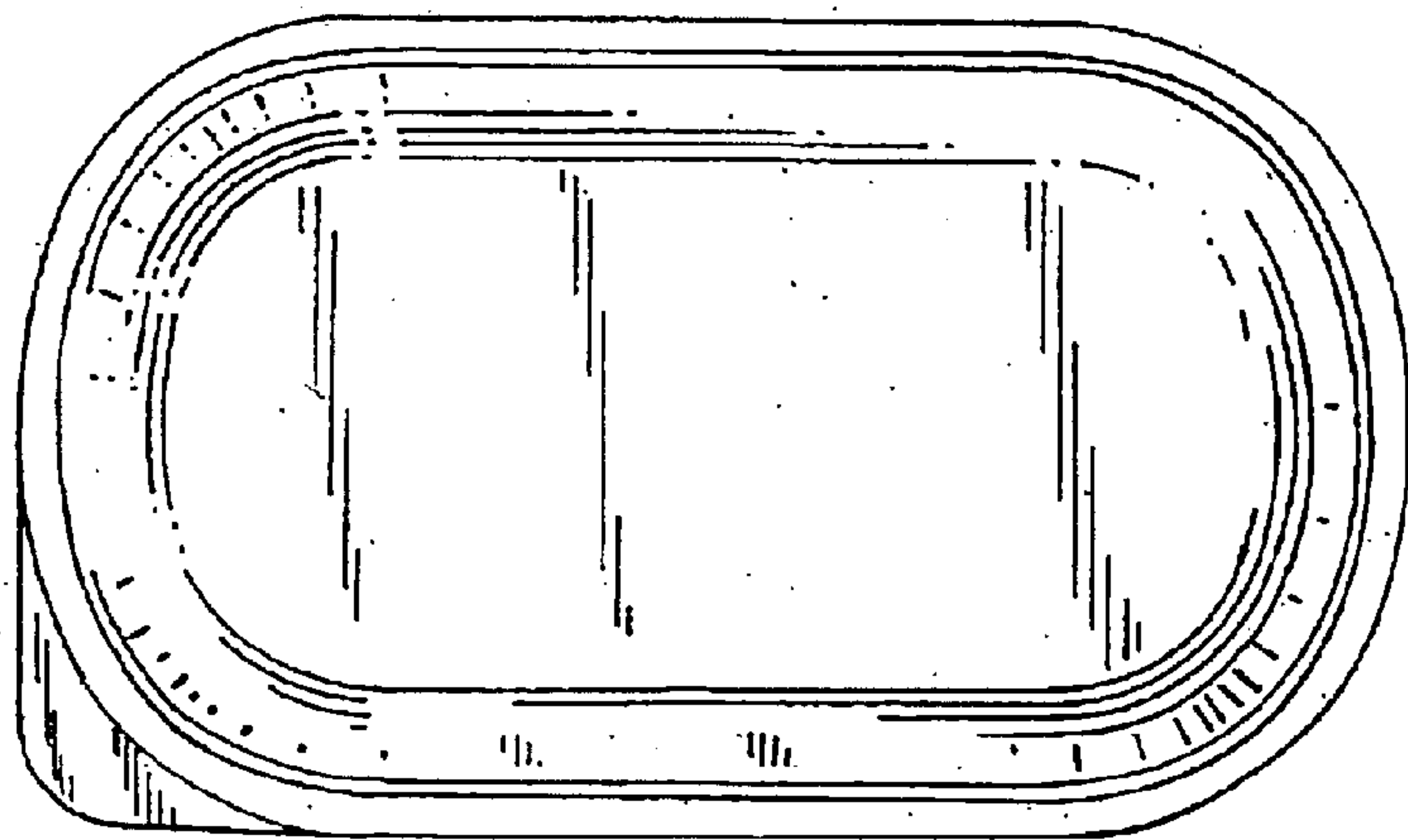

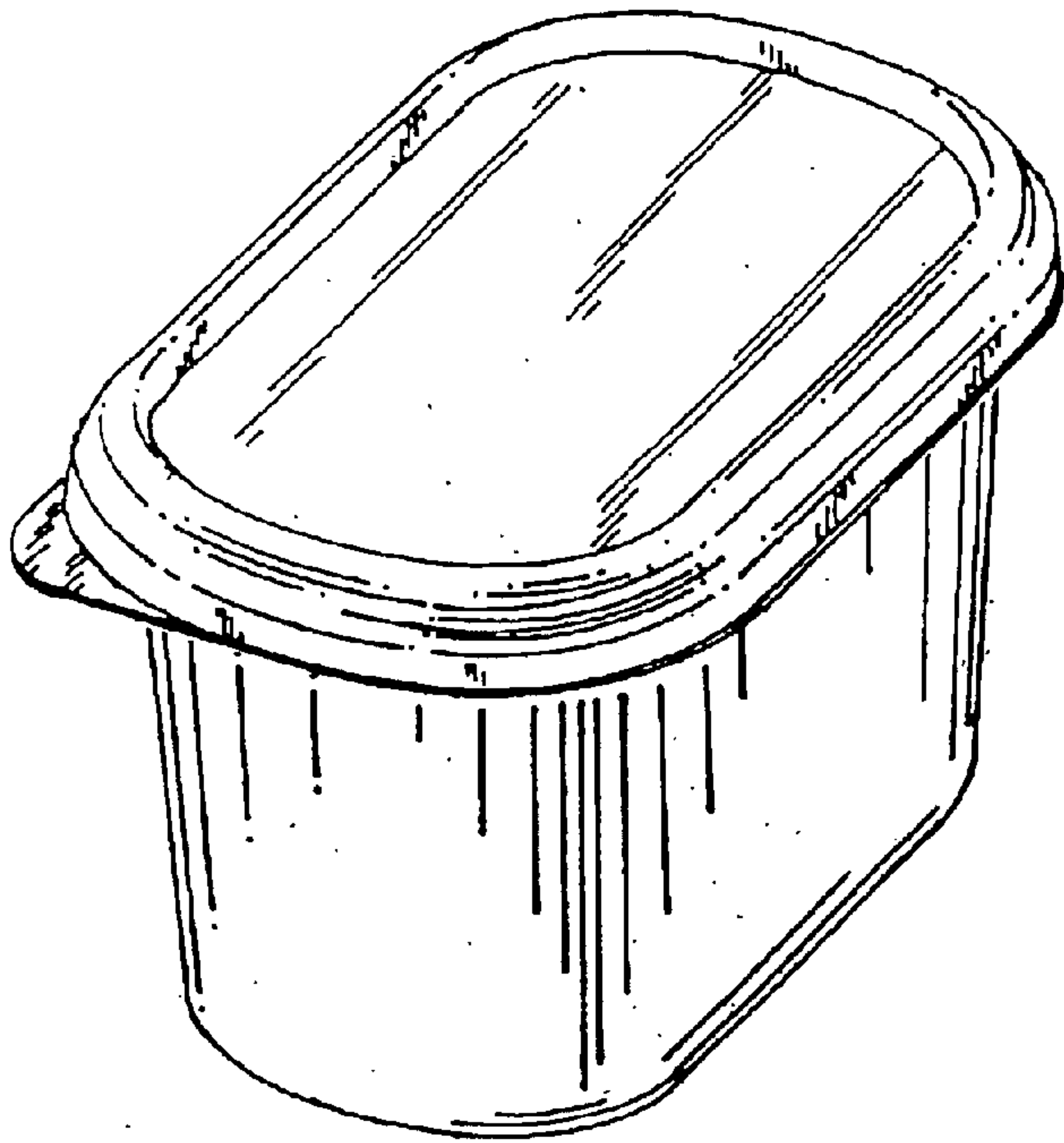

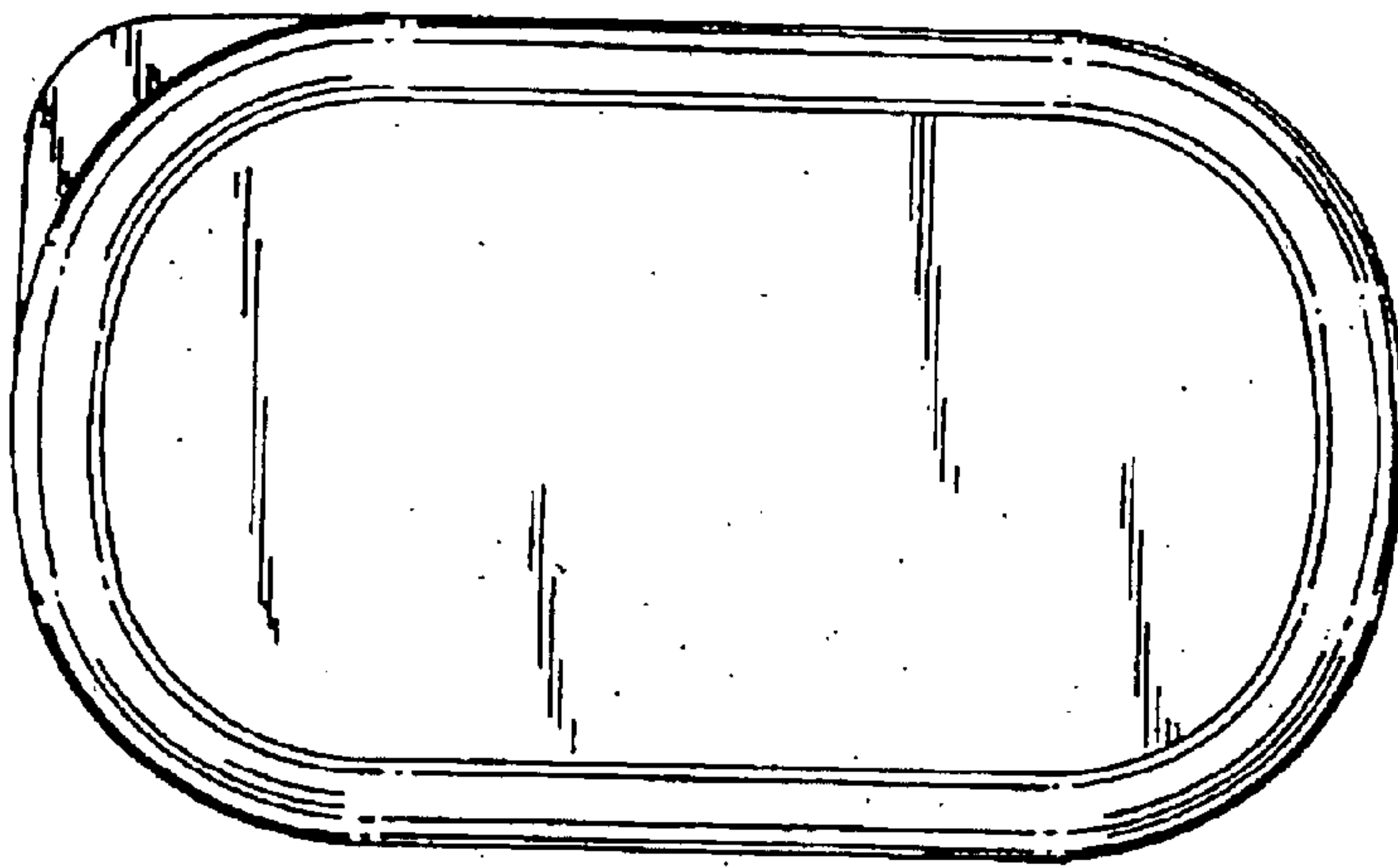

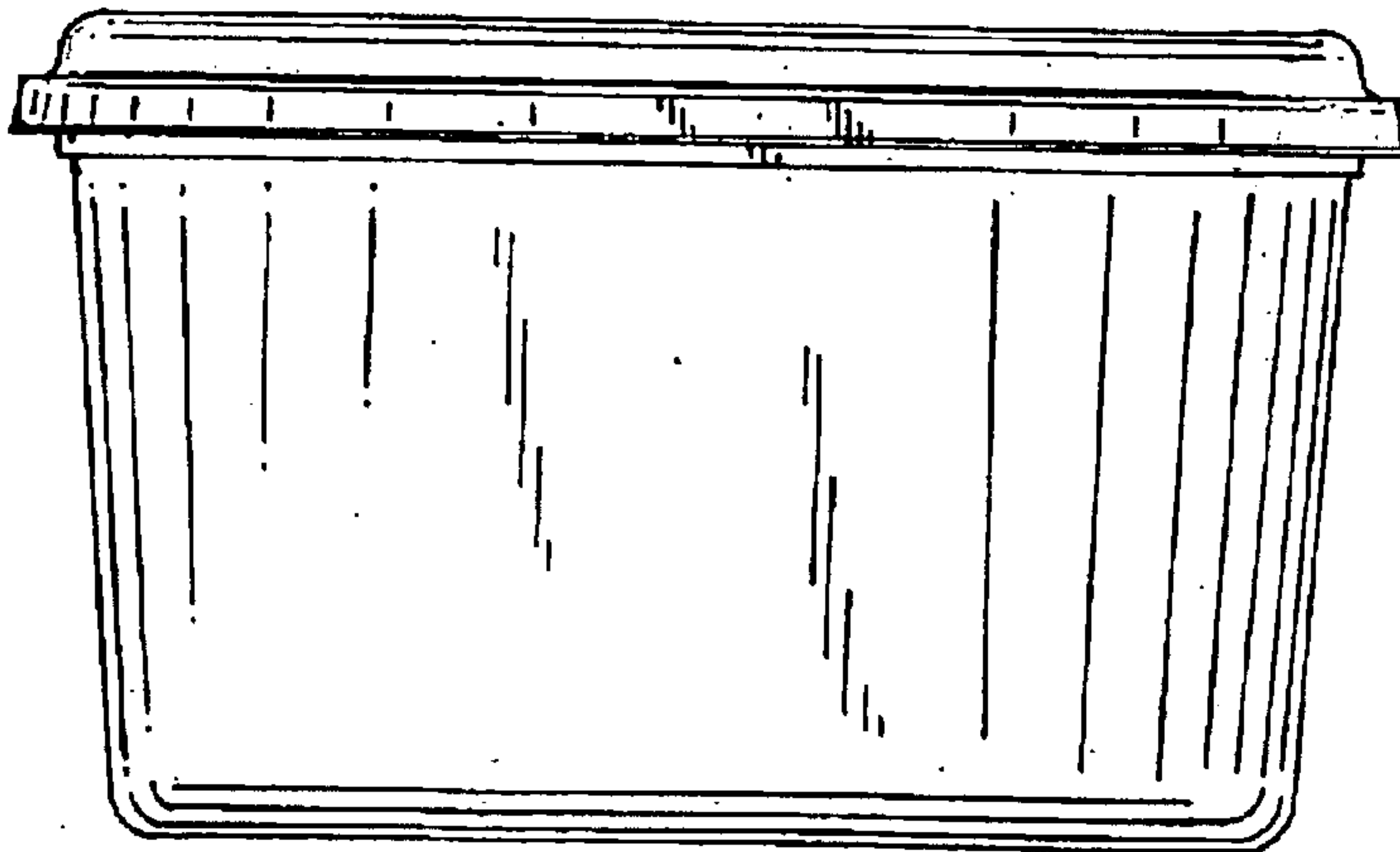

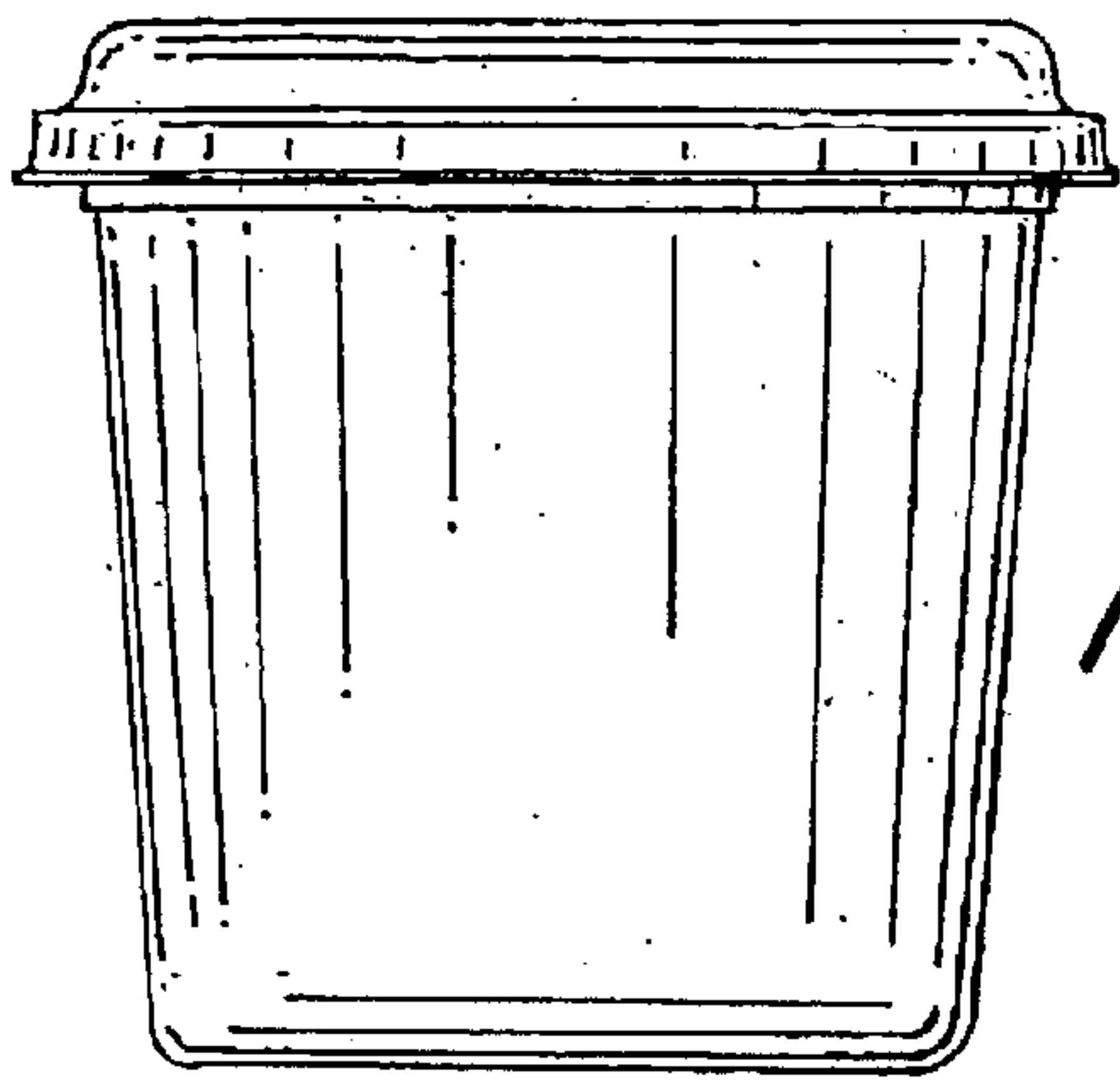

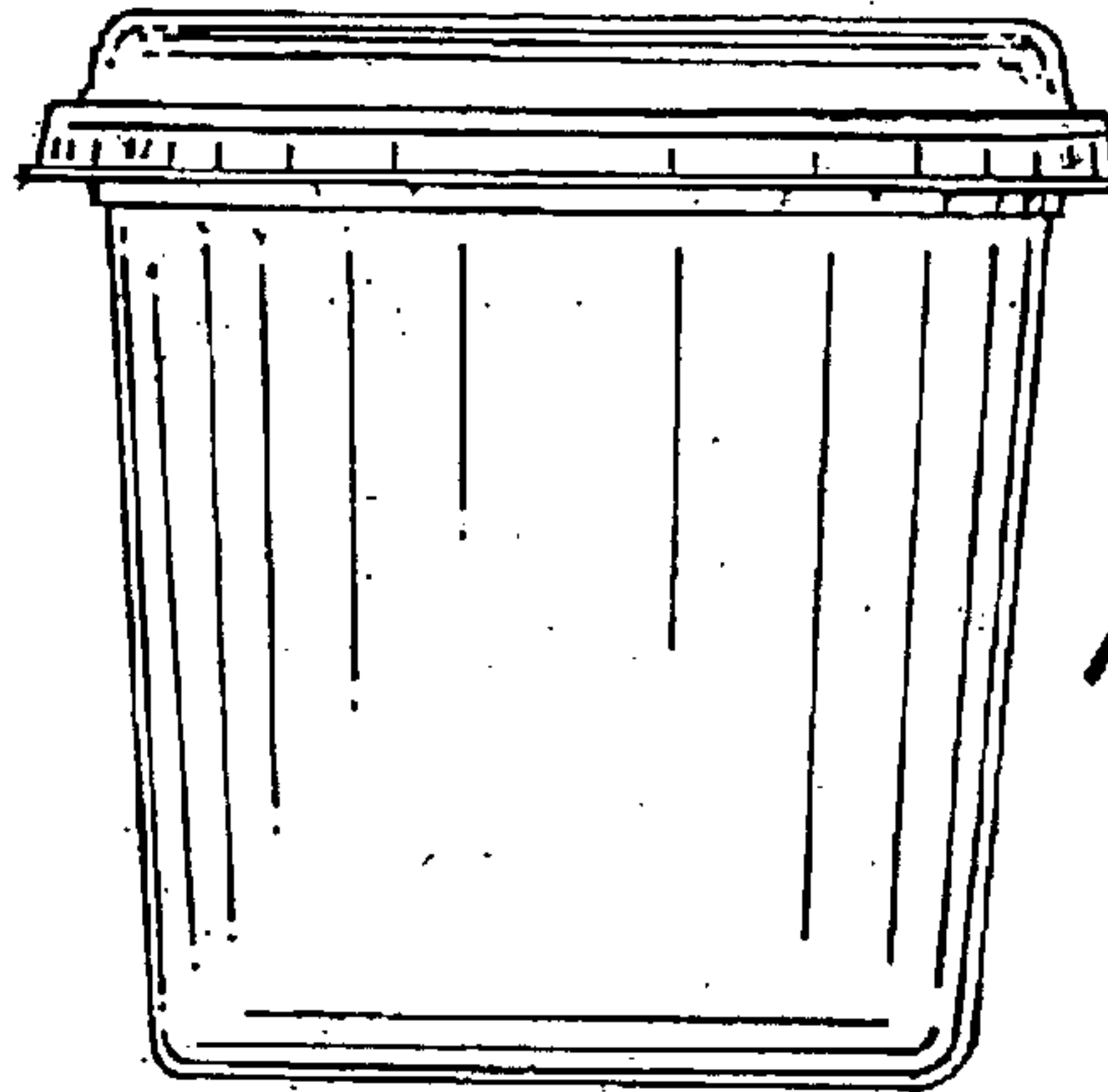

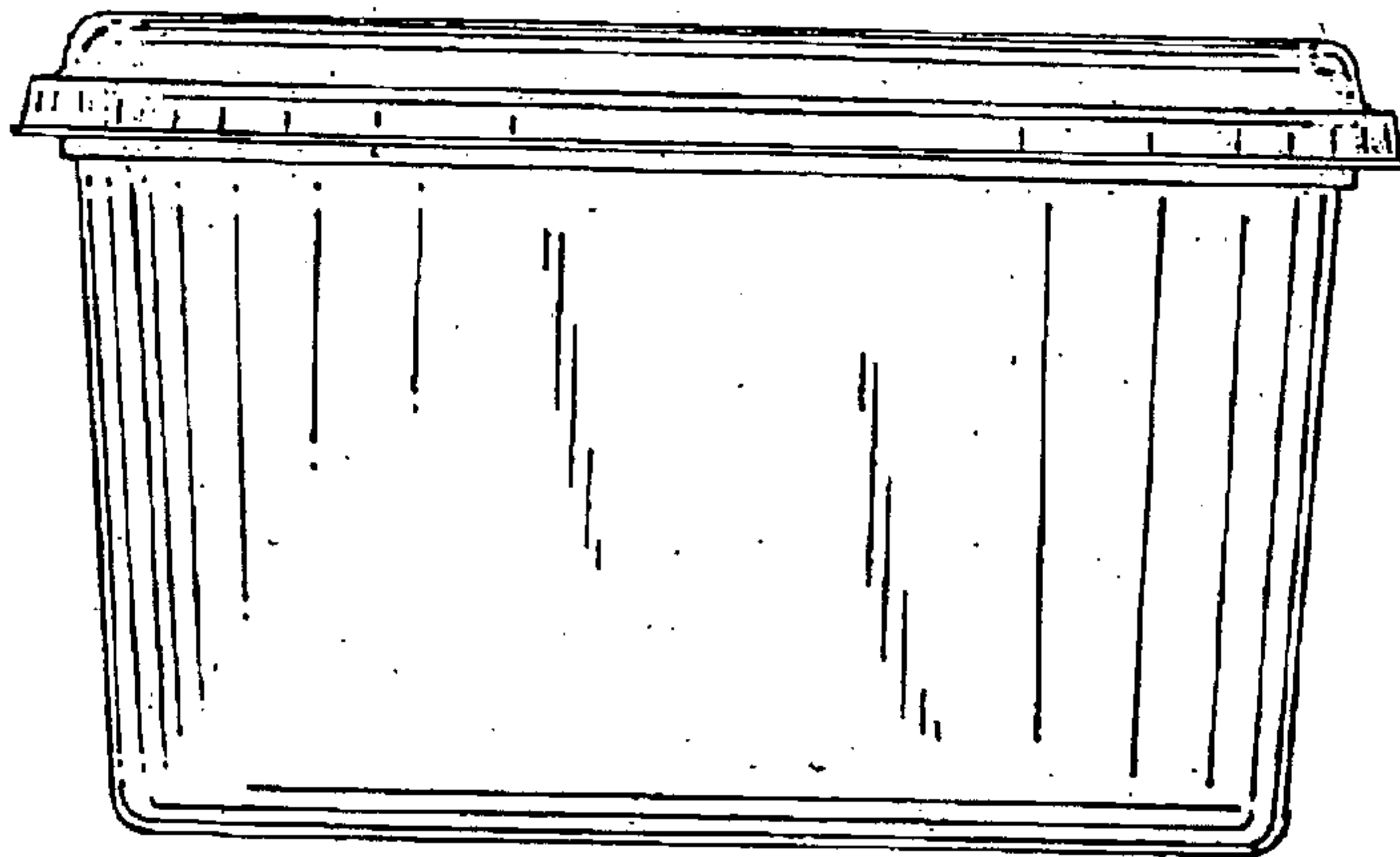

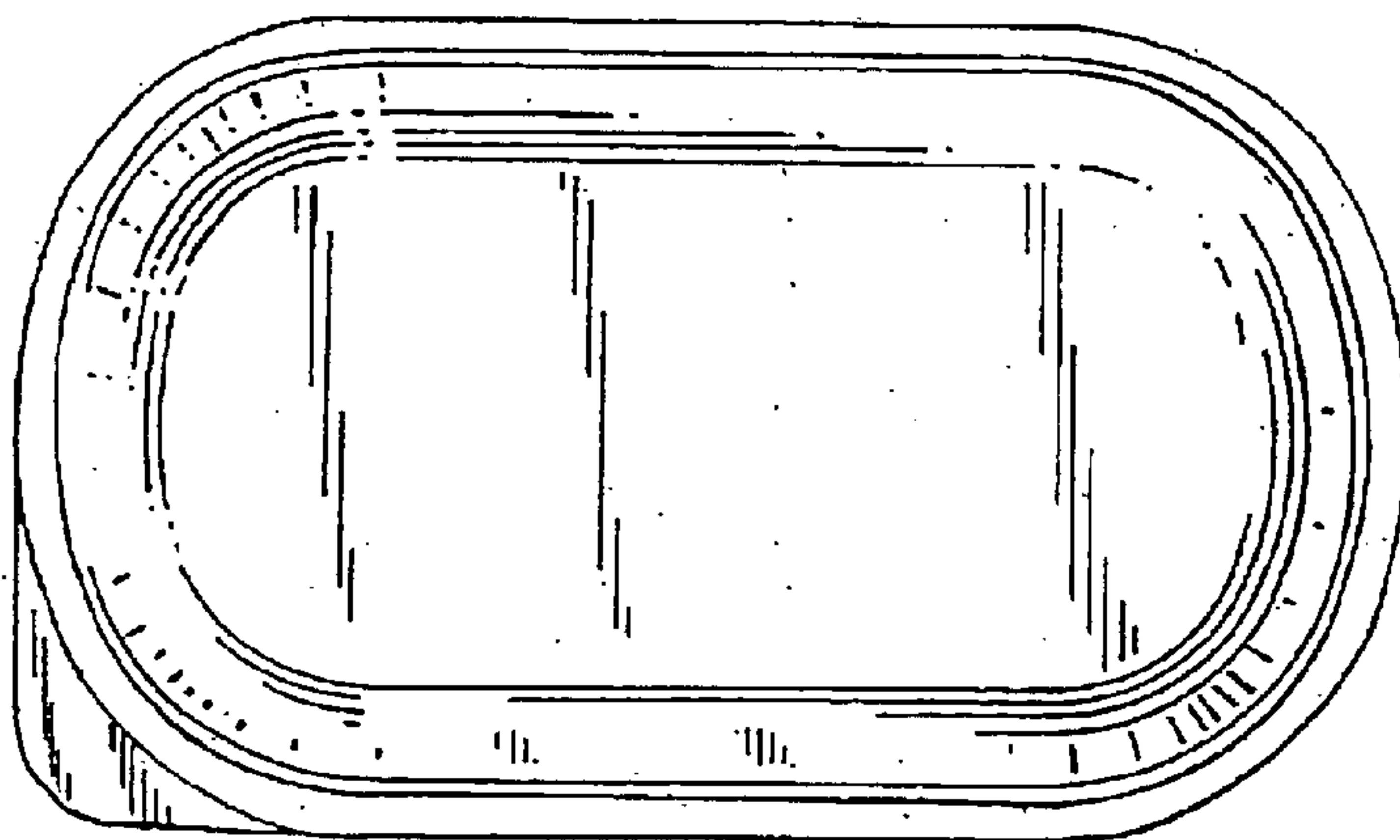

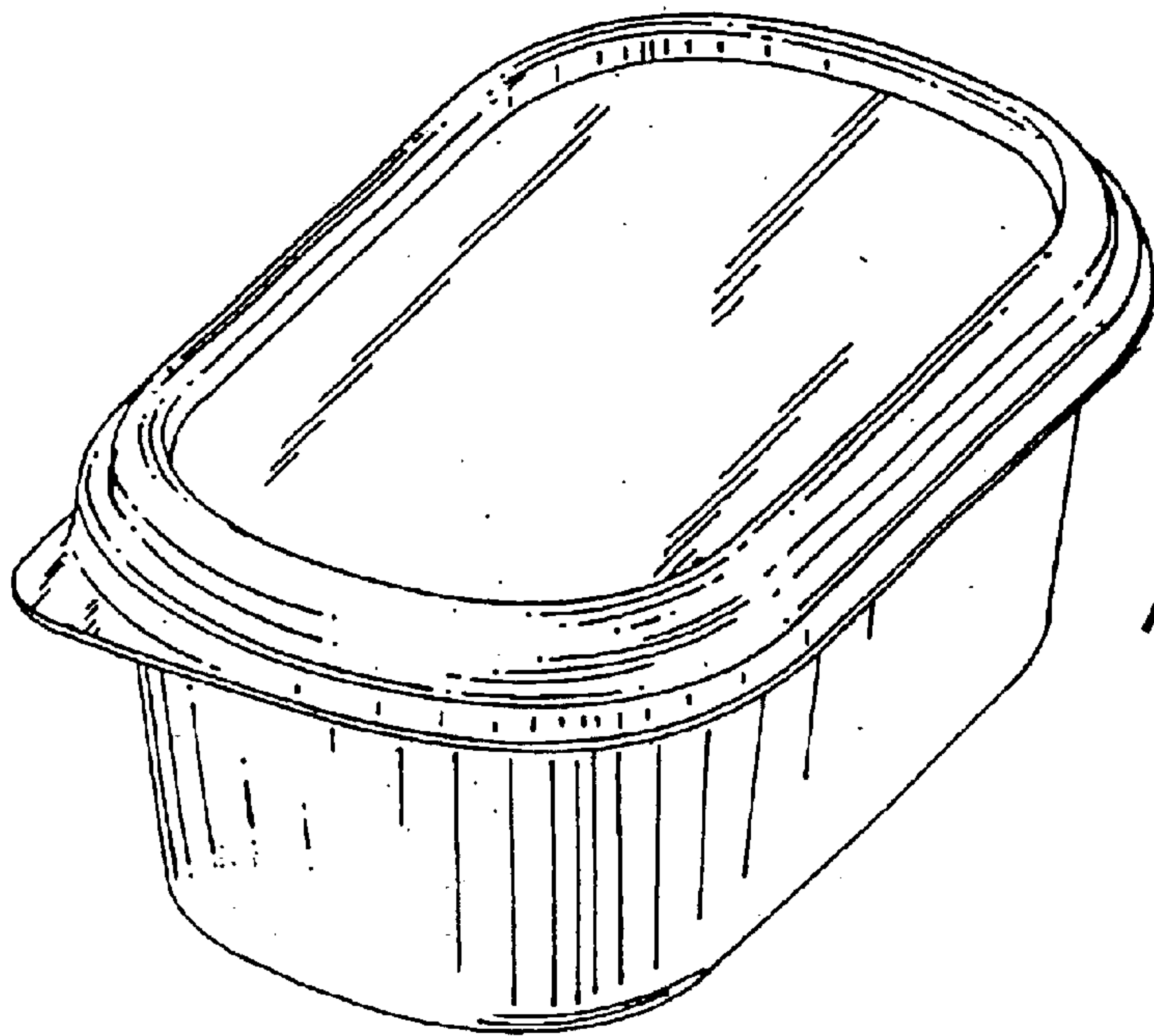

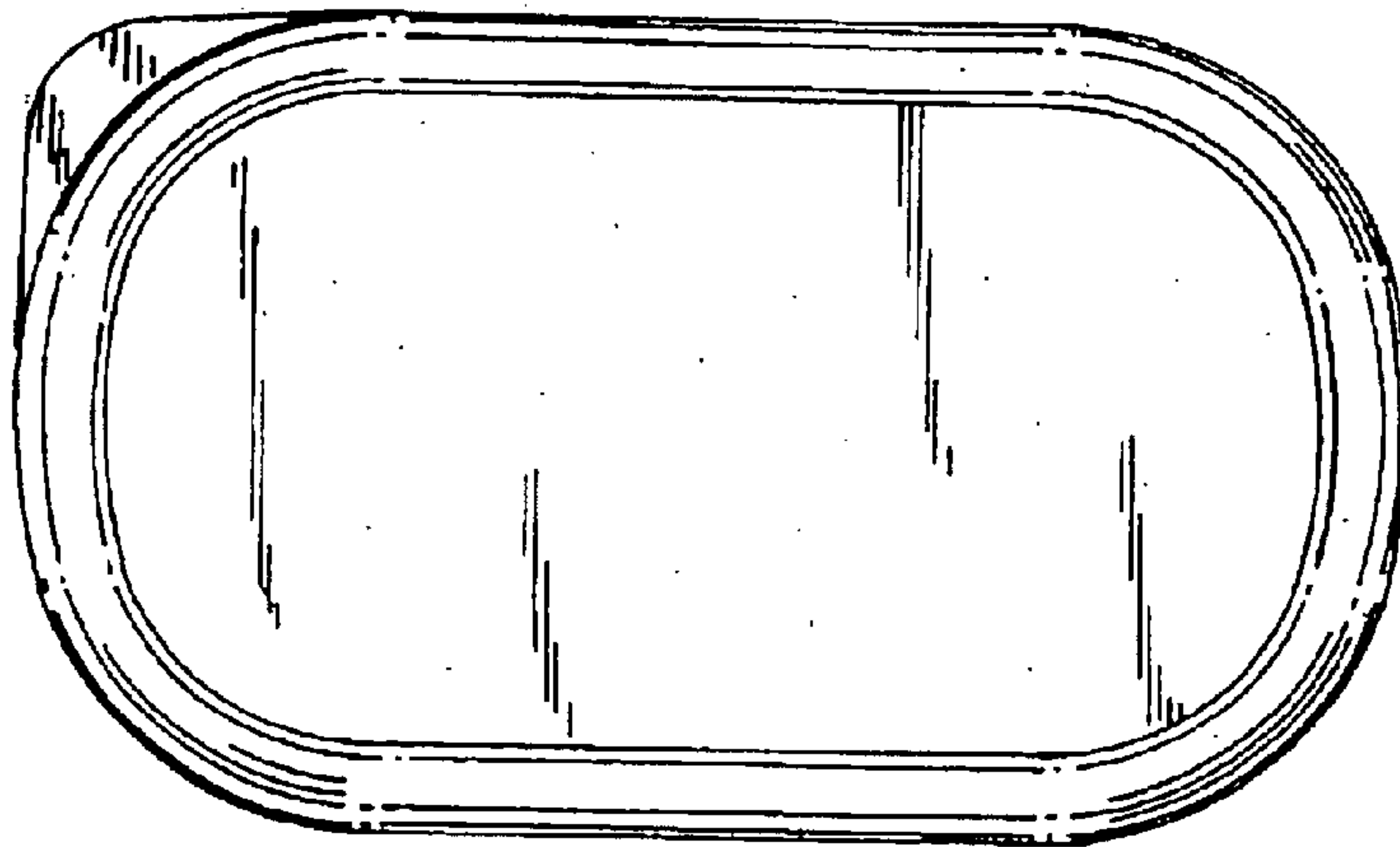

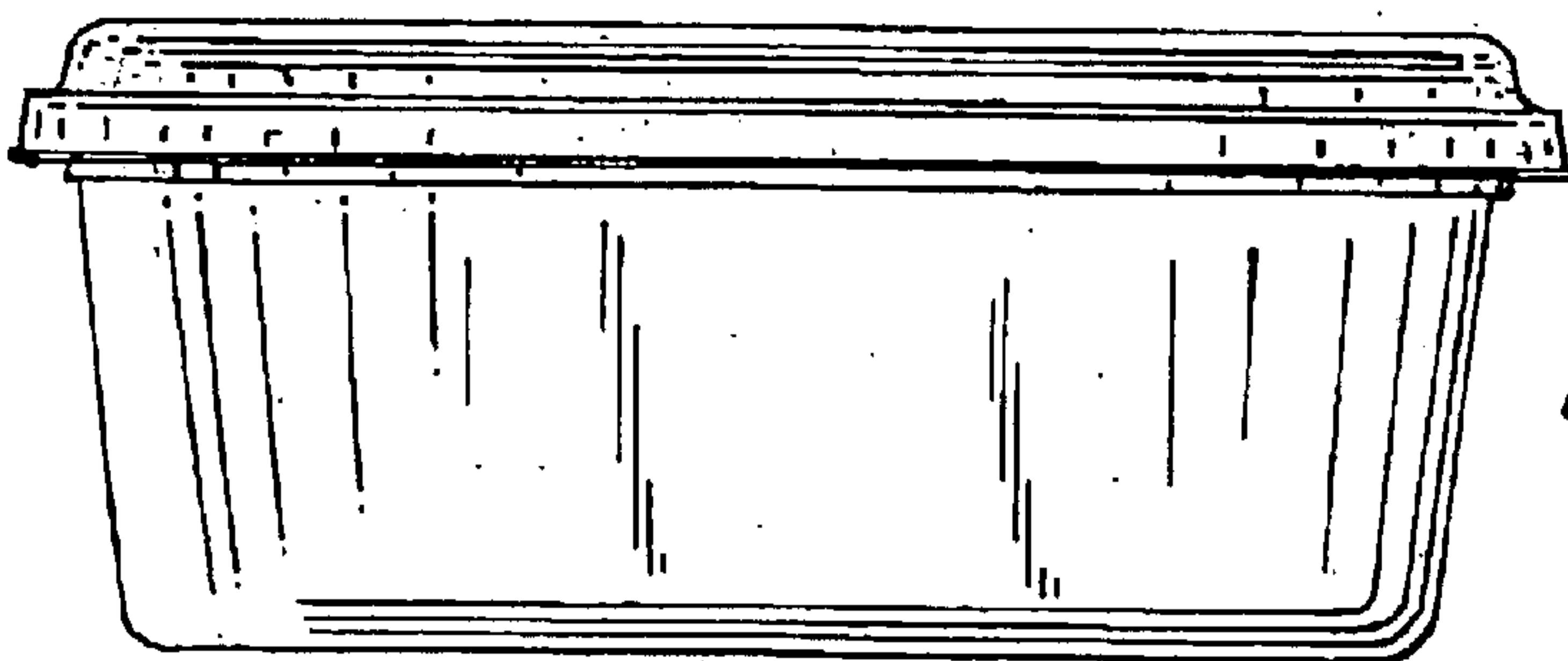

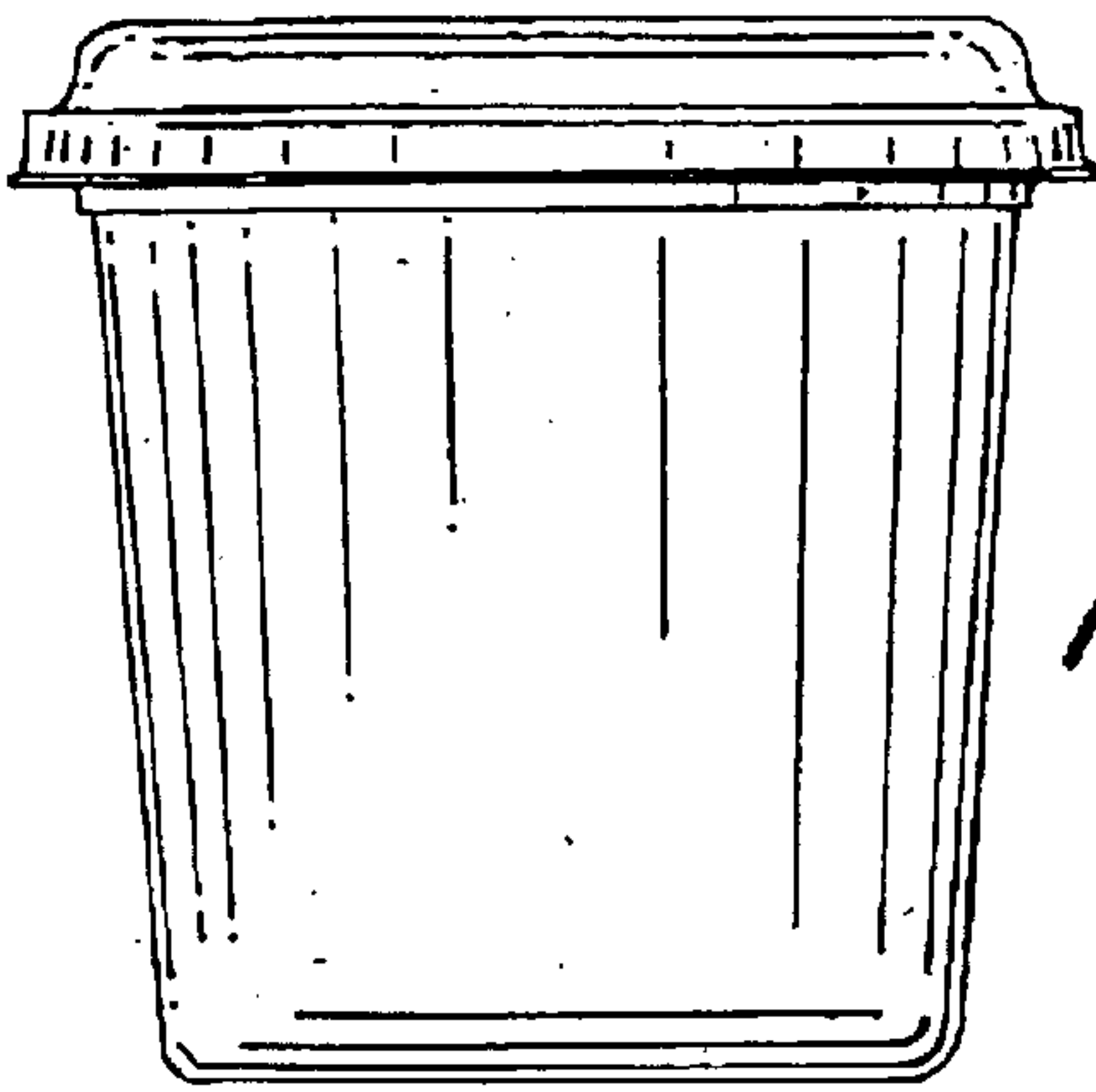

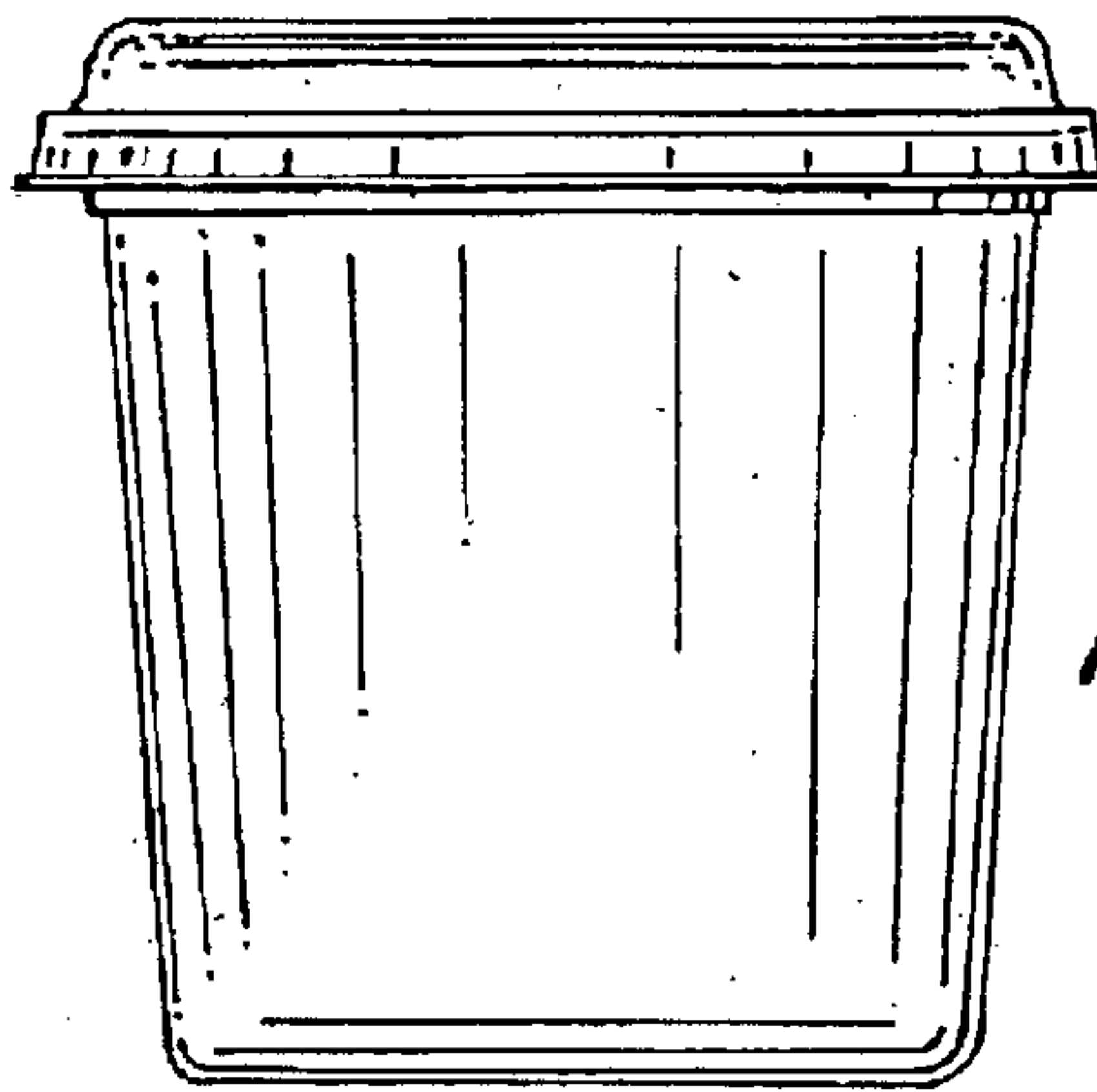

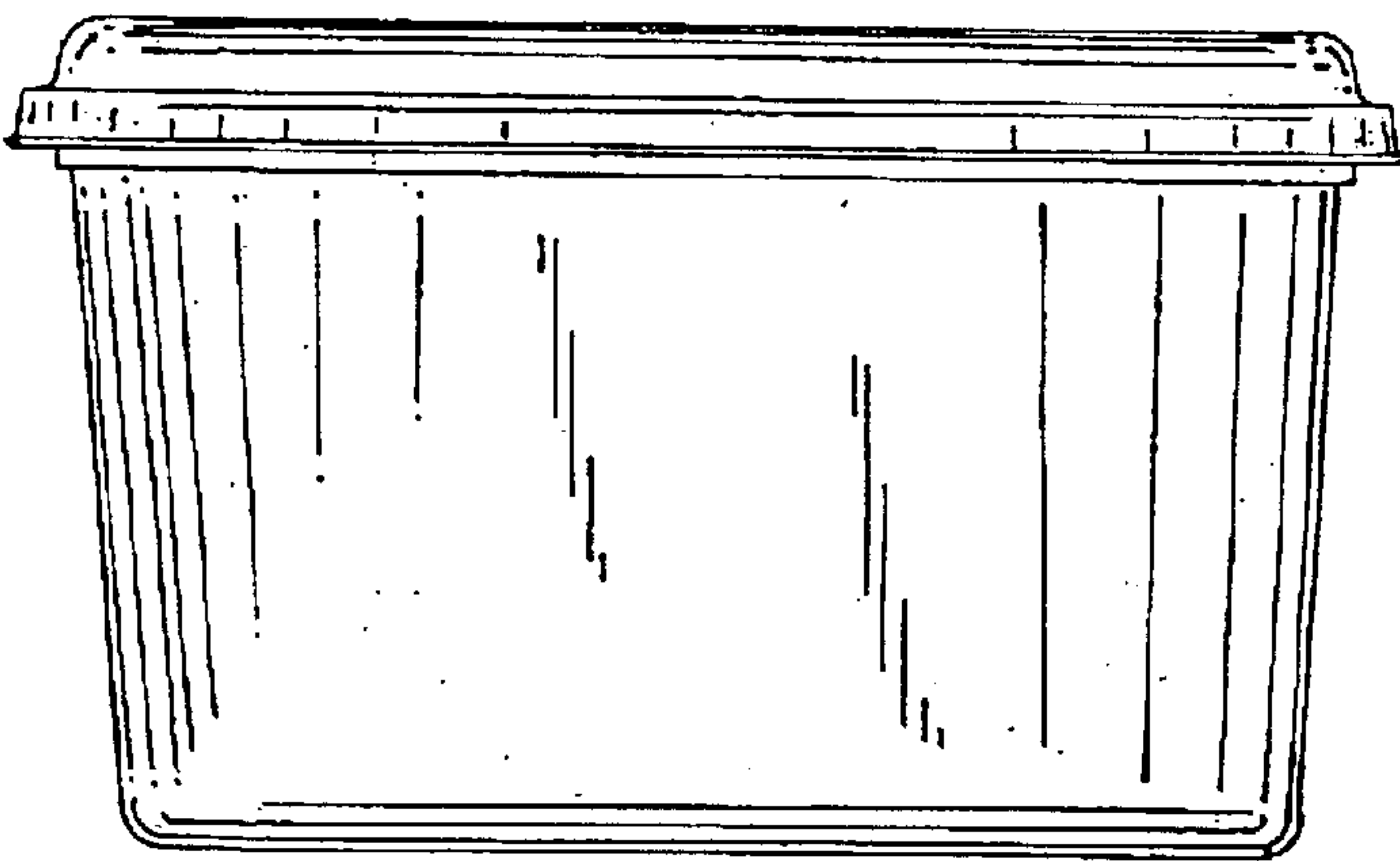




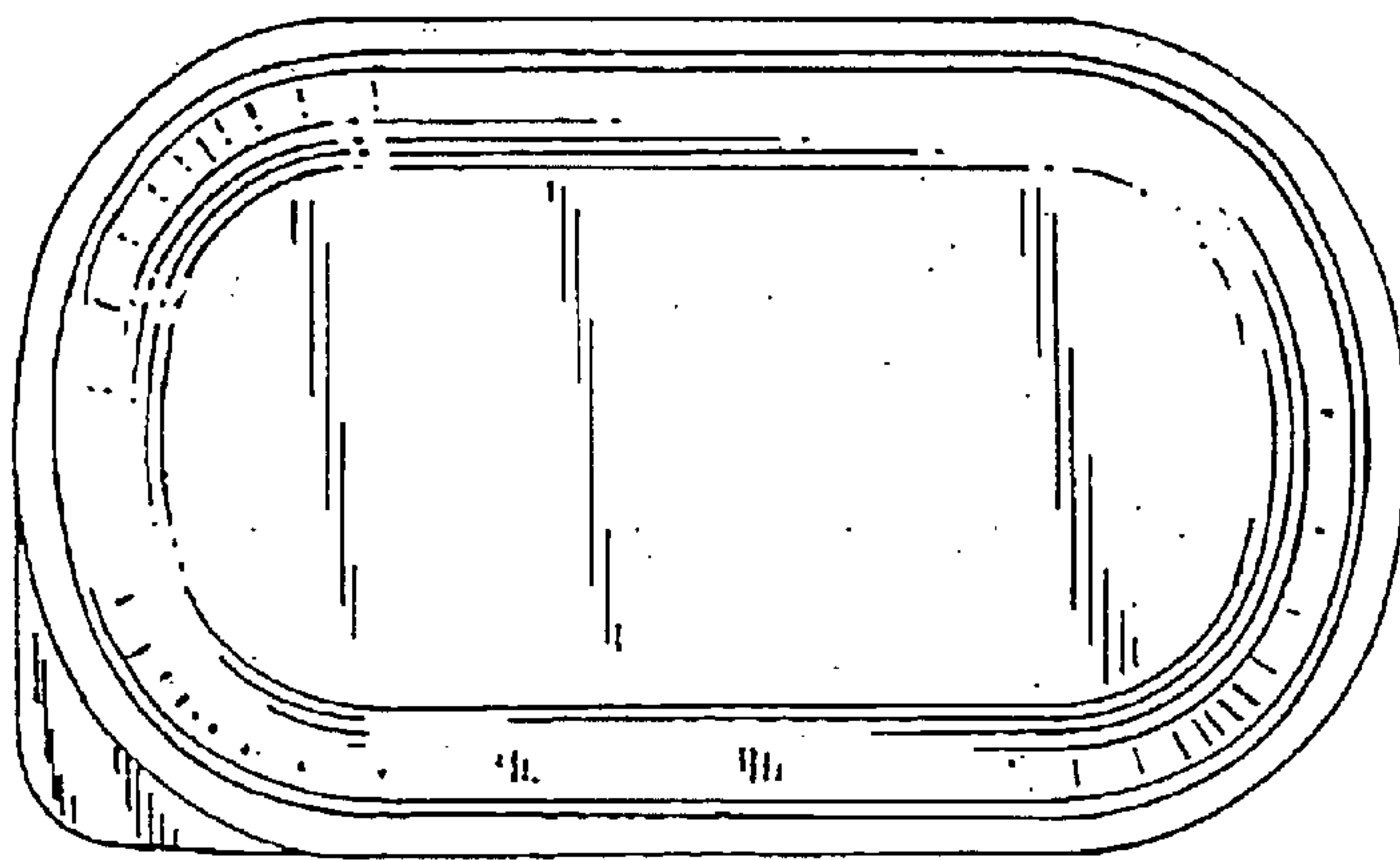
