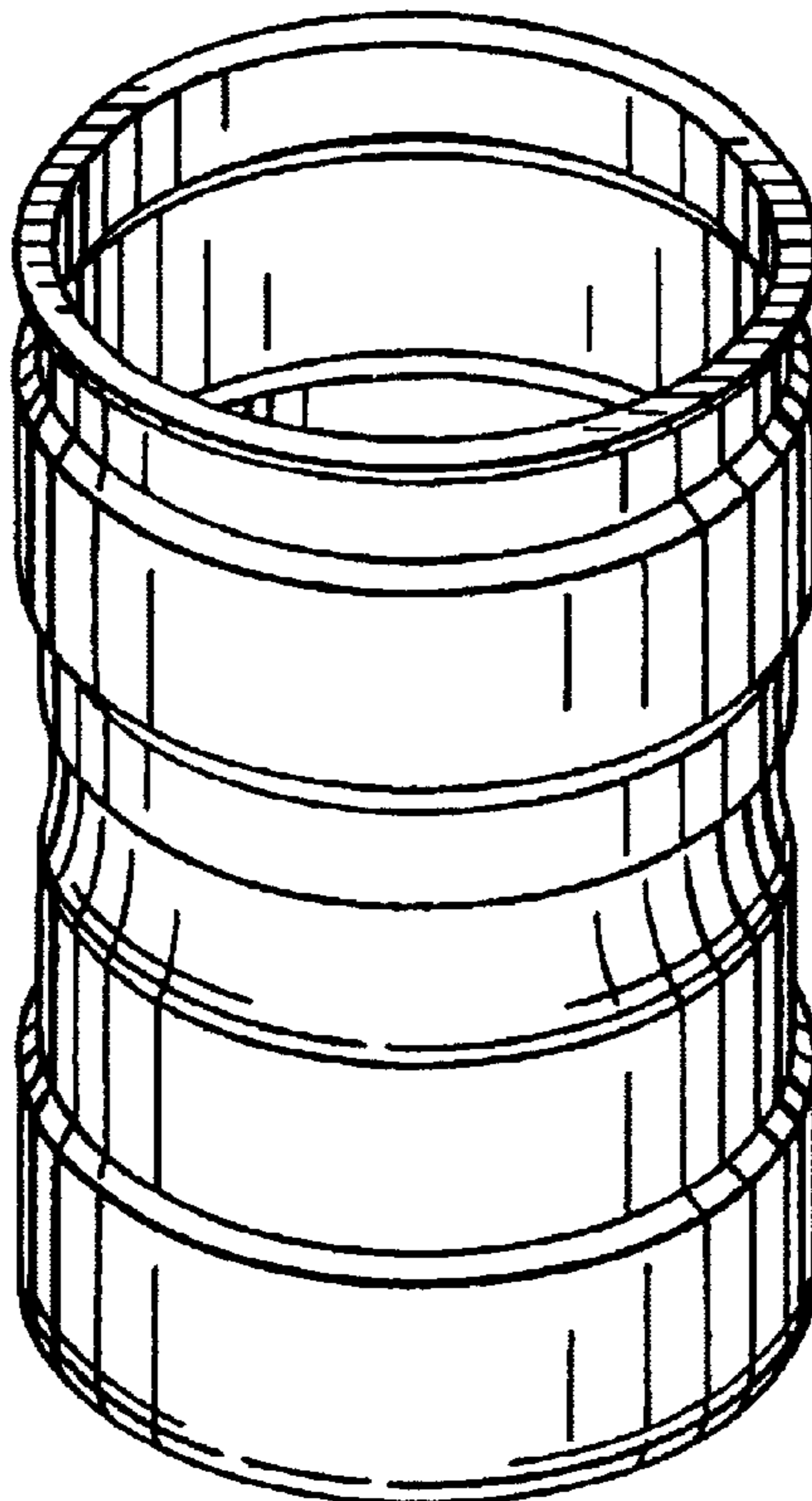

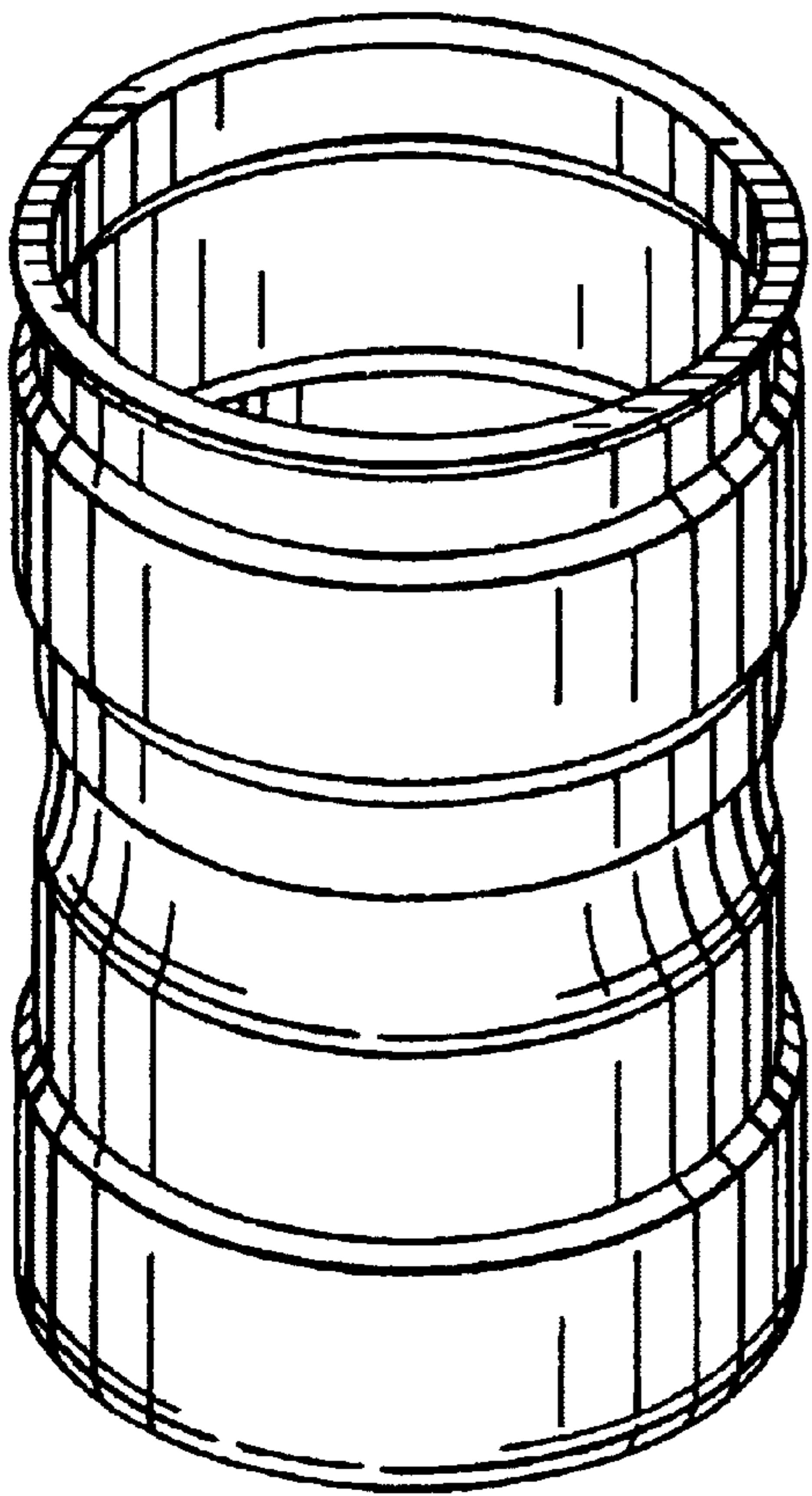
The ornamental design for a container, as shown and described.

DESCRIPTION

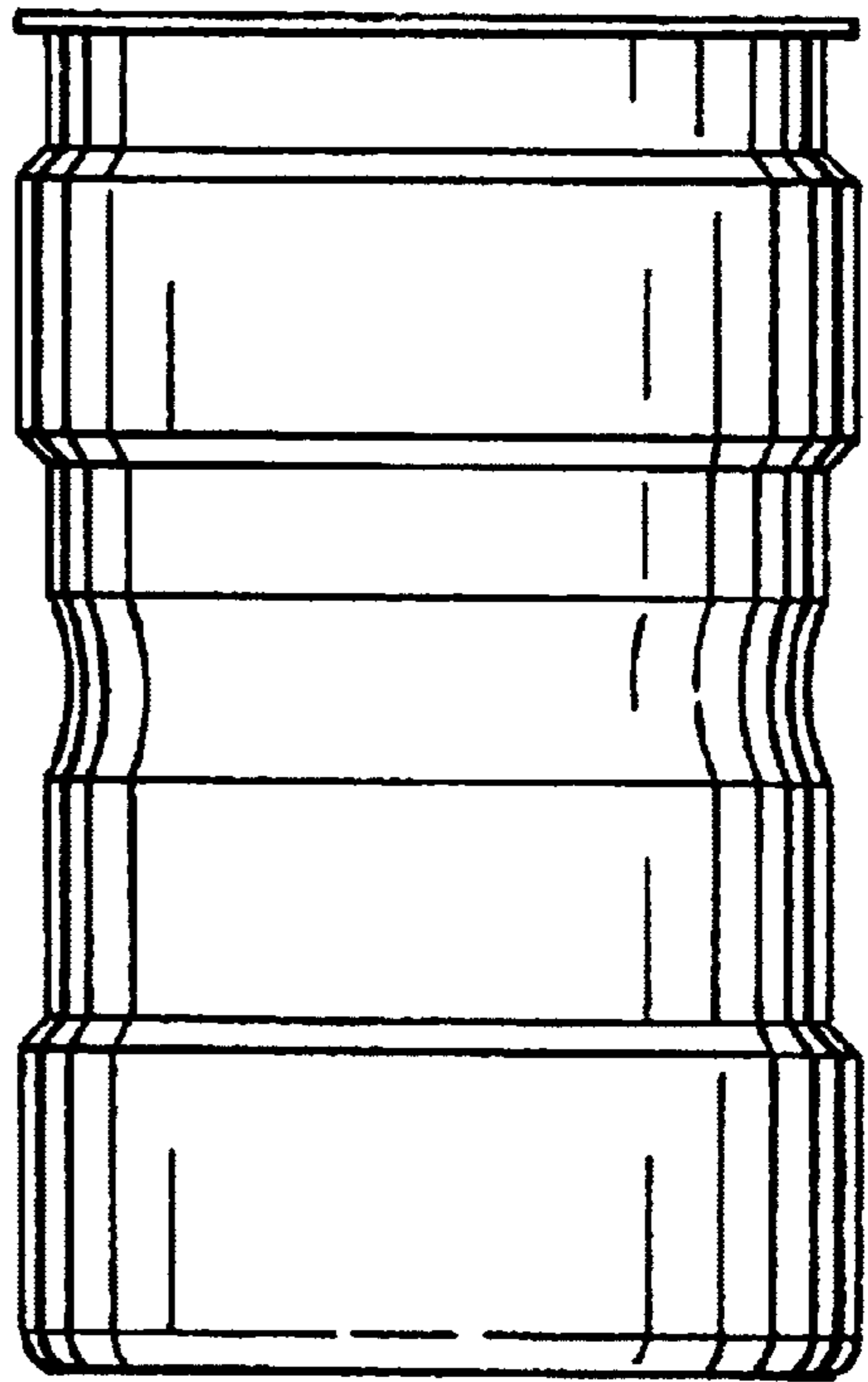
FIG. 1 is a perspective view of the container;

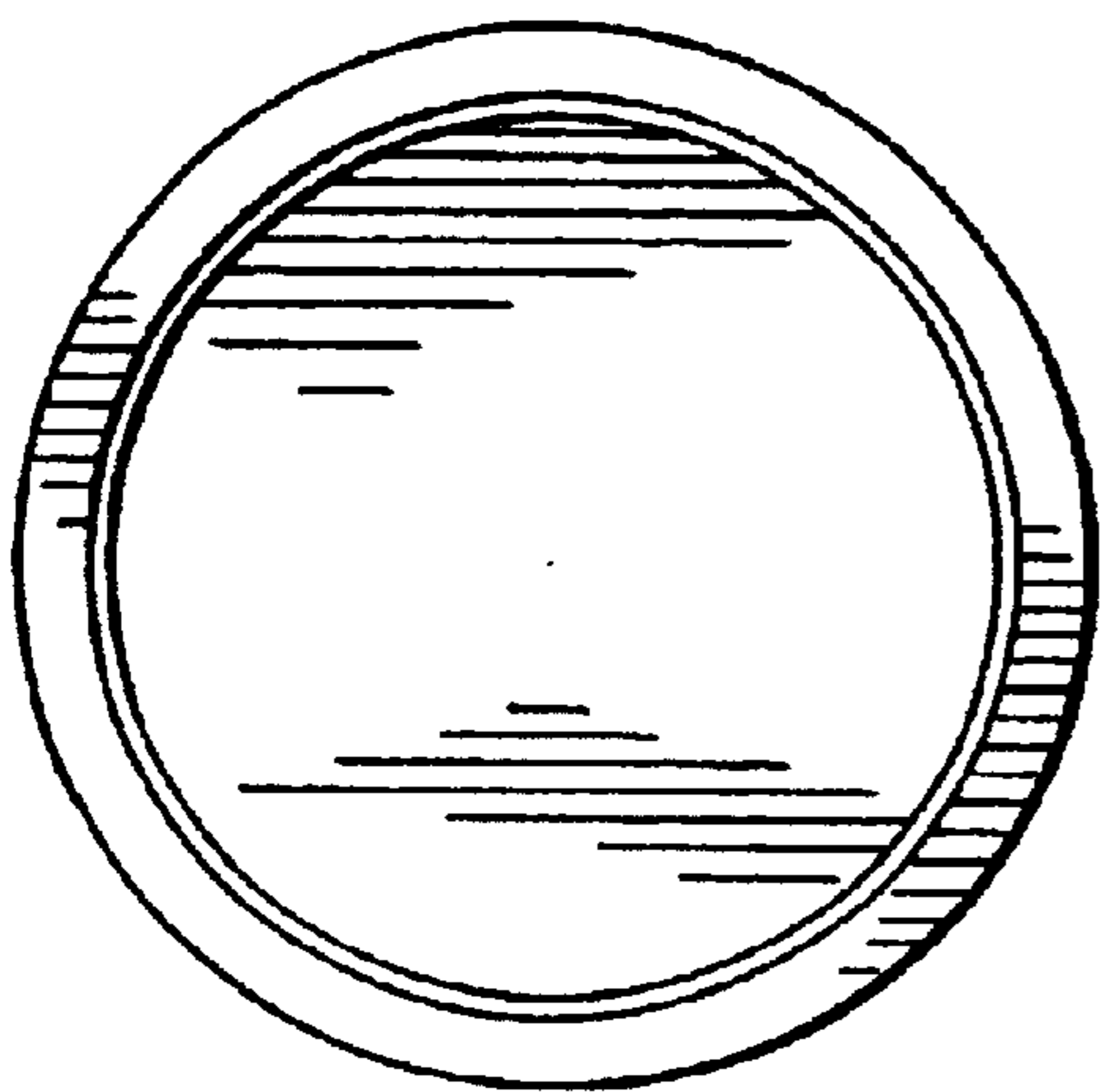




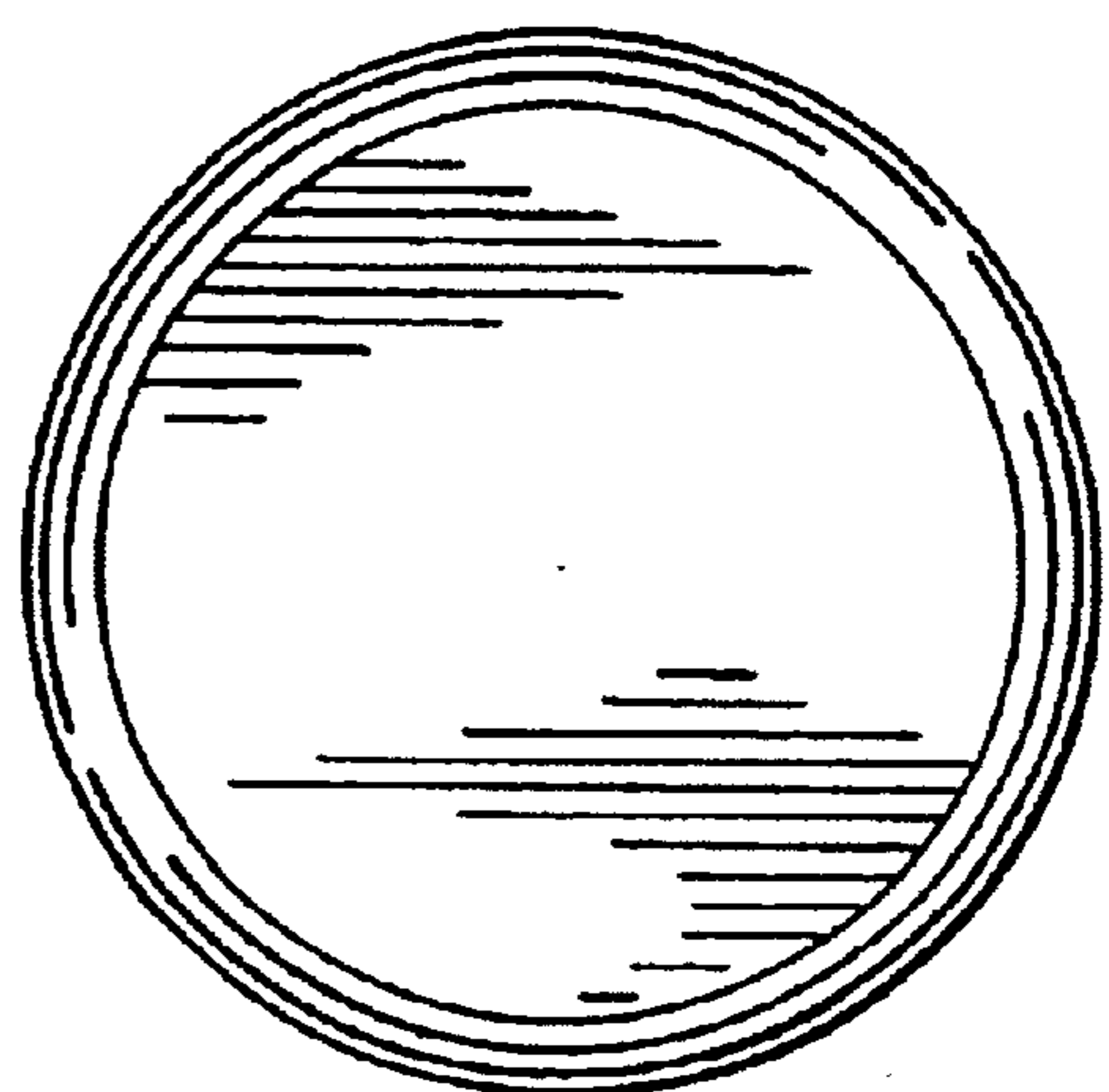
