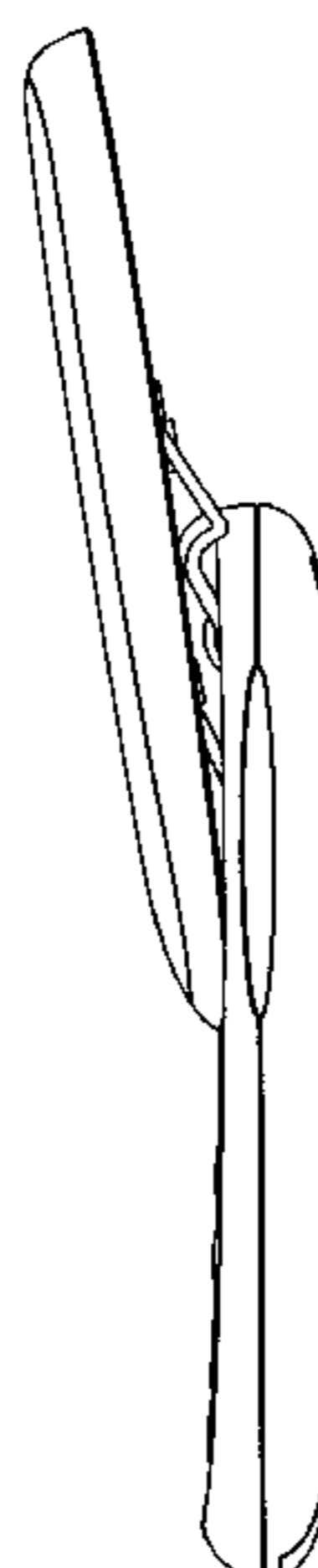
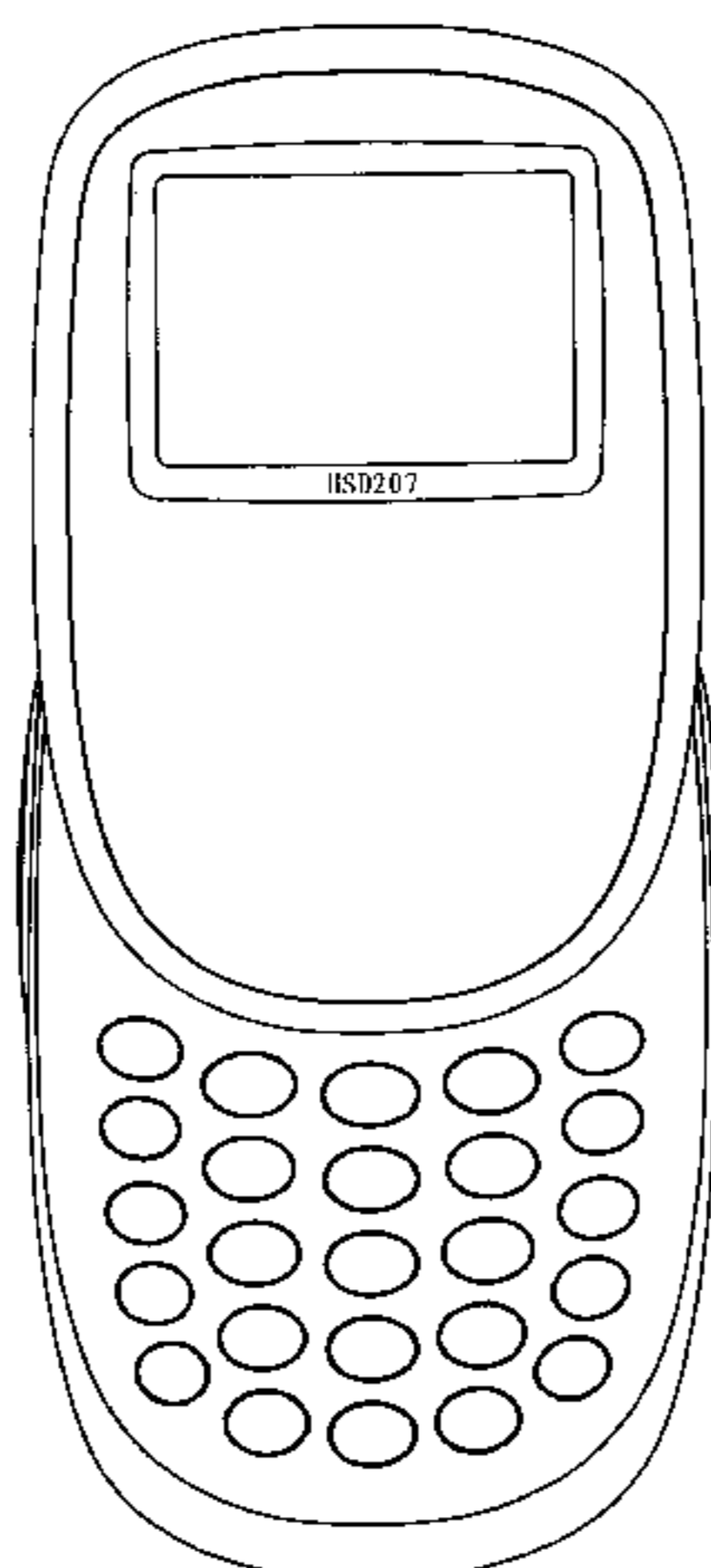
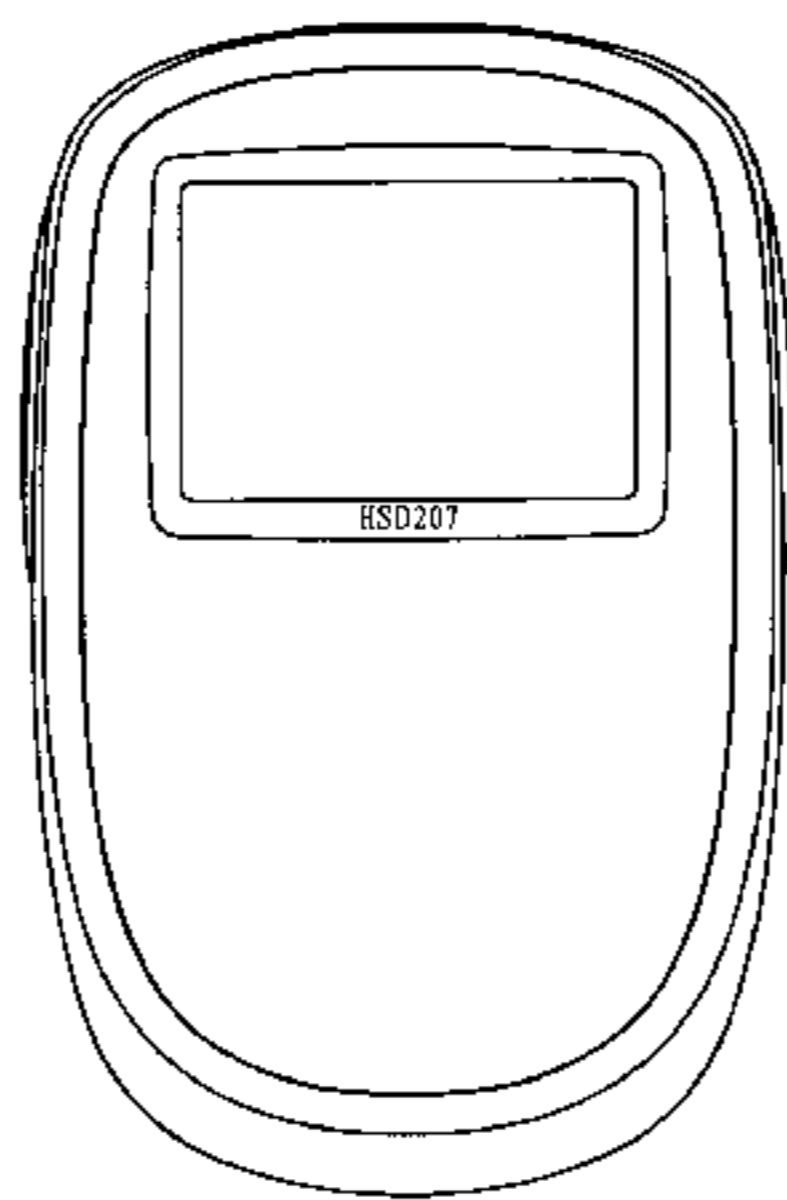
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a calendar calculator showing our new Design;
FIG. 2 is a right side elevational view thereof;

FIG. 6 is a rear elevational view thereof;

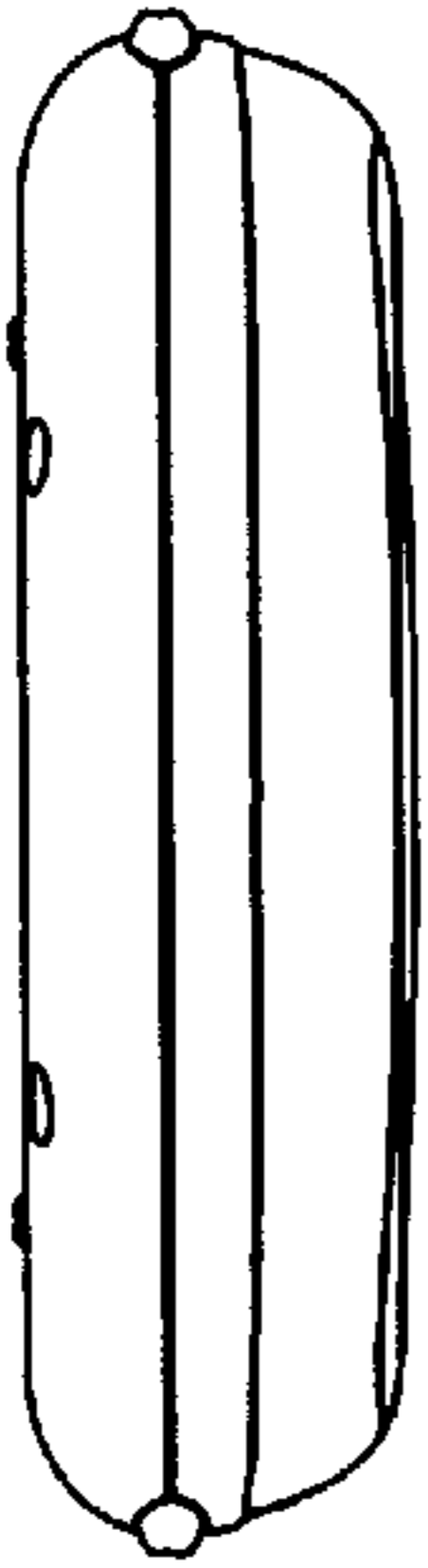

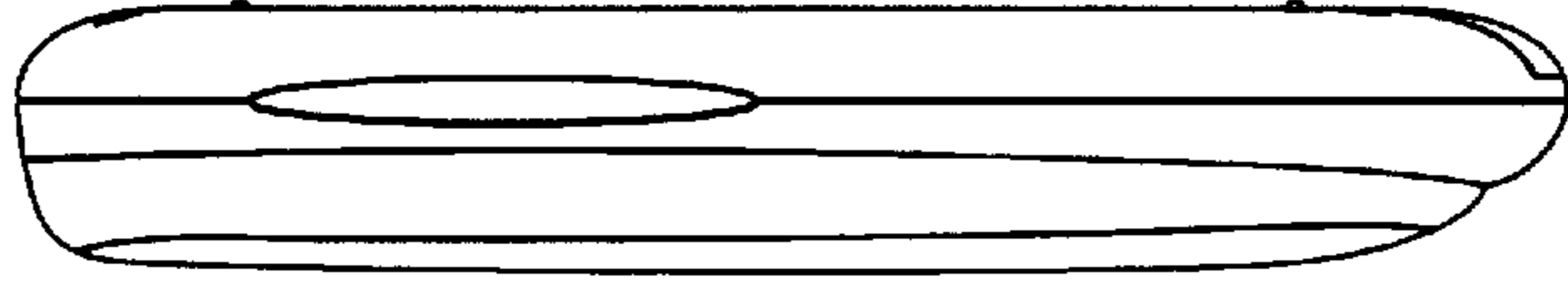

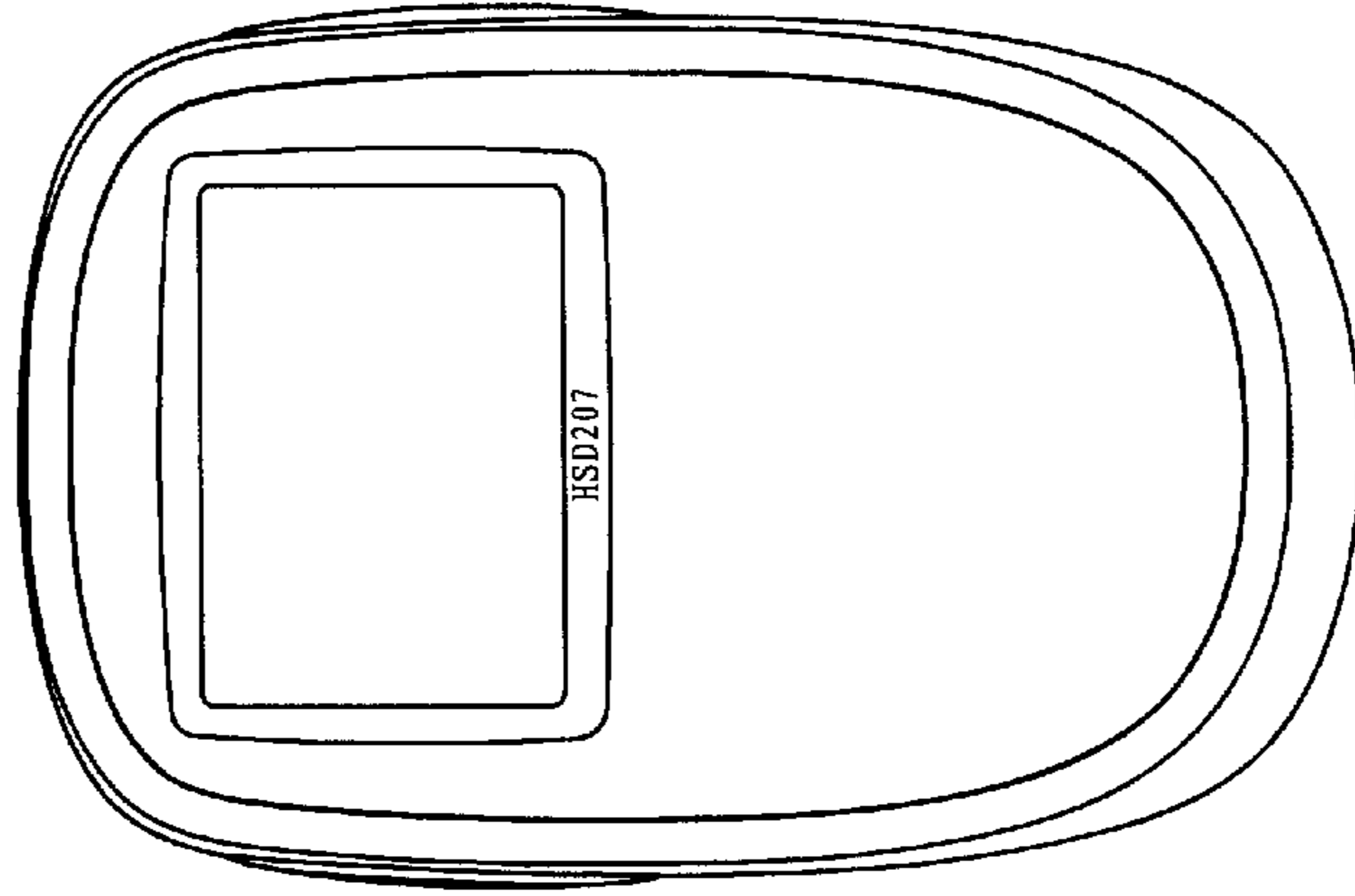

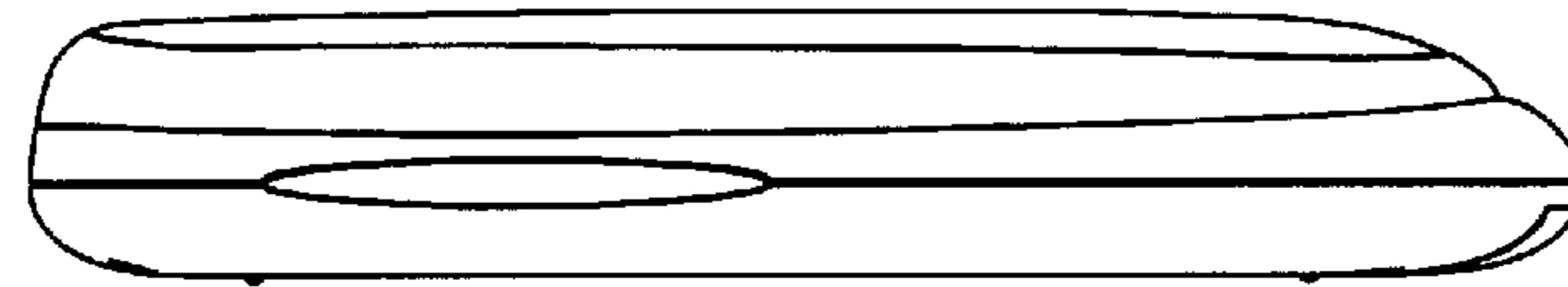

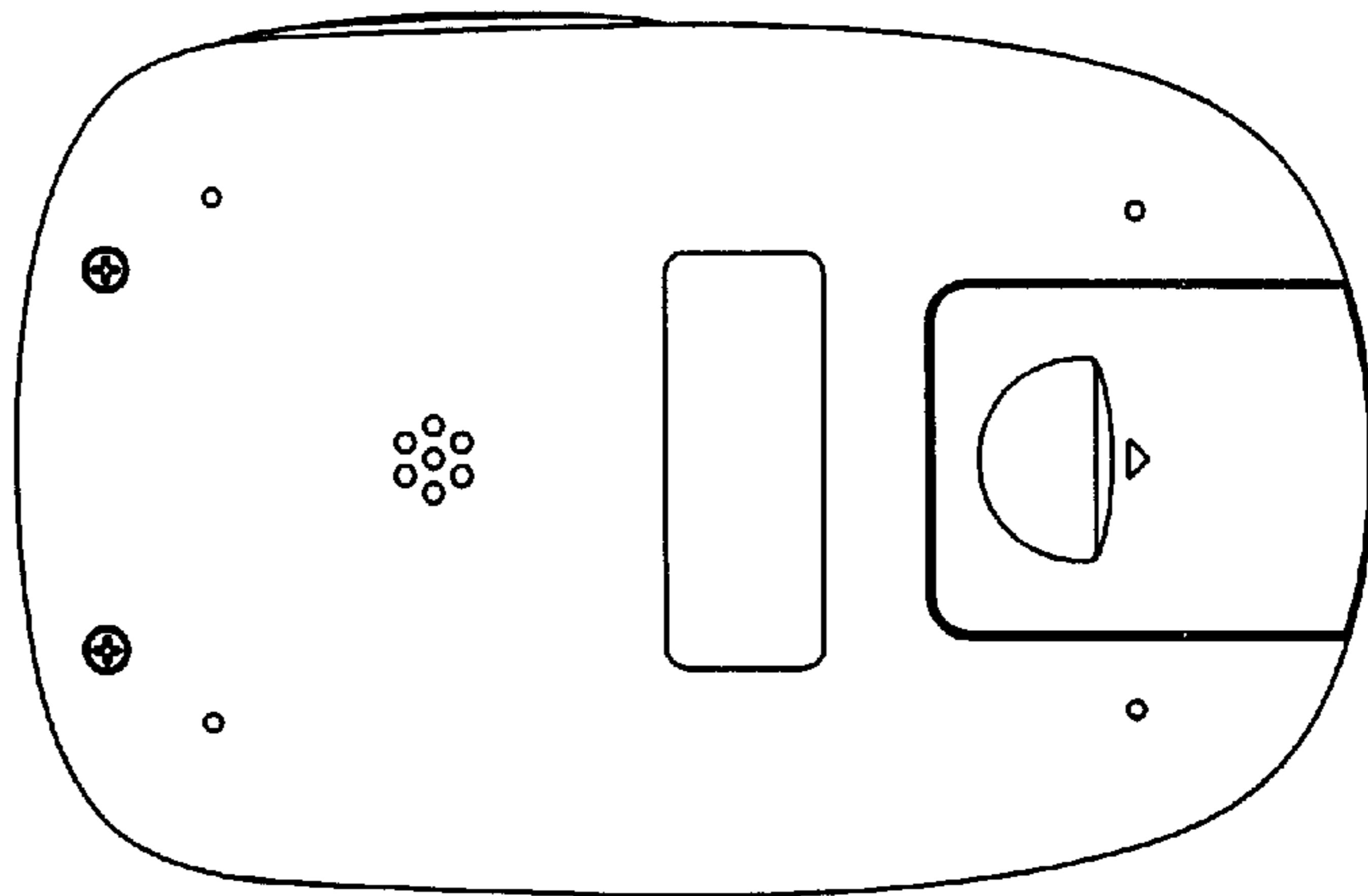

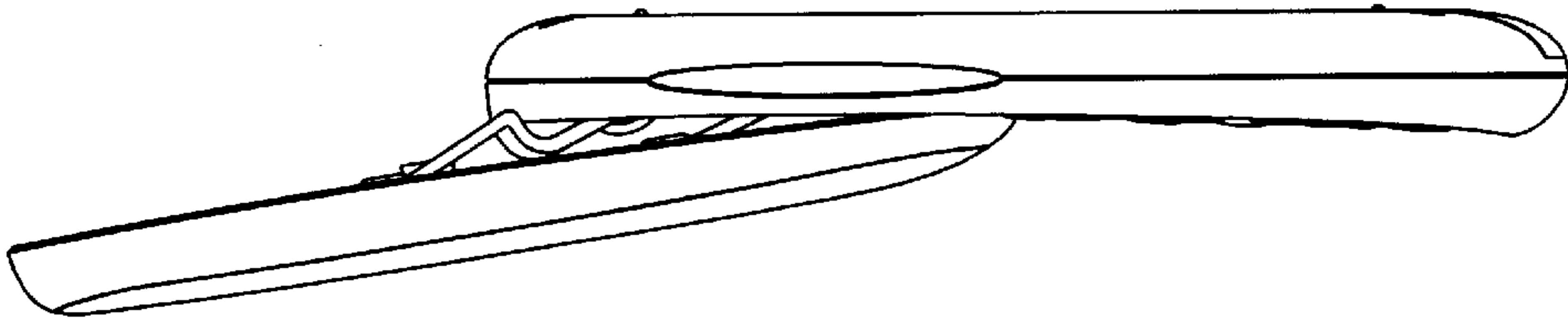

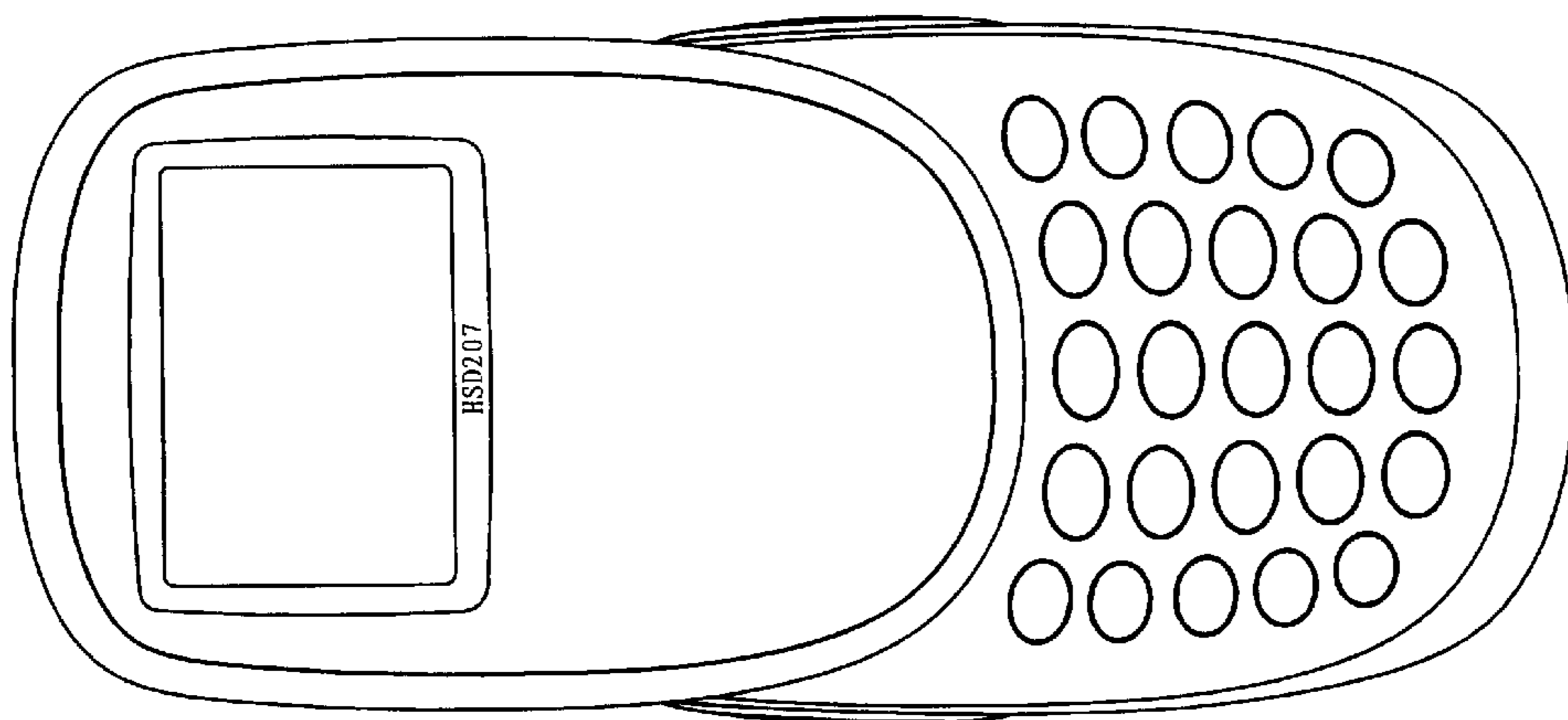
