(57) **CLAIM**

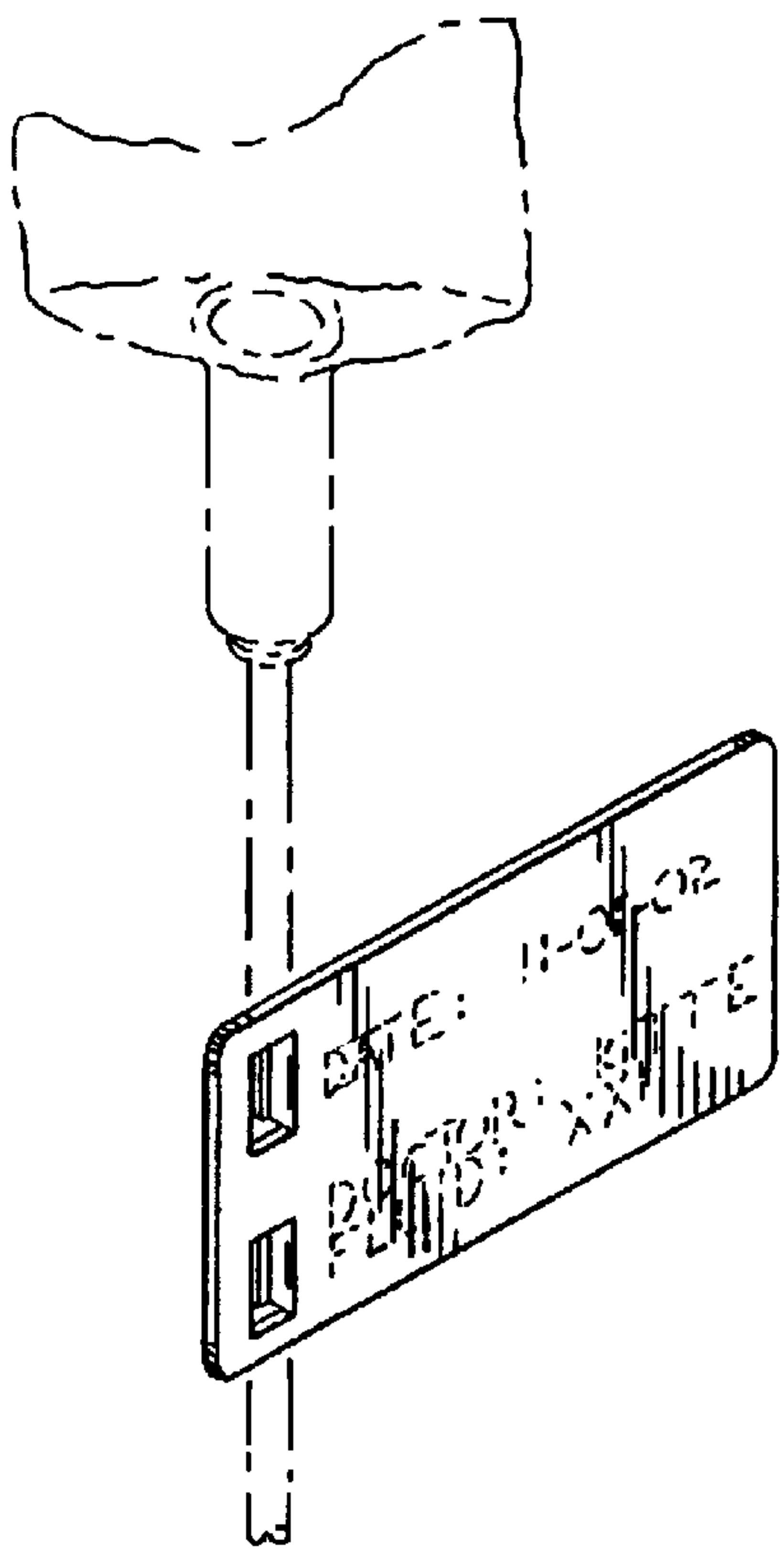
The ornamental design for a tag for intravenous infusion systems, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tag for intravenous infusion systems showing our new design;
FIG. 2 is a perspective view of the tag;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a left-hand side elevation view thereof;
FIG. 7 is a right-hand side elevation view thereof; and,
FIG. 8 is a bottom plan view thereof.

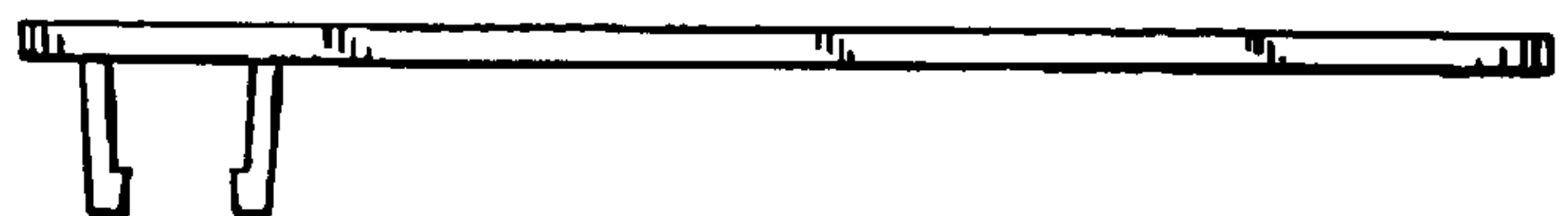
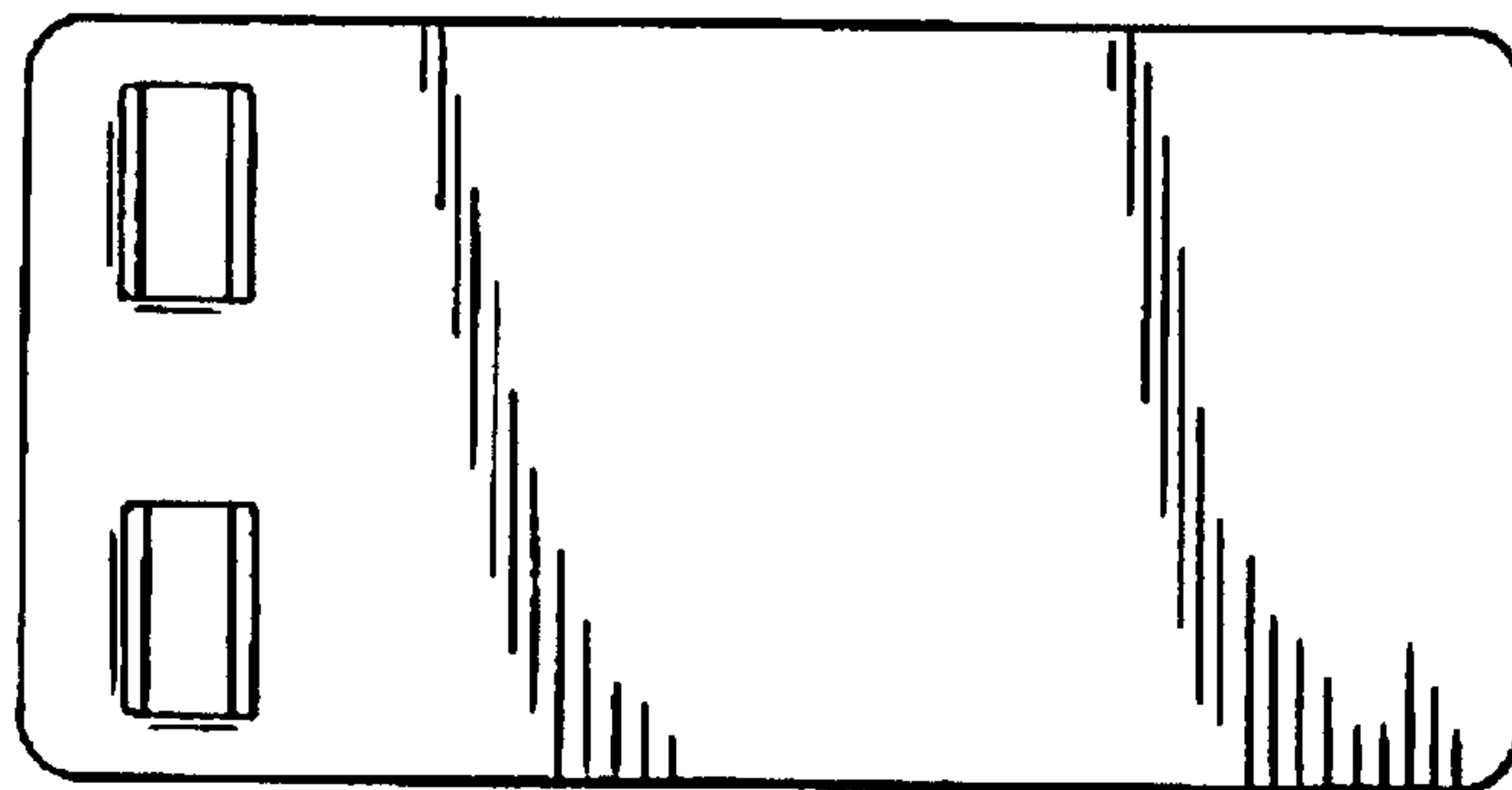
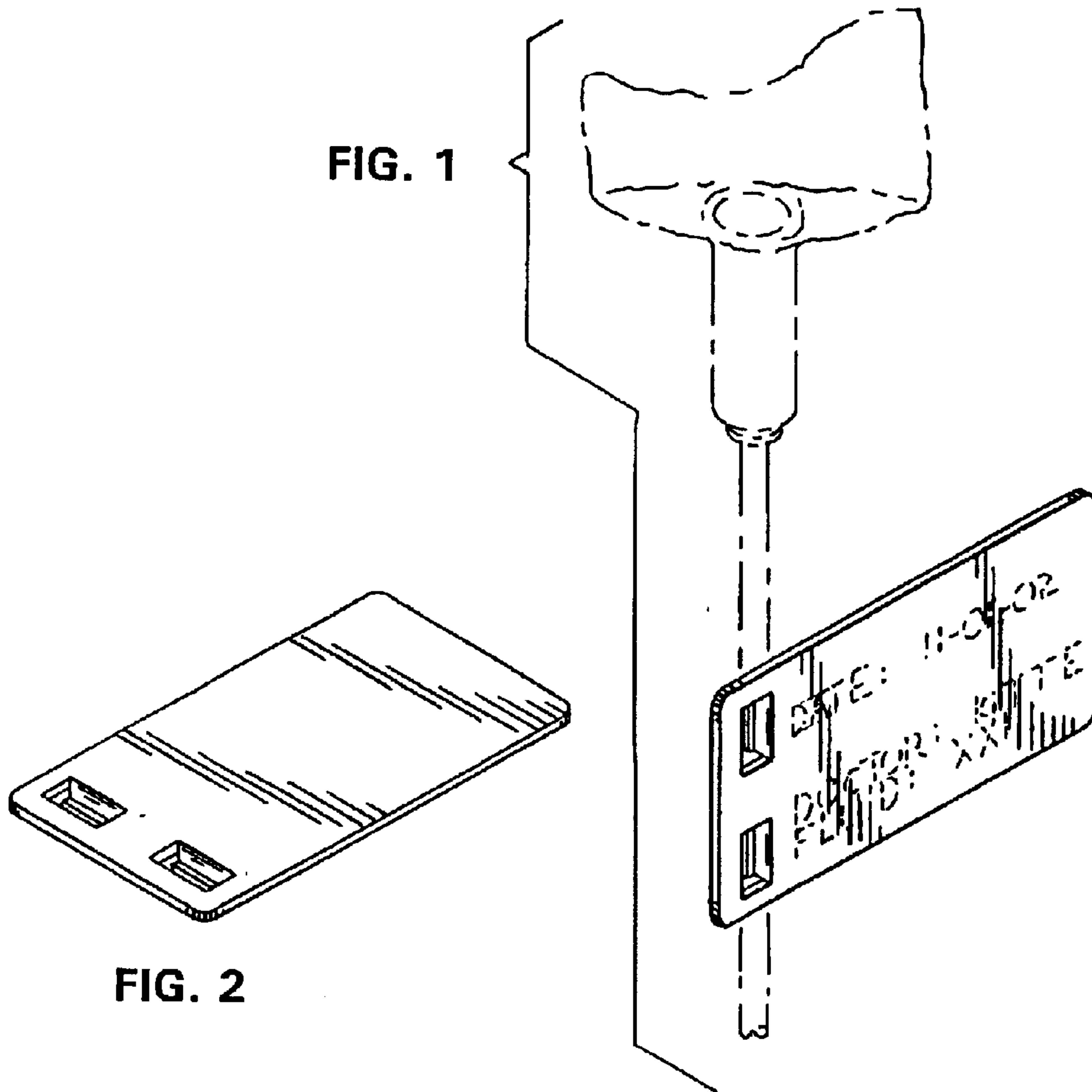

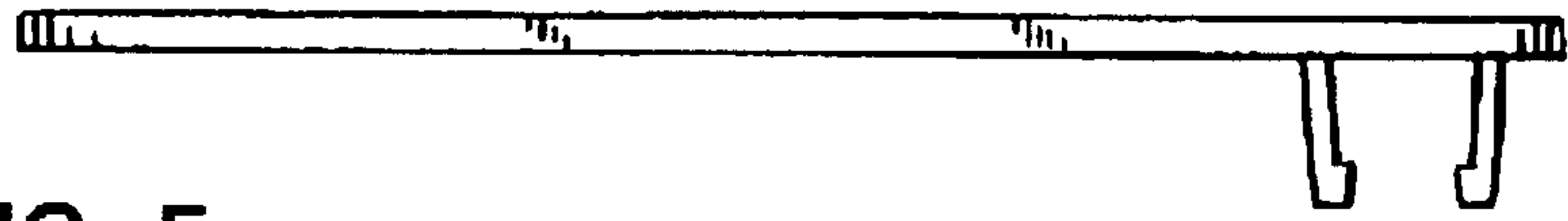

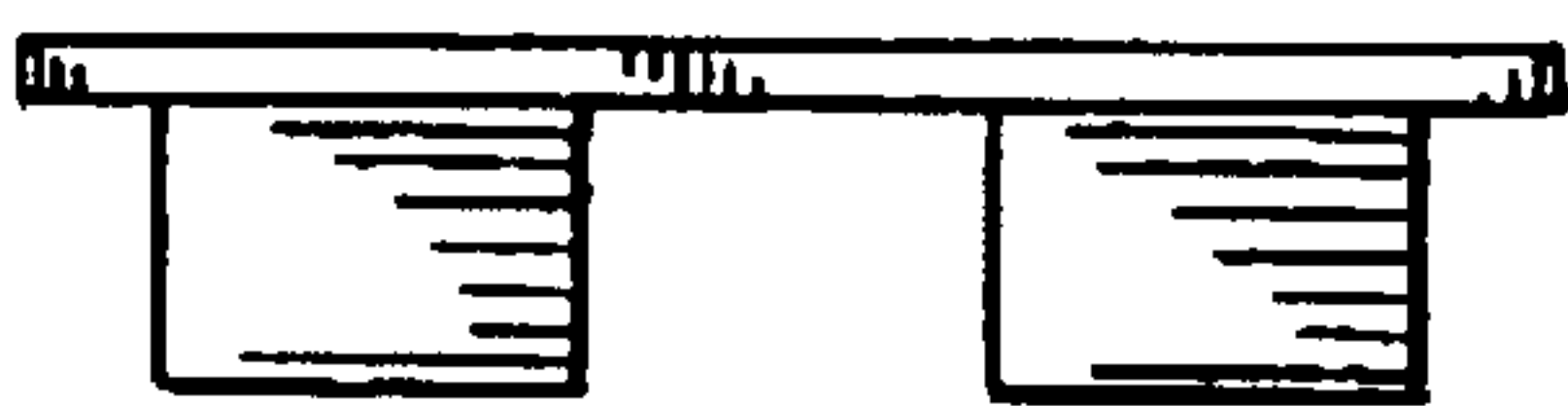

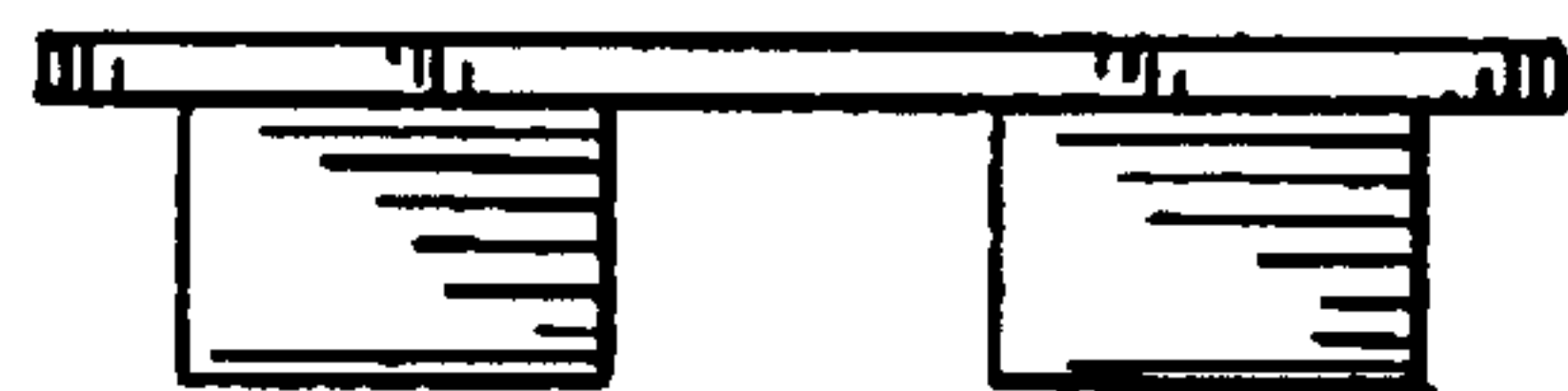

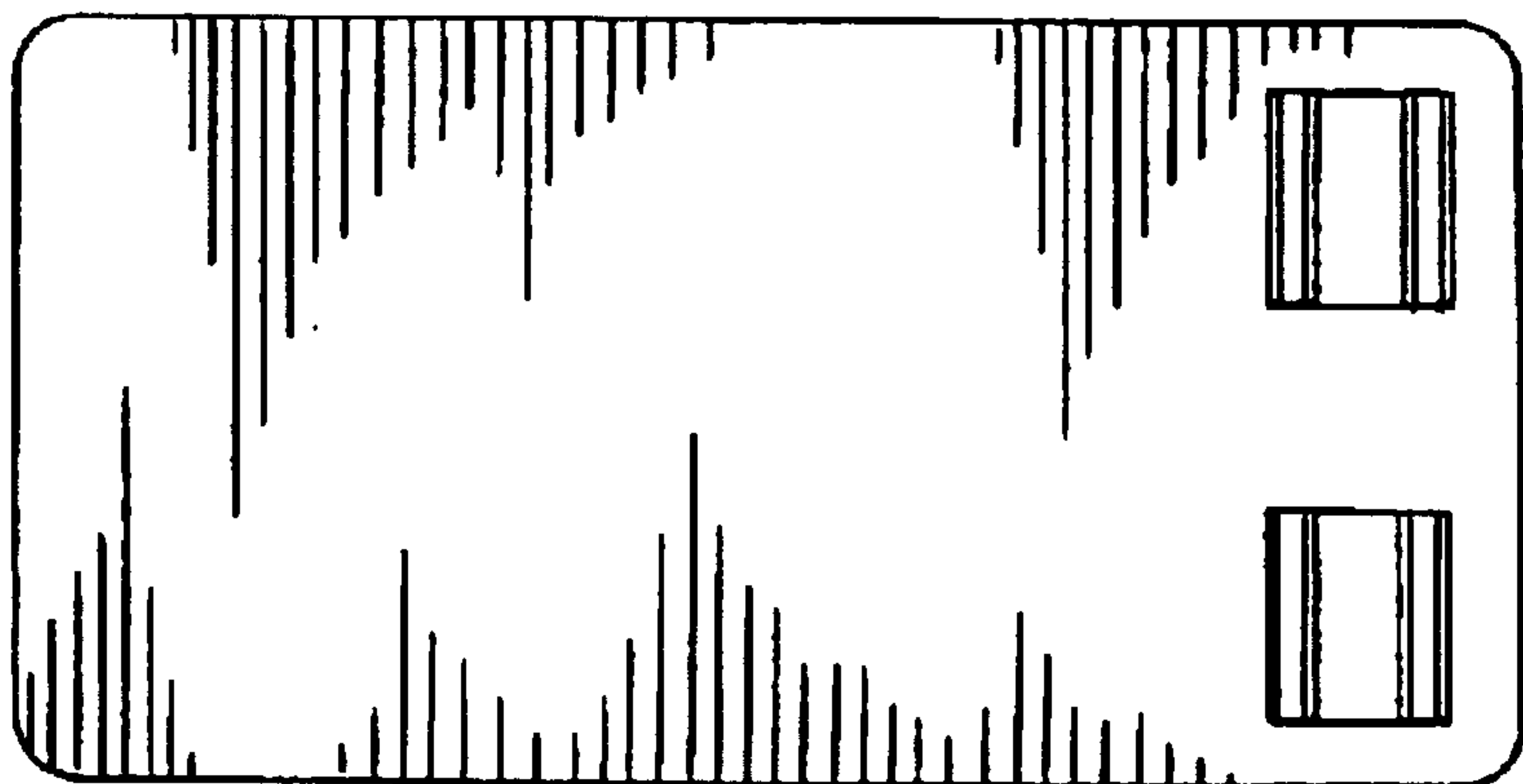
