(57) **CLAIM**

The ornamental design for a long oven mitten, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side view of the long oven mitten with “anti-grip” raised bands

FIG. 2 is a right side view of the long oven mitten

FIG. 3 is a top plan view of the long oven mitten

FIG. 4 is a bottom plan view of the long oven mitten

FIG. 5 is a front view of the long oven mitten; and,

FIG. 6 is a rear view of the long oven mitten.

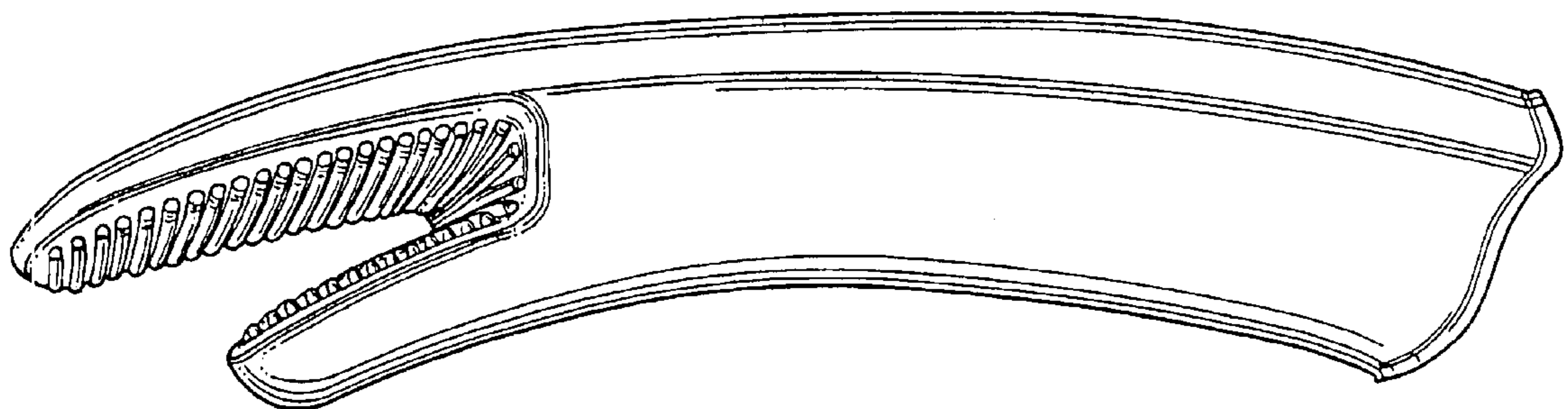

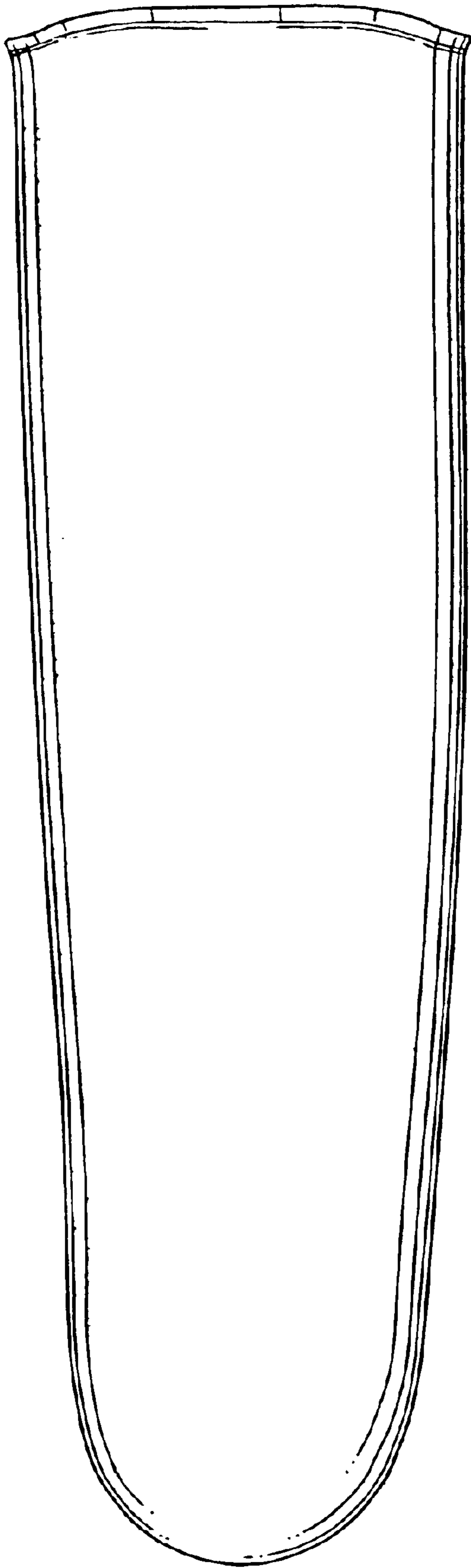

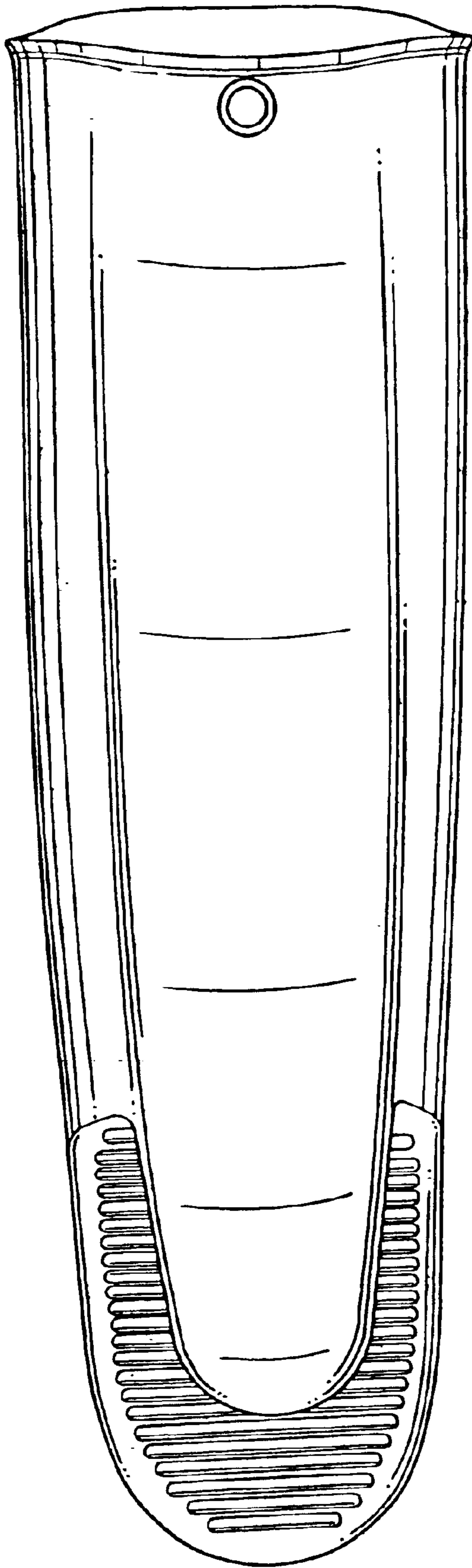
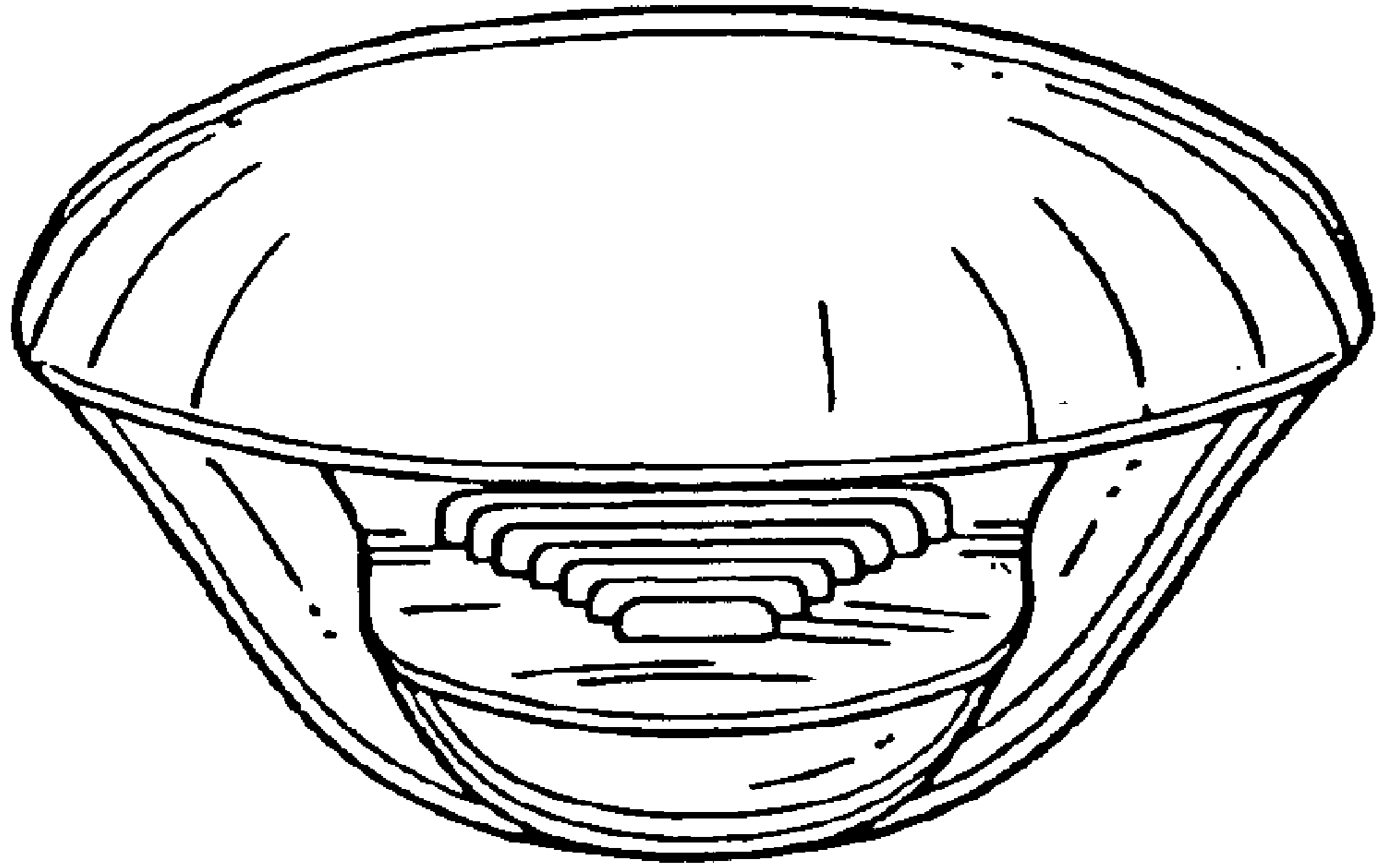
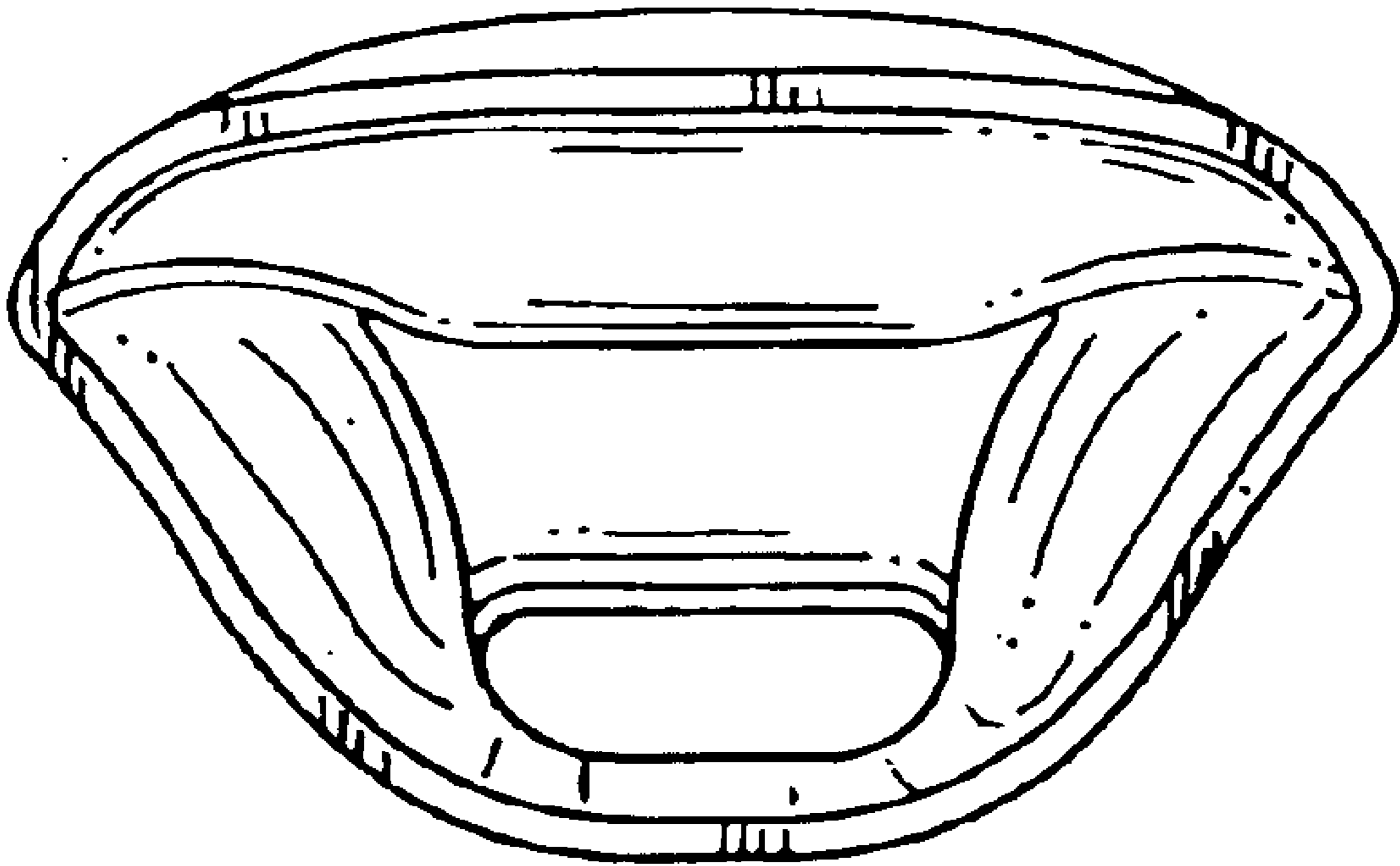
