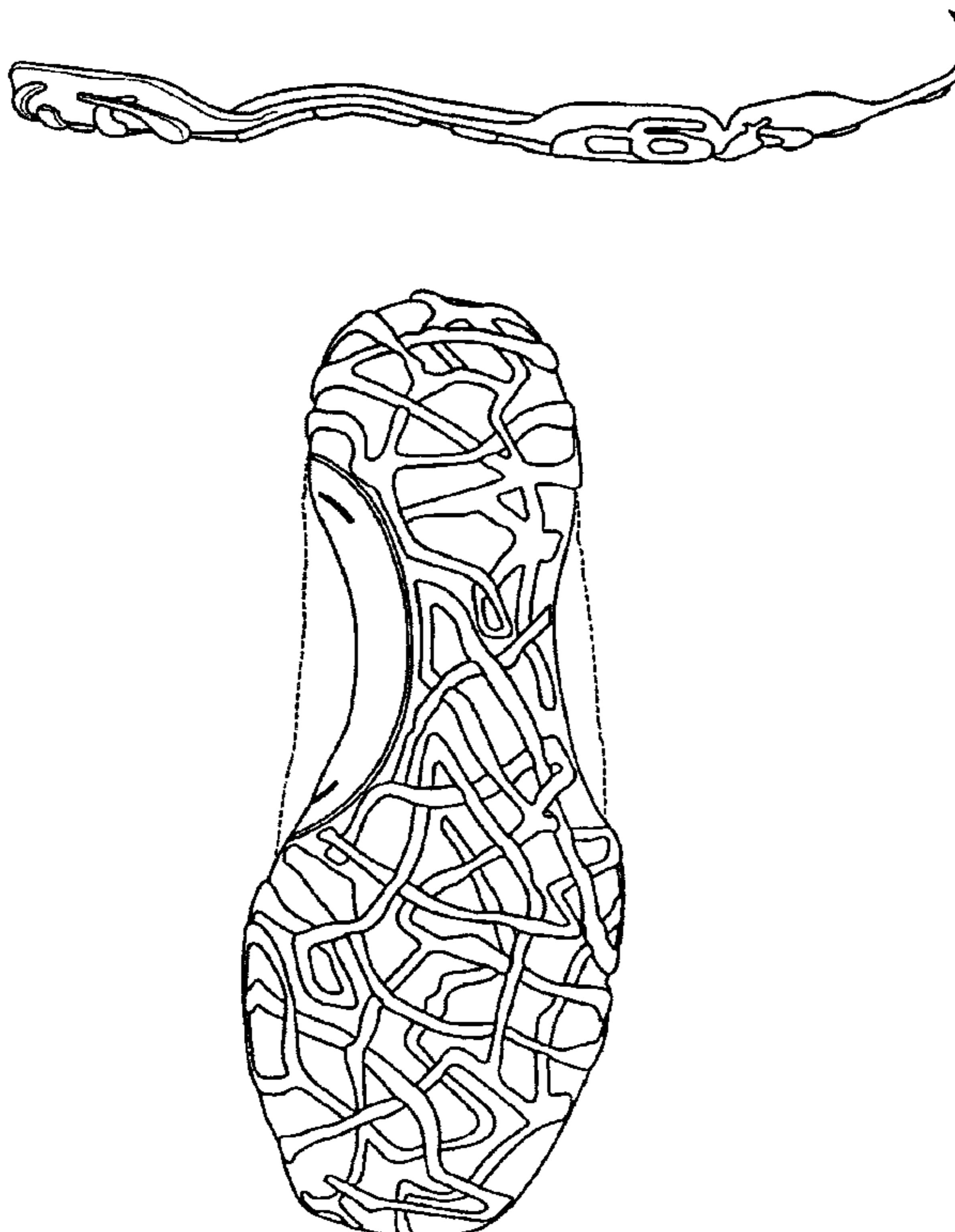
(57) **CLAIM**

The ornamental design for a footwear outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a footwear outsole showing our new design;

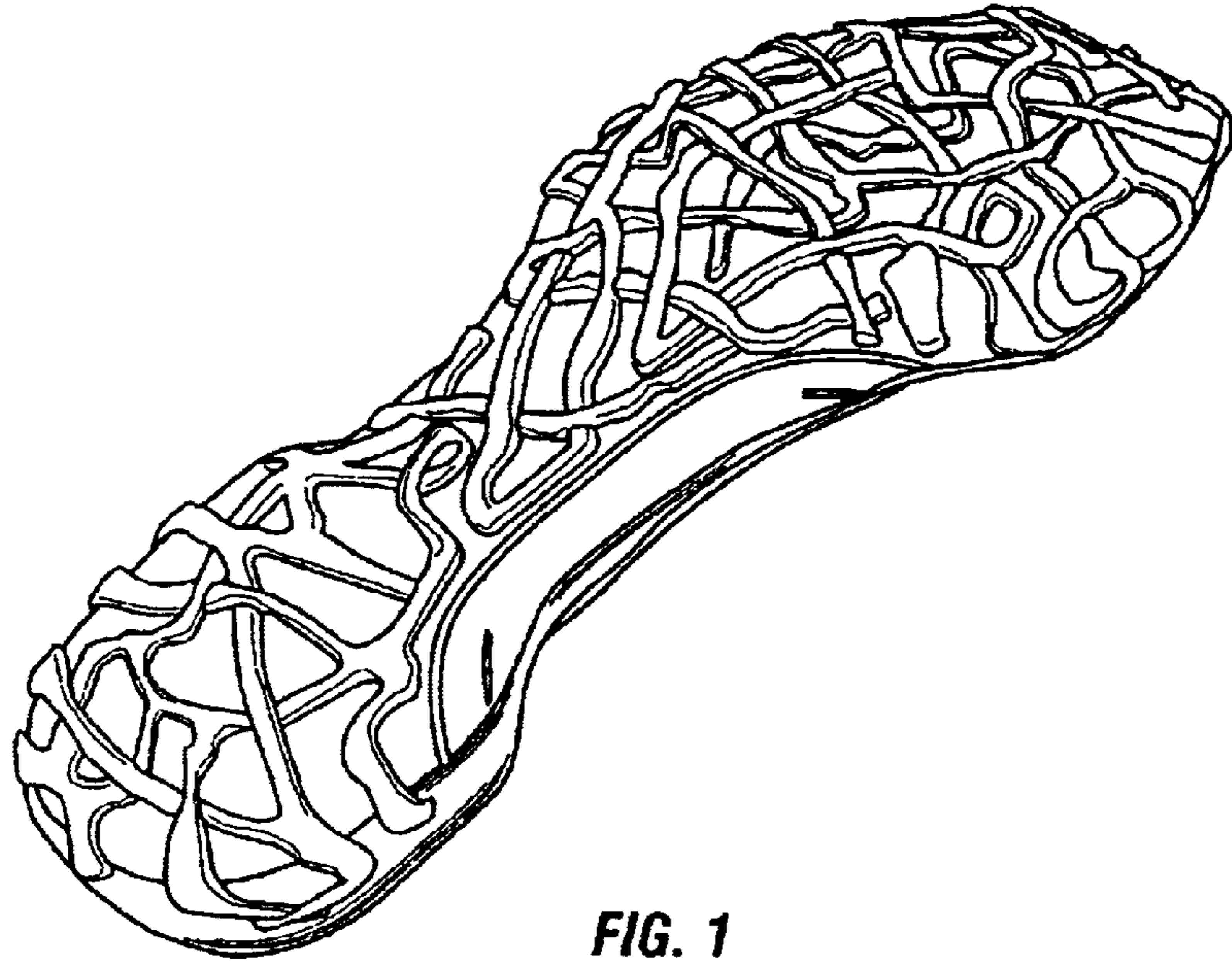

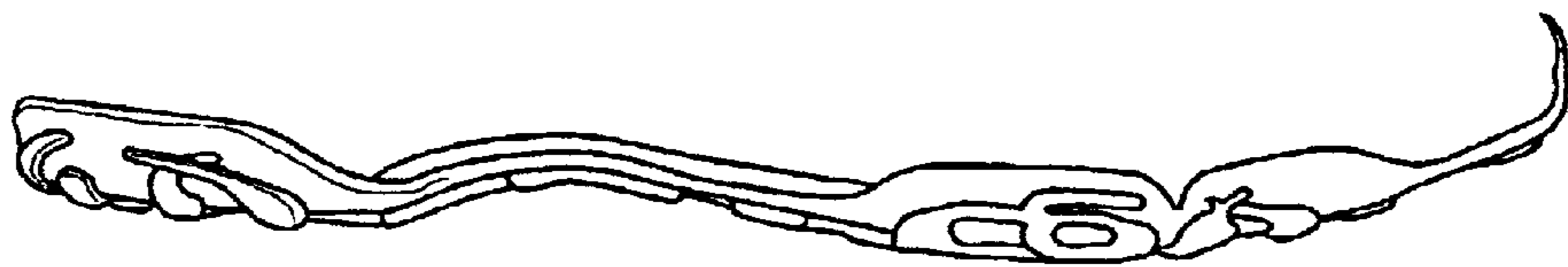

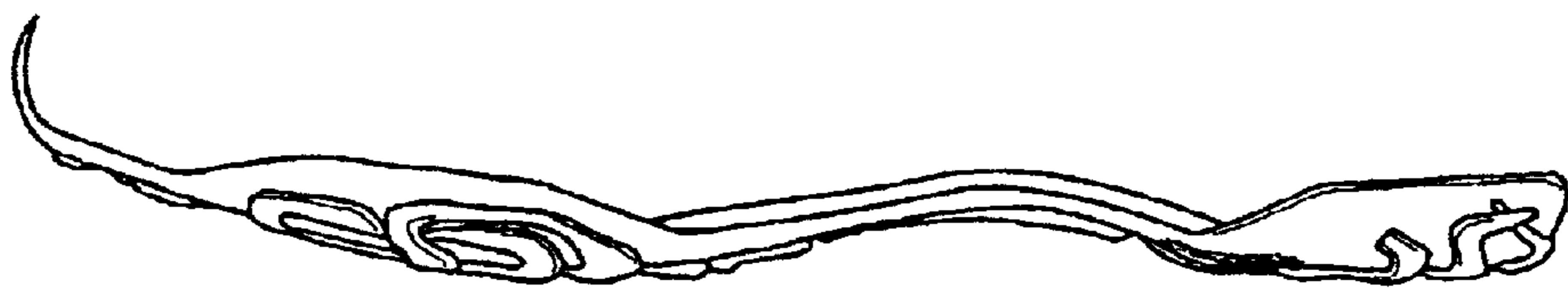
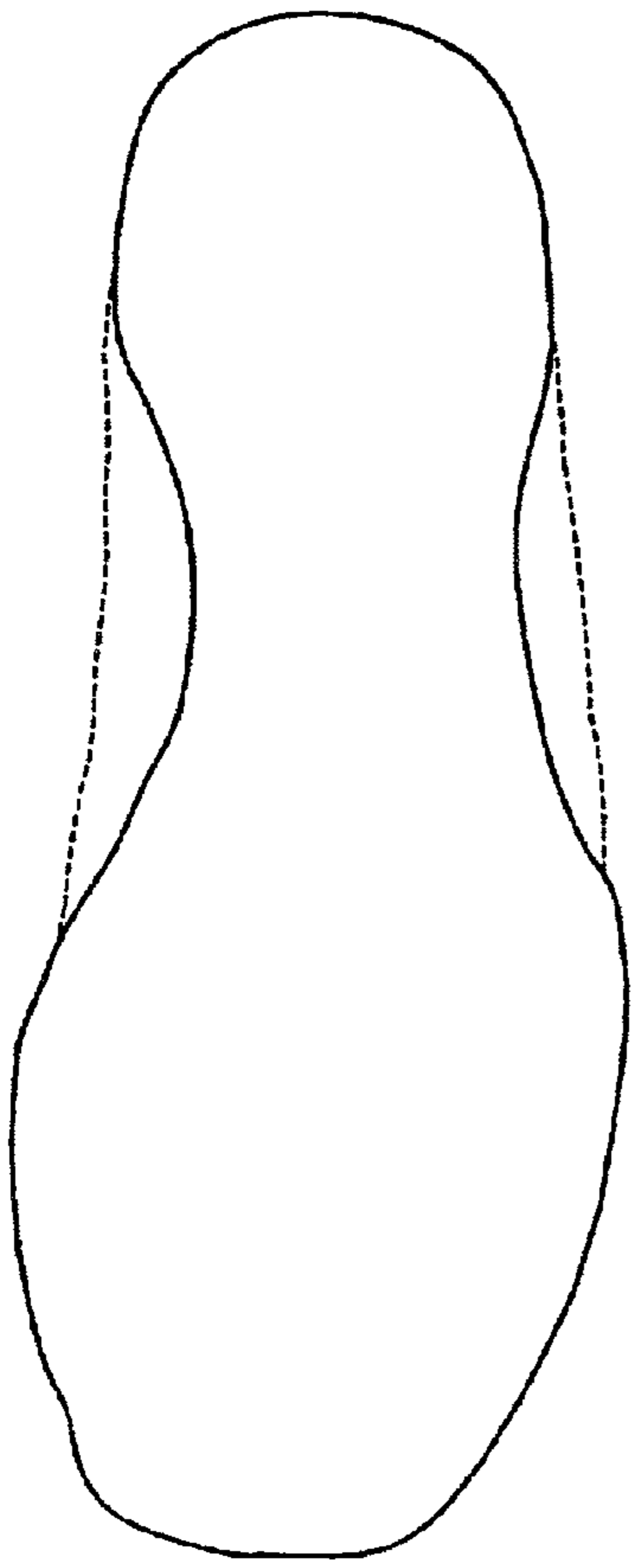
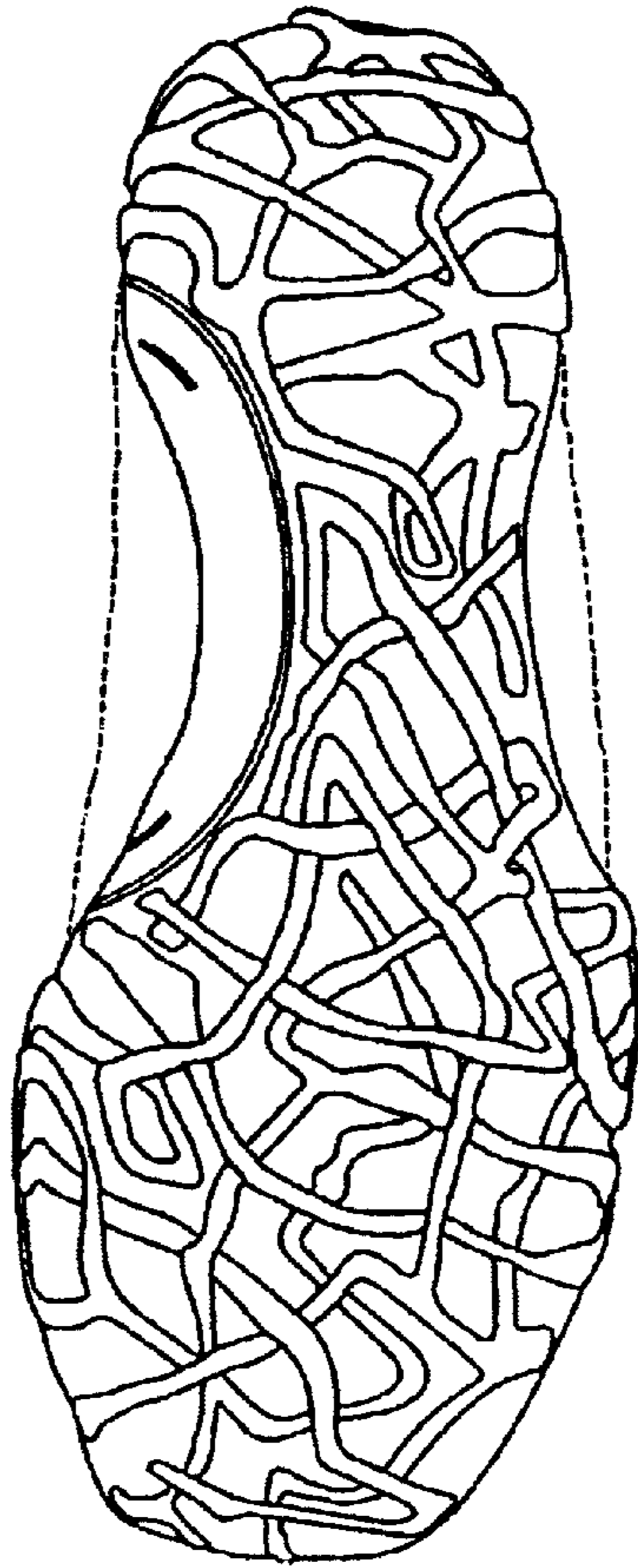
