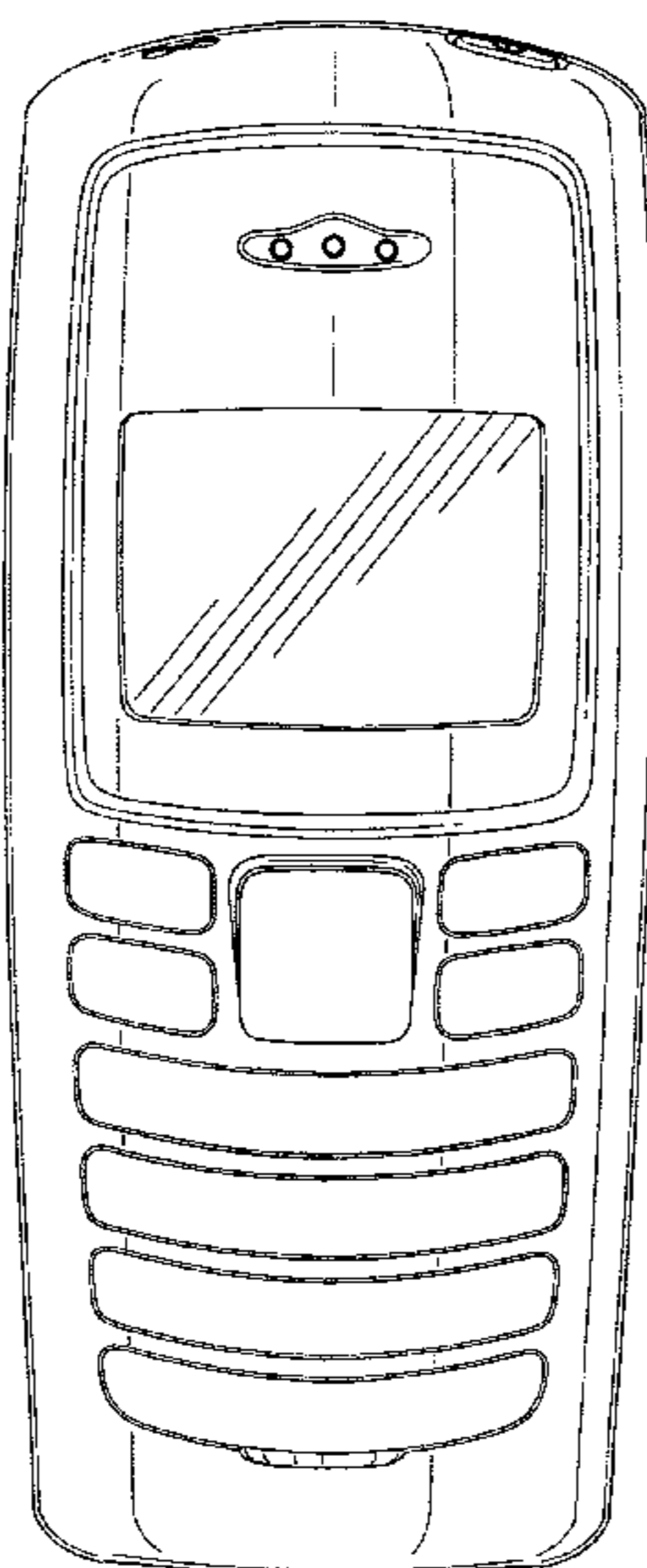
(57) **CLAIM**

I claim the ornamental design for a front cover for a handset, as shown and described.

DESCRIPTION

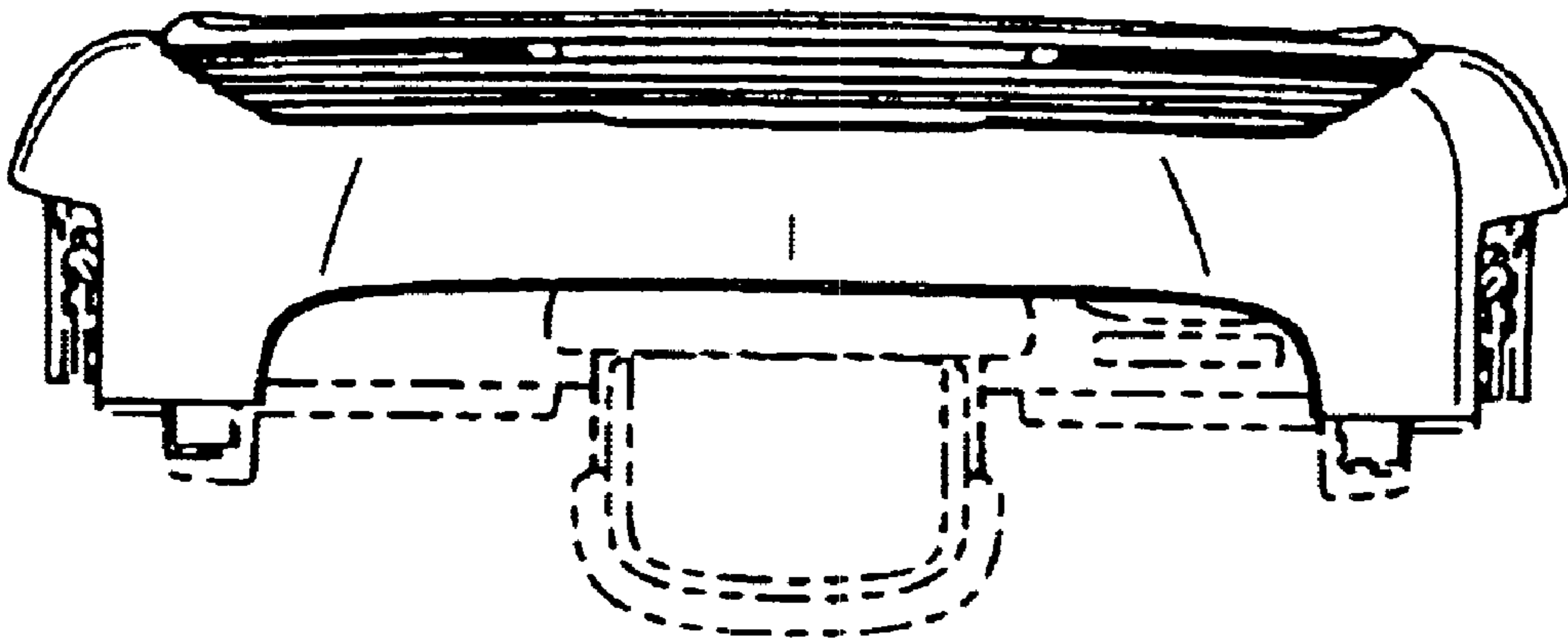

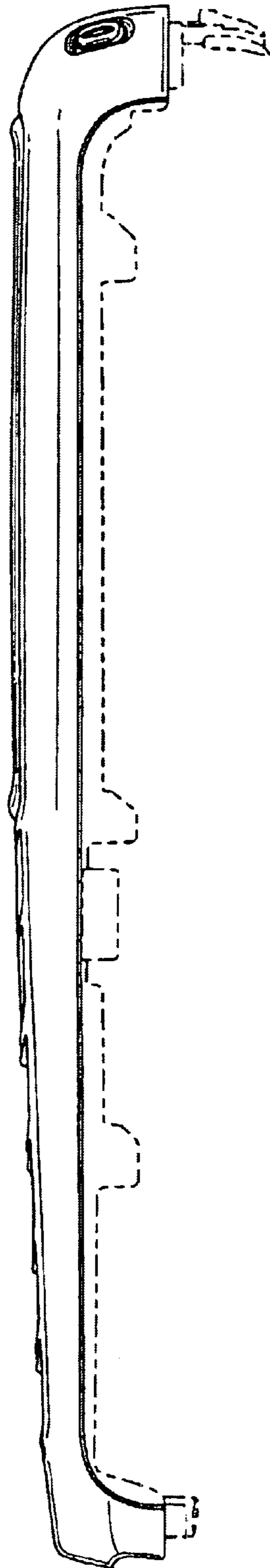

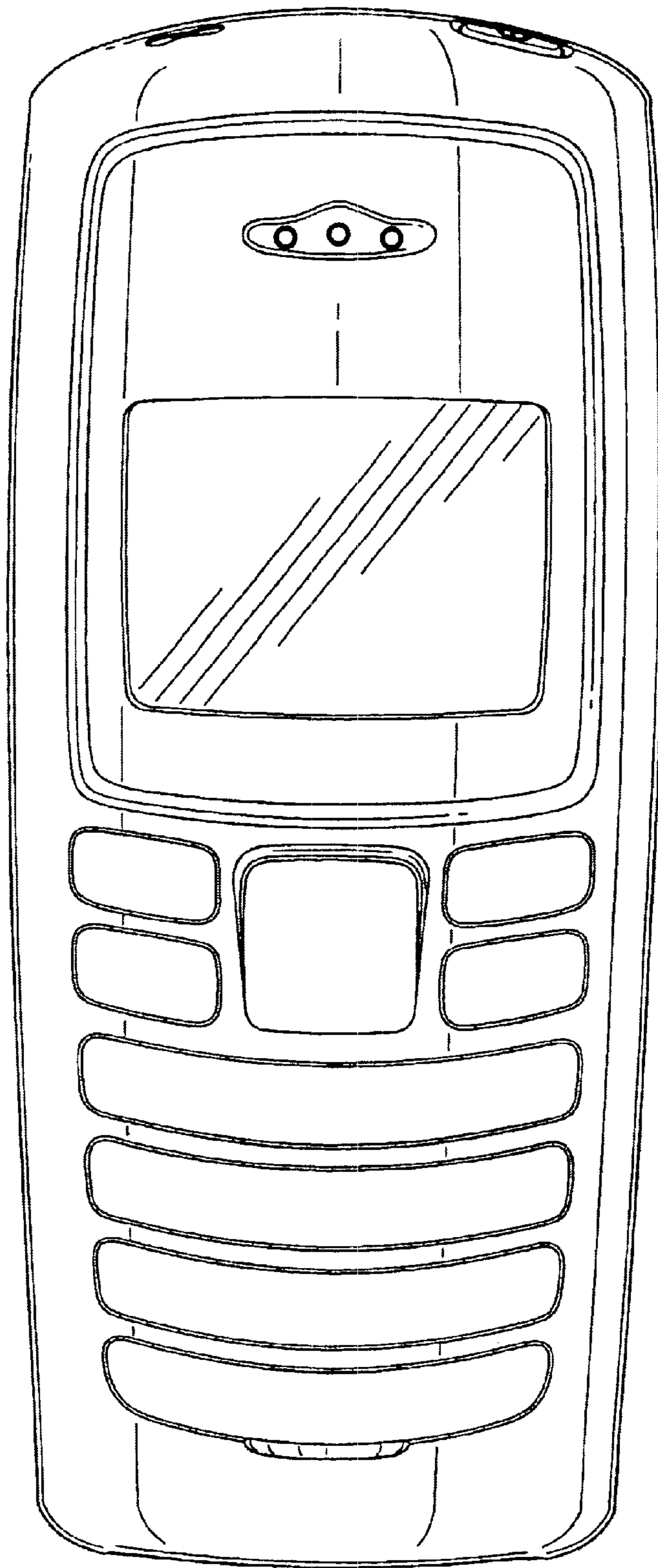

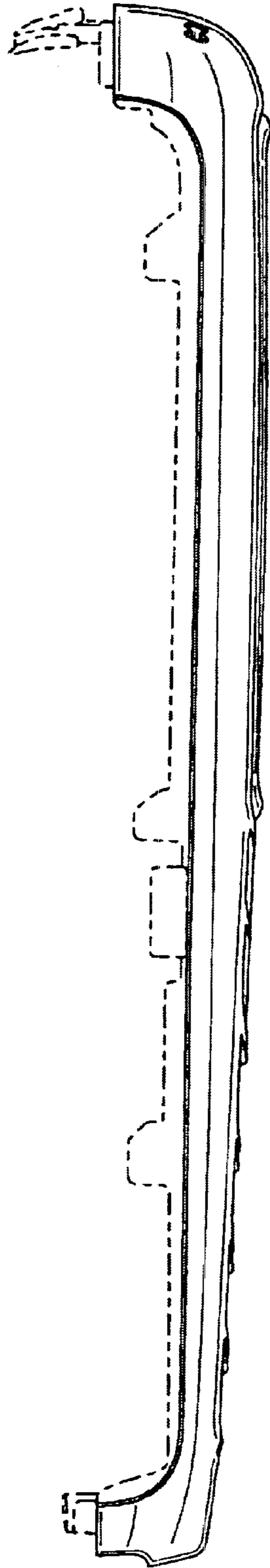

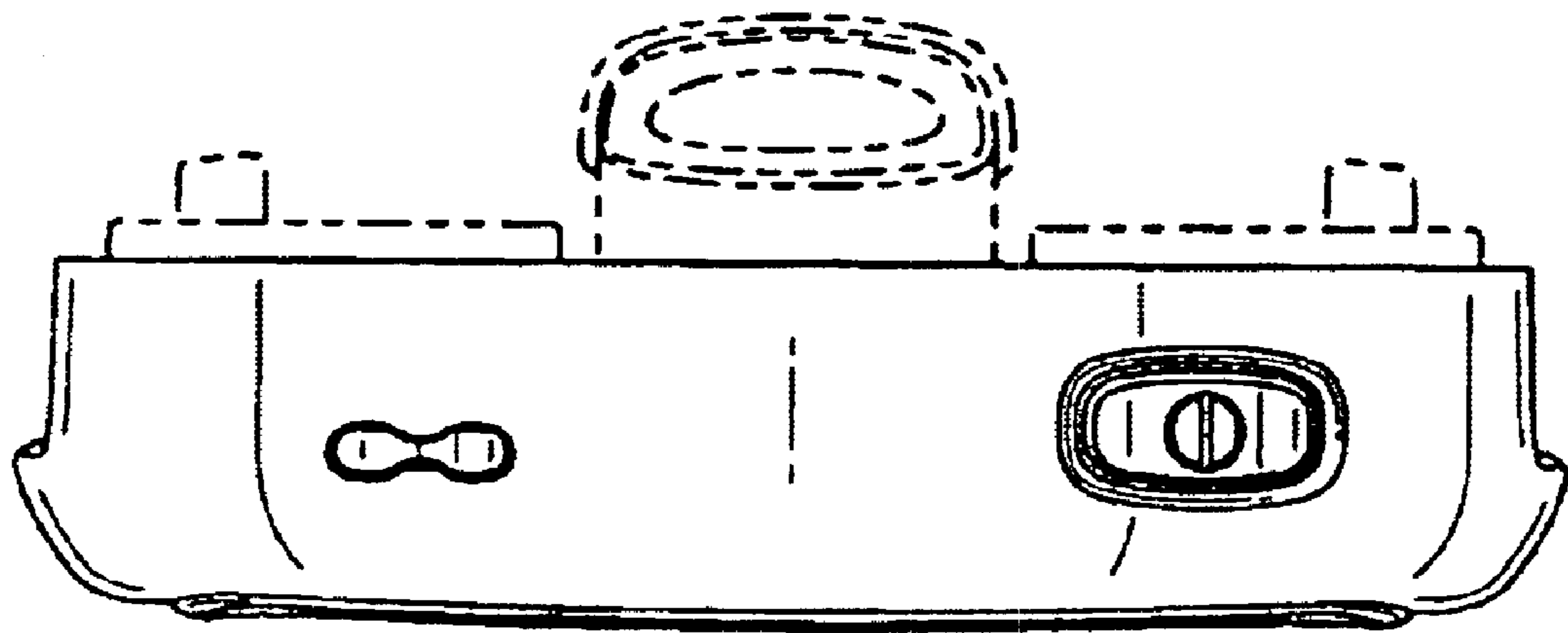

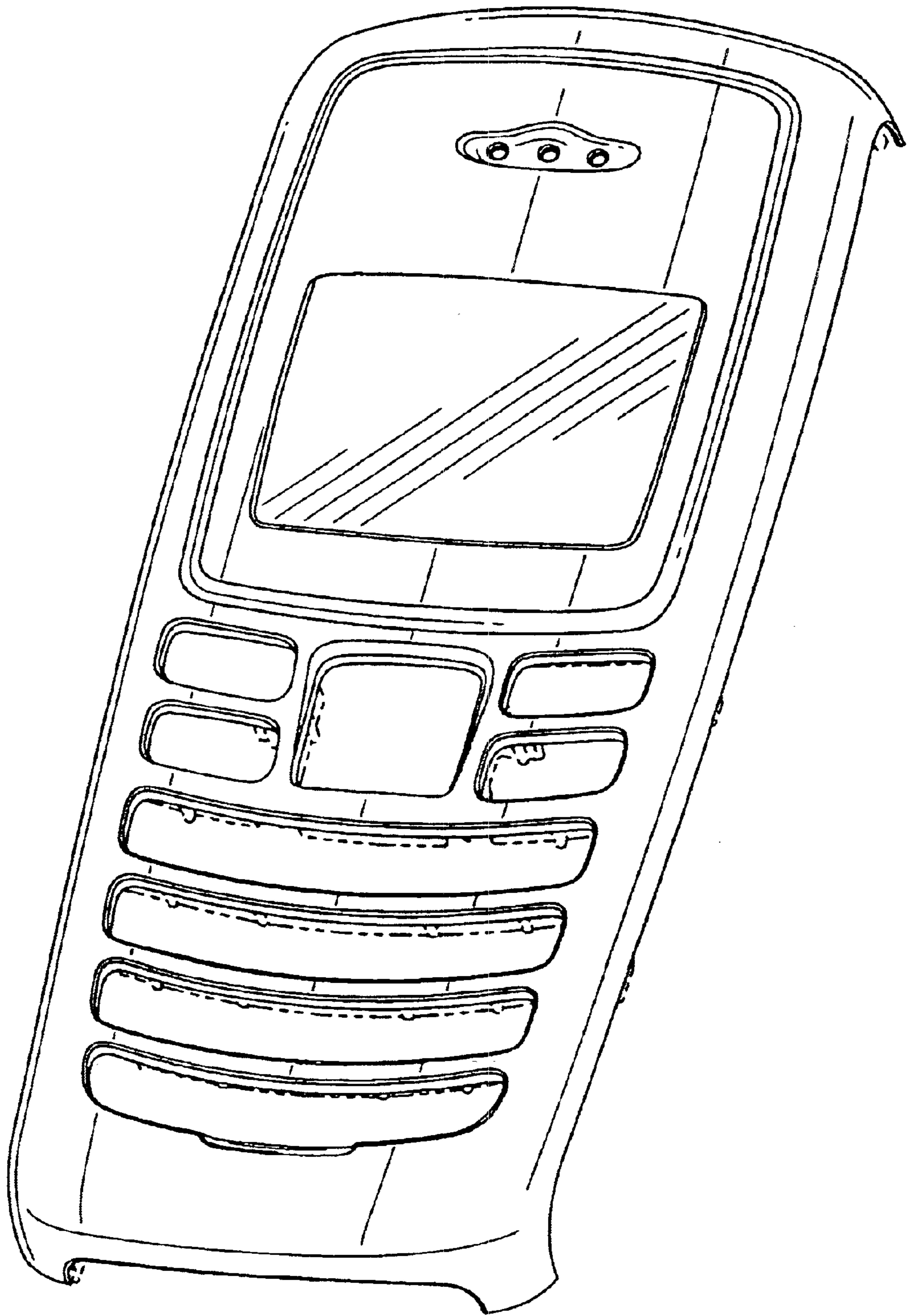
