The ornamental design for a user interface for computer display, as shown and described.

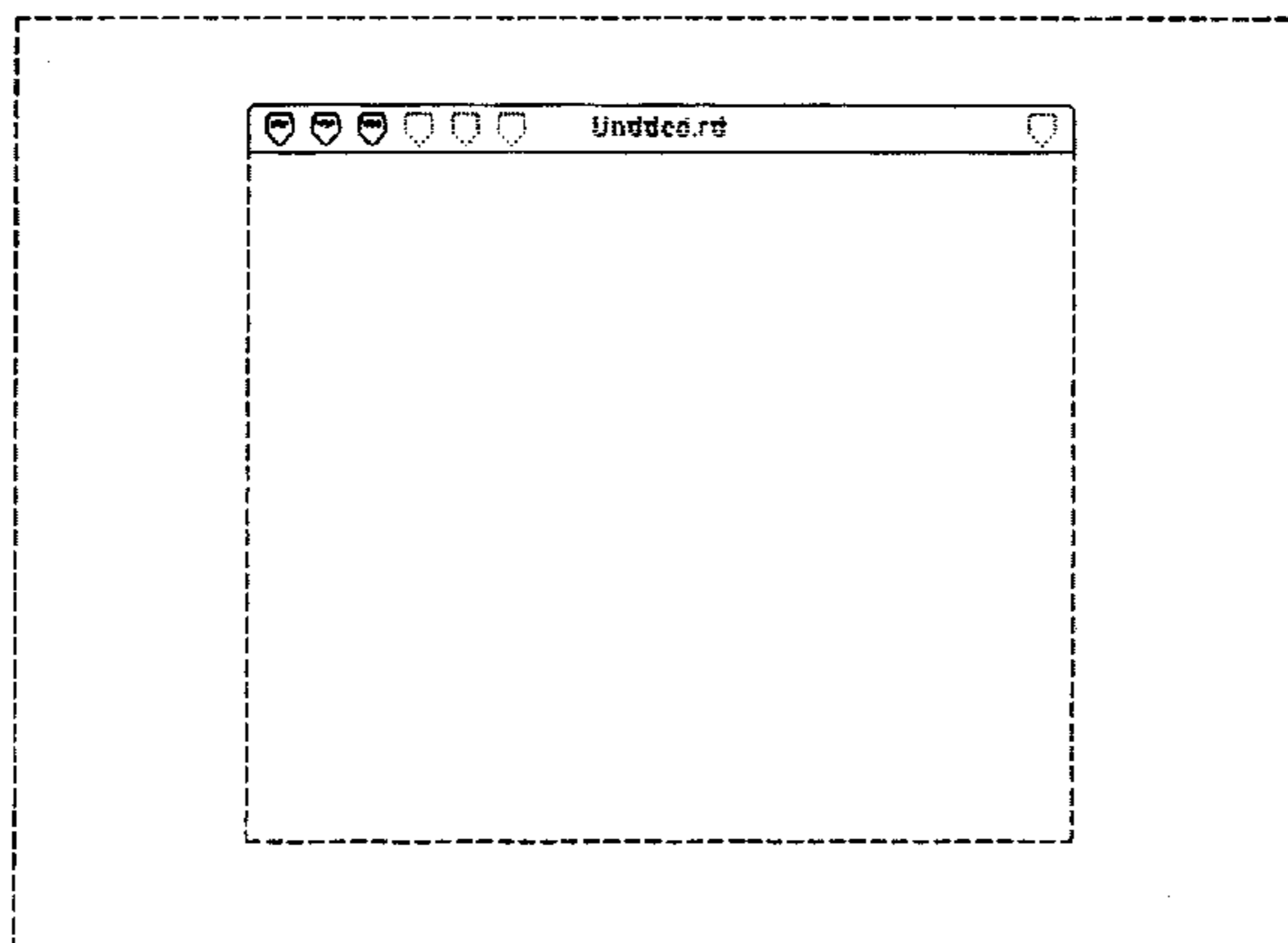
DESCRIPTION

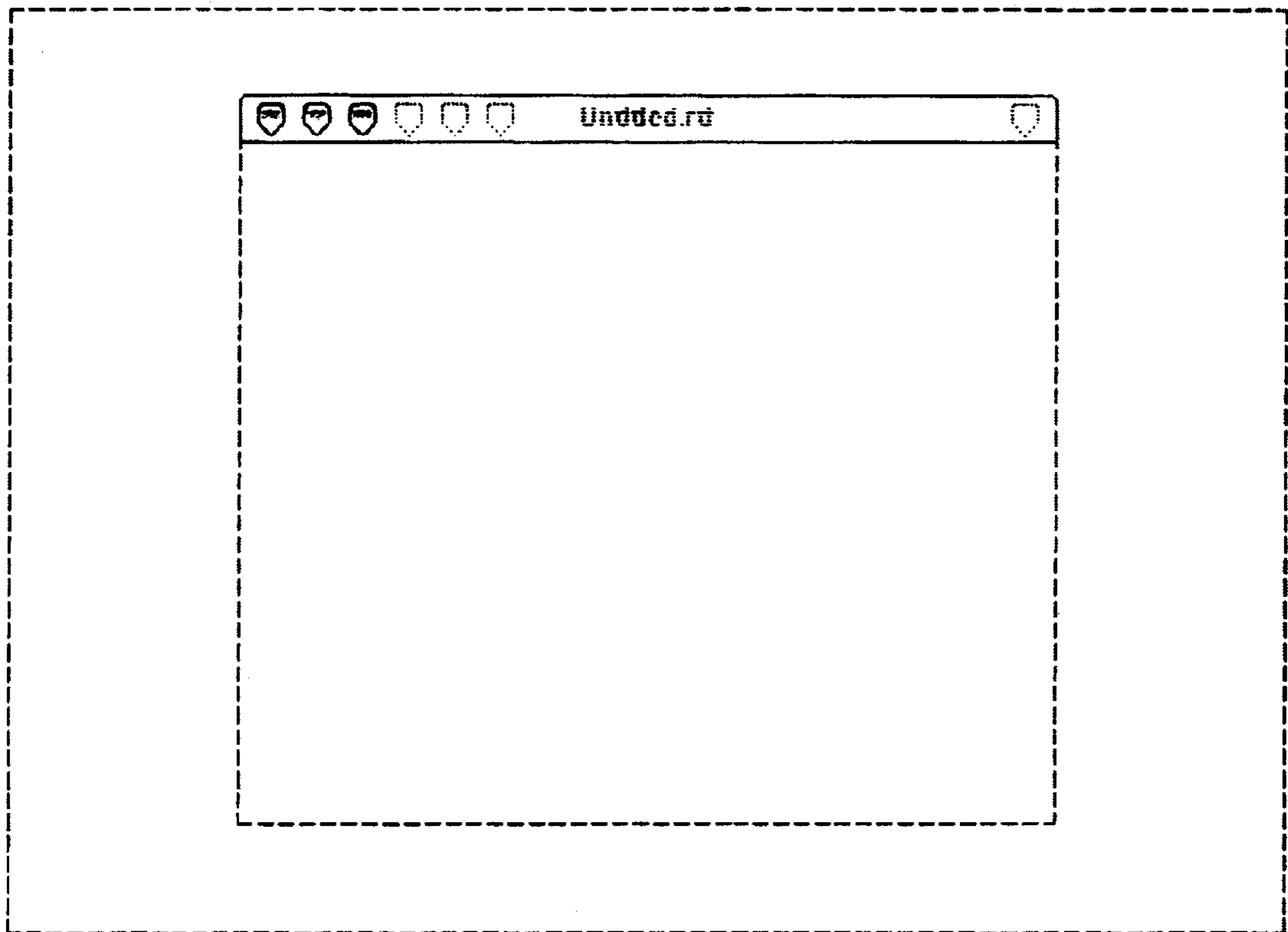

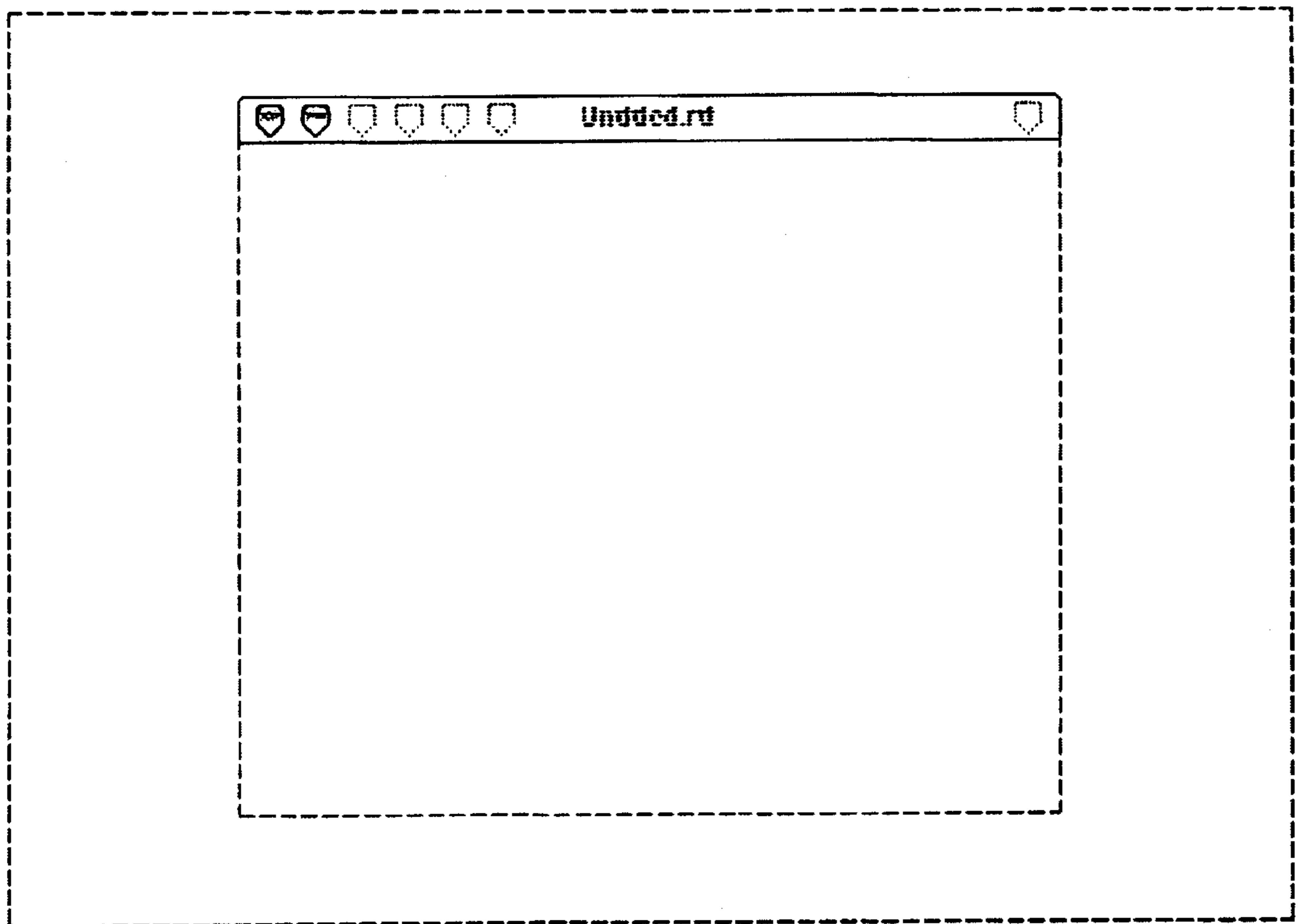
