(57) **CLAIM**

The ornamental design for a golf club head with dual grid faceplate groove pattern, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the top, front and toe end sides of a golf club head embodying the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a toe end elevational view thereof;

FIG. 4 is a heel end elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective showing the top, front and toe end sides of a golf club head embodying a first alternative of the new design;

FIG. 9 is a front elevation view of the embodiment of FIG. 8;

FIG. 10 is a top plan view of the embodiment of FIG. 8;

FIG. 11 is a perspective view showing the top, front and toe end sides of a golf club head embodying a second alternative of the new design;

FIG. 12 is a front elevation view of the embodiment of FIG. 11;

FIG. 13 is a top plan view of the embodiment of FIG. 11;

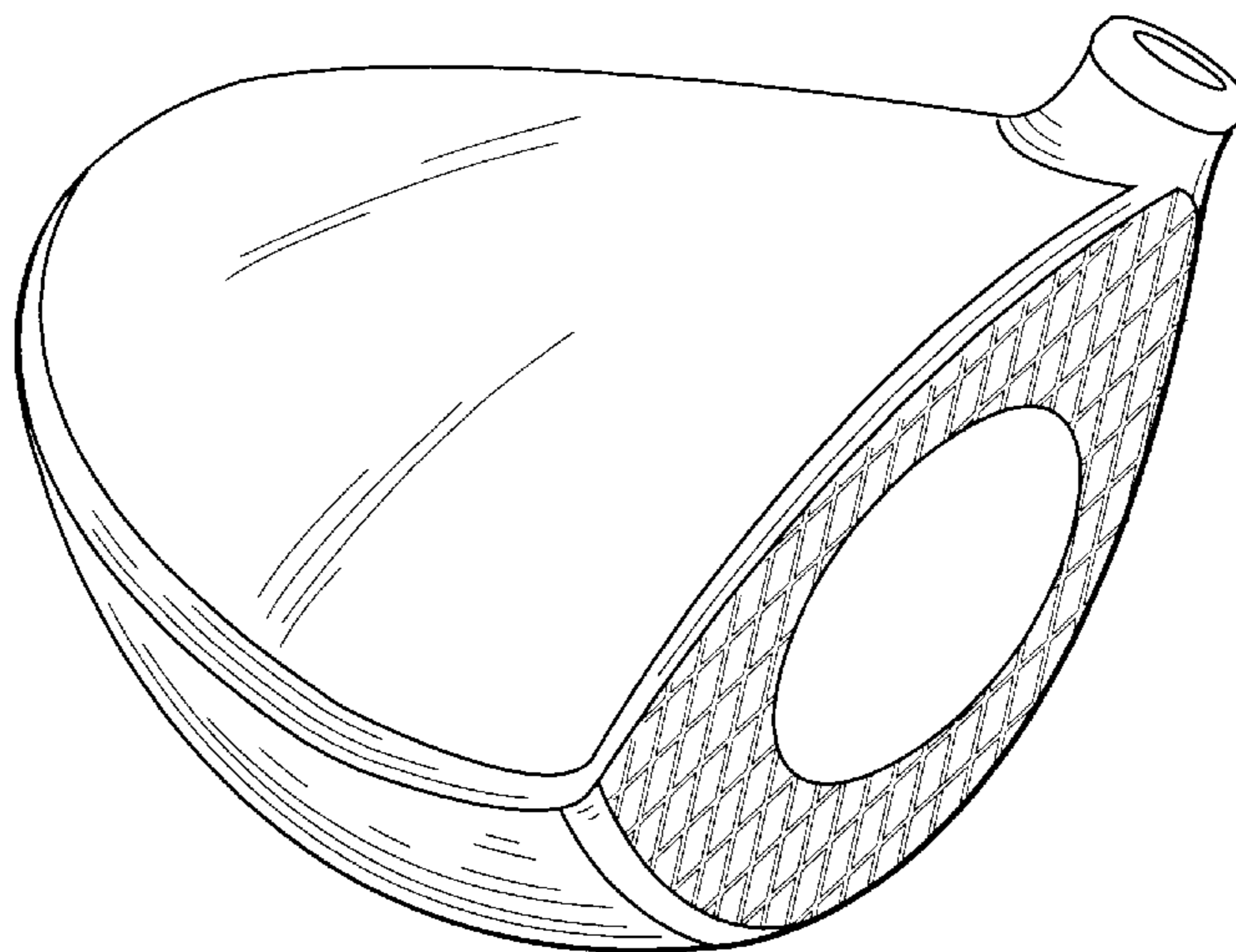
FIG. 14 is a perspective view showing the top, front and toe end sides of a golf club head embodying a third alternative of the new design;

FIG. 15 is a front elevation view of the embodiment of FIG. 14; and,

FIG. 16 is a top plan view of the embodiment of FIG. 14.

The toe end, heel end, rear elevation, and bottom plan views of each of the first, second and third alternative embodiments shown in FIGS. 8-16 are identical to FIGS. 2, 3, 5 and 7, respectively.

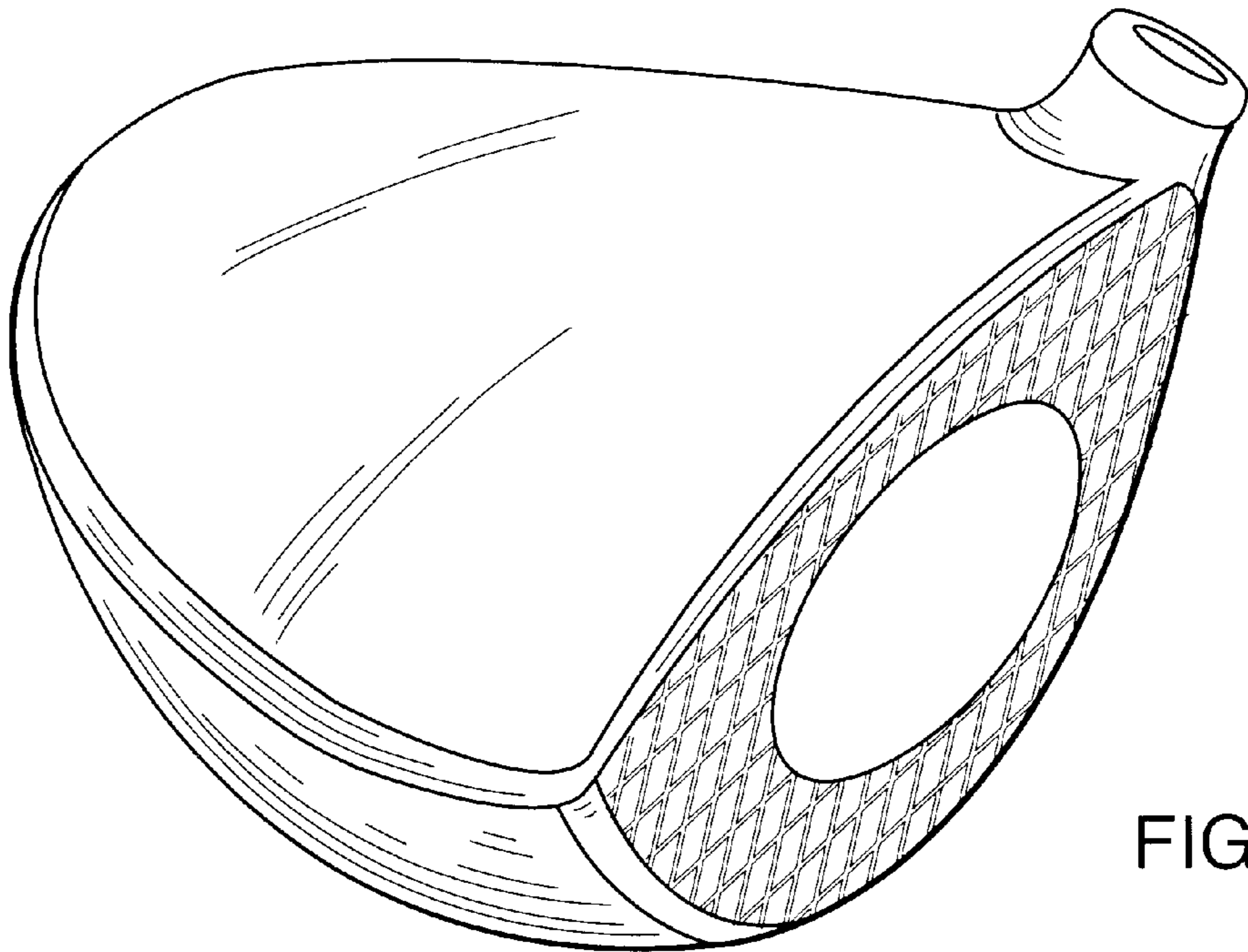

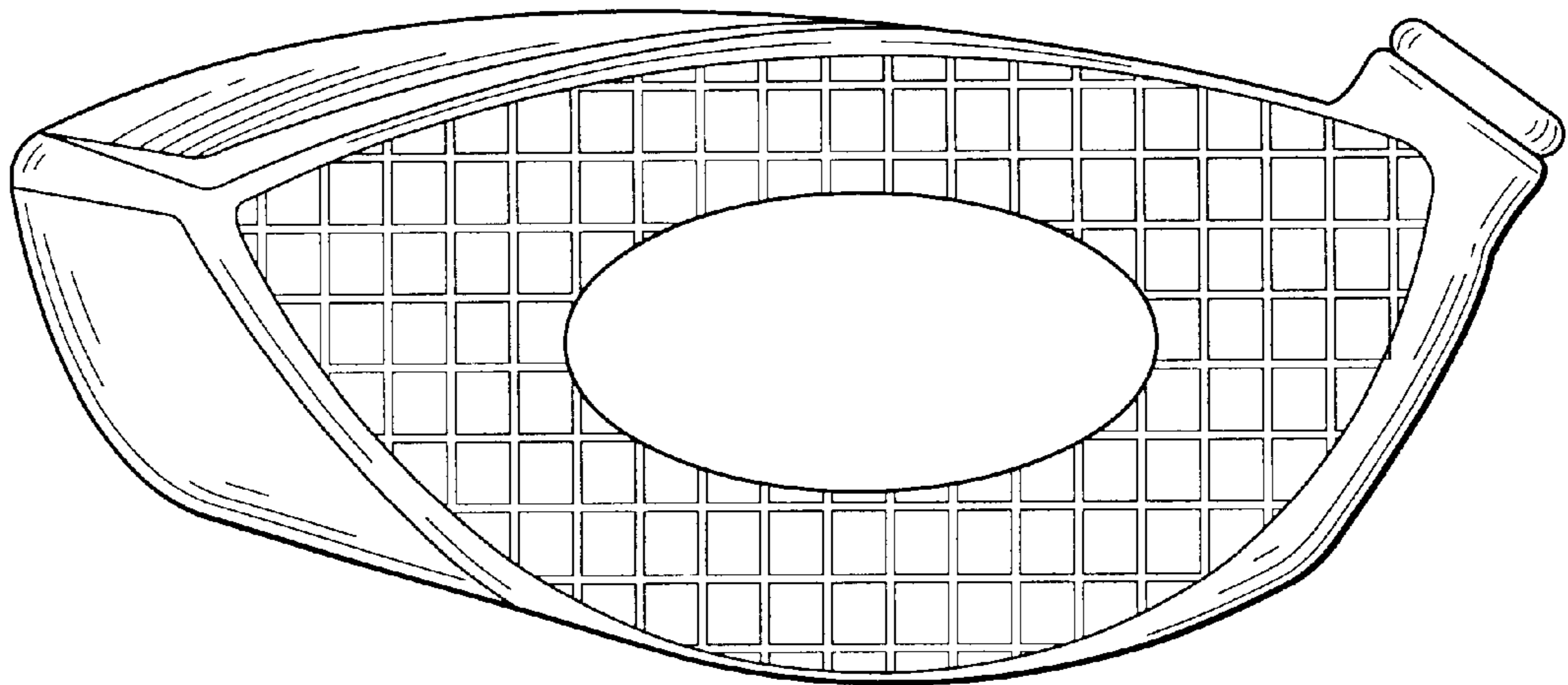

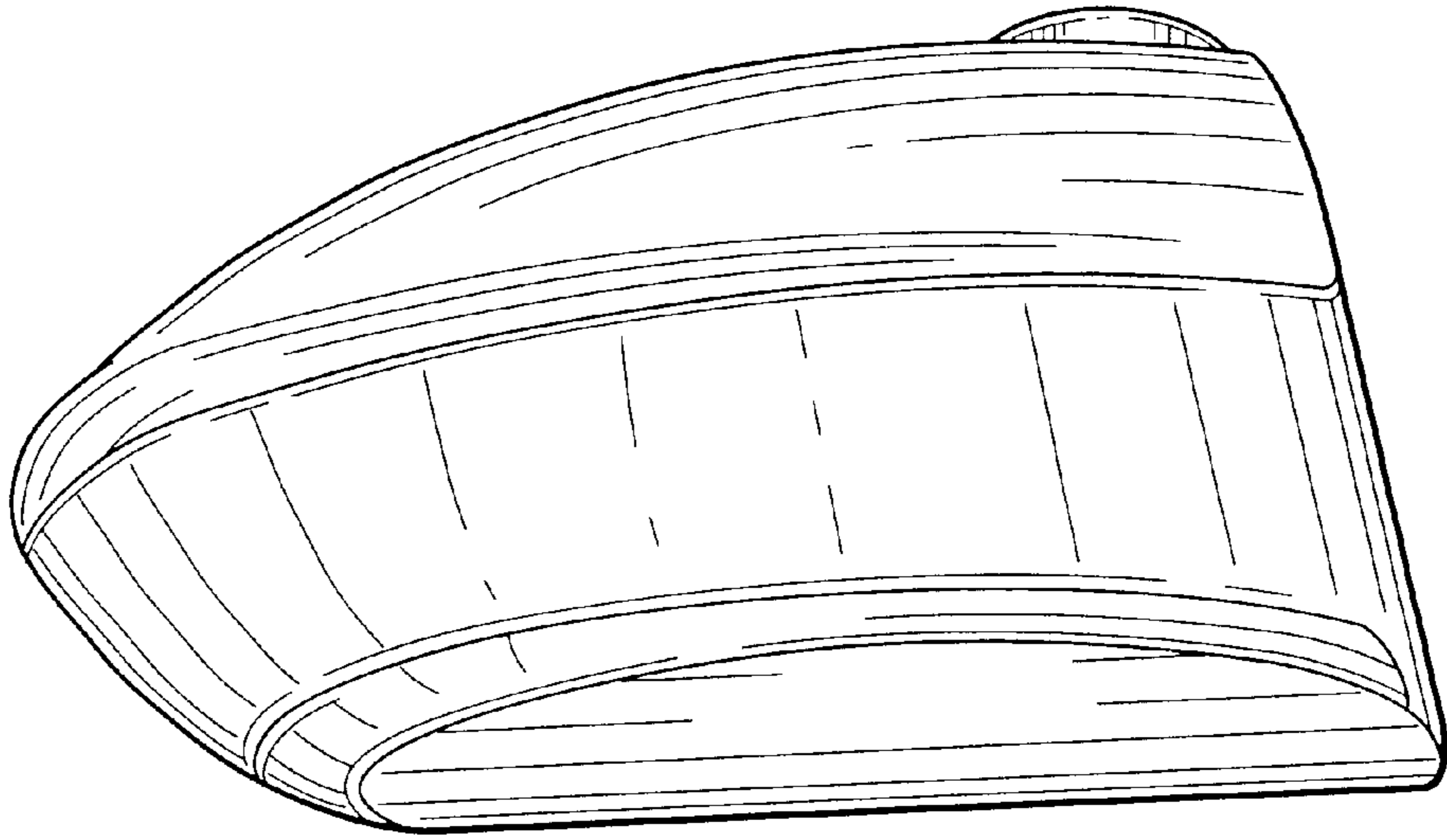

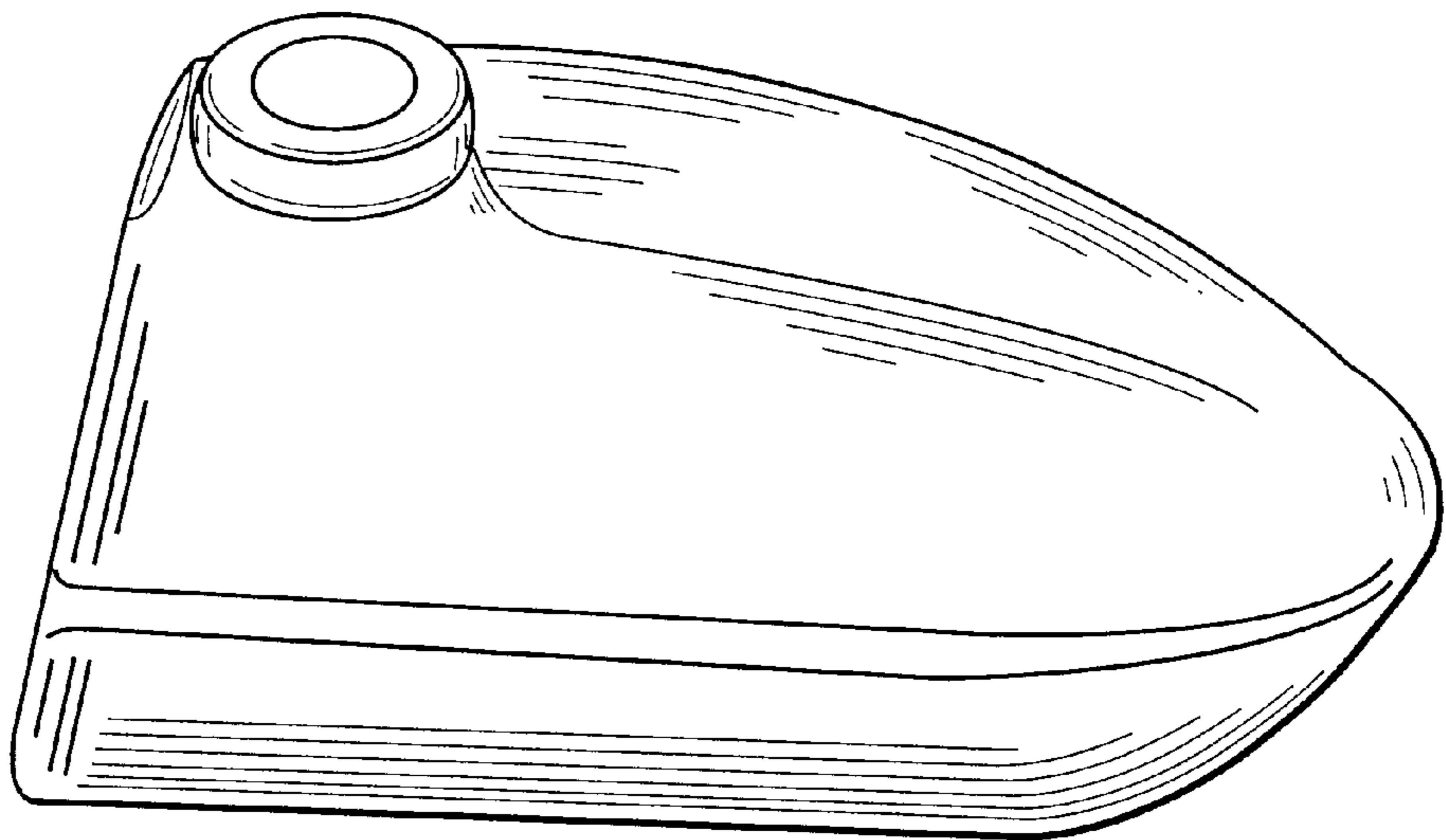

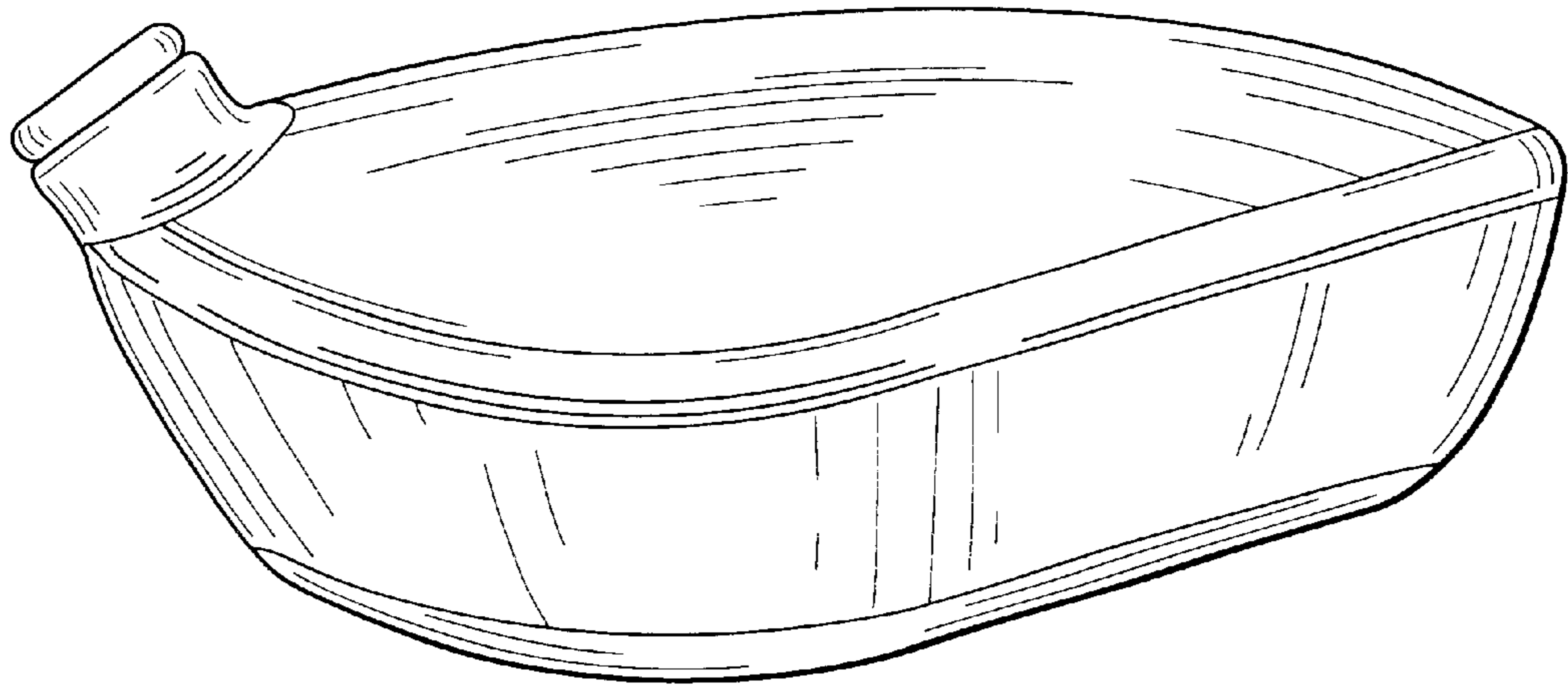

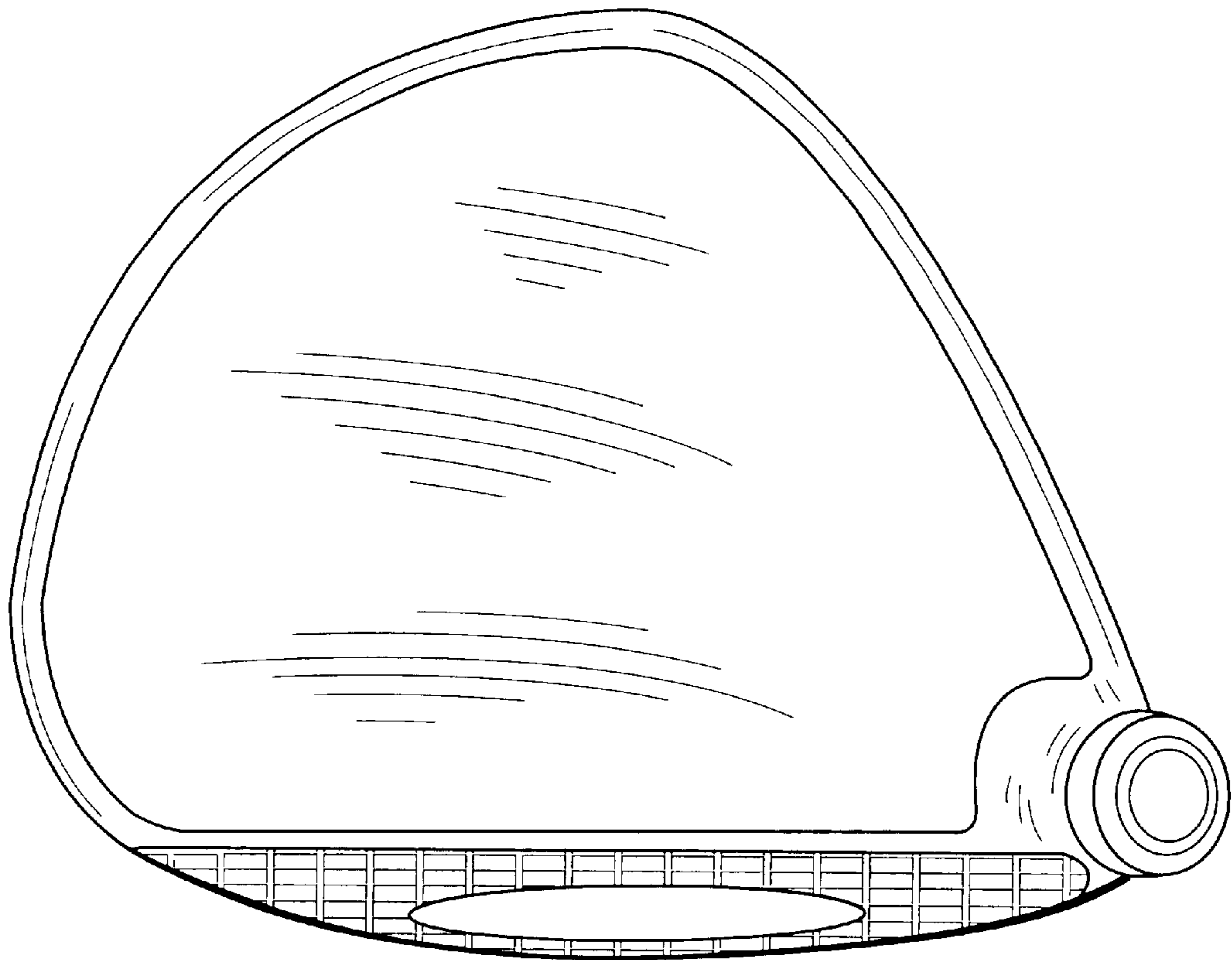

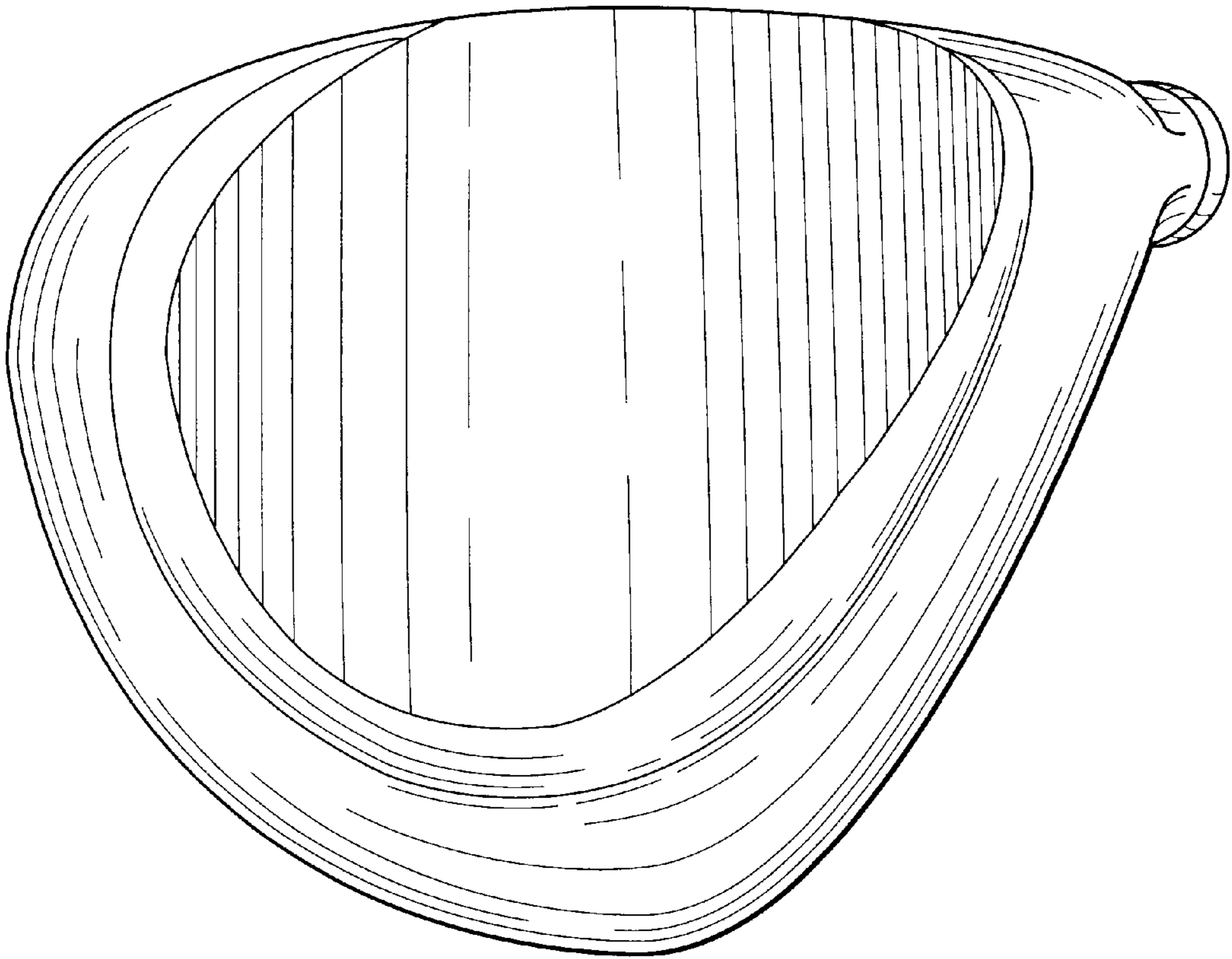

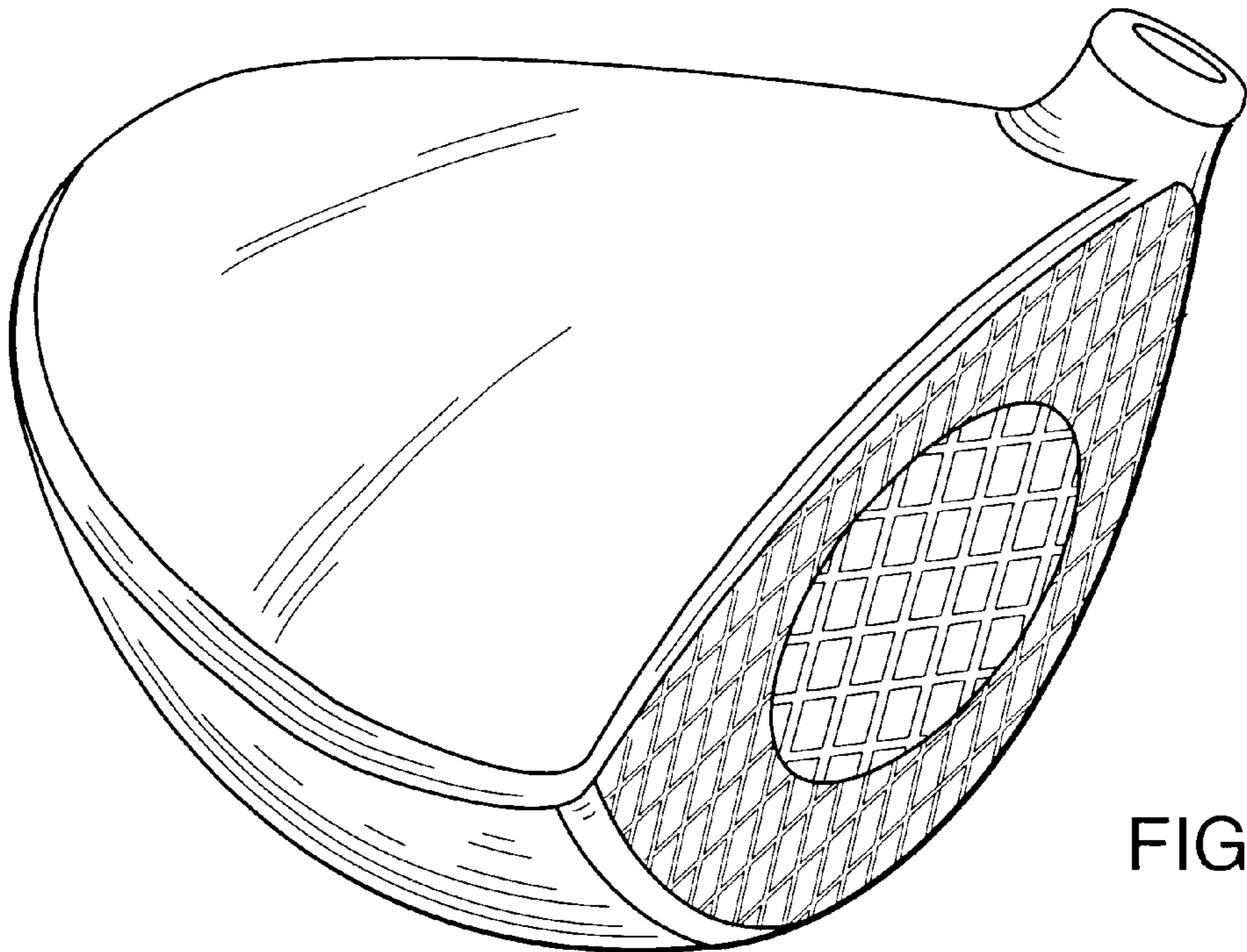

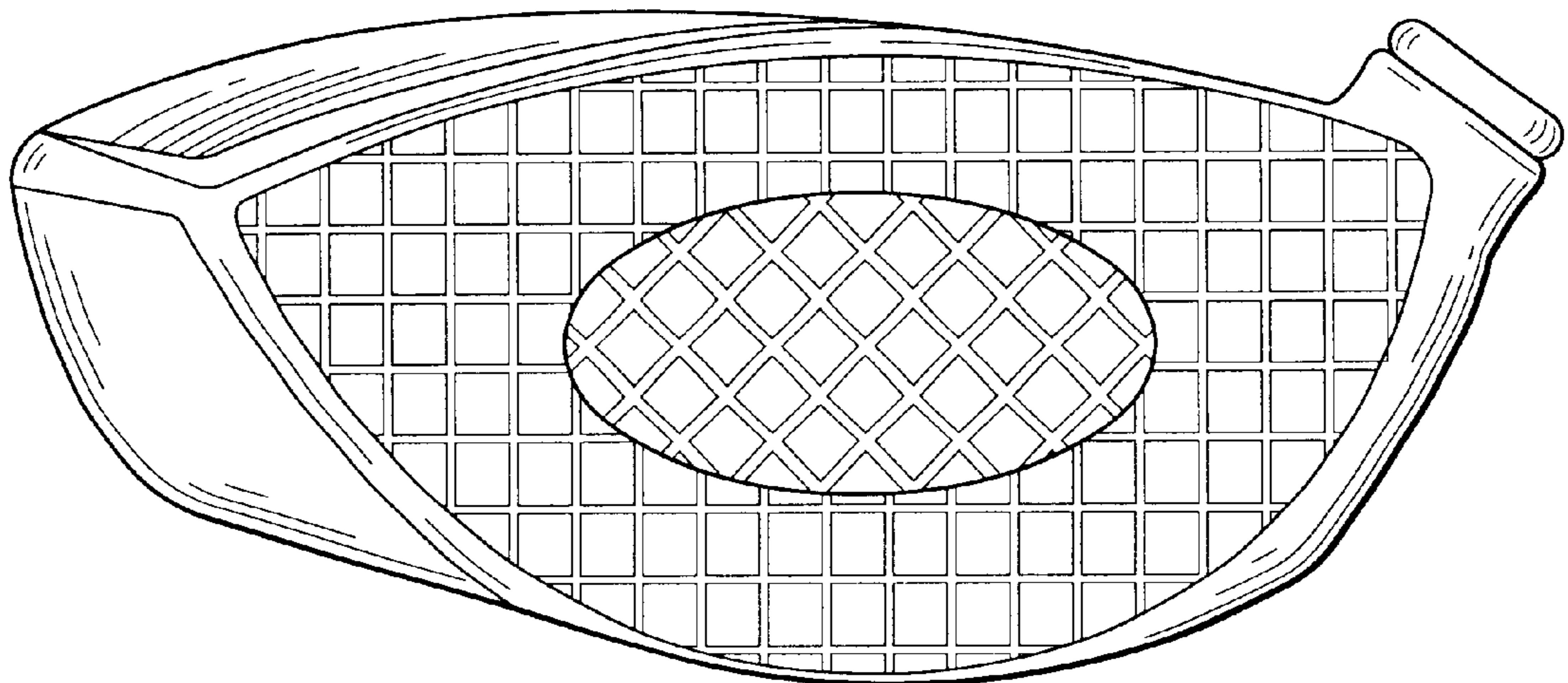

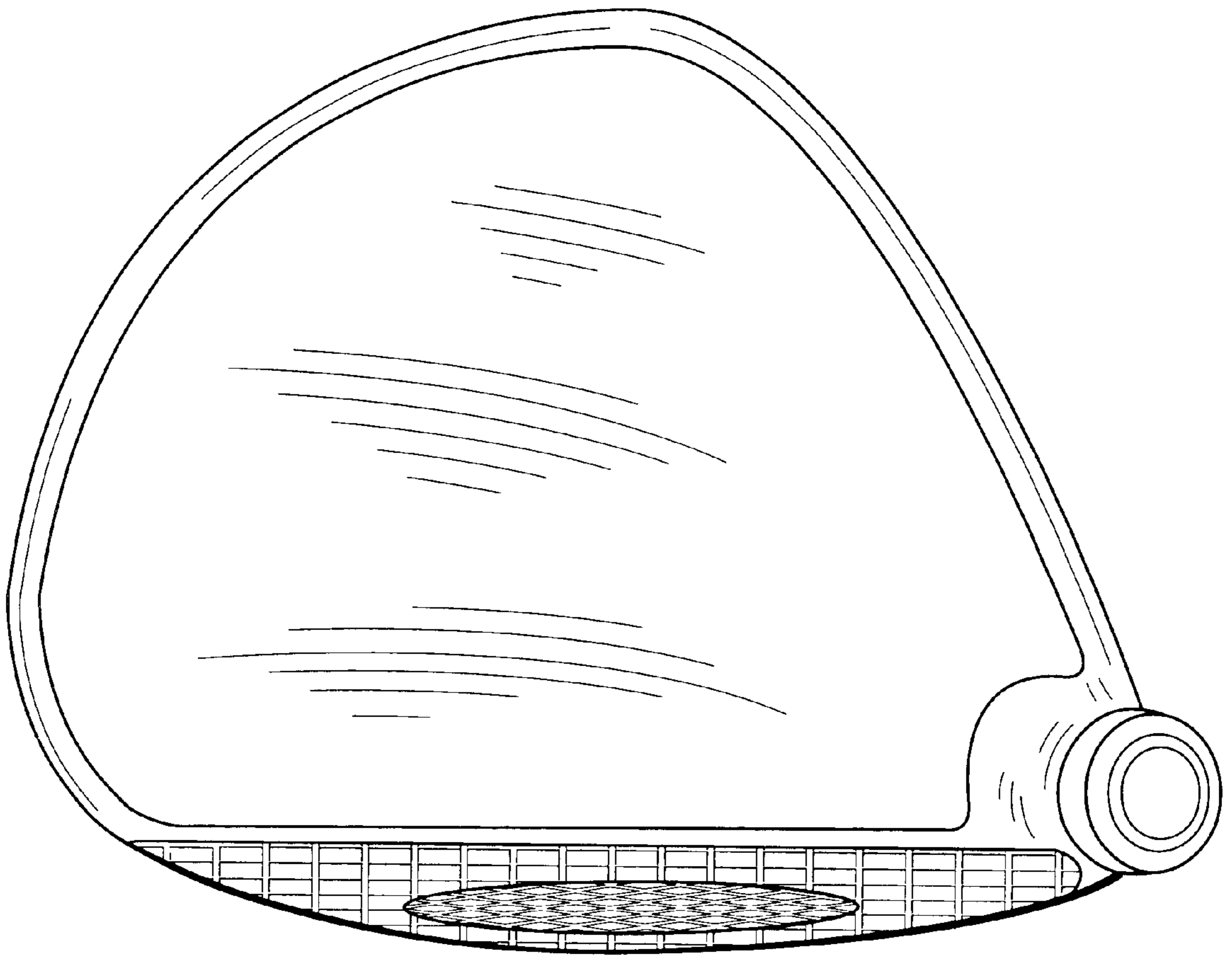

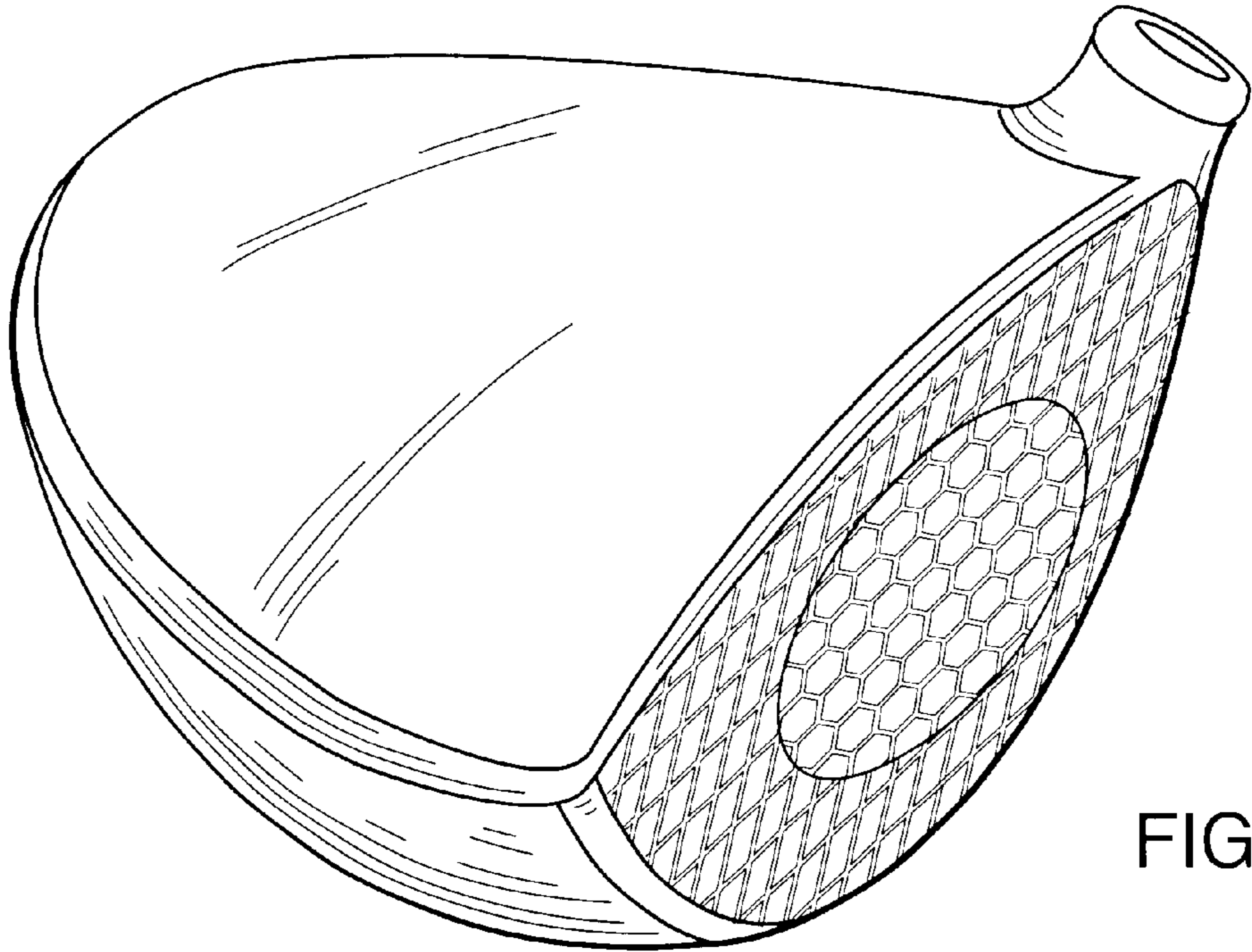

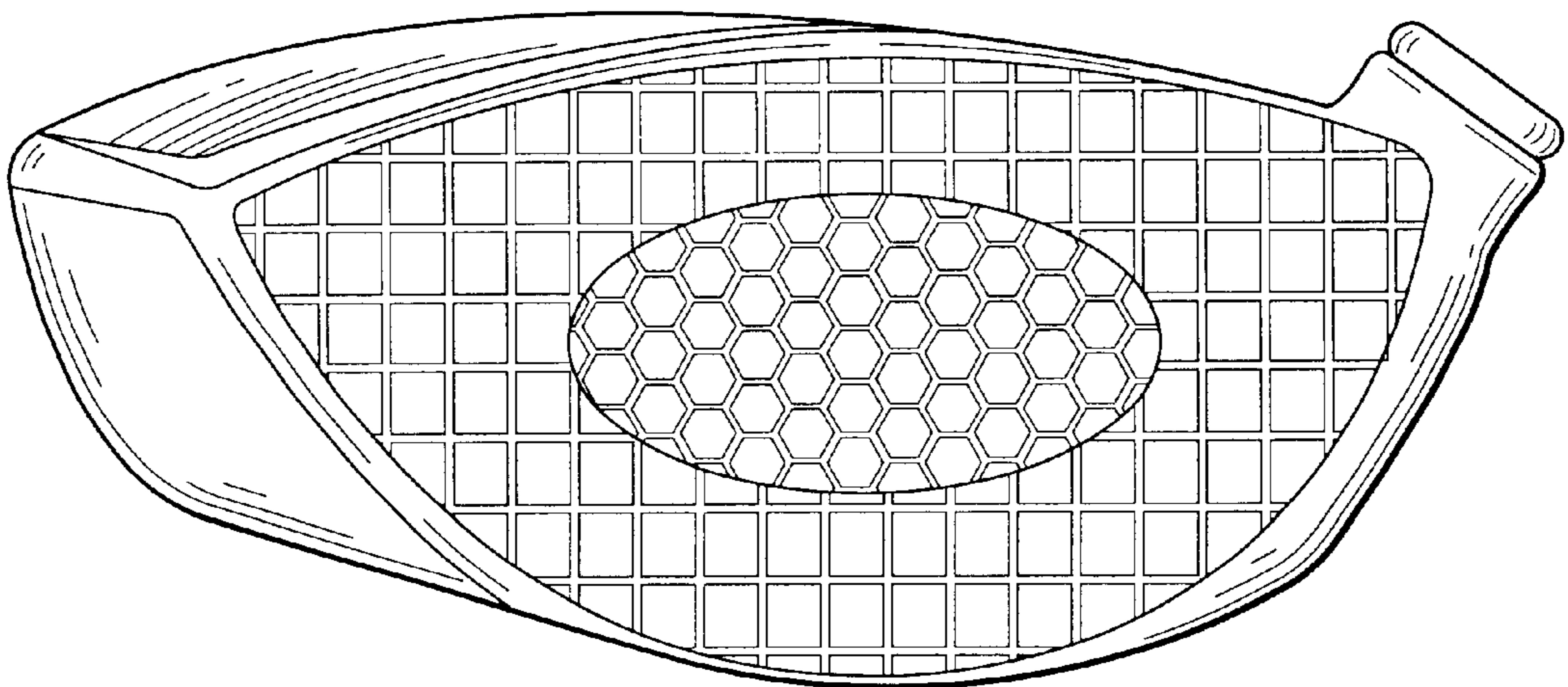

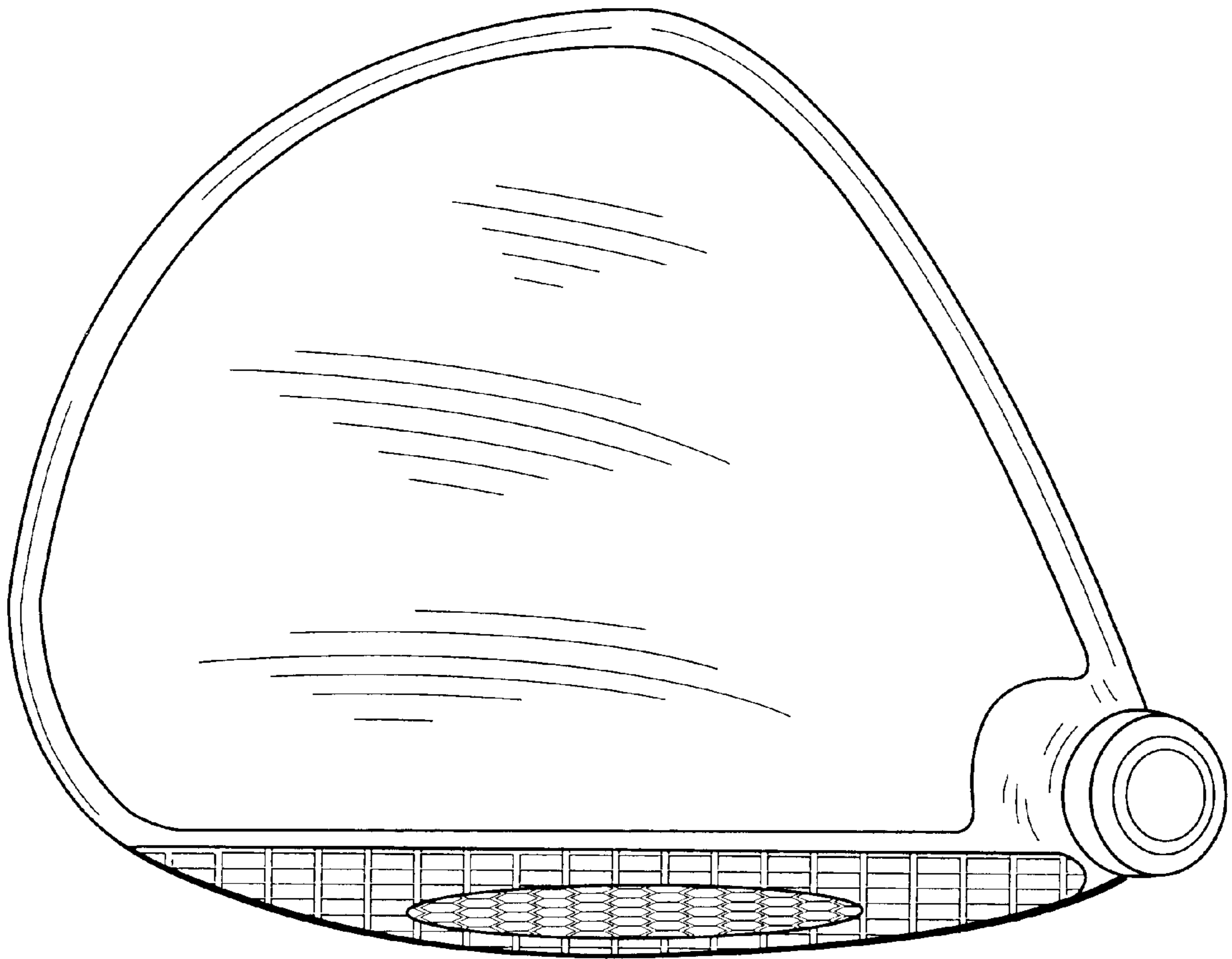

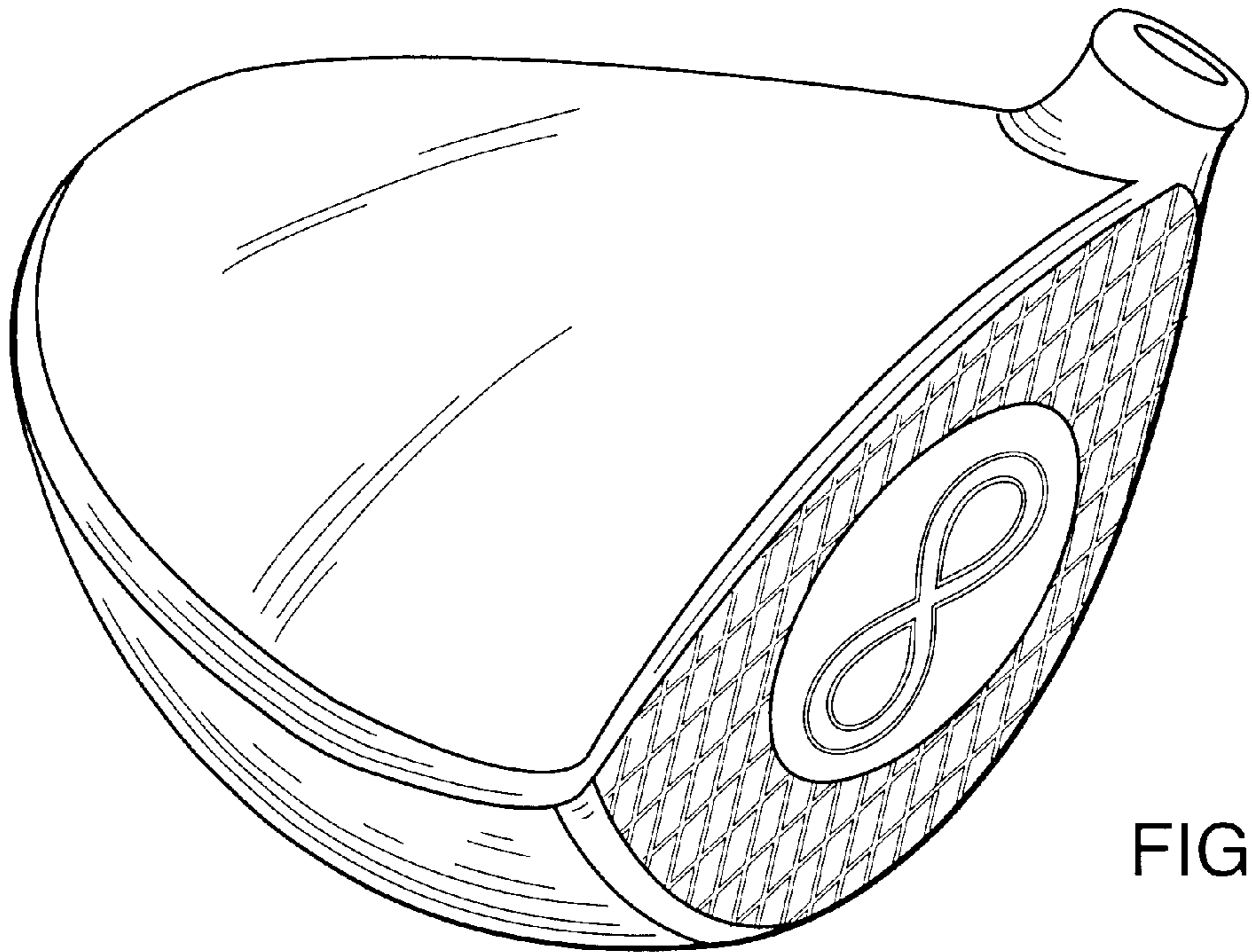

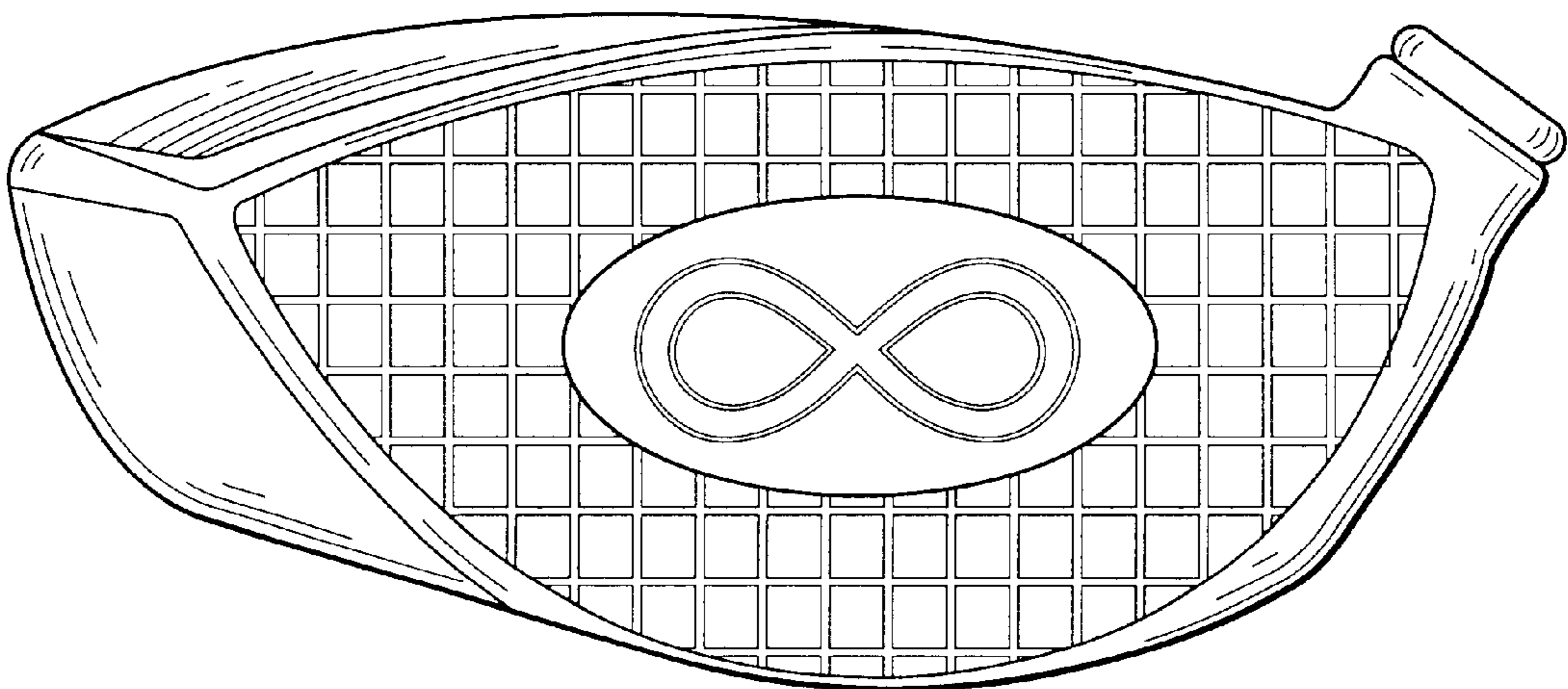

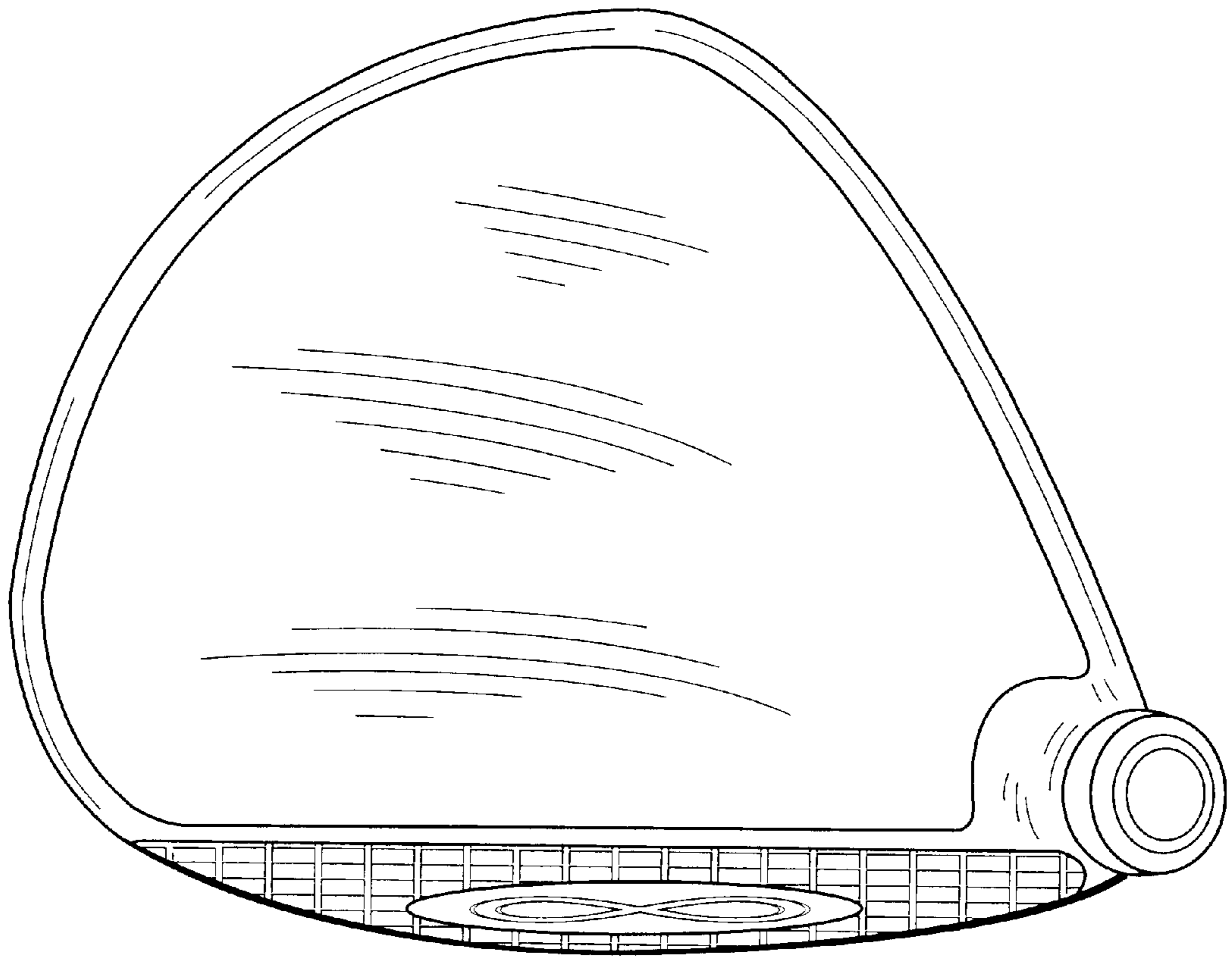
