FIG. 7 is a bottom plan view of the golf club head of FIG. 1; and,

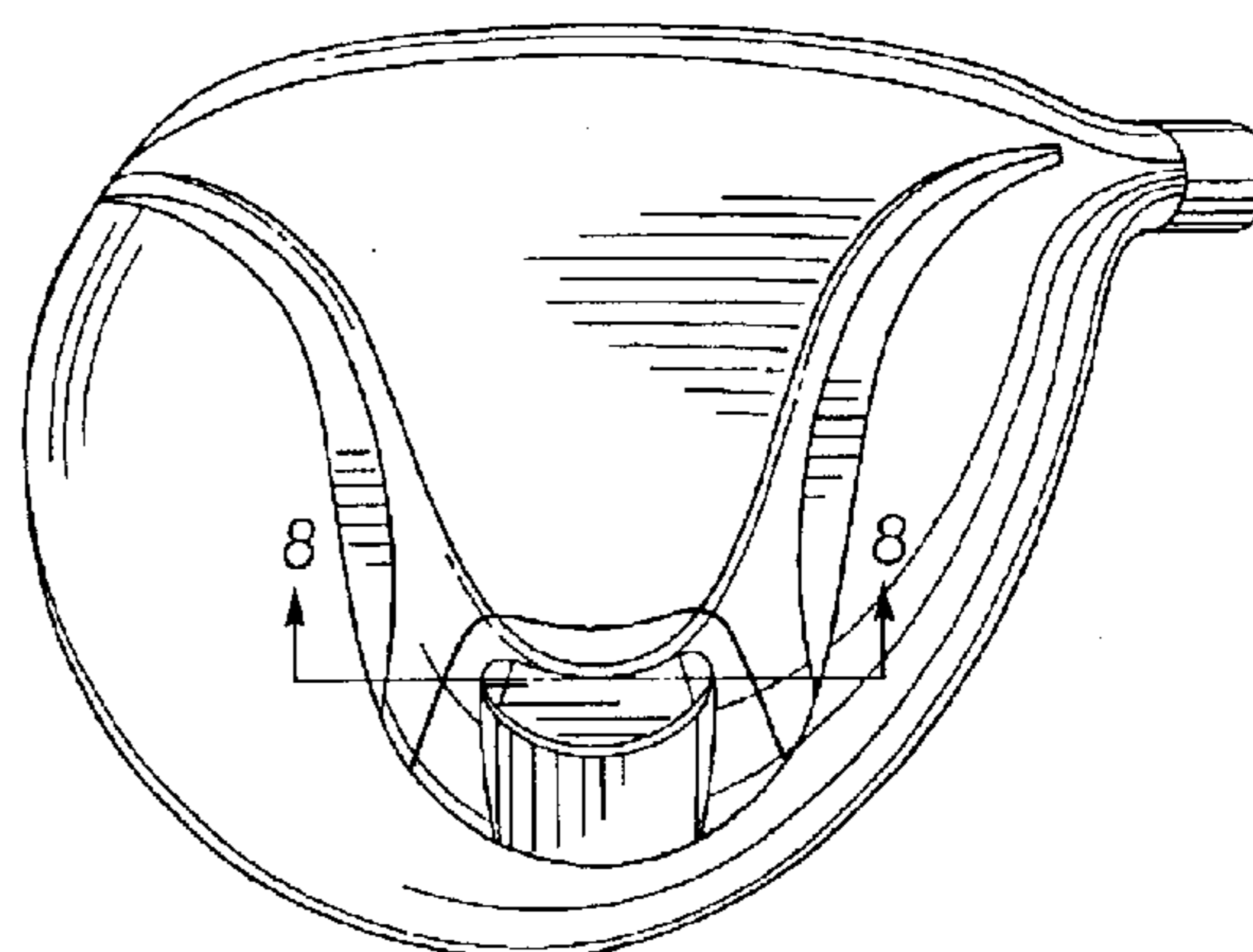
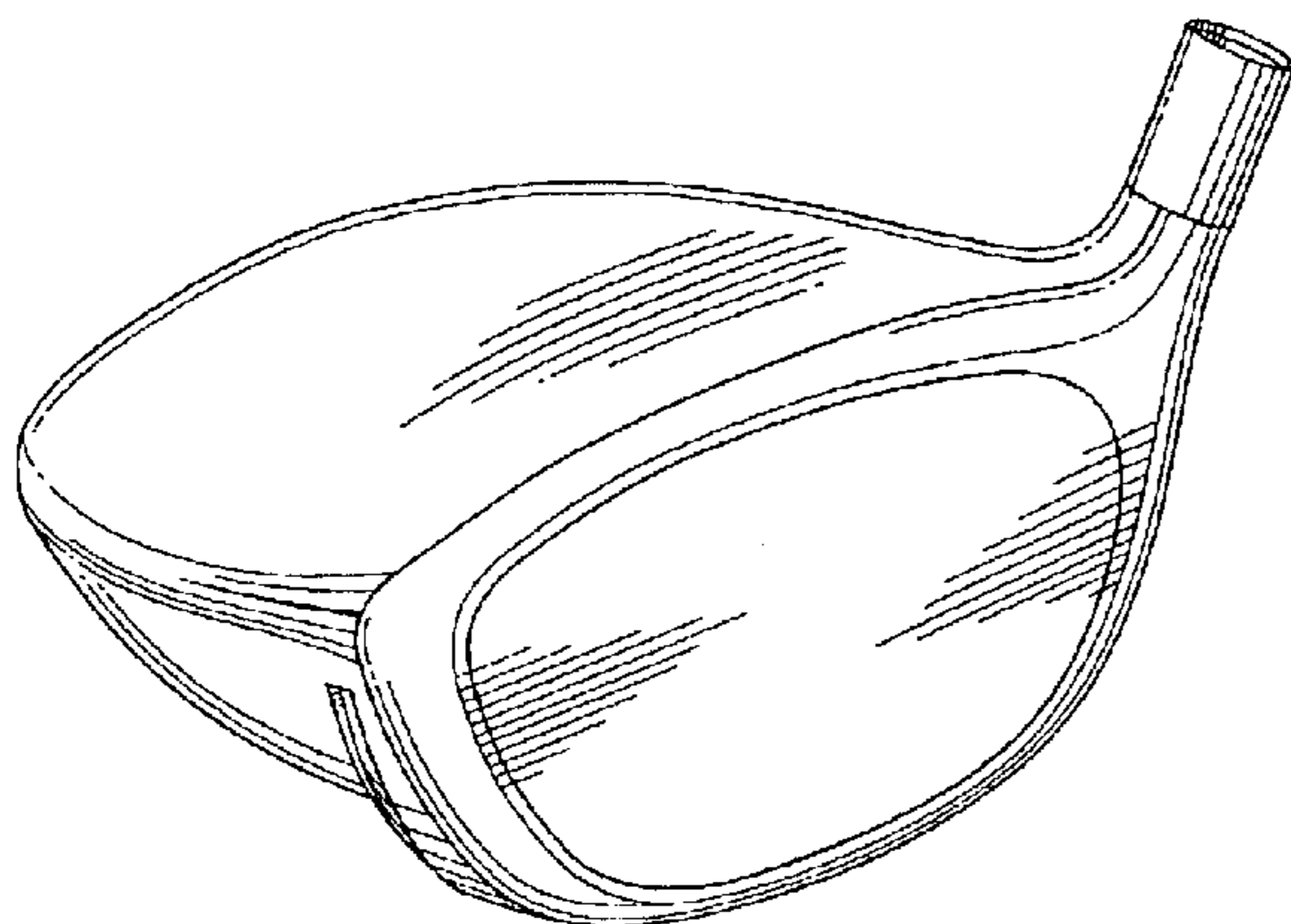
FIG. 8 is a sectional view of the golf club head of FIG. 1, taken substantially in the direction of the arrows 8—8 in FIG. 7.

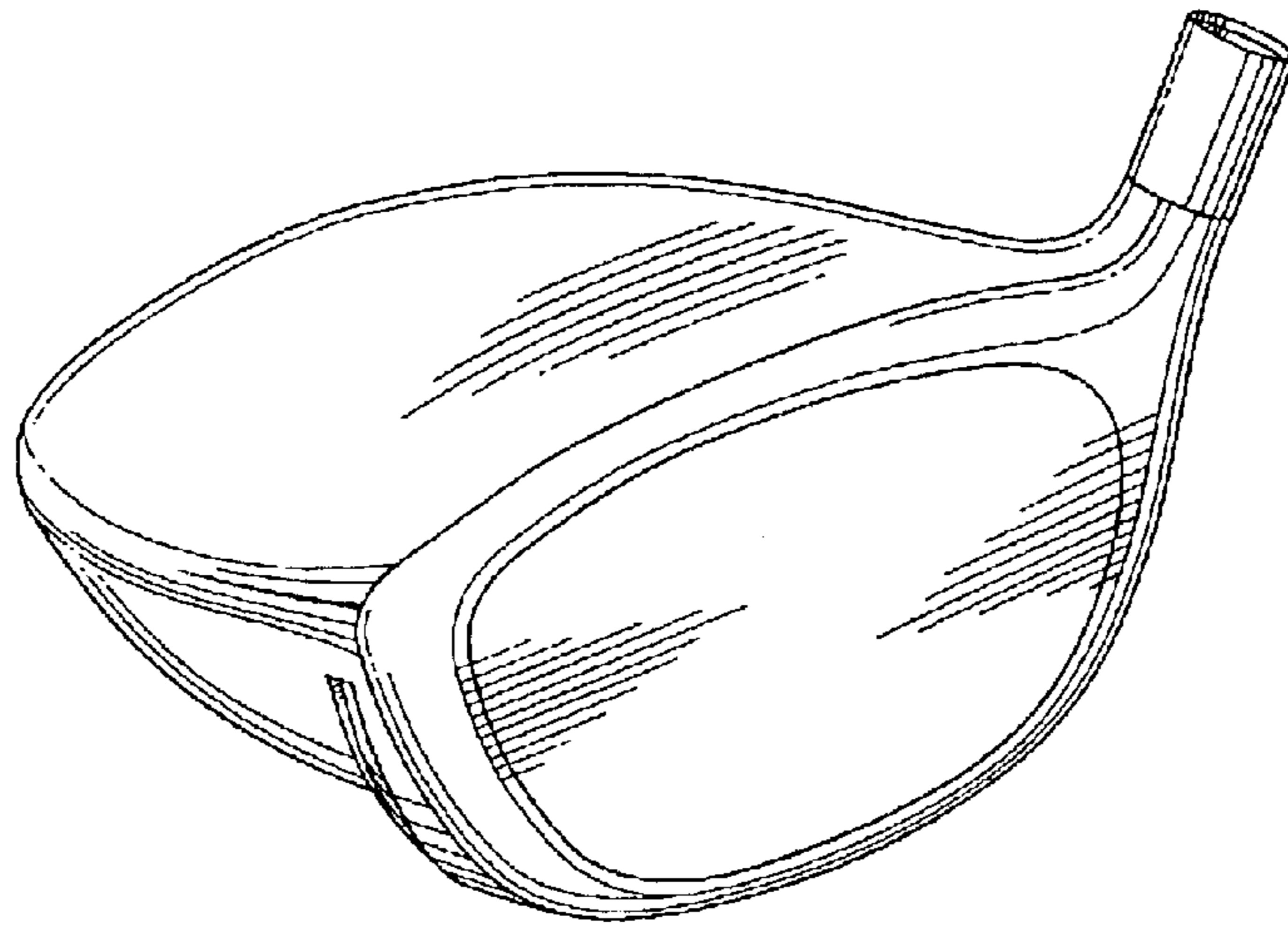

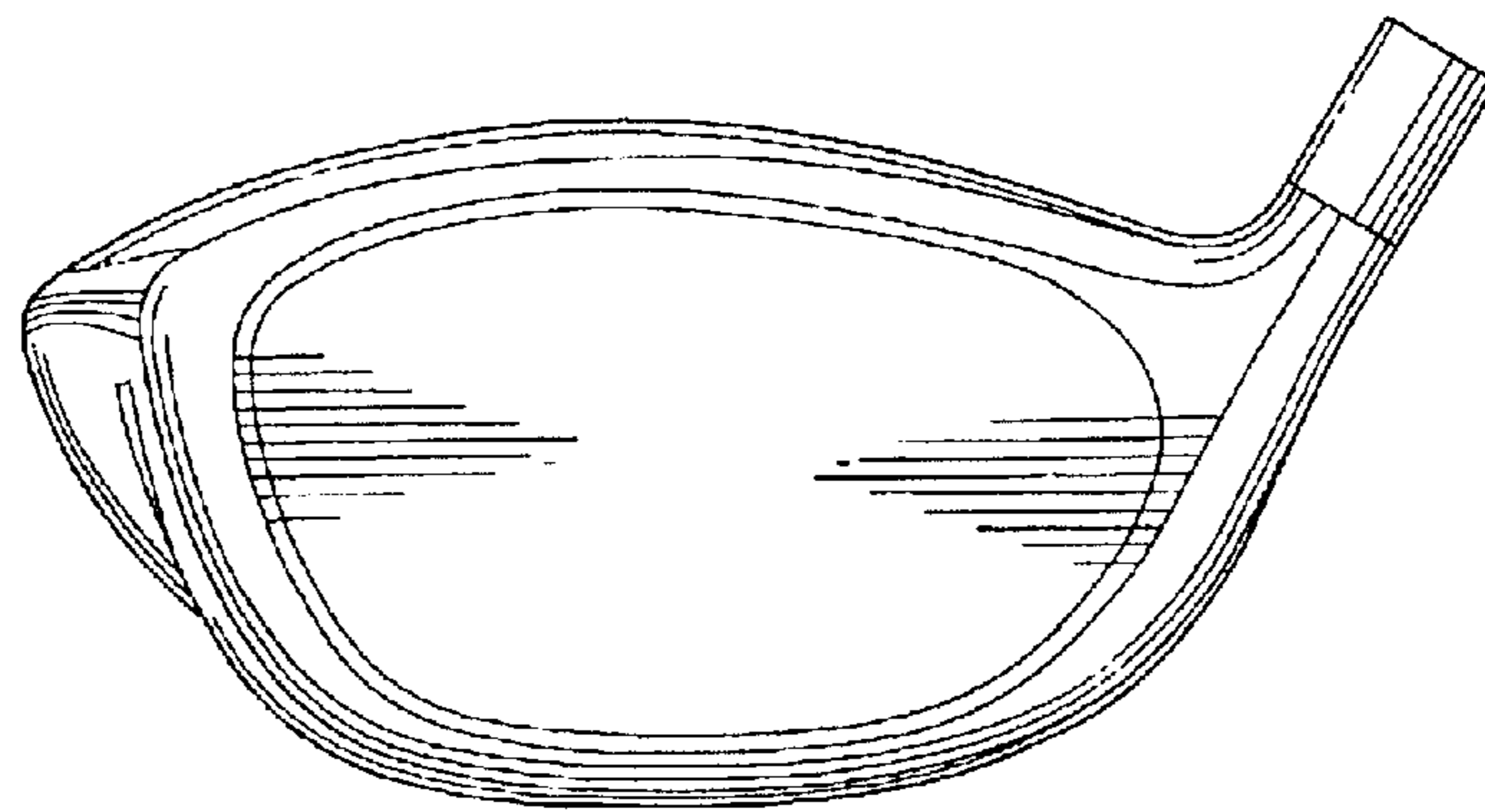

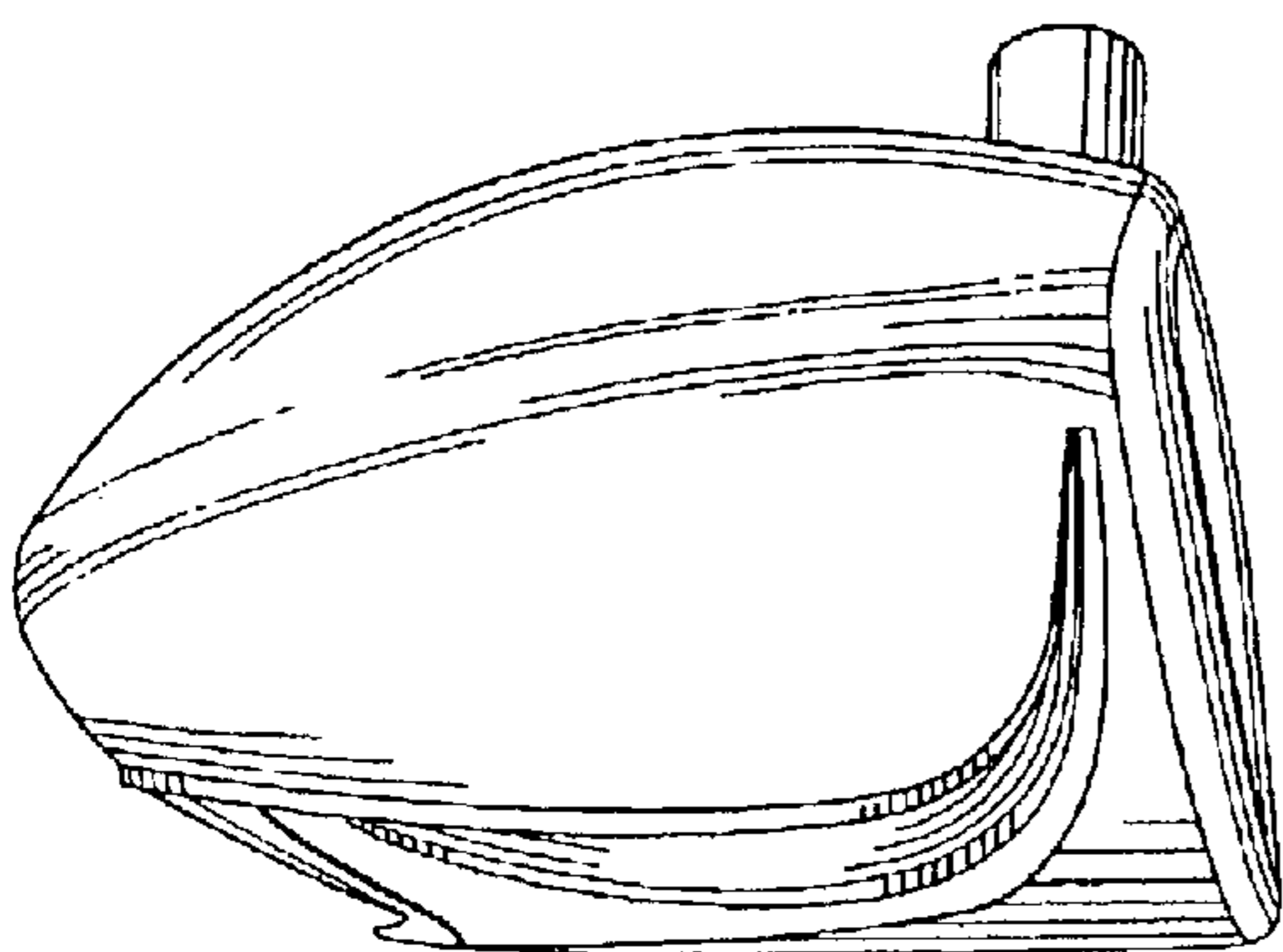

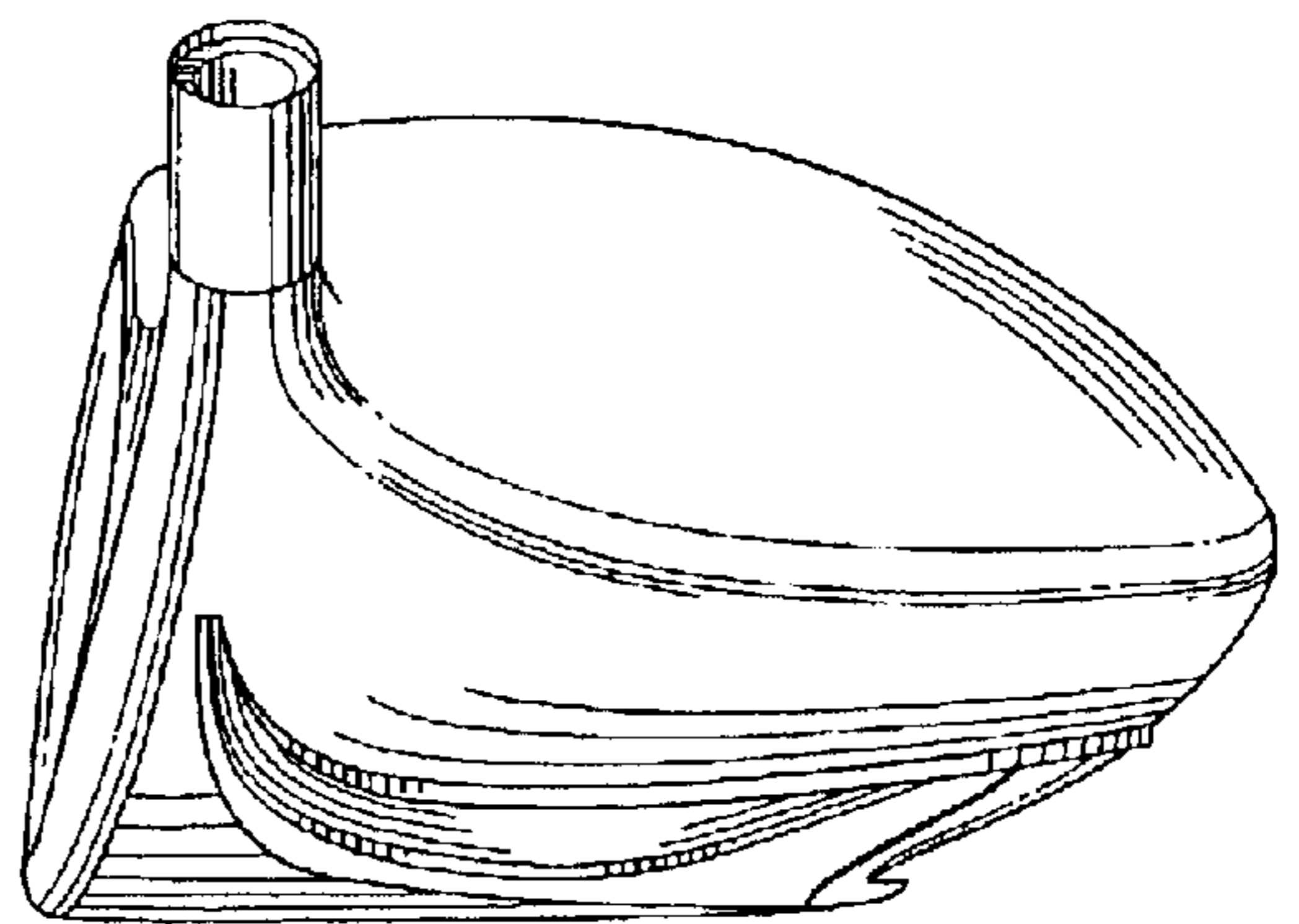

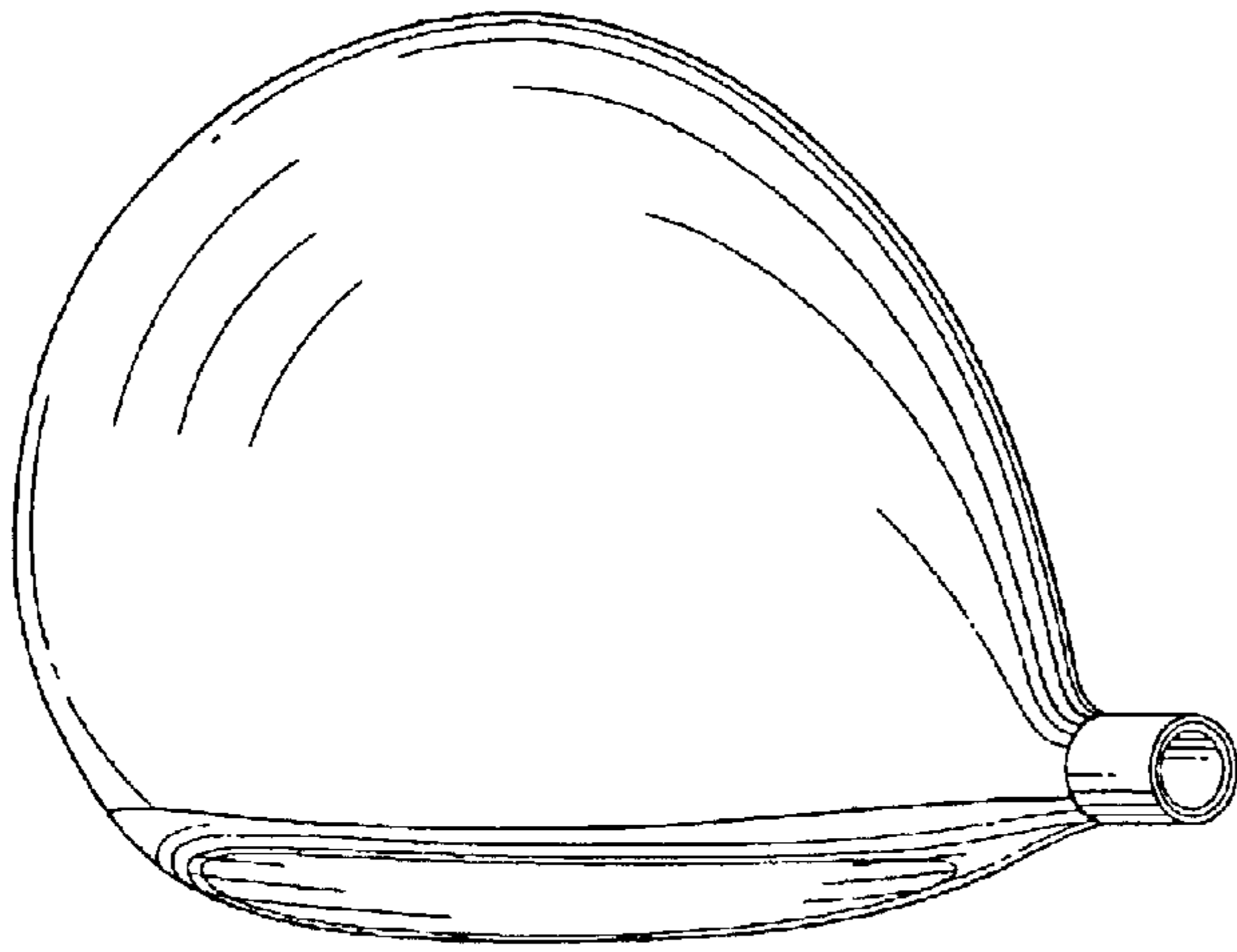

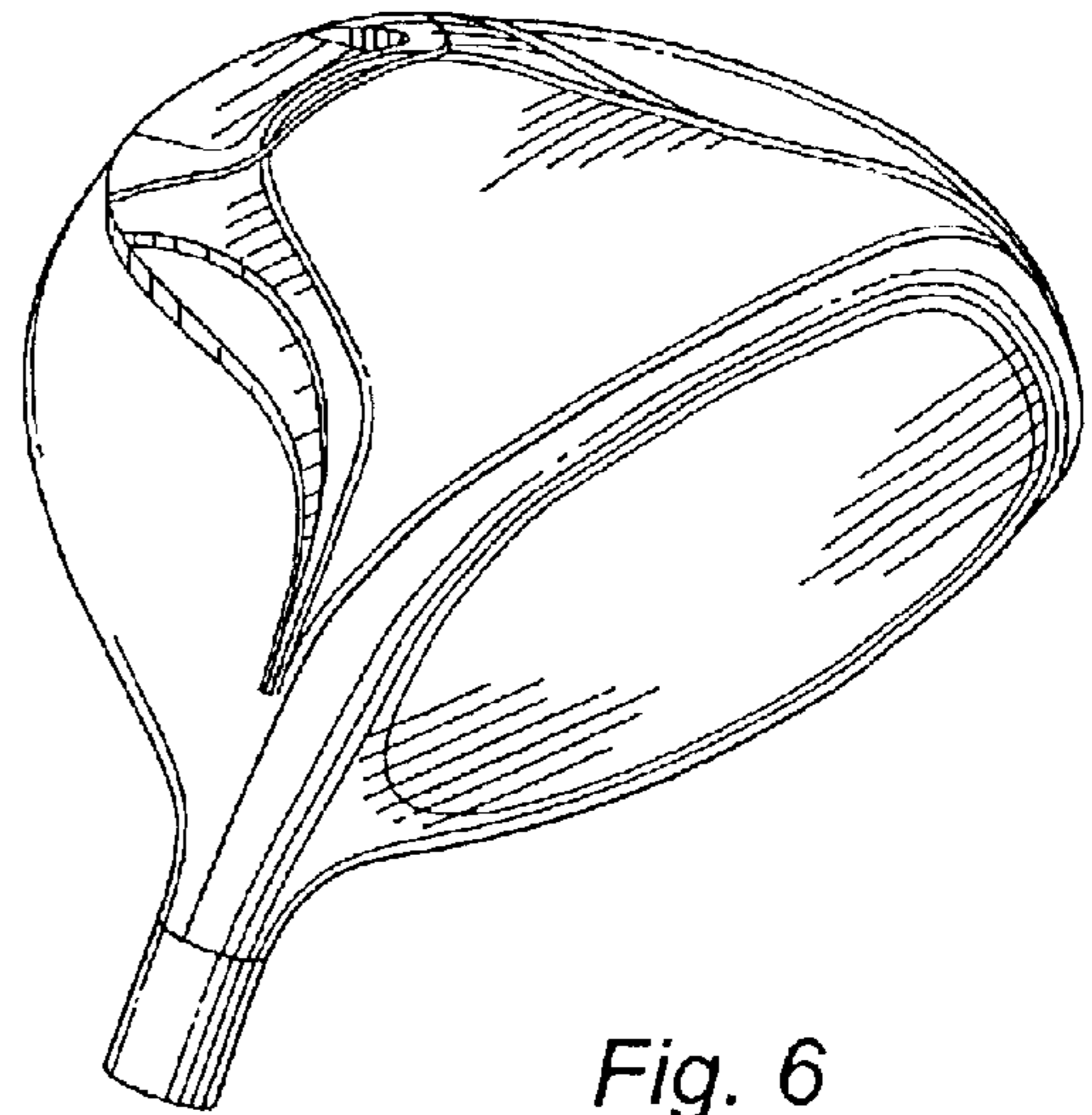

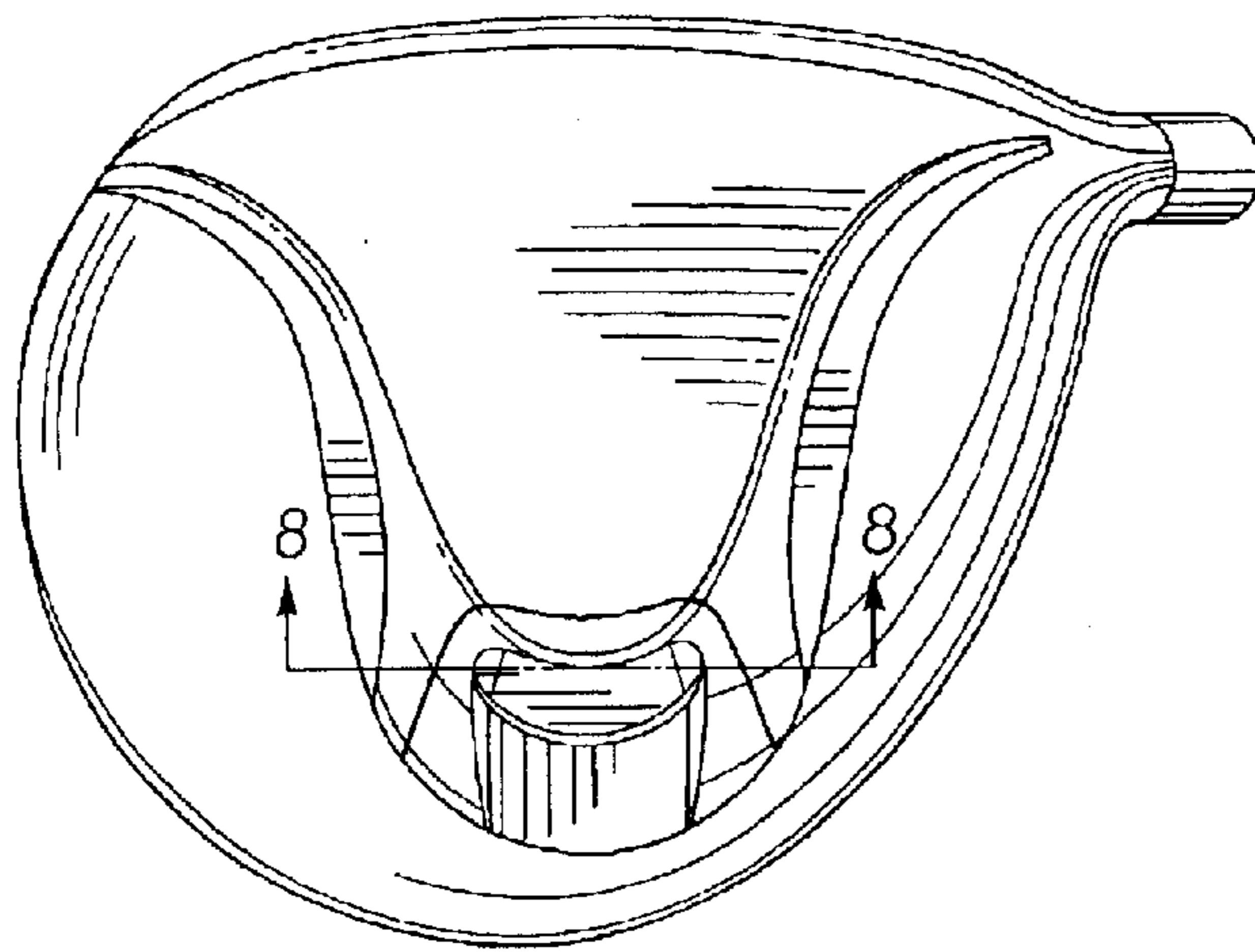

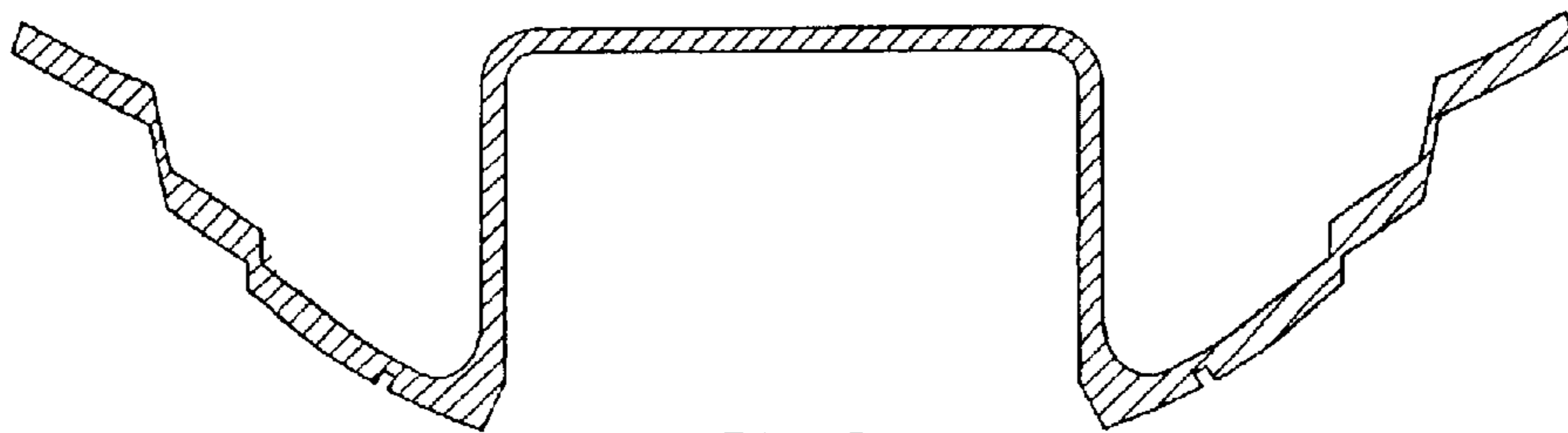
