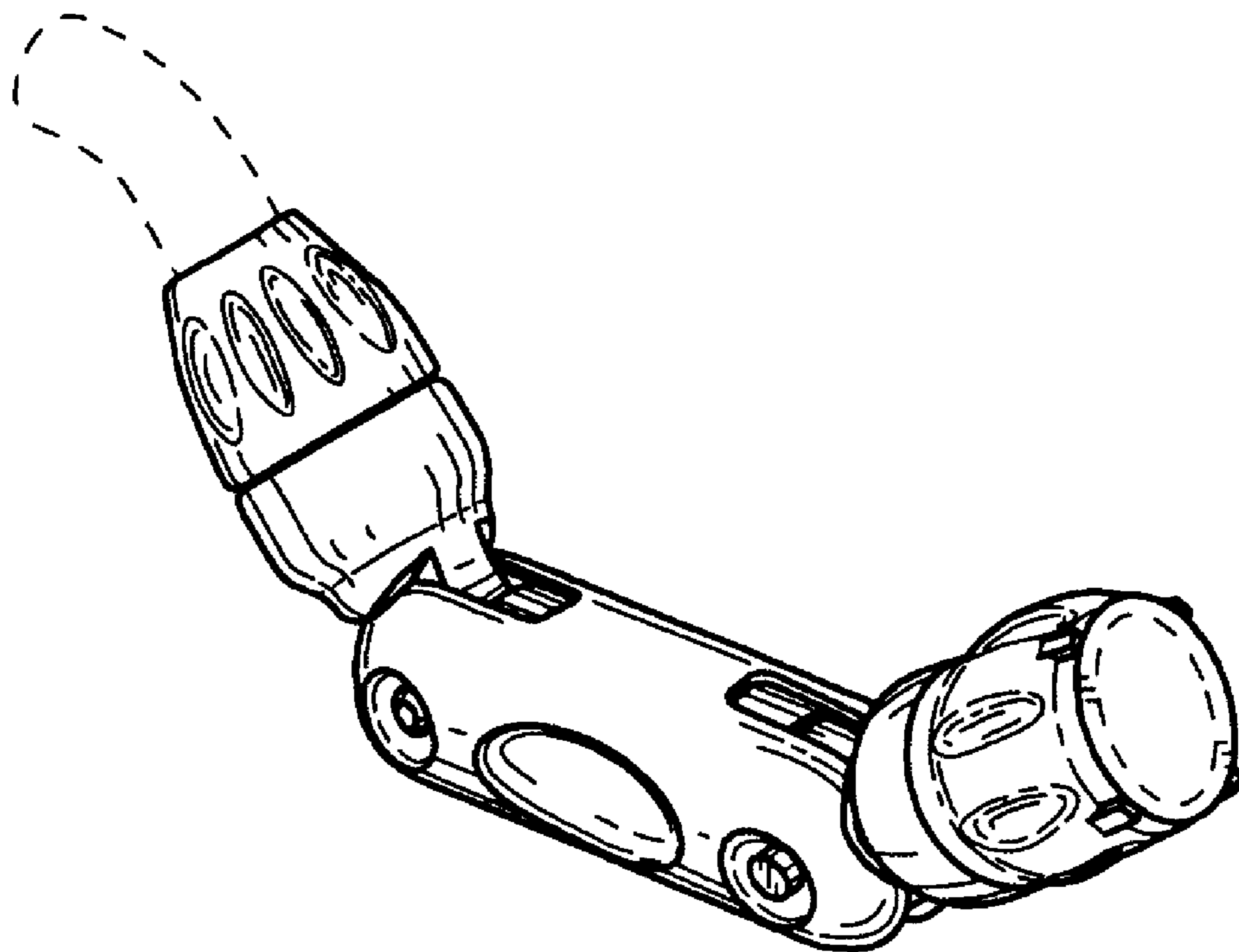
(57) **CLAIM**

The ornamental design for an articulating arm for a shower head, as shown and described.

**DESCRIPTION**

FIG. 1 is a left-side perspective view of an articulating arm for a shower head showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a left elevation thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken line showing is for illustrative purposes only and forms no part of the claimed design.

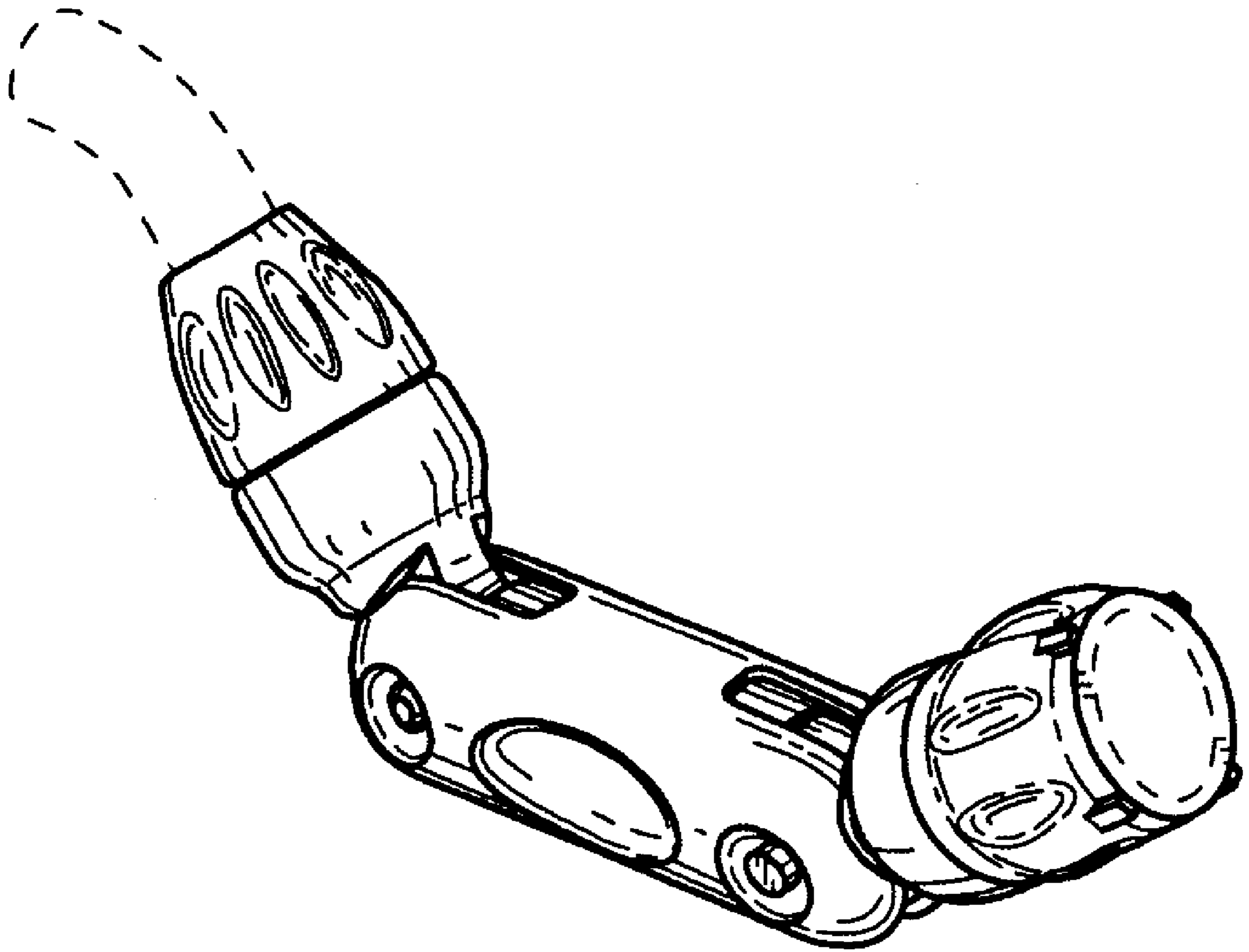

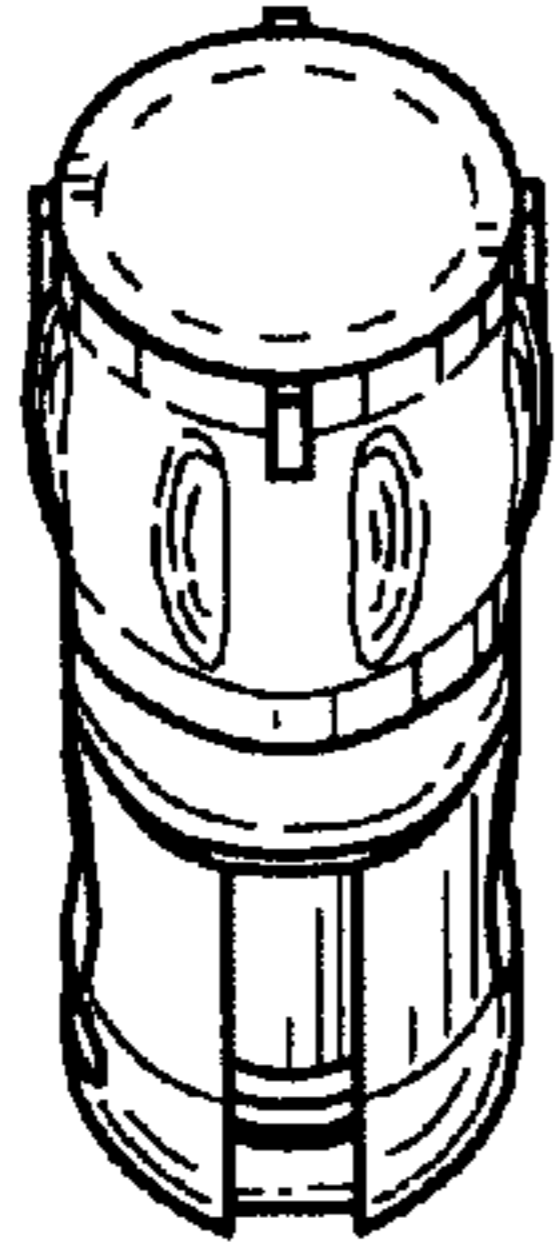

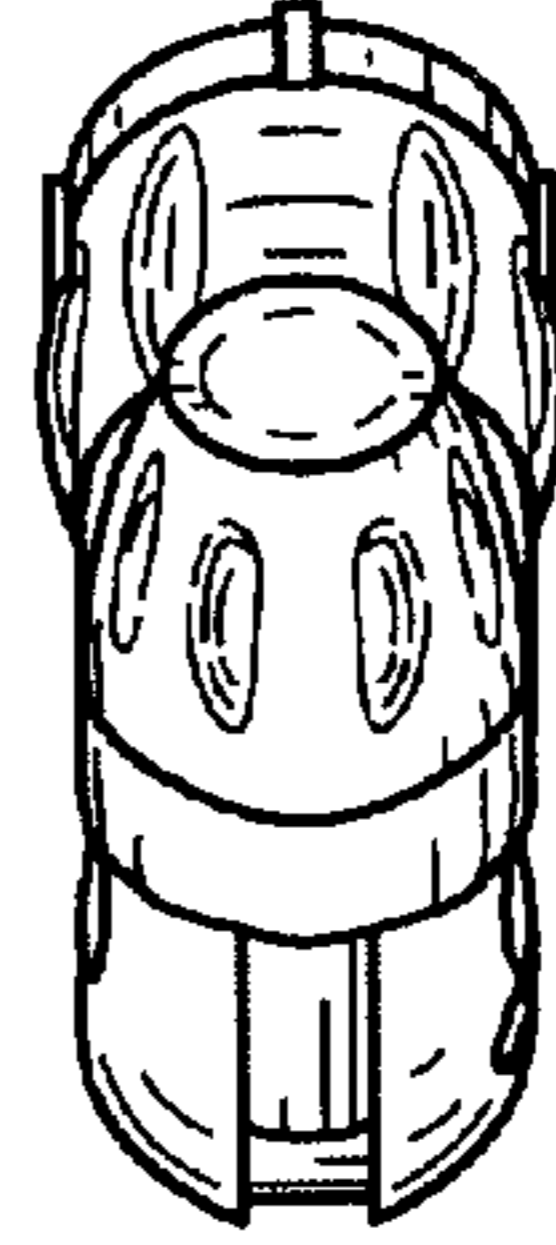

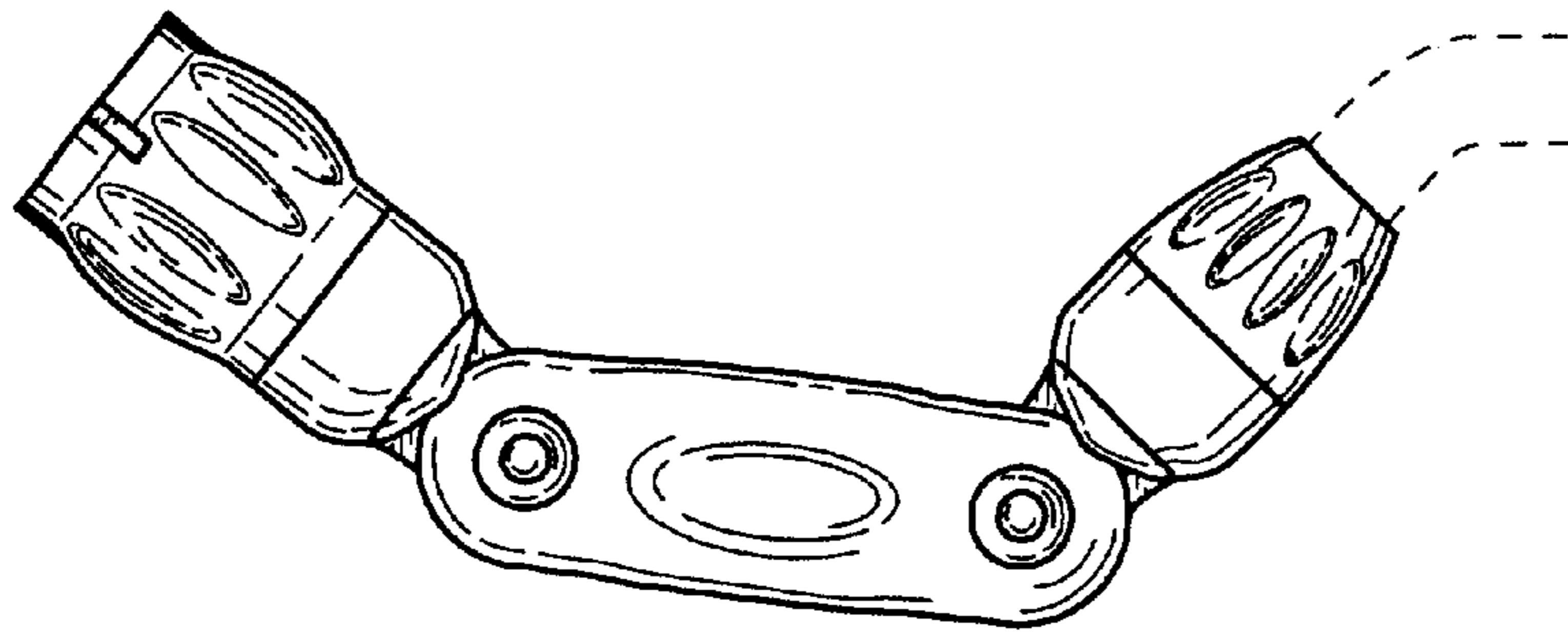

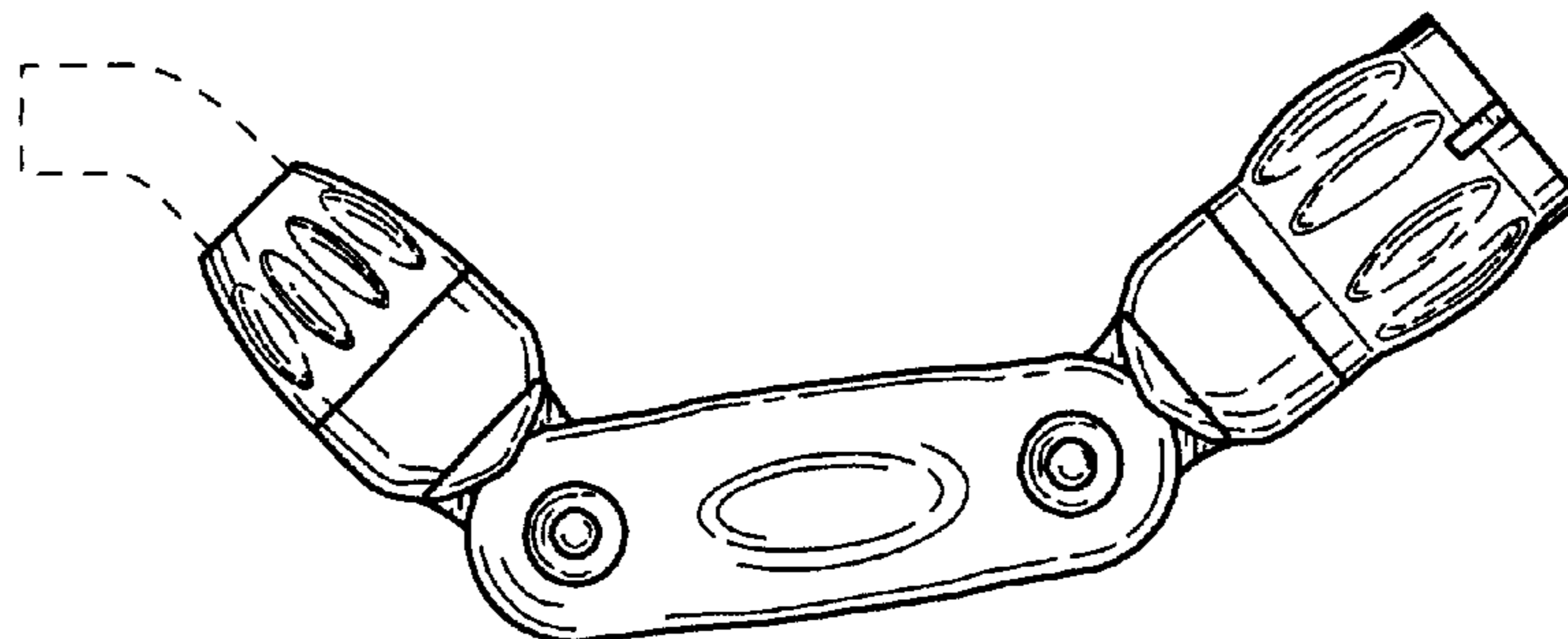

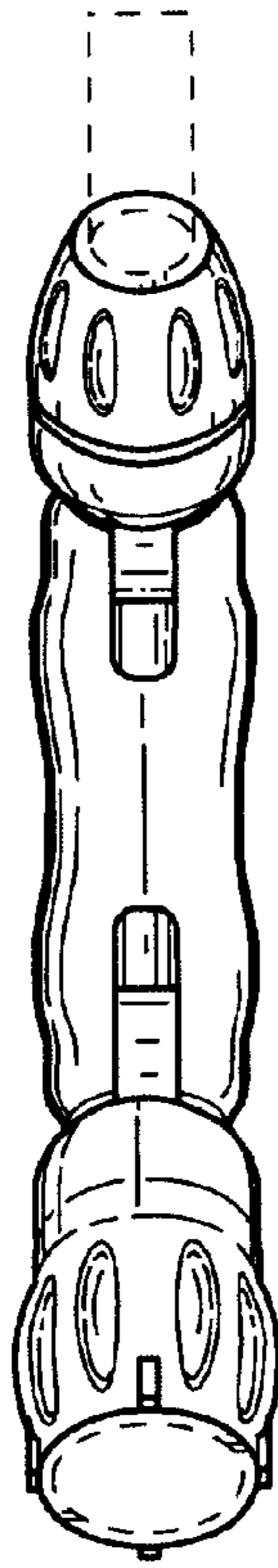

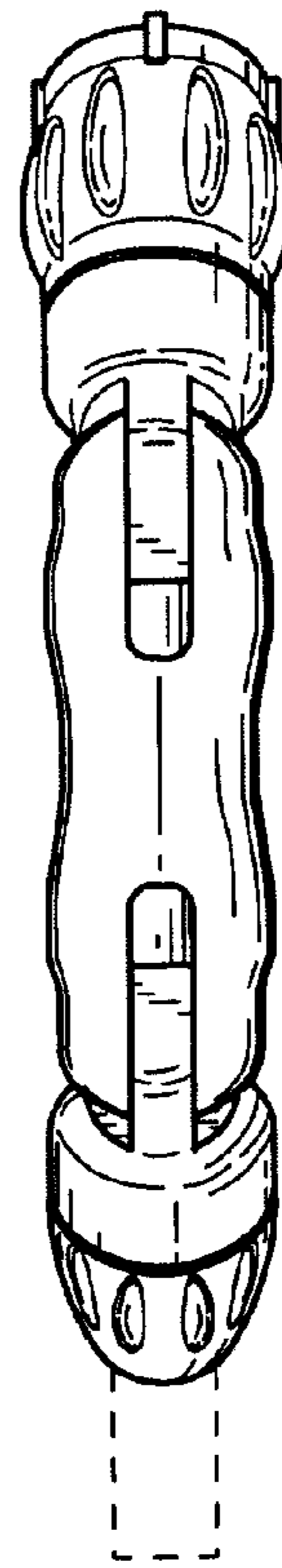
