(57) **CLAIM**

The ornamental design for a ceiling fan blade iron, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from above of the ceiling fan blade iron in accordance with my design, illustrating the environment of said blade iron;

FIG. 2 is a partial front elevation view of the ceiling fan blade iron in accordance with my design, illustrating the environment of said blade iron;

FIG. 3 is a top plan view of the ceiling fan blade iron in accordance with my design, illustrating the environment of said blade iron;

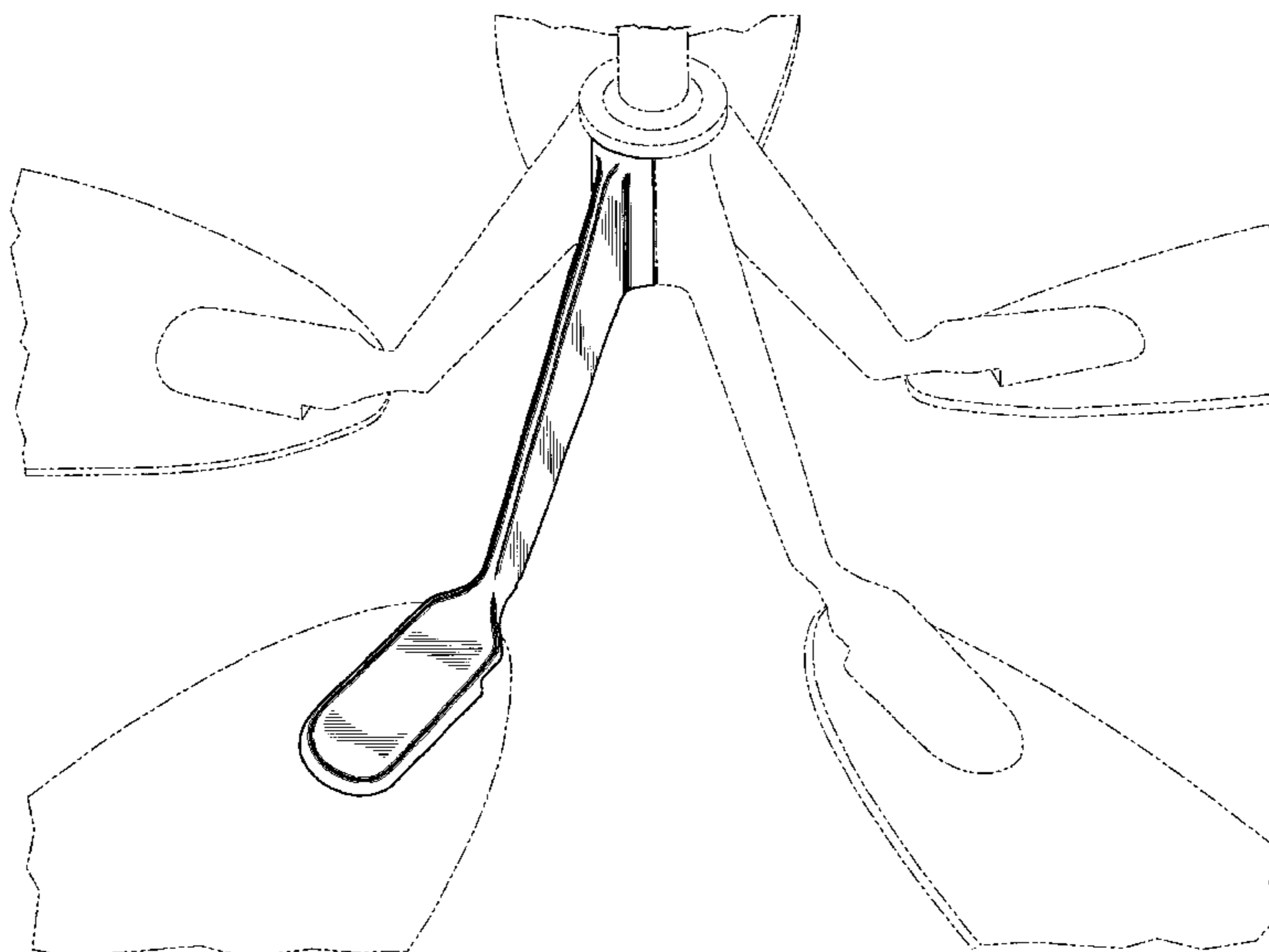

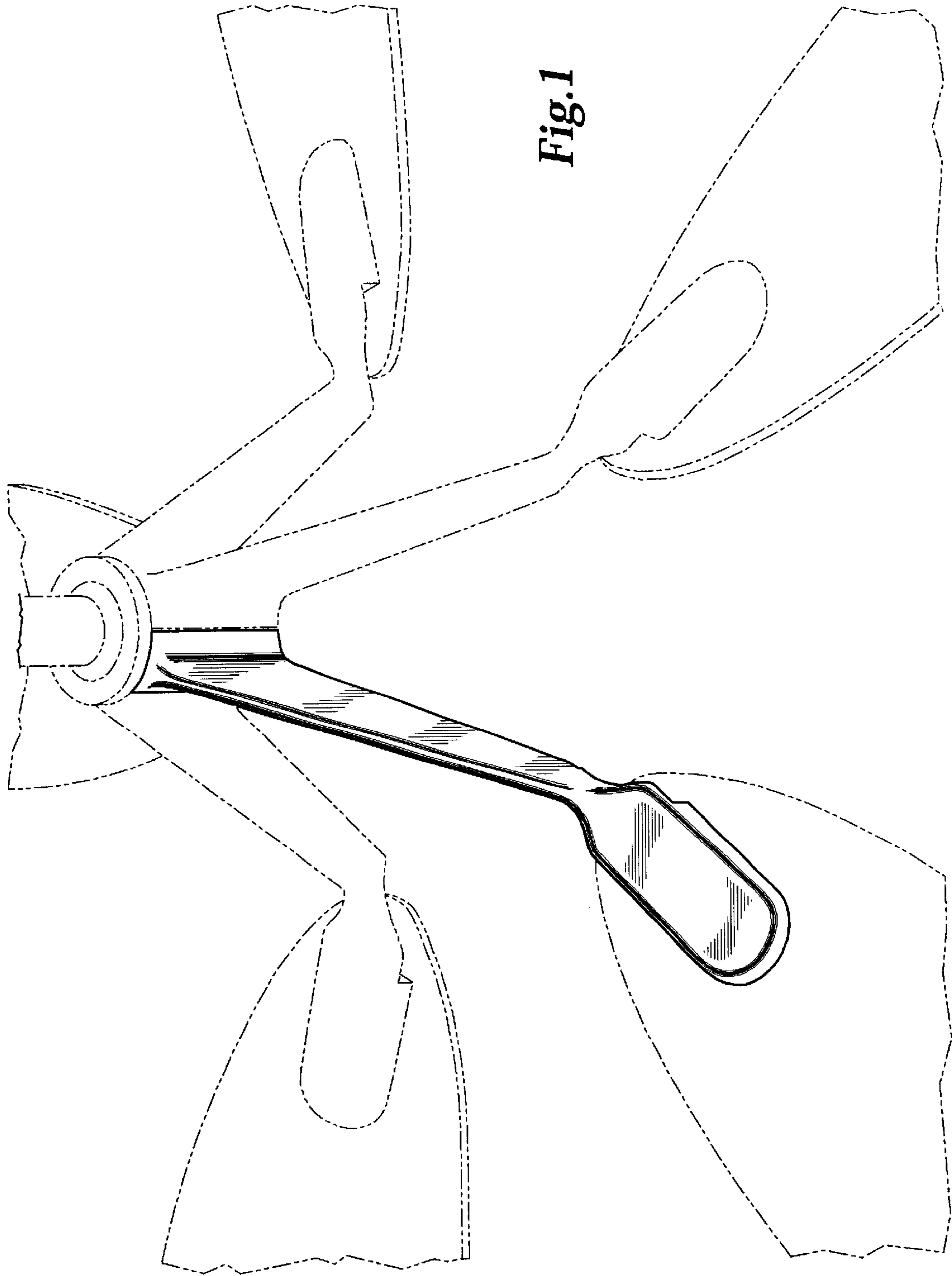
FIG. 5 is a rear elevation view of the ceiling fan blade iron in accordance with my design, illustrating the environment of said blade iron; and,

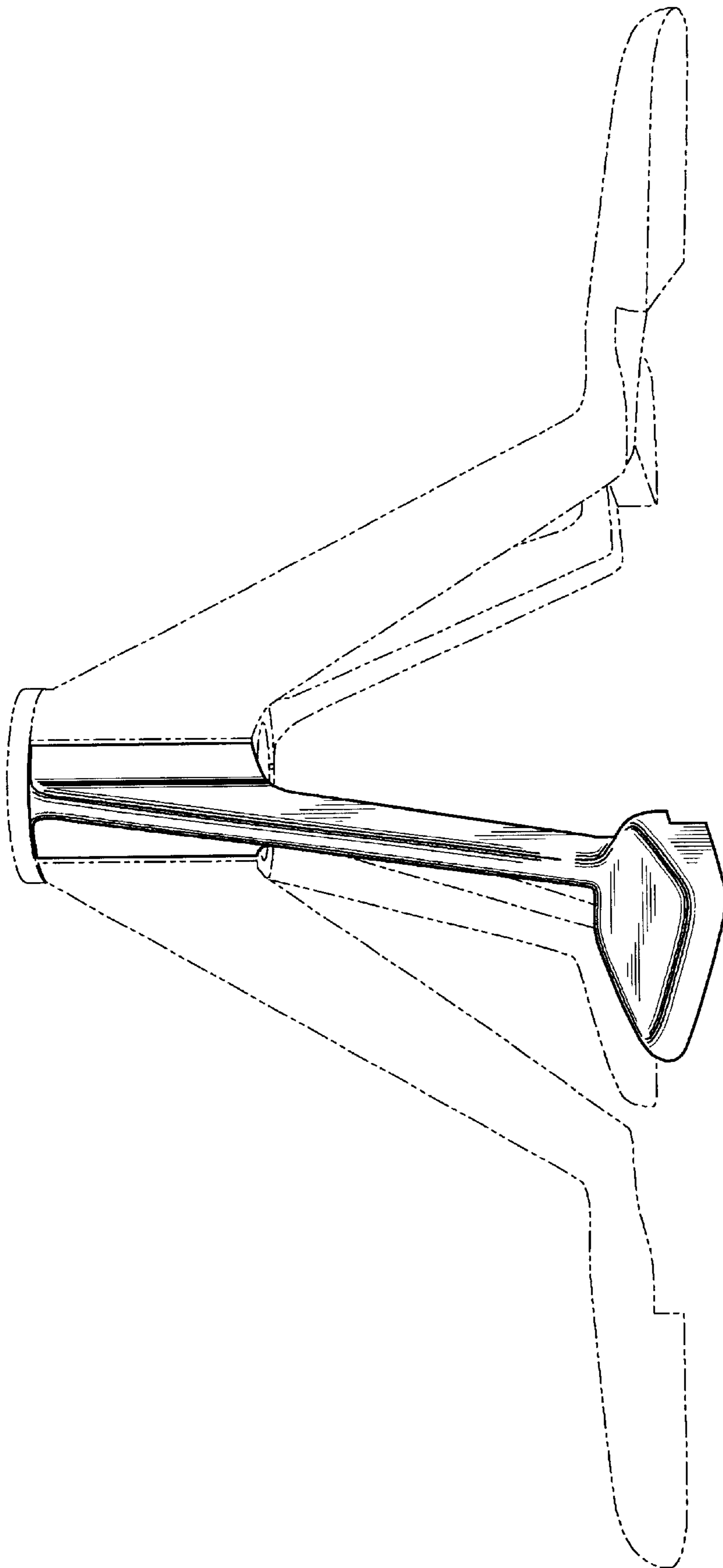
FIG. 6 is a perspective view from below of the ceiling fan blade iron in accordance with my design, illustrating the environment of said blade iron.

The broken lines in FIGS. 1-6 showing environmental structure are for illustrative purposes and form no part of the claimed design.

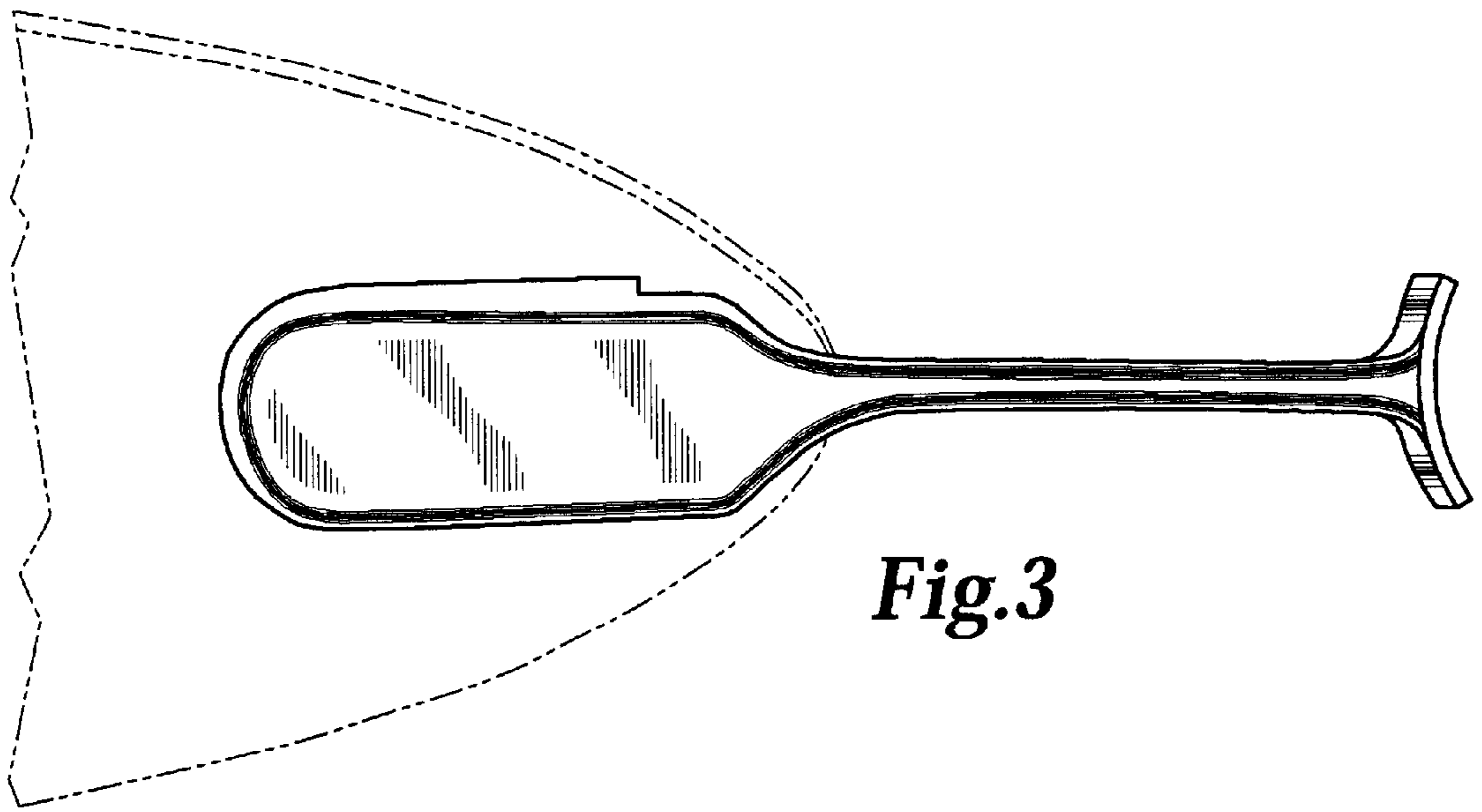

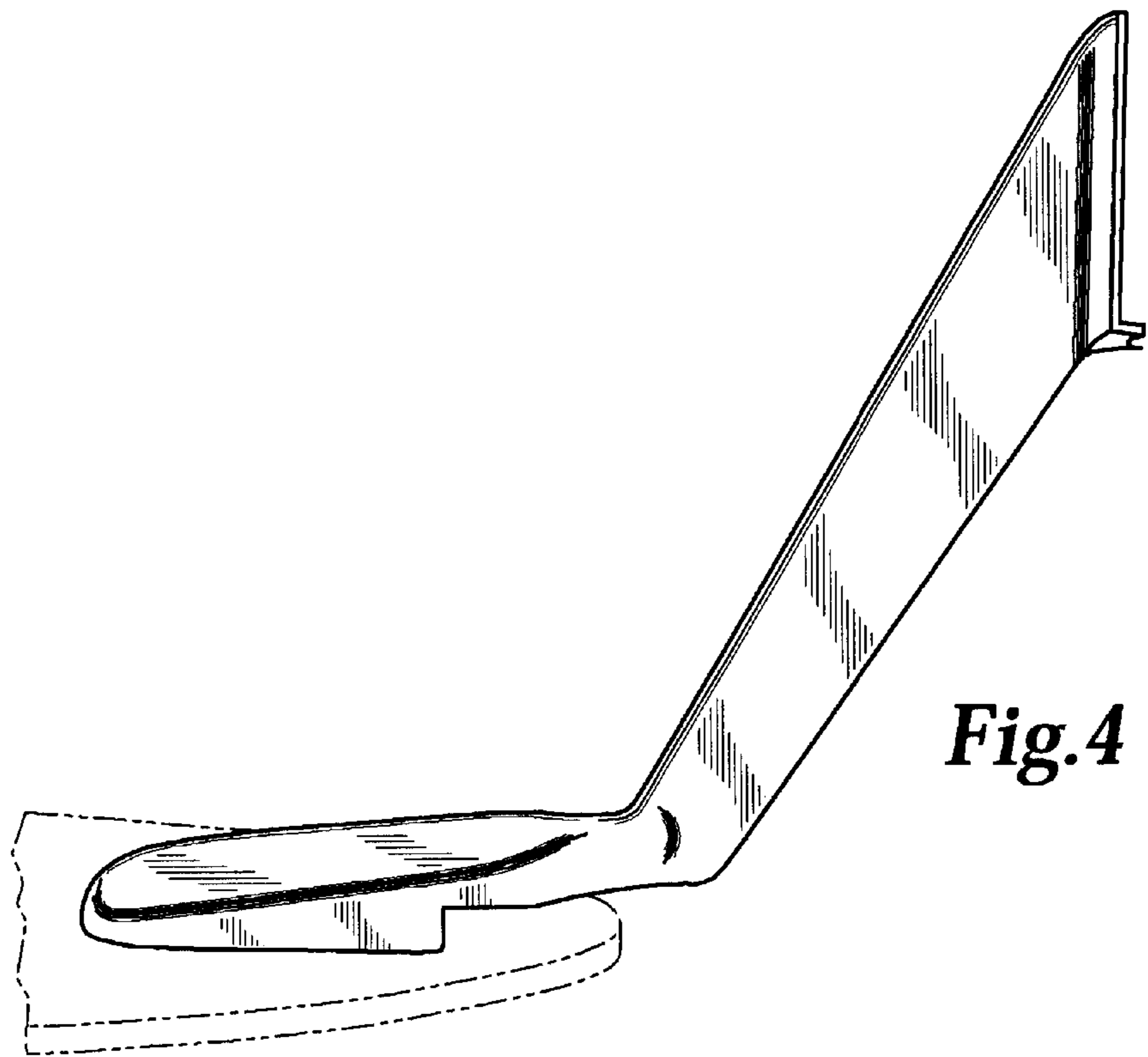
