(57) **CLAIM**

The ornamental design for a sector-shaped enclosed pizza food, as shown and described.

DESCRIPTION

FIG. 1 is a drawing of a top, side perspective view of a sector-shaped enclosed pizza food showing our new design. FIG. 2 is a drawing of a side view of the sector-shaped enclosed pizza food of FIG. 1.

FIG. 3 is a drawing of a top view of a pizza food of the sector-shaped enclosed pizza food of FIG. 1, shown separately for clarity; and,

FIG. 4 is a drawing of a top, side perspective view of the pizza food of the sector-shaped enclosed pizza food of FIG. 1, shown separately for clarity.

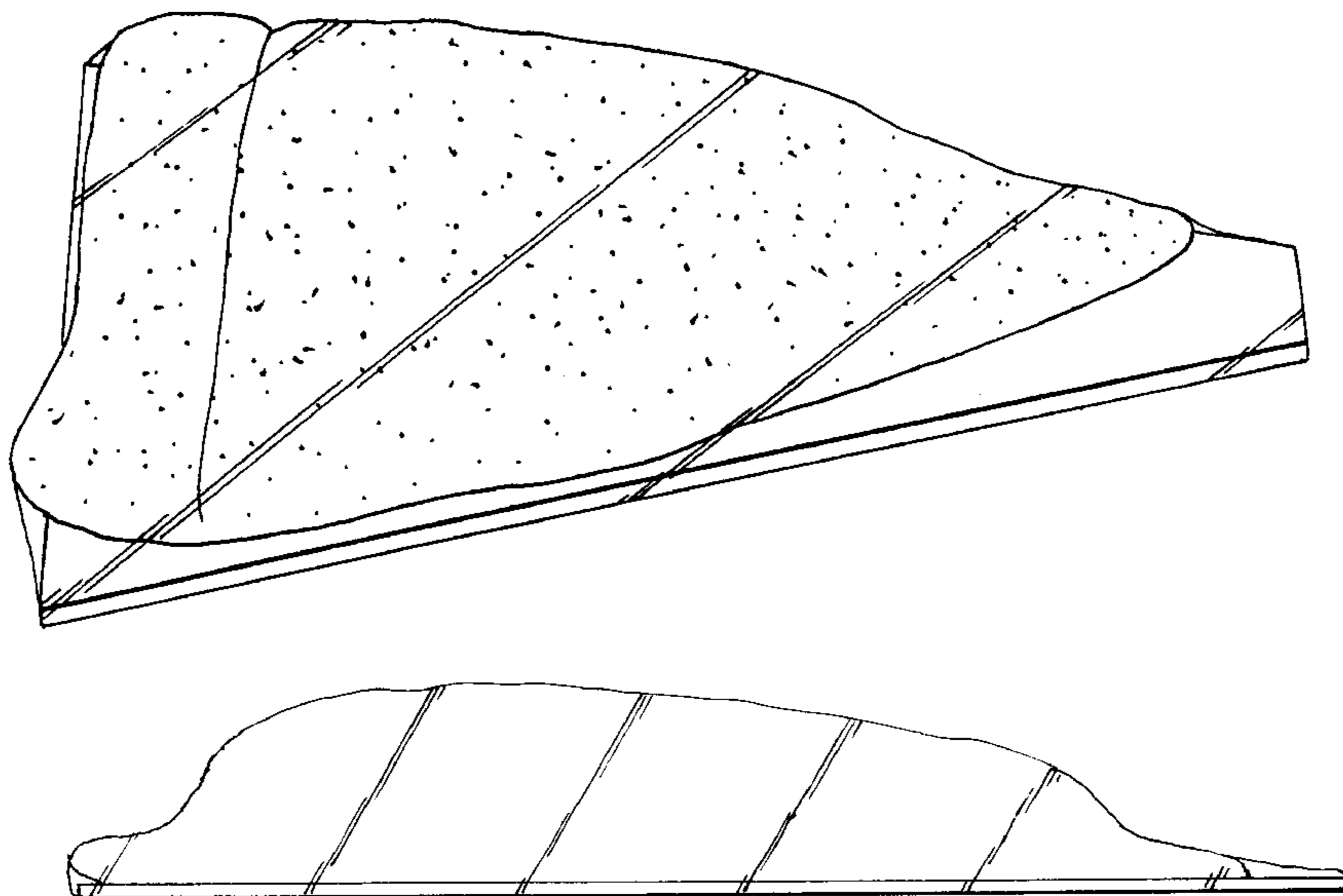

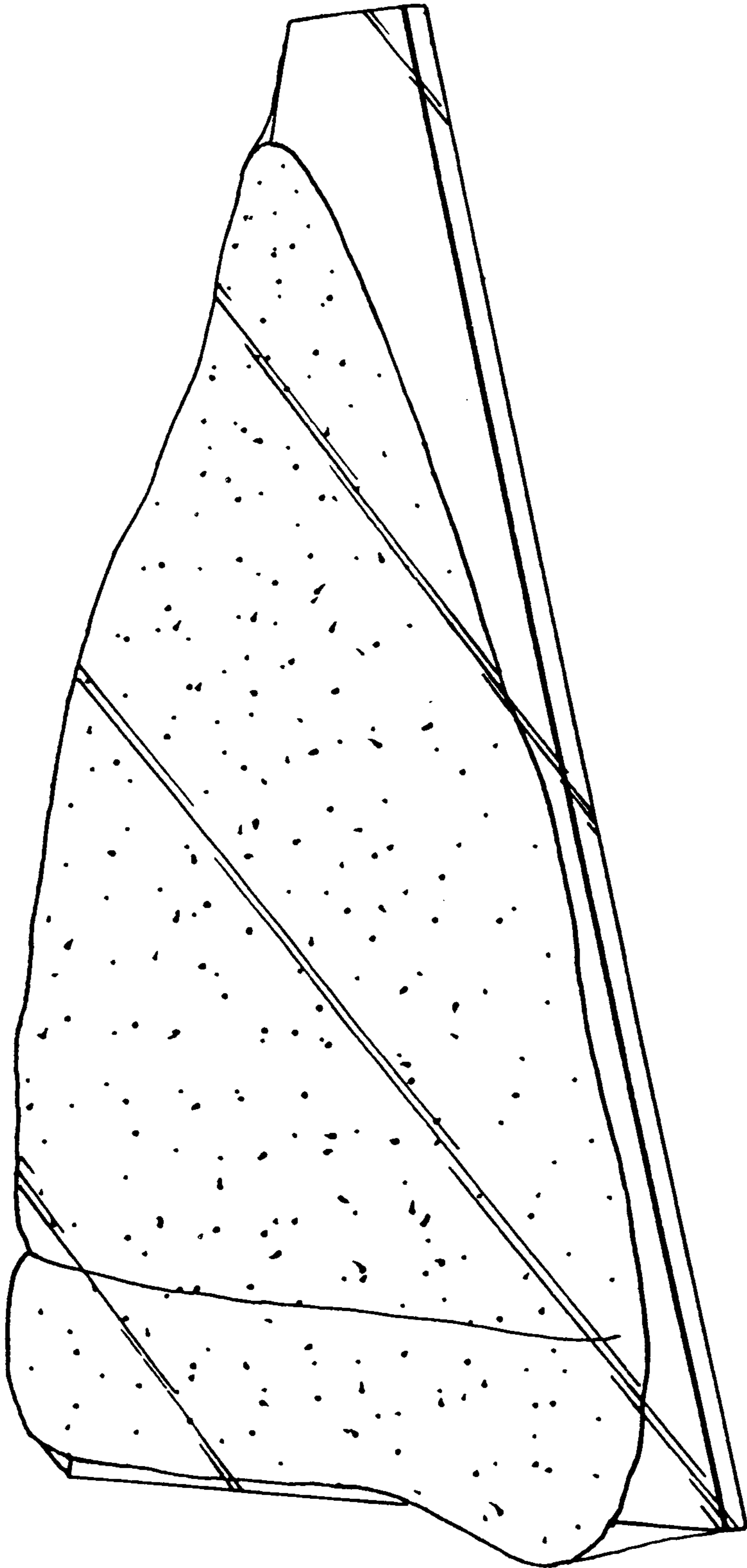

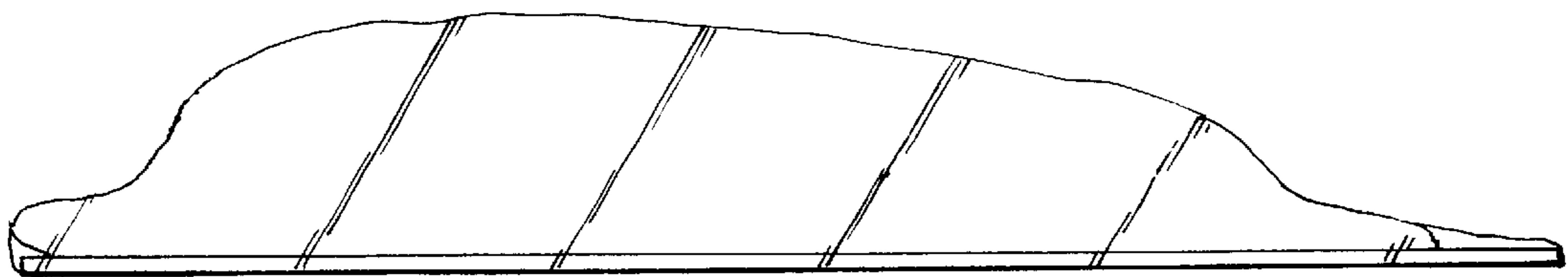

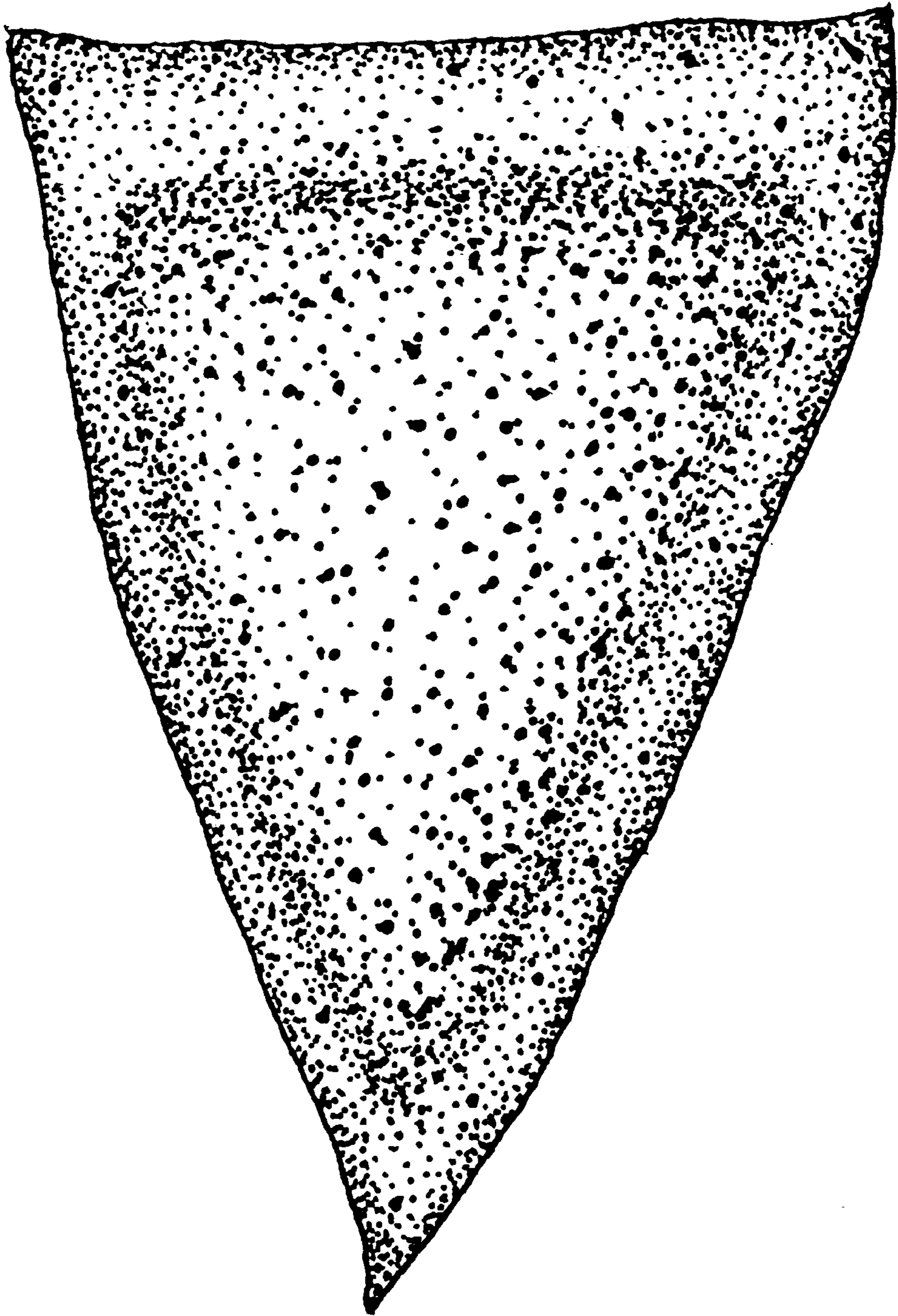
