The ornamental design for the portion of a shoe midsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevational view of a portion of a shoe midsole showing a new design;

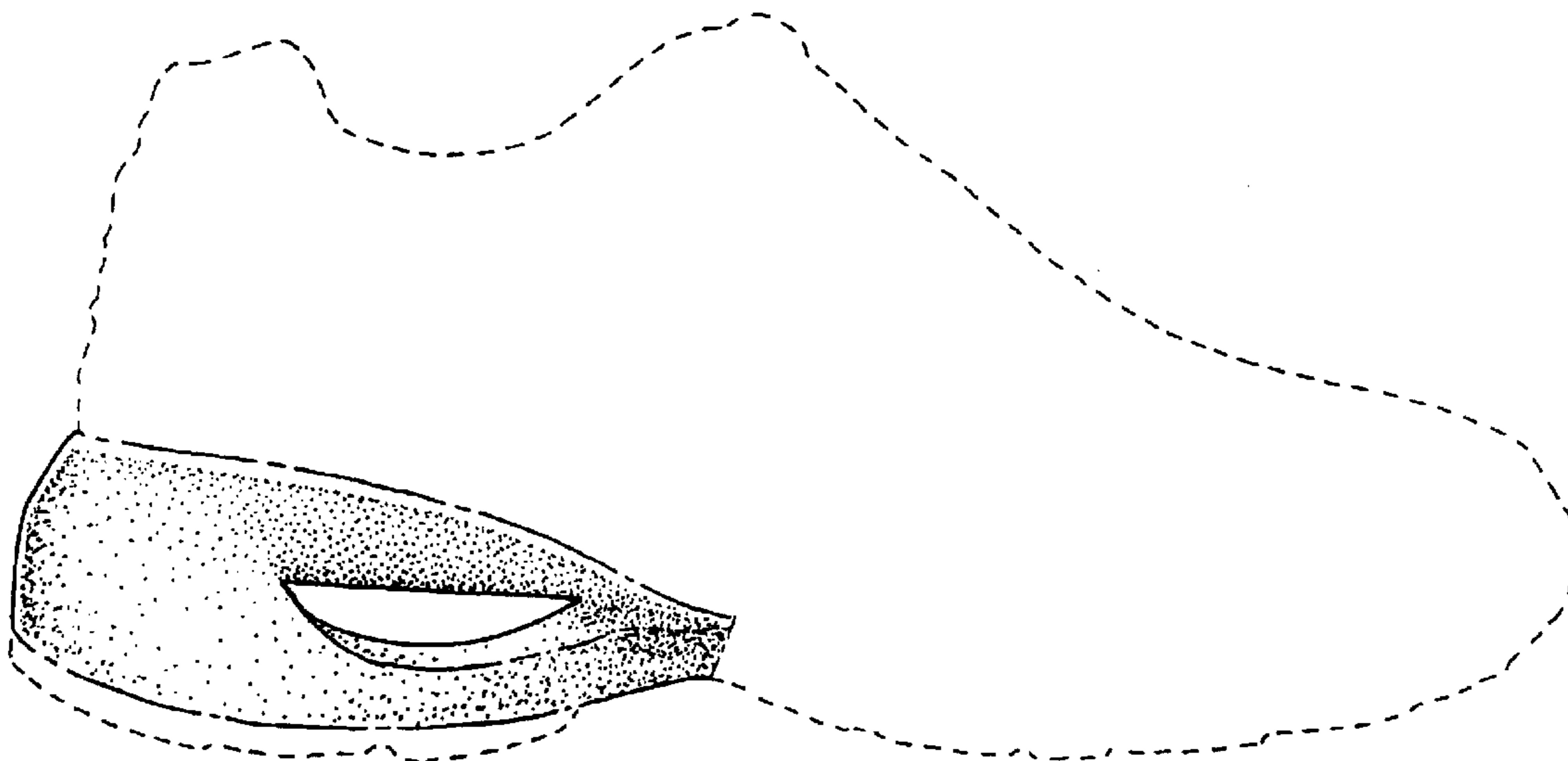
FIG. 2 is a right side elevational view thereof;

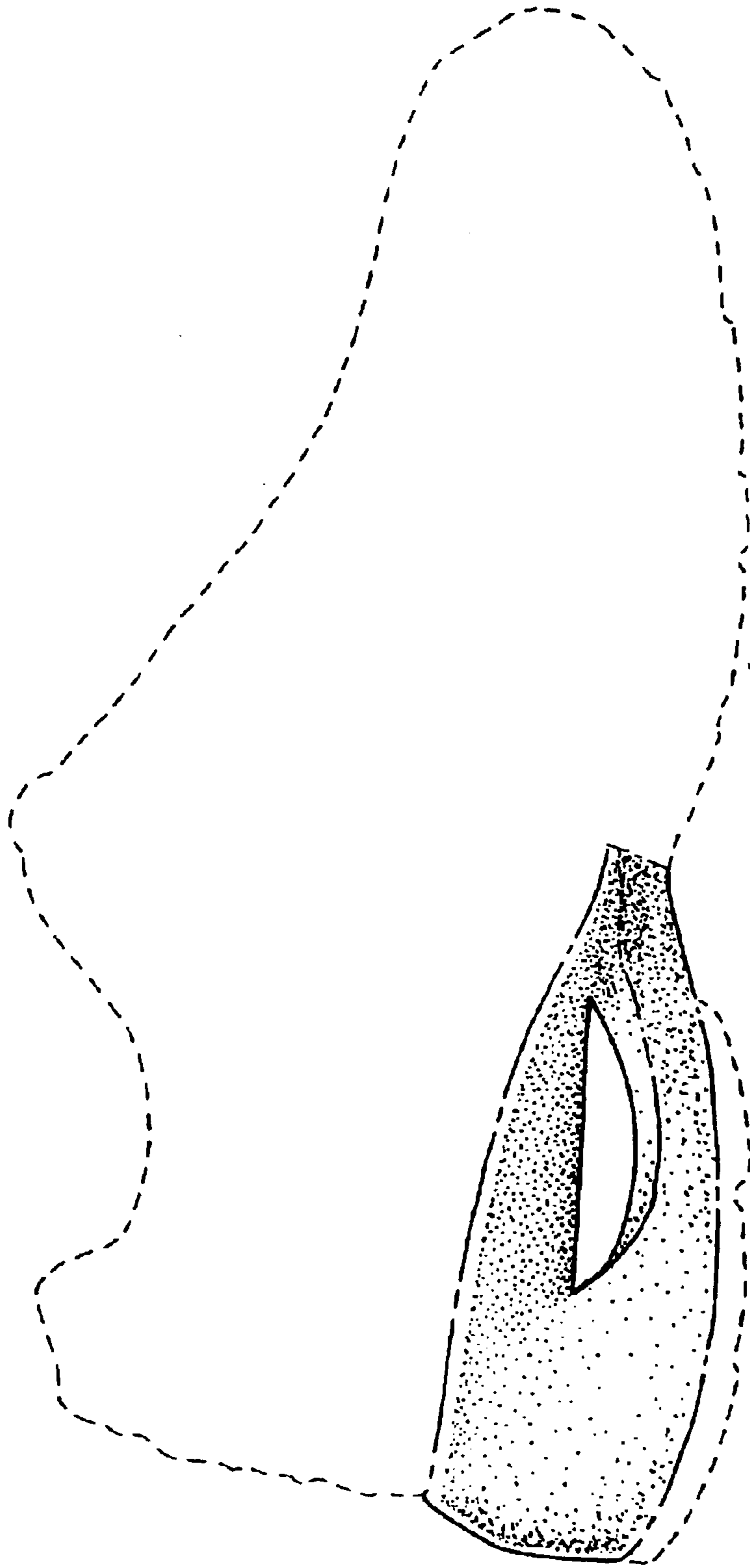

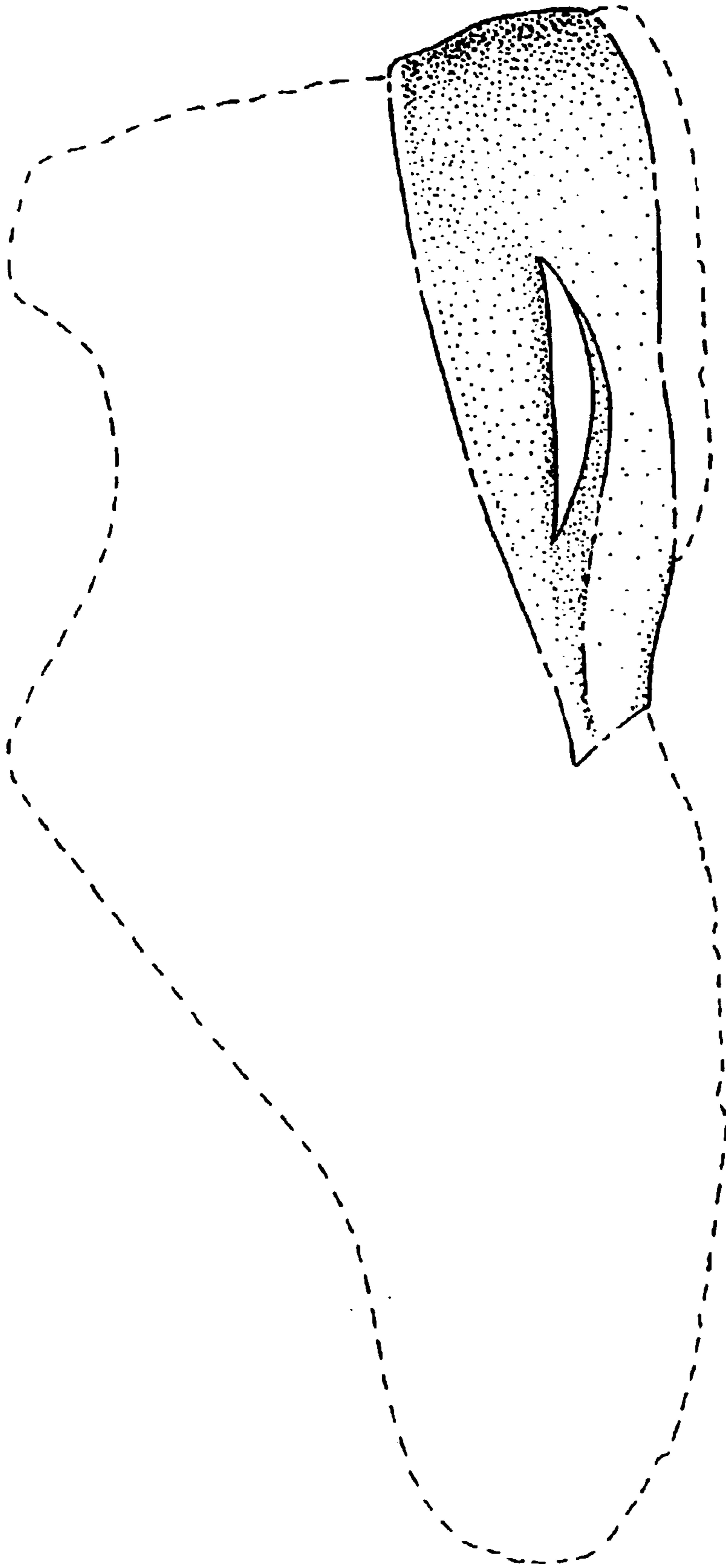
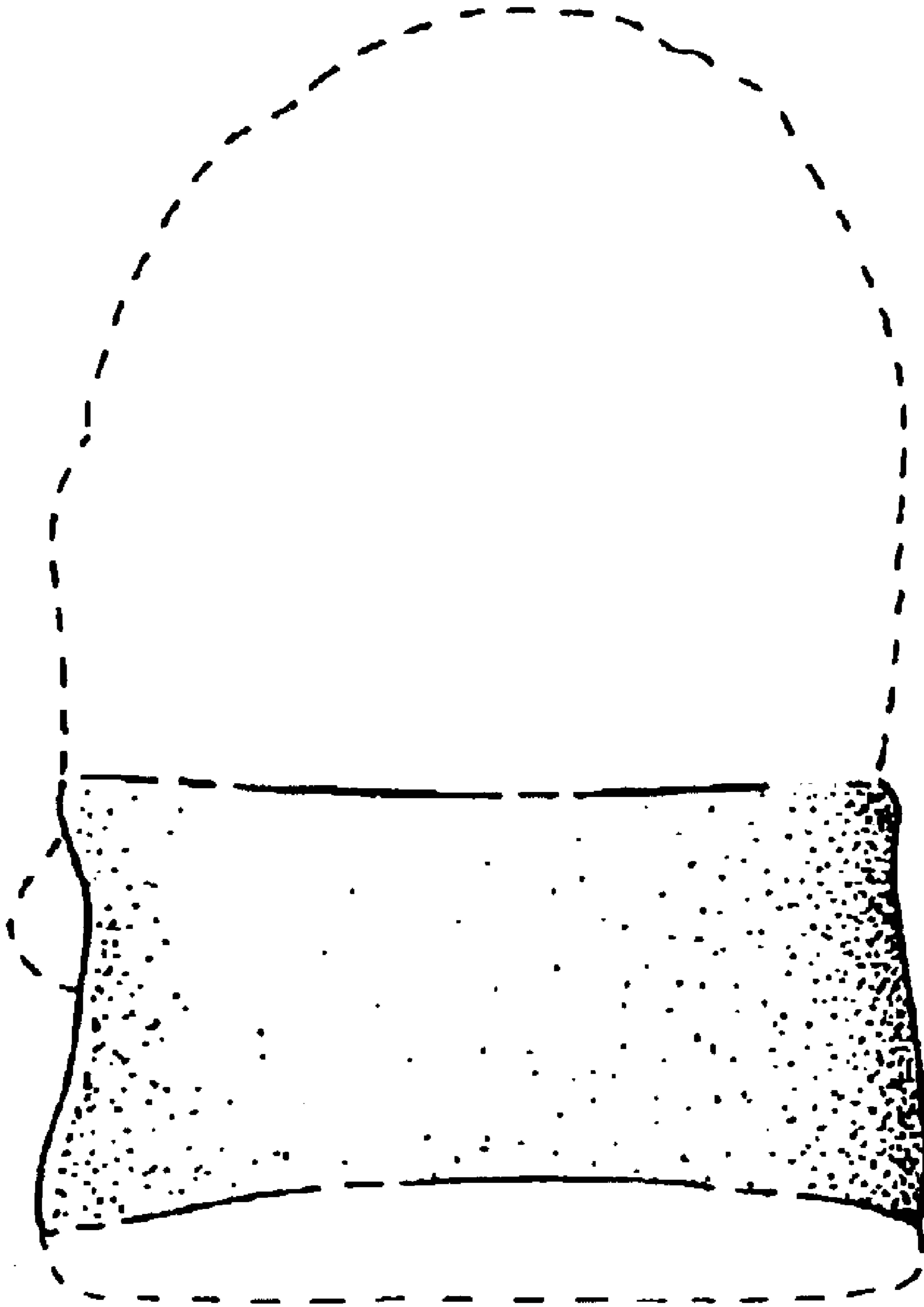
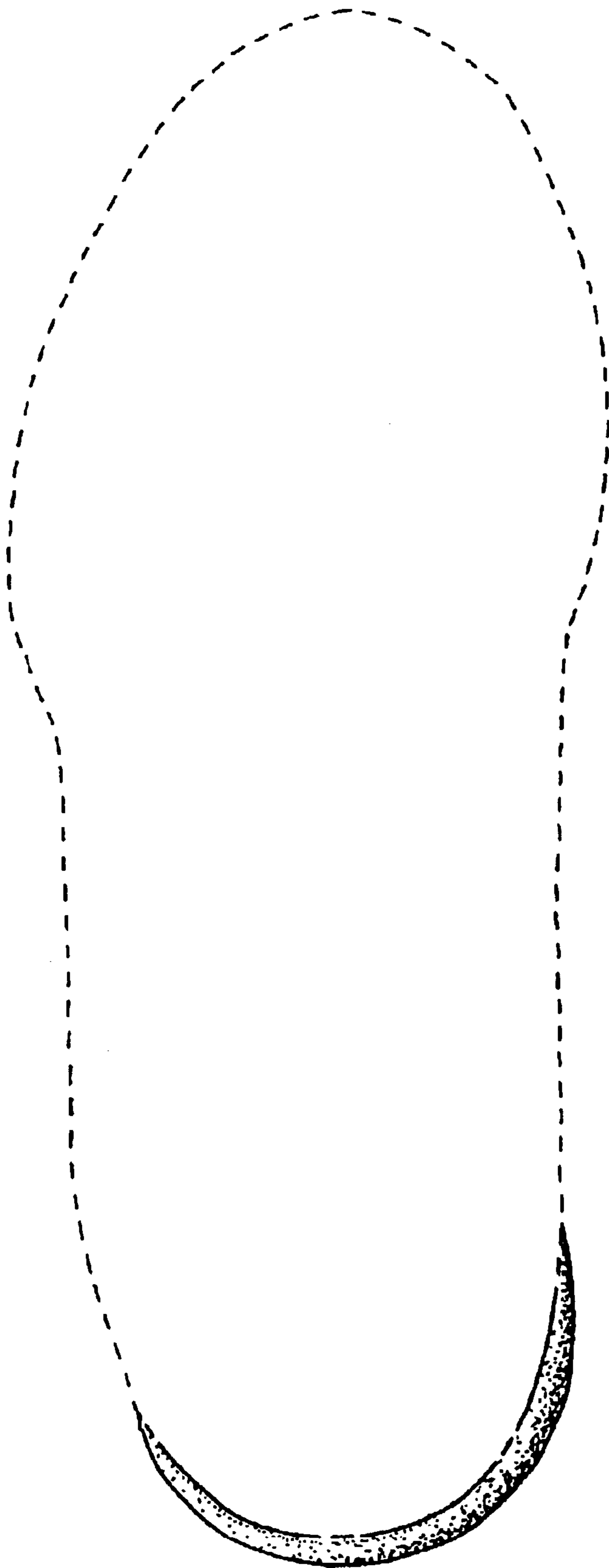
