FIG. 1 is an isometric view of the chaise lounge;

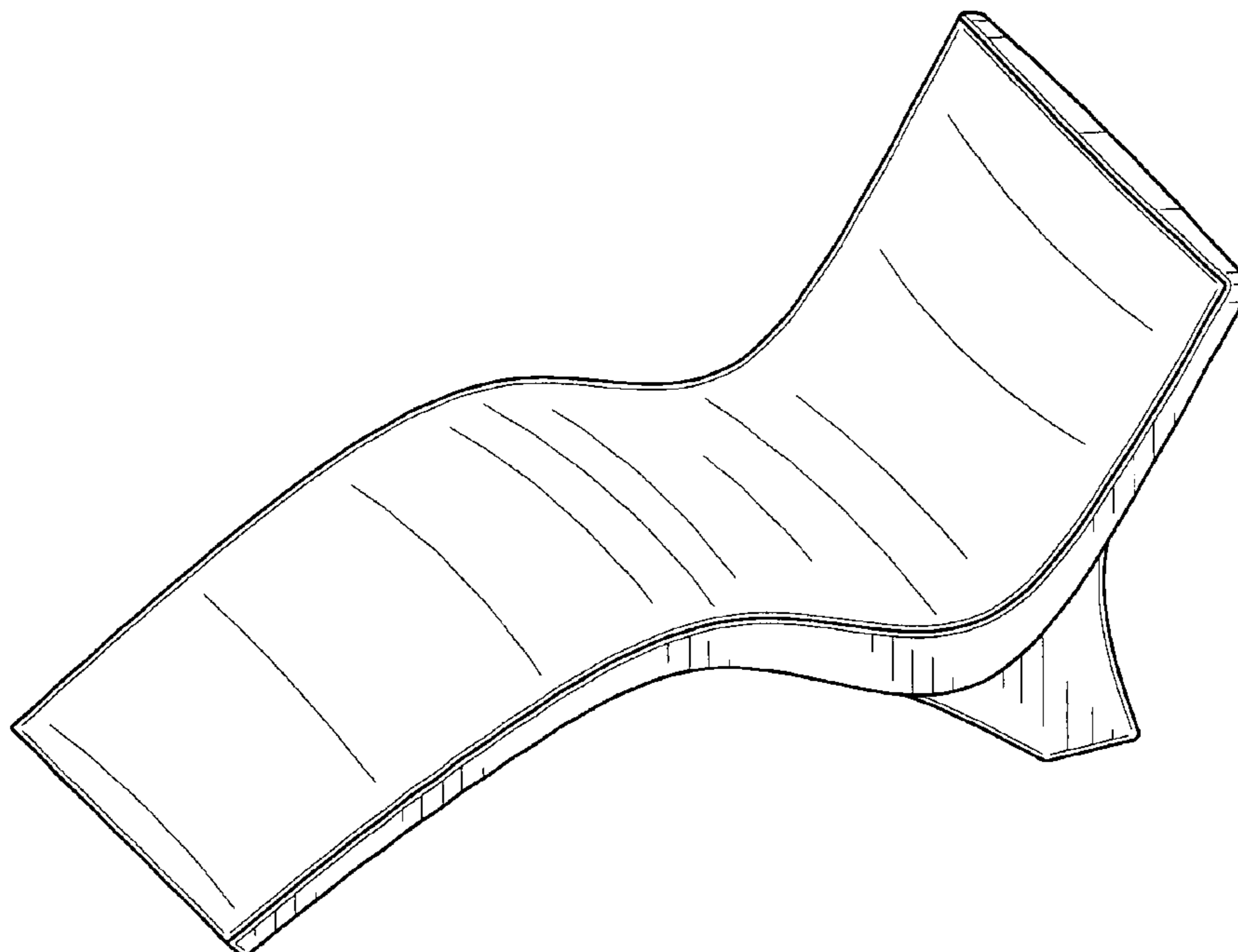
FIG. 2 is a front elevational view thereof;

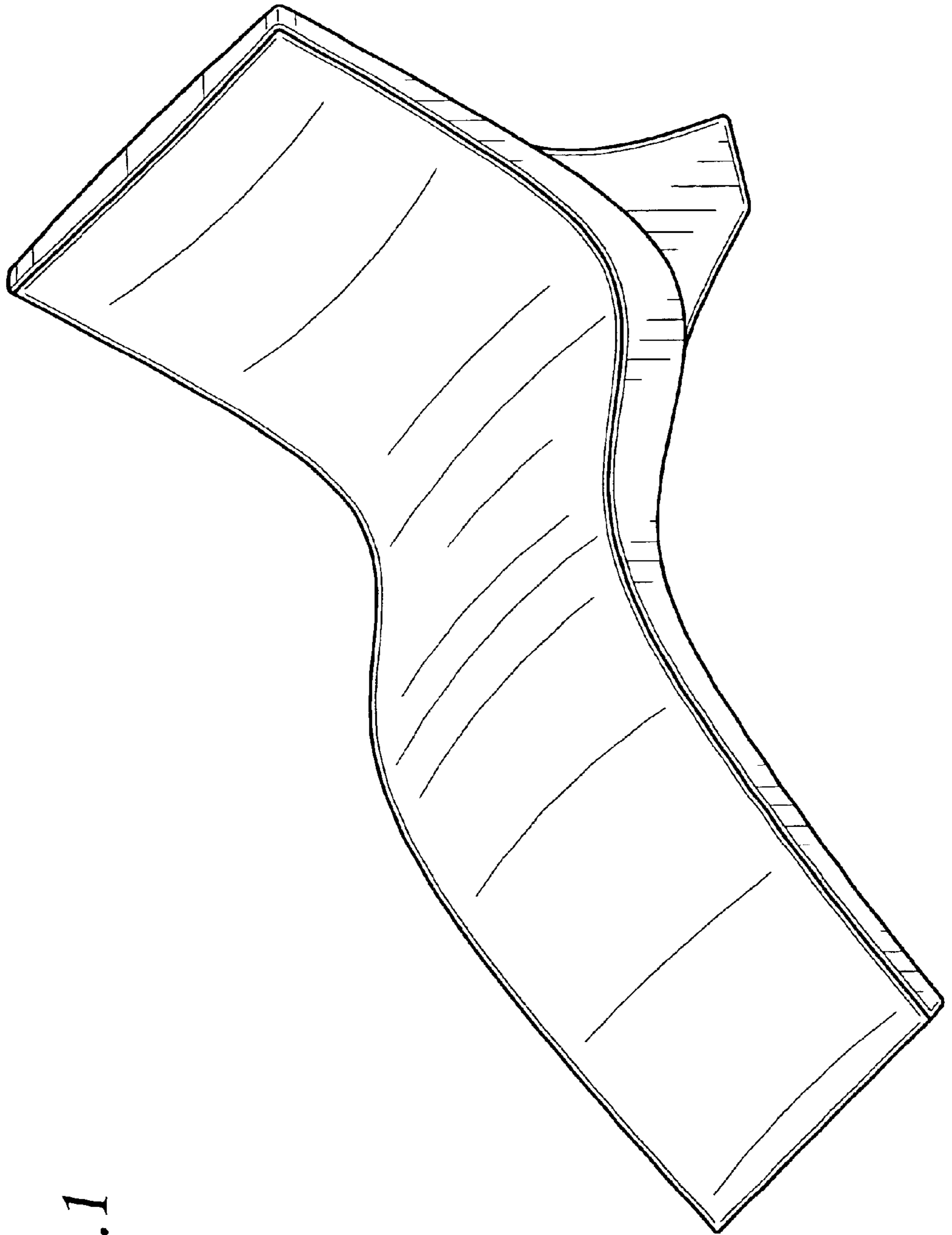

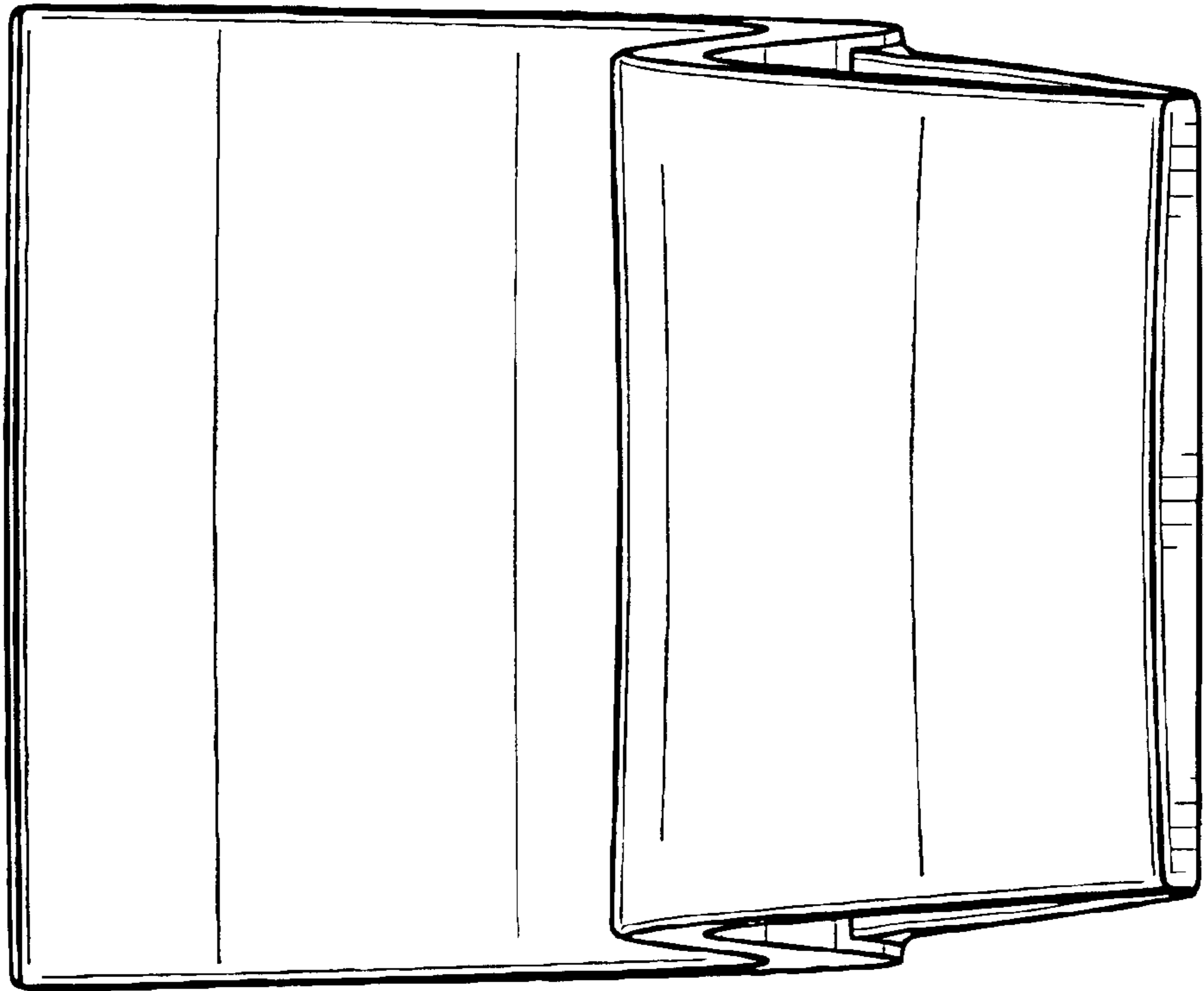

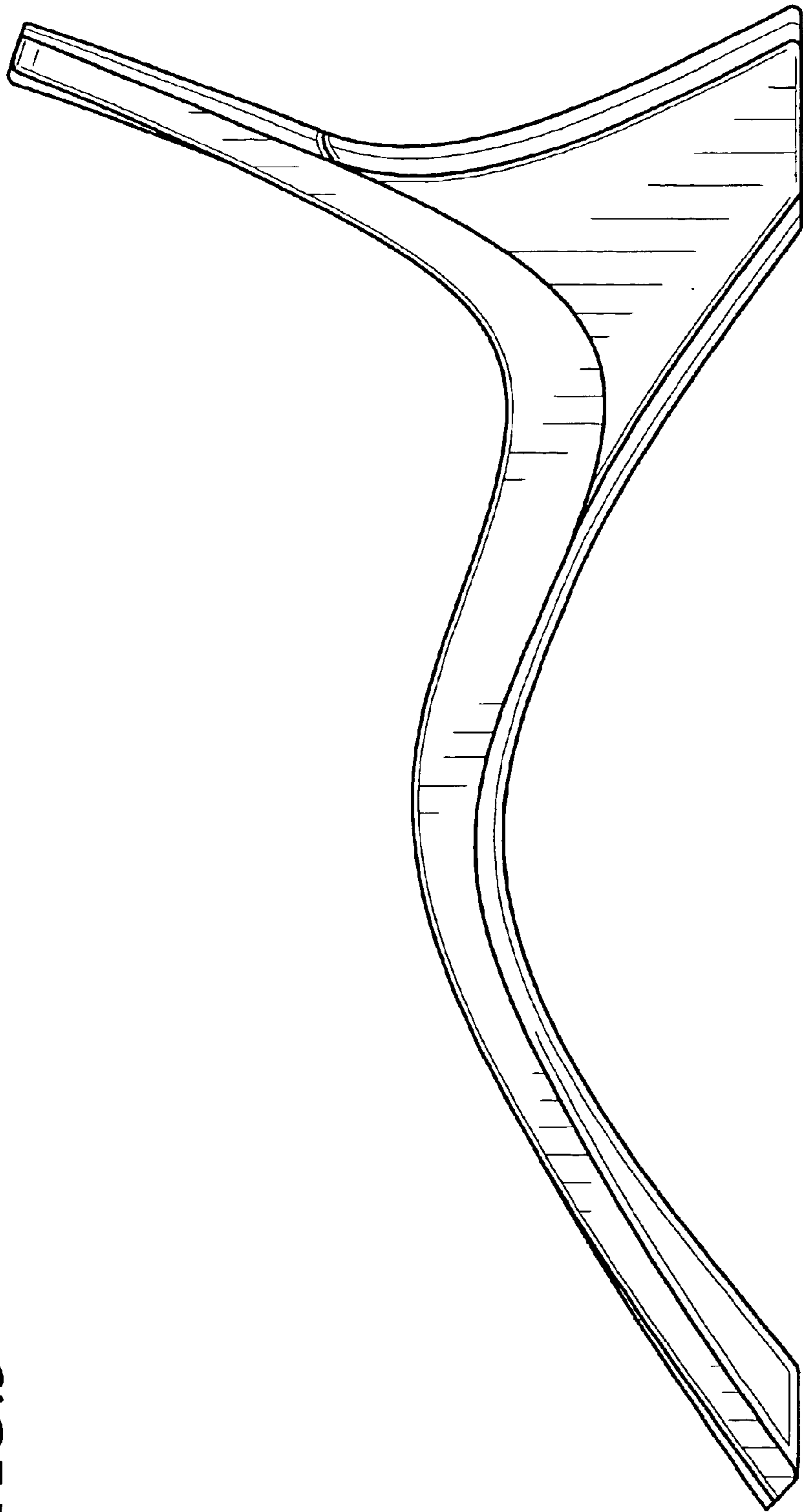

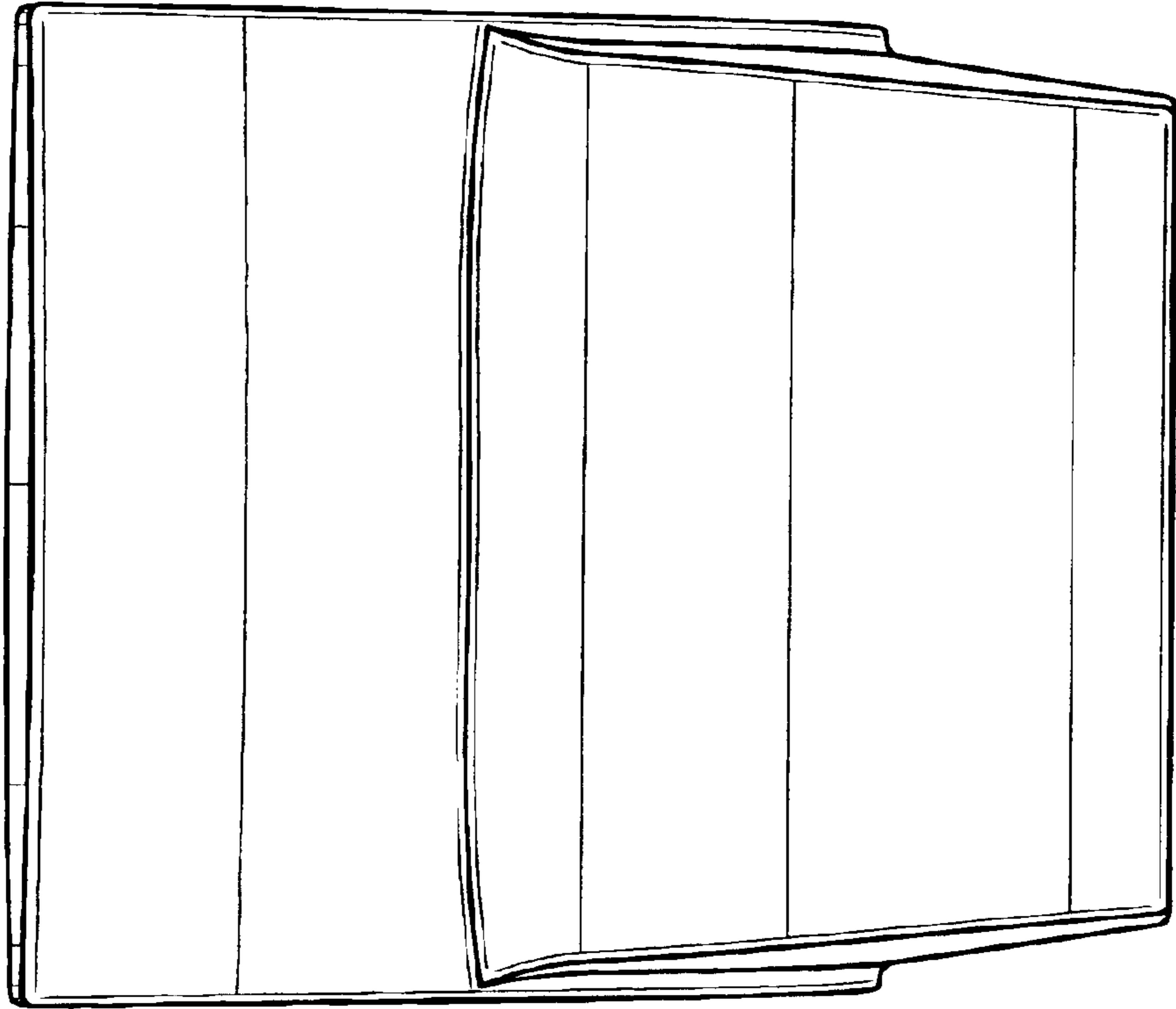

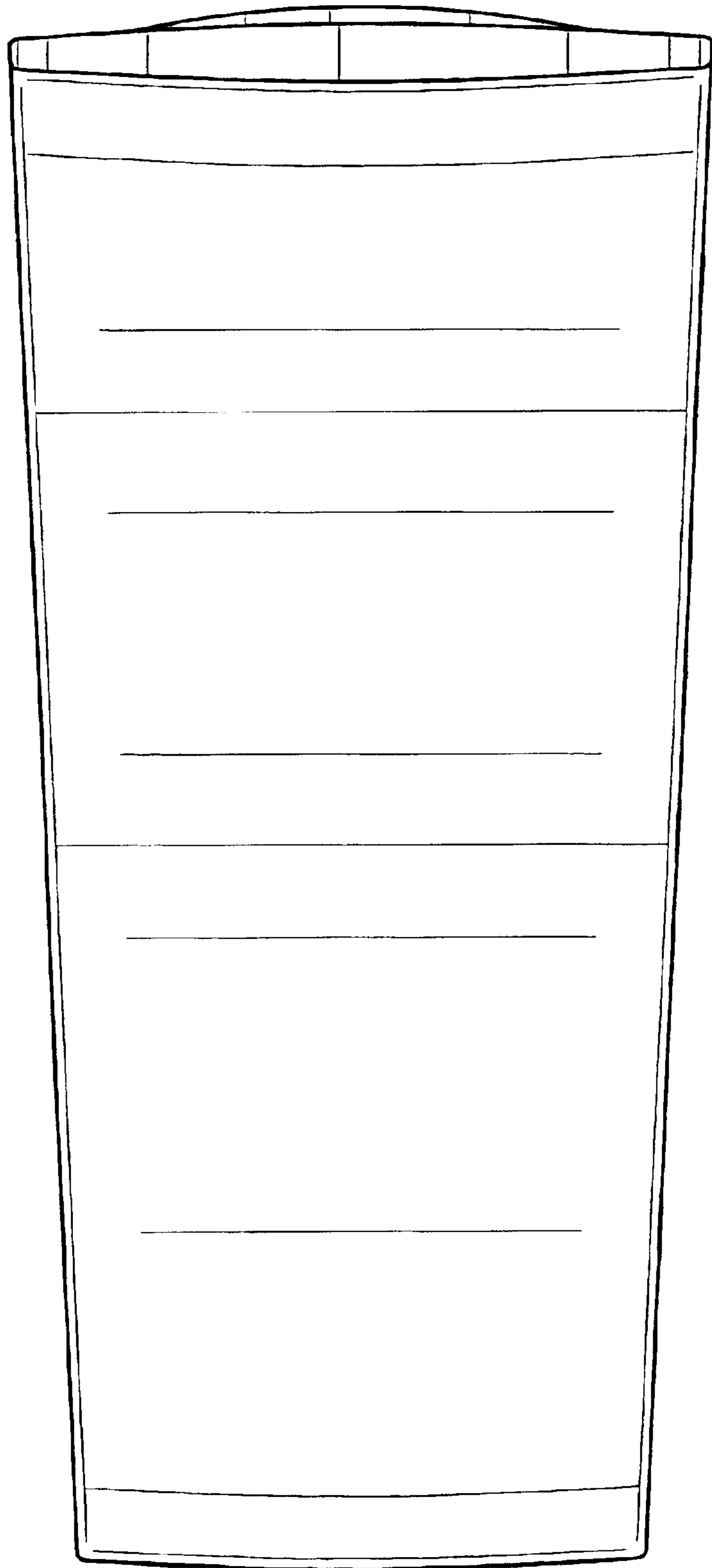
