FIG. 2 is a rear view of the appliance thereof;

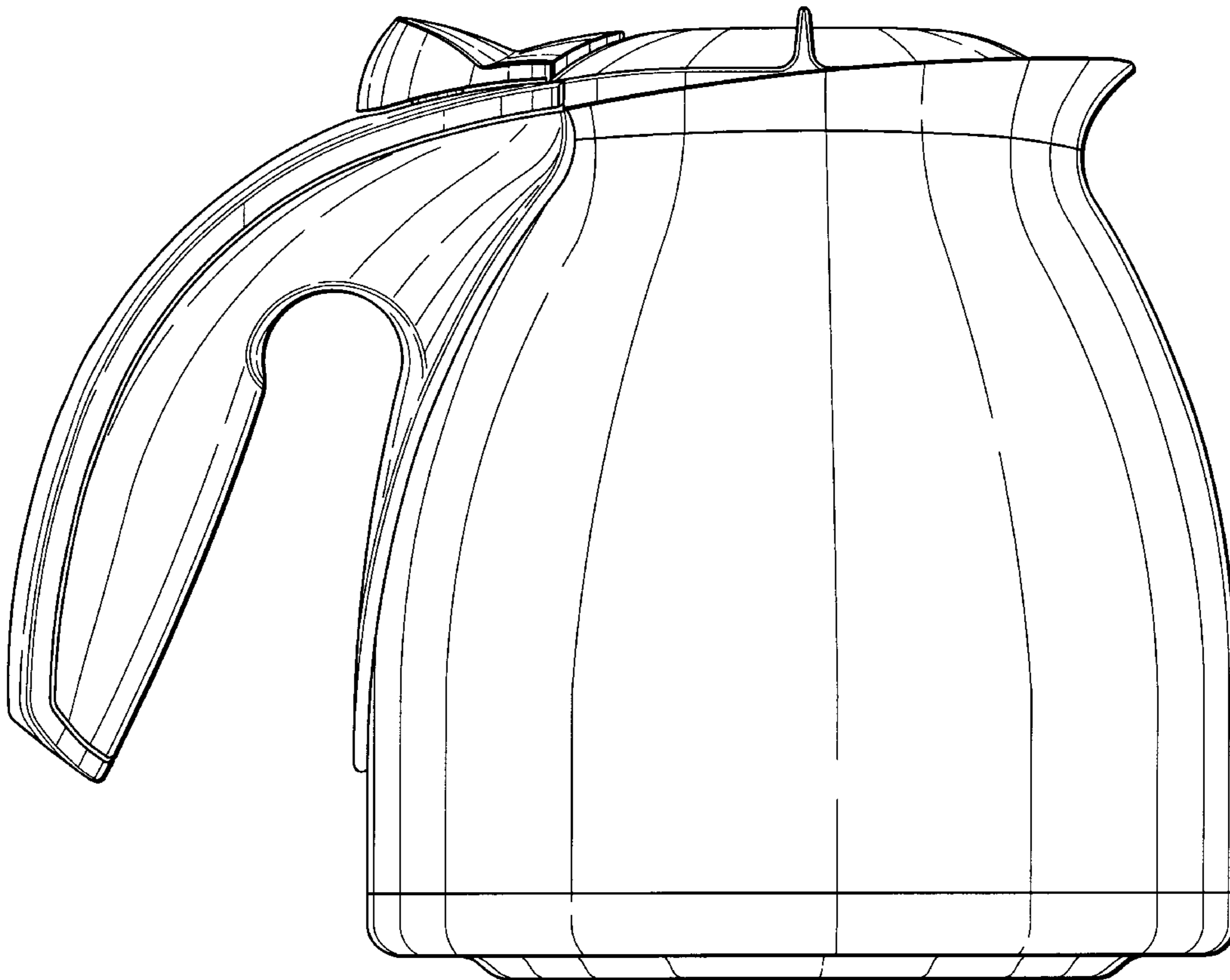
FIG. 3 is a left side view of the appliance thereof

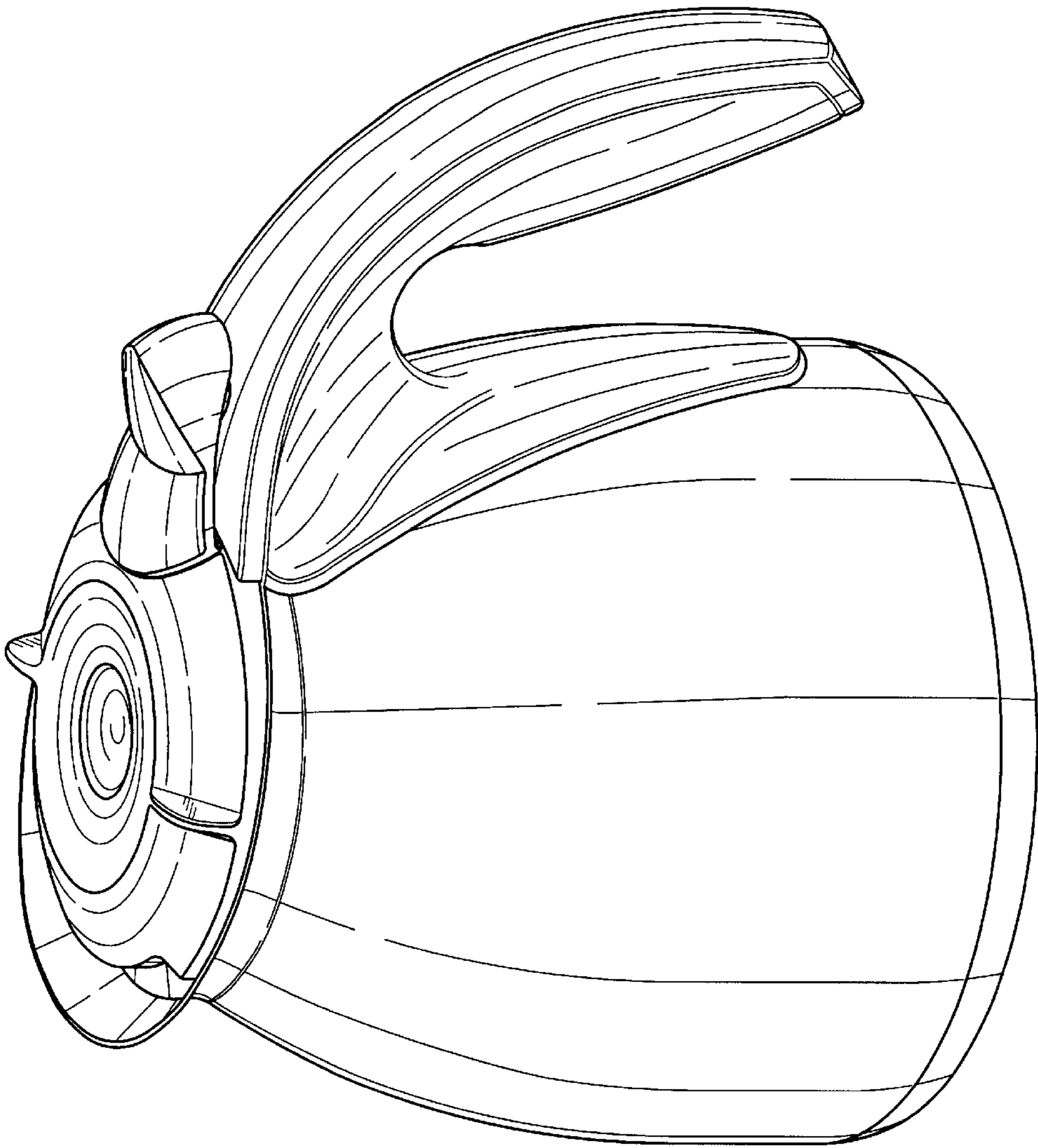
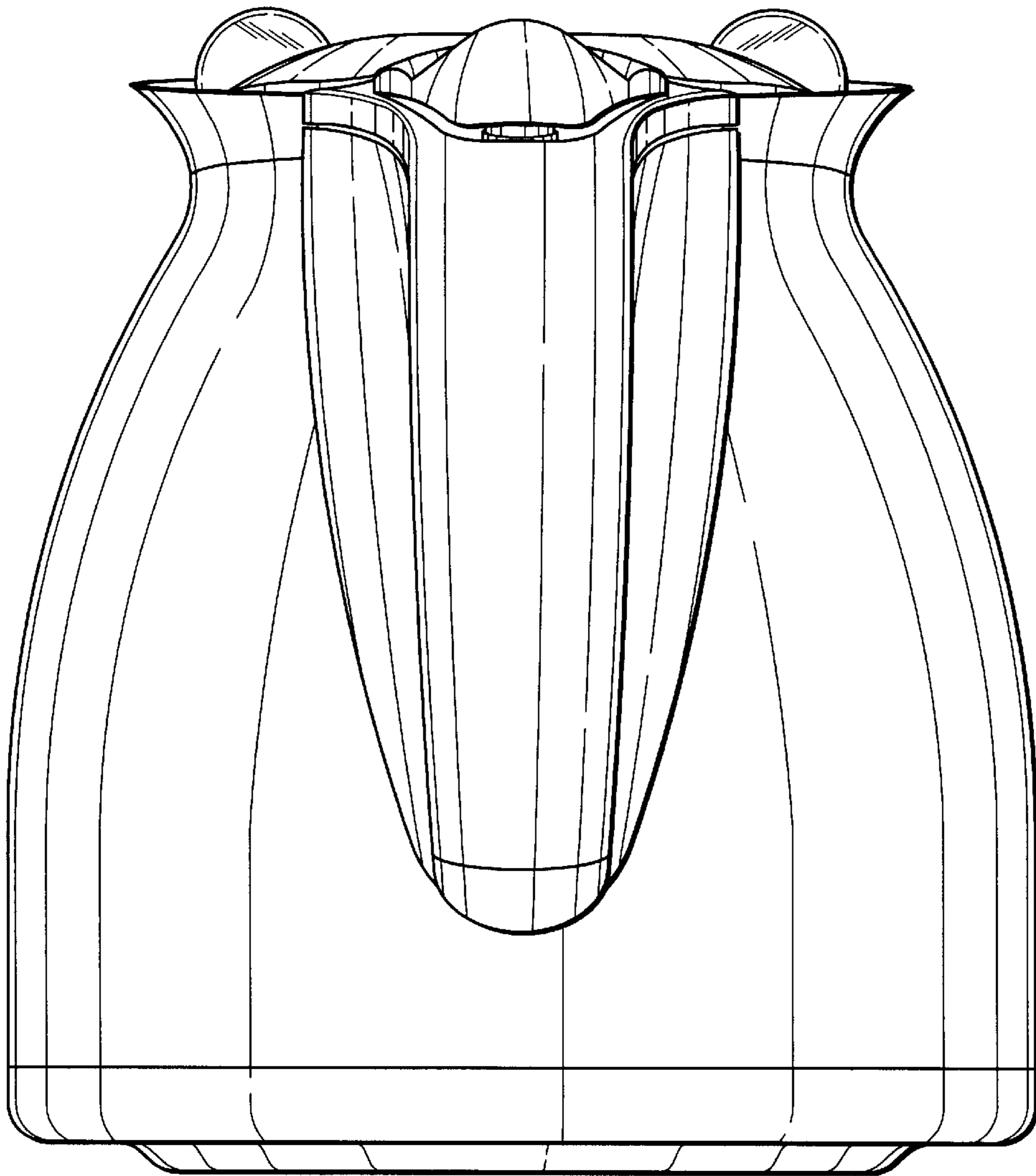

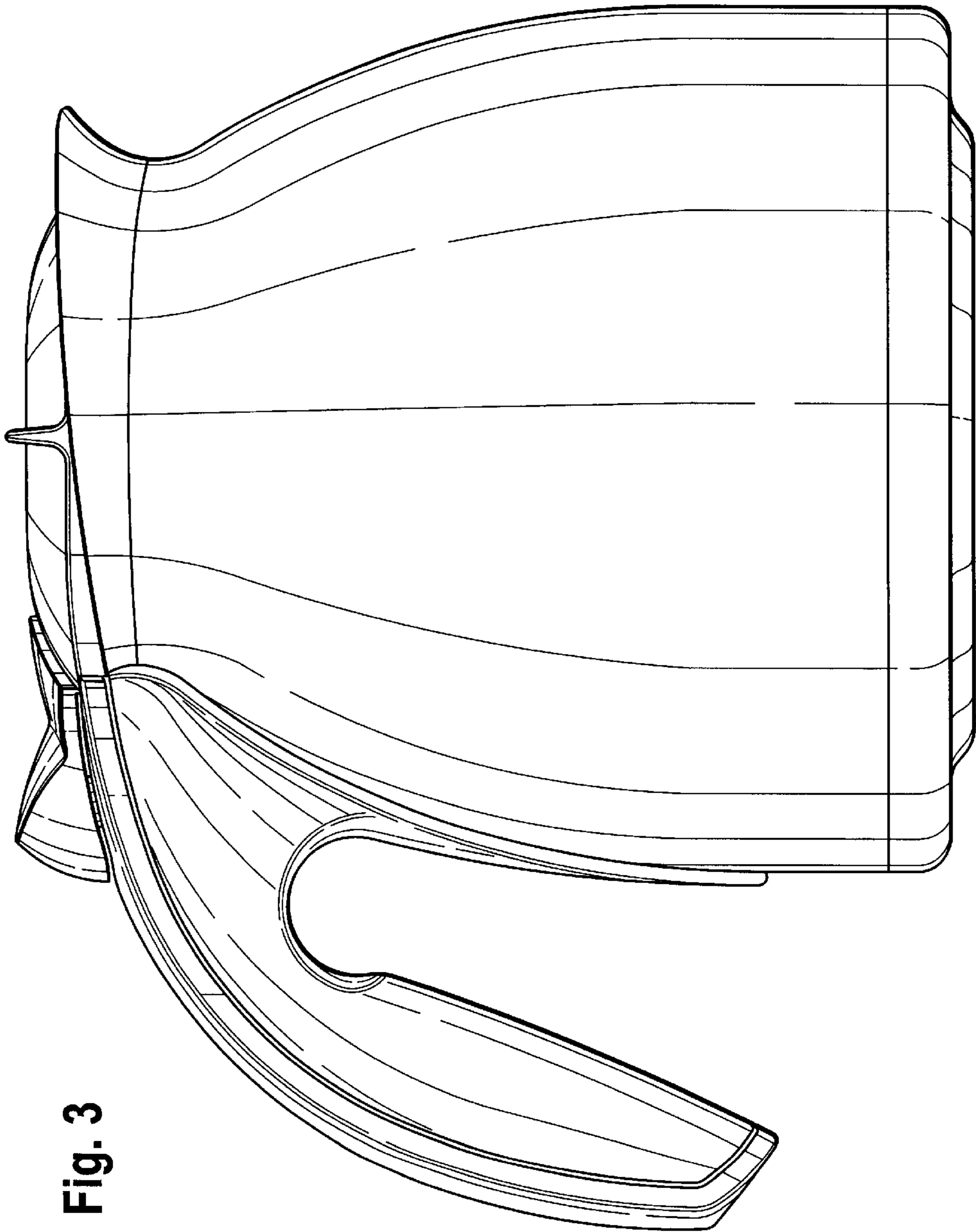

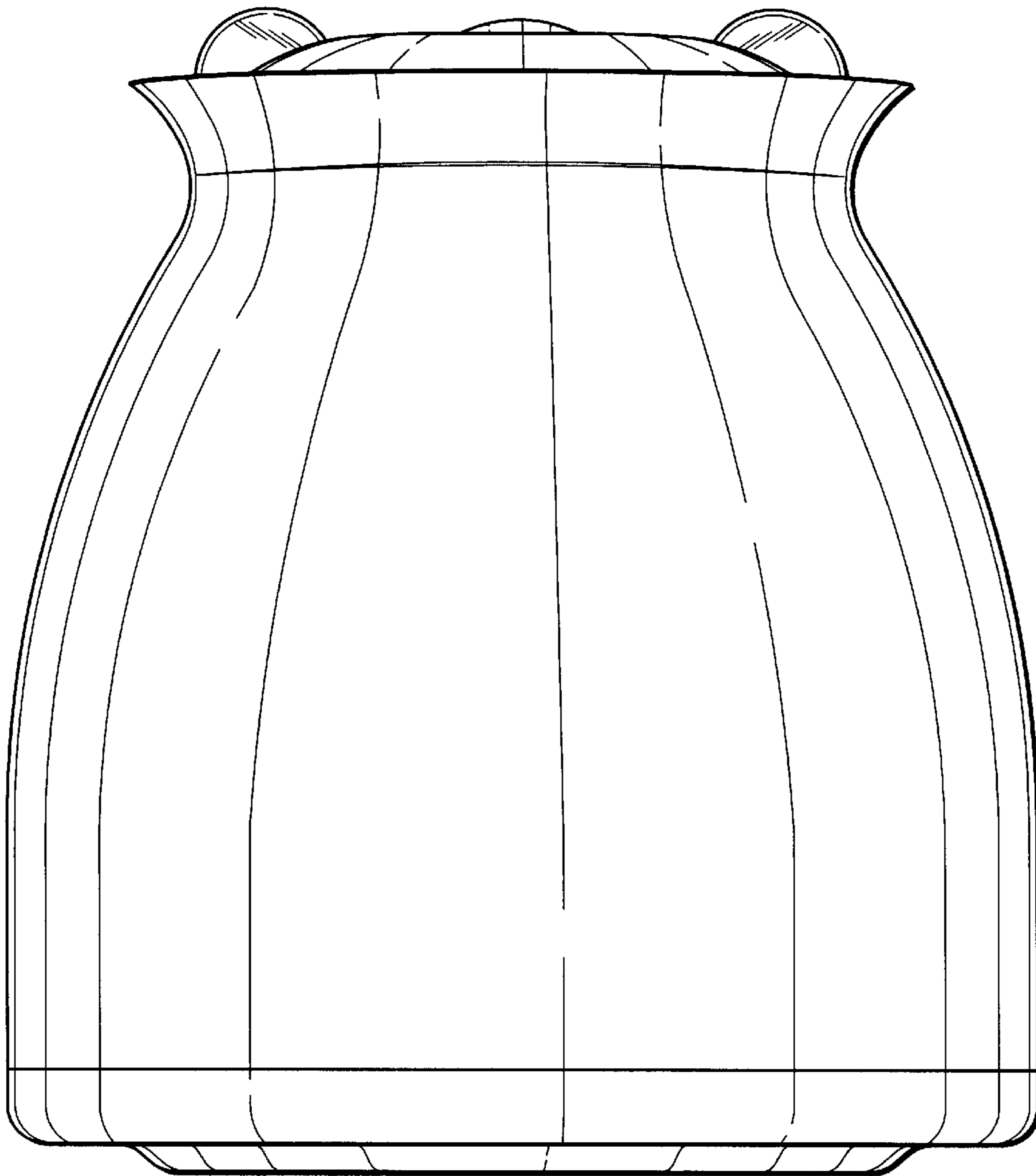

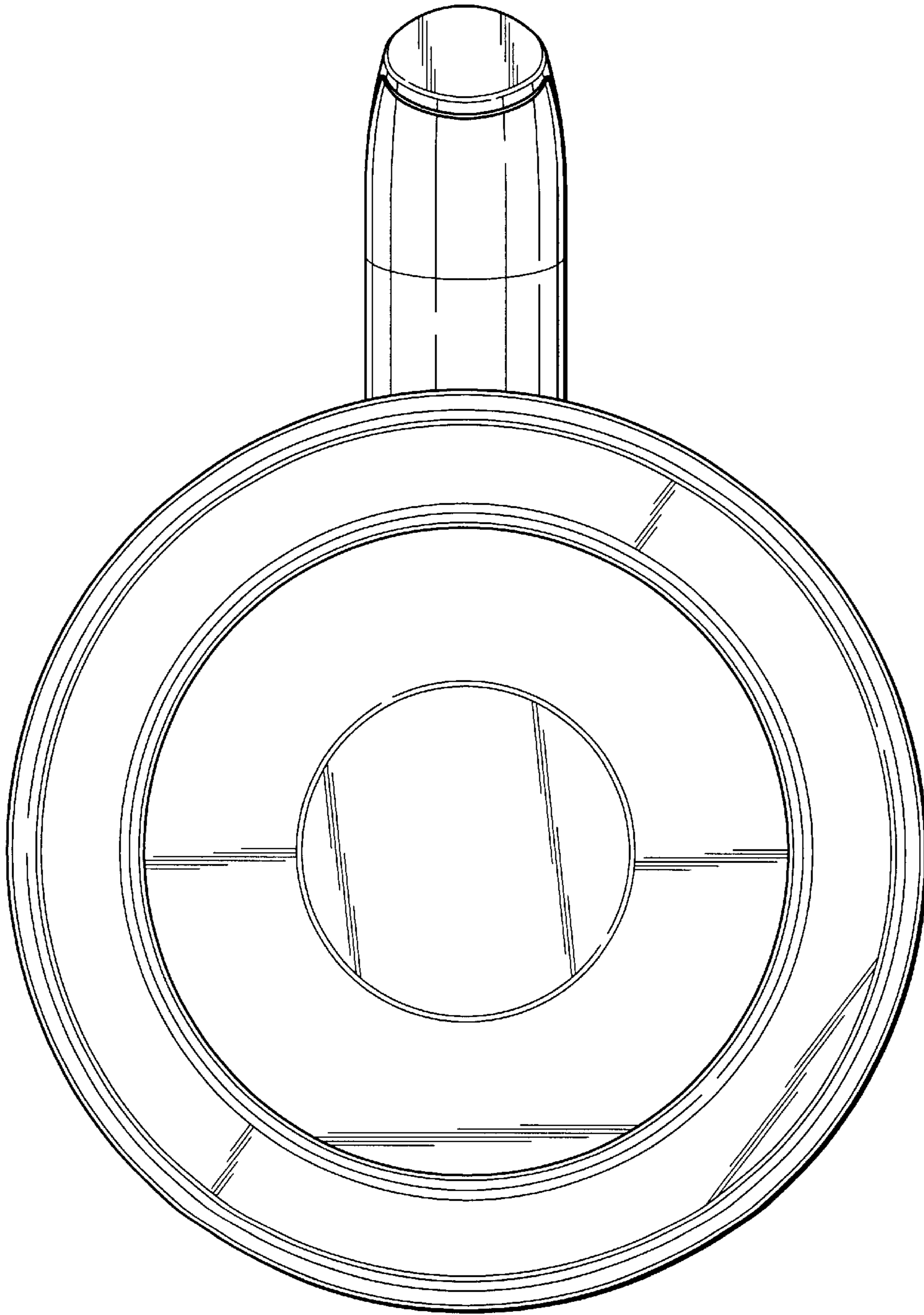
